DESCRIPTION

FIG. 1 is a right side elevational view of an “ultraviolet
fingernail dryer” showing our new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a front left side perspective view showing the top
in a partially open position; and,
FIG. 7 is a view similar to FIG. 6 showing the top in its fully
open position.

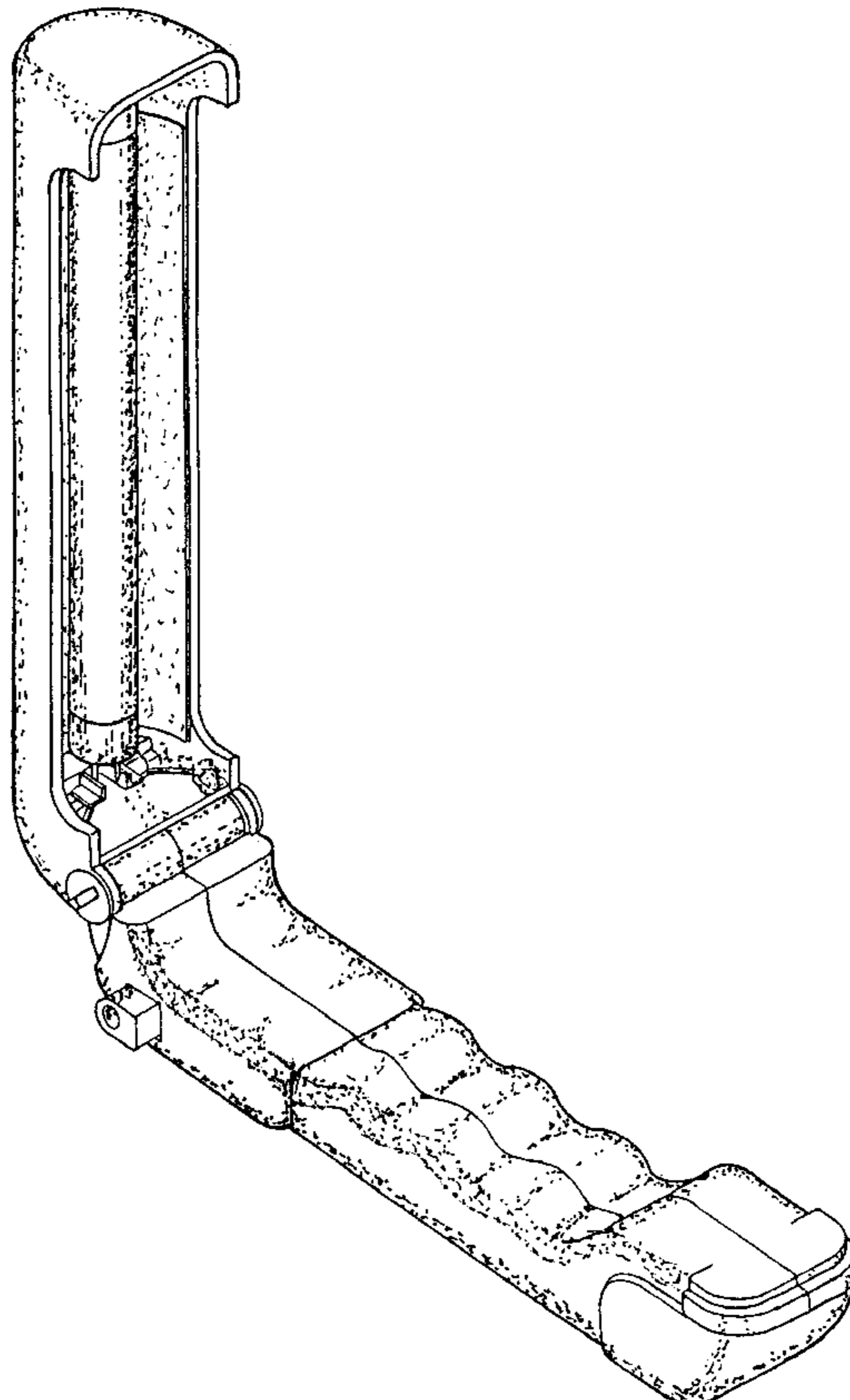

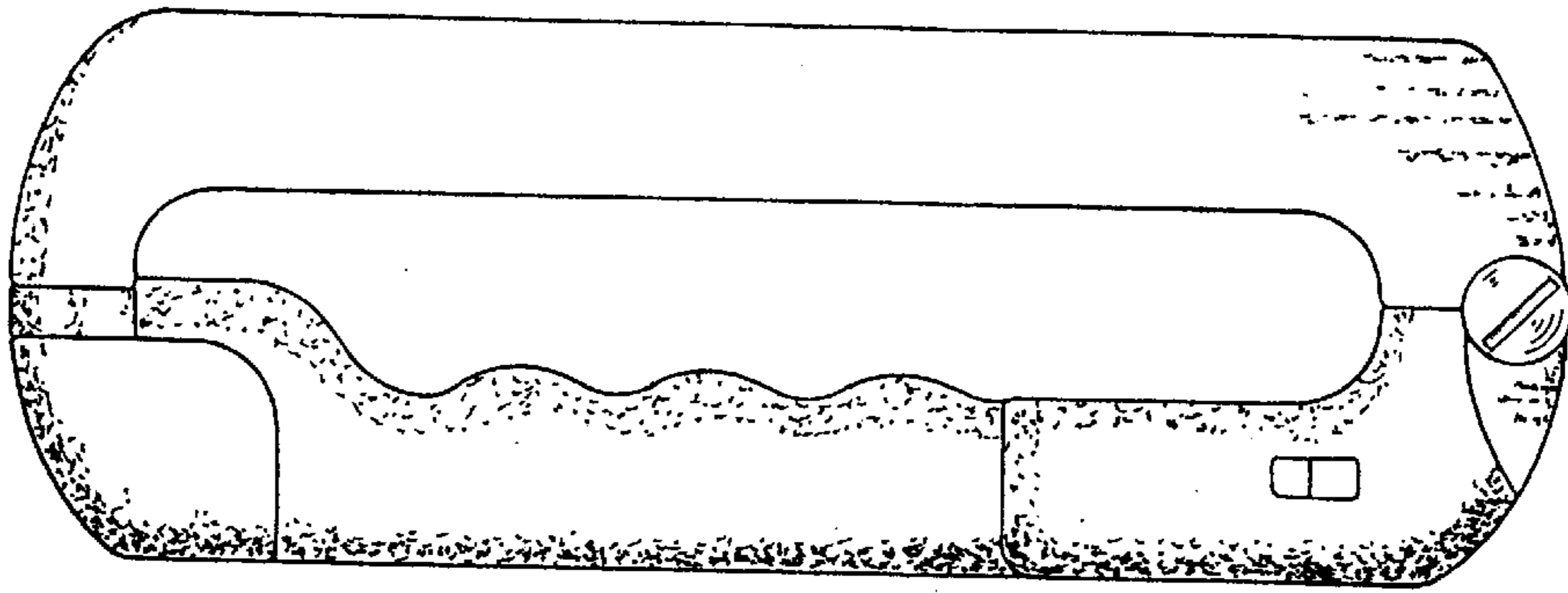

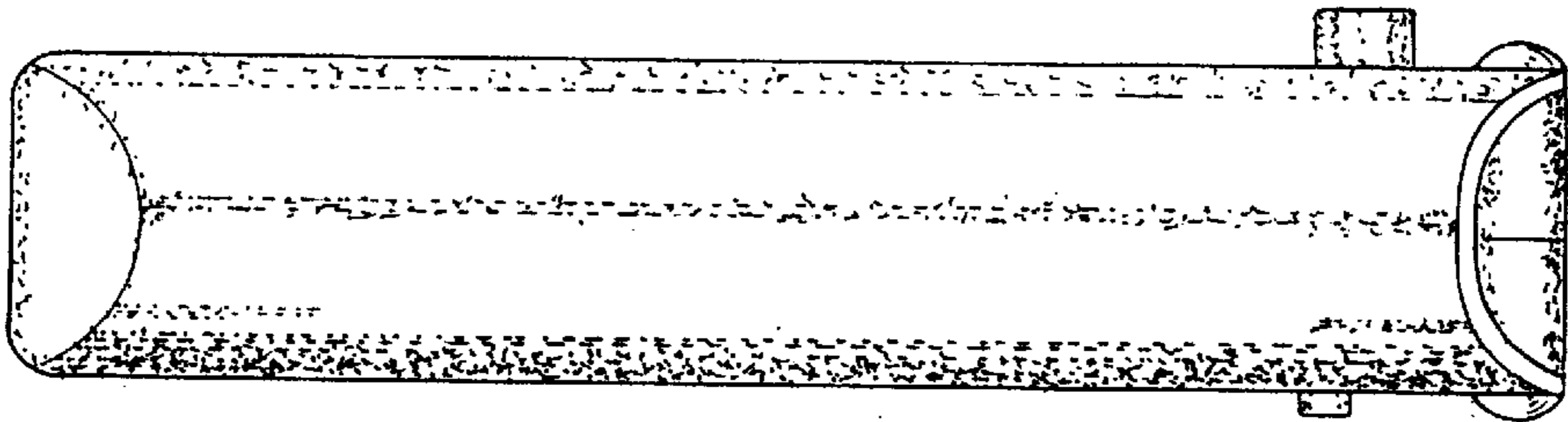

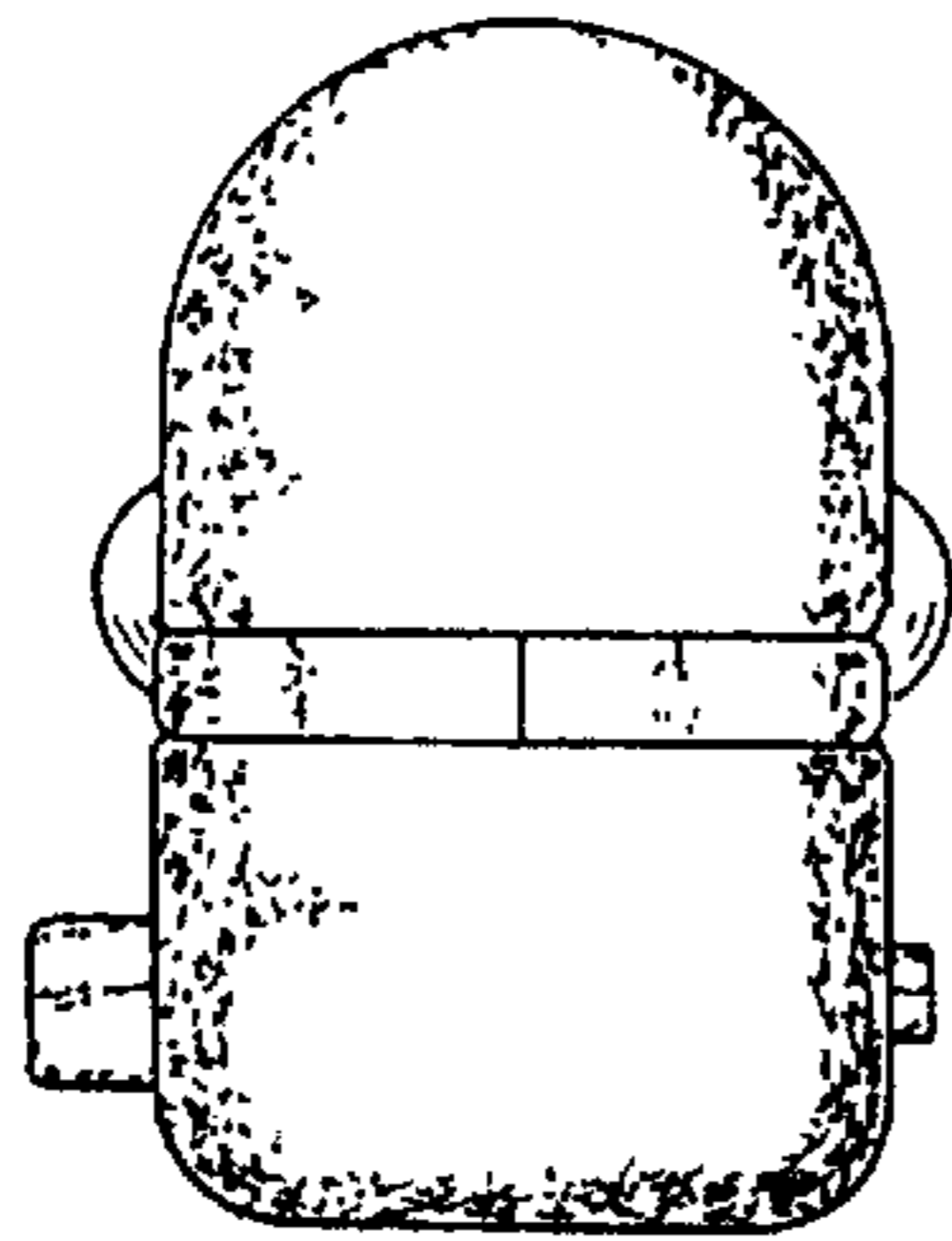

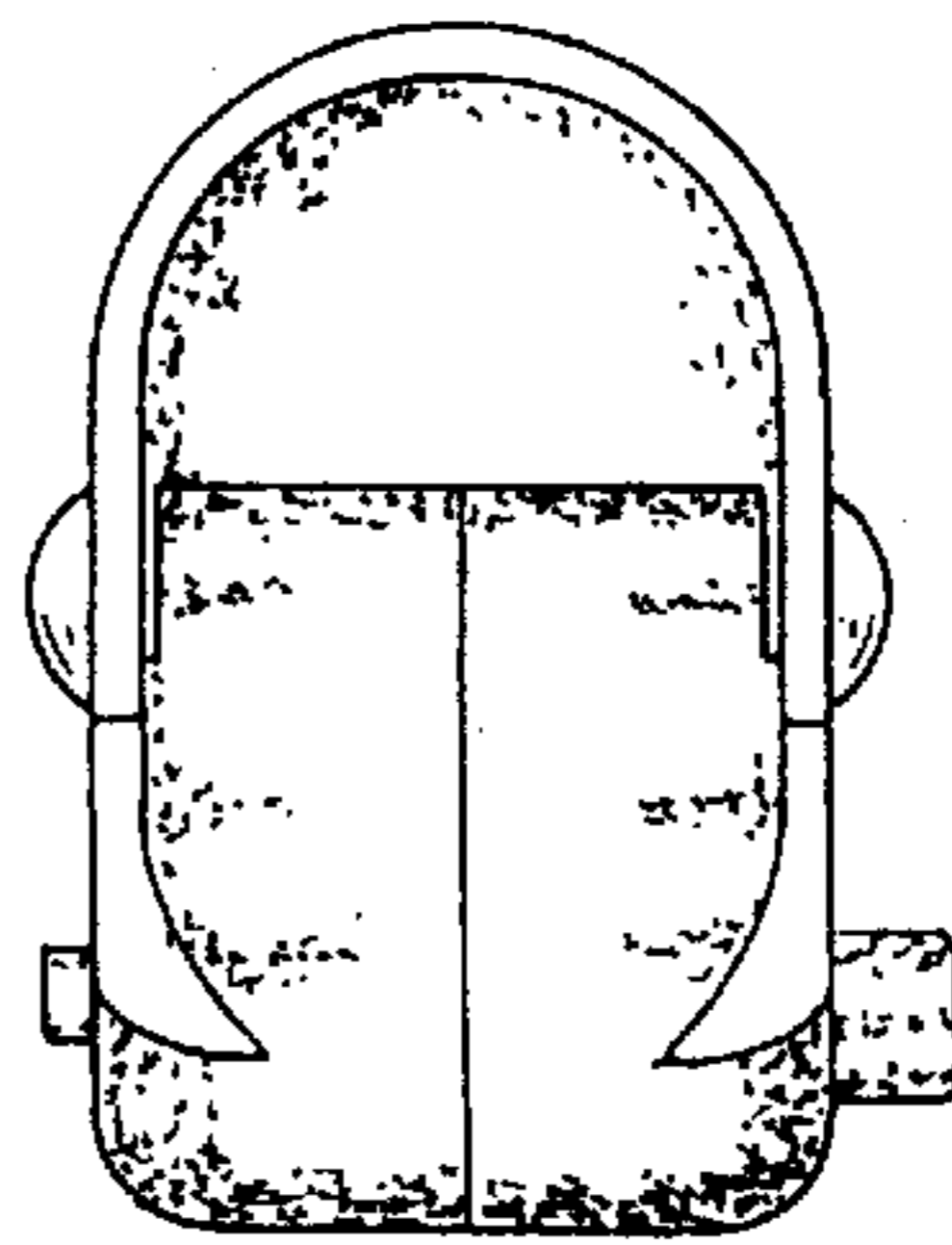
