(57) **CLAIM**

The ornamental design for plaid fabric design, as shown and described.

**DESCRIPTION**

The single FIGURE is a top plan view of a plaid fabric design showing my new design, the fabric having no appreciable thickness and the reverse side of the fabric being non-ornamental. The plaid fabric design repeats indeterminately in one or more directions.
