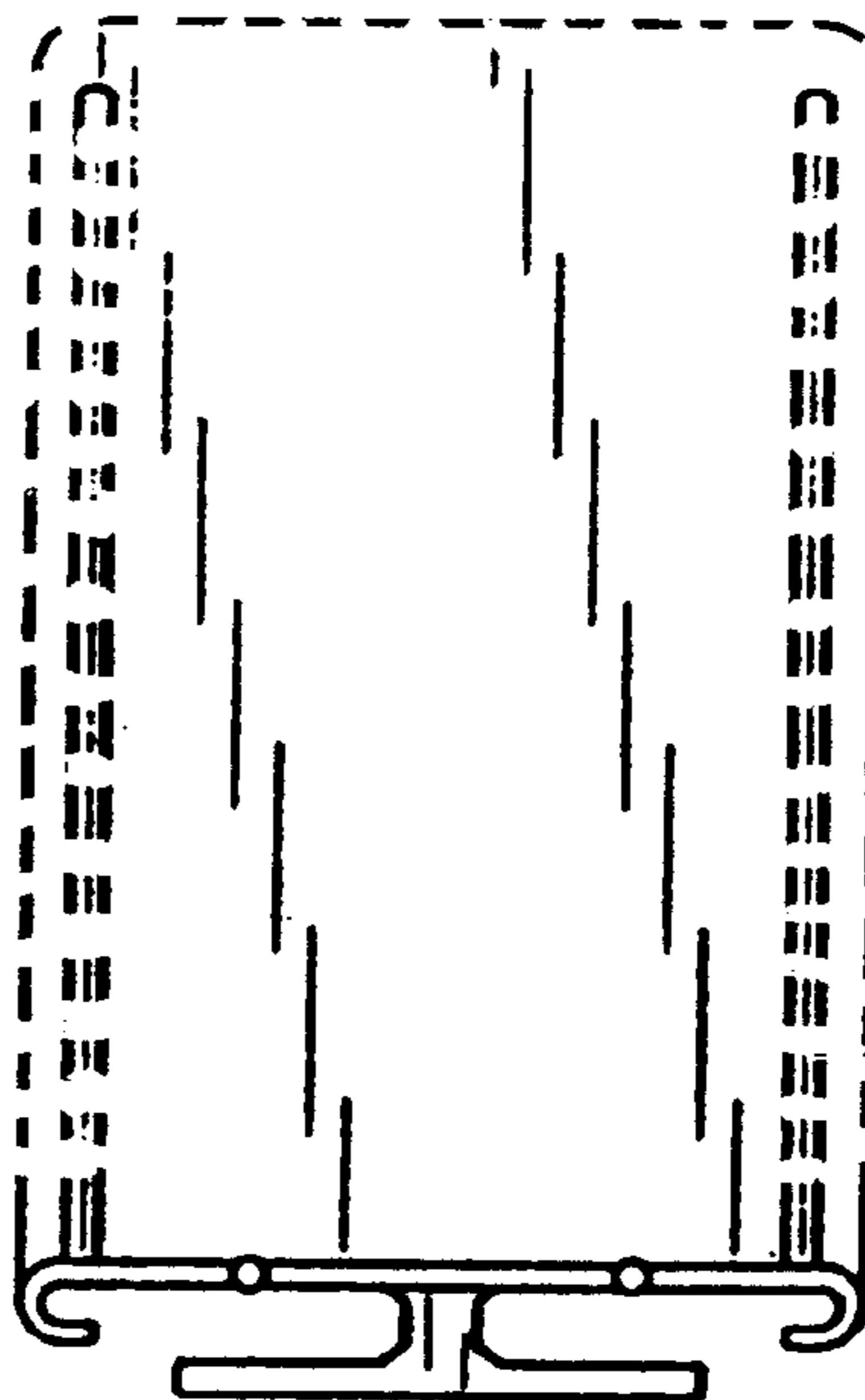
(57) **CLAIM**

The ornamental design for a slide member, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a slide member of the present invention, illustrating the slide member in connection with a track system;
FIG. 2 is a front elevational view of the slide member;
FIG. 3 is a right side elevational view of the slide member;
FIG. 4 is a left side elevational view of the slide member;
FIG. 5 is a top plan view of the slide member;
FIG. 6 is a back elevation view of the slide member; and,
FIG. 7 is a bottom plan view of the slide member.
The broken lines are for illustrative purpose only and forms no part of the claimed design.

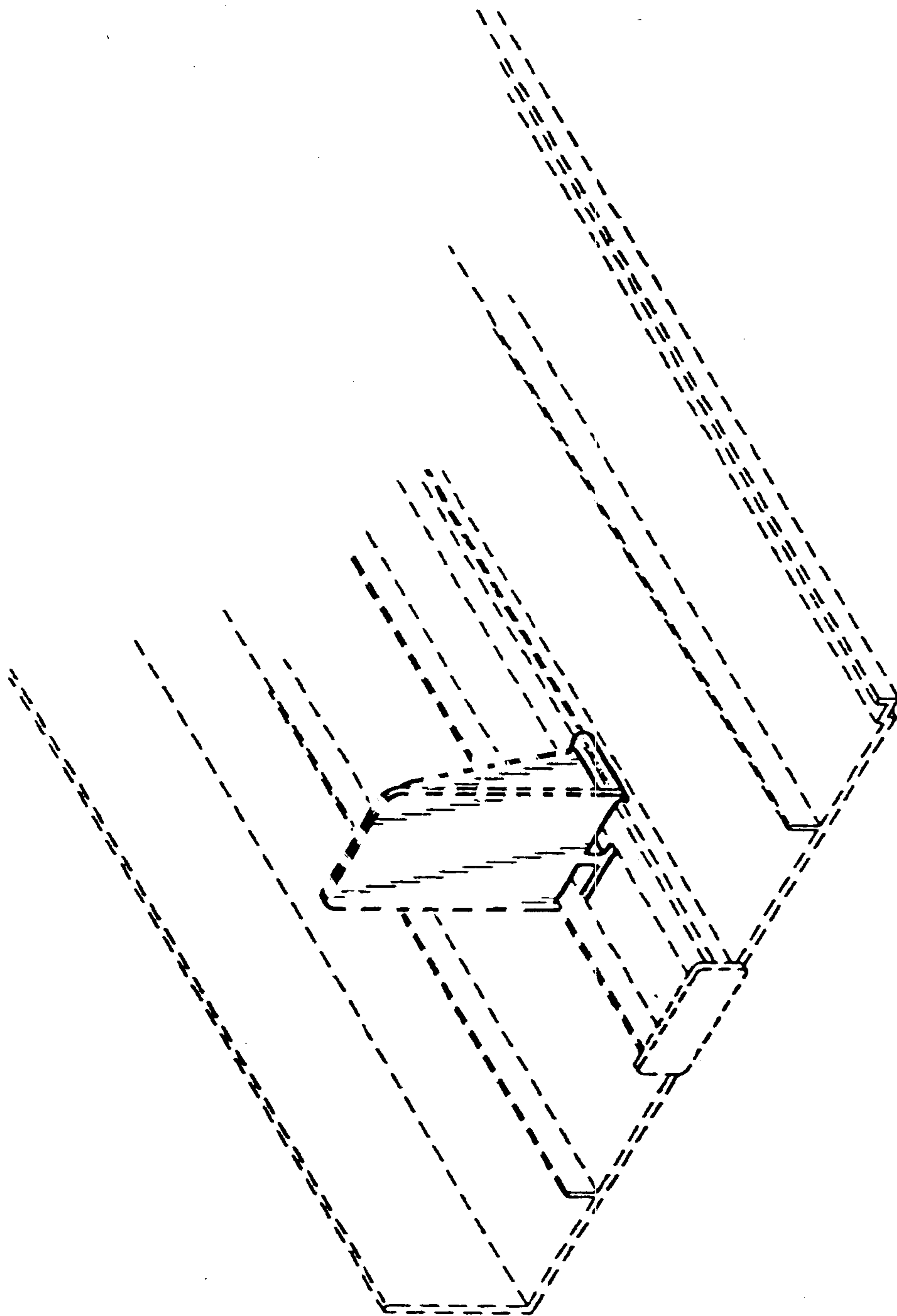

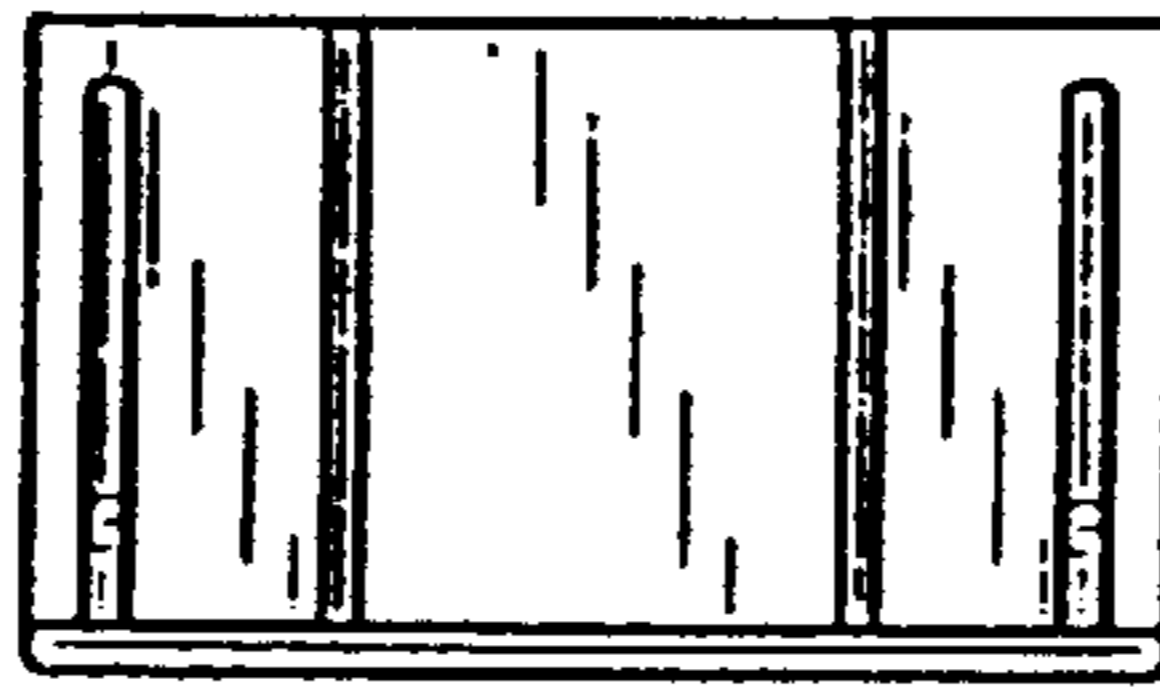

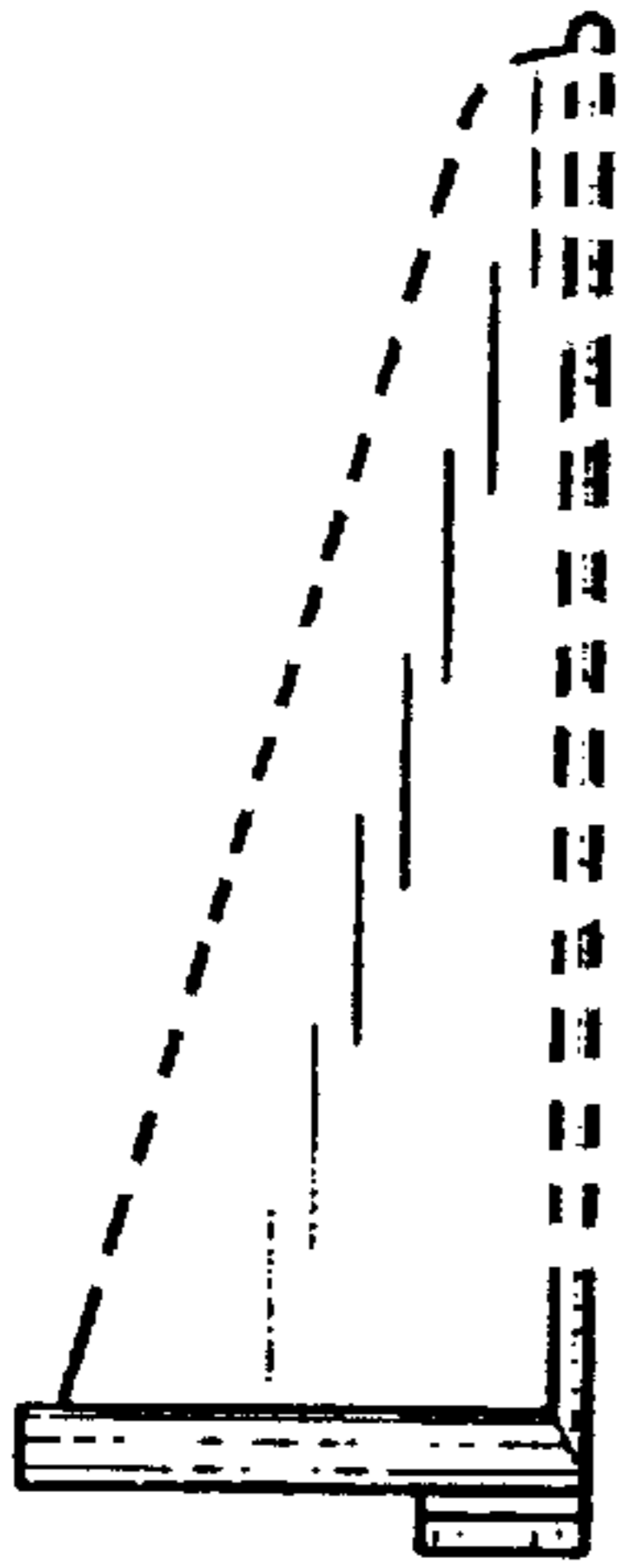

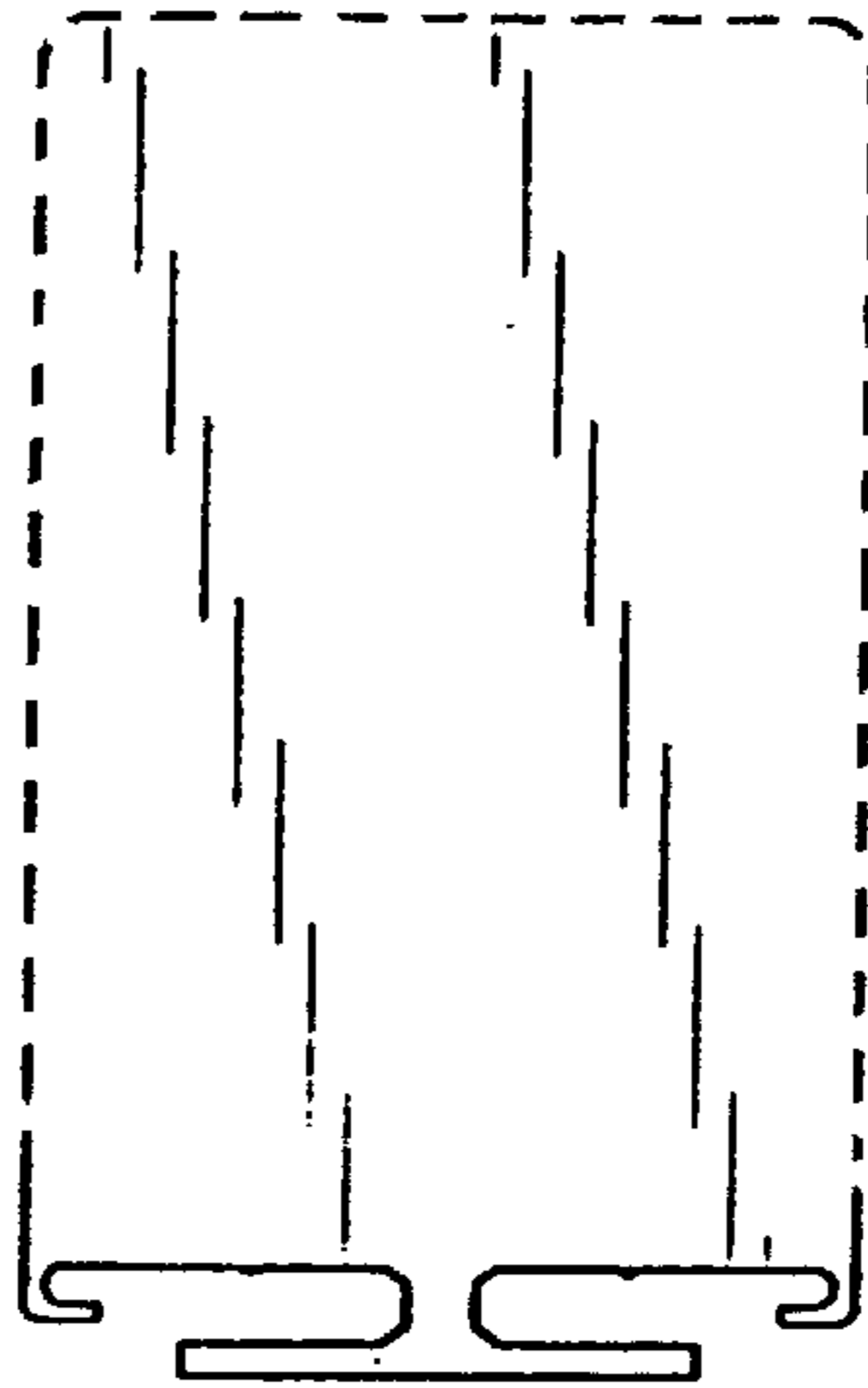

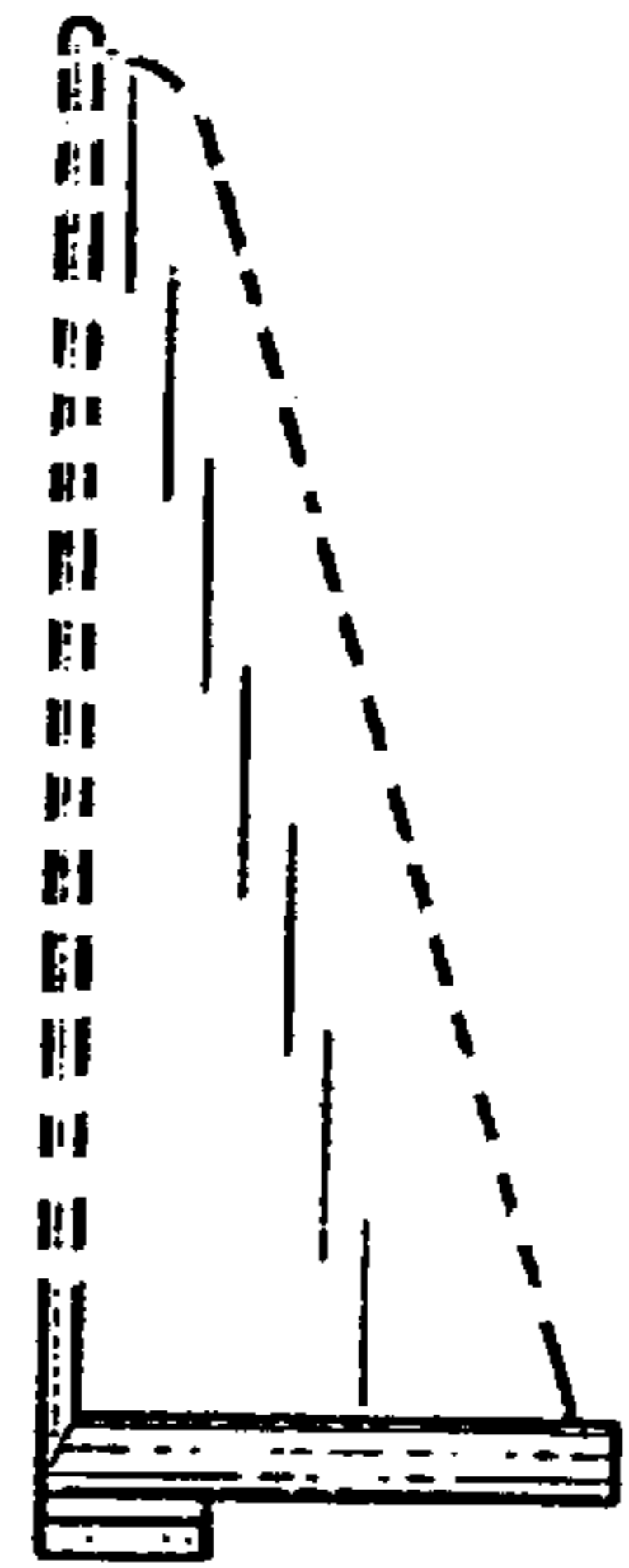

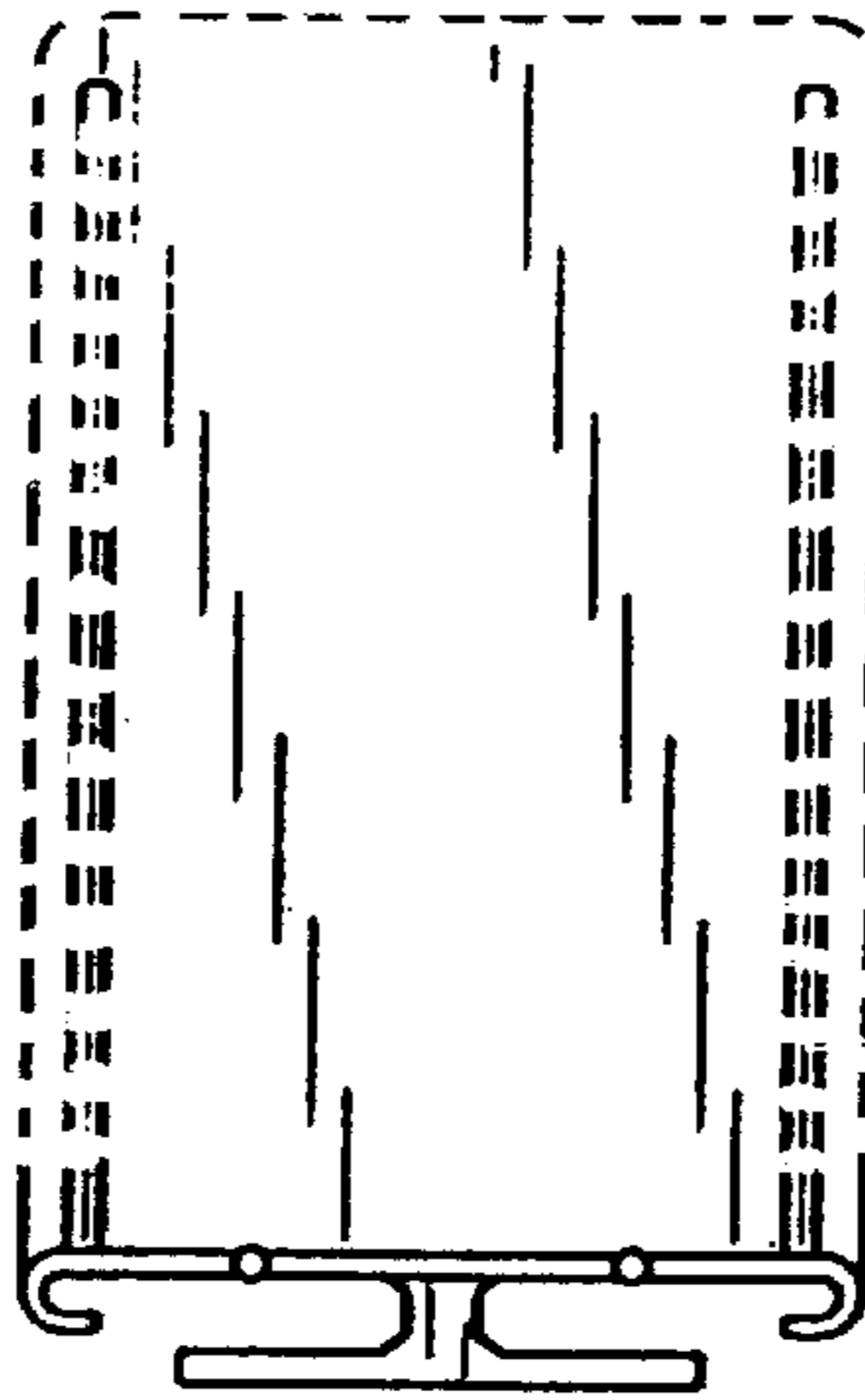

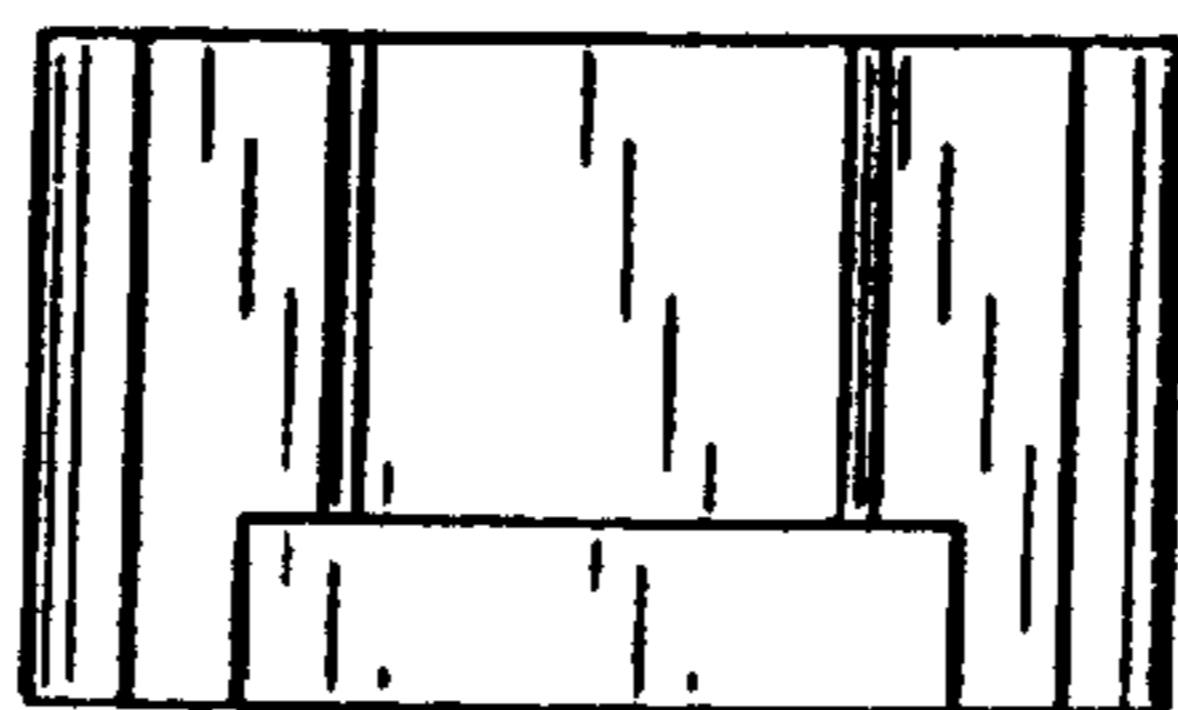
