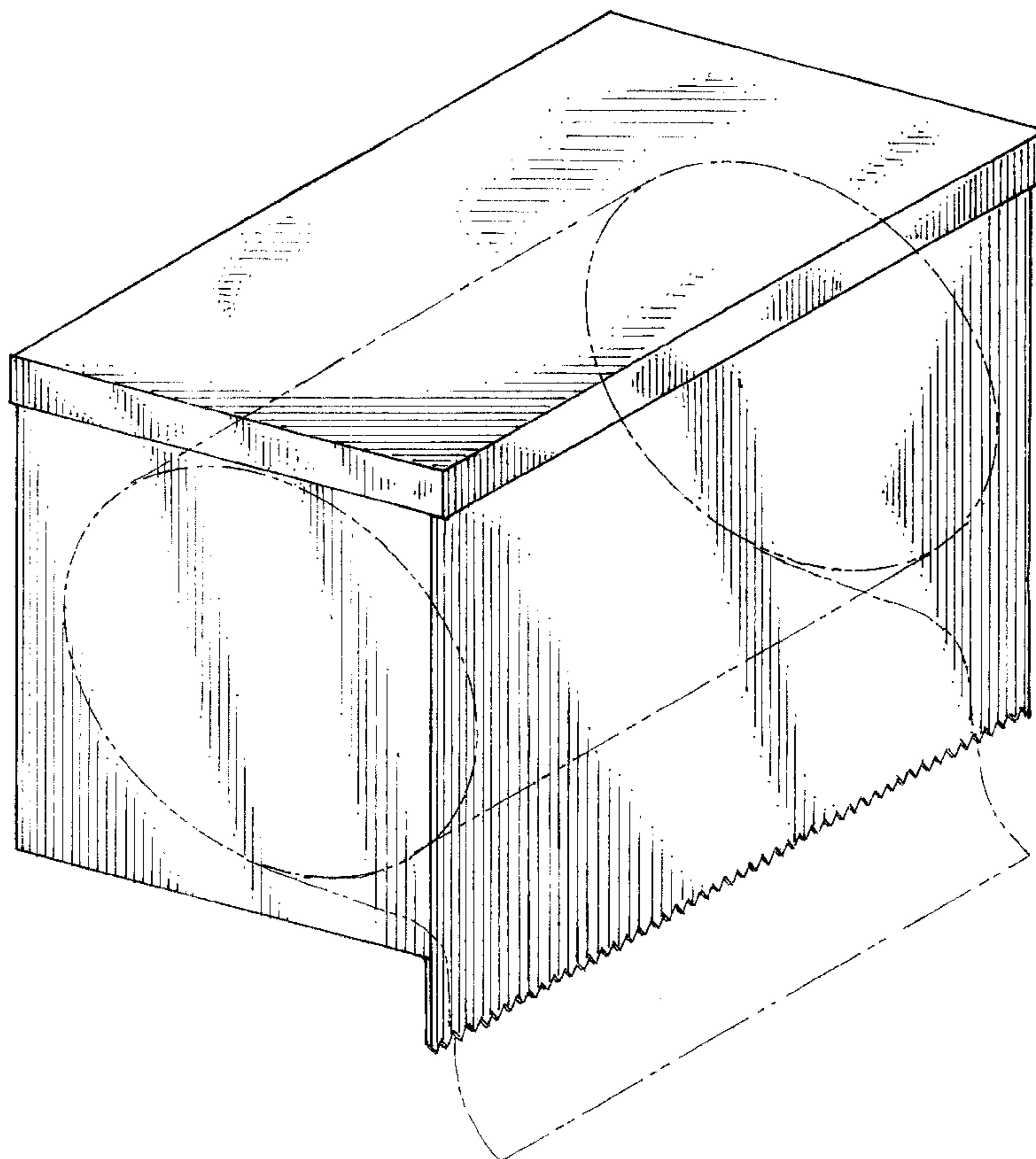

FIG. 1 is a top plan view of a universal paper towel dispenser showing my new design;
FIG. 2 is front view thereof;

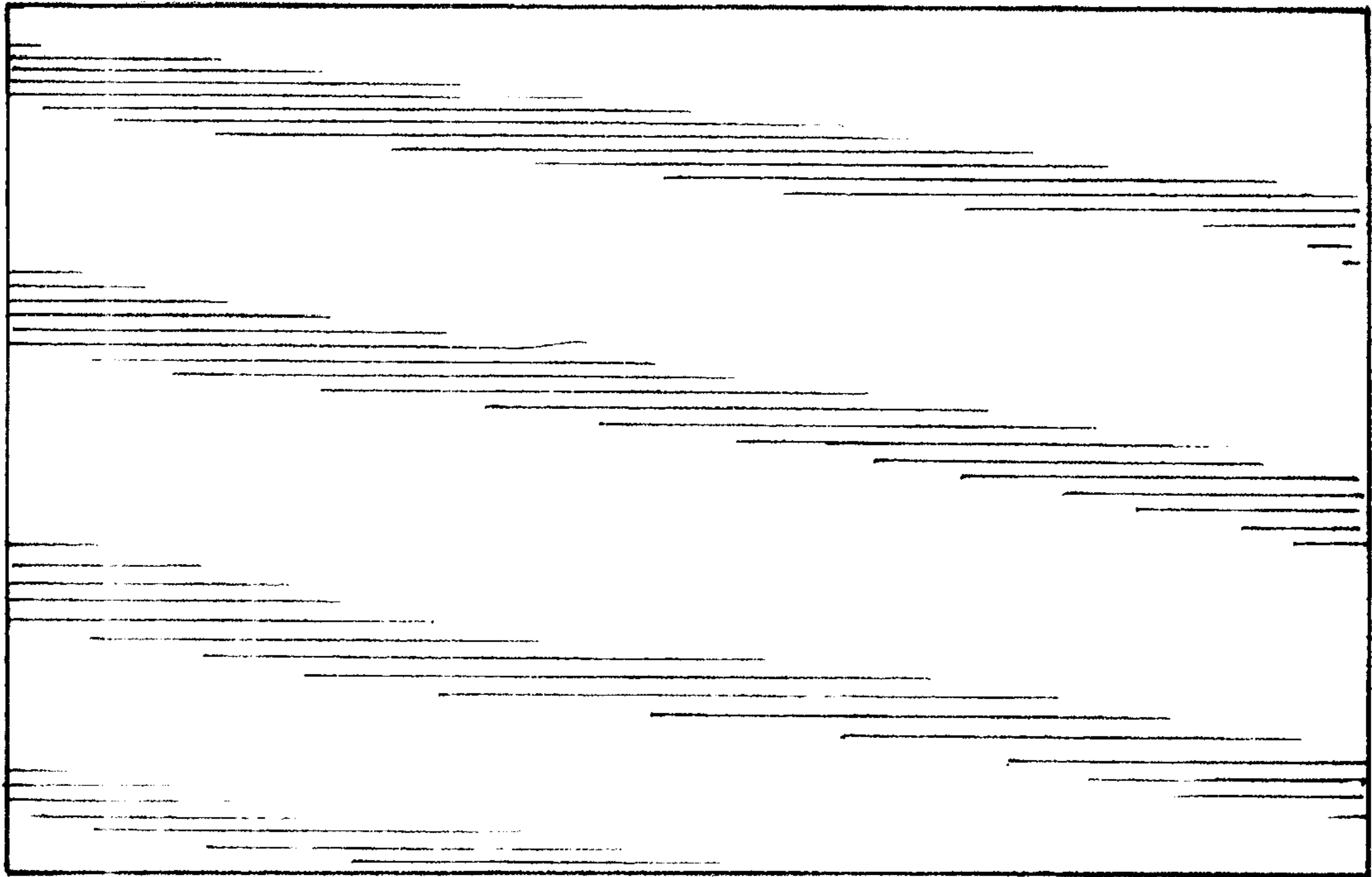

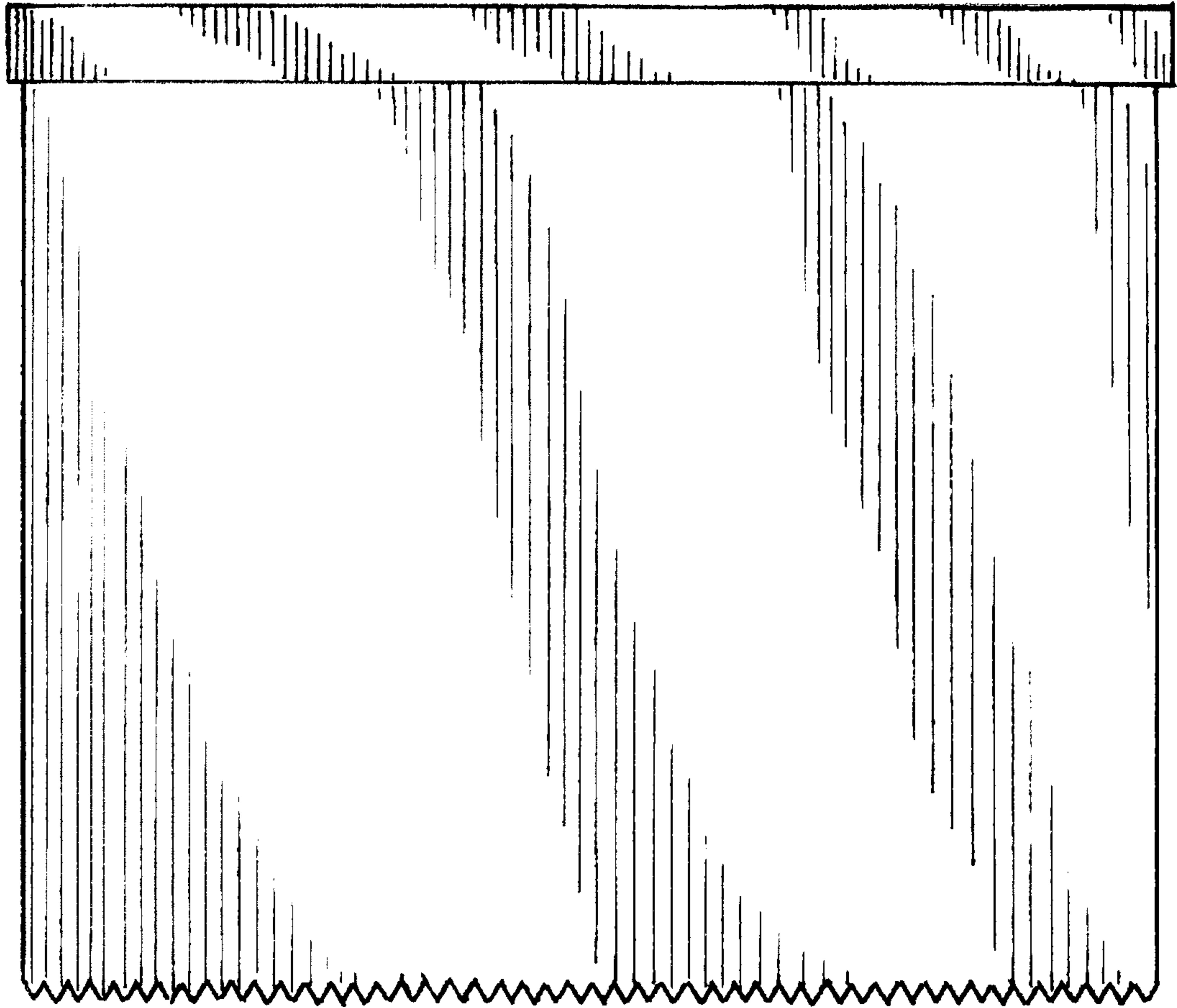

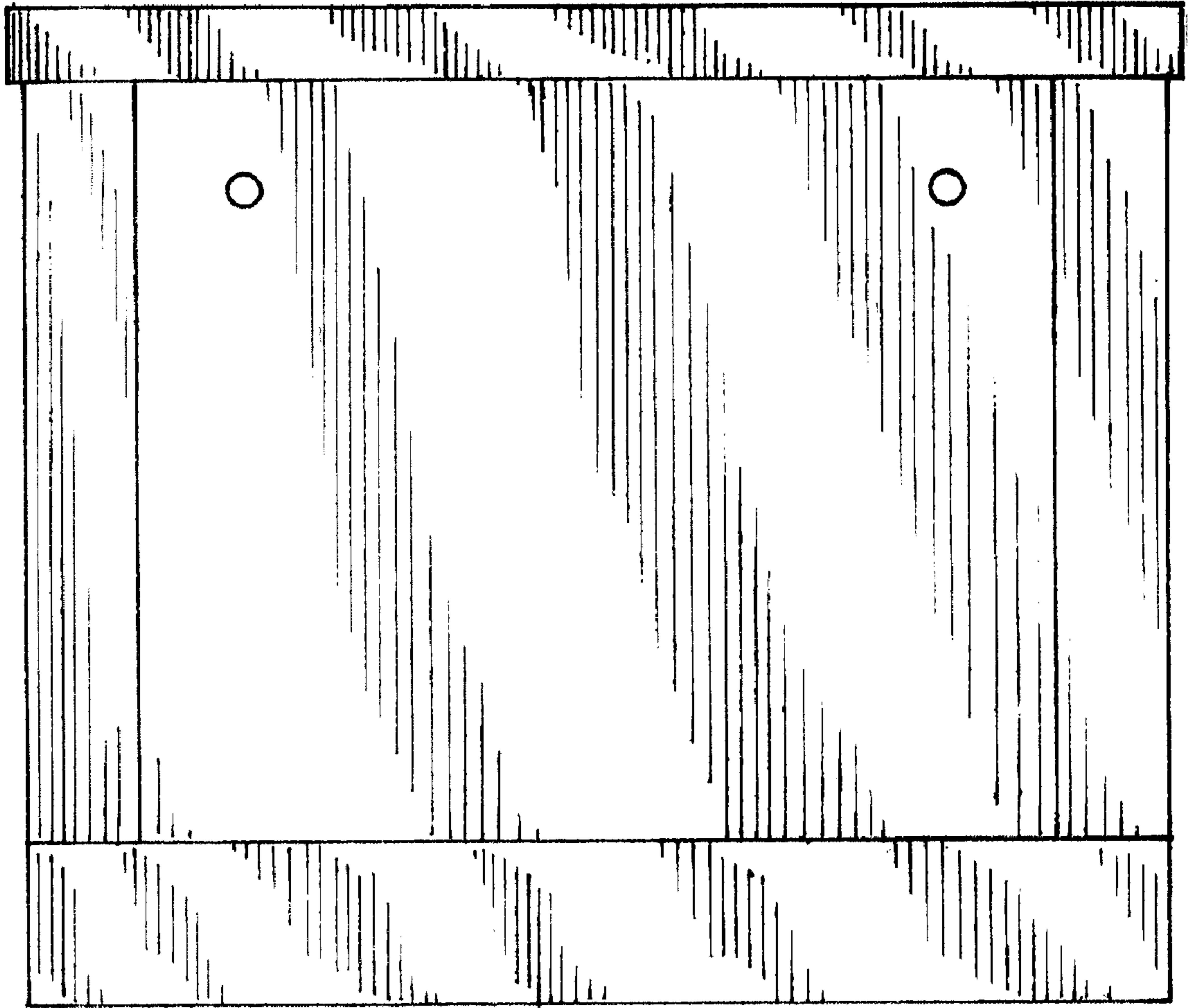

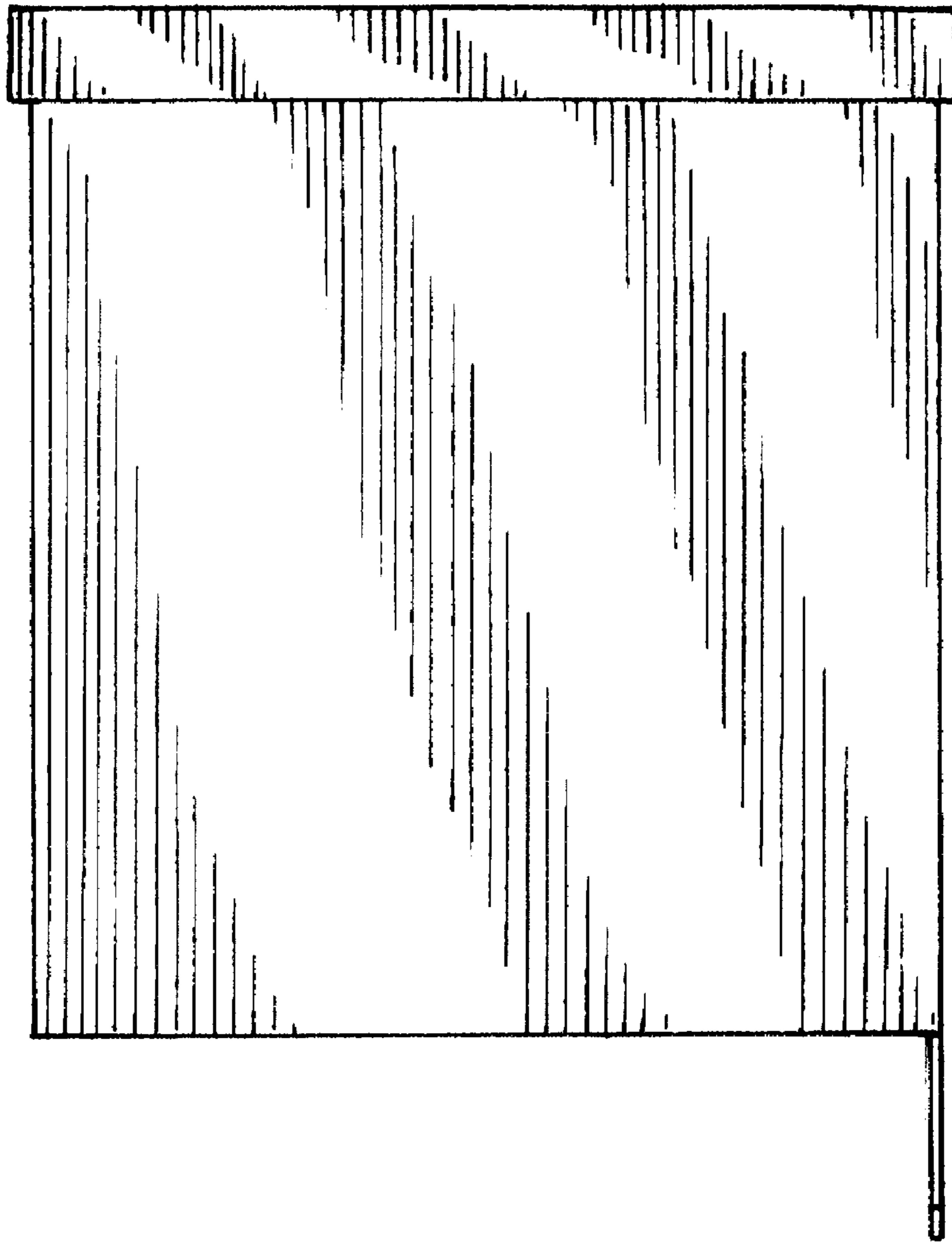

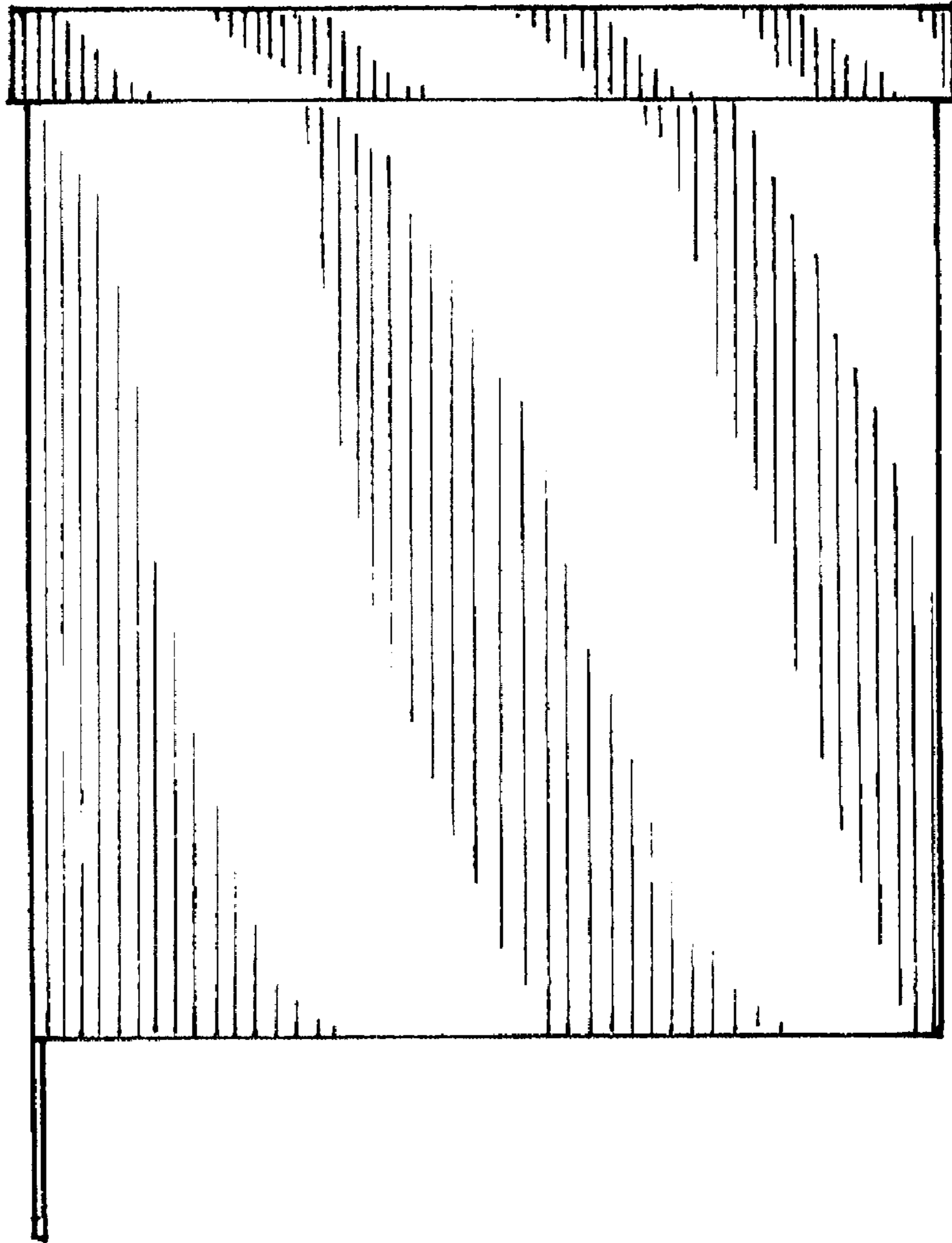

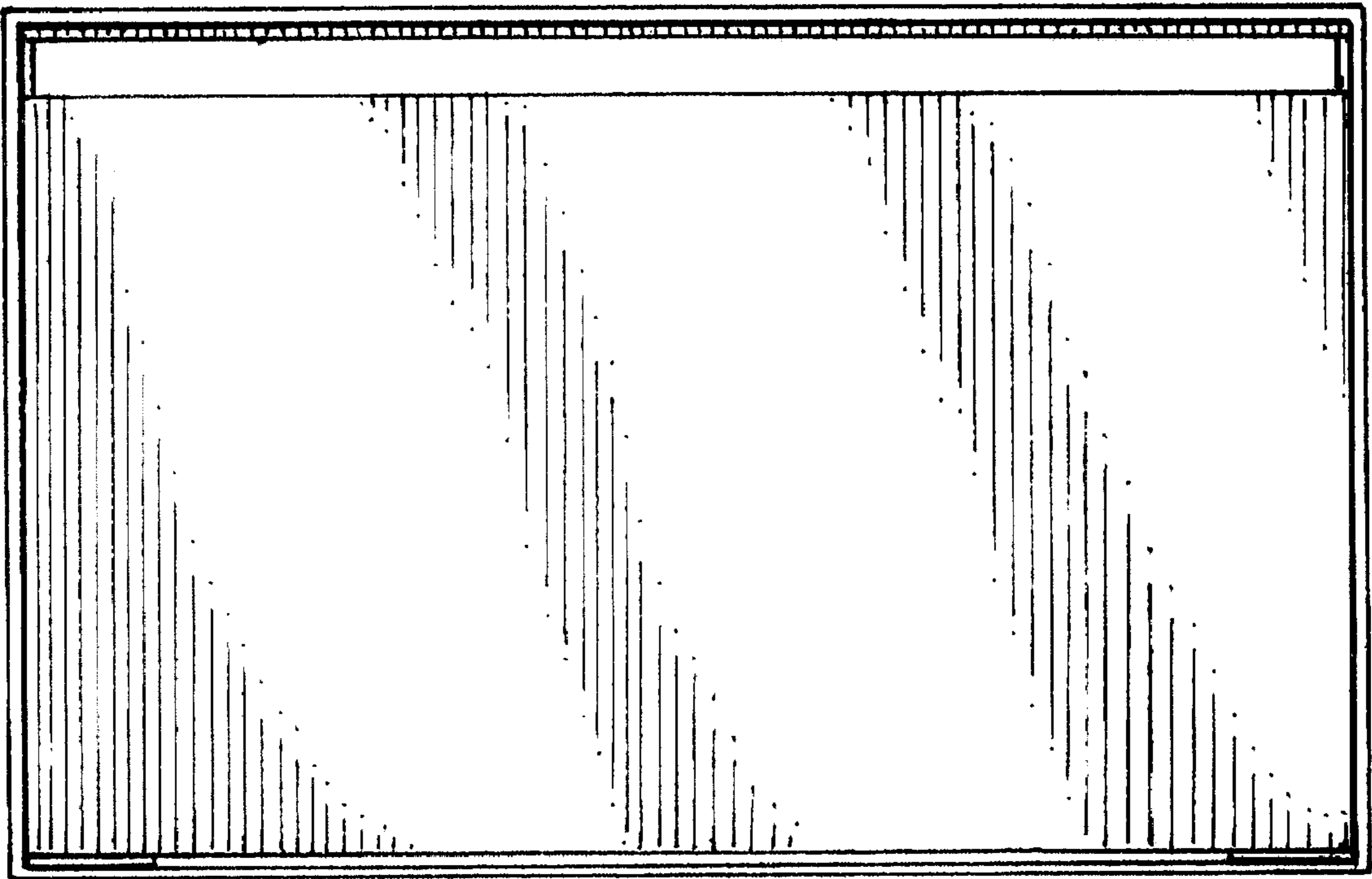

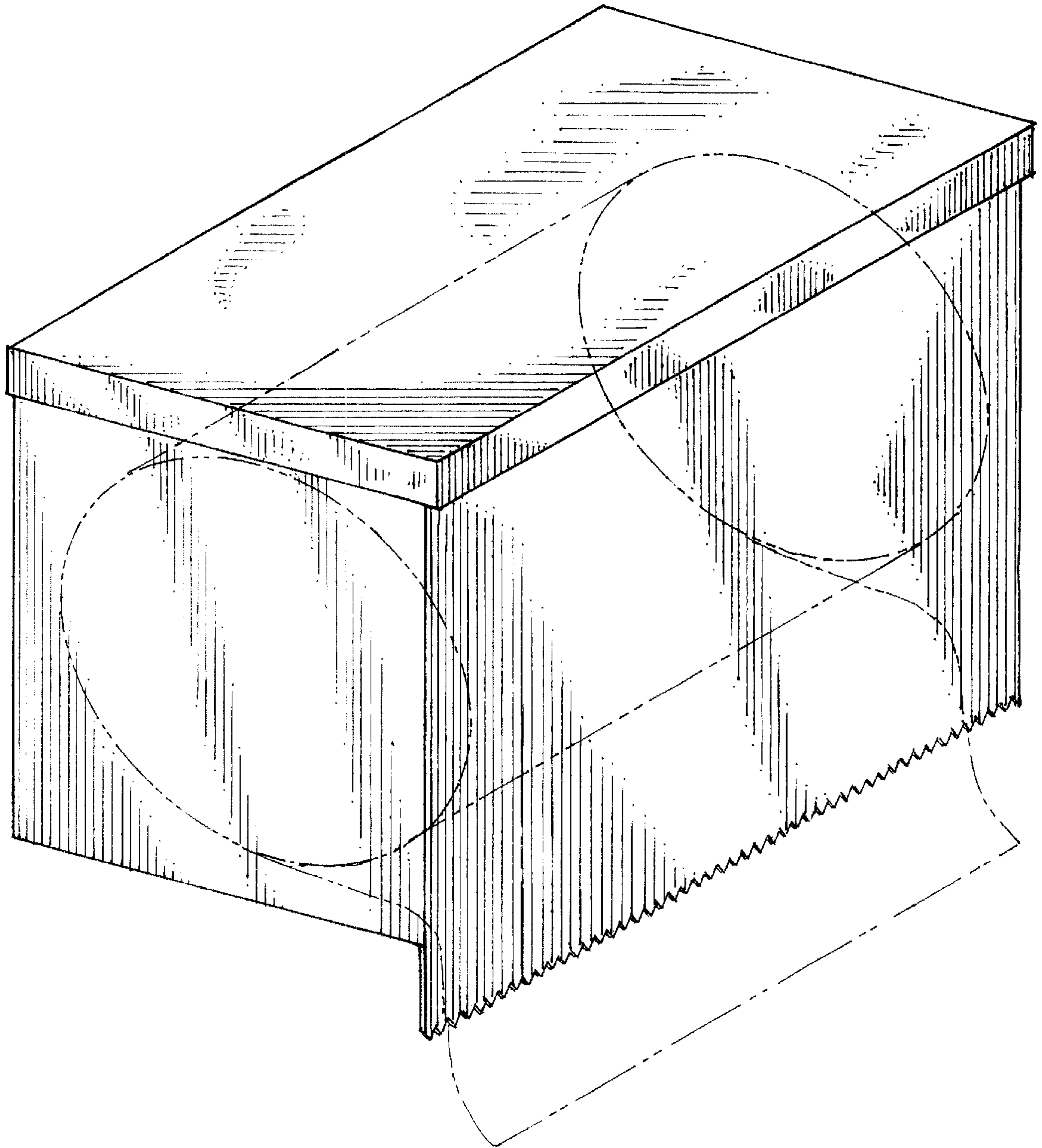
