The ornamental design for a video cassette storage container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a video cassette storage container showing our new design;

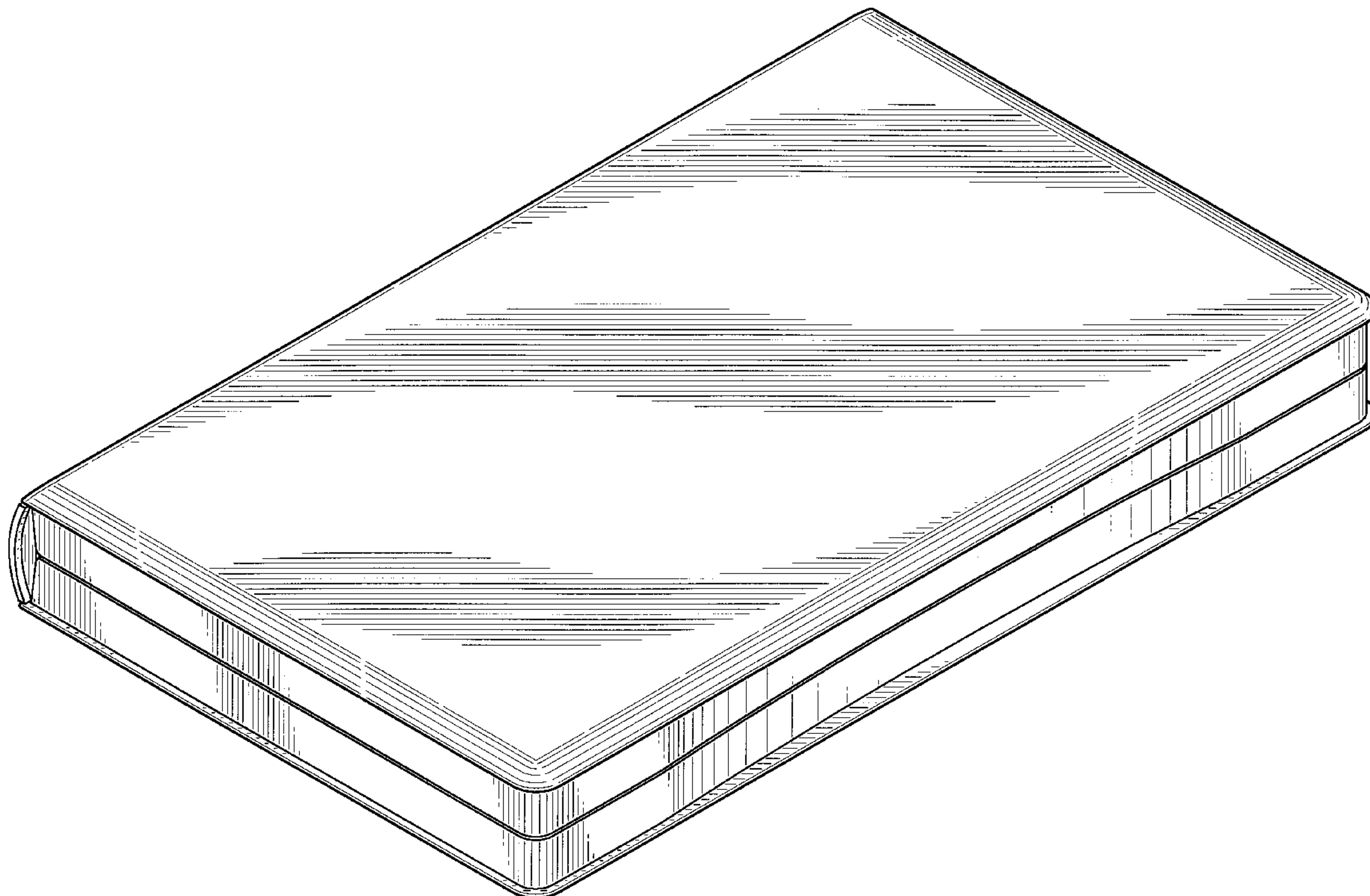
FIG. 2 is a front elevational view of the storage container of FIG. 1;

FIG. 3 is a top plan view of FIG. 2 with the bottom plan view being a mirror image thereof;

FIG. 4 is a rear elevational view of FIG. 2; and,

FIG. 5 is a left side elevational view of FIG. 3, the right side being a mirror image thereof.

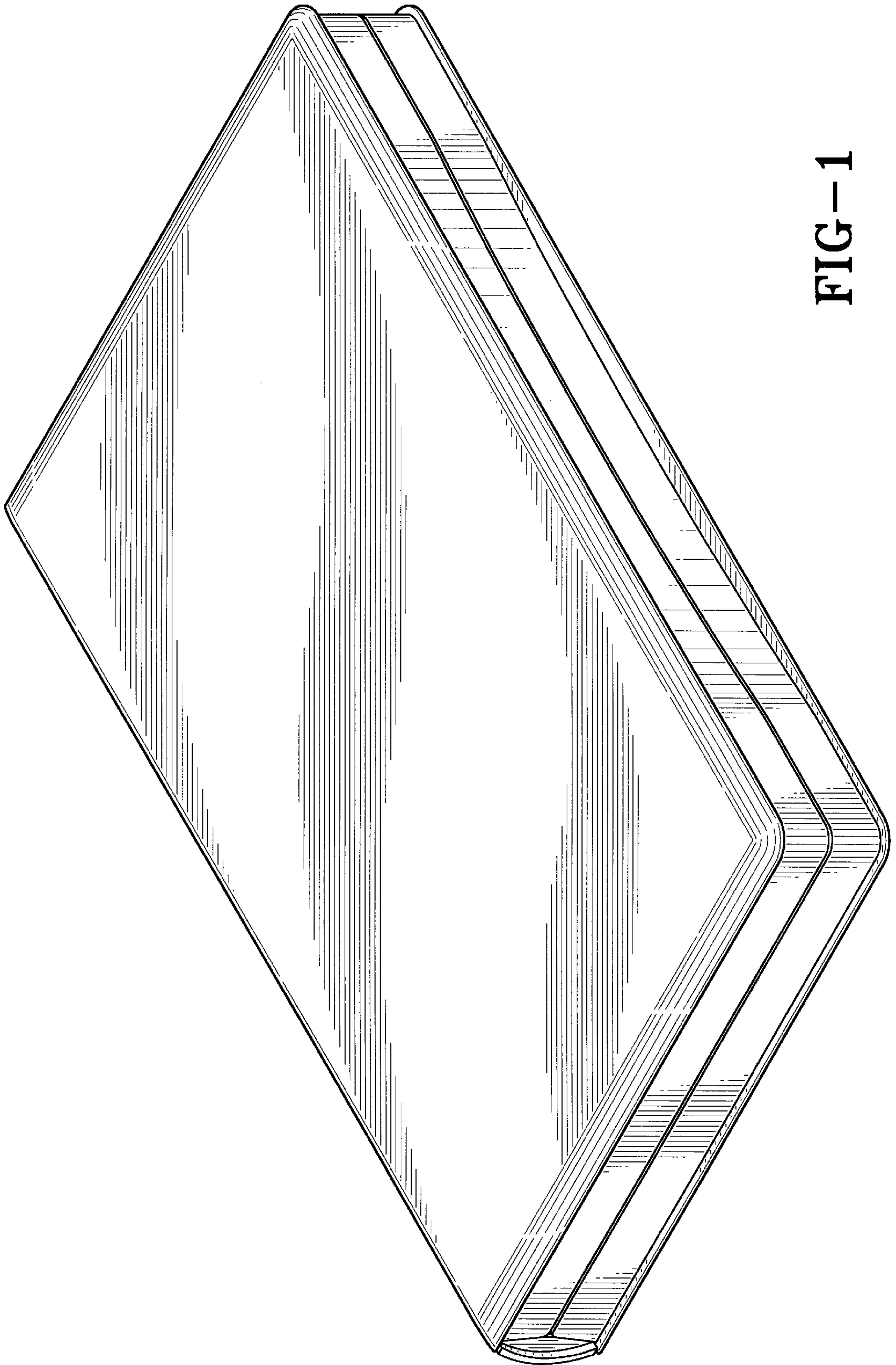

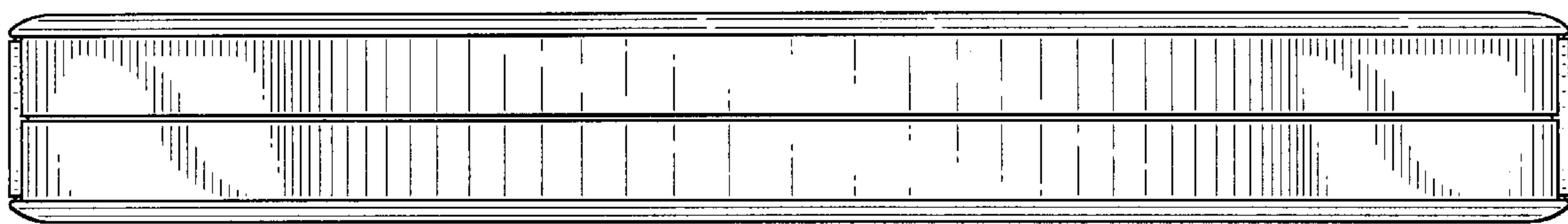

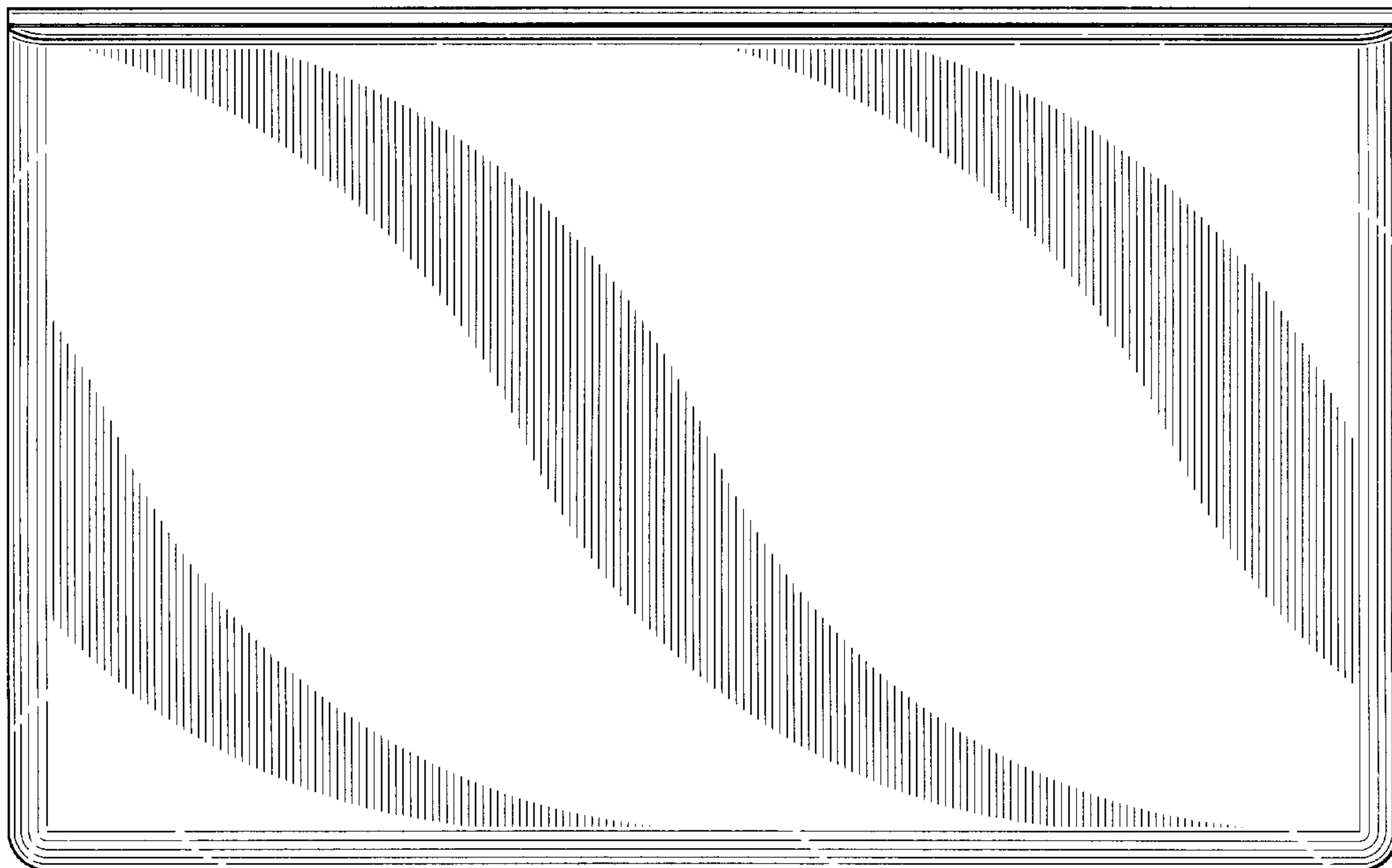

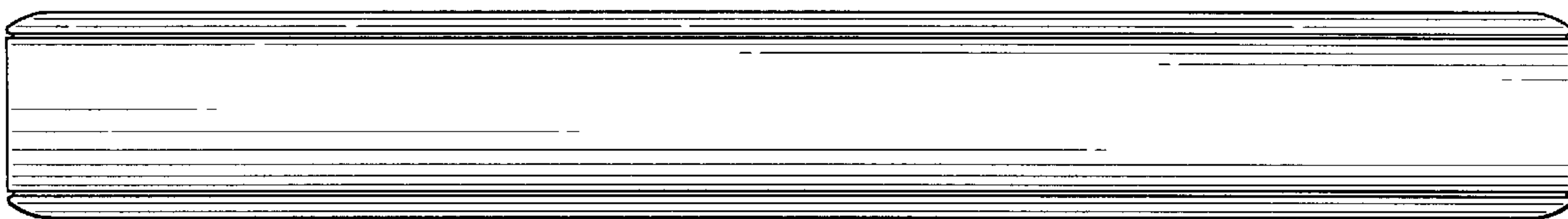

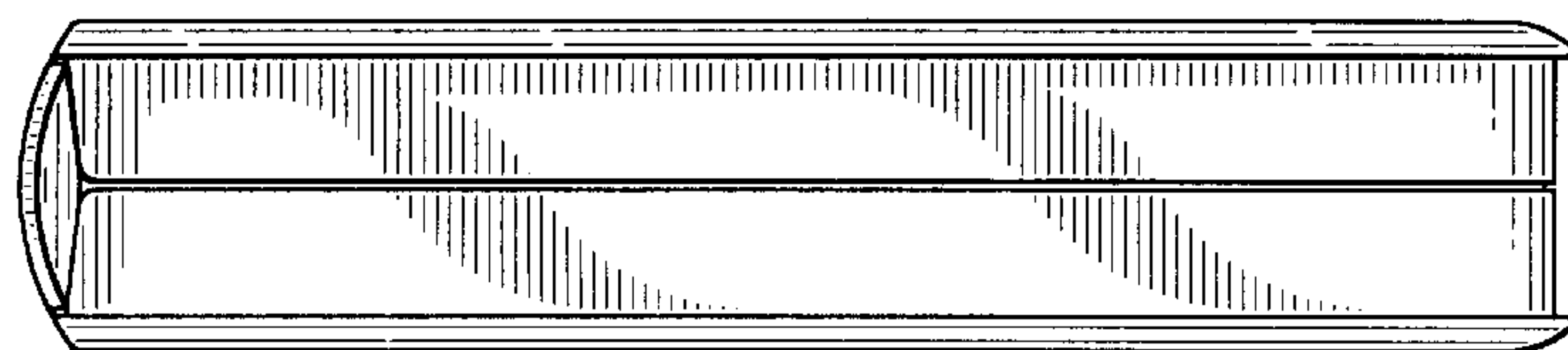
