(57) **CLAIM**

The ornamental design for a tumbler, as shown and described.

DESCRIPTION

- FIG. 1 is a top front perspective view of a tumbler showing our new design.
- FIG. 2 is a front elevational view of the design, the rear elevational view being a mirror image thereof.
- FIG. 3 is a right side elevational view of the design.
- FIG. 4 is a left side elevational view of the design.
- FIG. 5 is a top plan view of the design.
- FIG. 6 is a bottom plan view of the design.
- FIG. 7 is a top front perspective view of a second embodiment of the design without a handle.
- FIG. 8 is a side elevational view of the second embodiment of the design, all side views being identical.
- FIG. 9 is a top plan view of the second embodiment of the design; and,
- FIG. 10 is a bottom plan view of the second embodiment of the design.

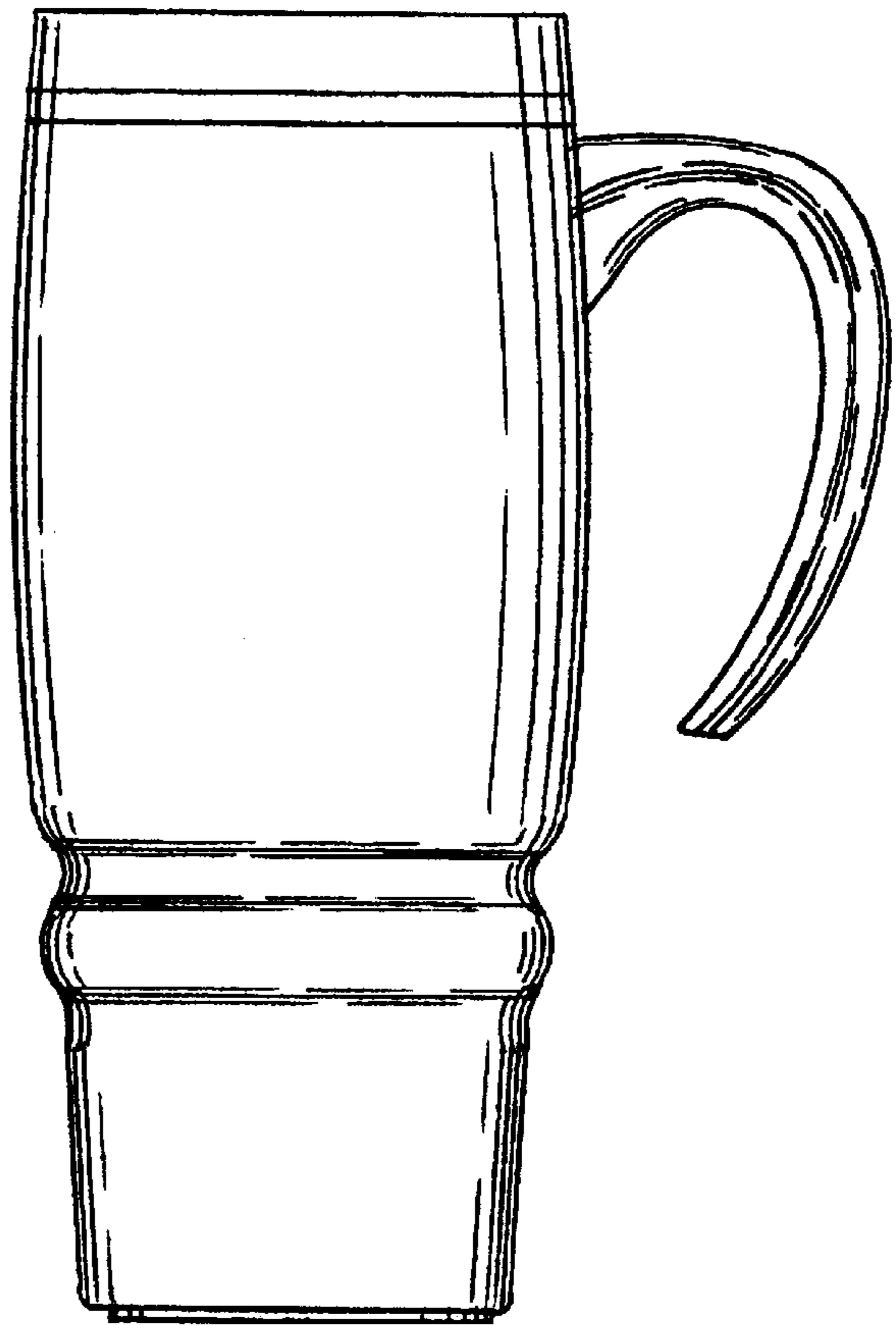

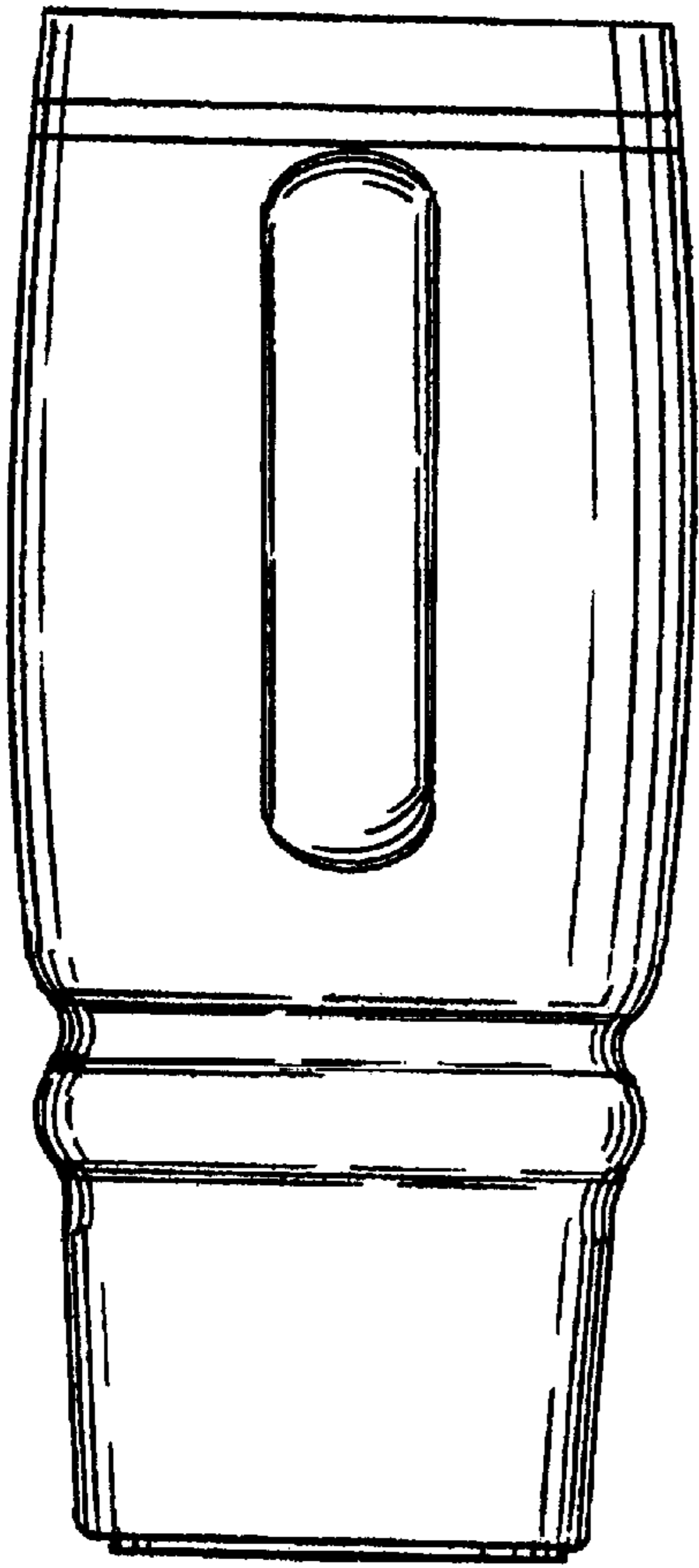

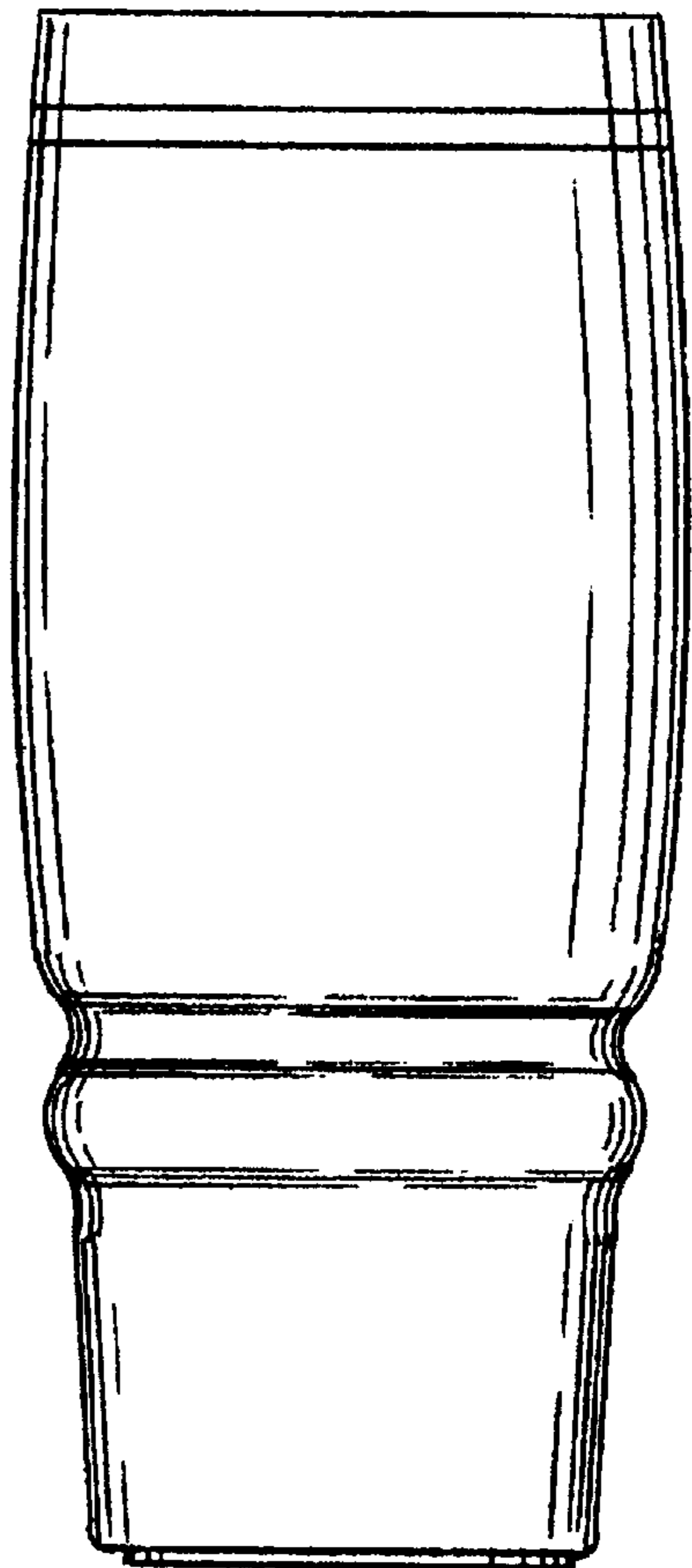

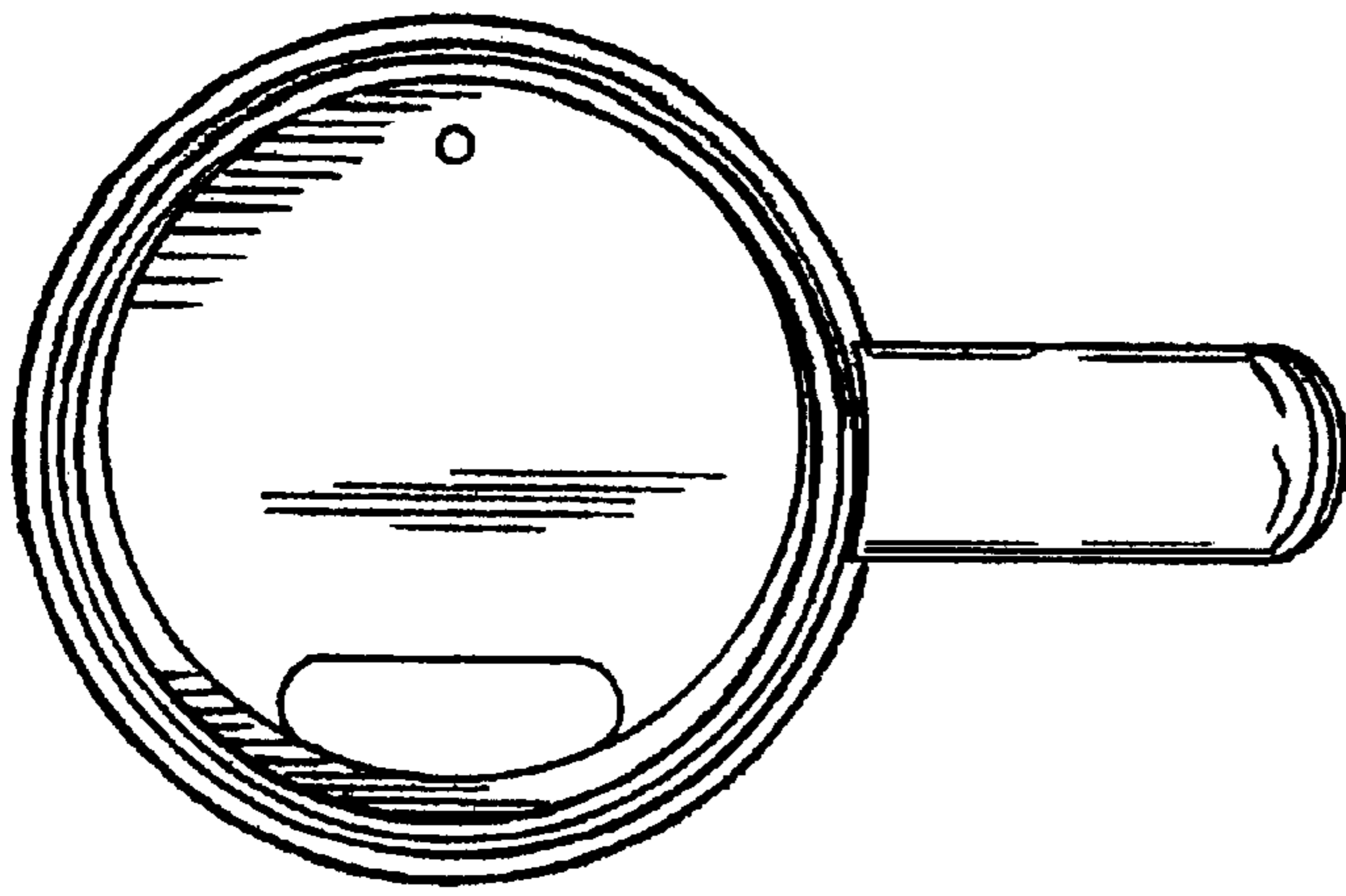

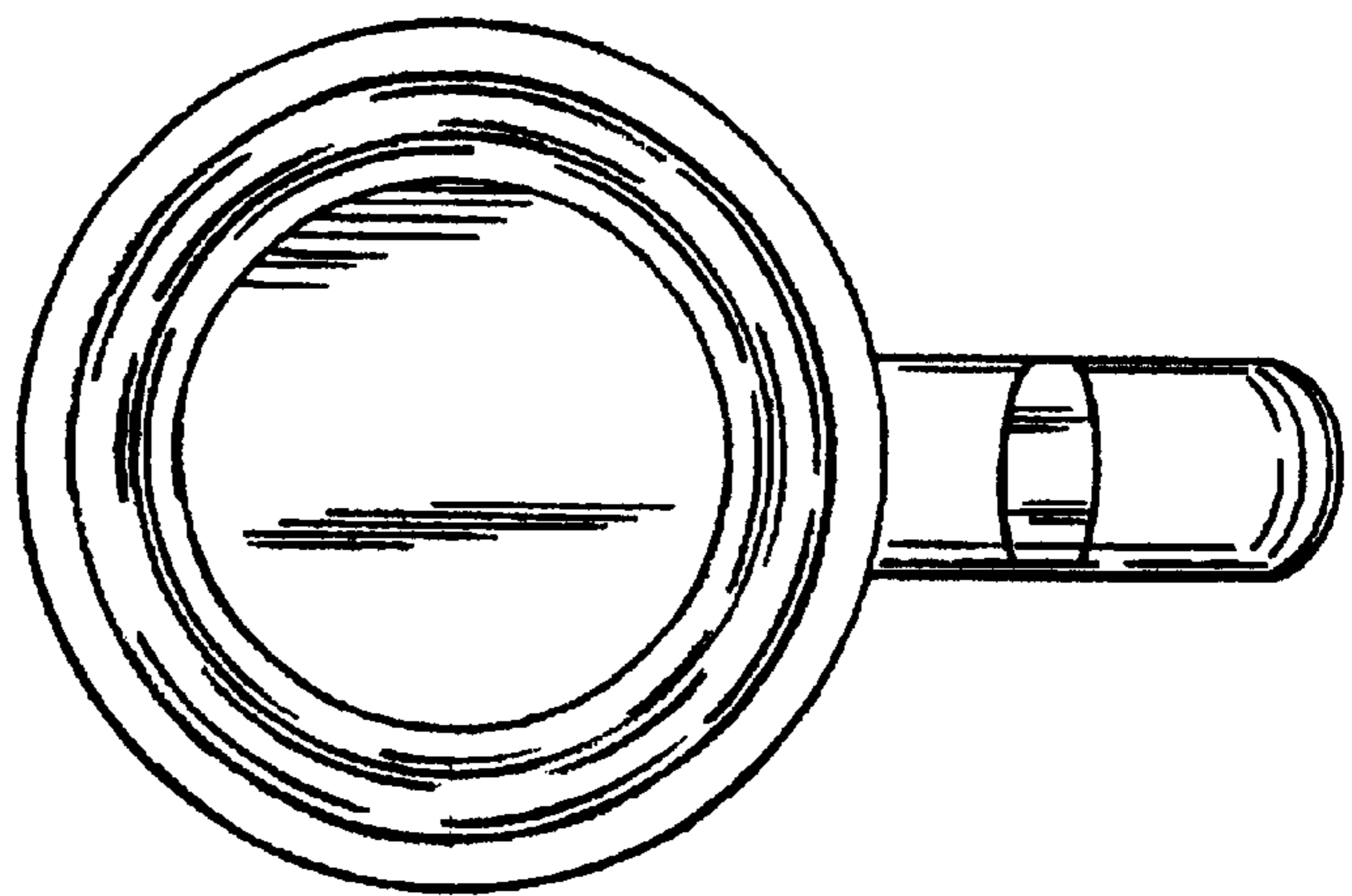

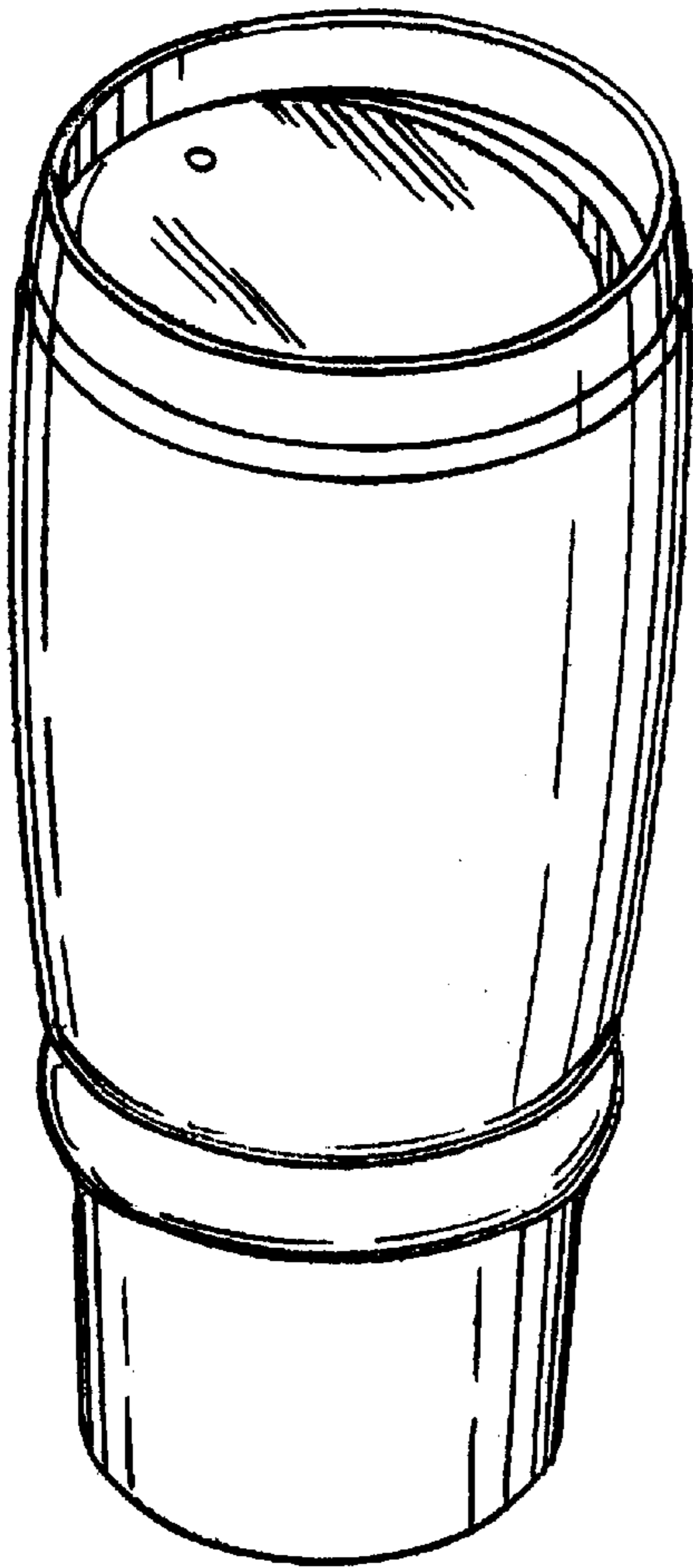

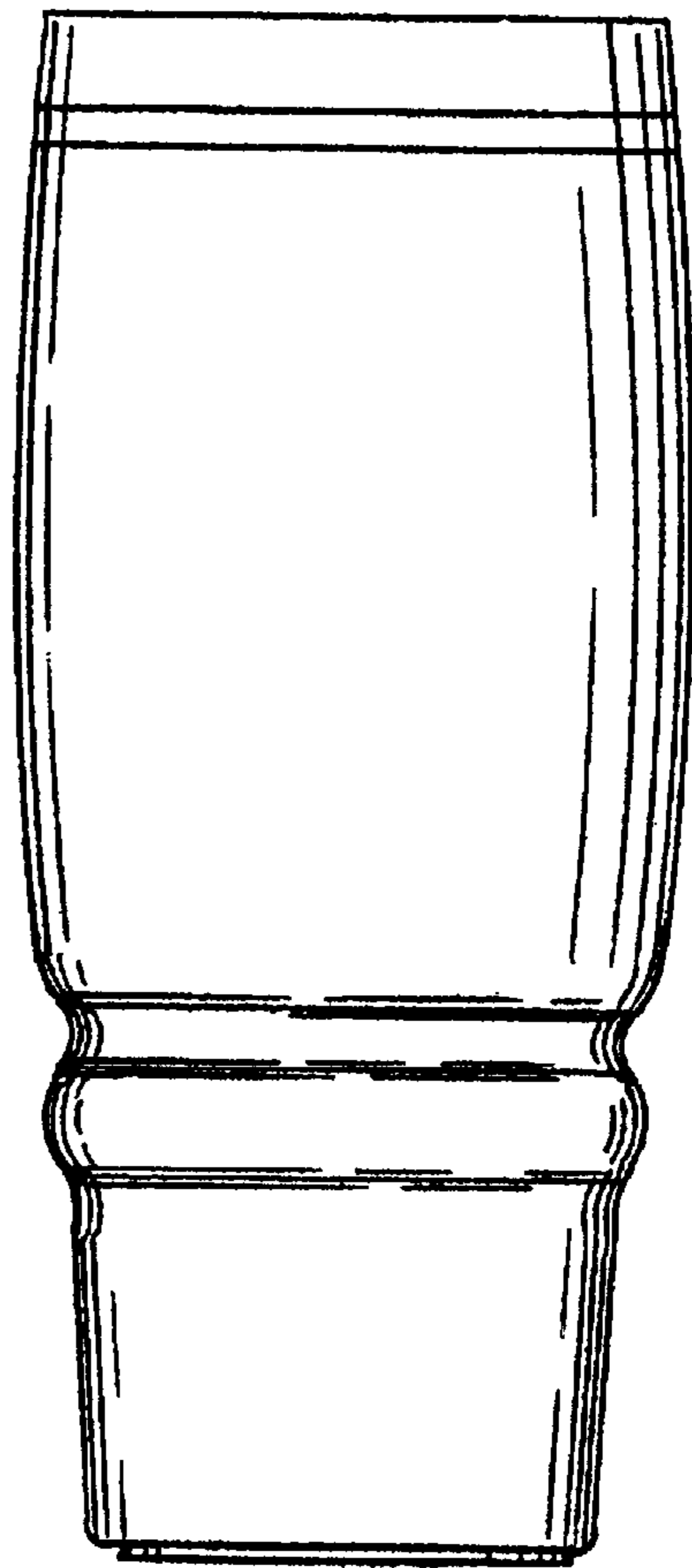

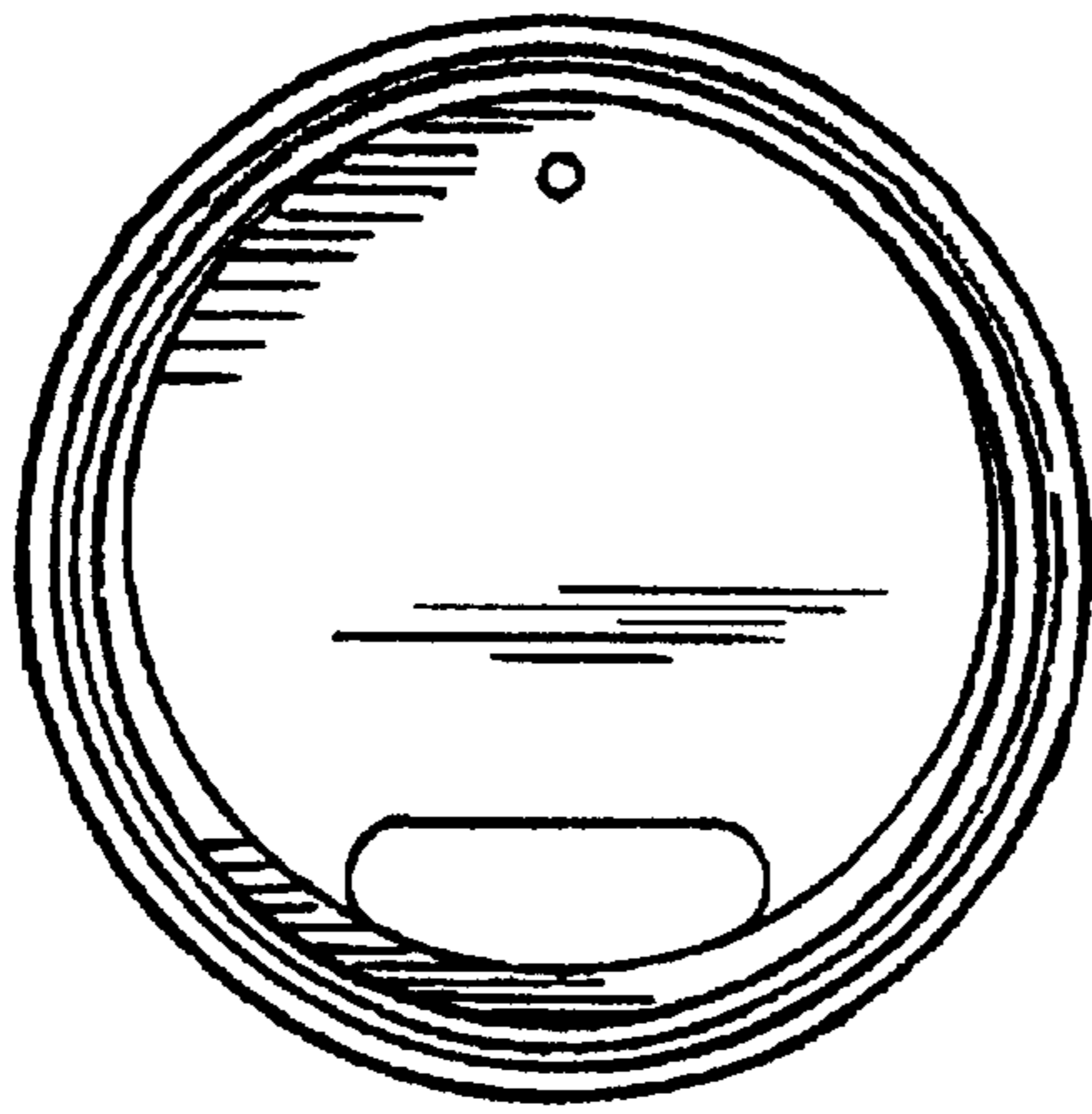

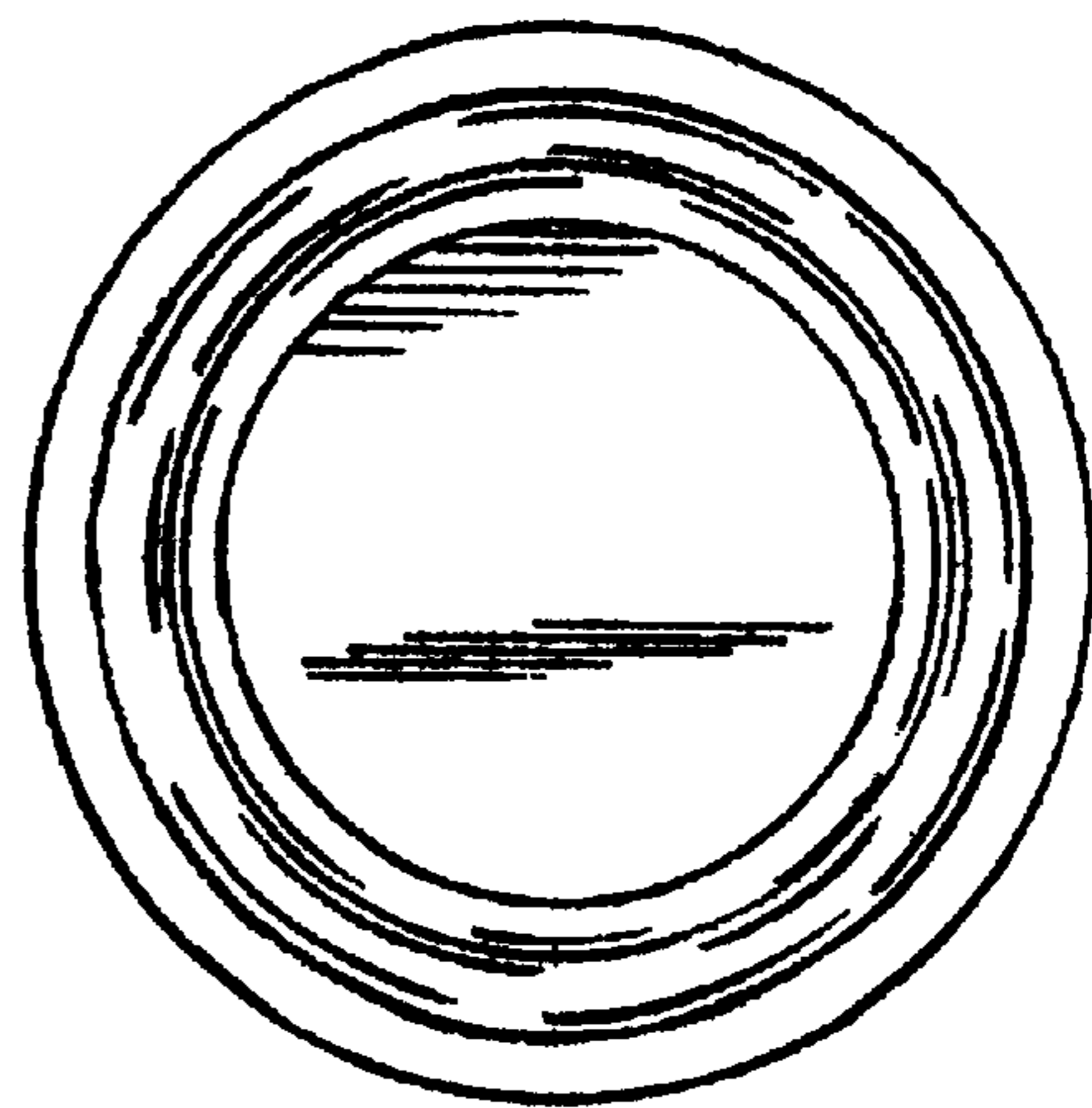
