DESCRIPTION

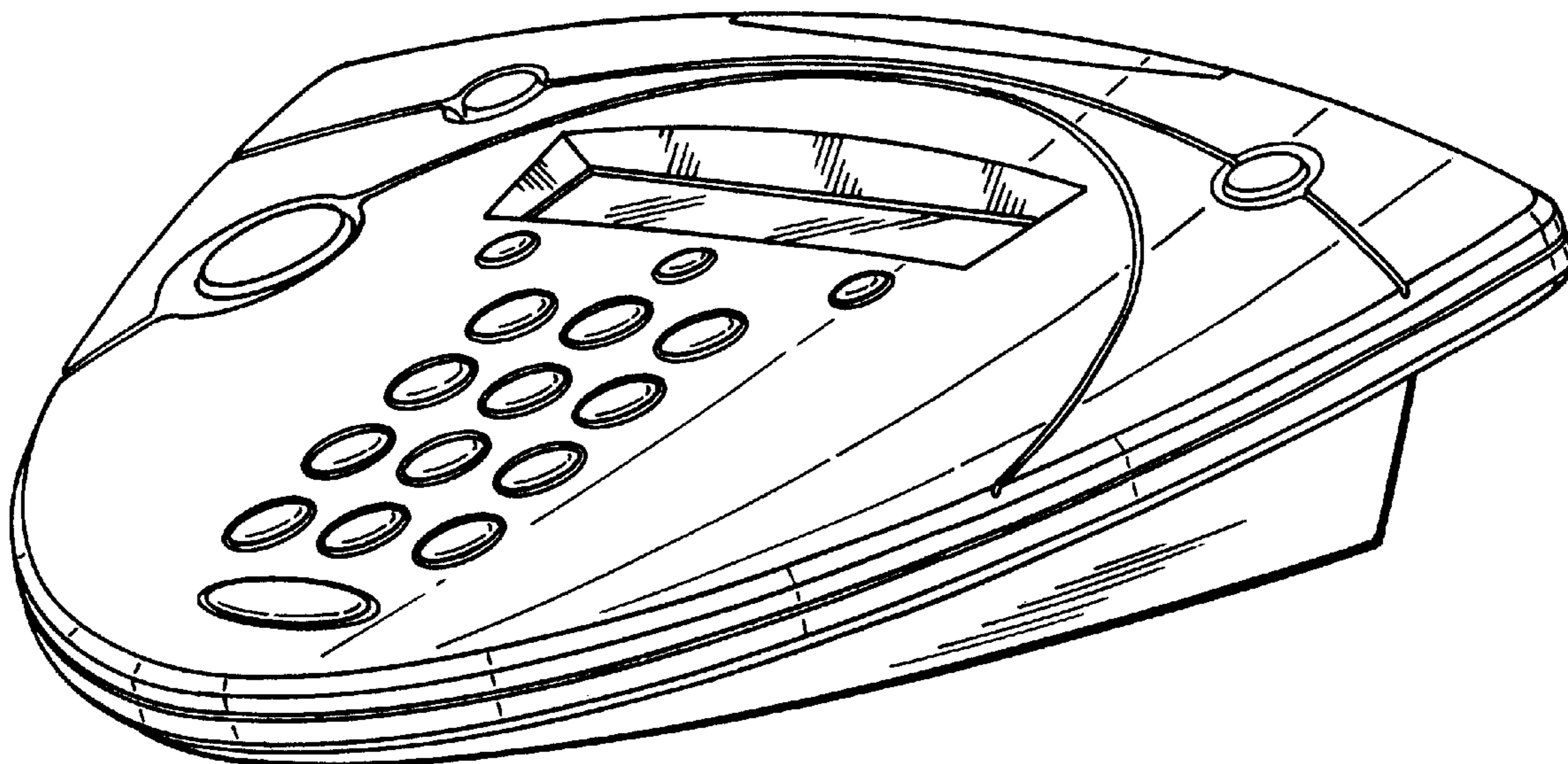
FIG. 1 is a perspective view of the telephone according to my design;

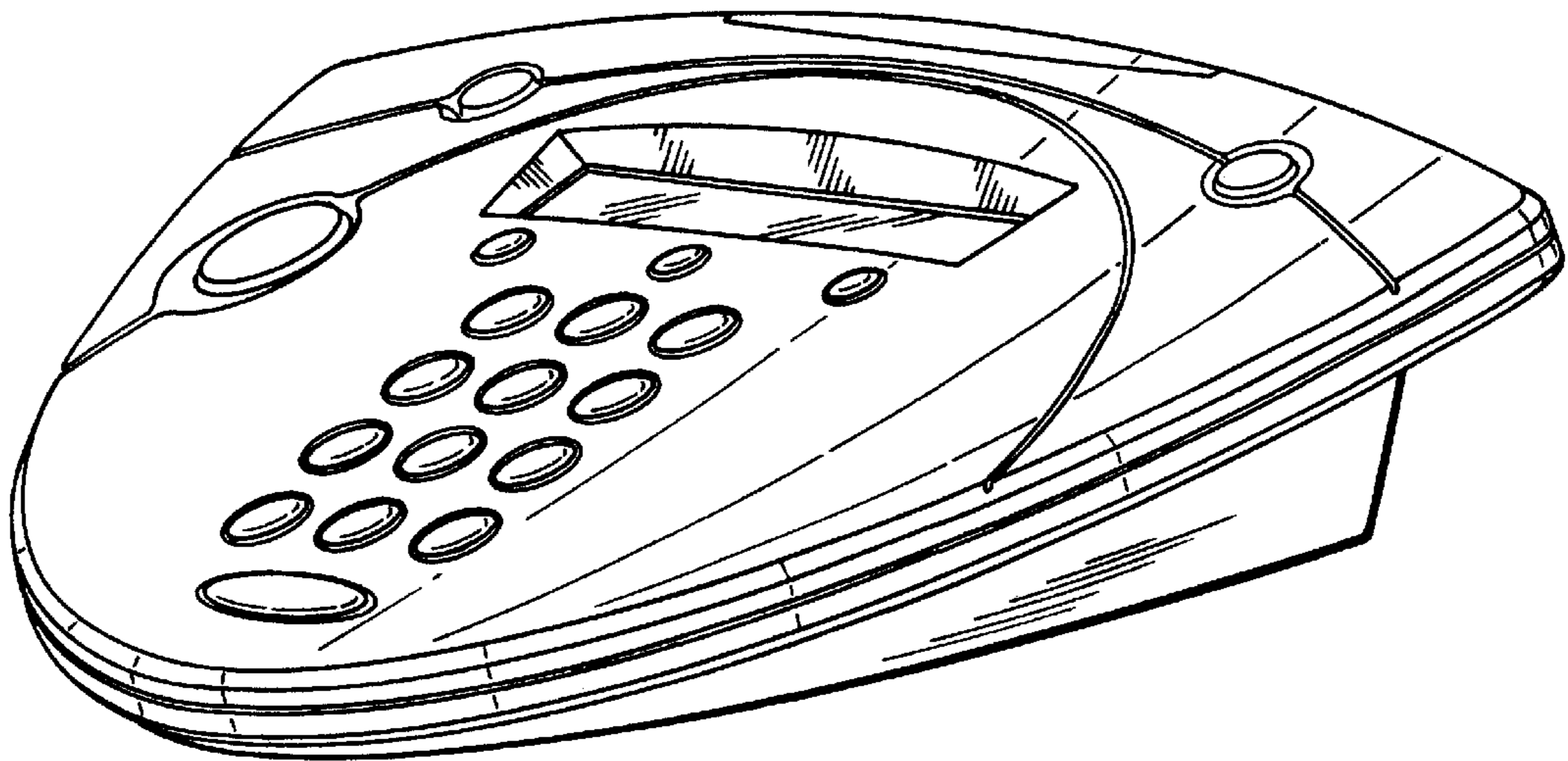

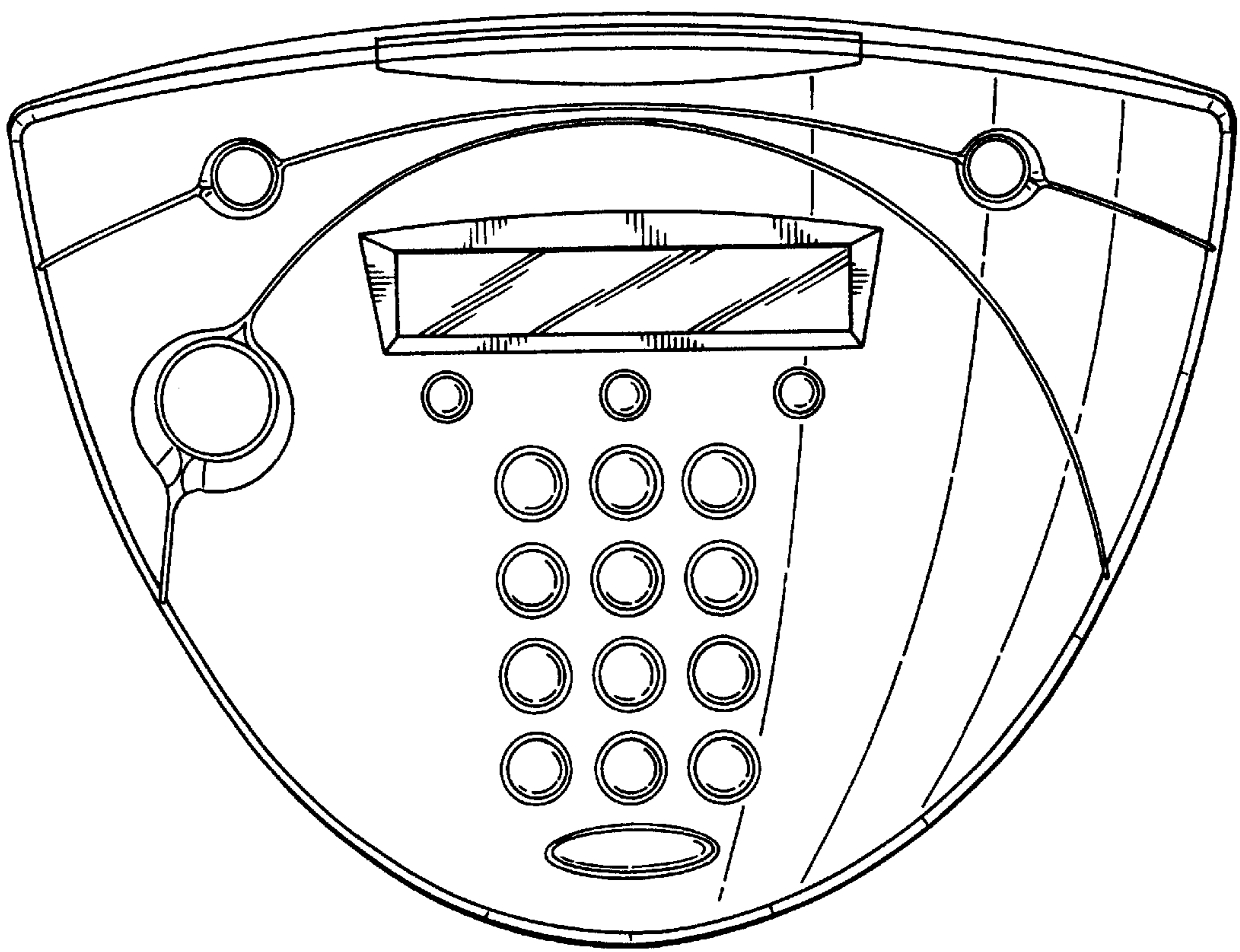

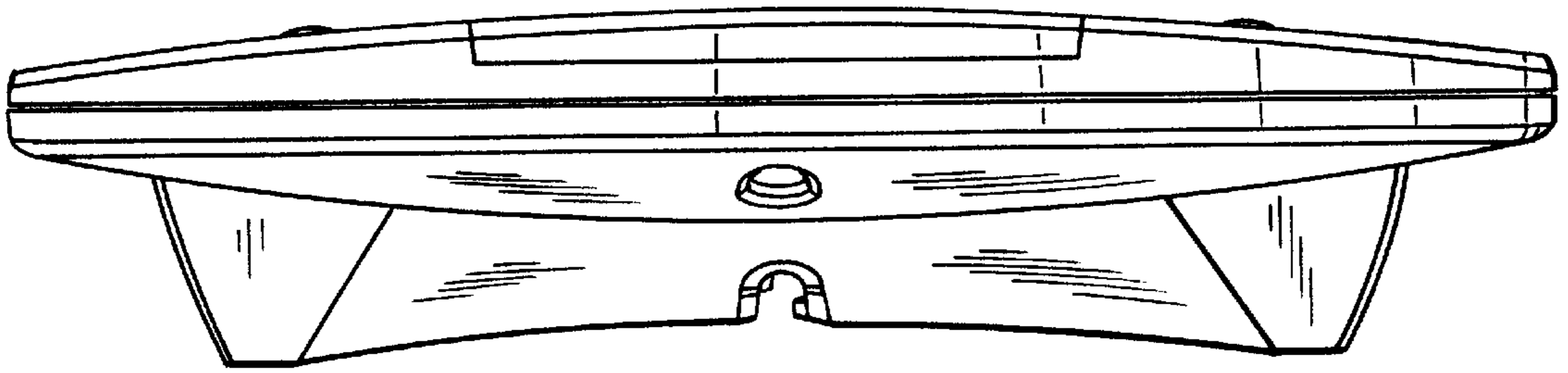

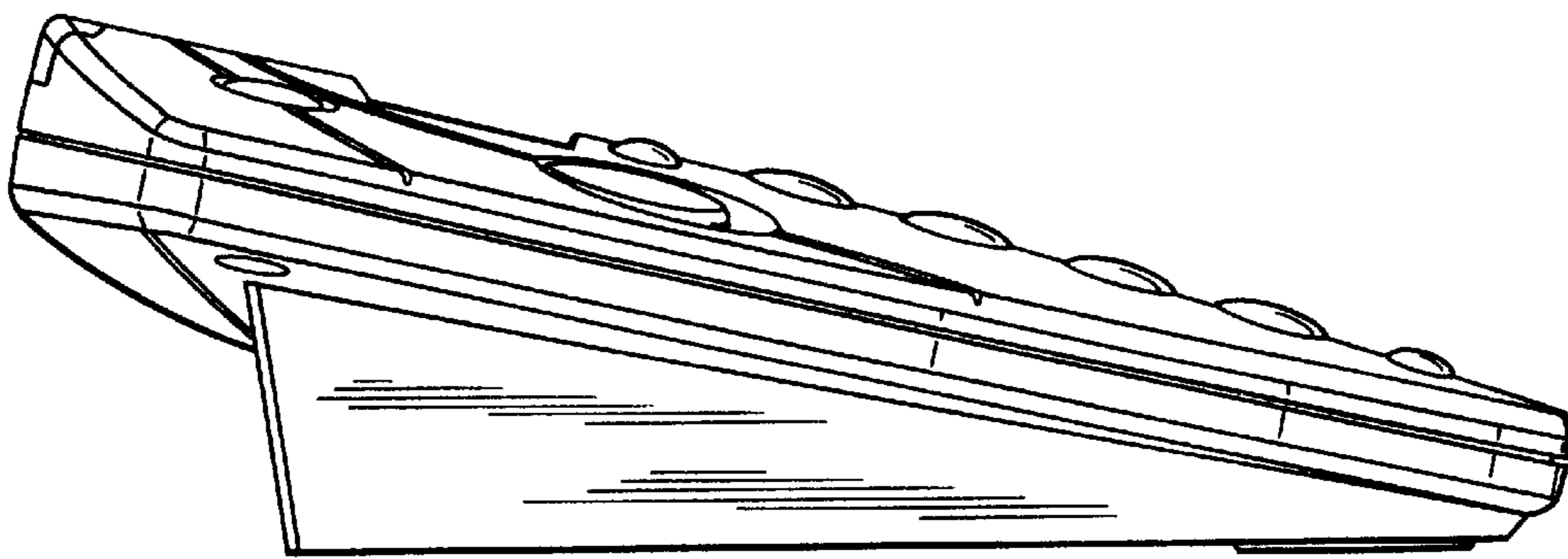
