The ornamental design for a footwear, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of the footwear in a first embodiment;
 FIG. 2 is a bottom plan view of the footwear of FIG. 1;
 FIG. 3 is a perspective view of the footwear of FIG. 1;
 FIG. 4 is a side sectional view of the footwear of FIG. 1;
 FIG. 5 is a perspective view of the footwear of FIG. 1 when worn by a foot; and,
 FIG. 6 is a top plan view of the footwear in a second embodiment.
 The broken lines in the Figures are for illustrative purposes only and form no part of the claimed design.

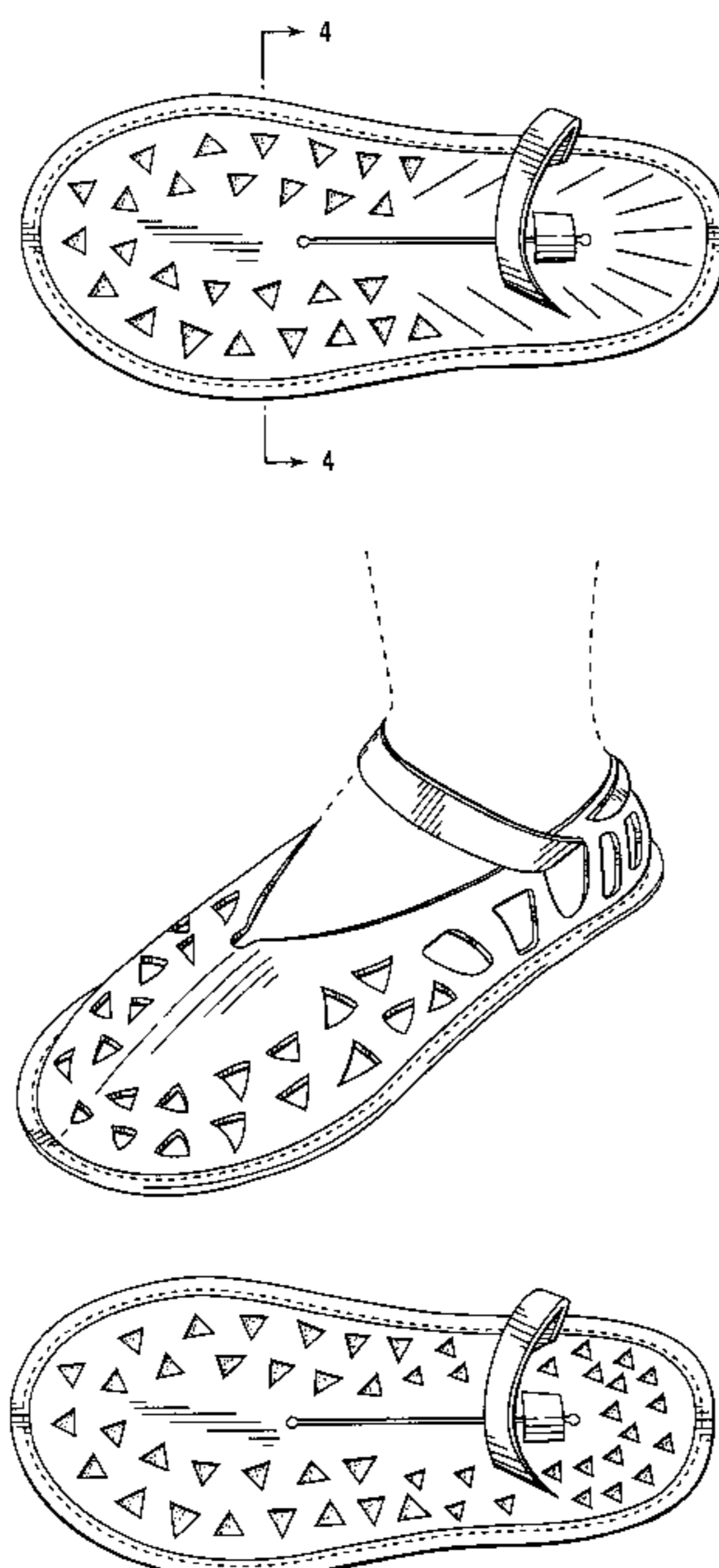

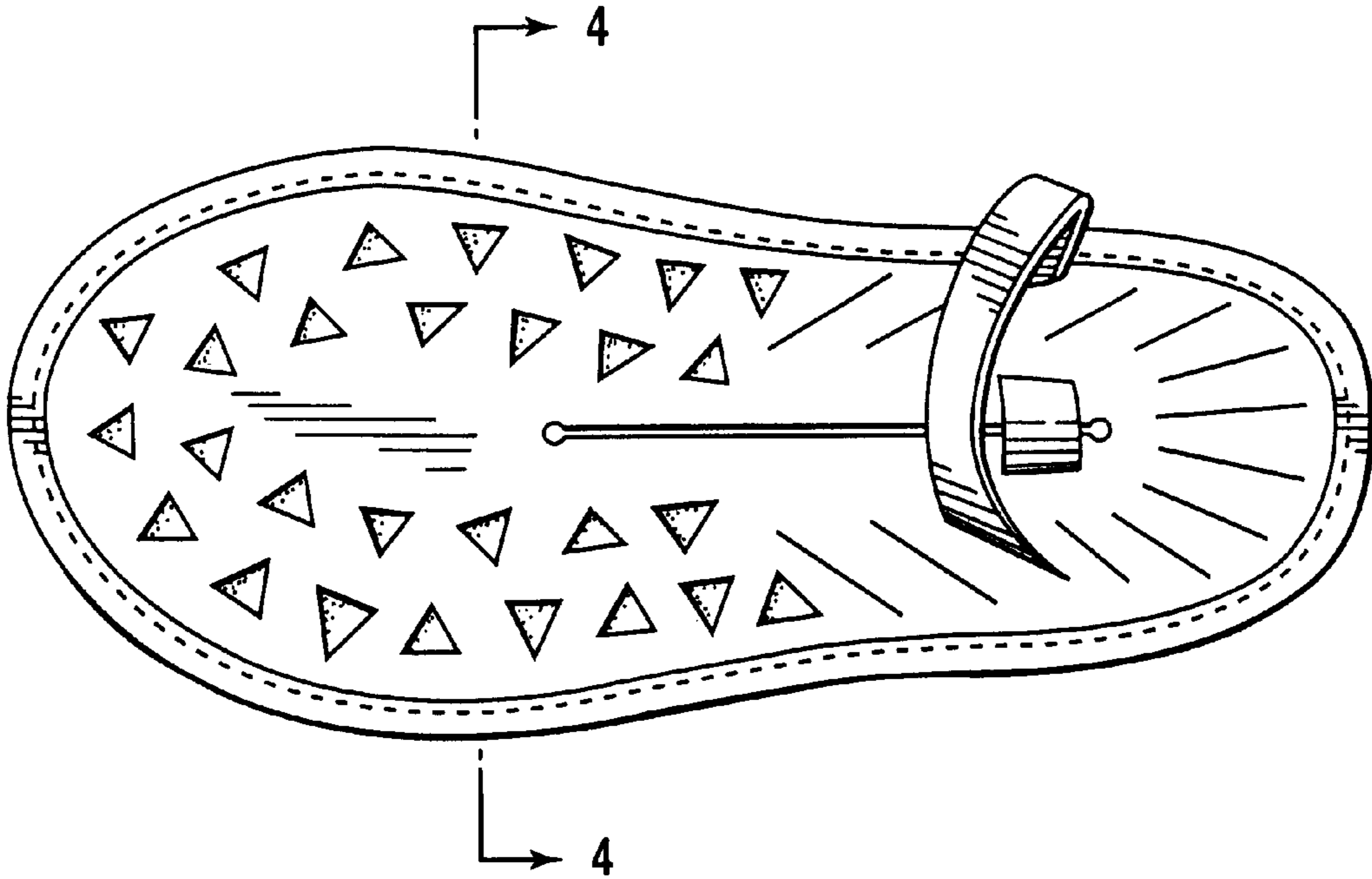

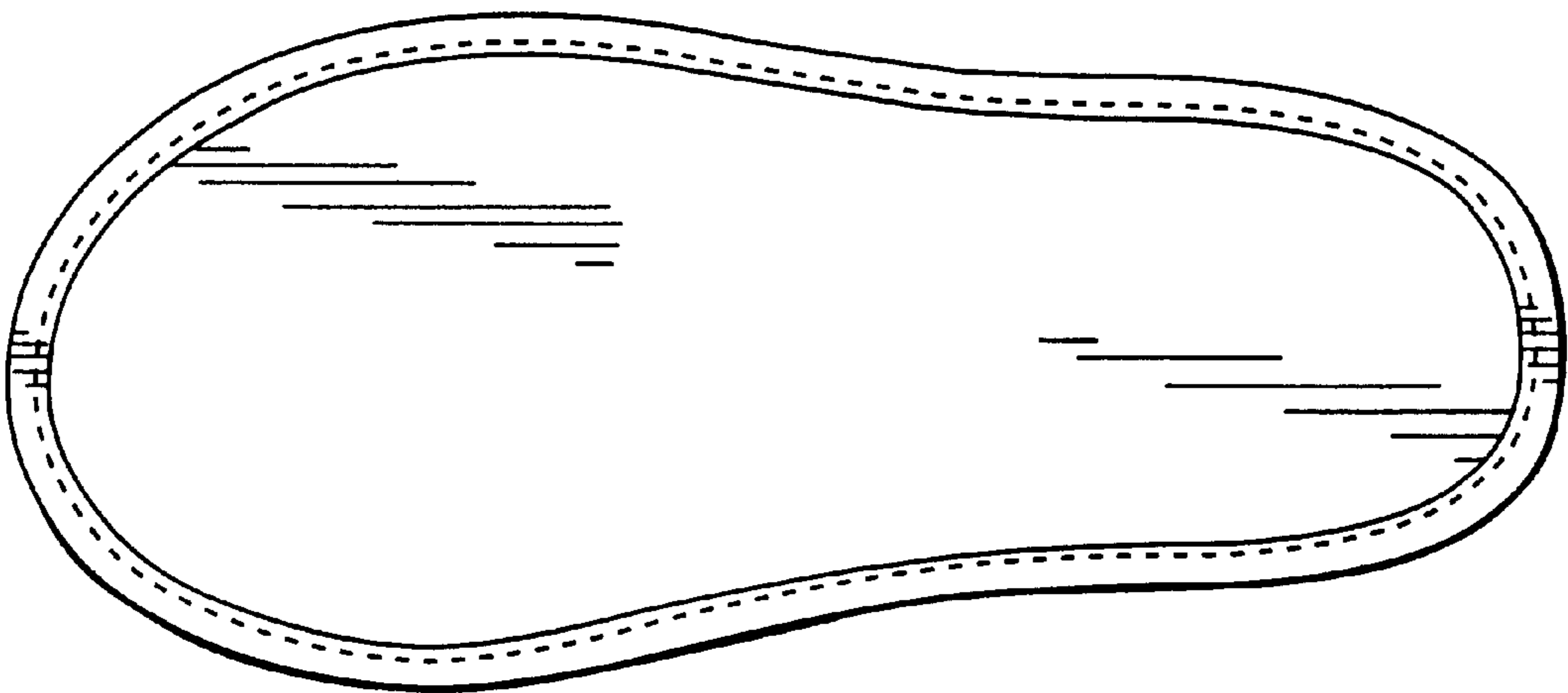

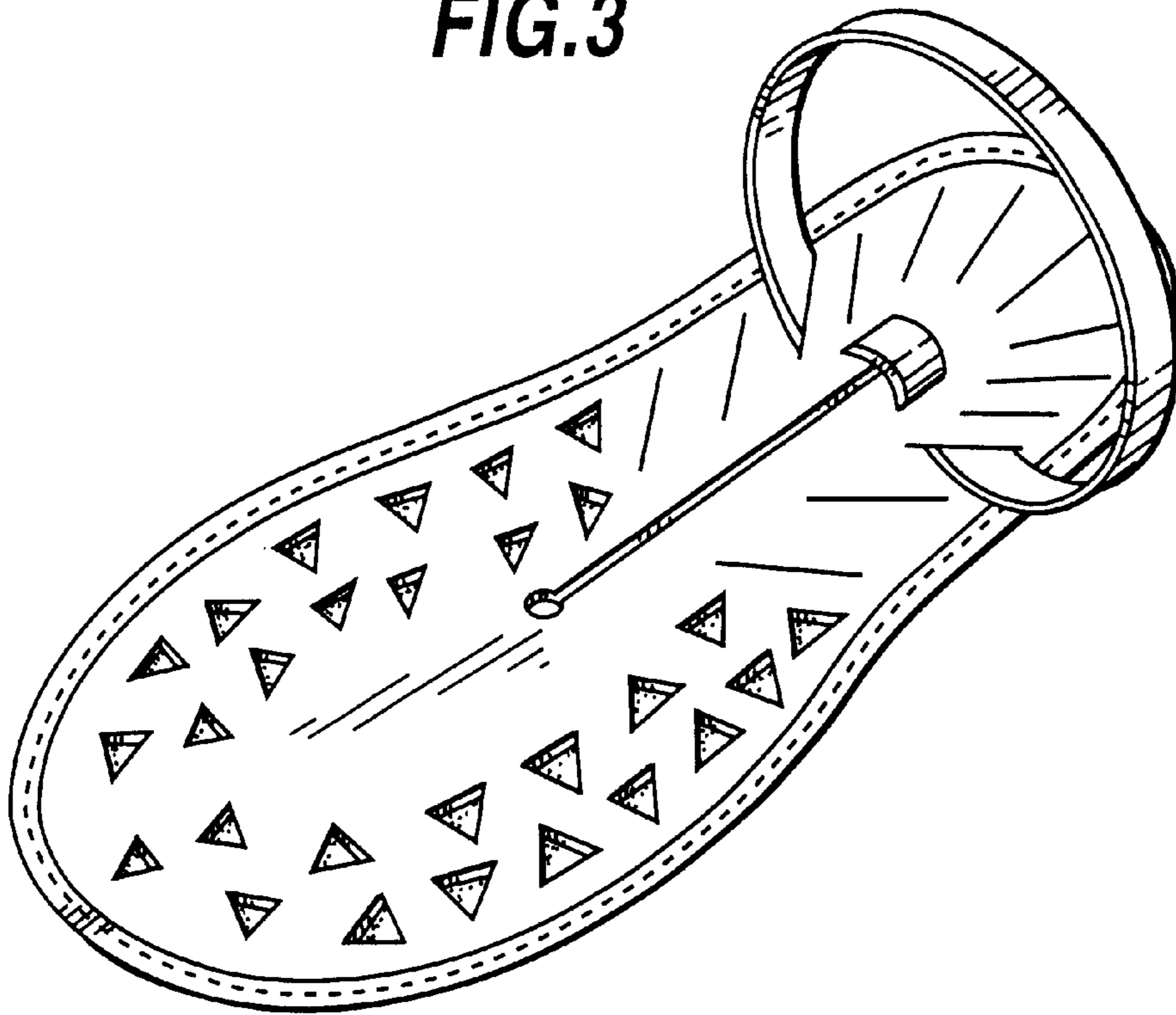

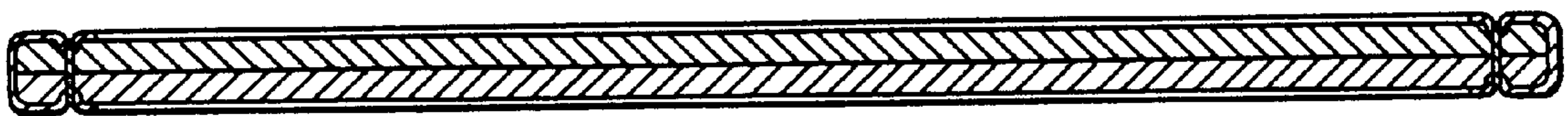

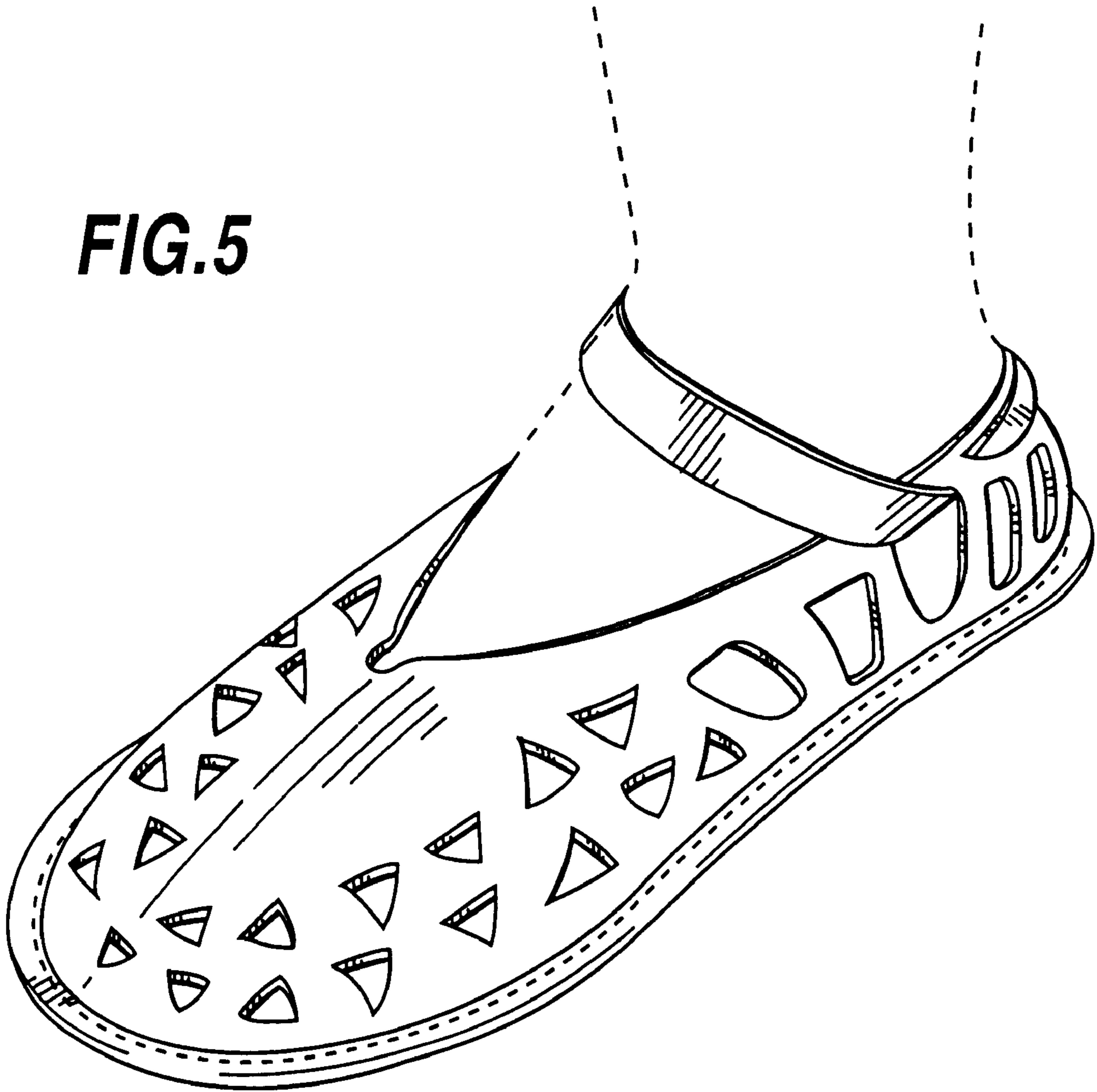
