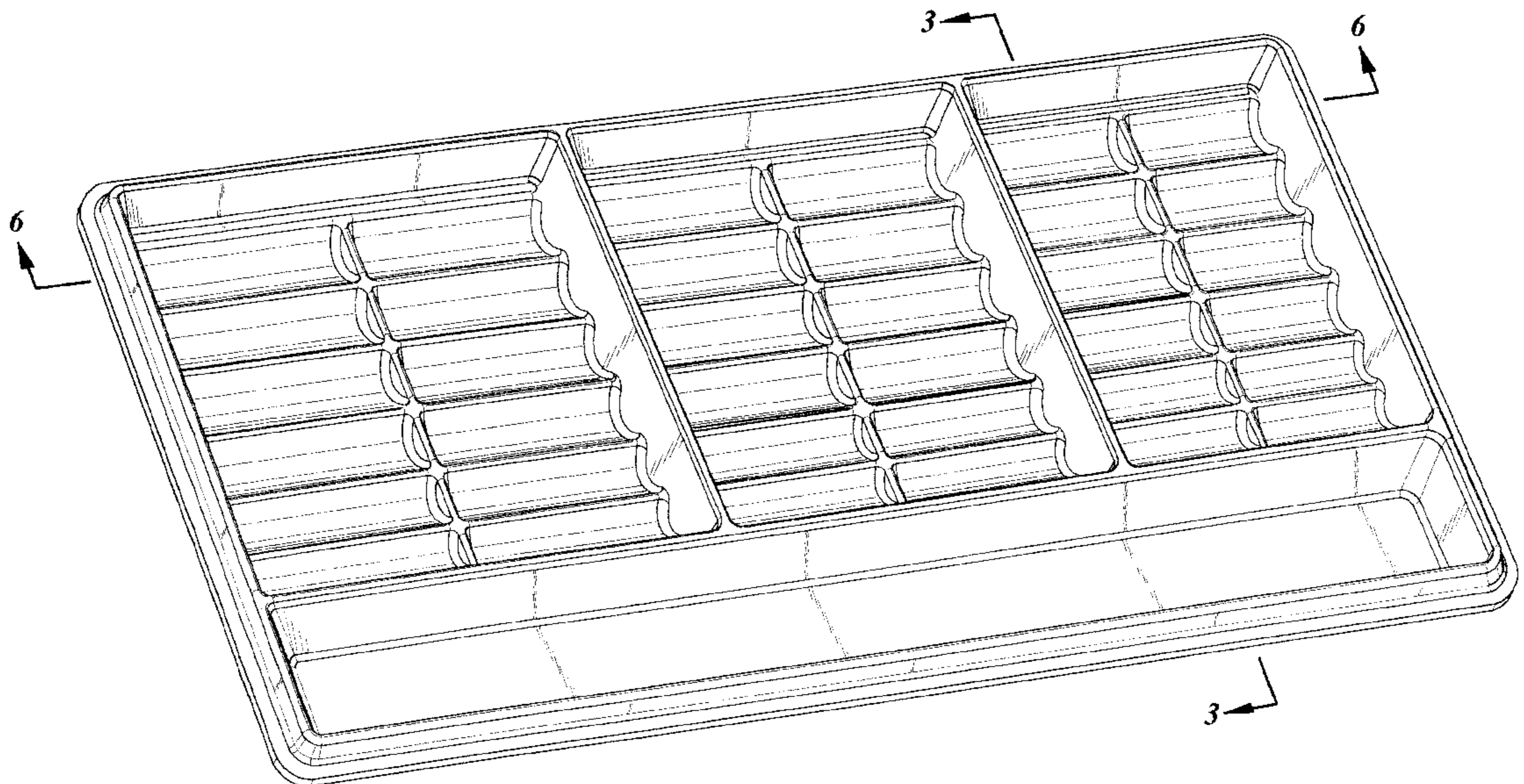
FIG. 5 is a rear view of the thirty-seven compartment socket tray in FIG. 1.

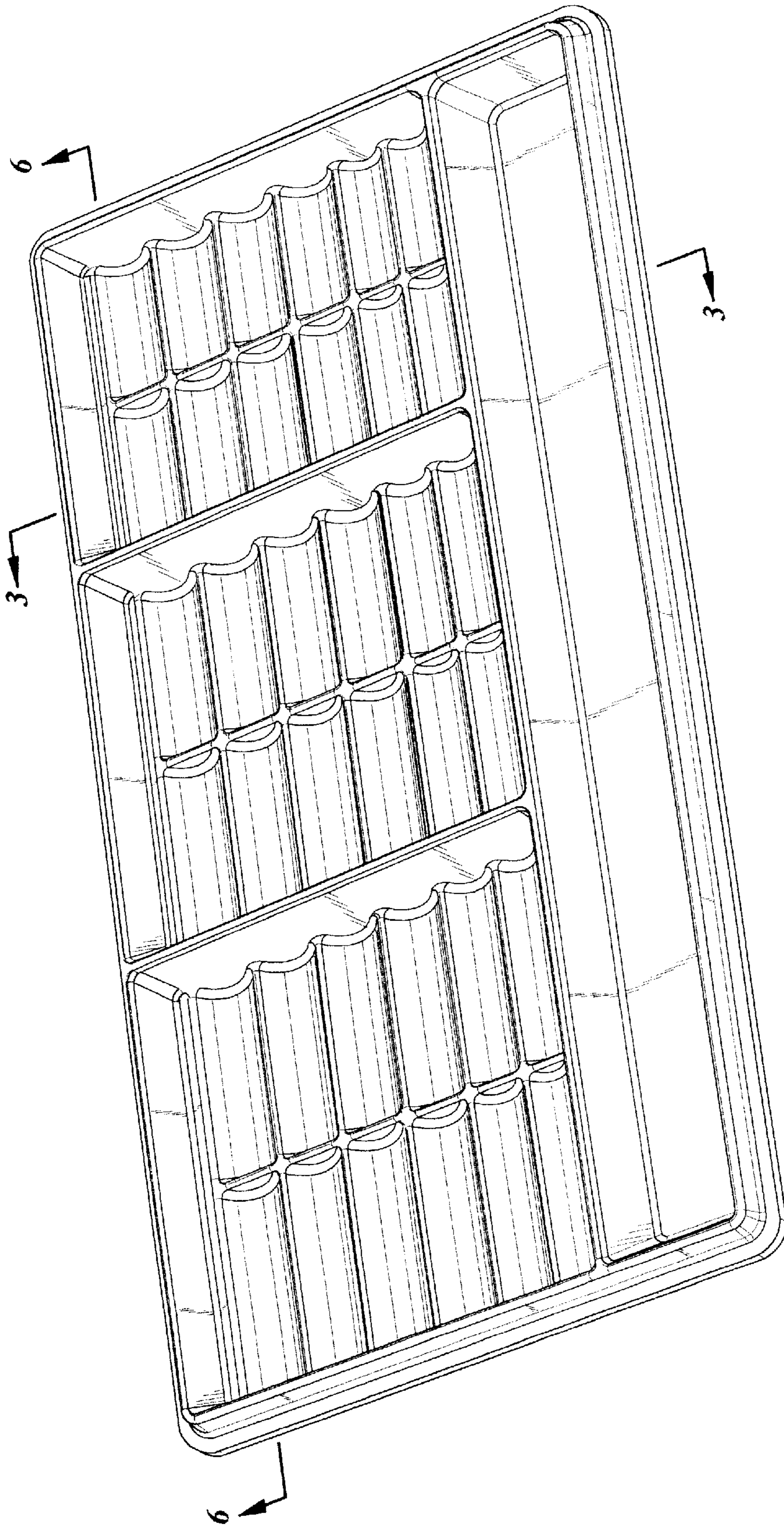

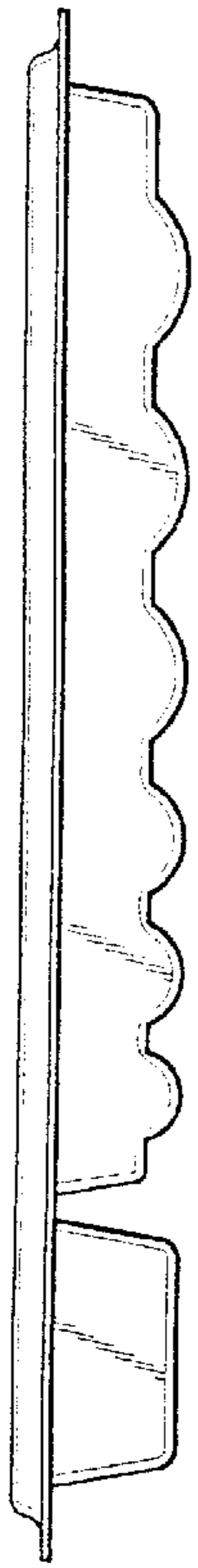

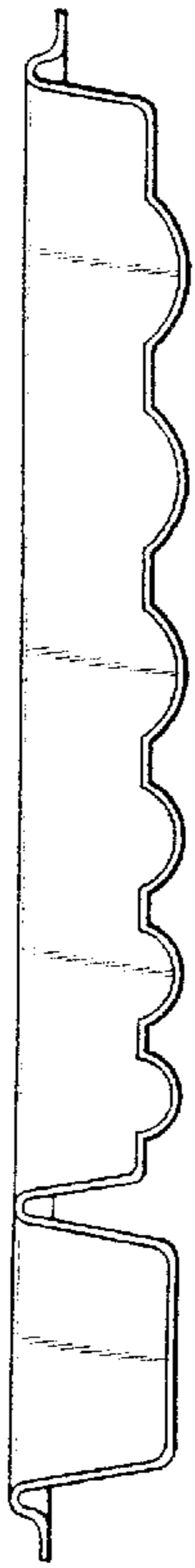

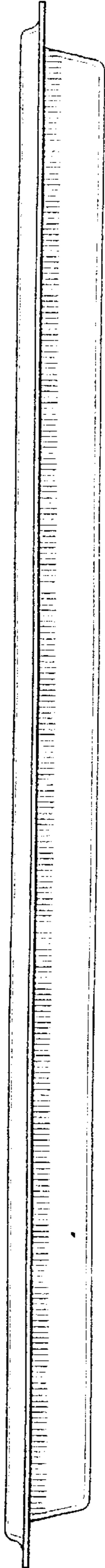

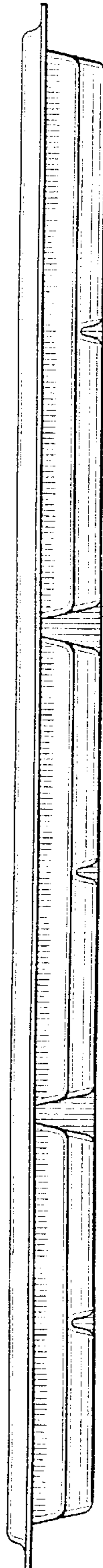

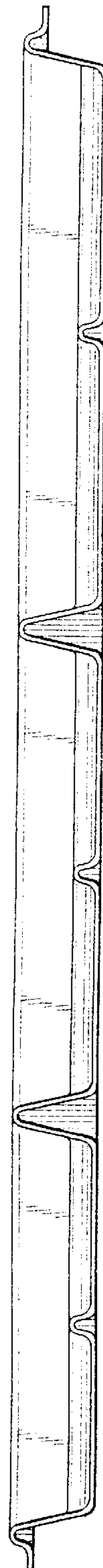

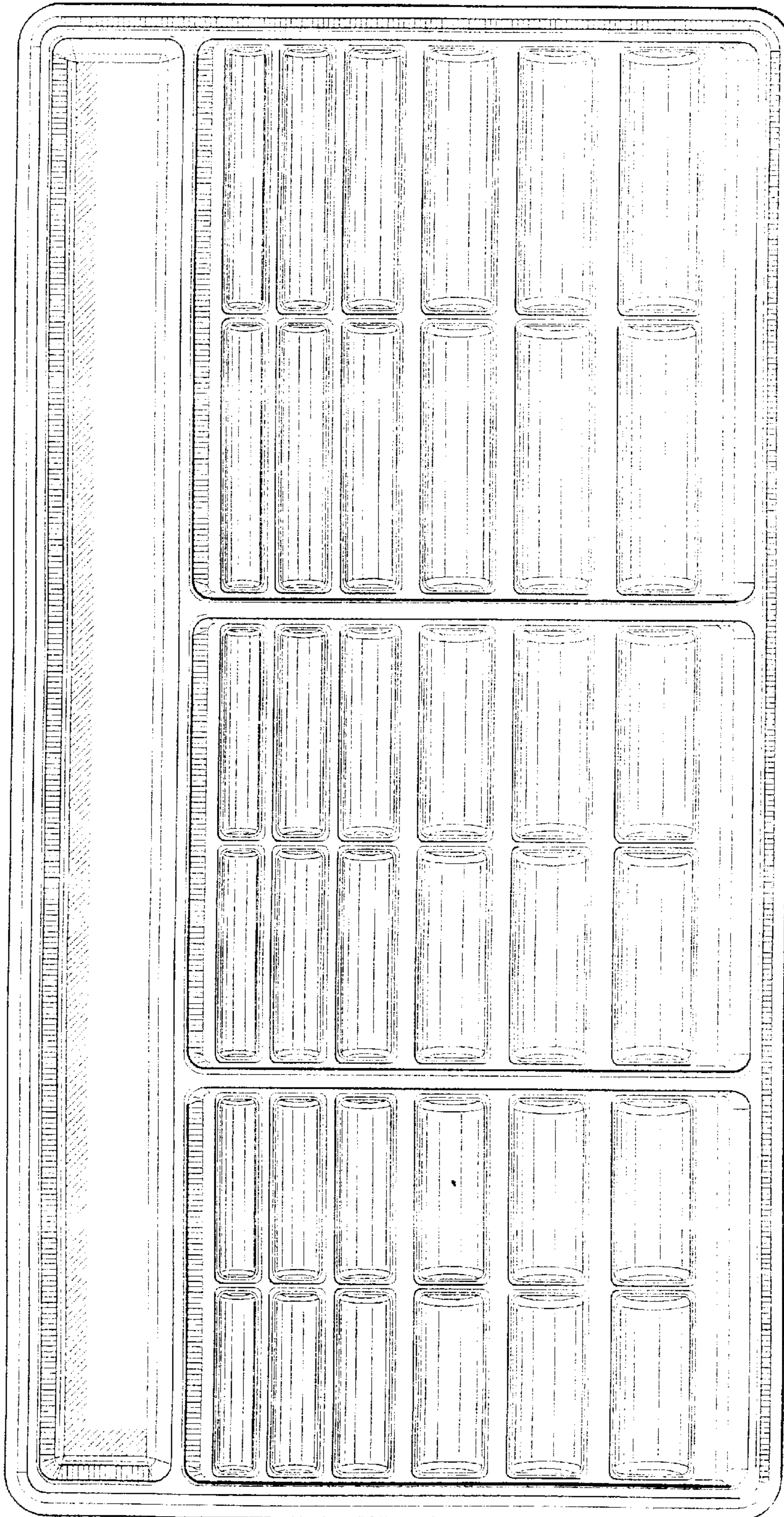

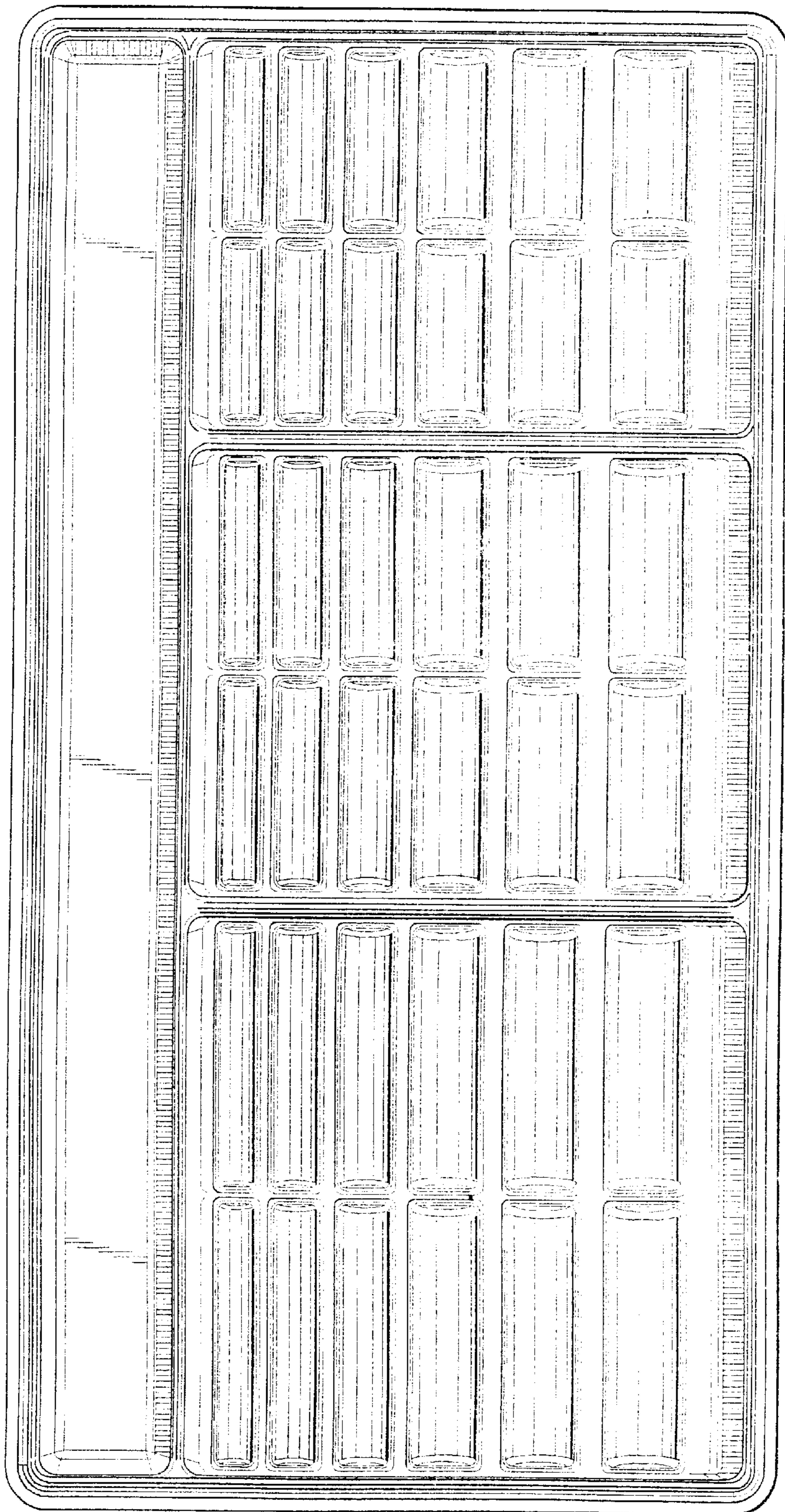
