in FIG. 1, with the right side being a mirror image thereof;

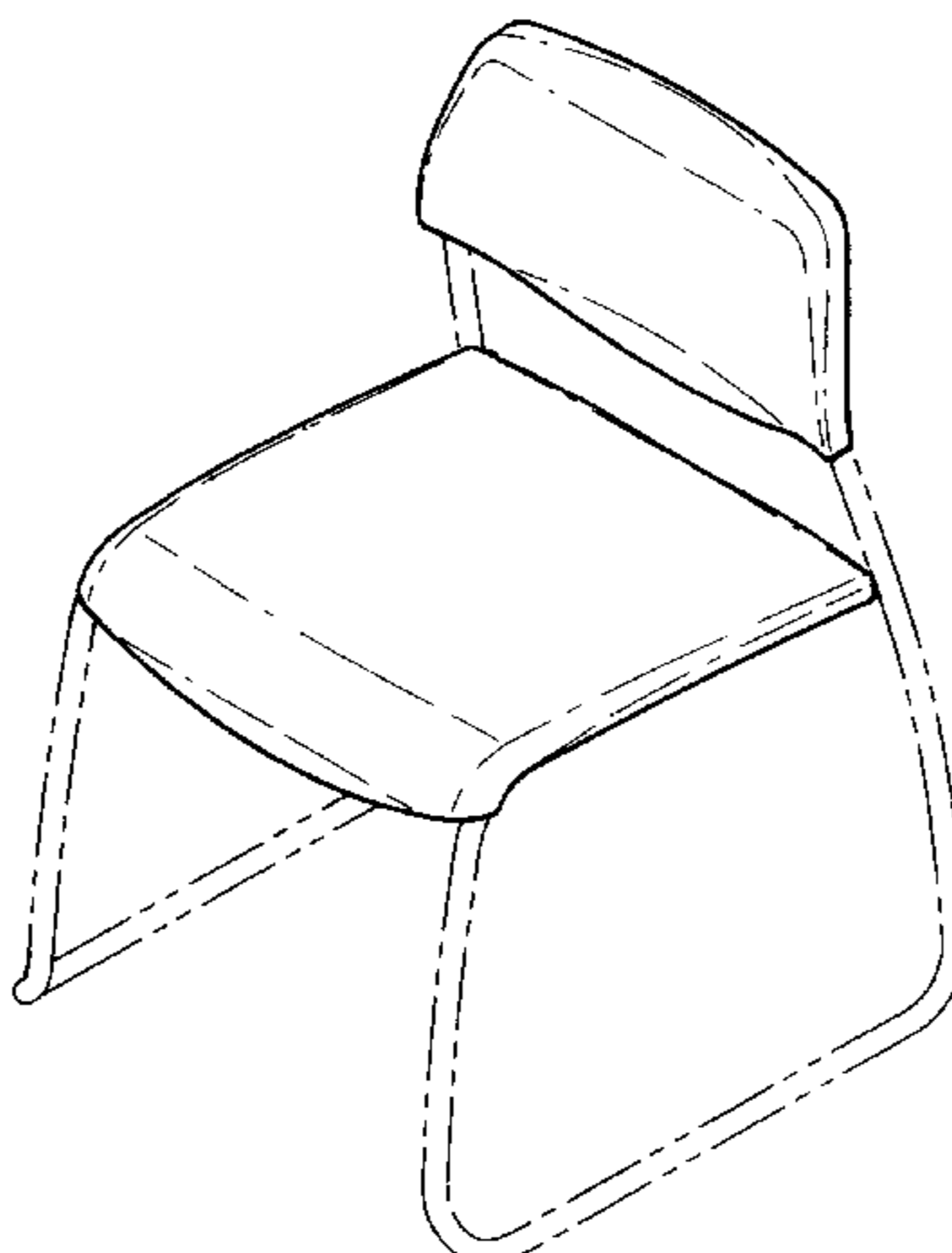
FIG. 5 is a top view of the chair back and seat shown in FIG.

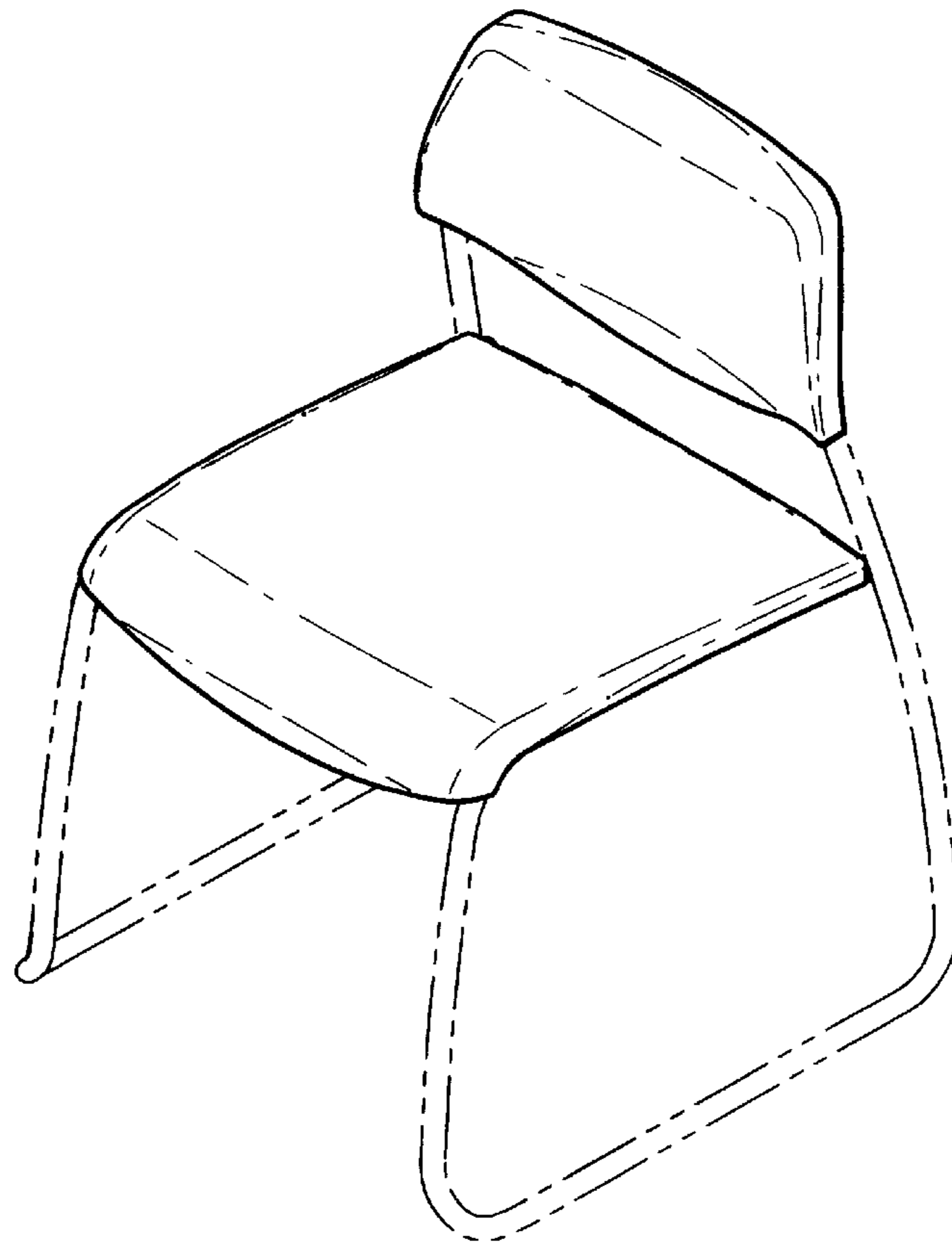
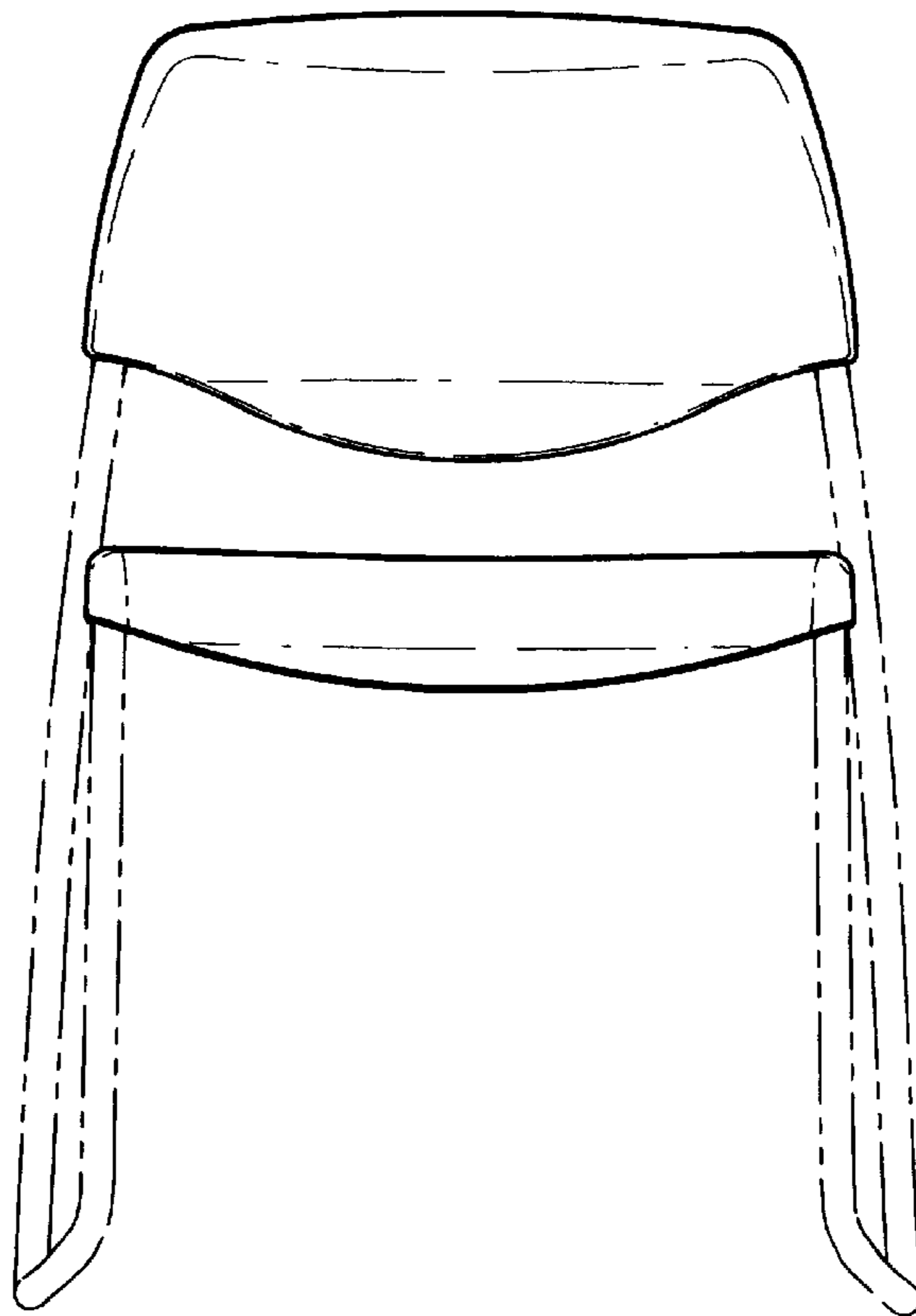

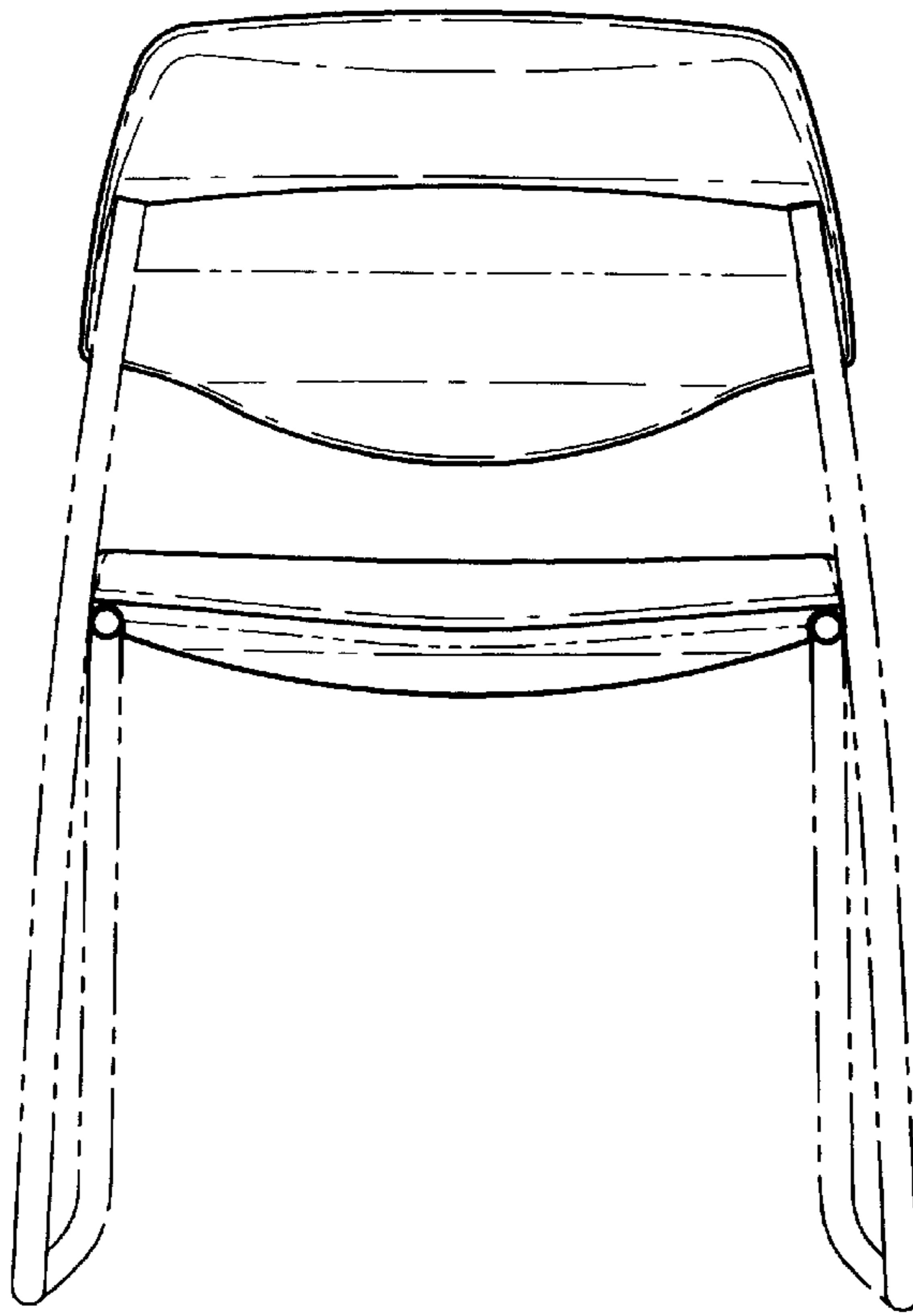

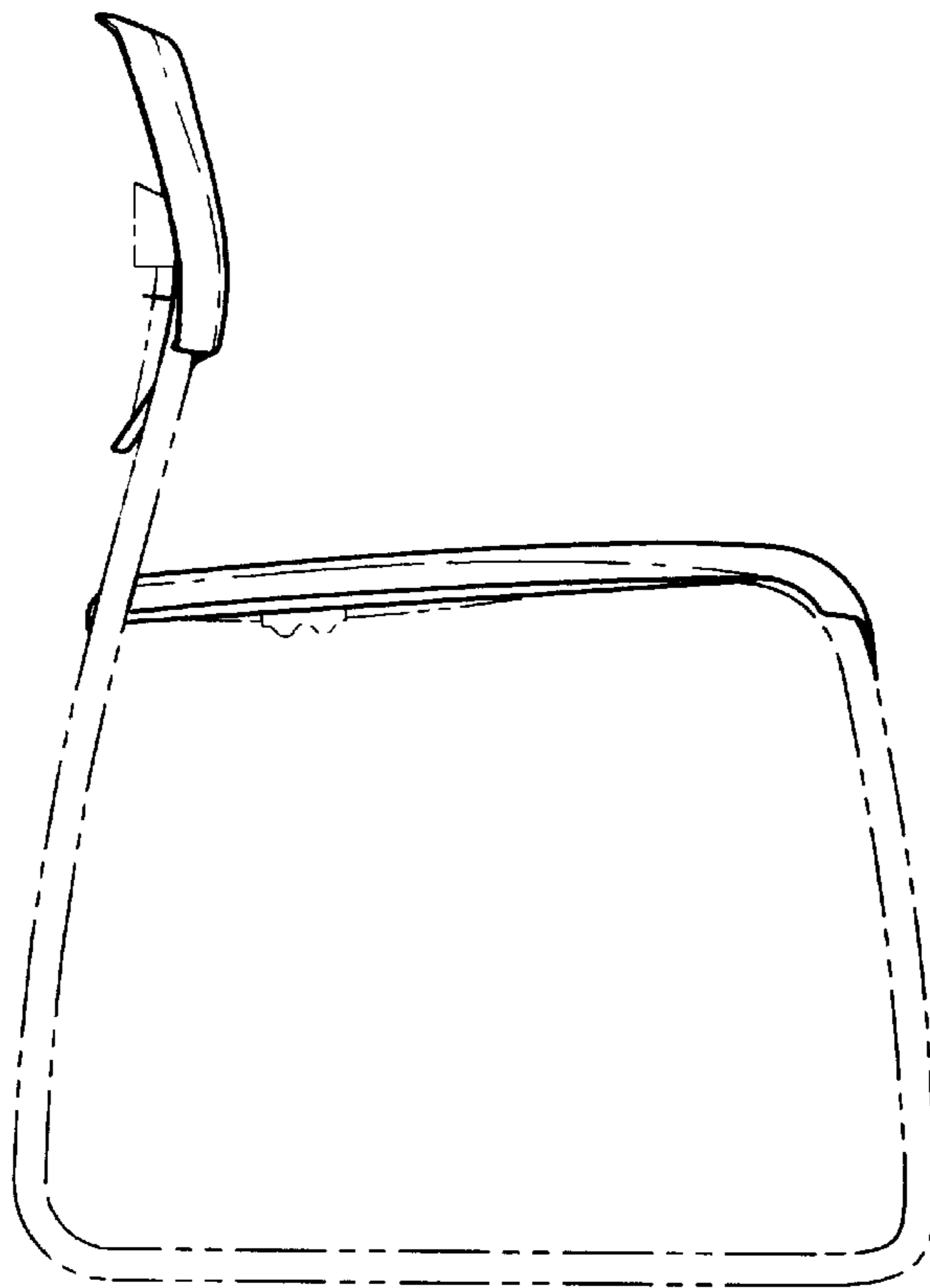

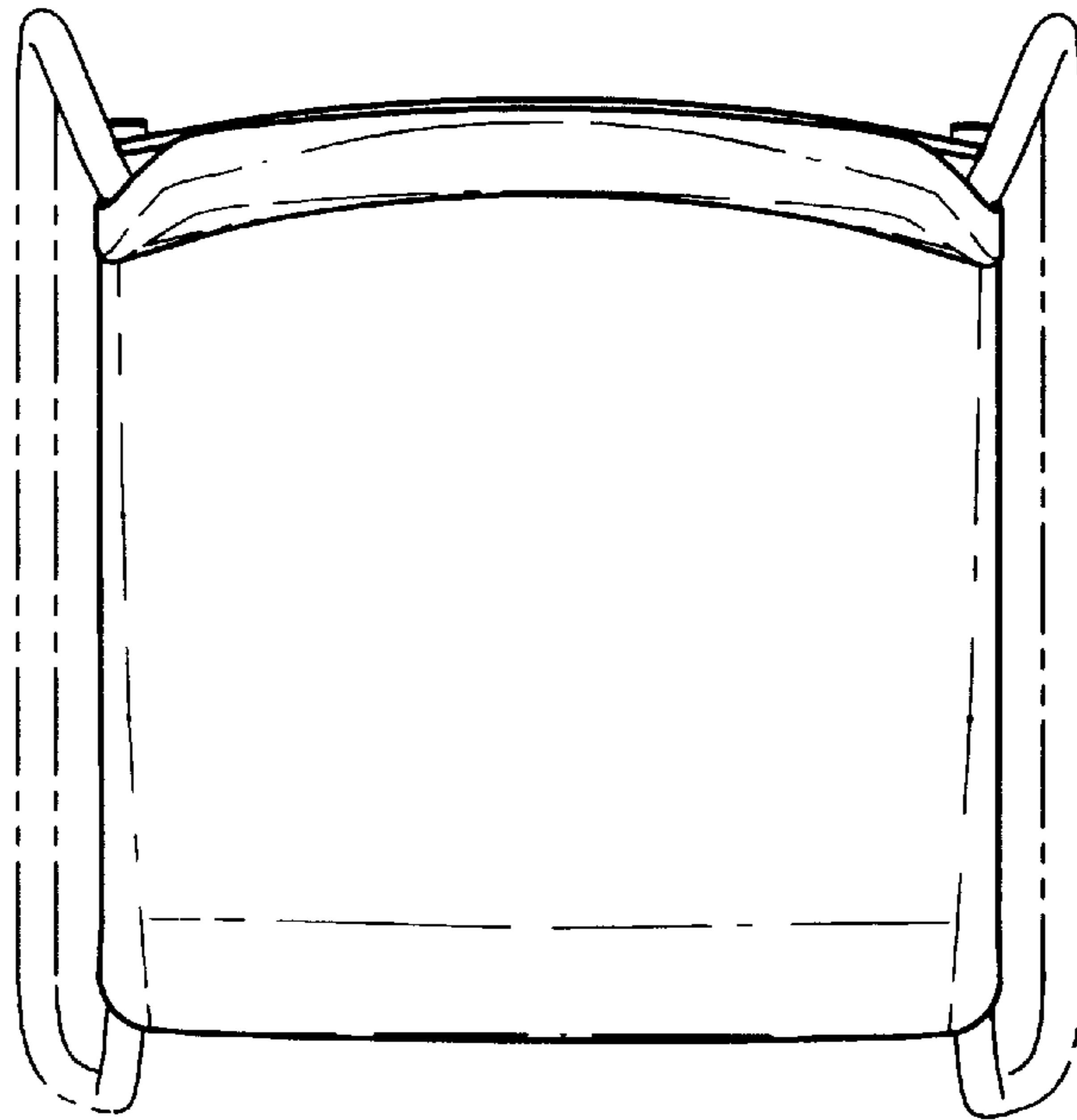

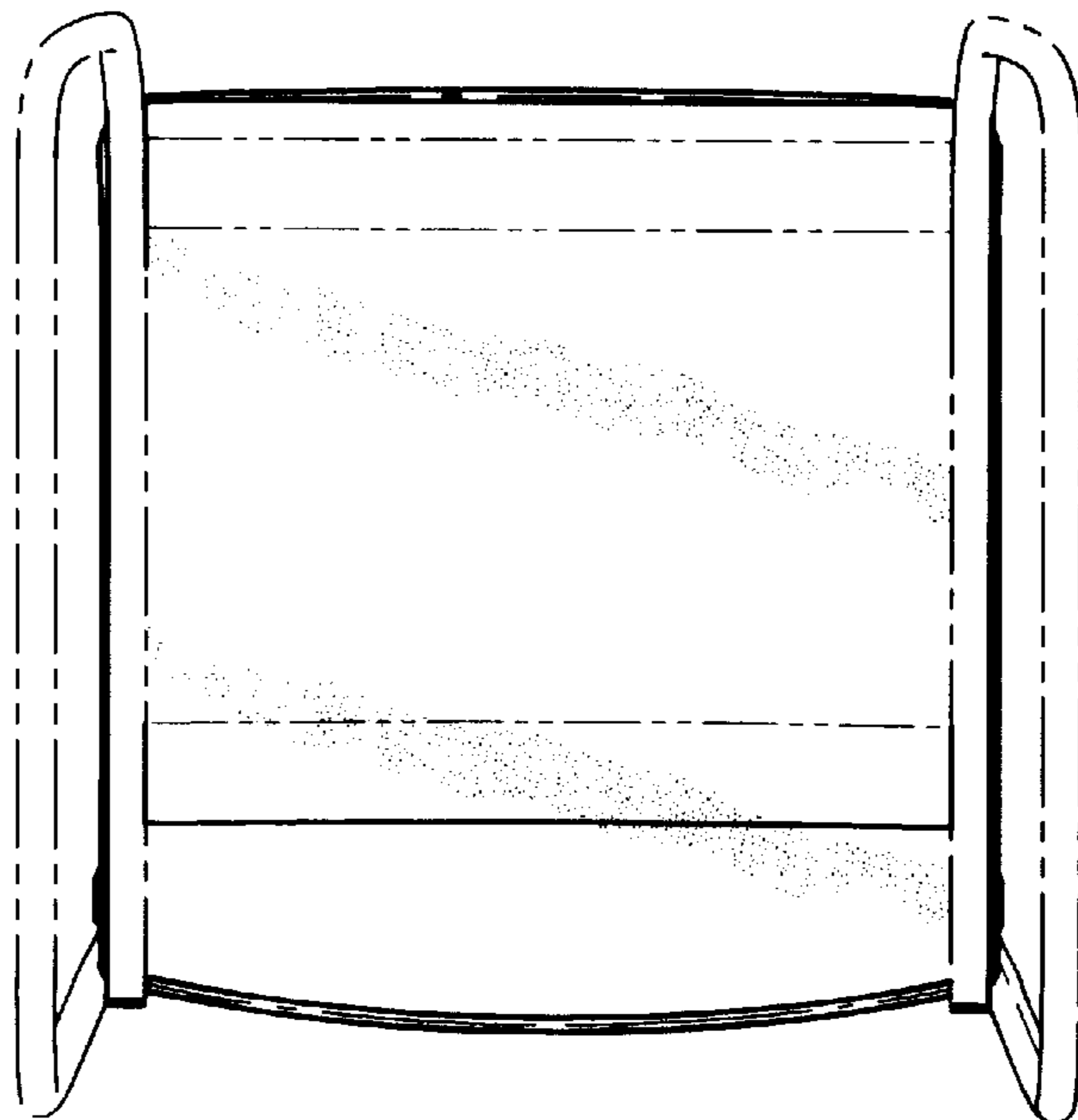
