The ornamental design for a Dutch oven, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the top side of a Dutch oven.

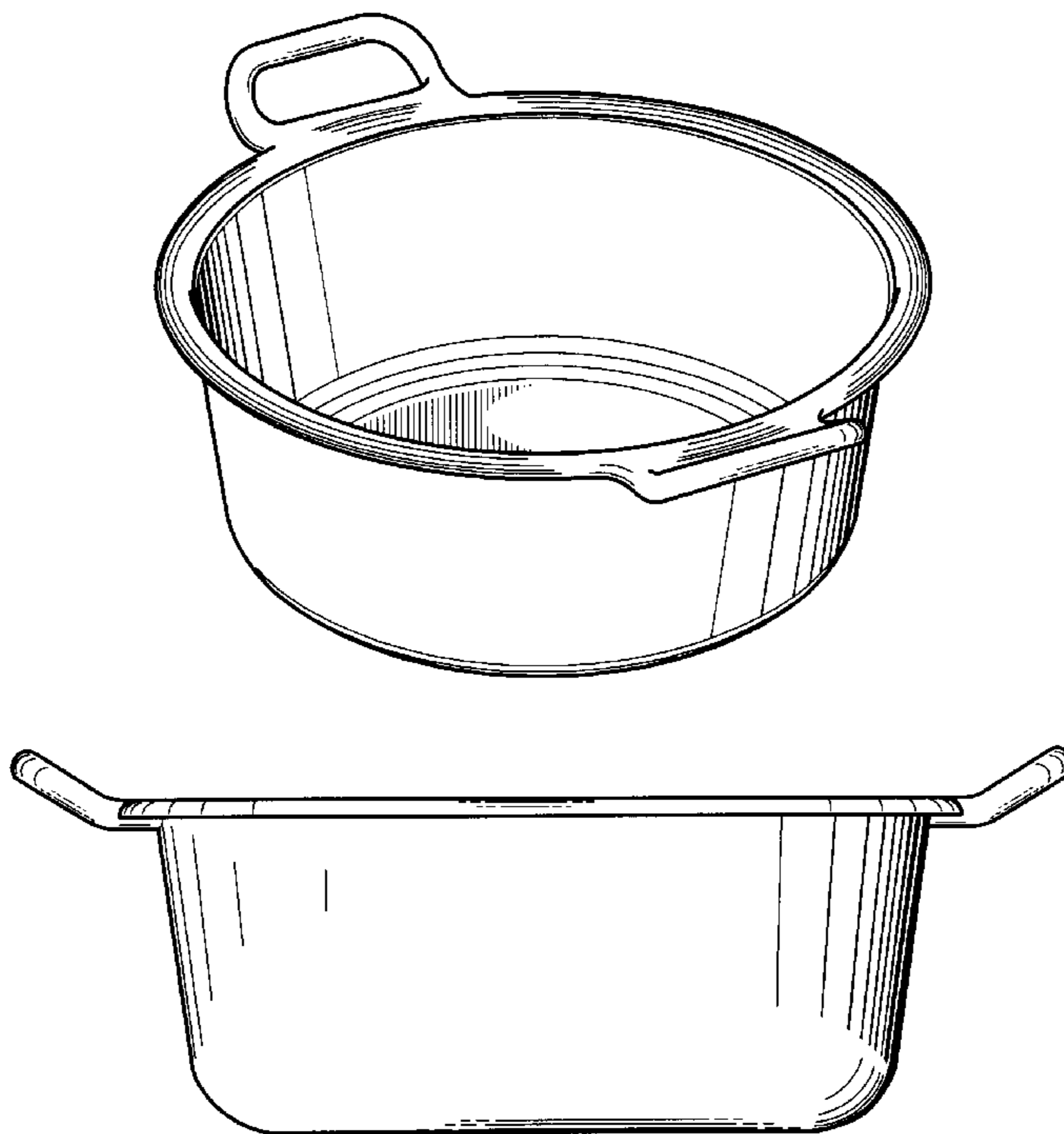
FIG. 2 is a left side view of the Dutch oven of FIG. 1, the right side view being a mirror image of the left side view.

FIG. 3 is the front view of the Dutch oven of FIG. 1, the back view being a mirror image of the front view.

FIG. 5 is a bottom view of the Dutch oven of FIG. 1.

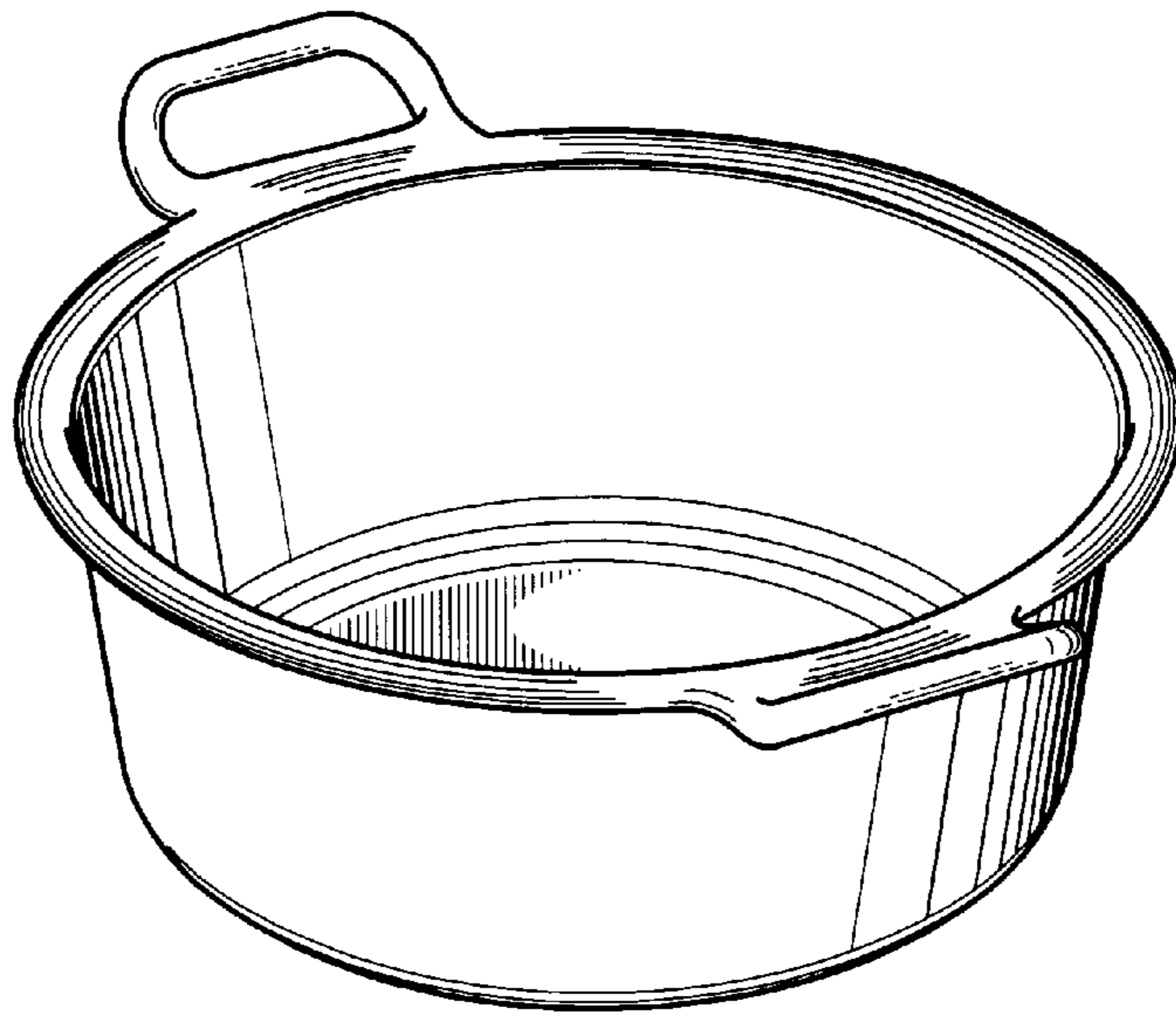

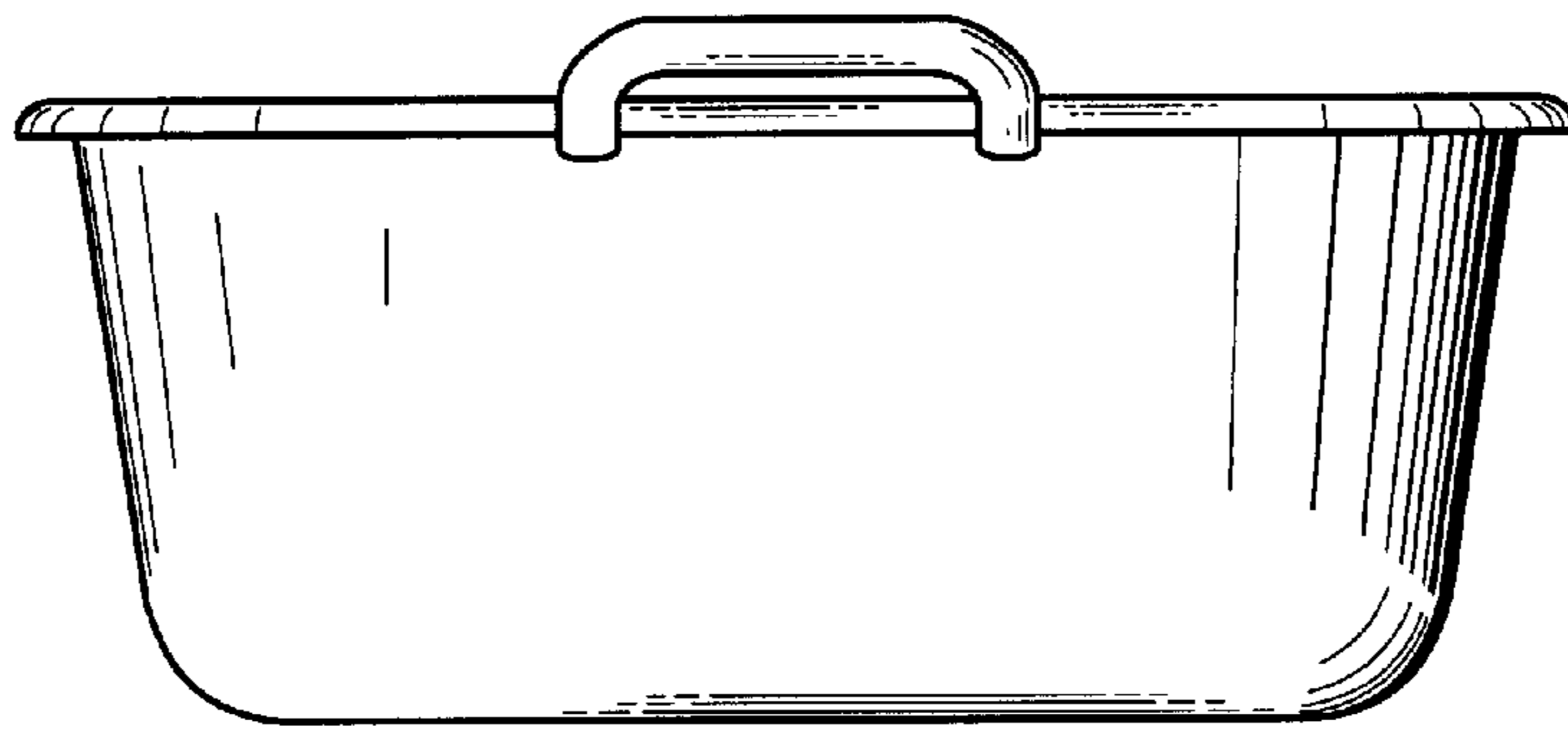

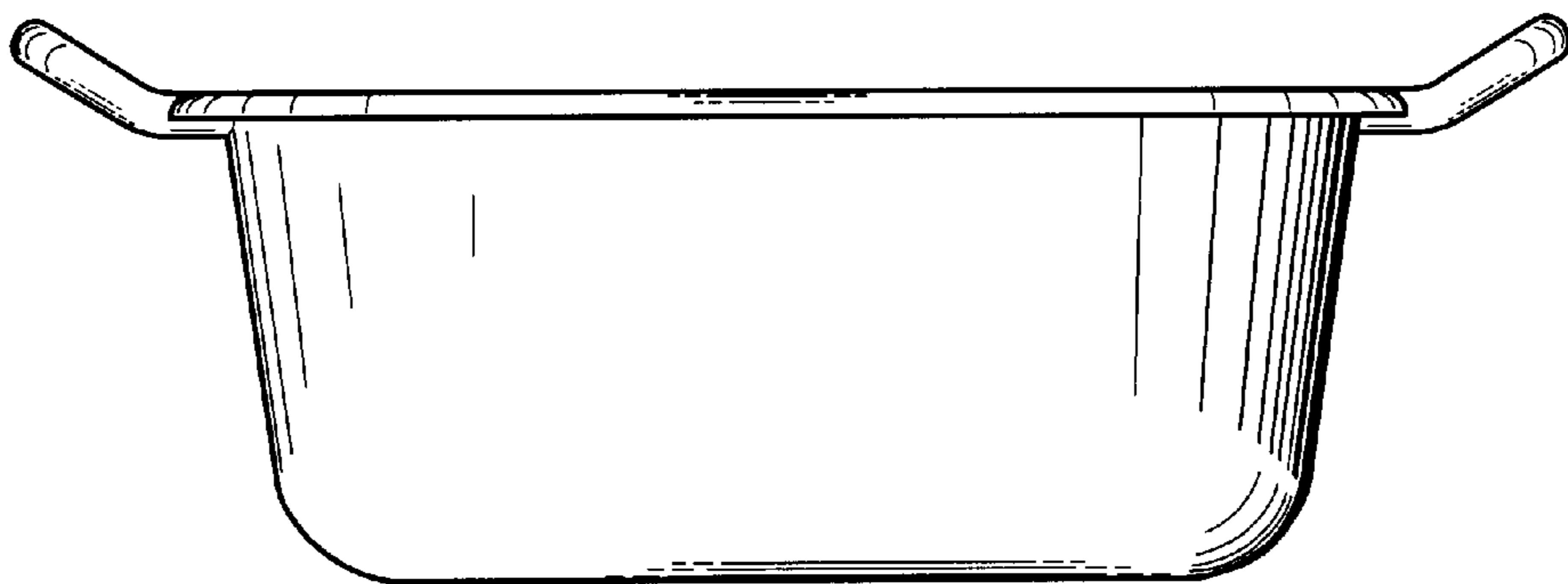

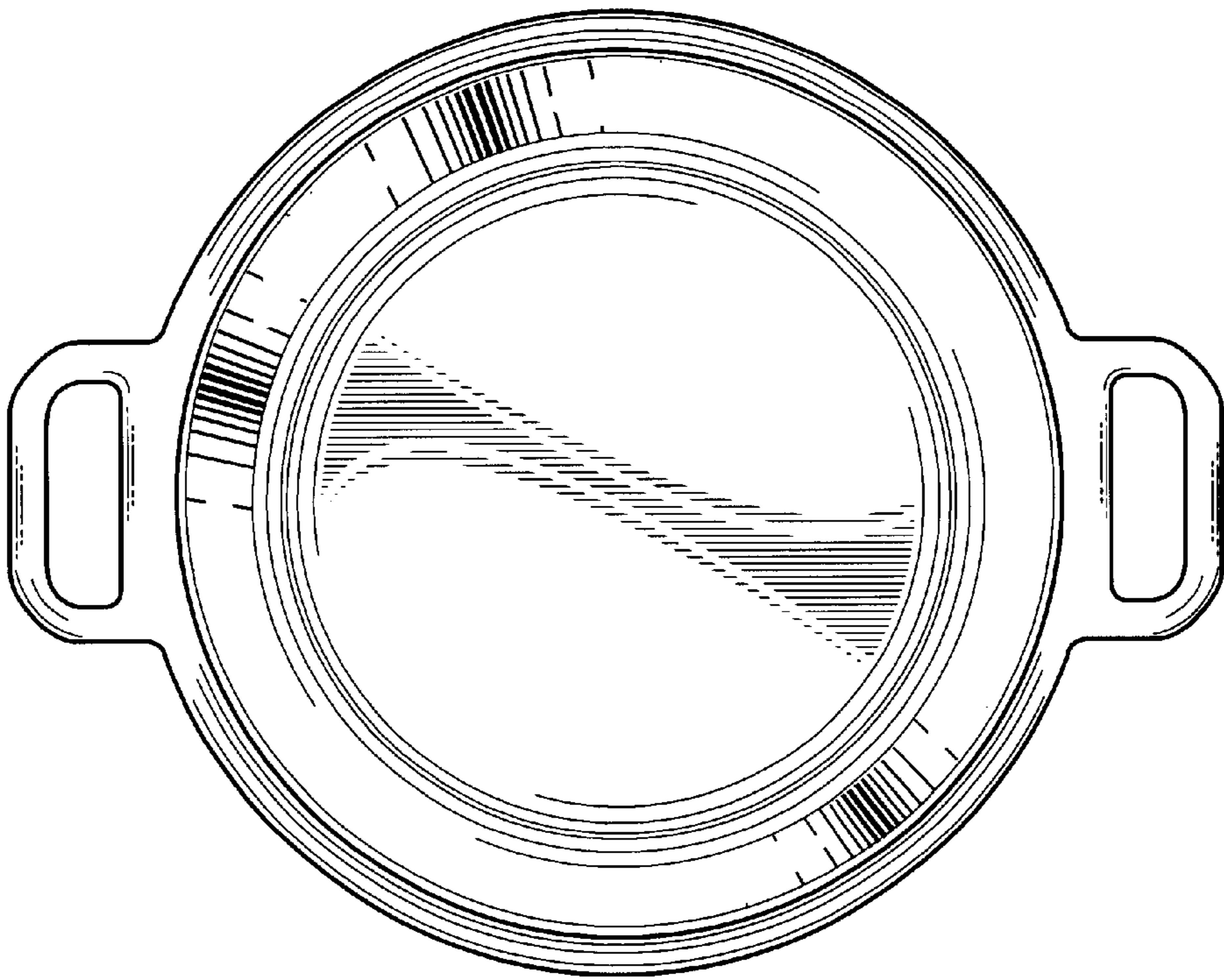

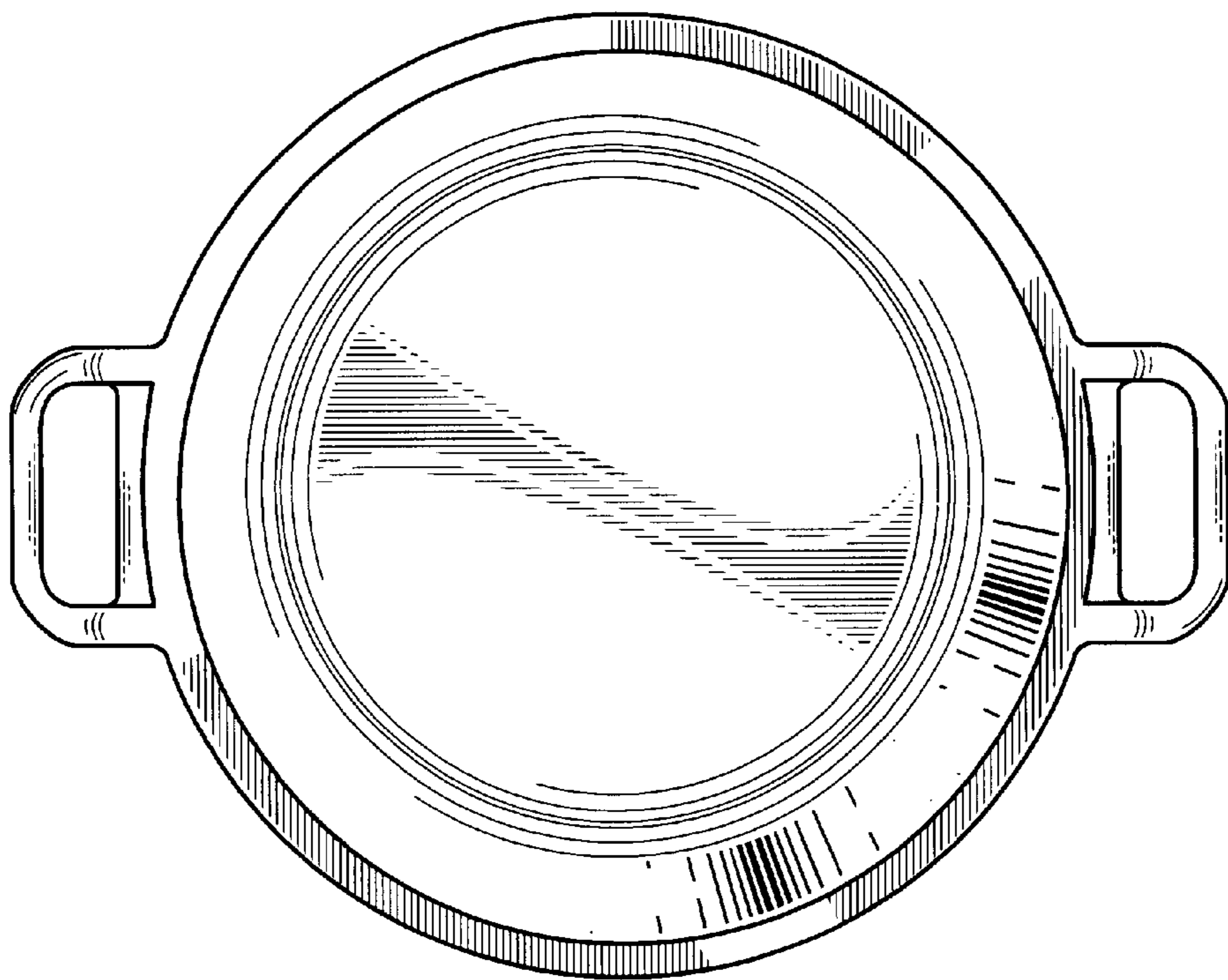
