FIG. 3 is a side view of said one side thereof;

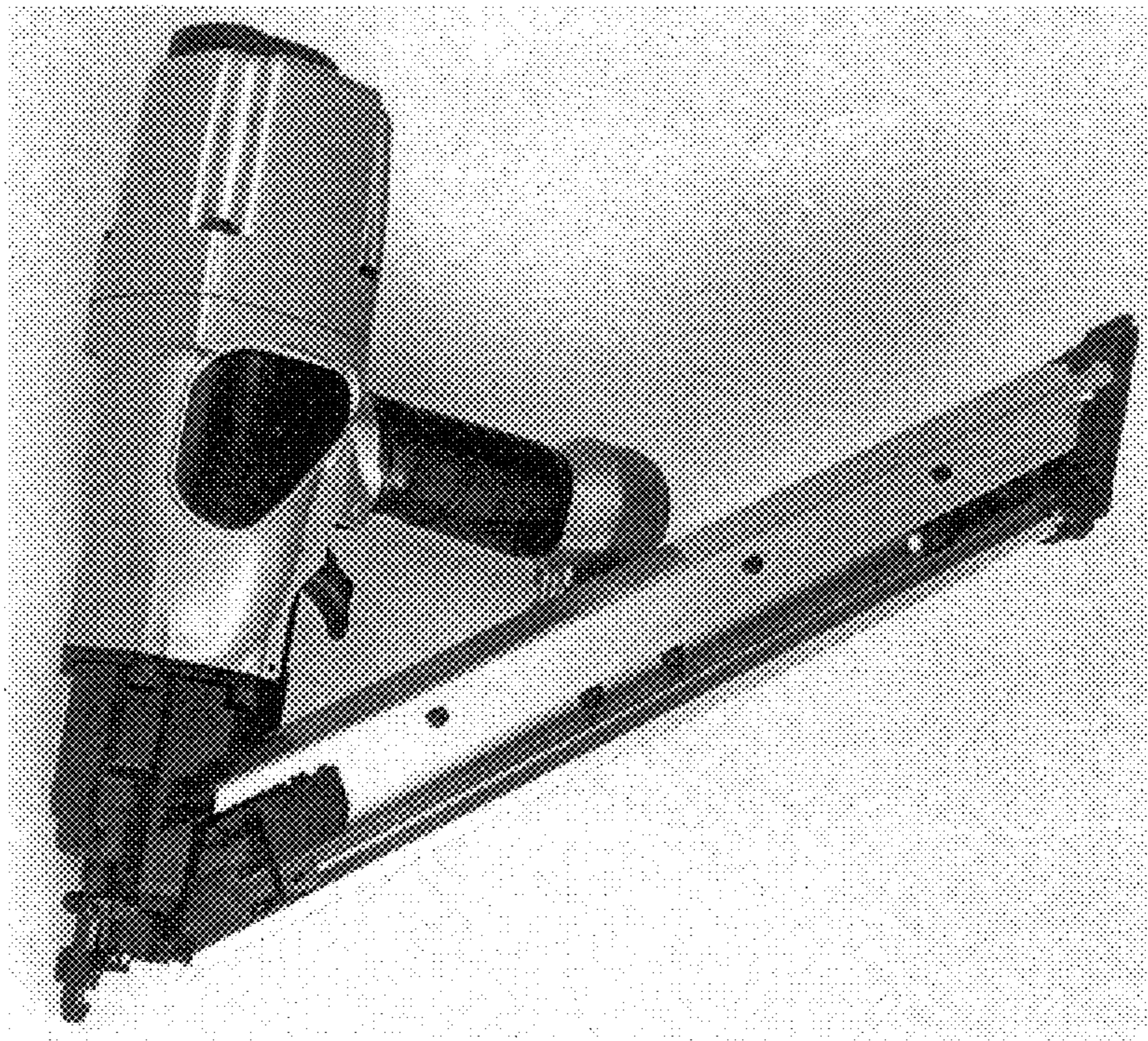
FIG. 4 is a bottom view thereof;

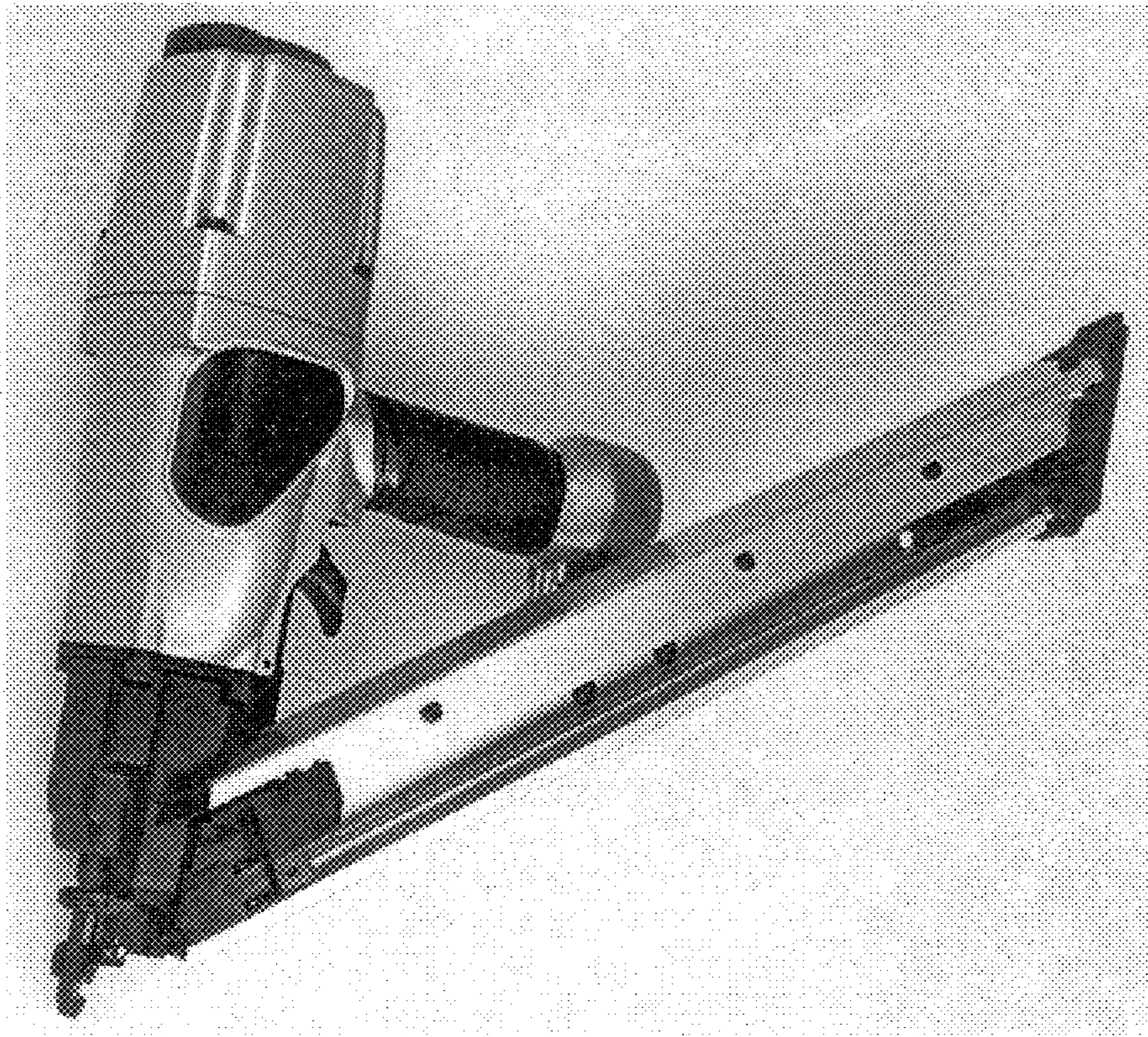

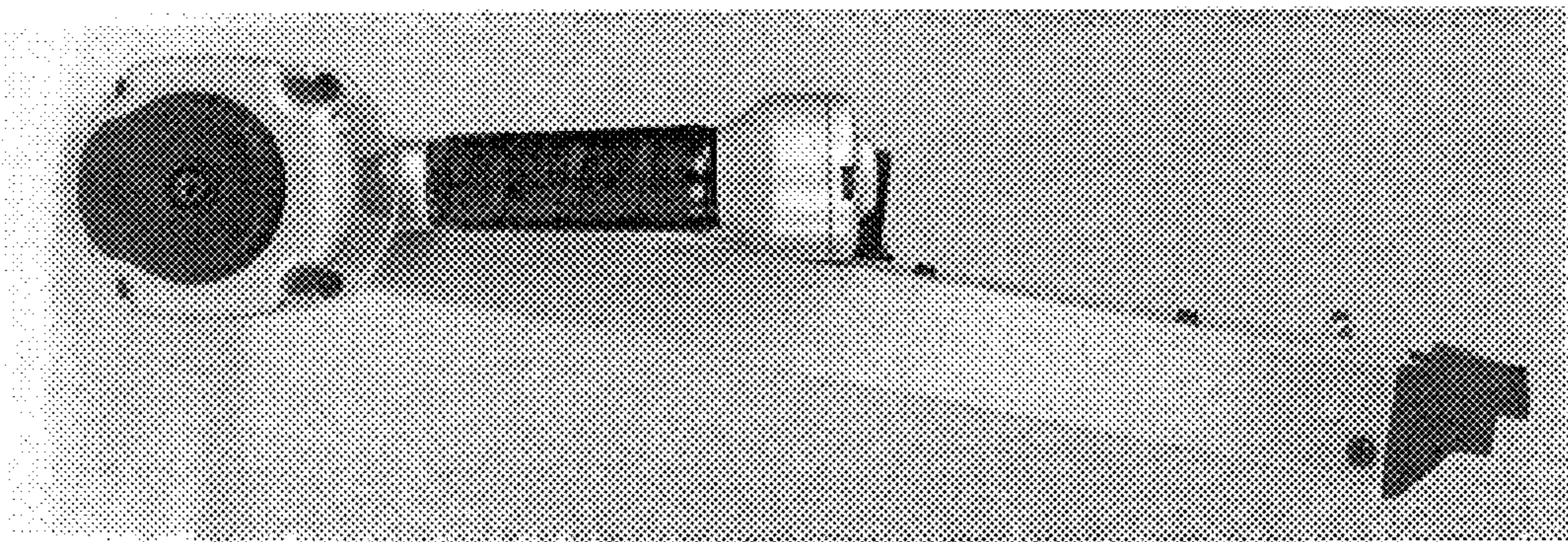

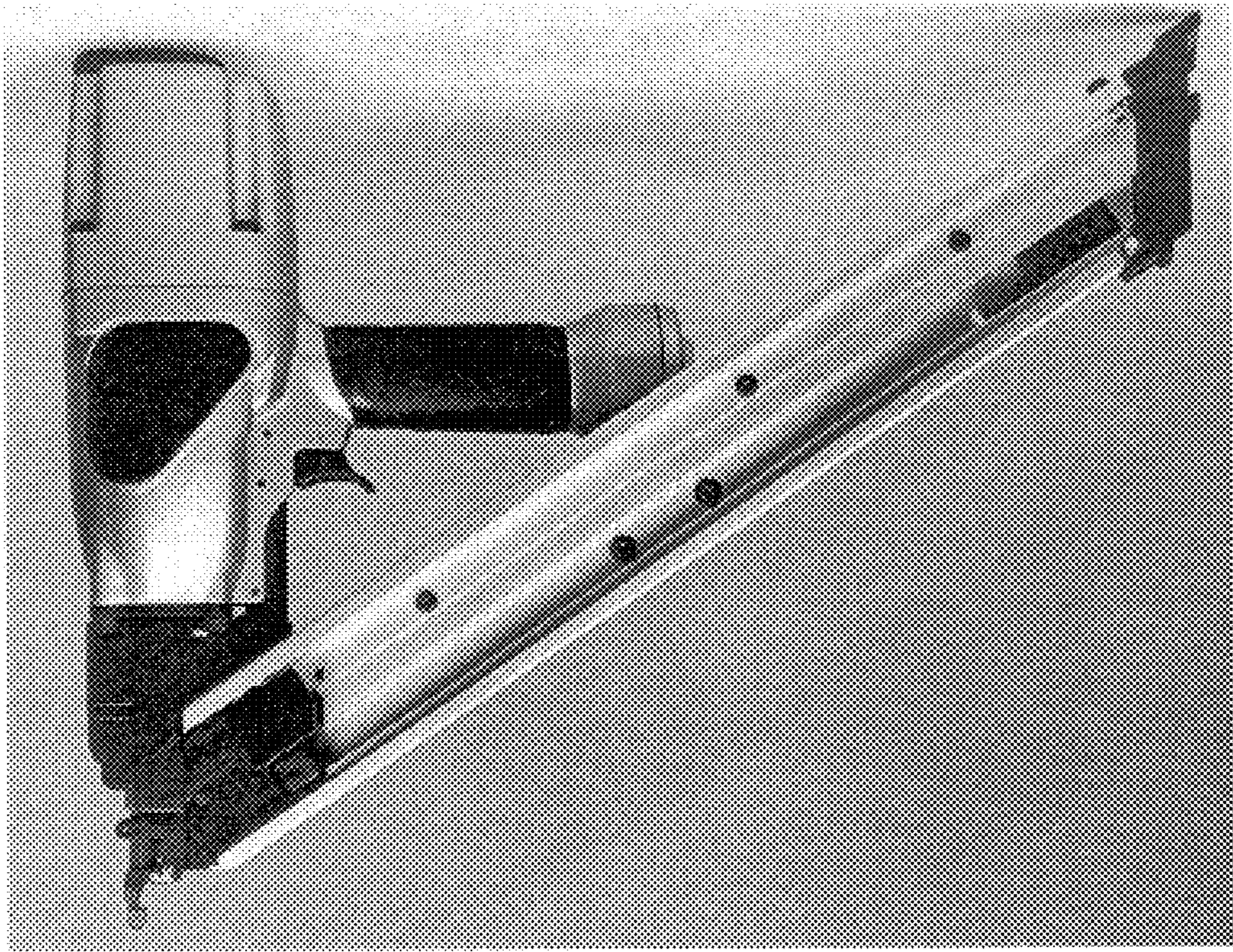

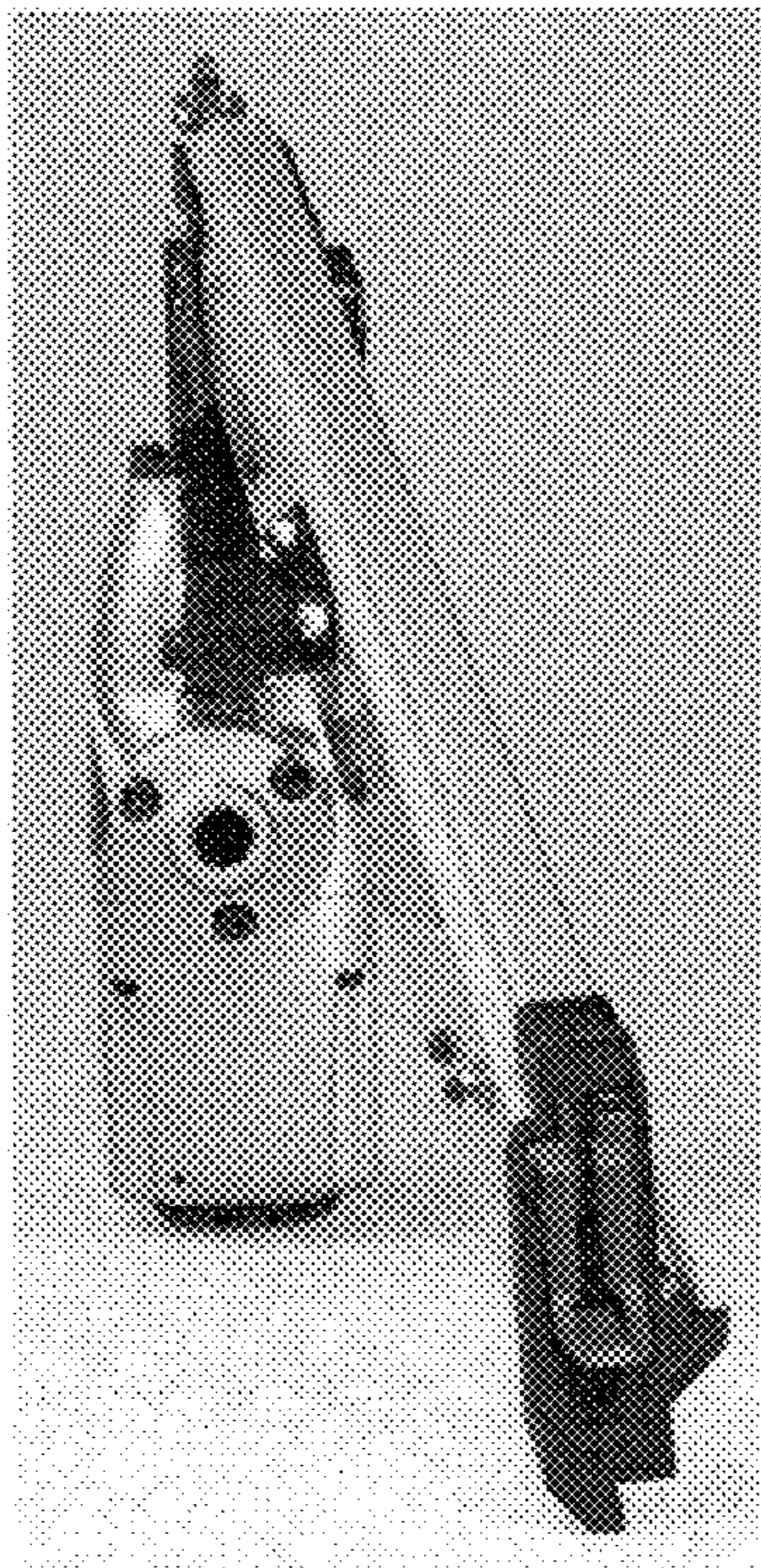

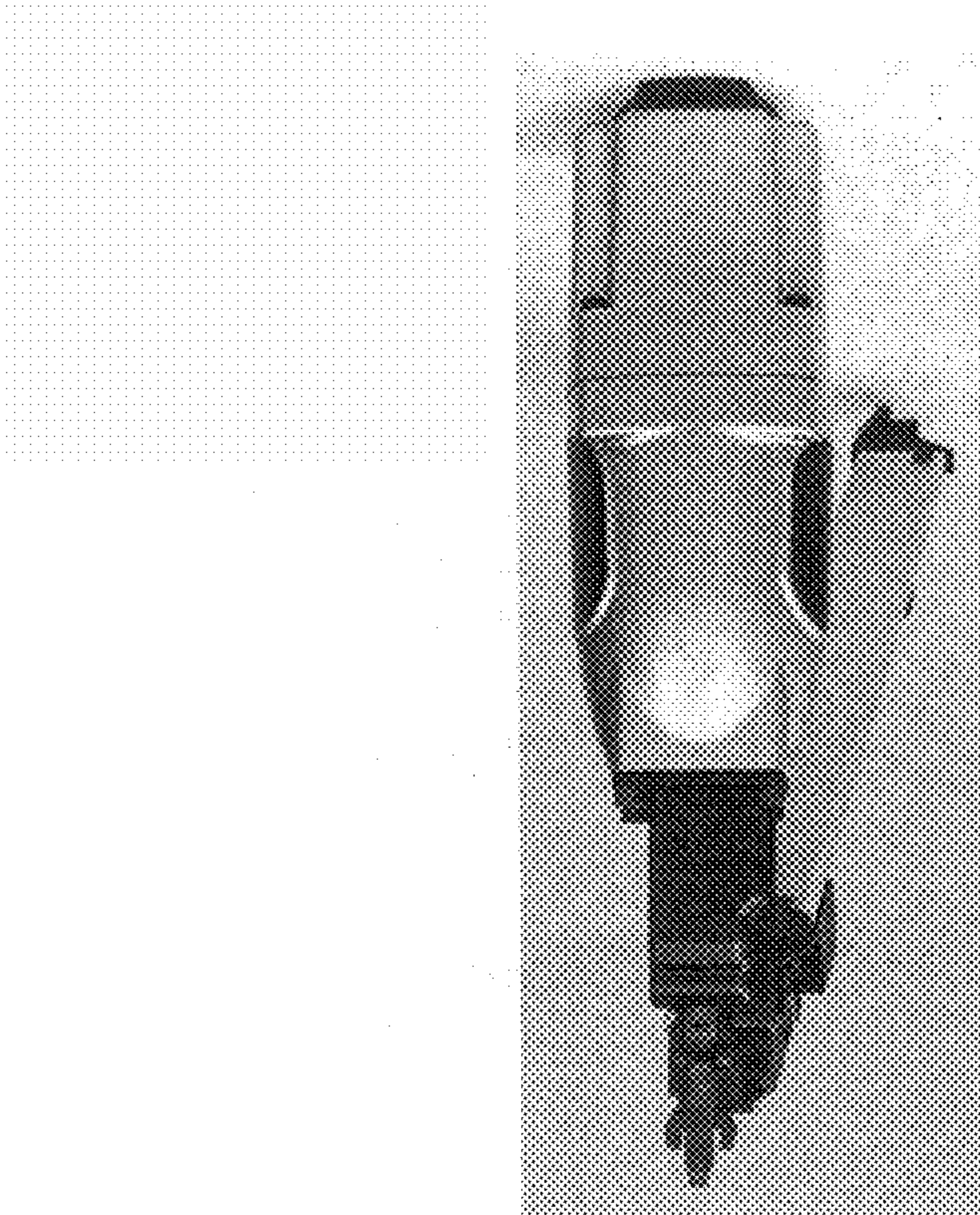

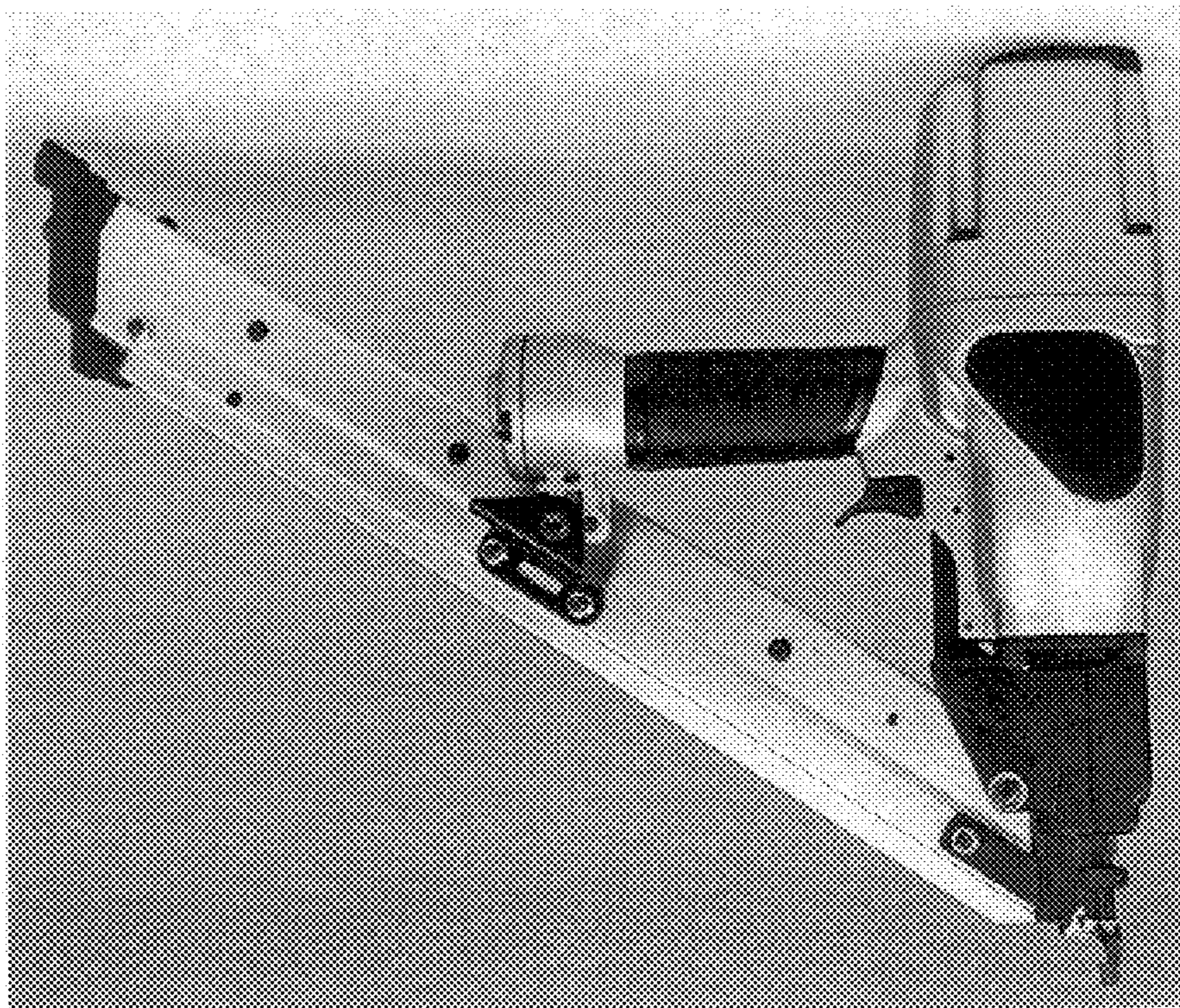

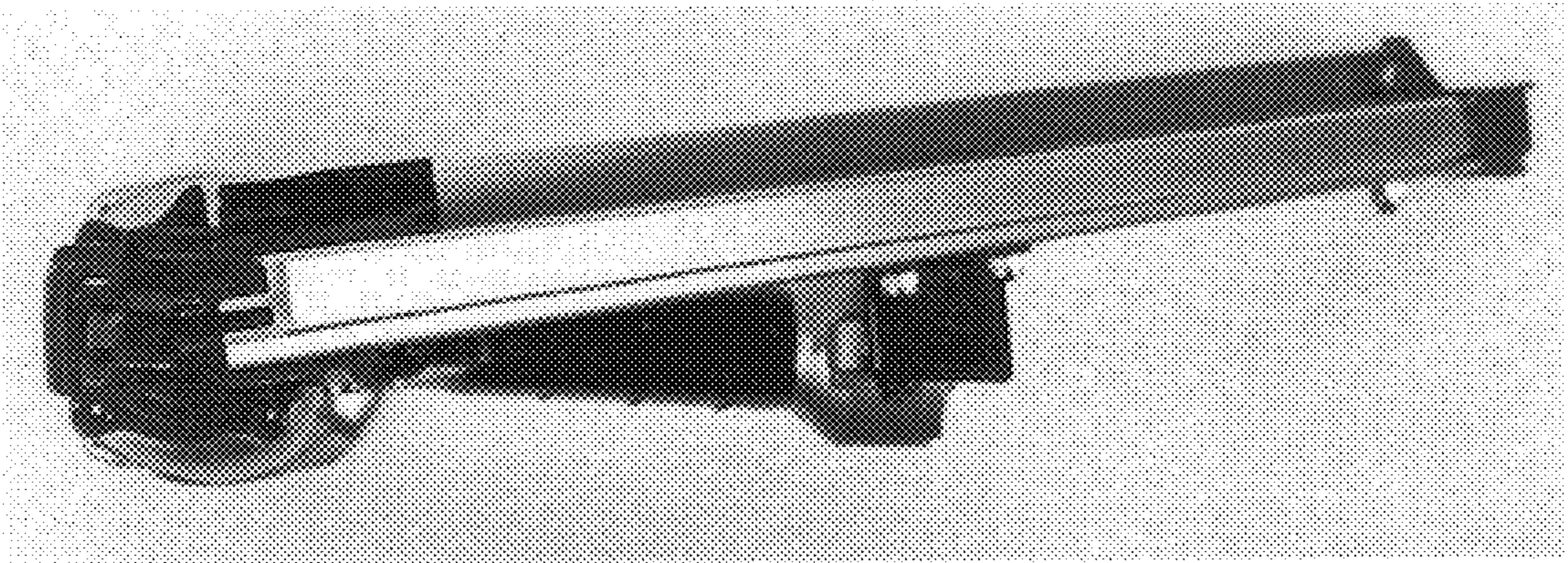
