(57) **CLAIM**

The ornamental design for a product container with locking end cap, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a product container with locking end cap showing our new design; FIG. 2 is a front plan view of the container; FIG. 3 is a rear plan view of the container; FIG. 4 is a left side view of the container; FIG. 5 is a right side view of the container; FIG. 6 is a top end view of the container; and, FIG. 7 is a bottom end view of the container.

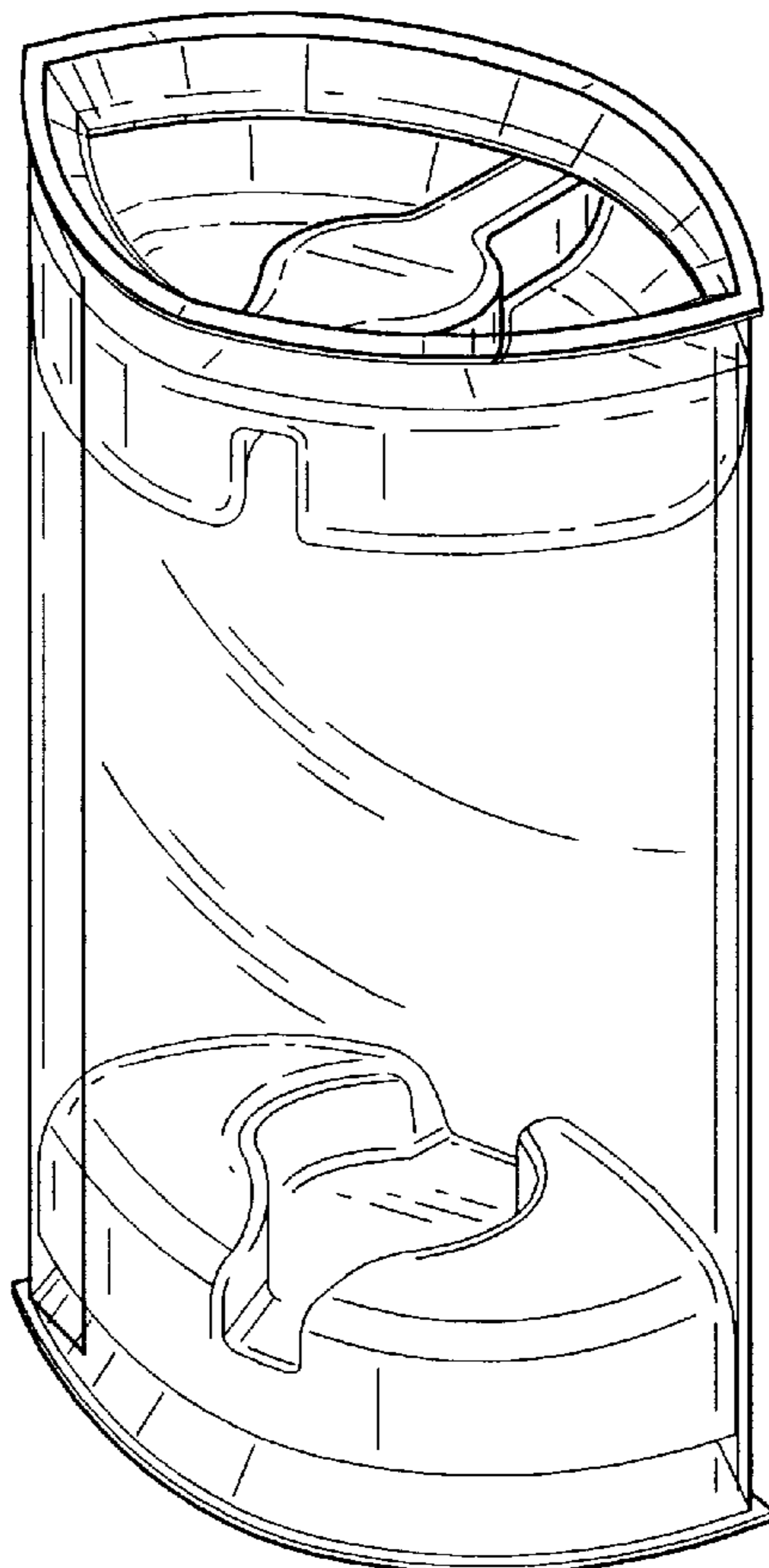

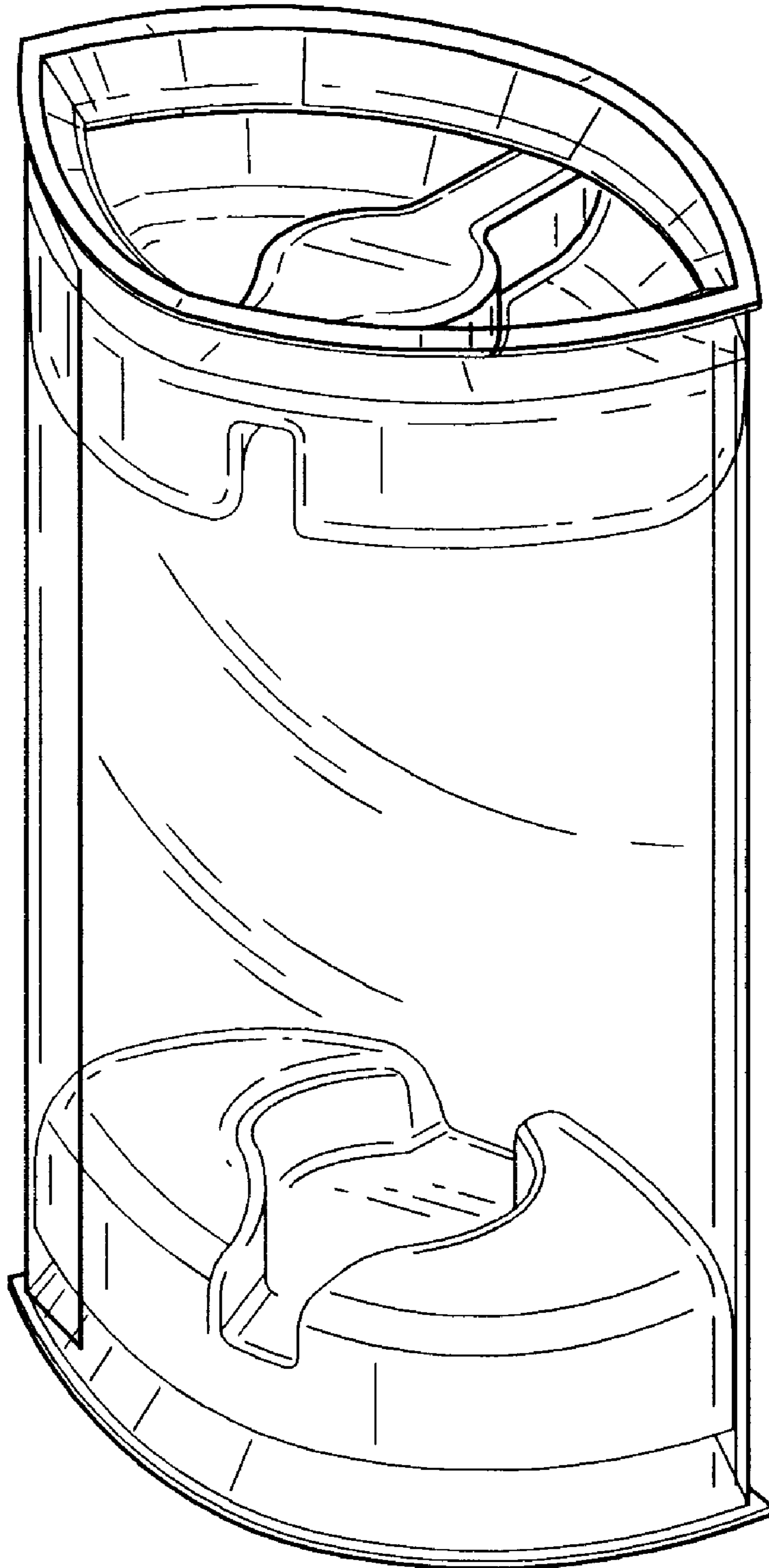

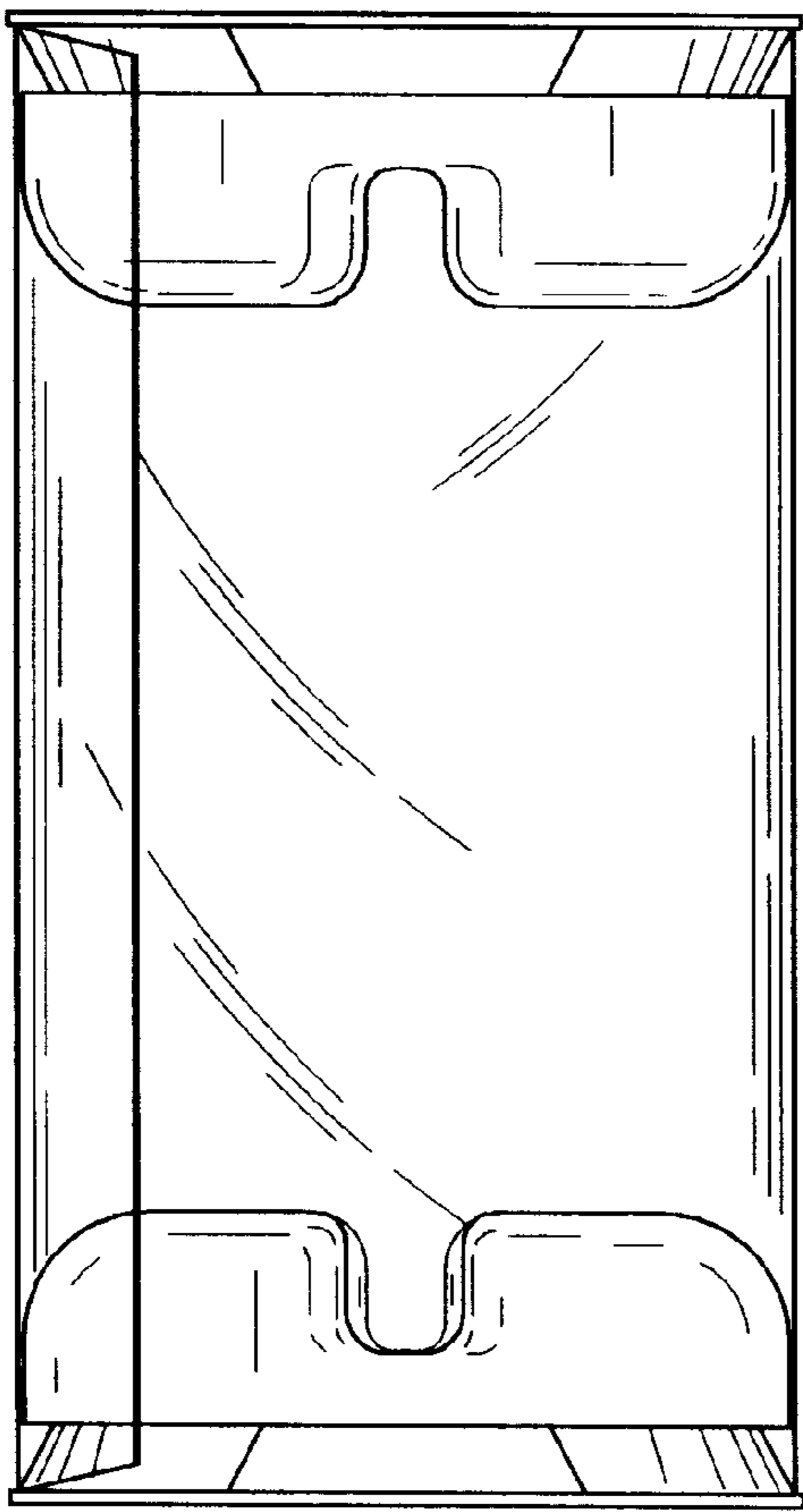

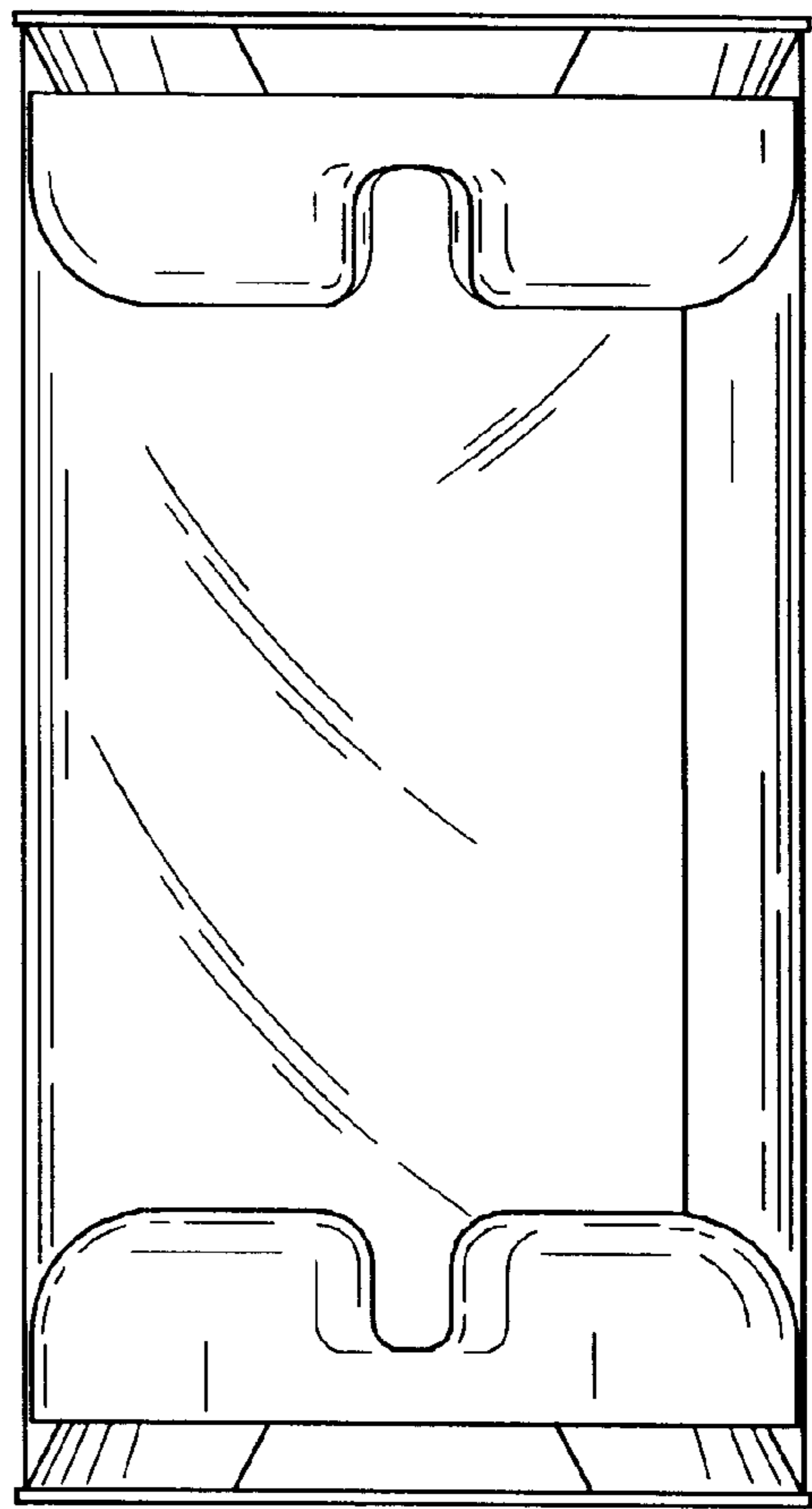

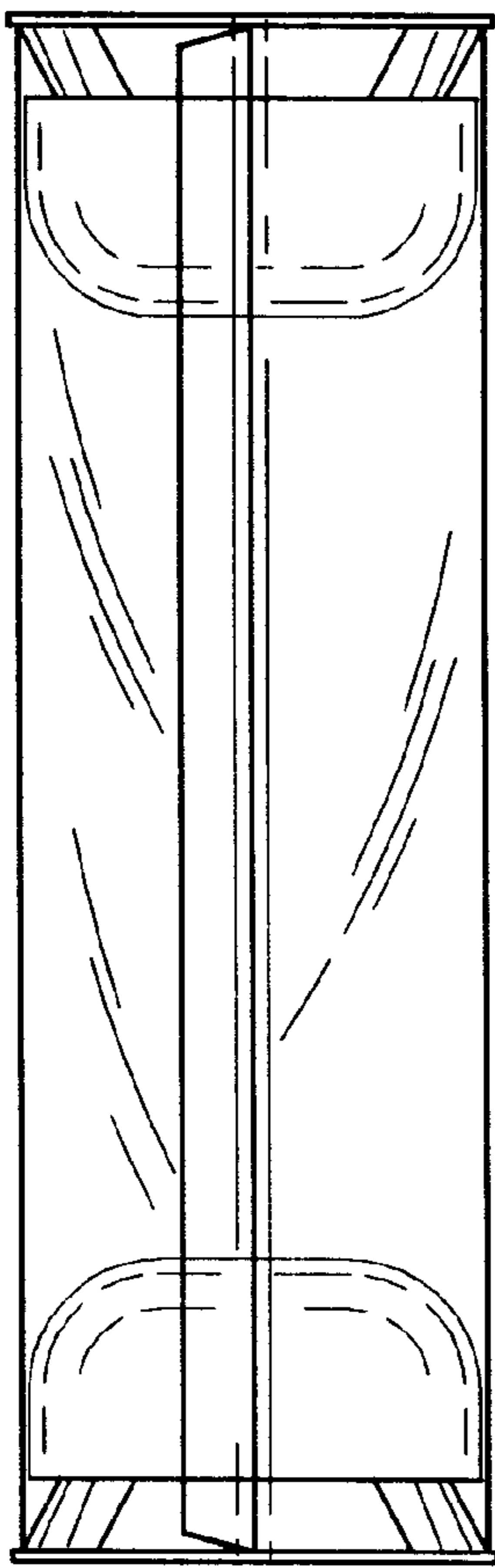

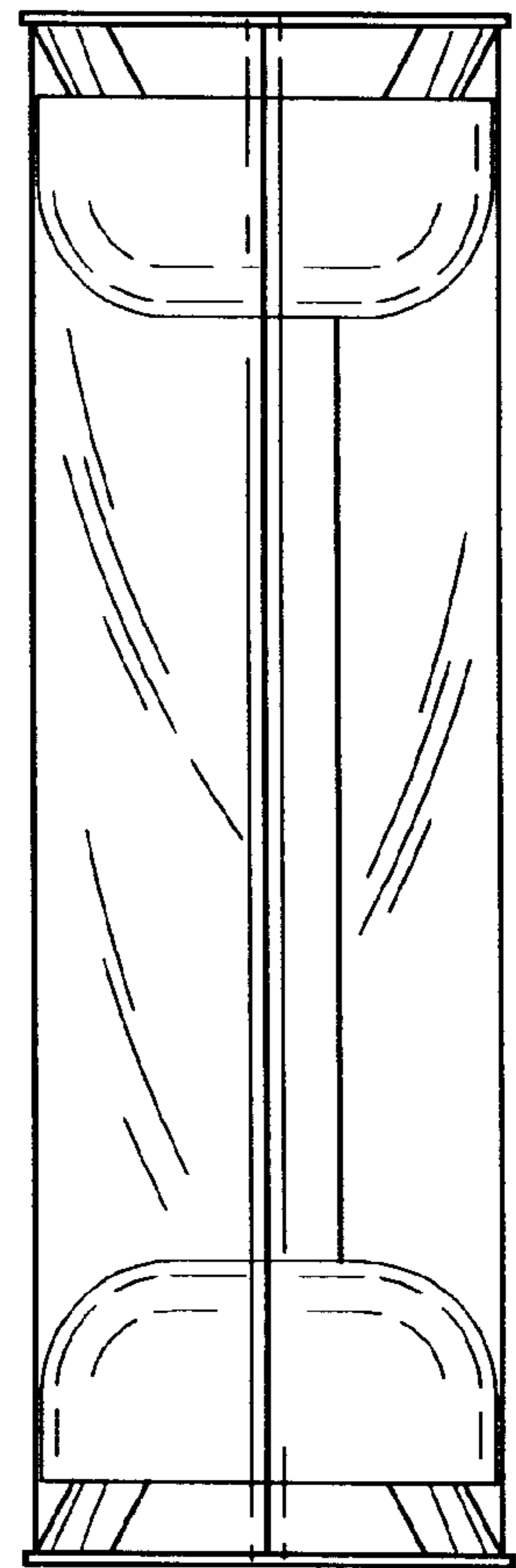

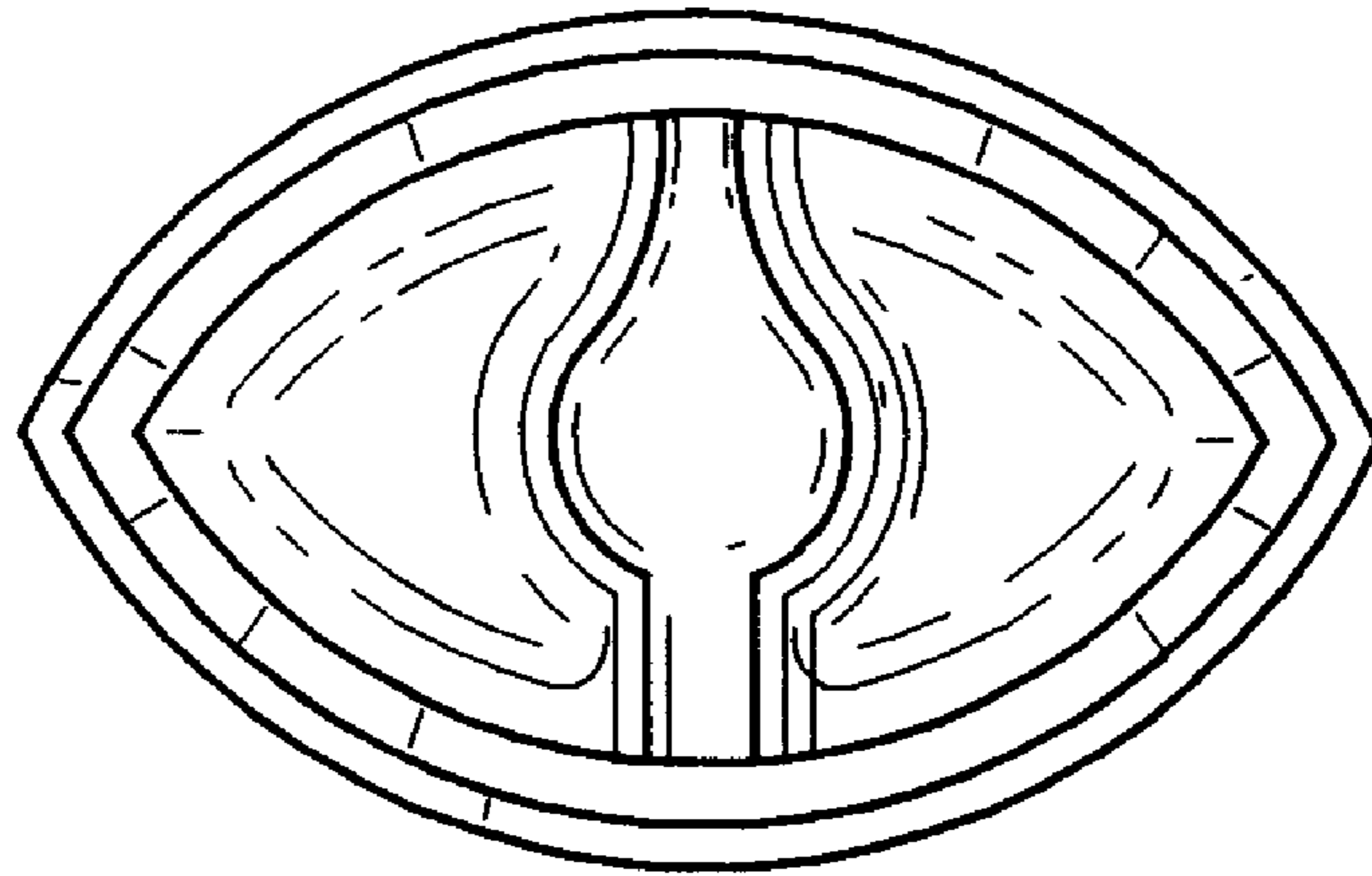
