(57) **CLAIM**

The ornamental design for a track propelled small loader, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a track propelled small loader embodying our new design;

FIG. 3 is a front elevational view thereof;

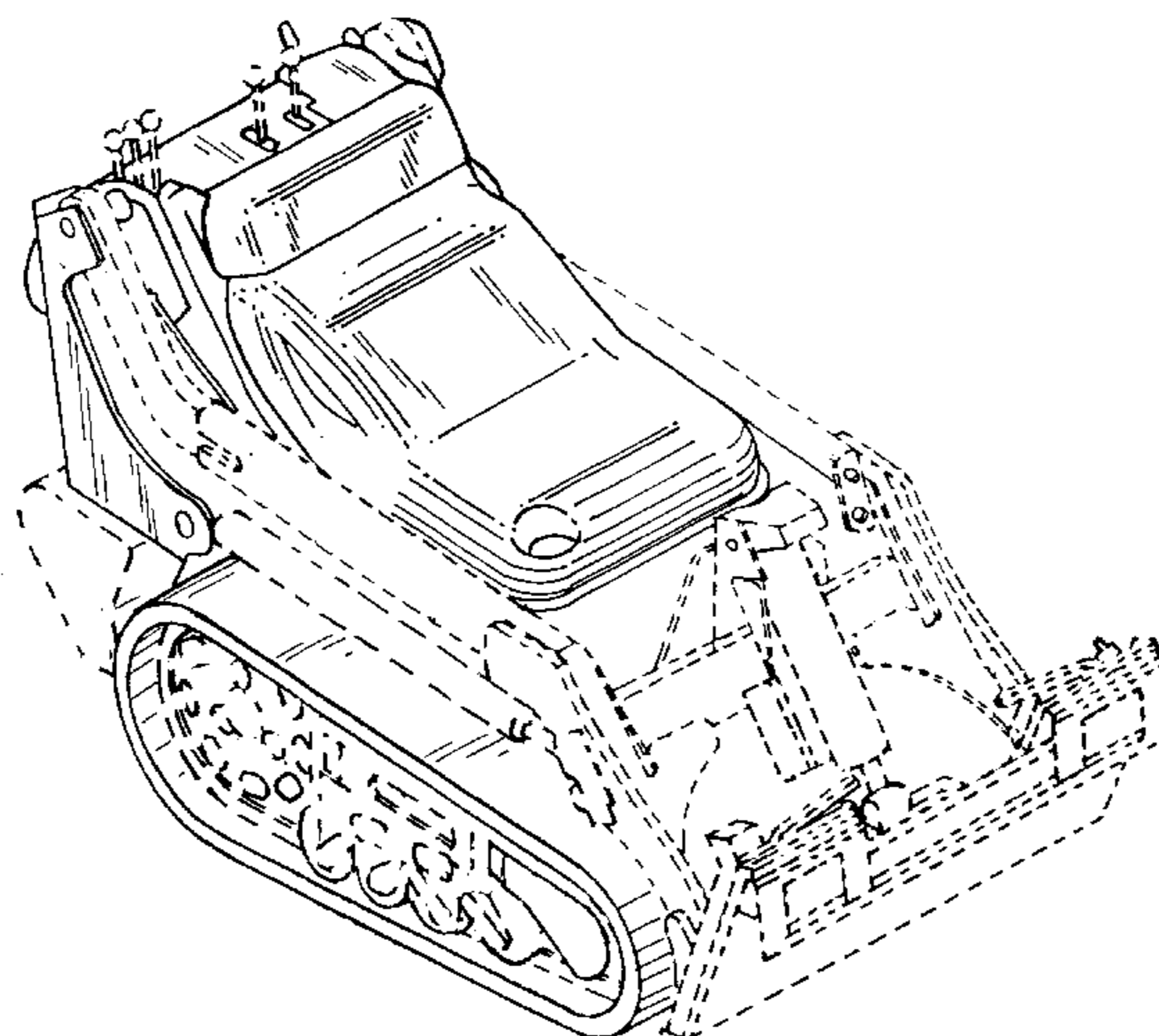
FIG. 4 is a rear elevational view of thereof;

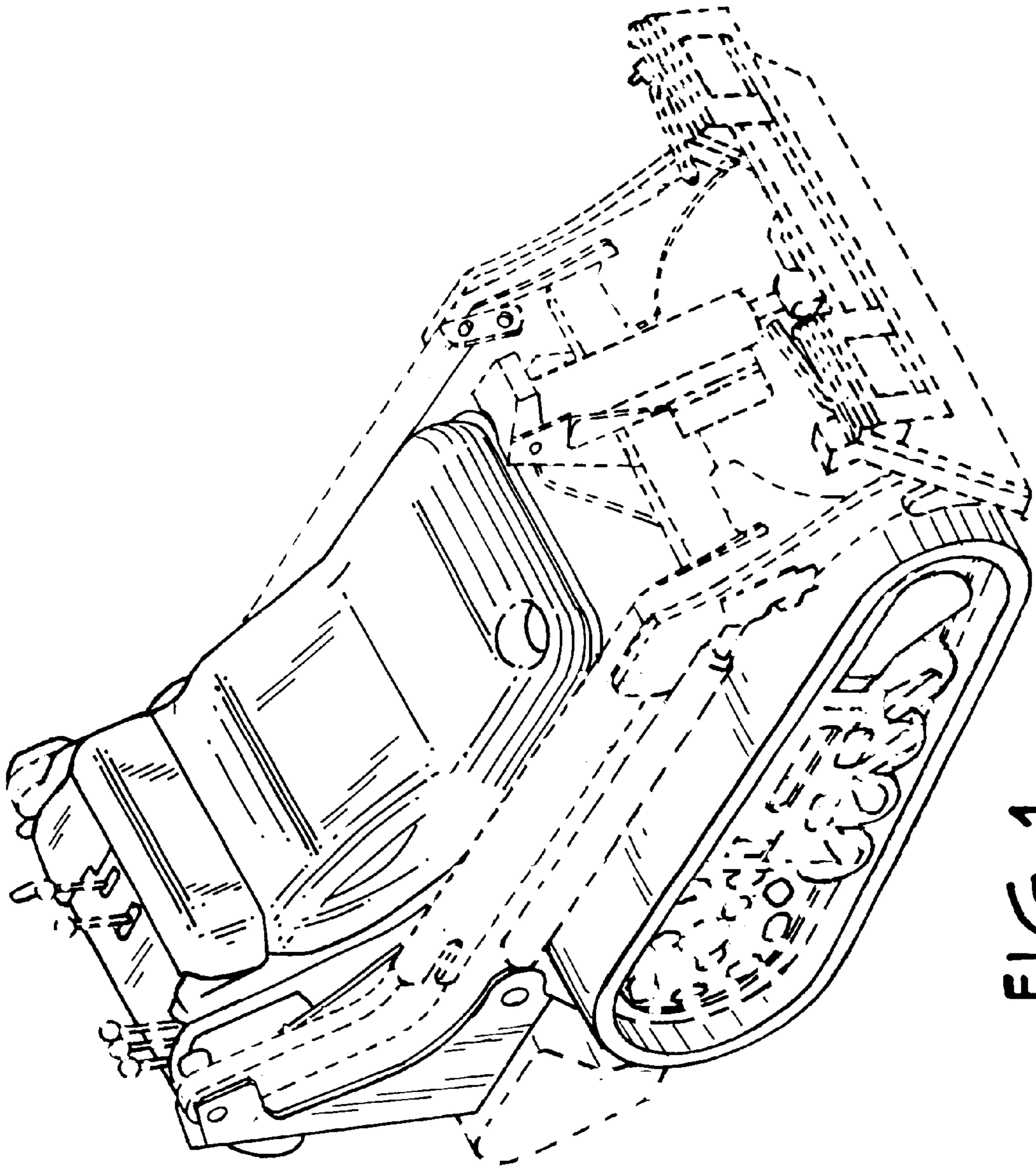

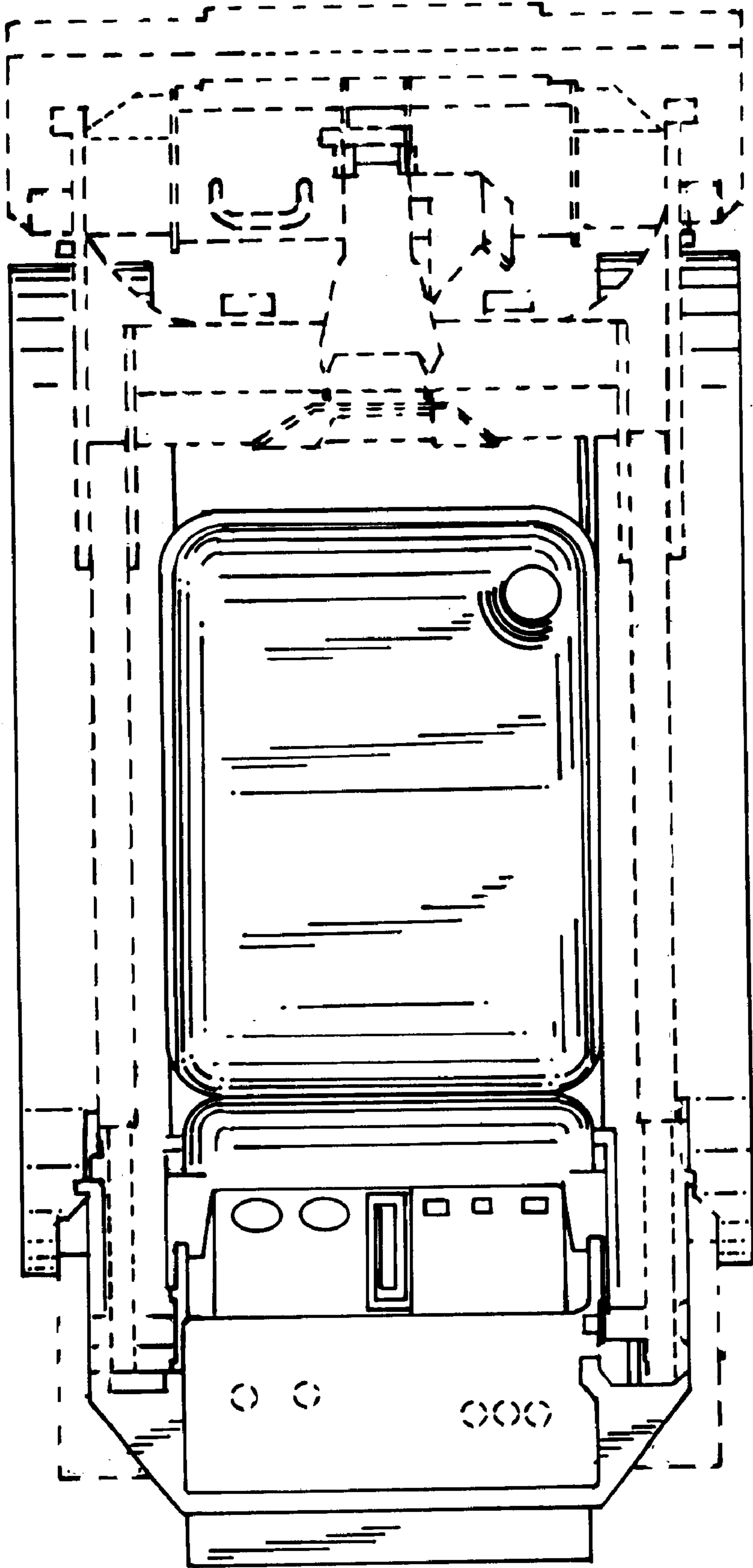

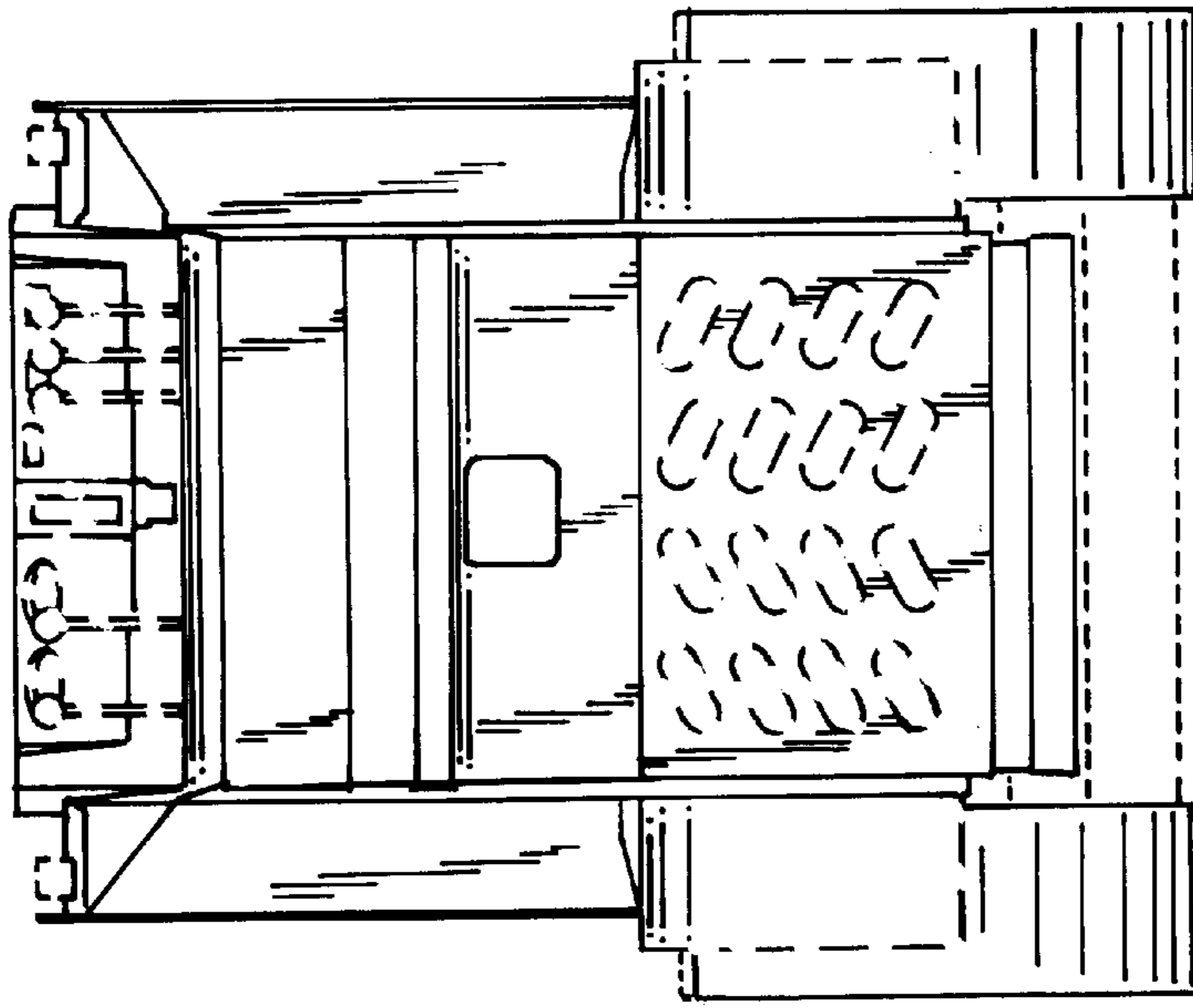

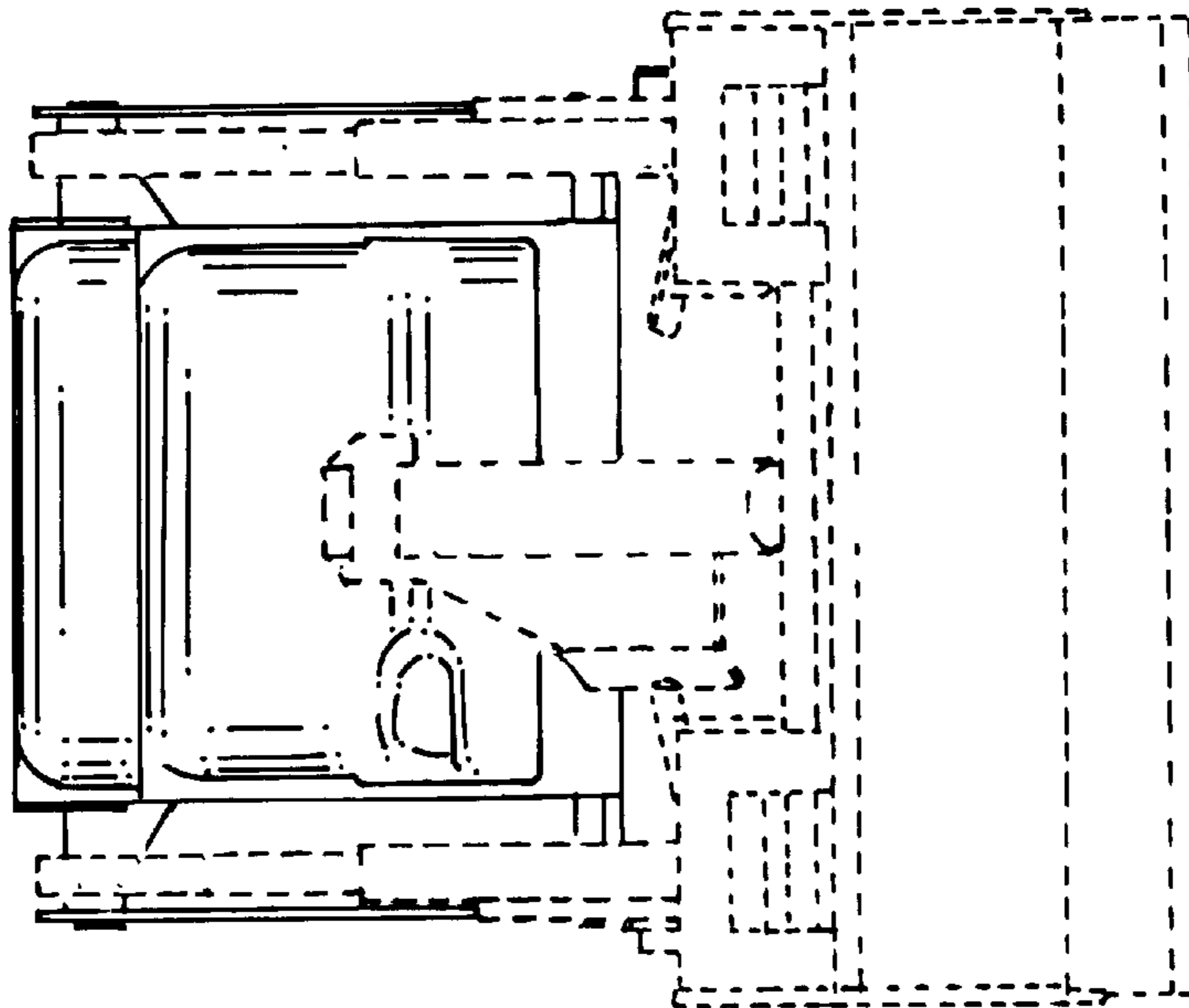

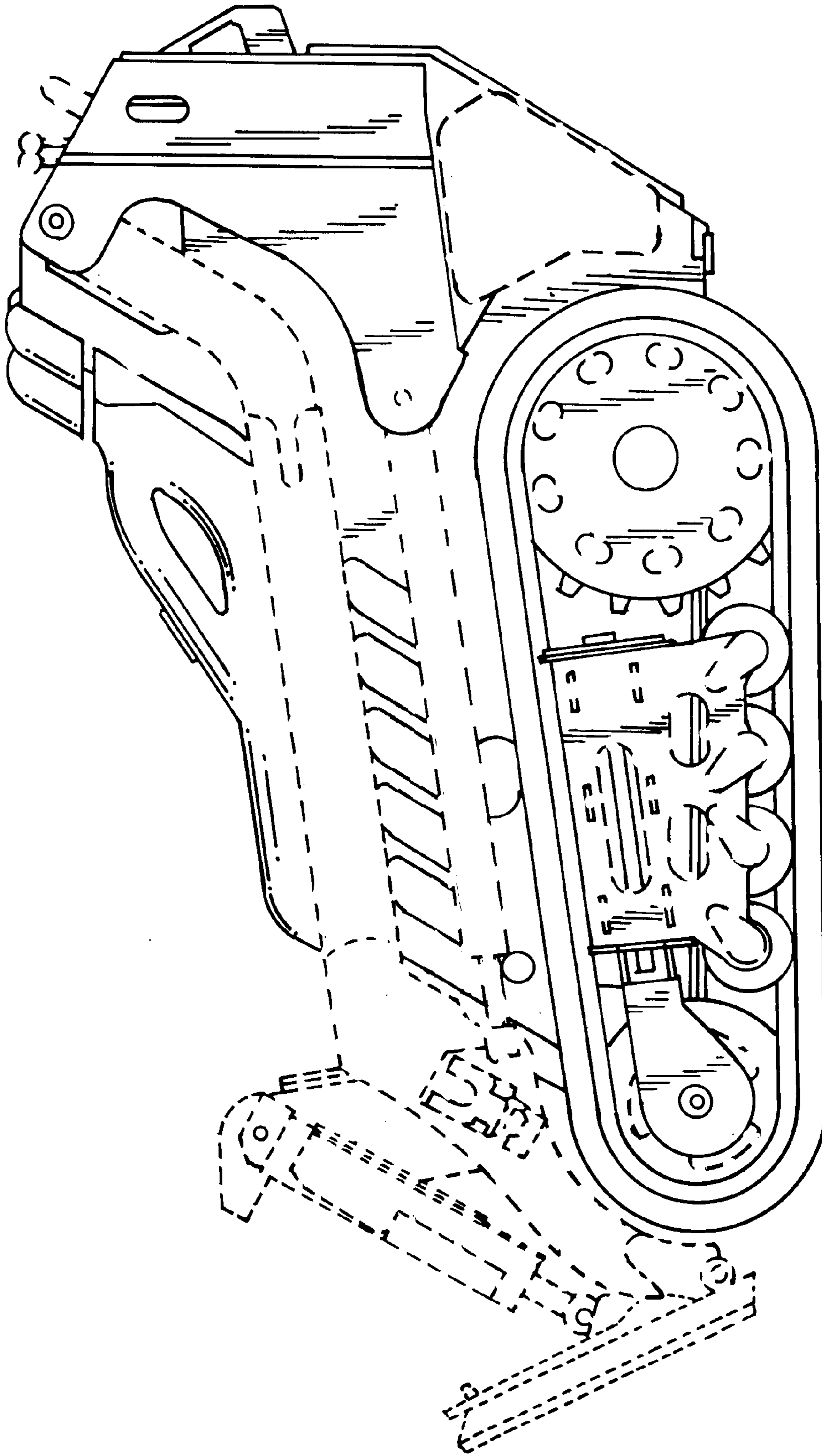

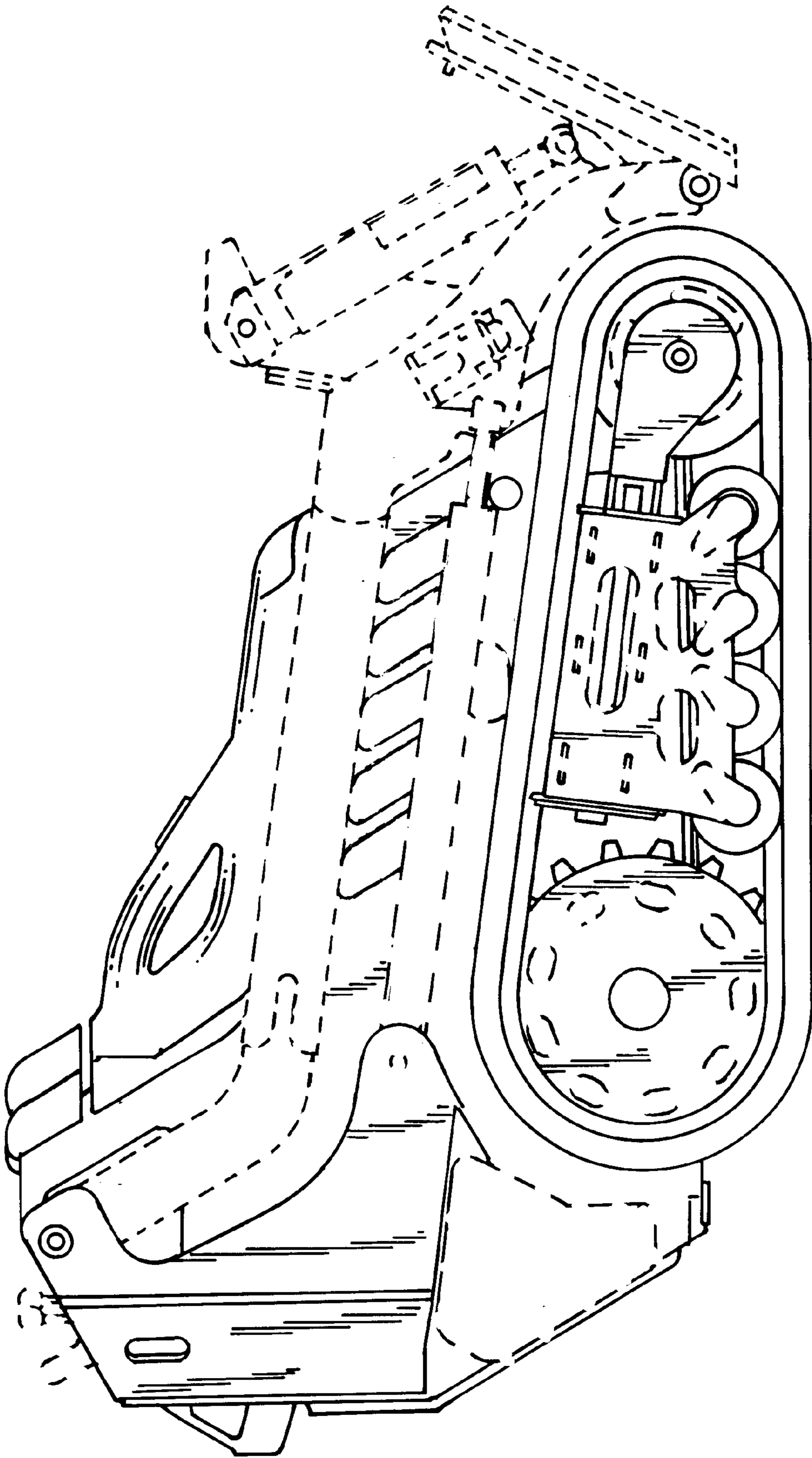

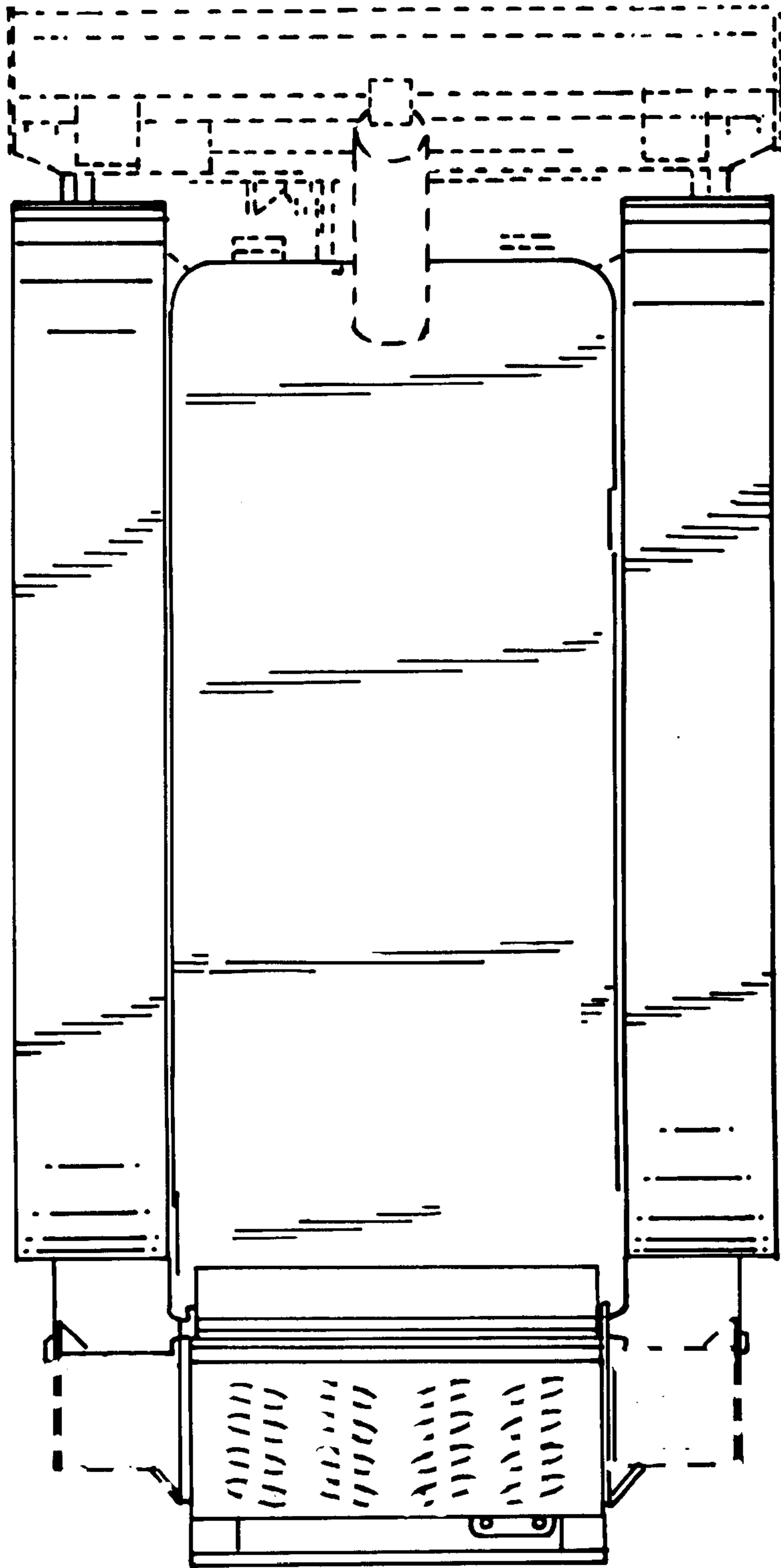
