**DESCRIPTION**

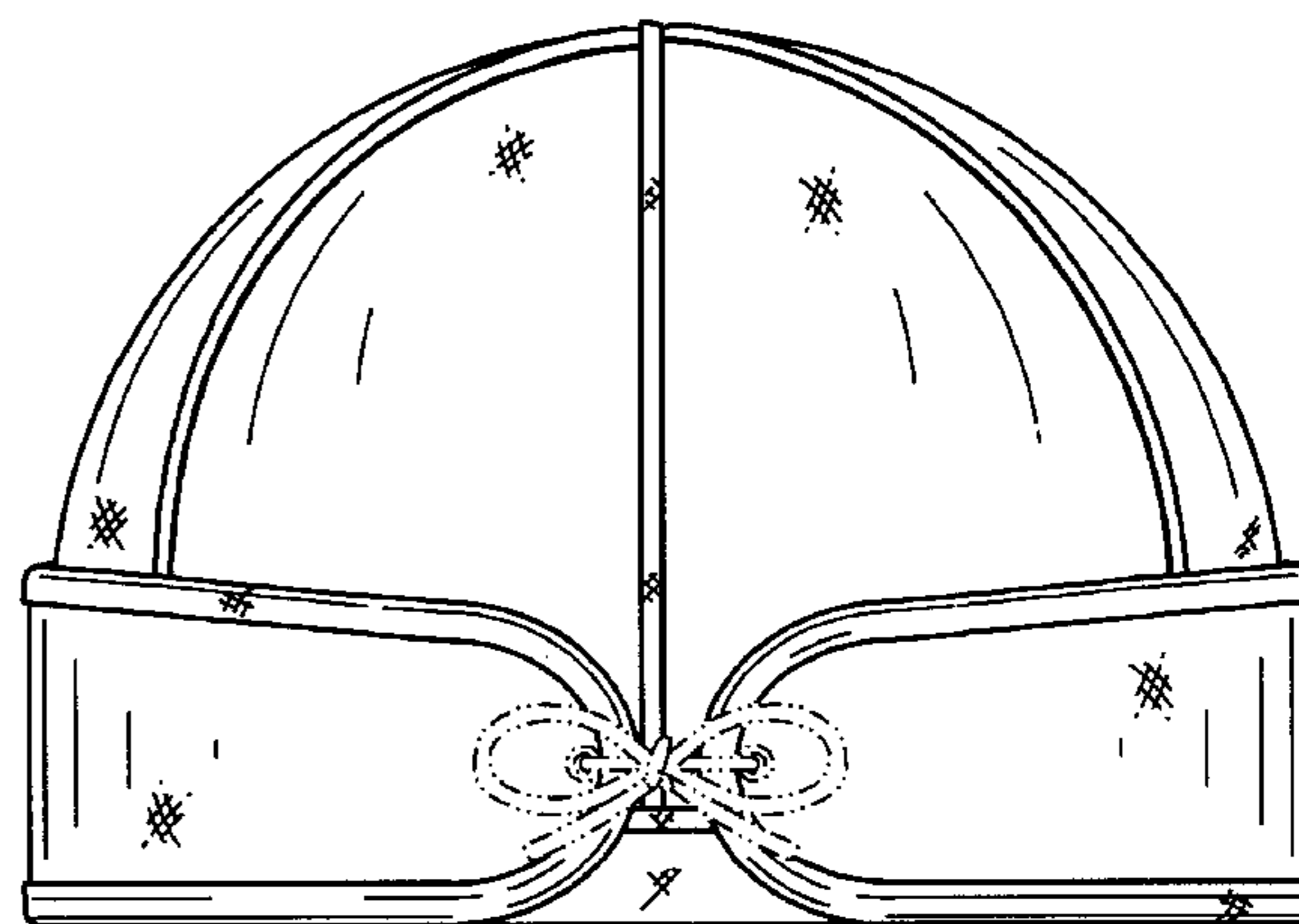
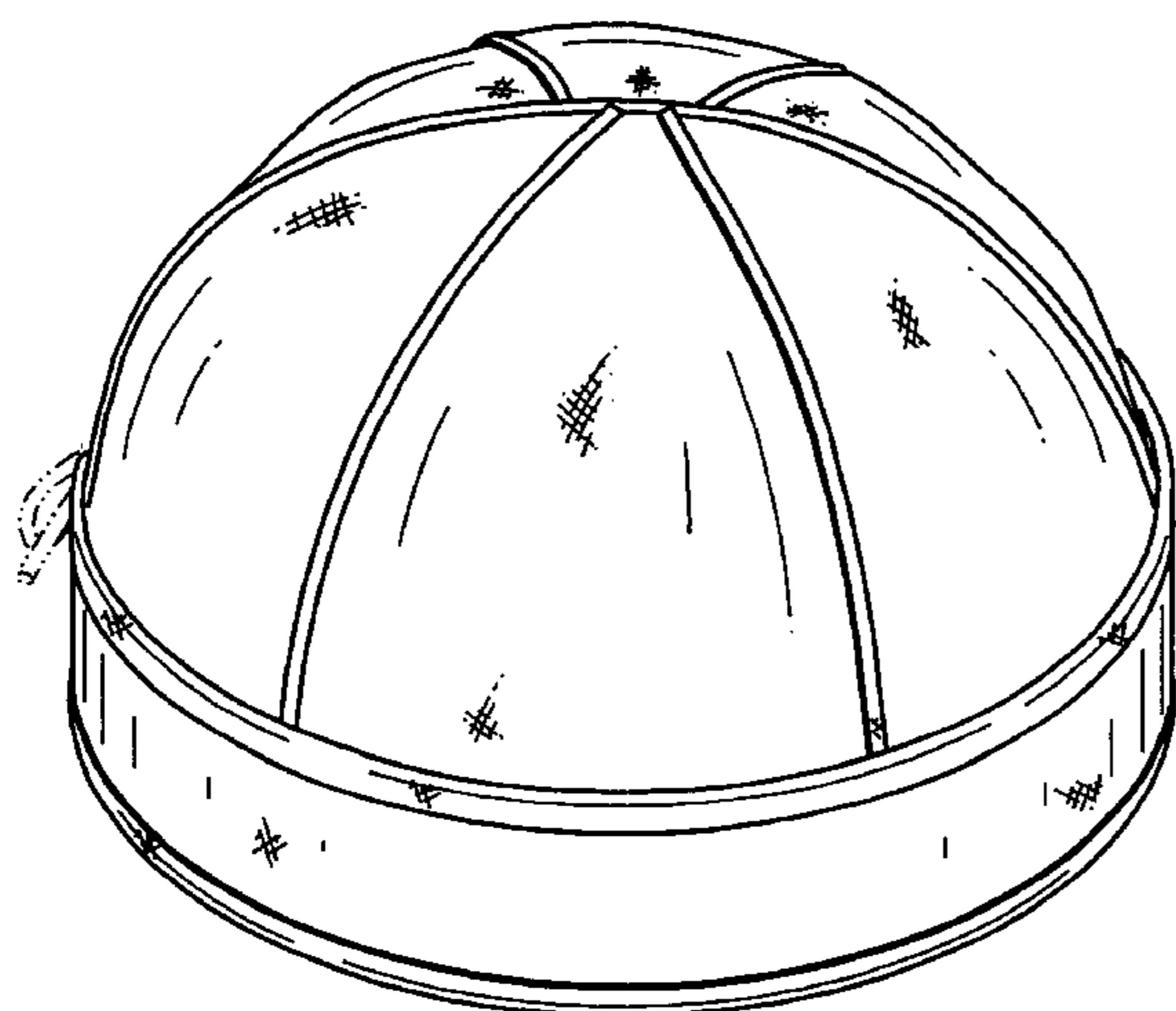

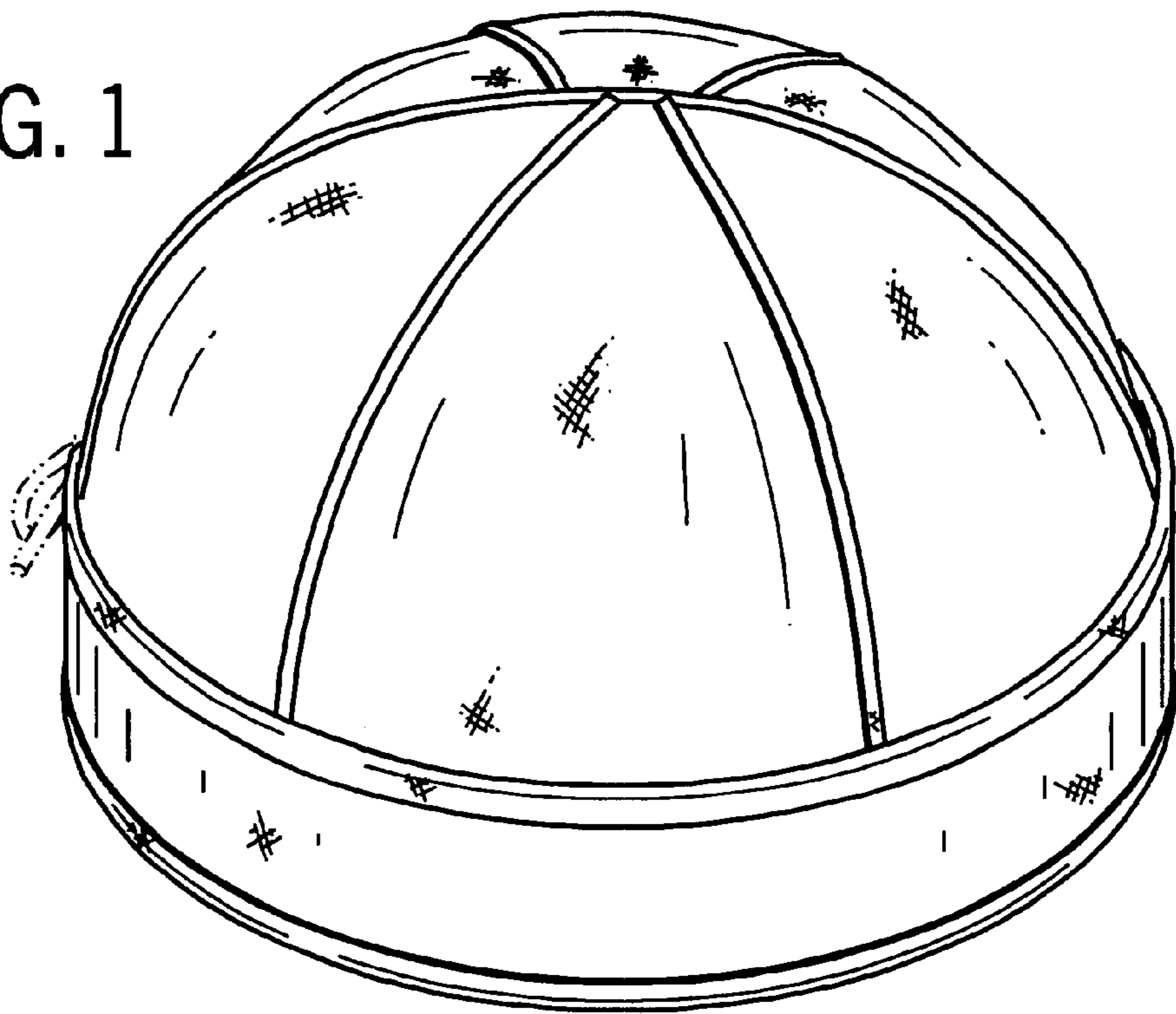

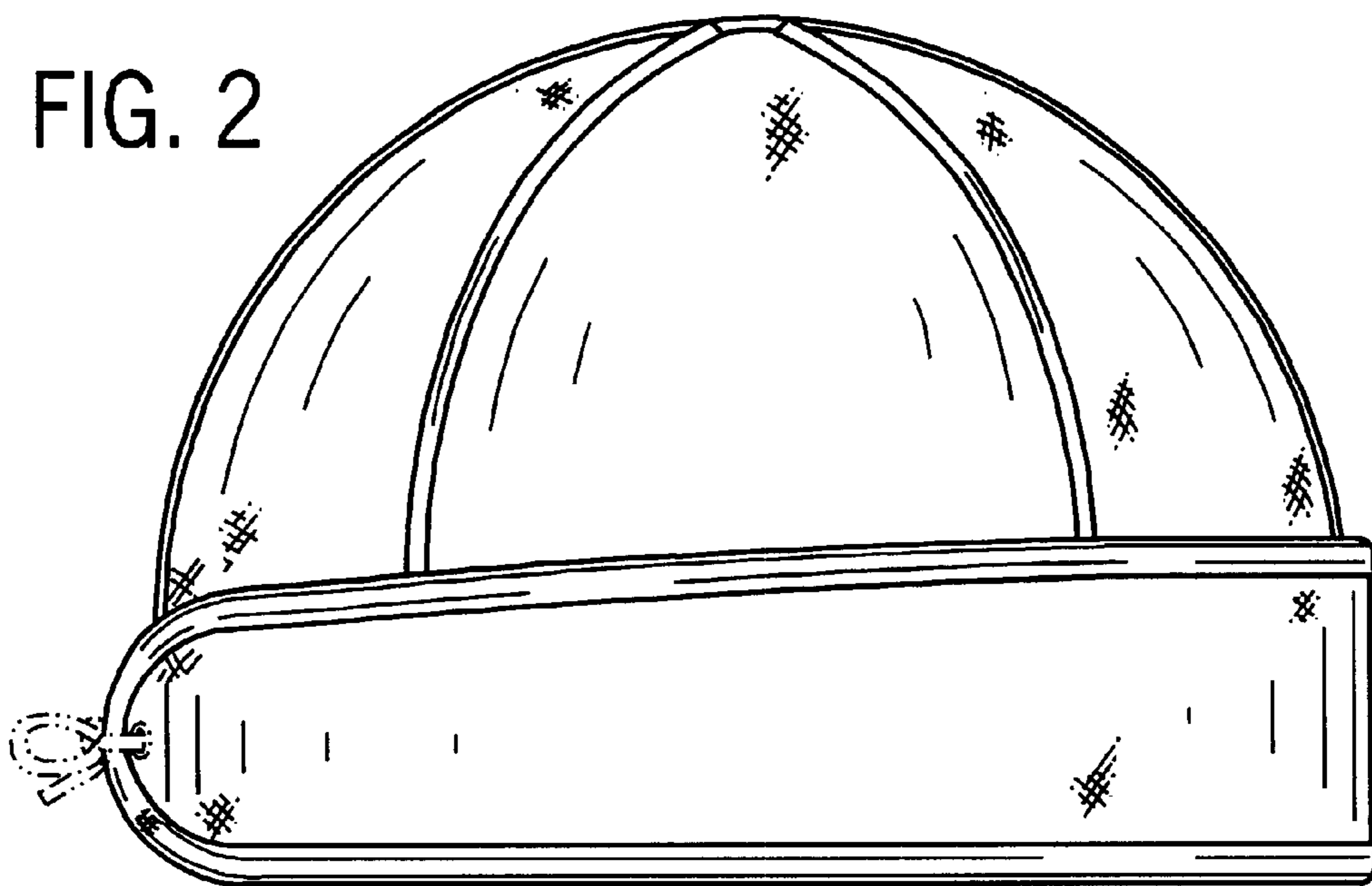

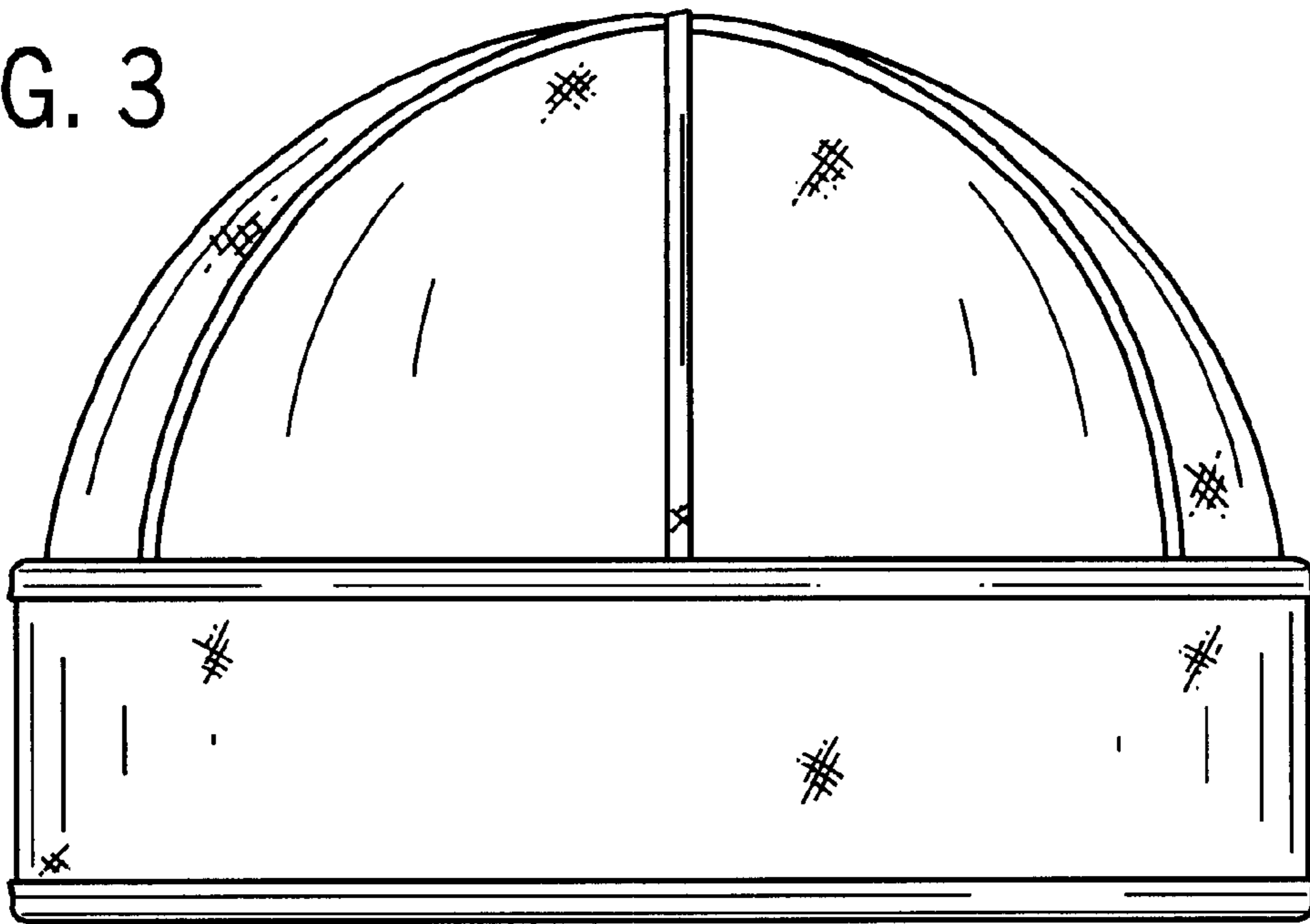

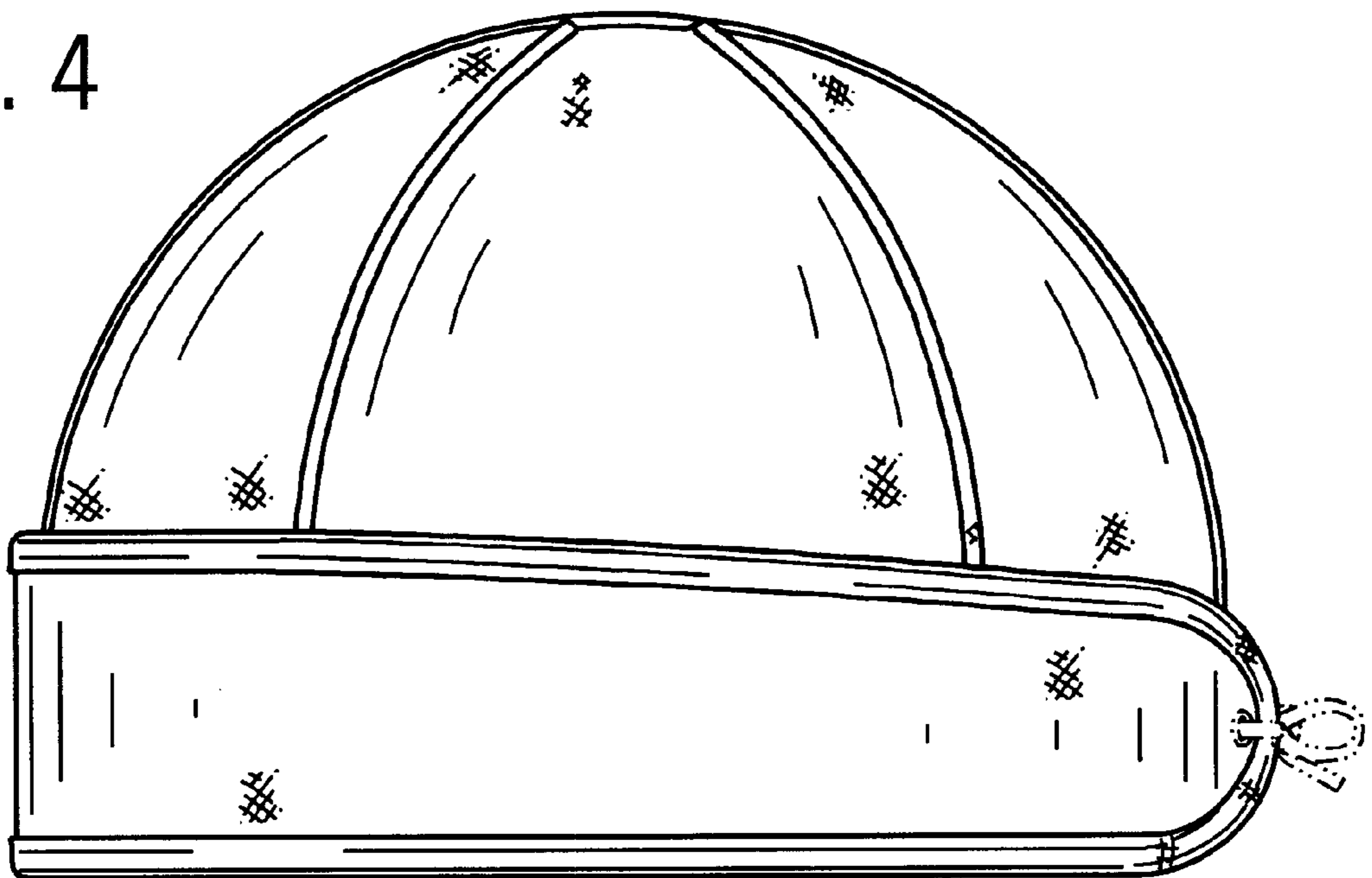

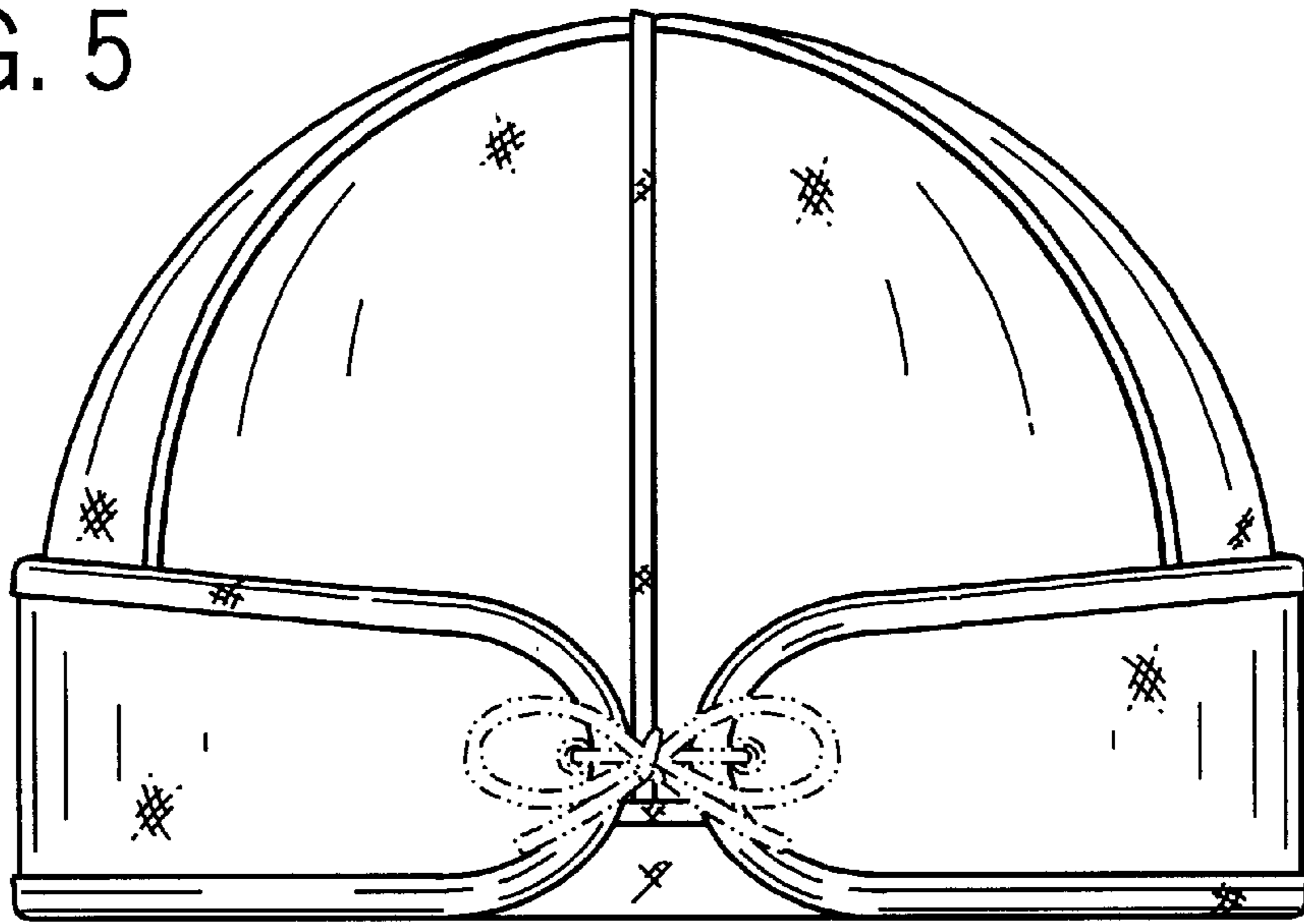

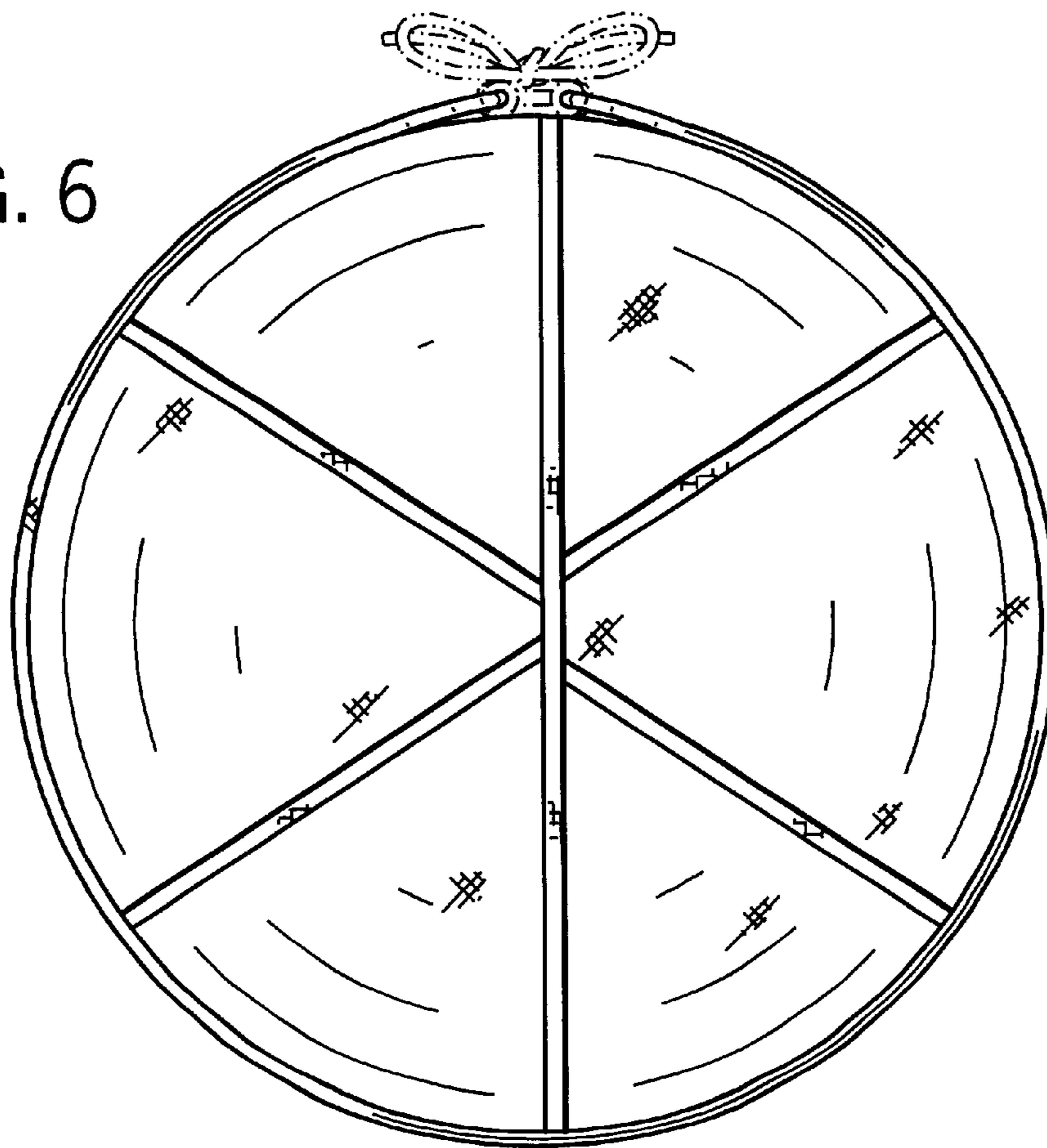
