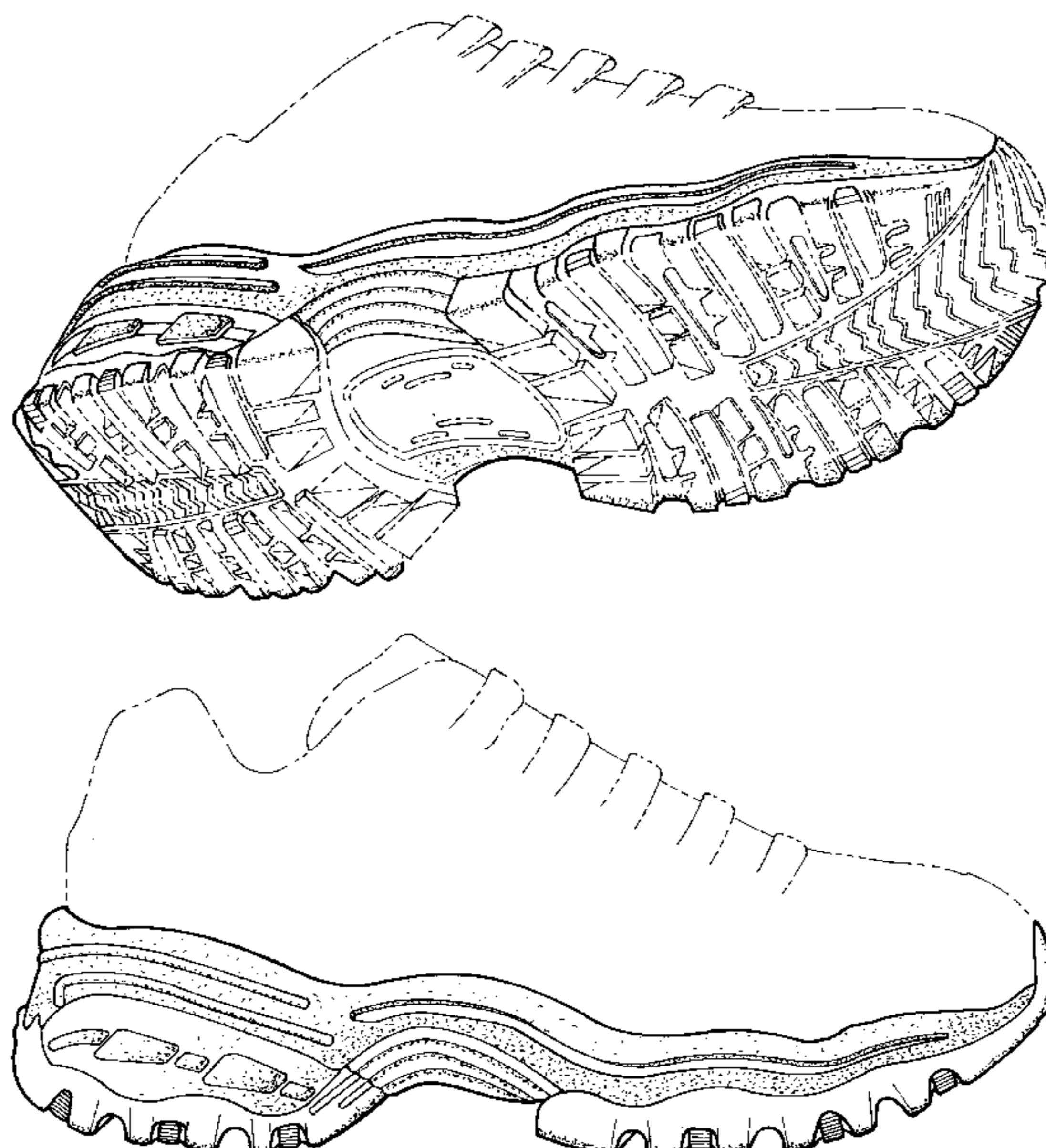
(57) **CLAIM**

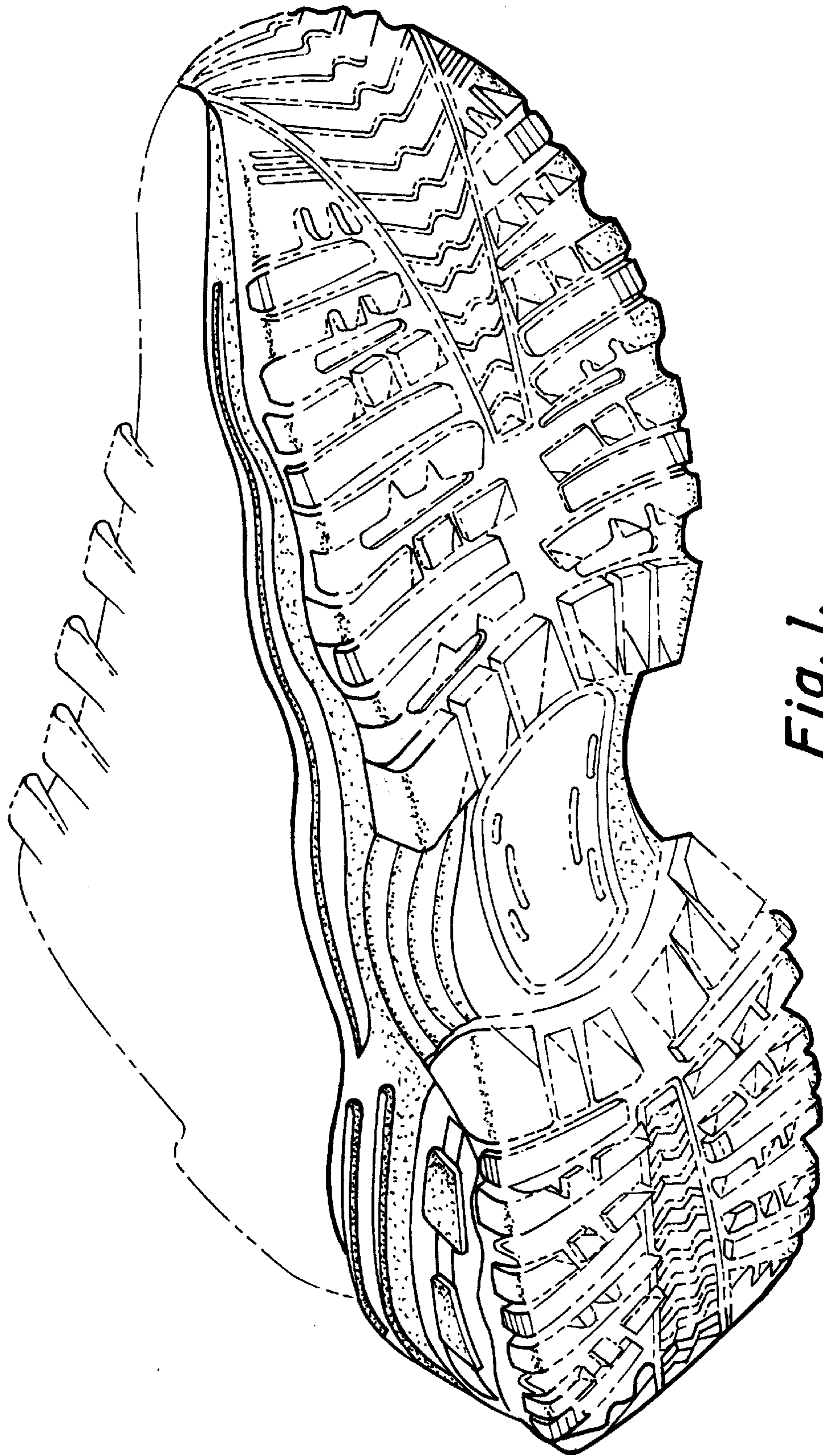
The ornamental design for a shoe bottom periphery, as shown and described.

**DESCRIPTION**

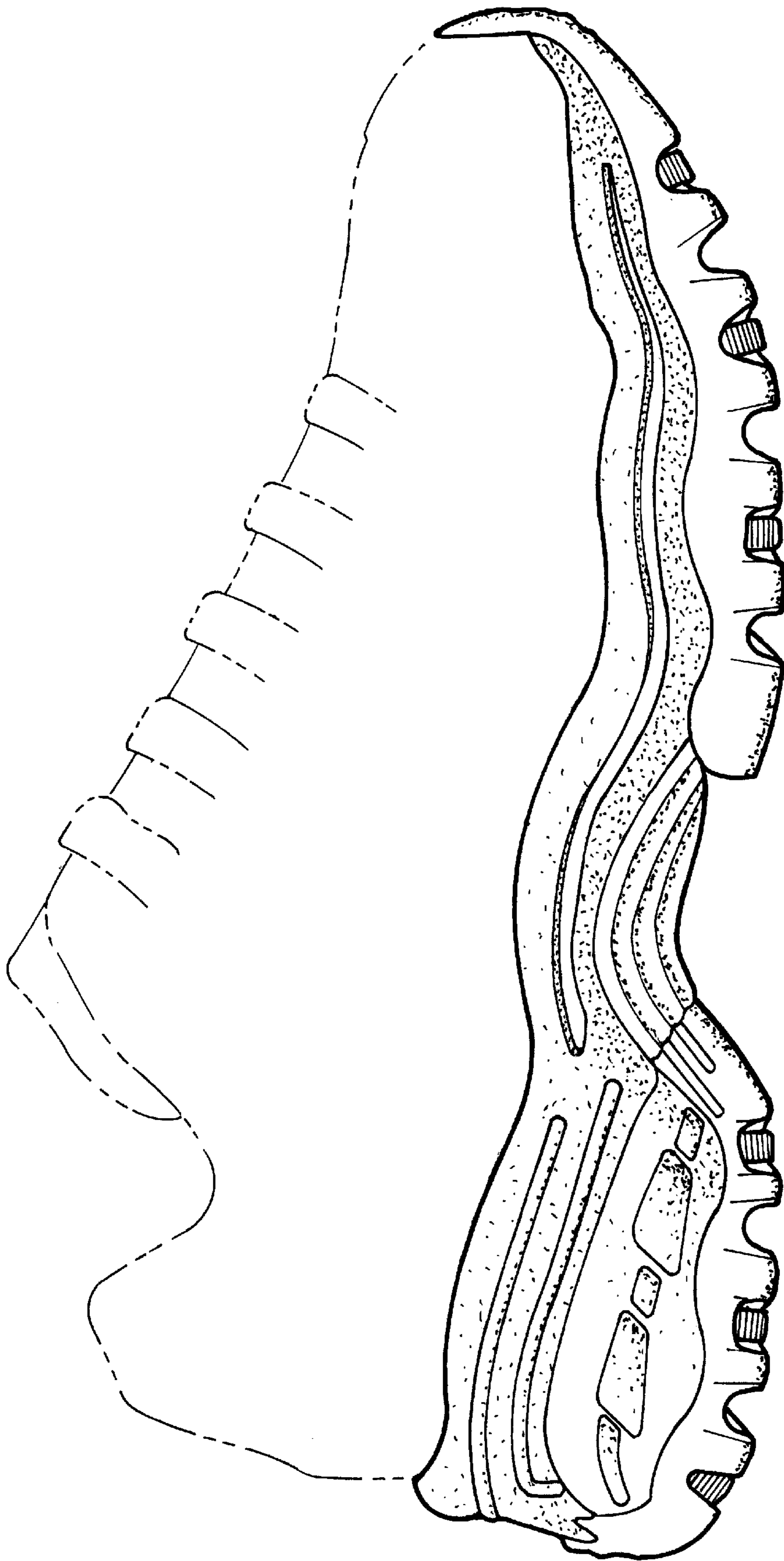
FIG. 1 is a perspective view of the portion of the shoe bottom periphery showing my new design; FIG. 2 is a right side elevational view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is a front elevational view thereof; and, FIG. 5 is a rear elevational view thereof. The broken lines showing the shoe upper and features on the sole, in the figures are for illustrative purposes only and form no part of the claimed design.

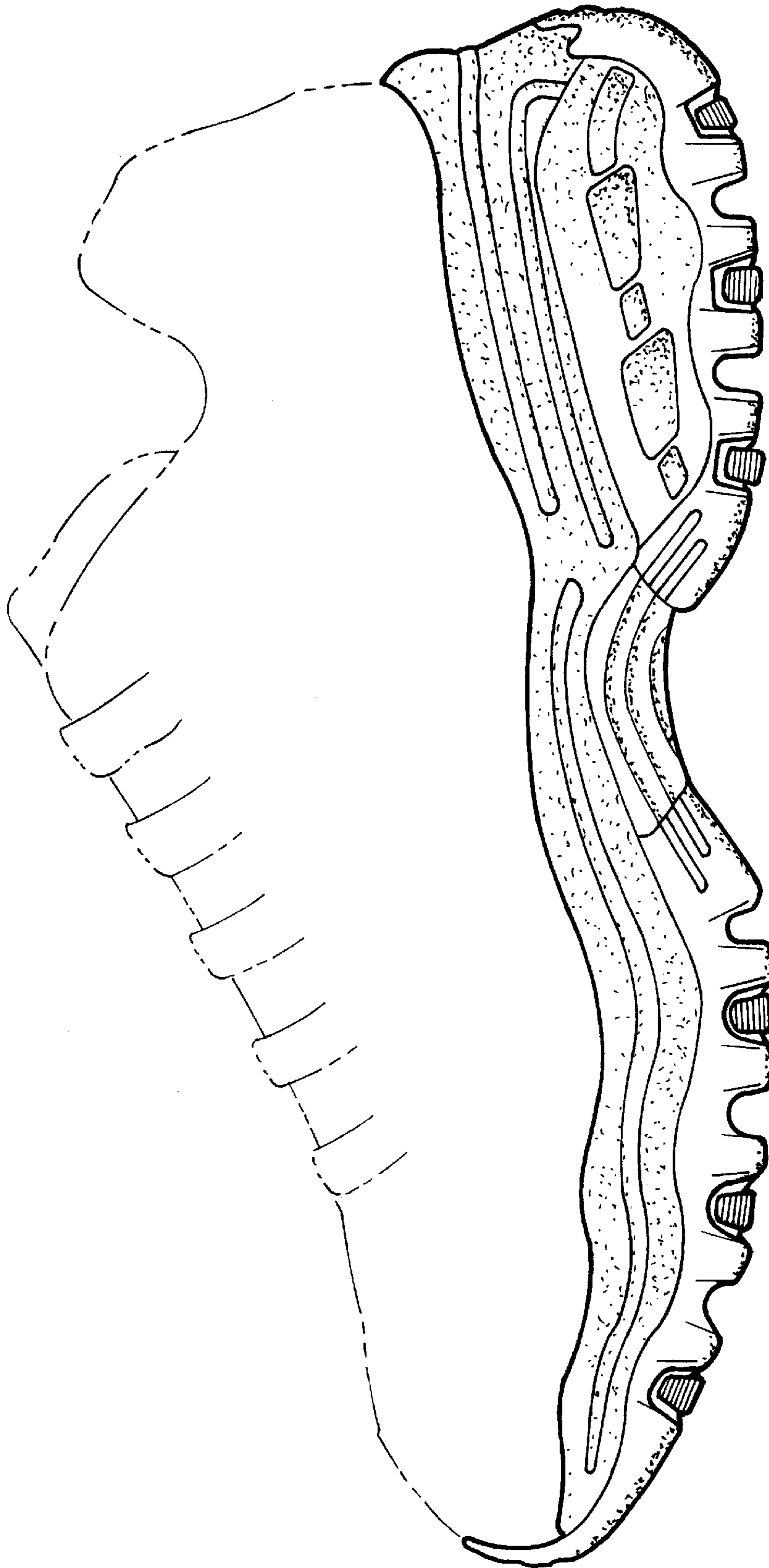




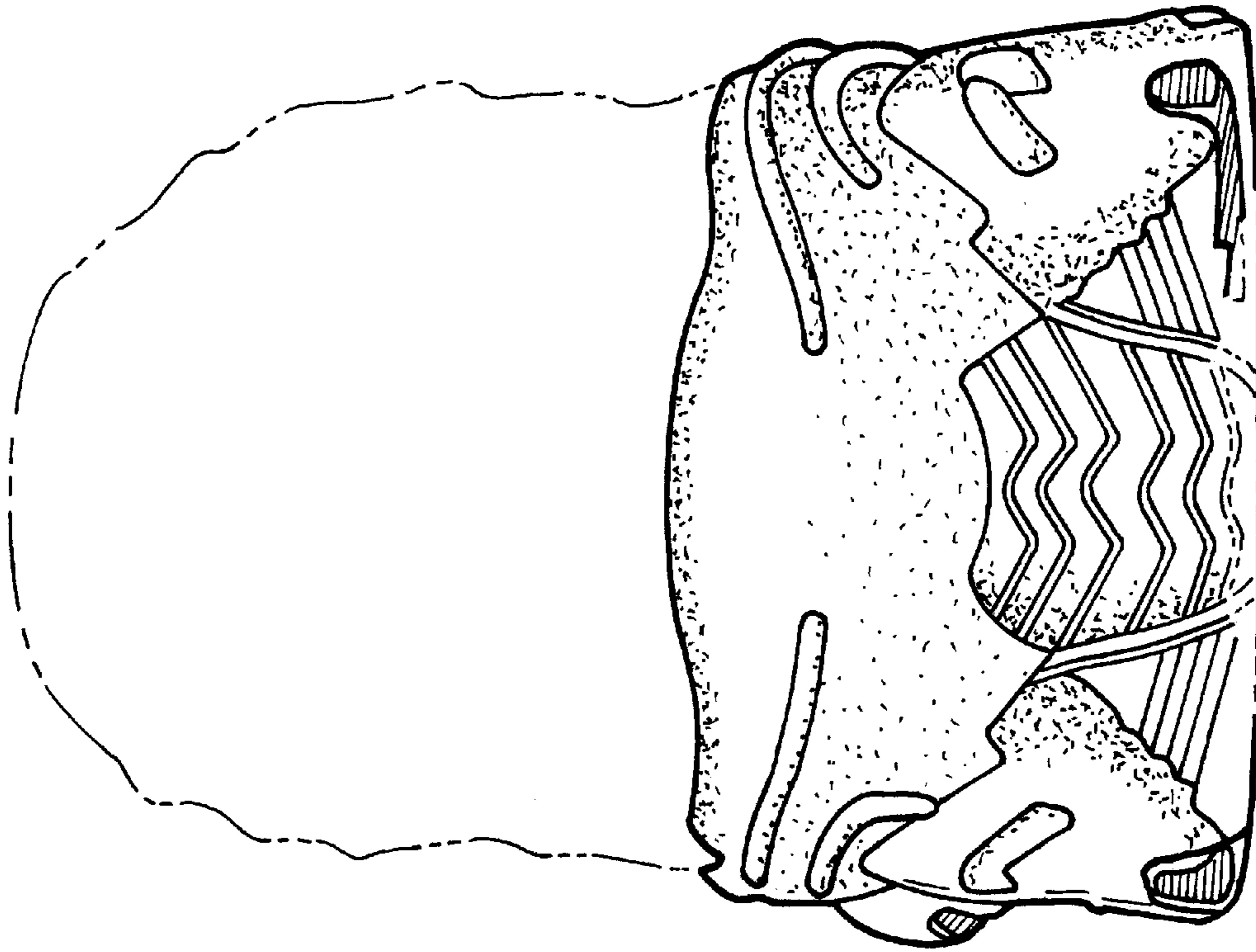

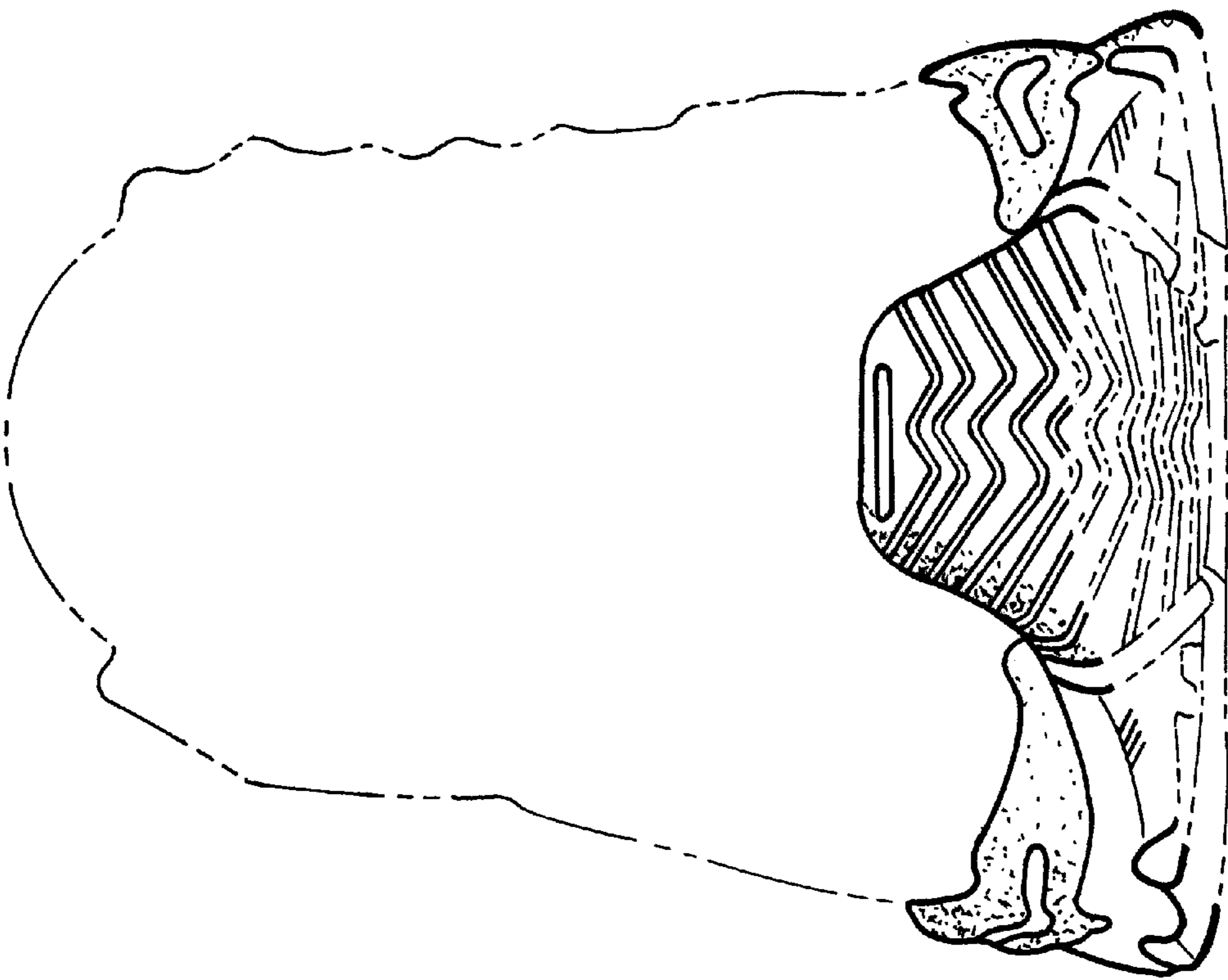
