(57) **CLAIM**

The ornamental design for a paint roller frame cage, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of one embodiment of a paint roller frame cage showing my new design as seen from the outboard end thereof;

FIG. 2 is an enlarged top plan view thereof, the bottom plan view being a mirror image;

FIG. 3 is an enlarged front side elevation view thereof, the back side being a mirror image;

FIG. 4 is an enlarged right end elevation view thereof;

FIG. 5 is an enlarged left end elevation view thereof;

FIG. 6 is a top plan view of a second embodiment of a paint roller frame cage showing my new design, the bottom plan view being a mirror image;

FIG. 7 is a front side elevation view of the paint roller frame cage of FIG. 6, the back side being a mirror image;

FIG. 8 is a right end elevation view of the paint roller frame cage of FIG. 6;

FIG. 9 is a left end elevation view of the paint roller frame cage of FIG. 6;

FIG. 10 is a top plan view of a third embodiment of a paint roller frame cage showing my new design, the bottom plan view being a mirror image;

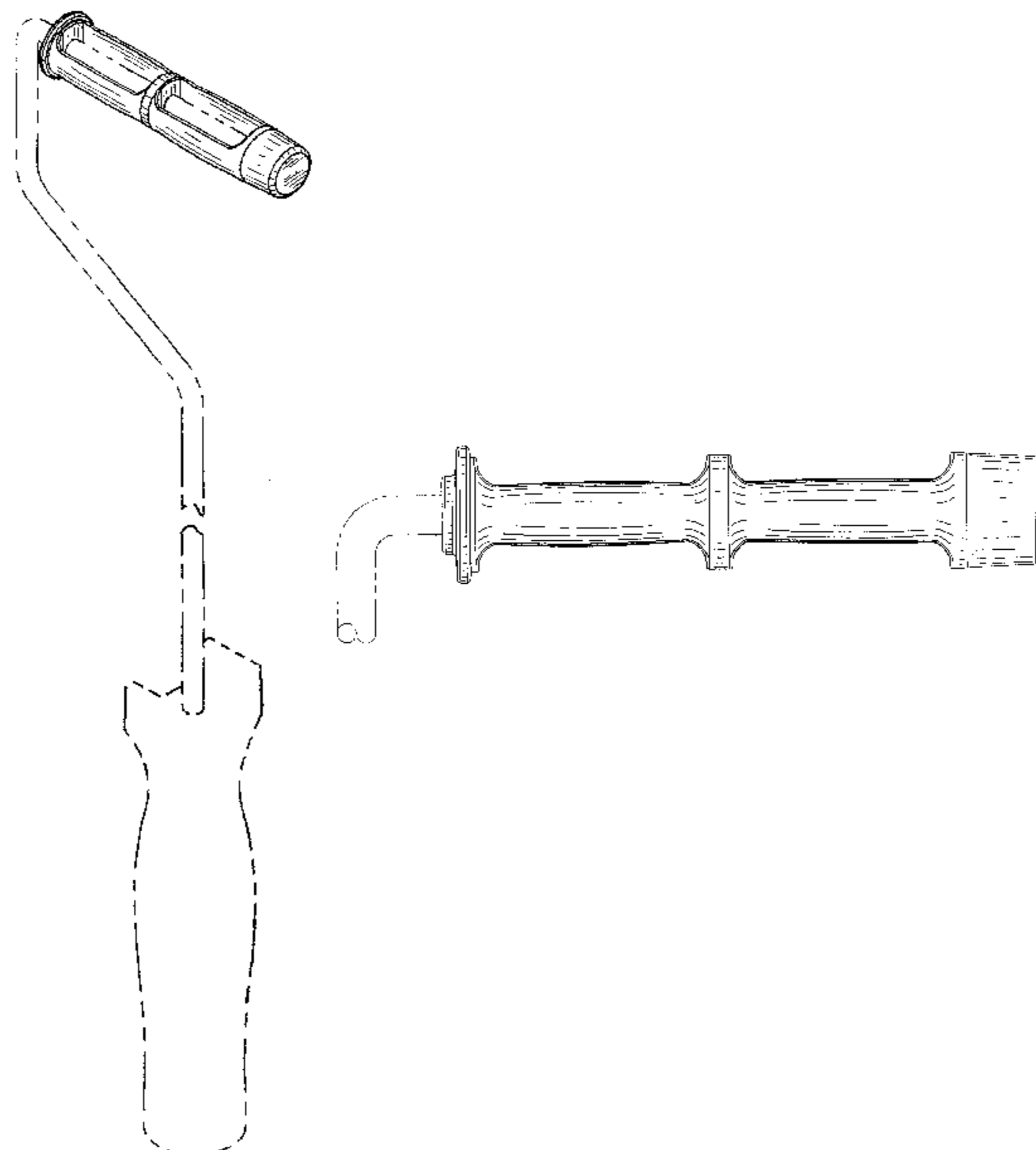
FIG. 11 is a front side elevation view of the paint roller frame cage of FIG. 10, the back side being a mirror image;

FIG. 12 is a right end elevation view of the paint roller frame cage of FIG. 10; and,

FIG. 13 is a left end elevation view of the paint roller frame cage of FIG. 10.

The broken line showing of the wire frame and handle in FIG. 1 and the wire frame in FIGS. 2, 3, 6, 7, 10 and 11 is for illustrative purposes only and forms no part of the claimed design.

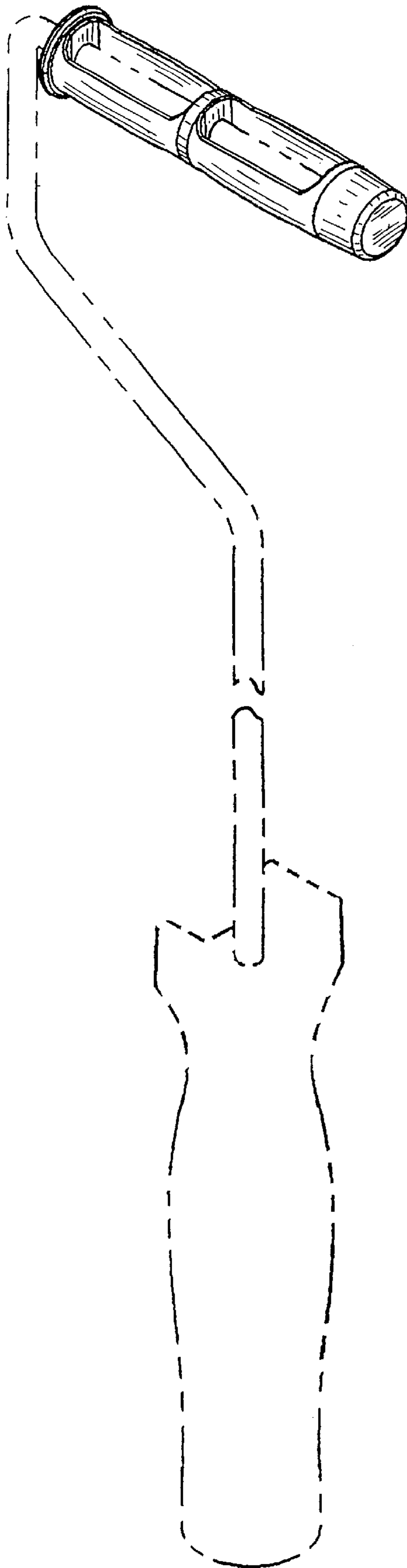

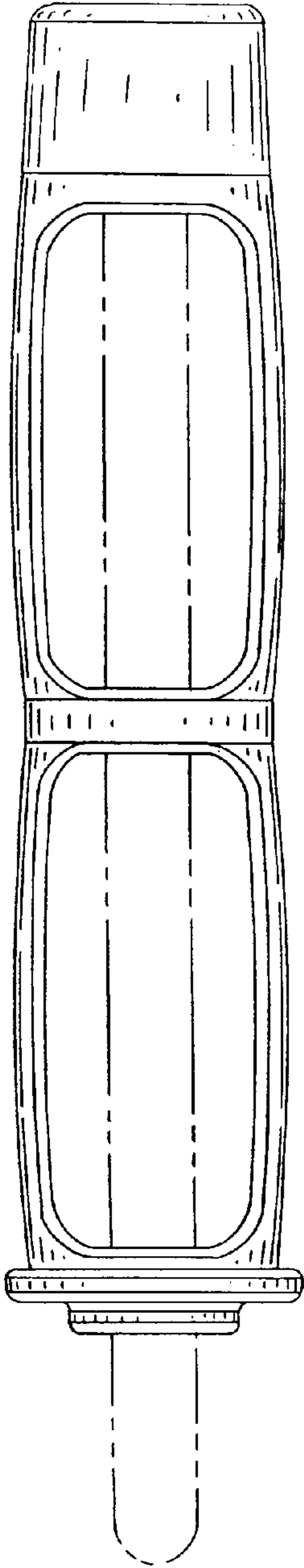

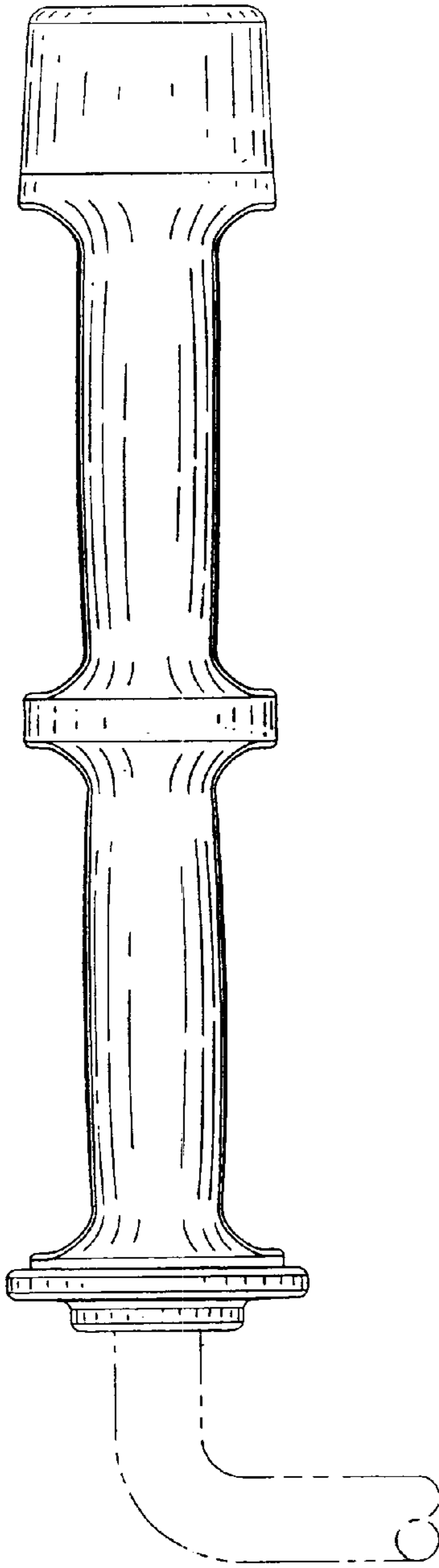

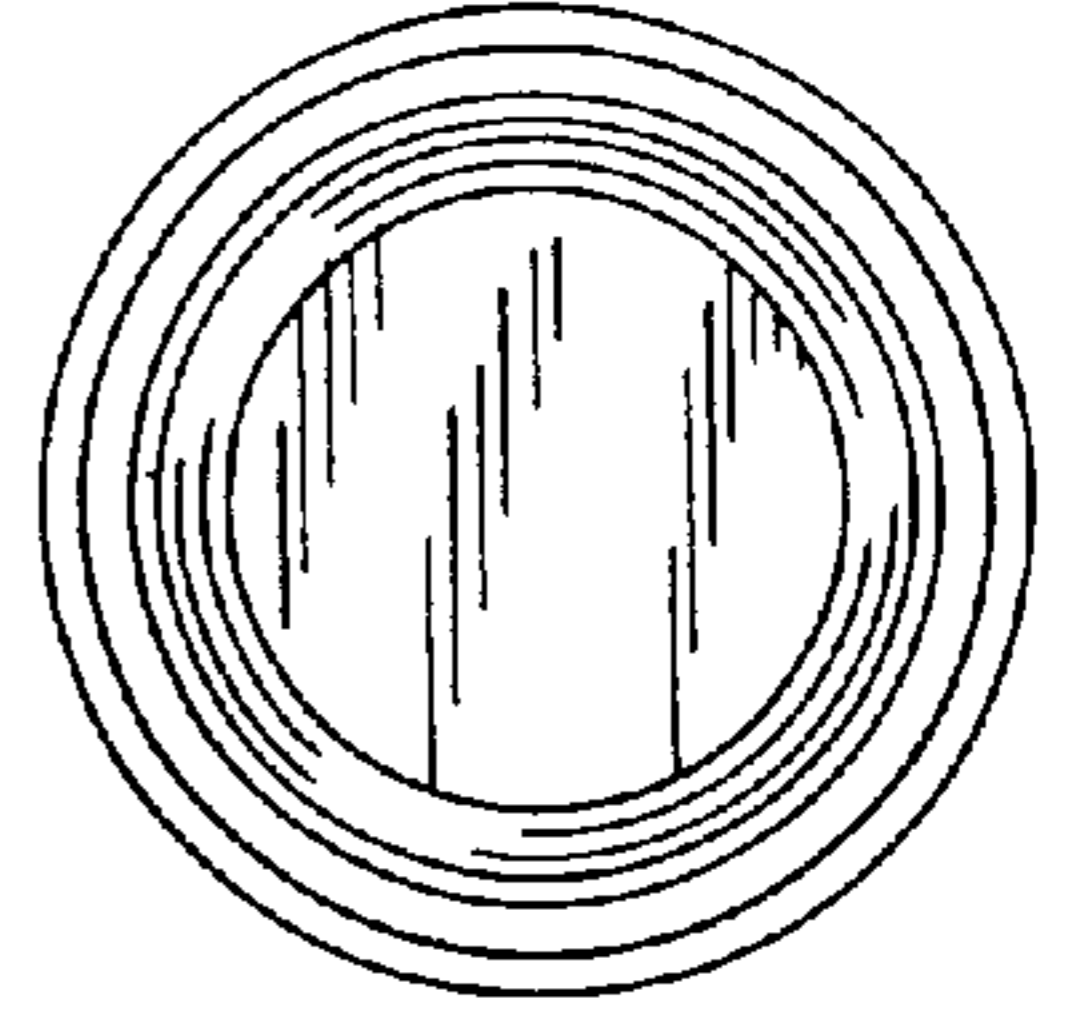
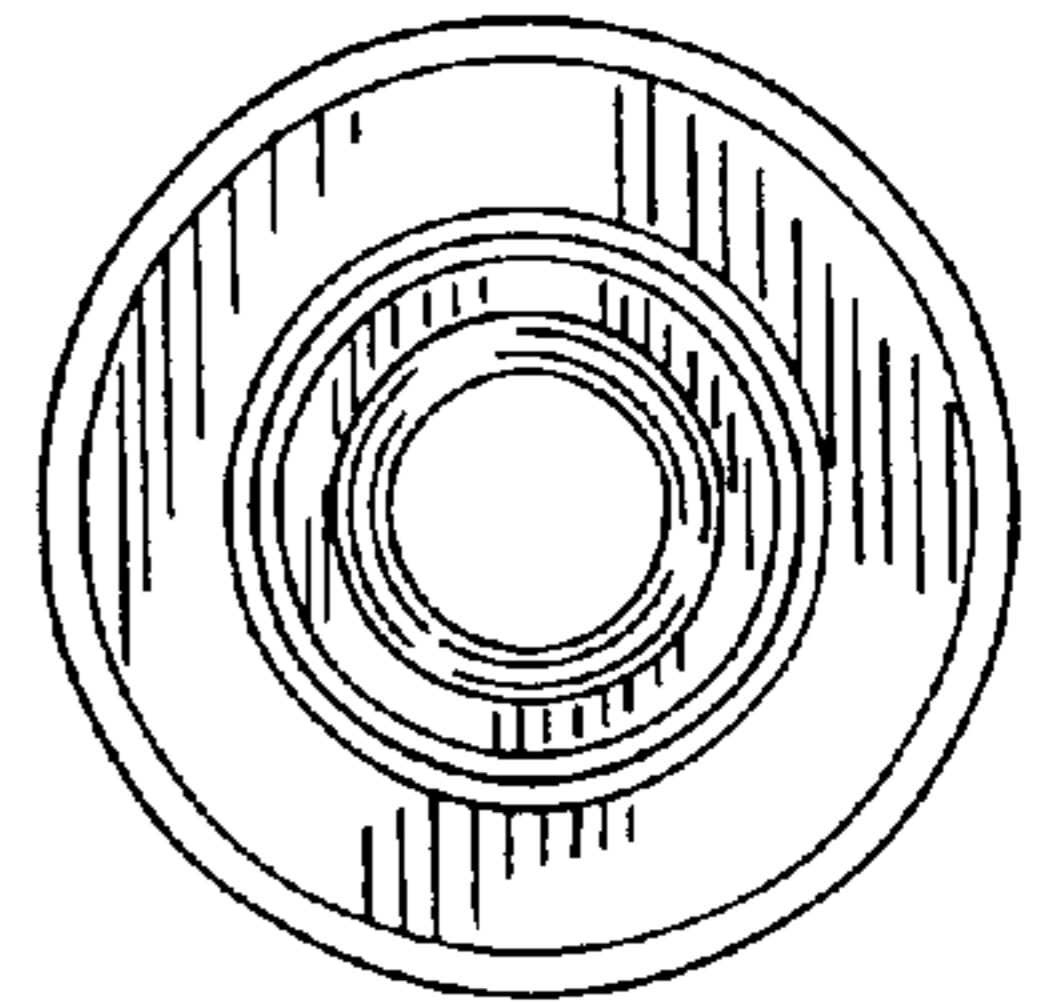

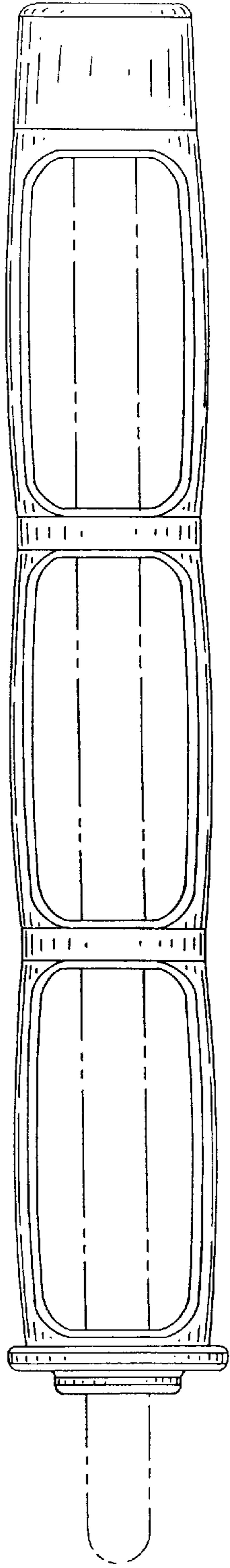

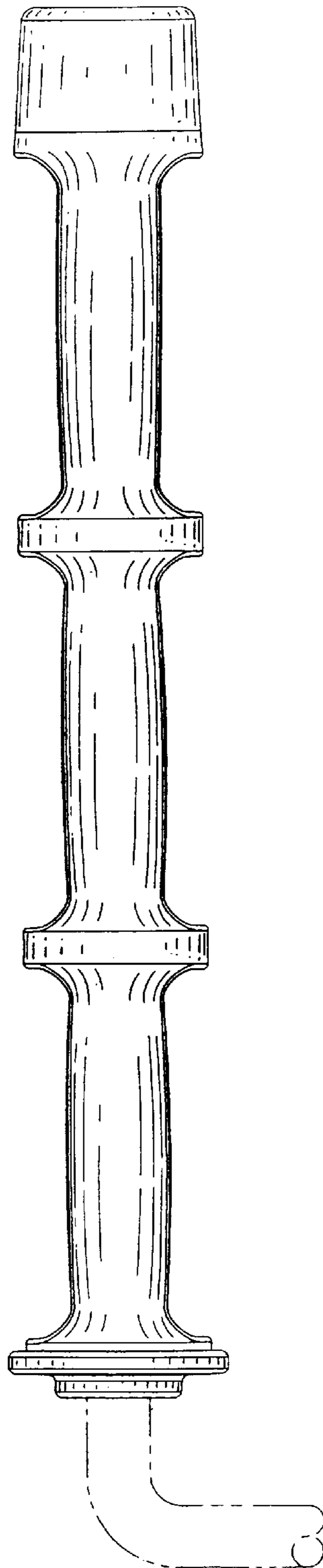

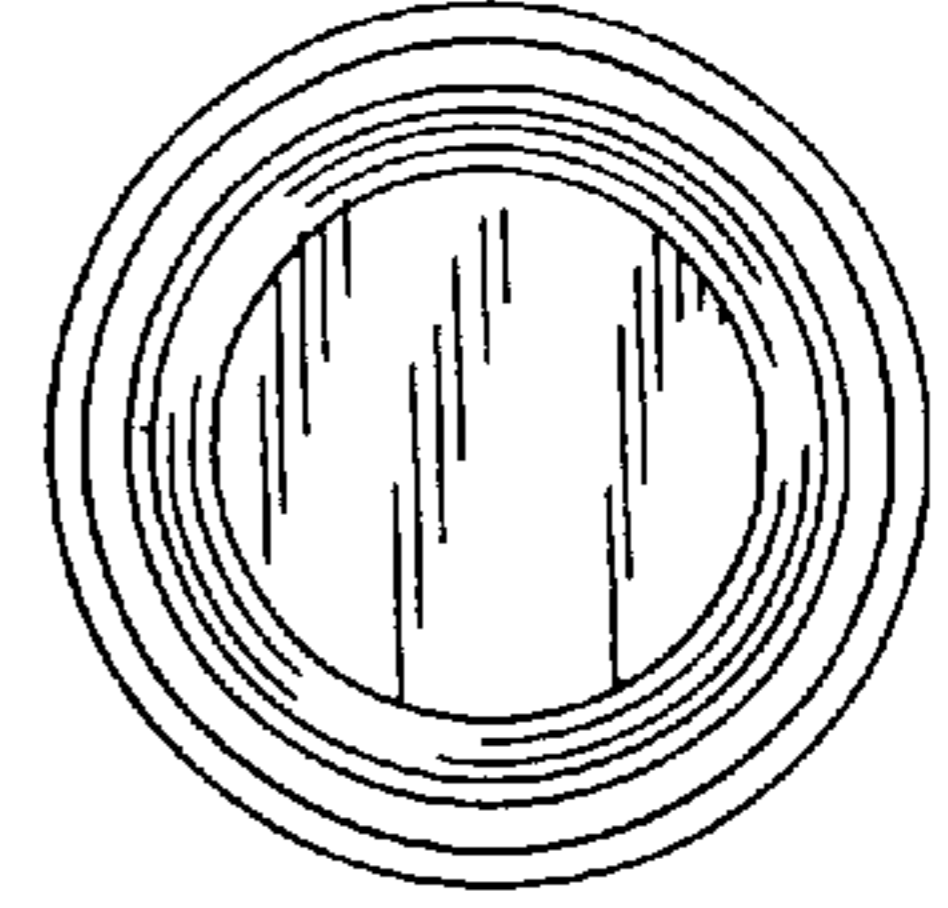

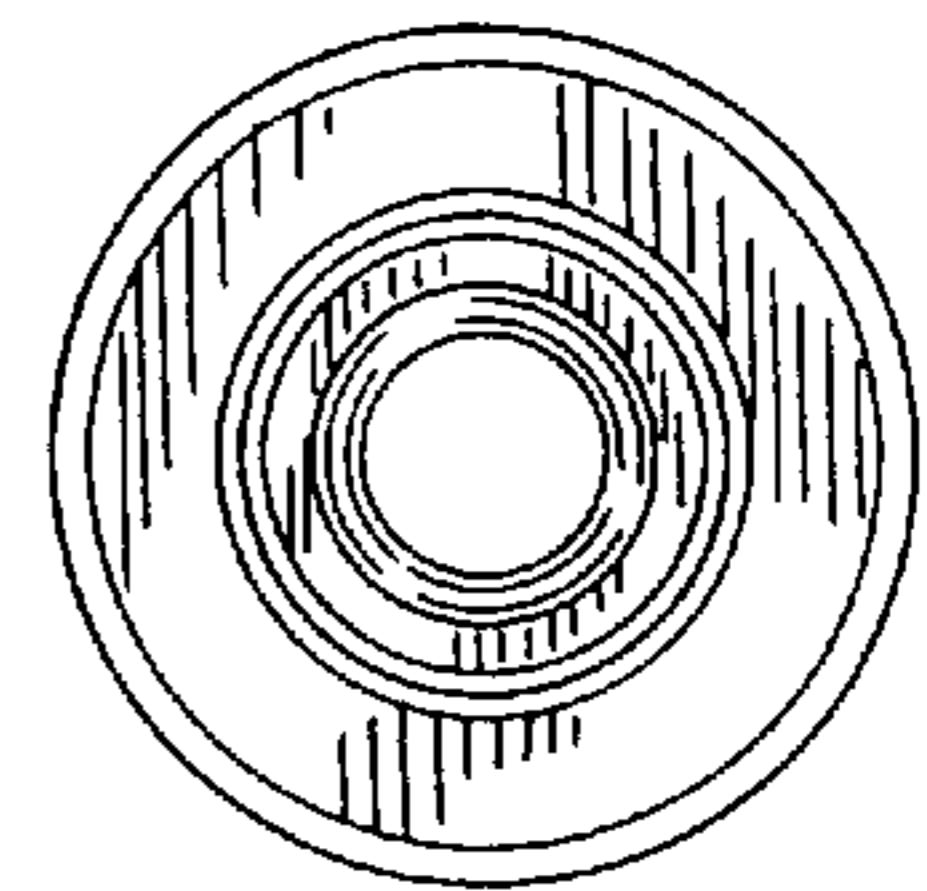

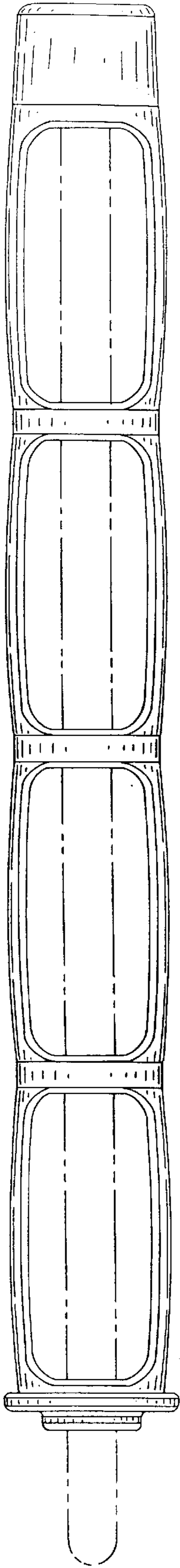

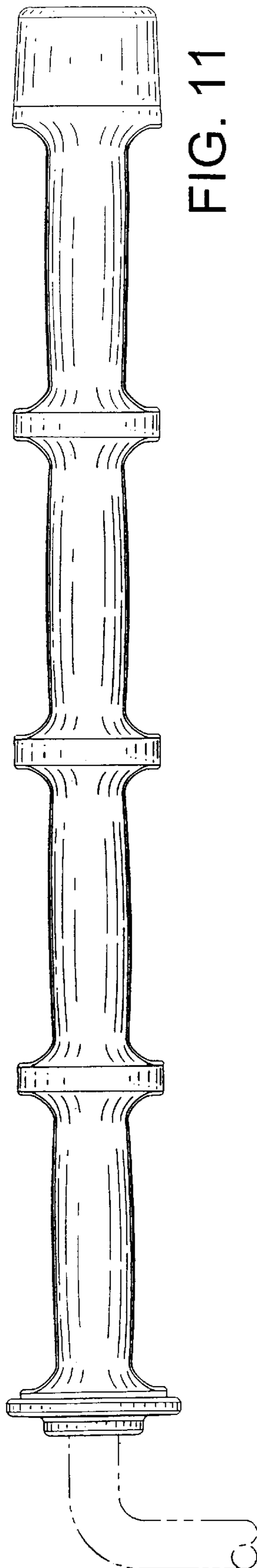

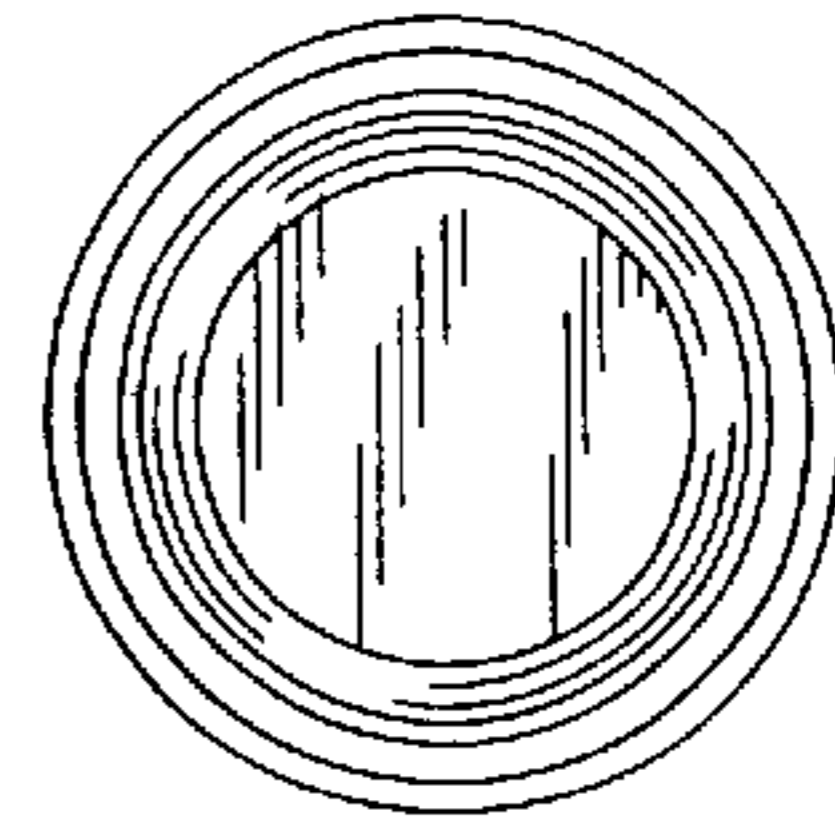

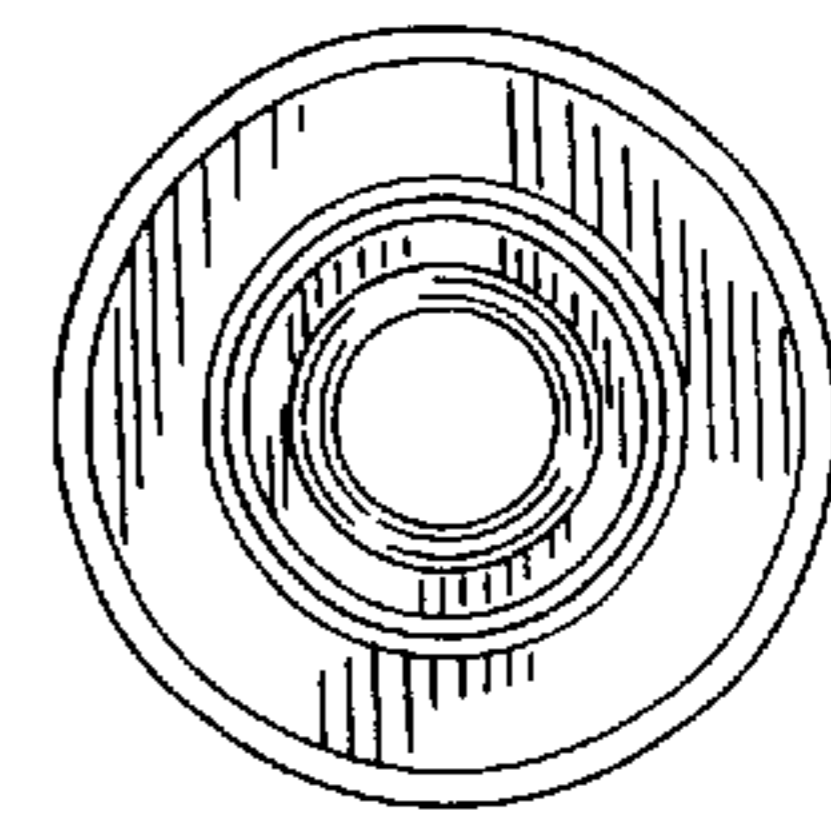
