The ornamental design for a cup, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a cup showing our new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a right side elevation thereof, the left side elevation being a mirror image thereof;  
FIG. 4 is a front elevation thereof;  
FIG. 5 is a rear elevation thereof;  
FIG. 6 is a sectional view taken along lines 6—6 of FIG. 2; and,  
FIG. 7 is a bottom plan view thereof.

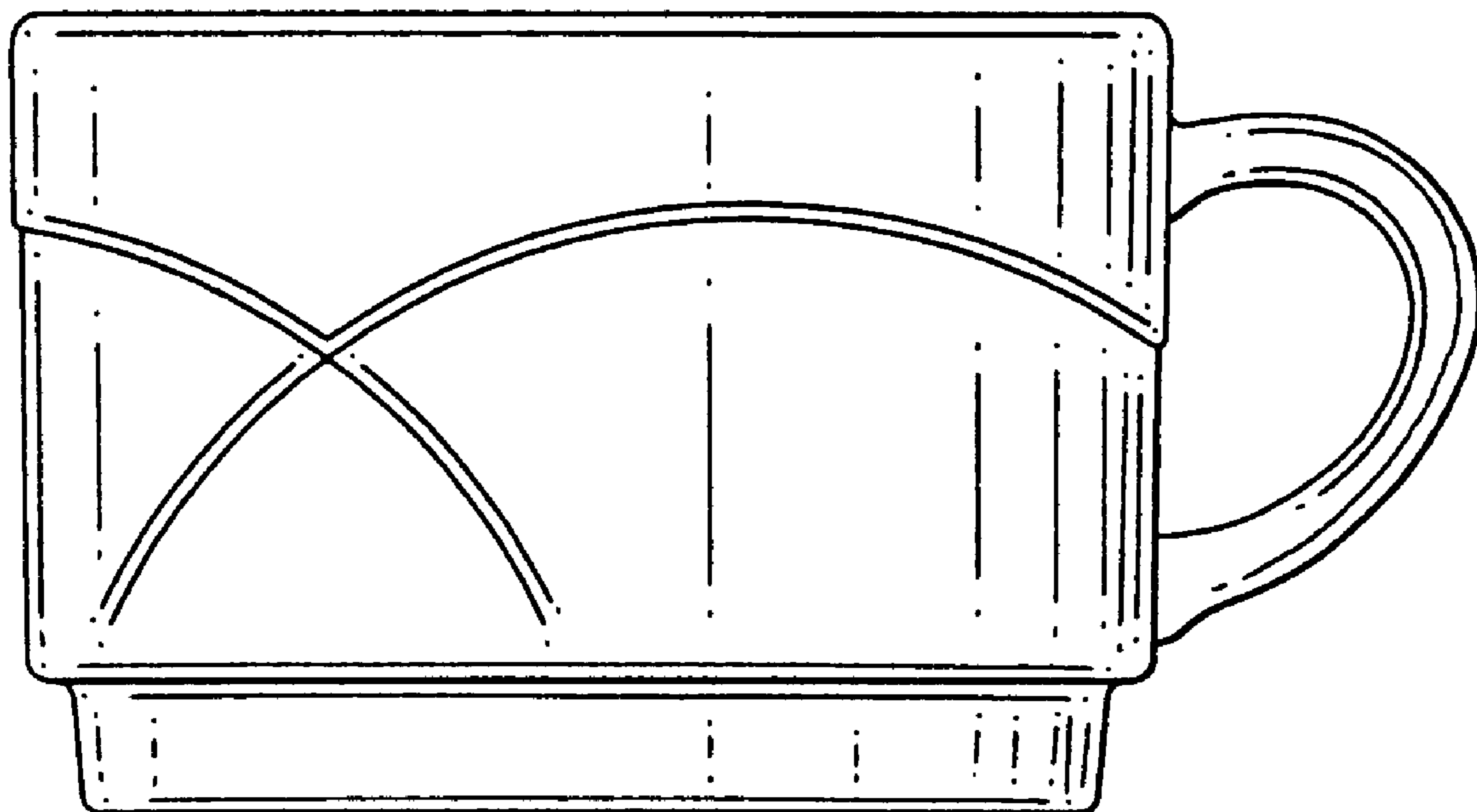

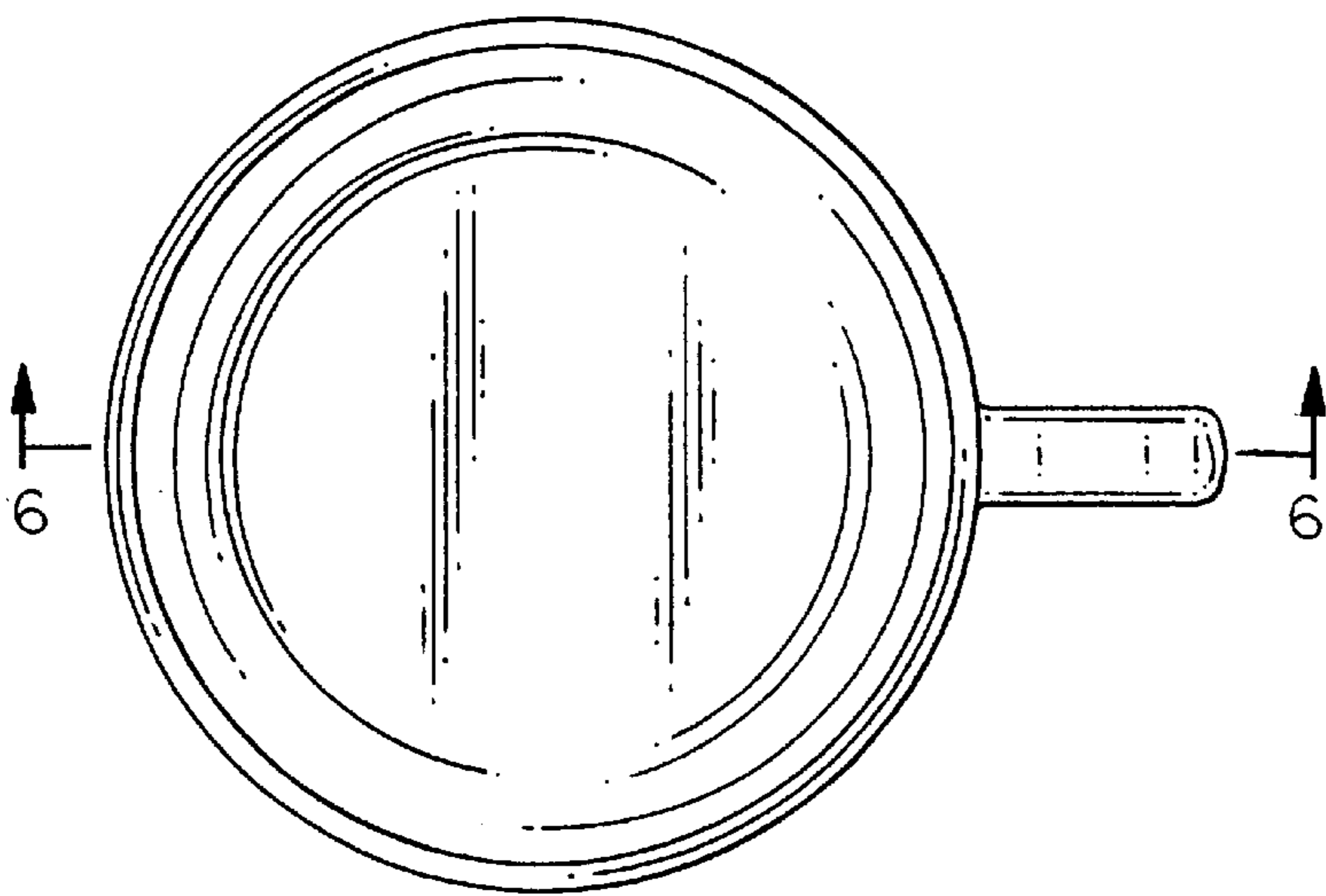
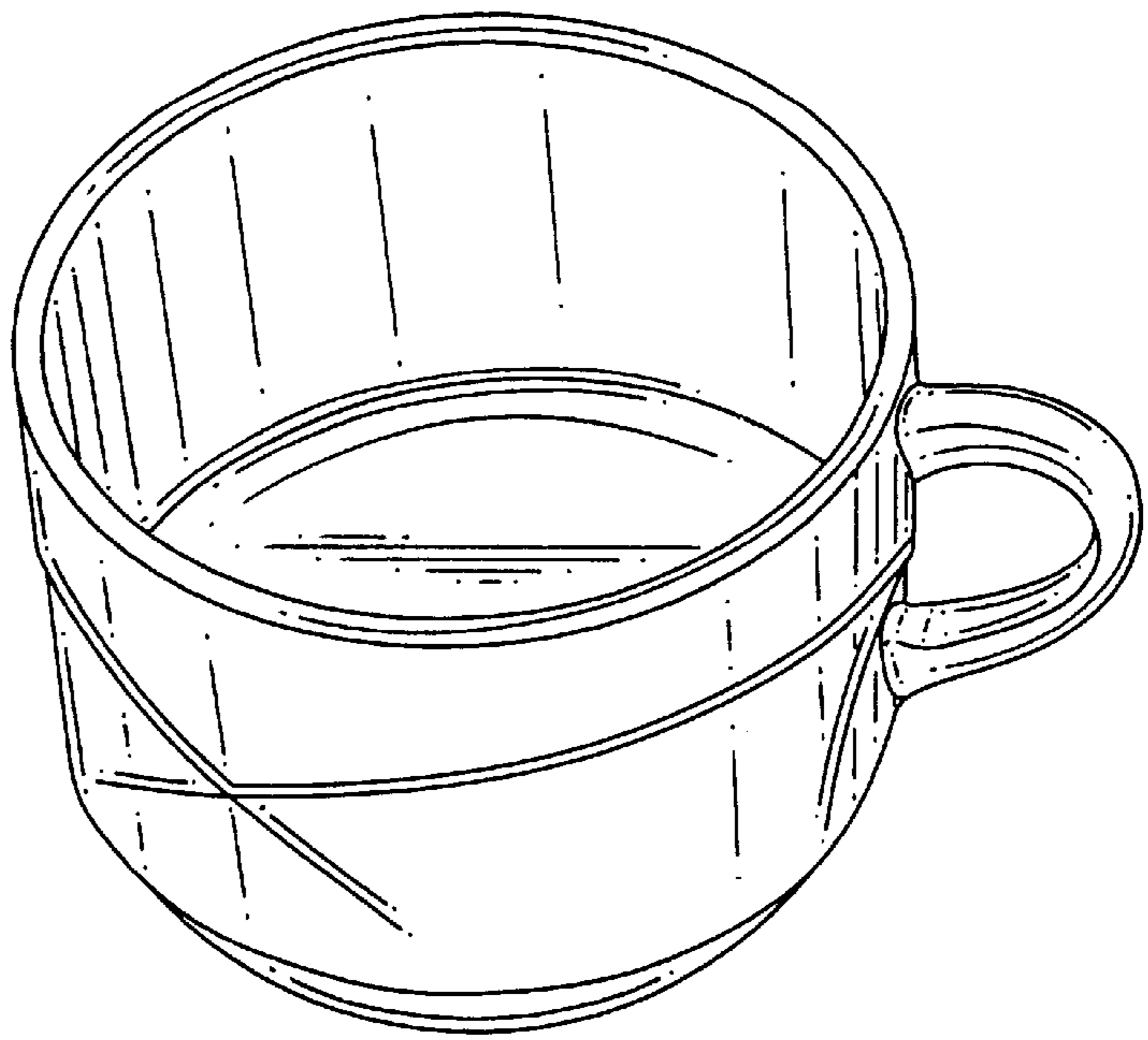

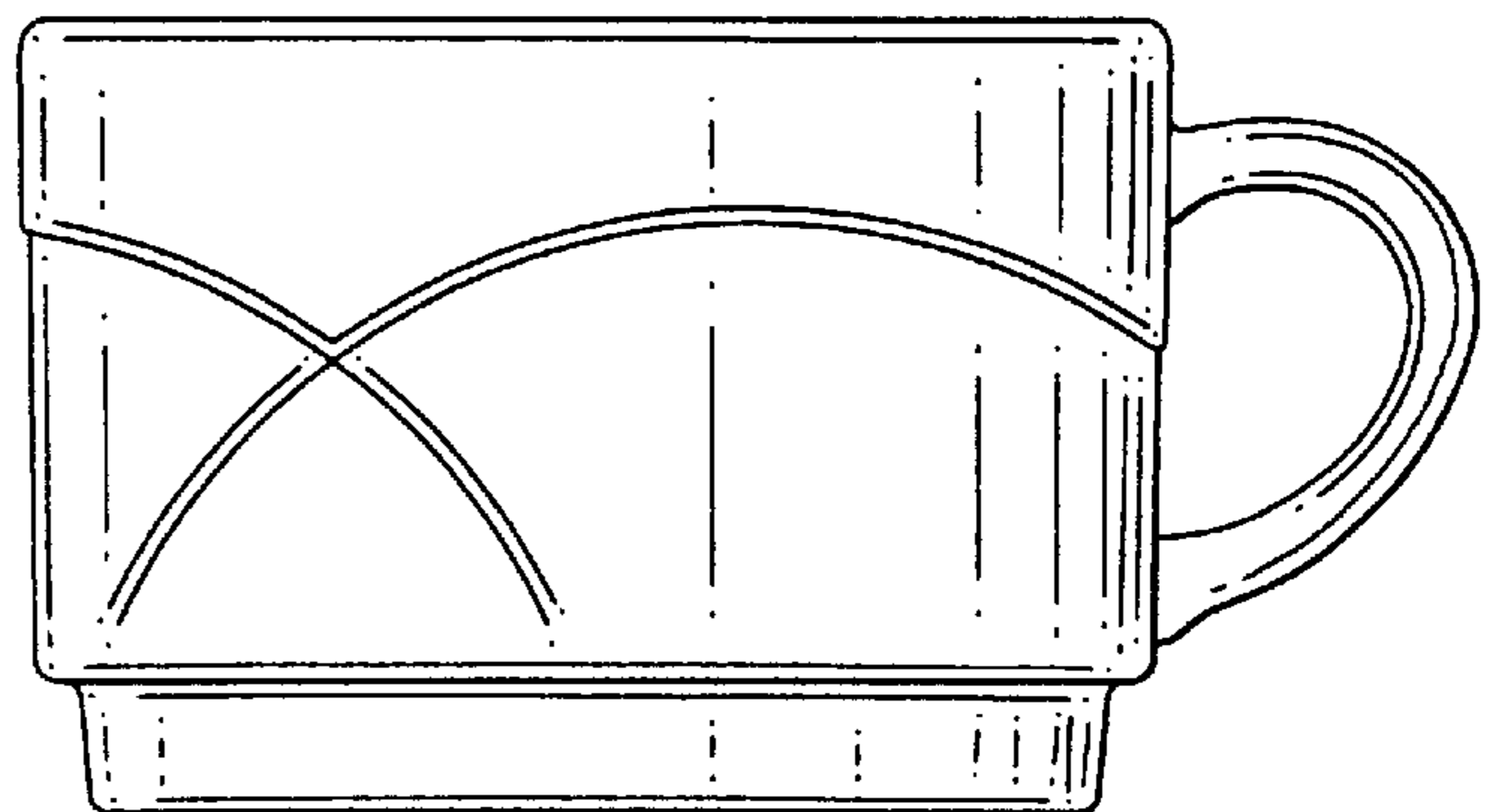

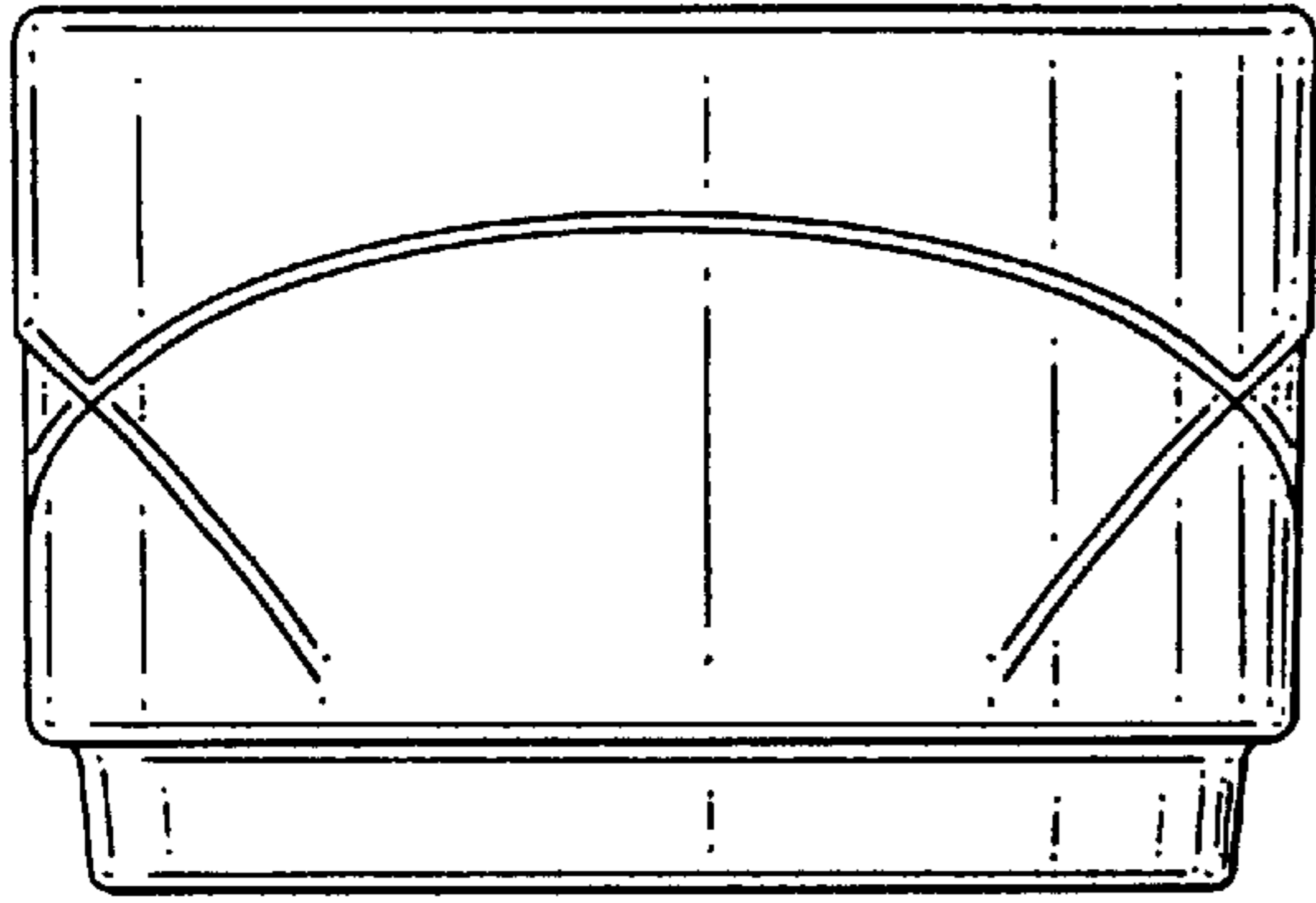

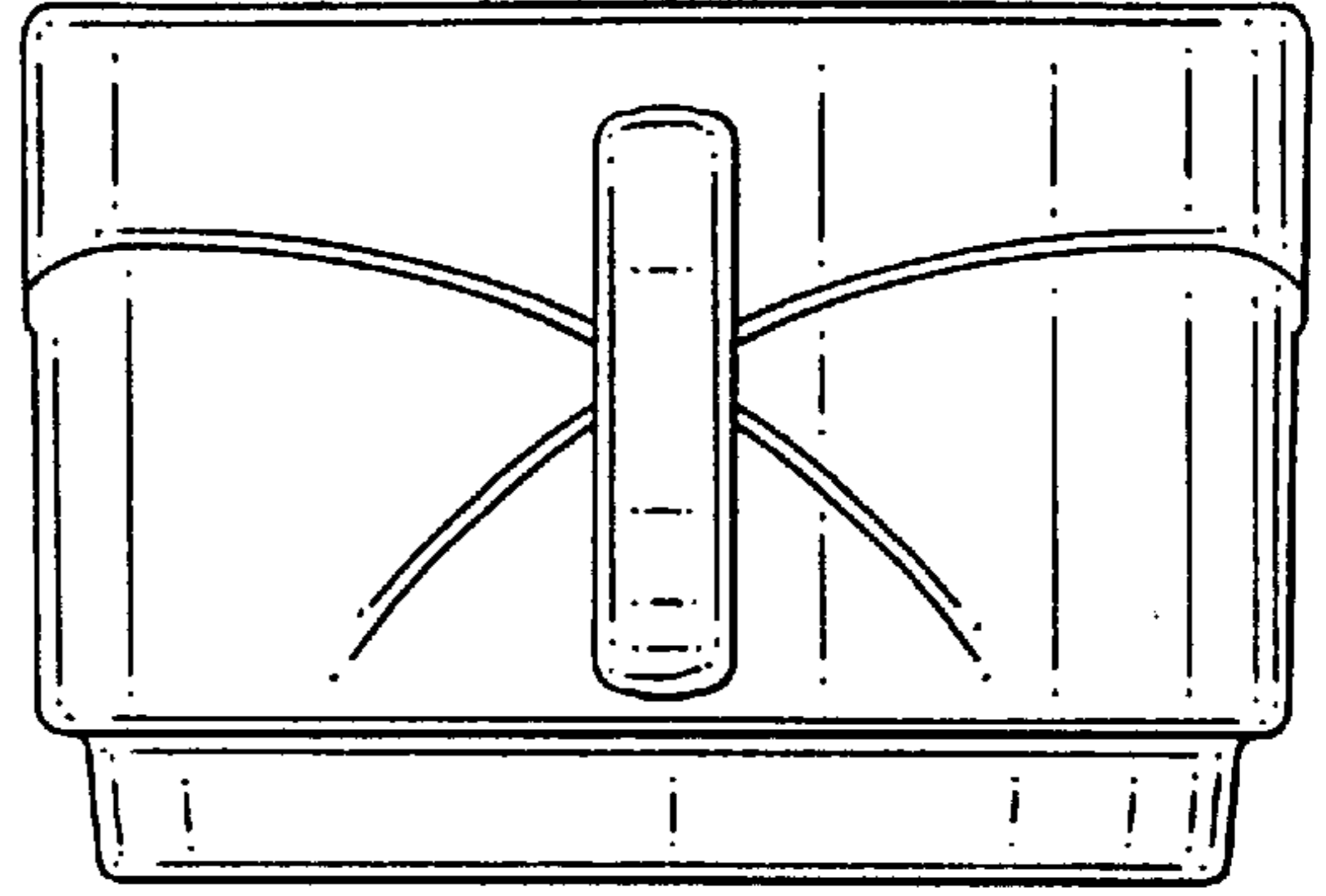

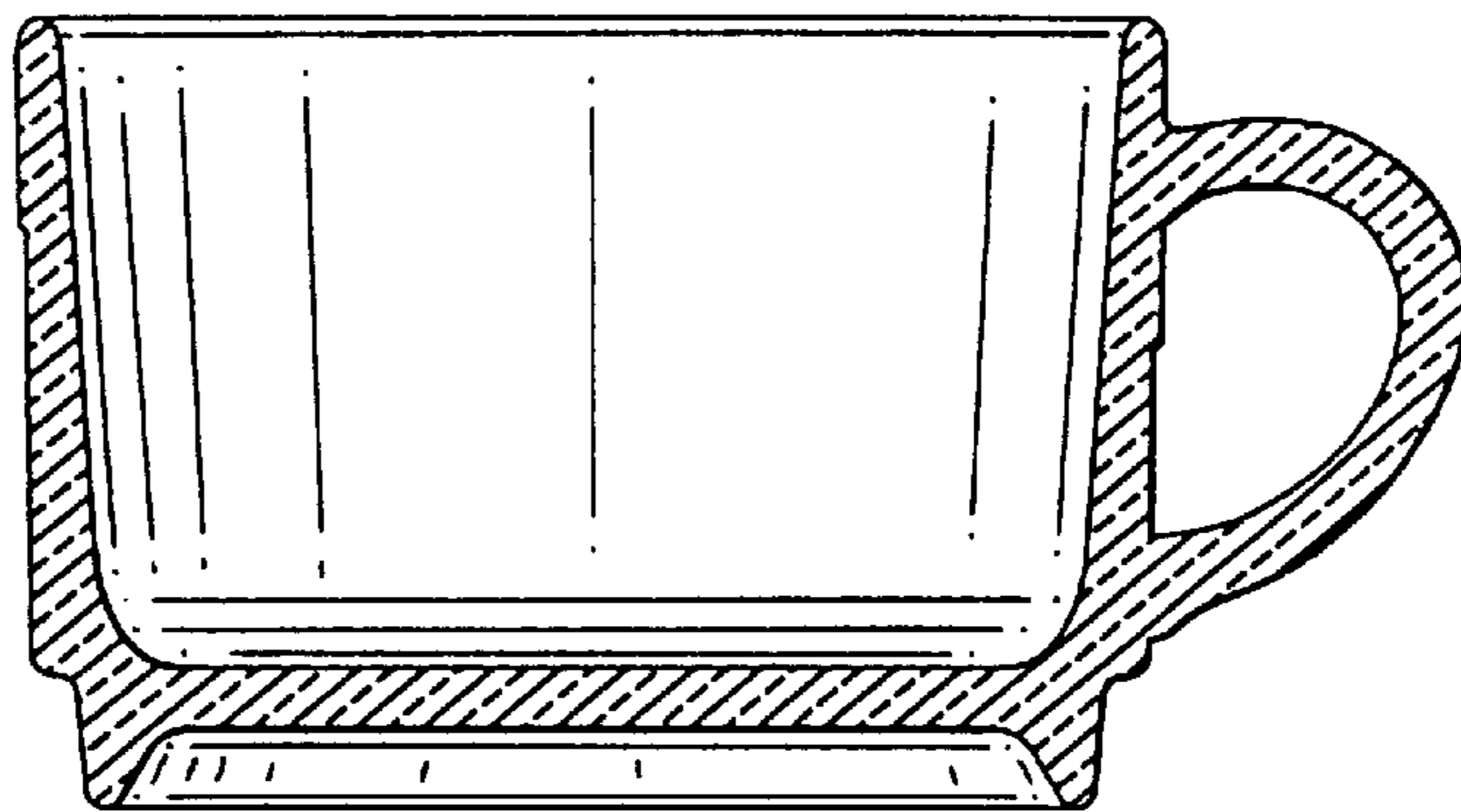

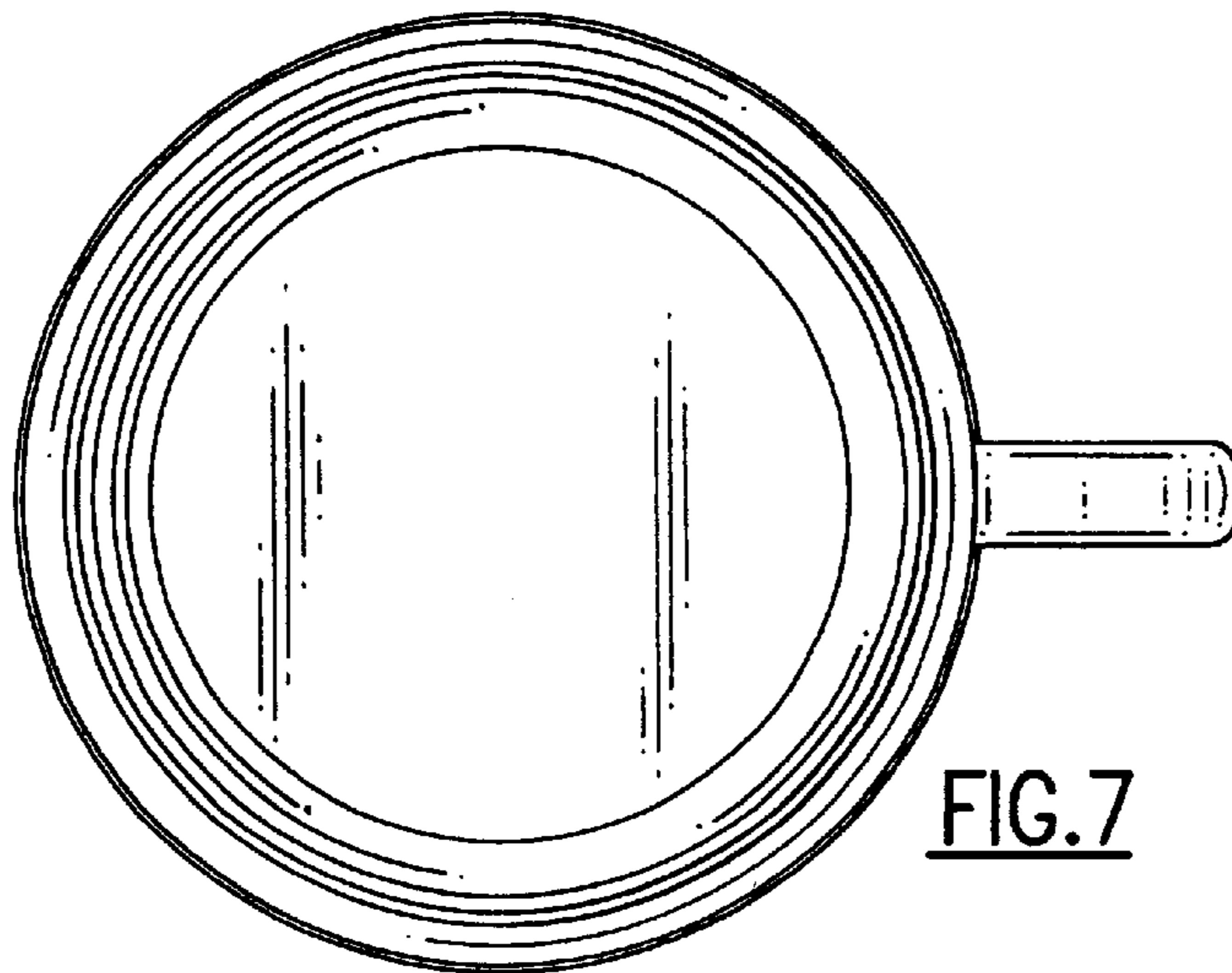
