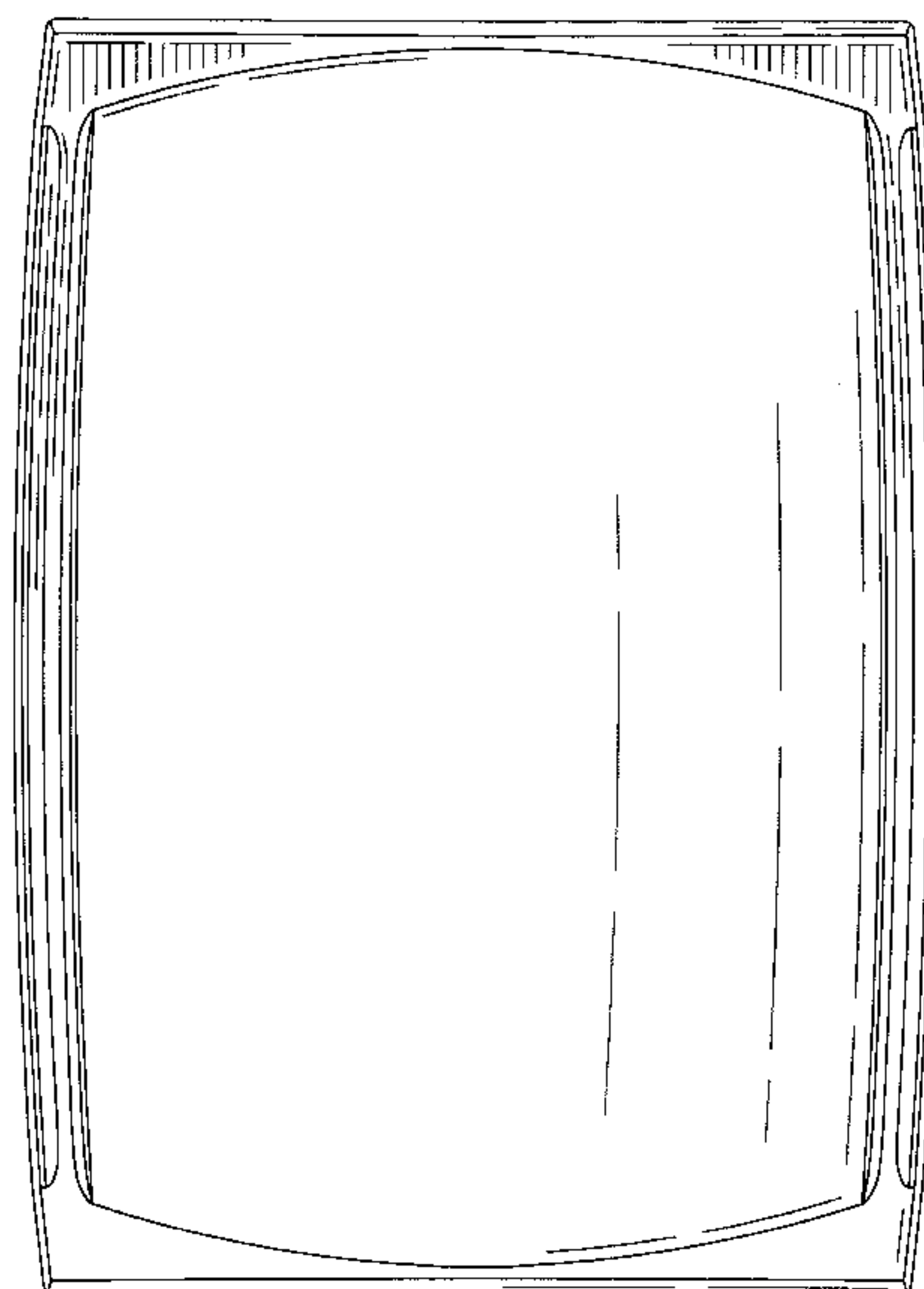
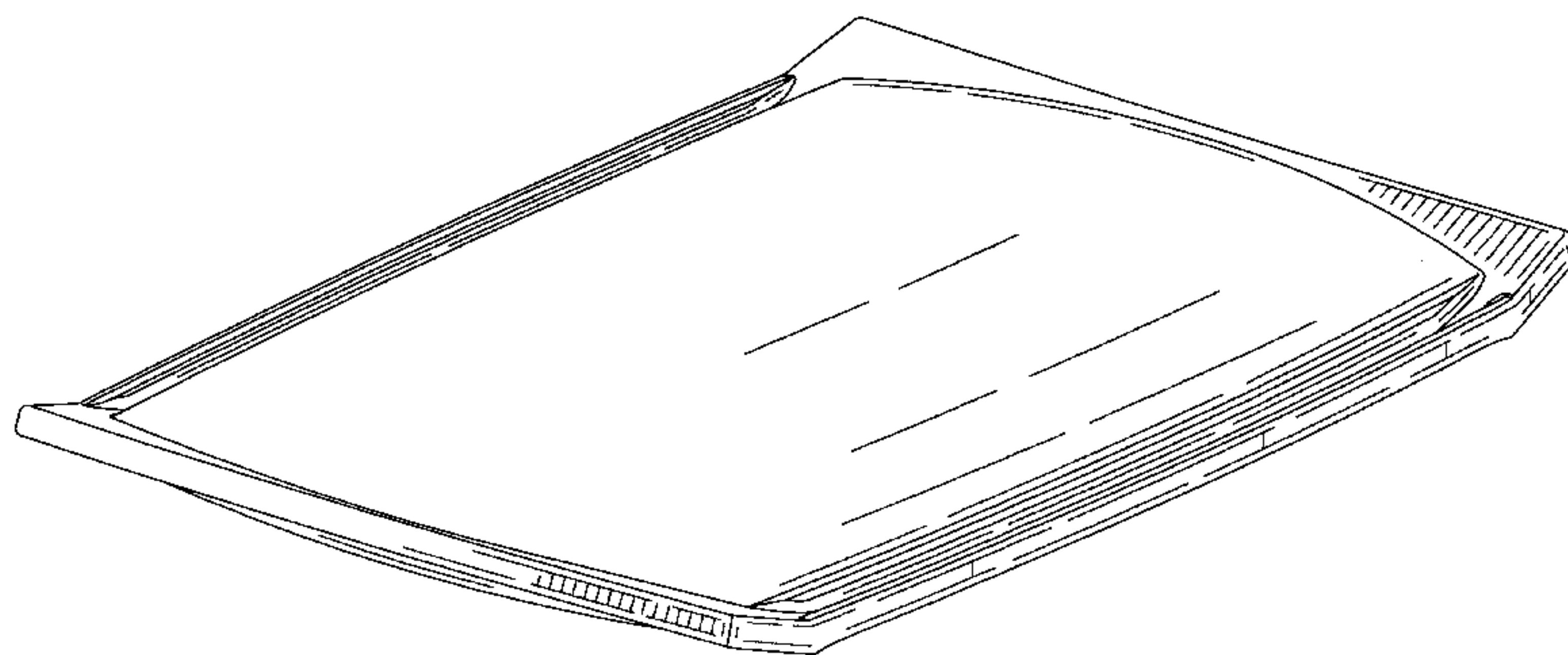
(57) **CLAIM**

The ornamental design for a cutting board, as shown and described.

DESCRIPTION

FIG. 1 is a top, side and front perspective view of a cutting board showing the new design;
FIG. 2 is a bottom, side and front perspective view thereof;
FIG. 3 is a front elevation view thereof, the rear elevation being identical thereto;
FIG. 4 is a left side elevation view thereof, the right side elevation being identical thereto;
FIG. 5 is a top plan view thereof; and,
FIG. 6 is a bottom plan view thereof.

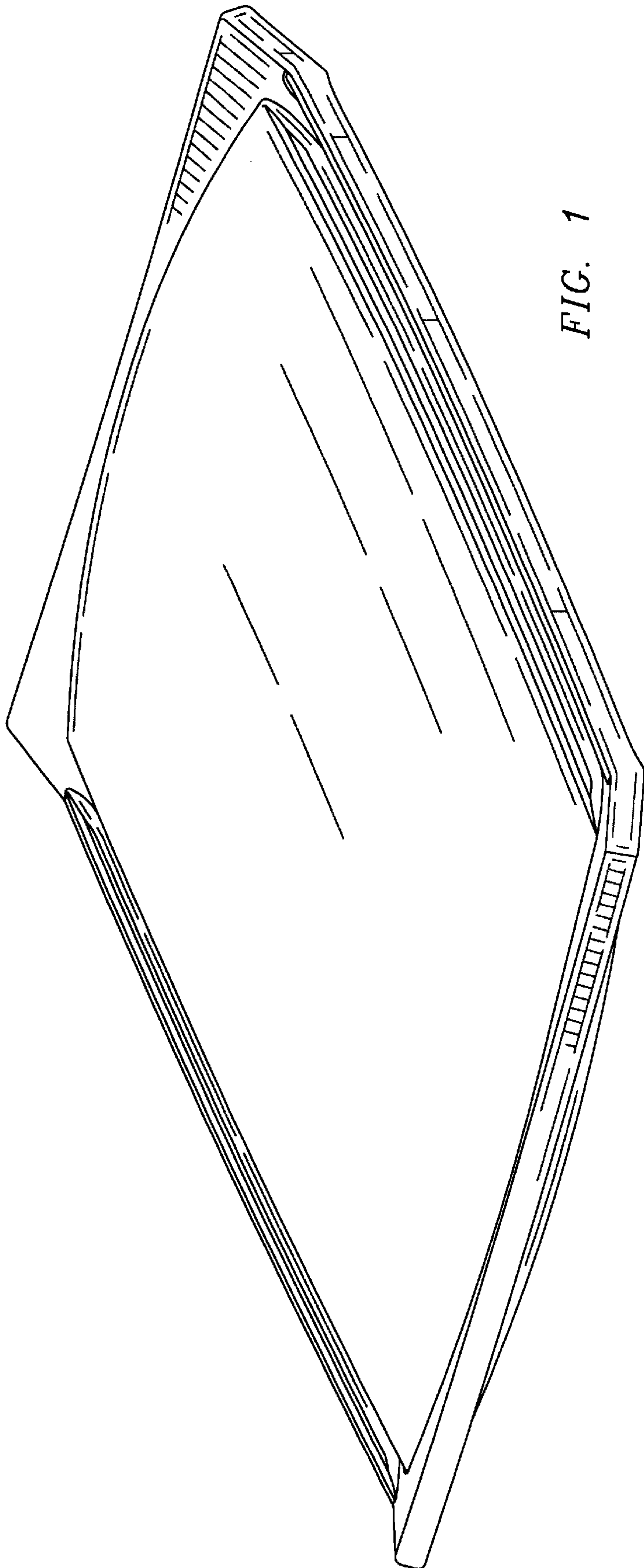

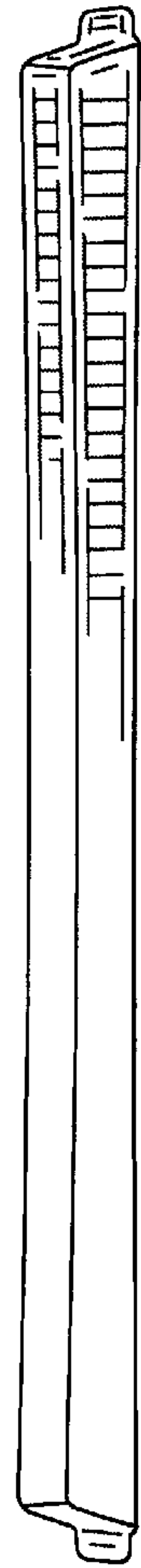

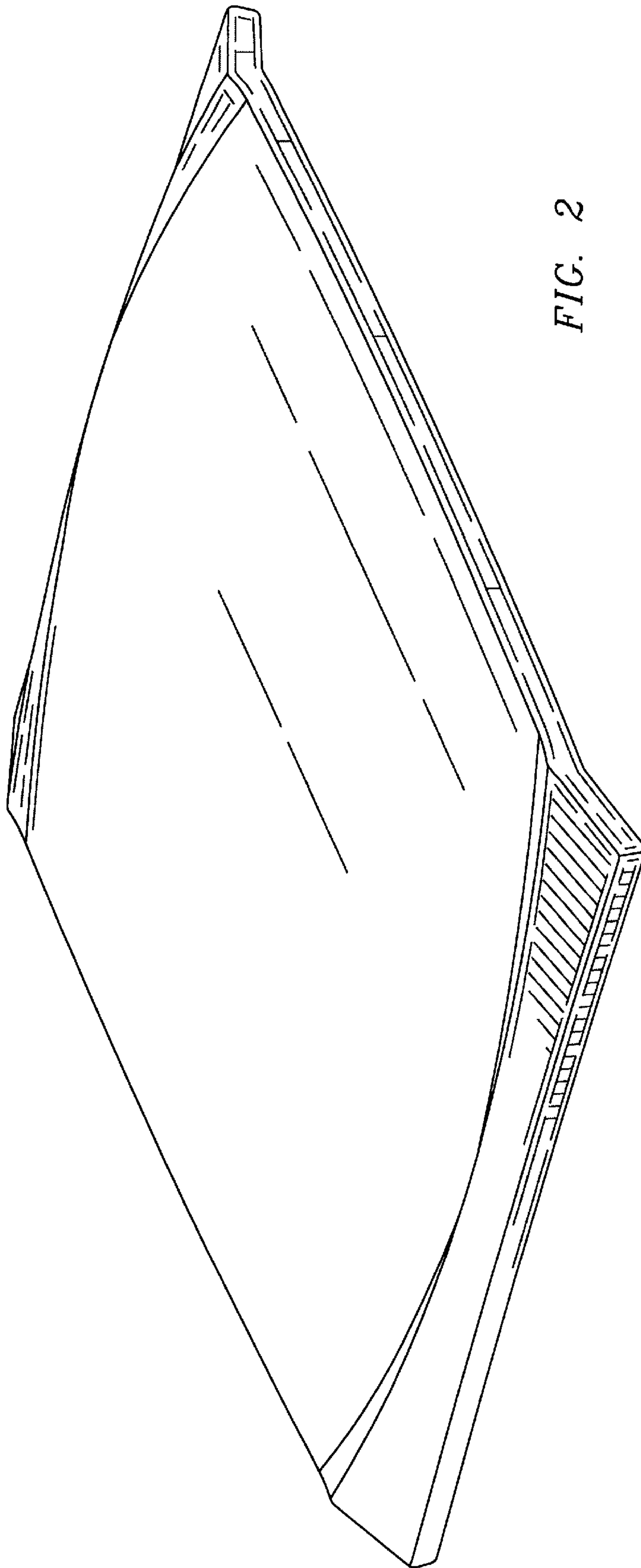

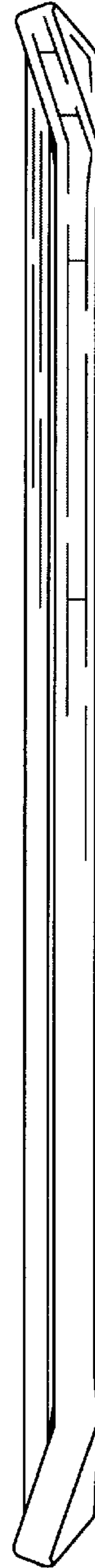

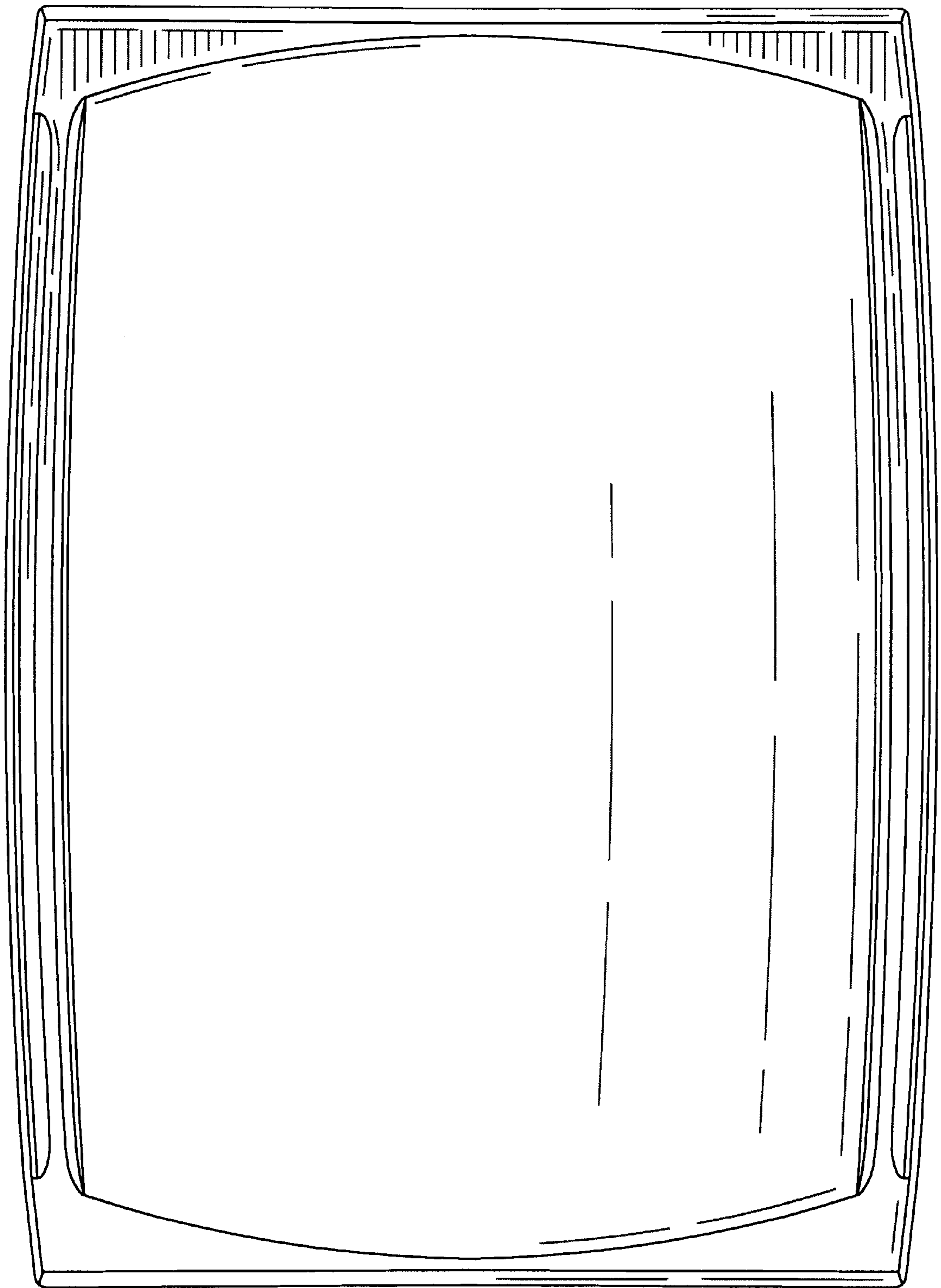

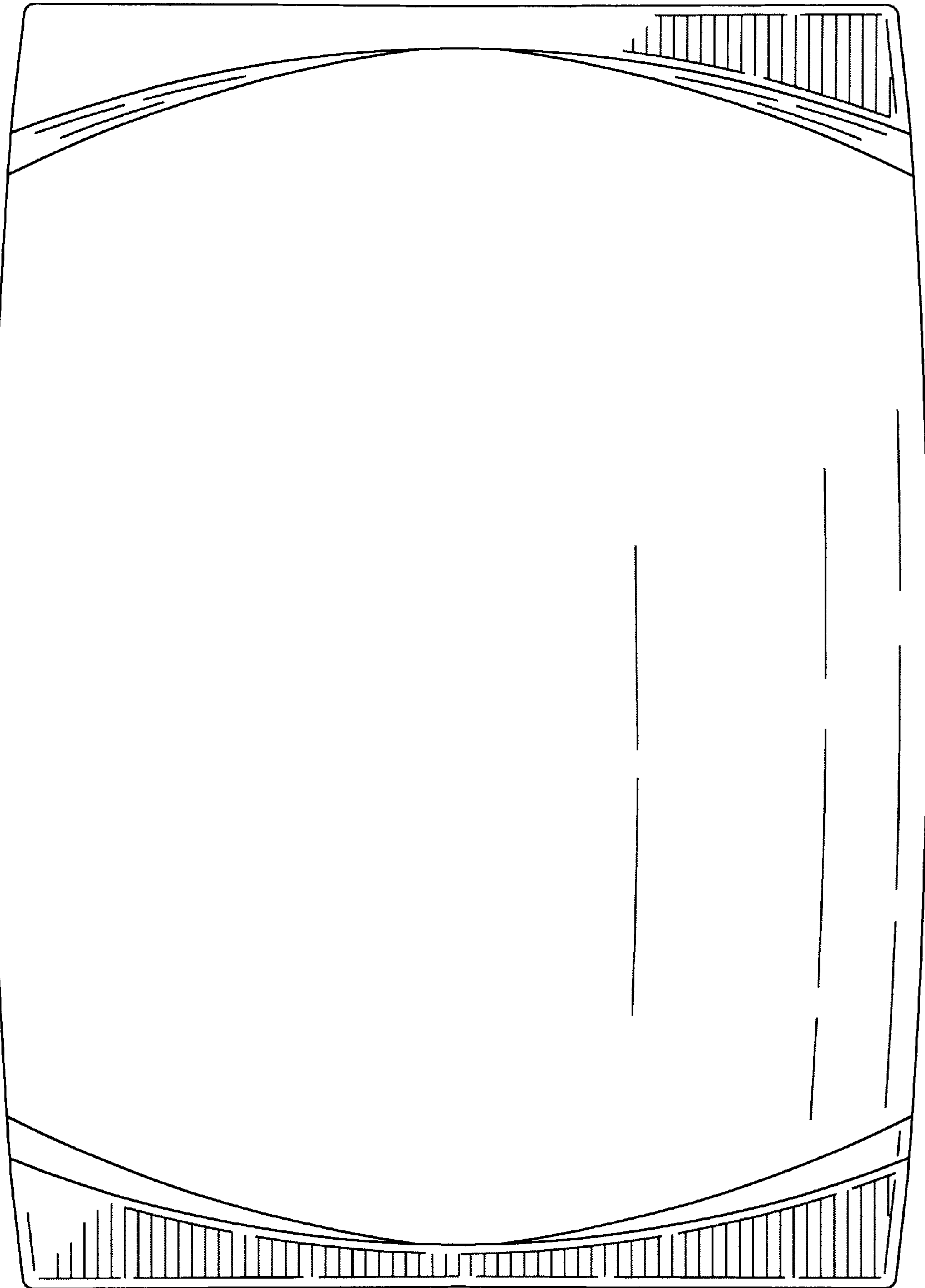
