(57) **CLAIM**

I claim the ornamental design for reflective pendant, as shown and described in the drawings.

DESCRIPTION

FIG. 1 is a front perspective view of a reflective pendant in accordance with one embodiment of the new design;

FIG. 2 is a rear perspective view of the reflective pendant in accordance with the embodiment of the new design shown in FIG. 1;

FIG. 3 is a rear elevational view of the reflective pendant in accordance with the embodiment of the new design shown in FIG. 1;

FIG. 4 is a side elevational view of the reflective pendant in accordance with the embodiment of the new design shown in FIG. 1;

FIG. 5 is a front perspective view of a reflective pendant in accordance with another embodiment of the new design;

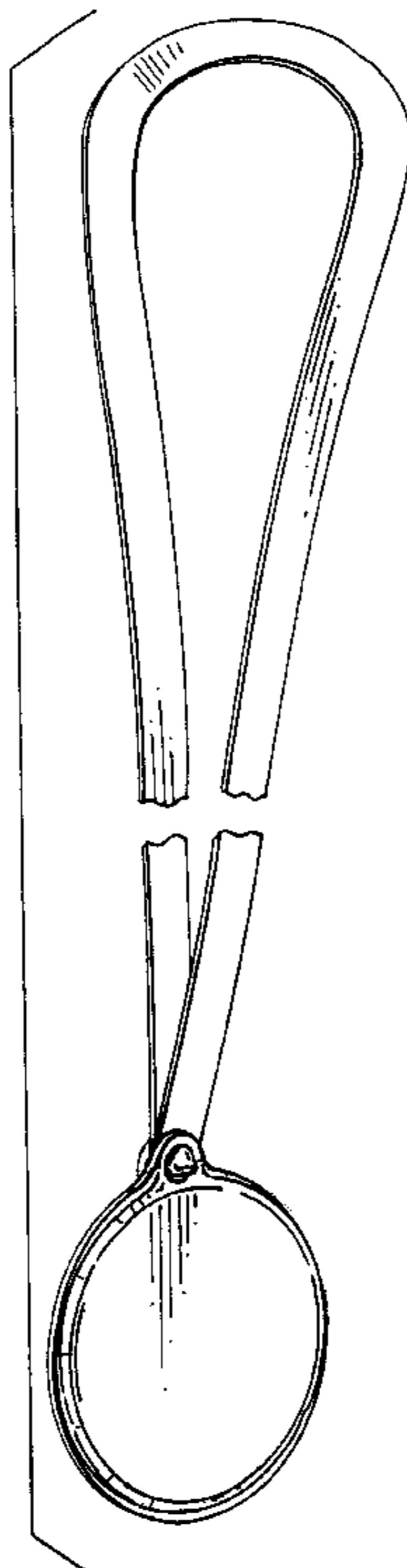
FIG. 6 is a rear perspective view of the reflective pendant in accordance with the embodiment of the new design shown in FIG. 5;

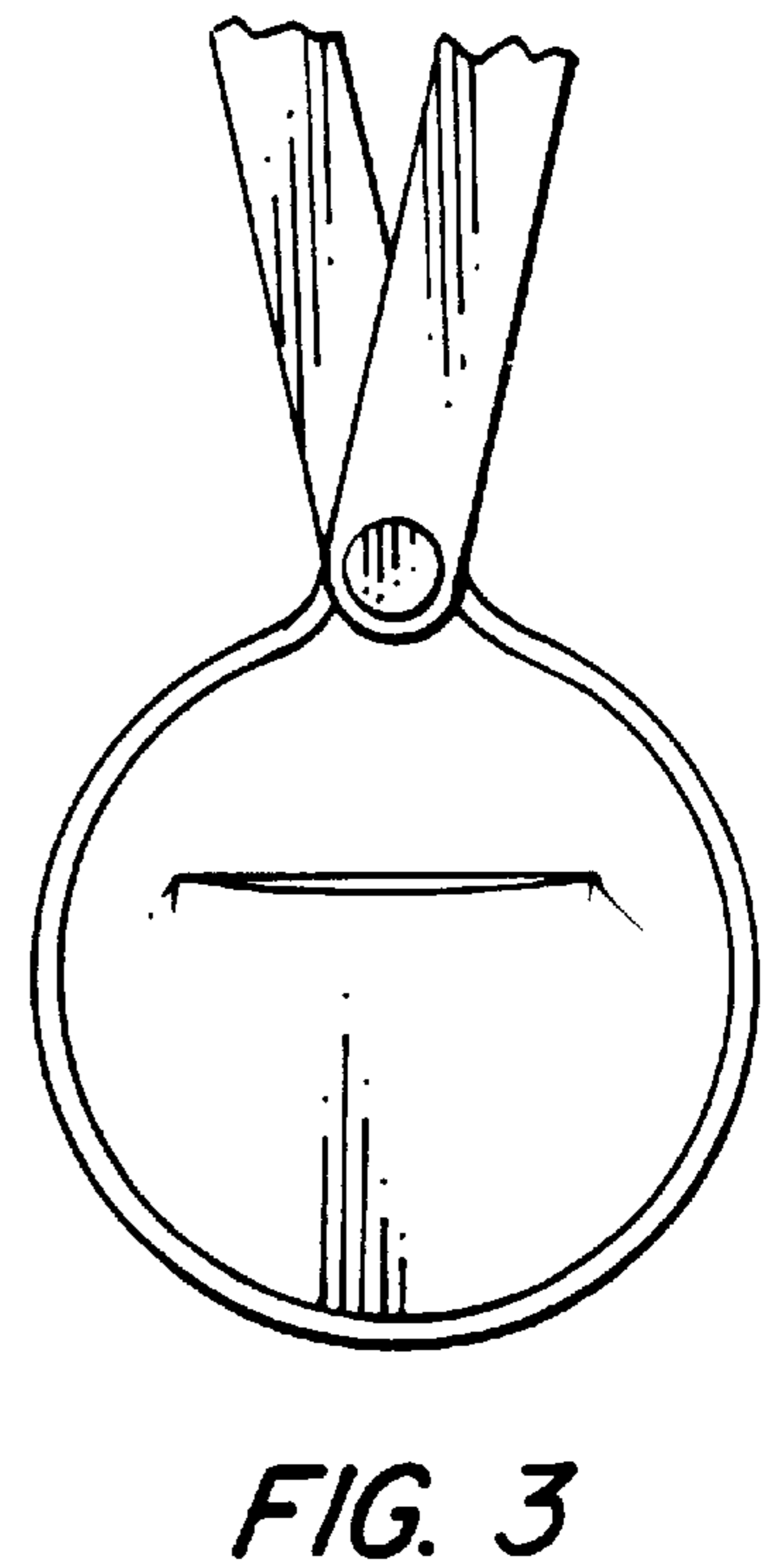
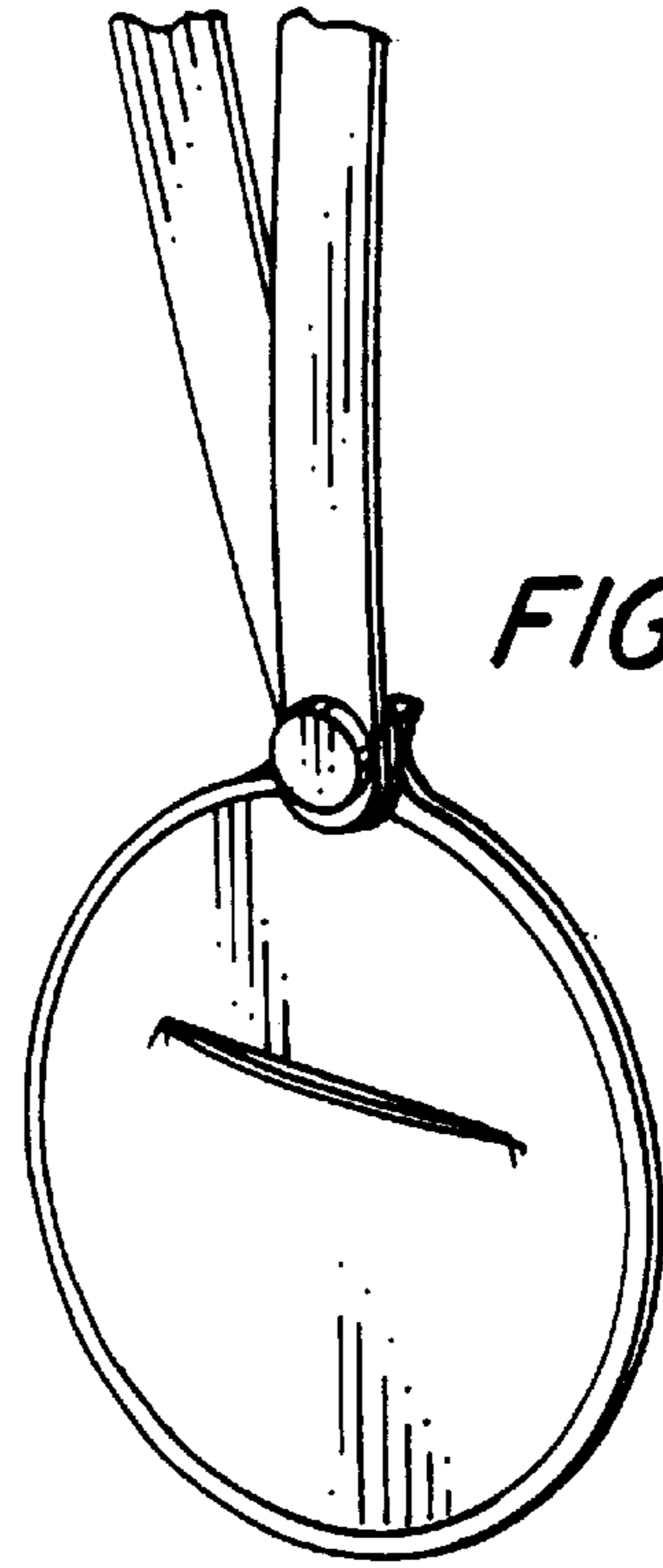
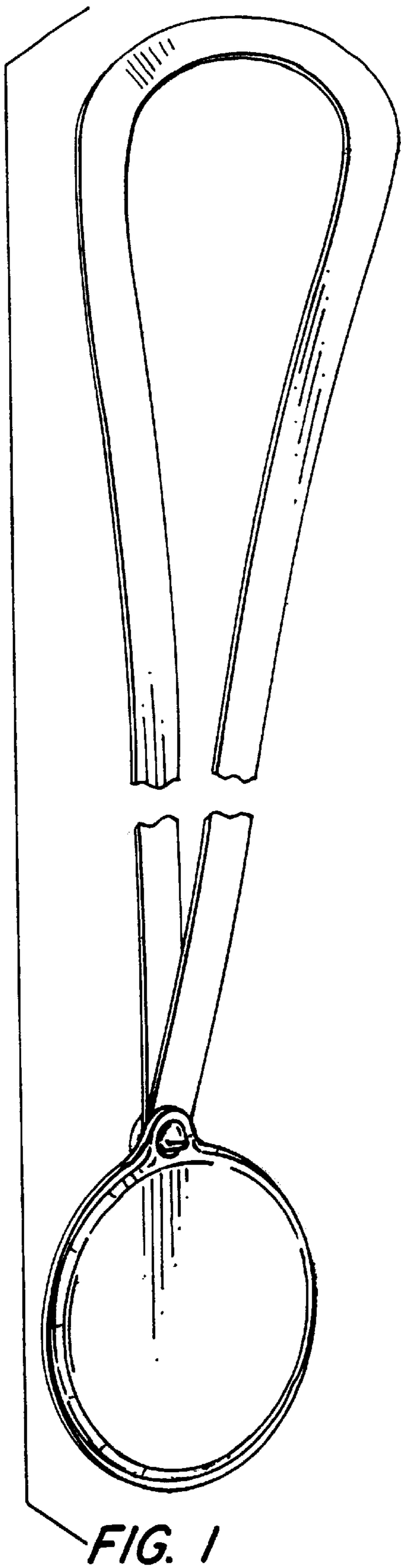
FIG. 7 is a rear elevational view of the reflective pendant in accordance with the embodiment of the new design shown in FIG. 5;

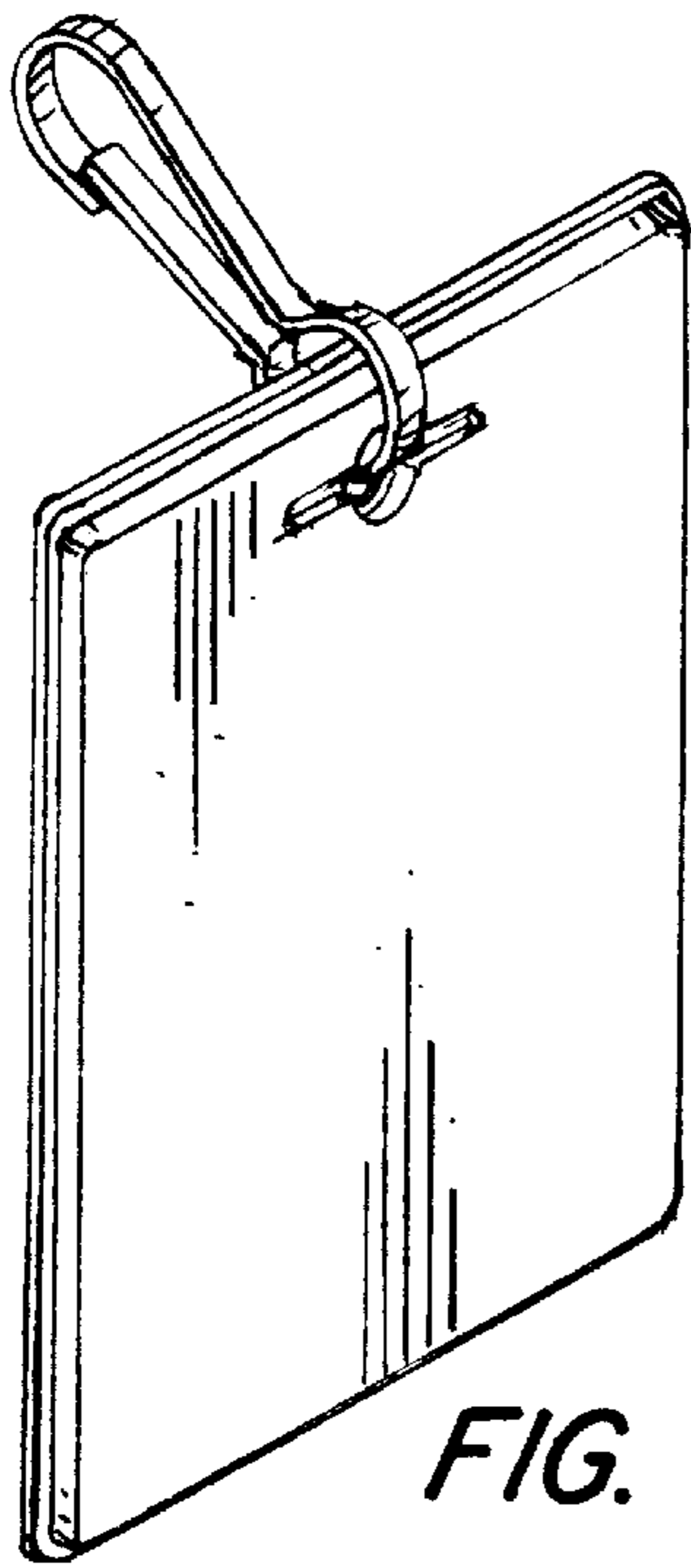

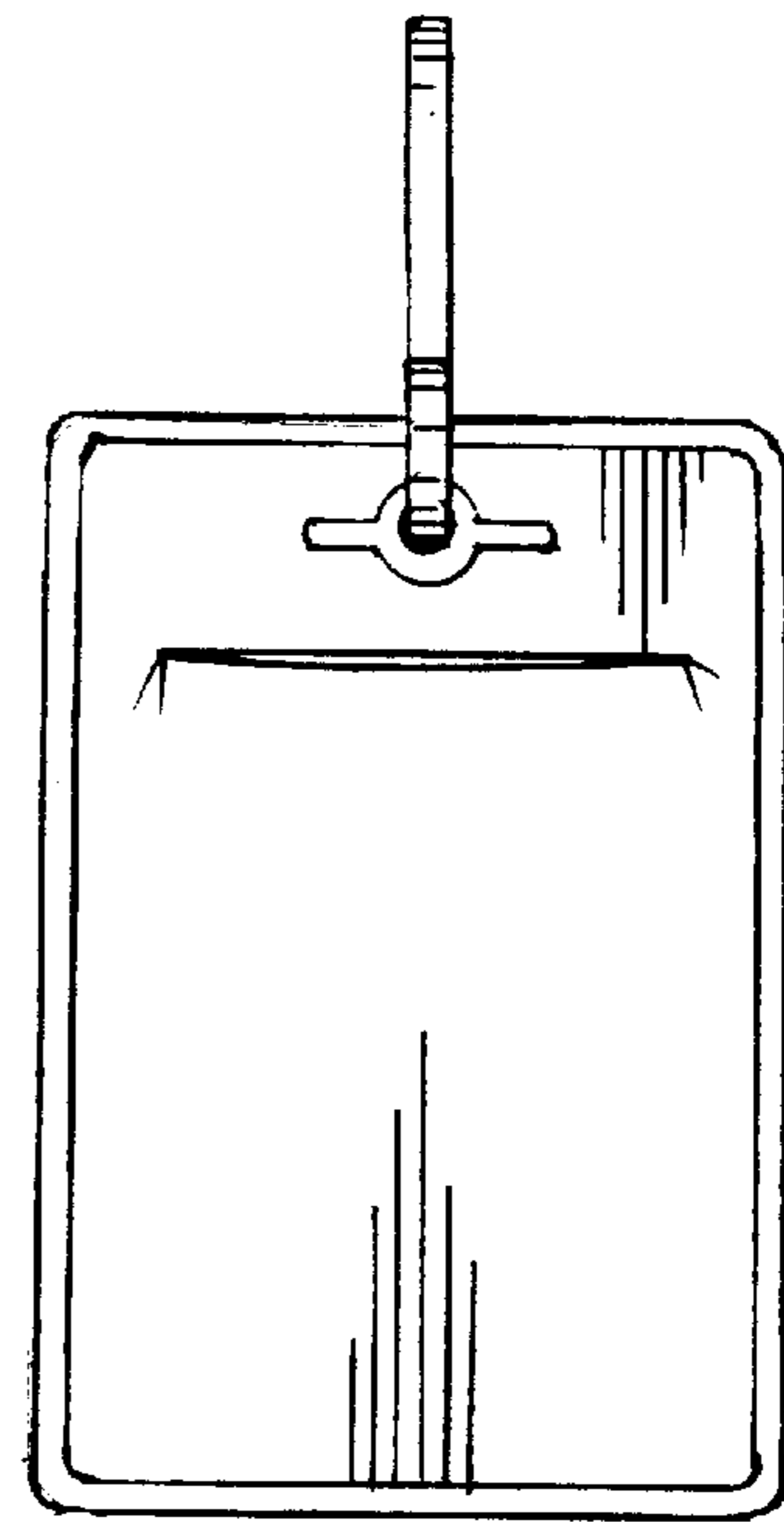

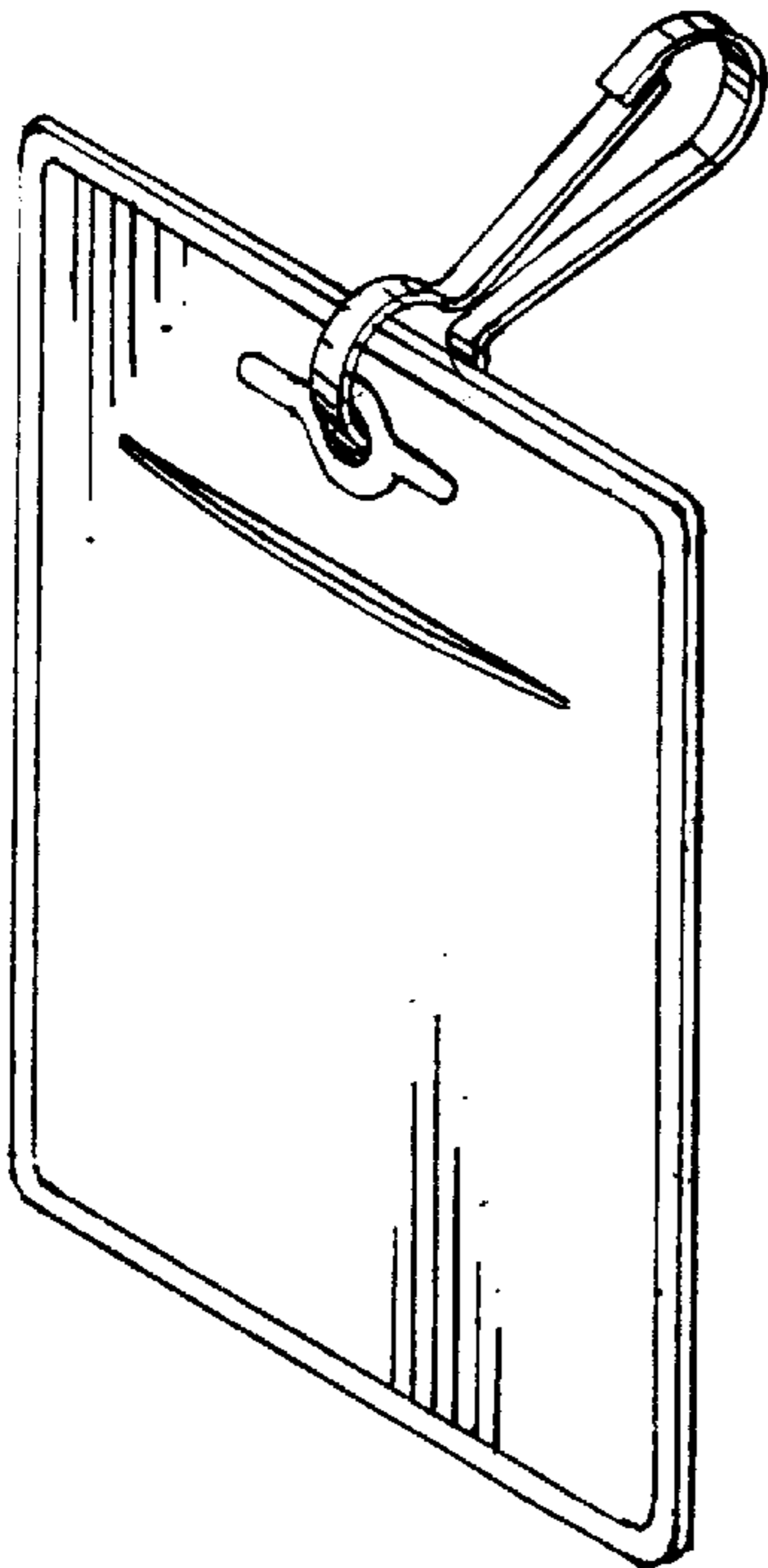

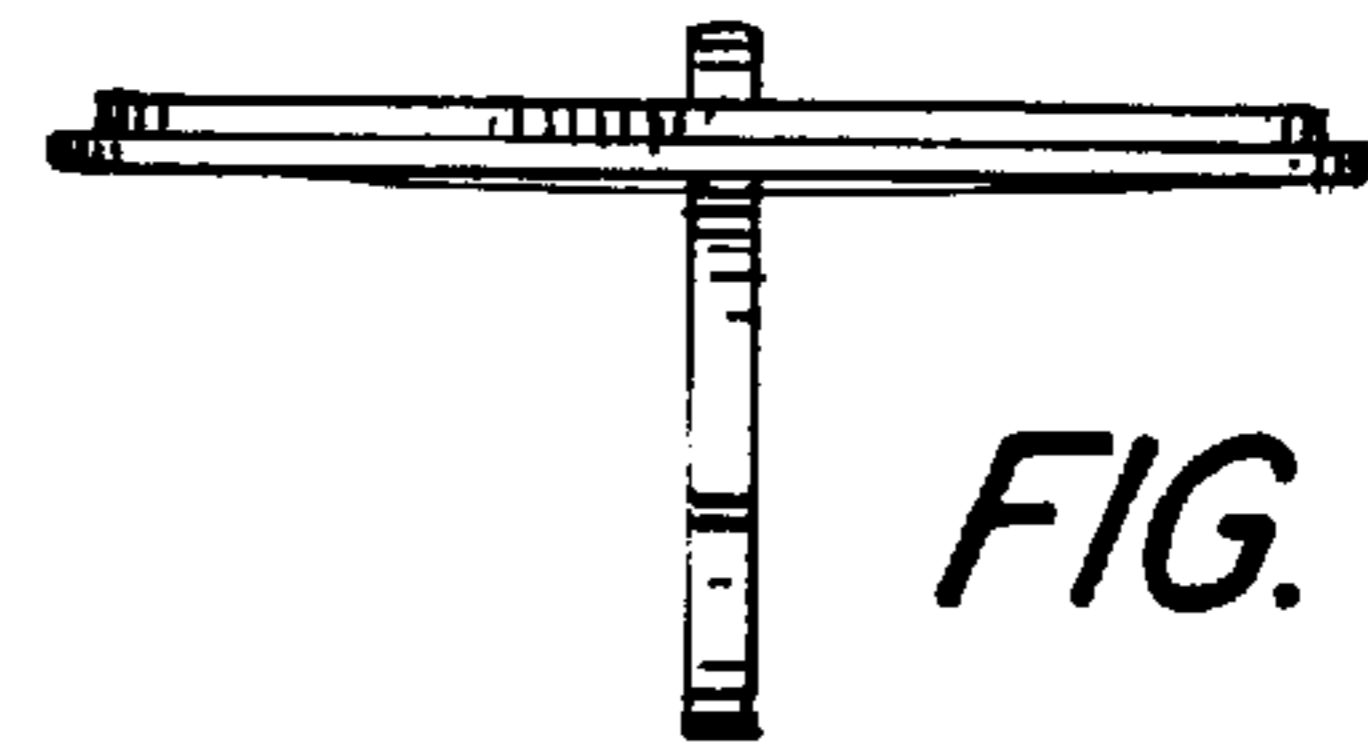

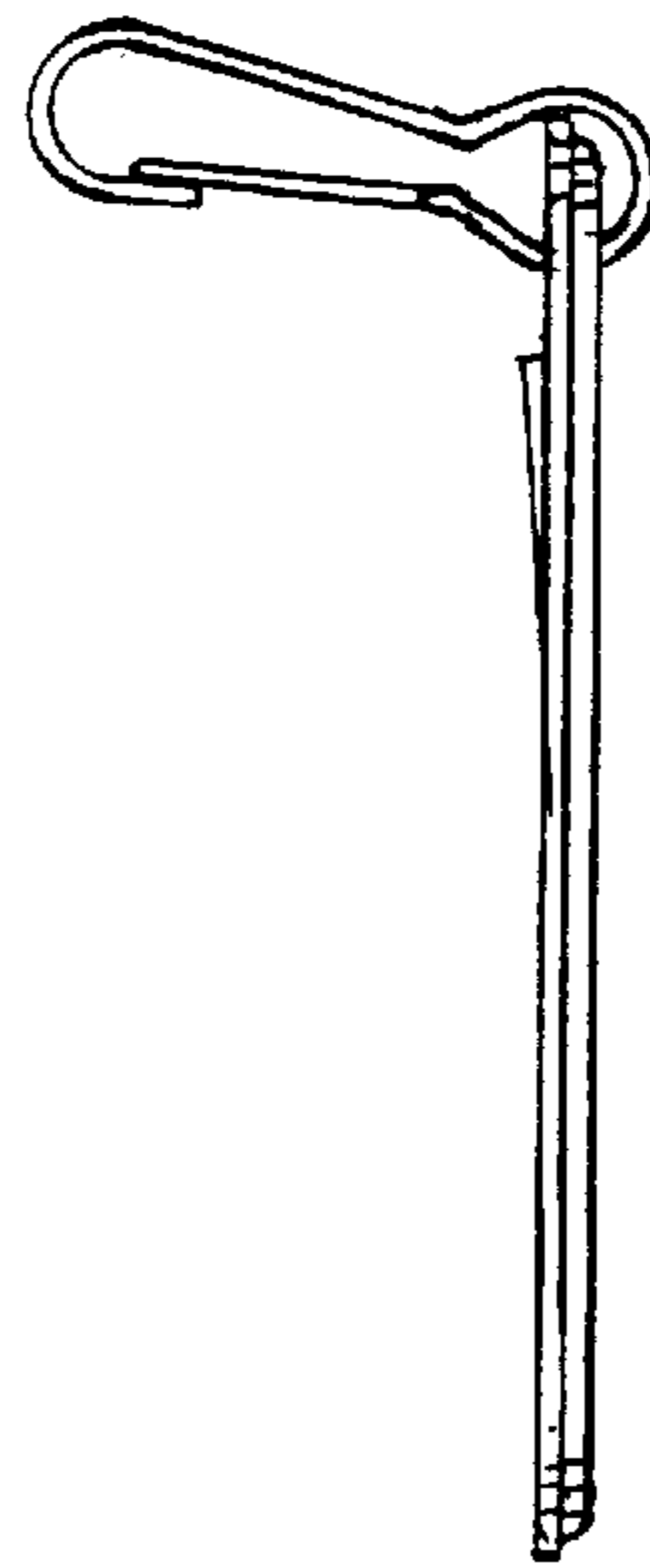
