thereof.

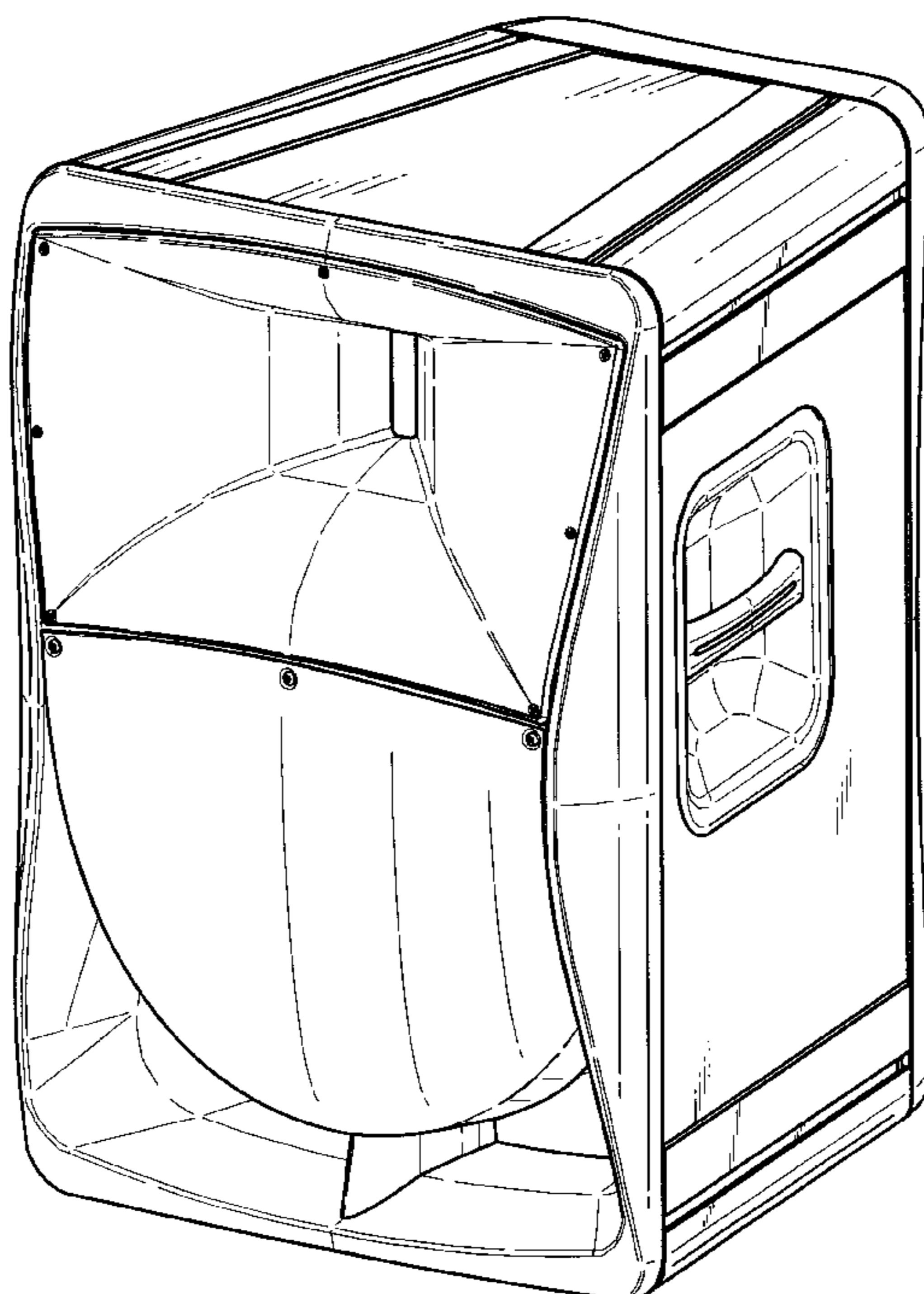
FIG. 4 is a rear elevation of the single two way speaker of

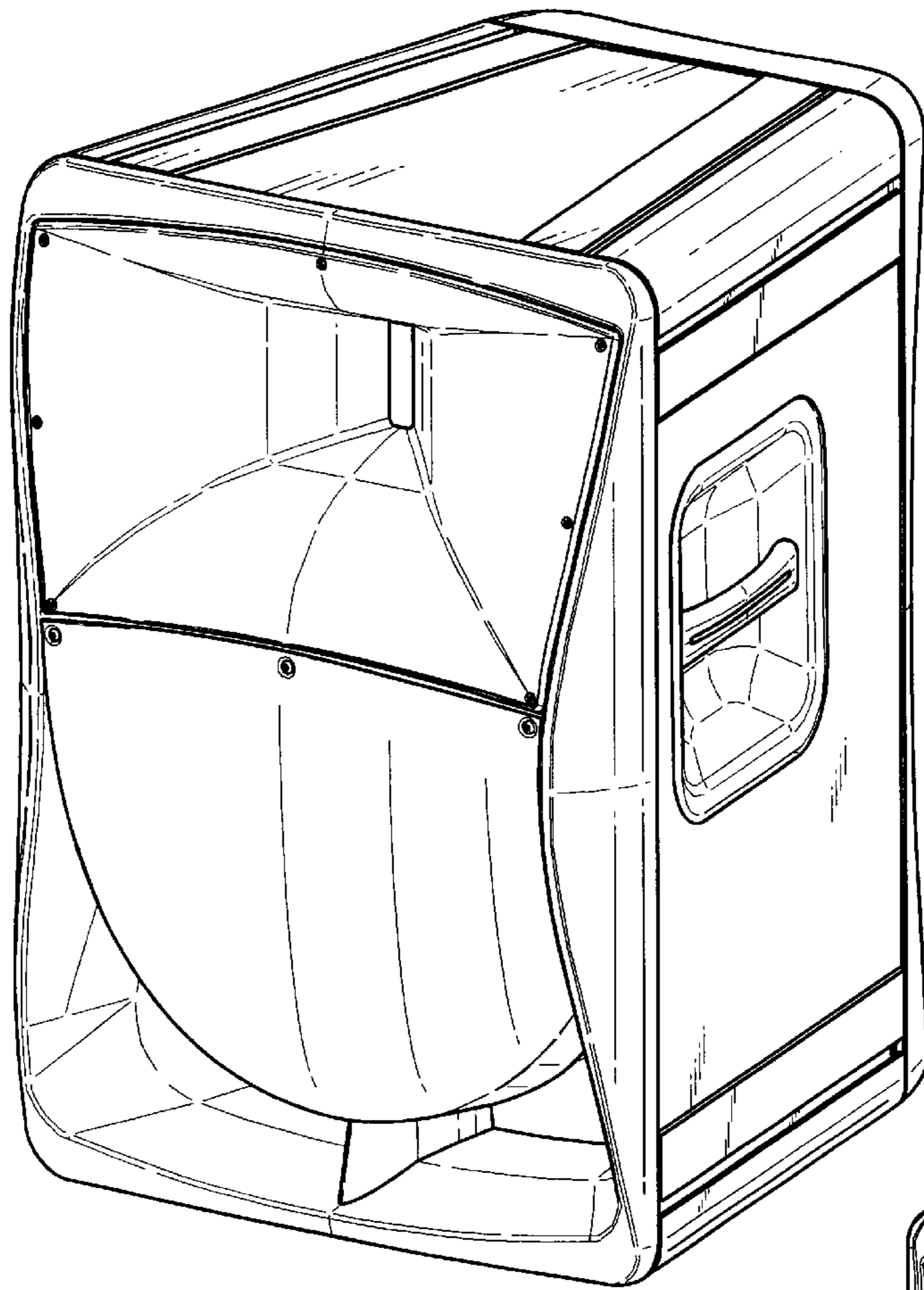

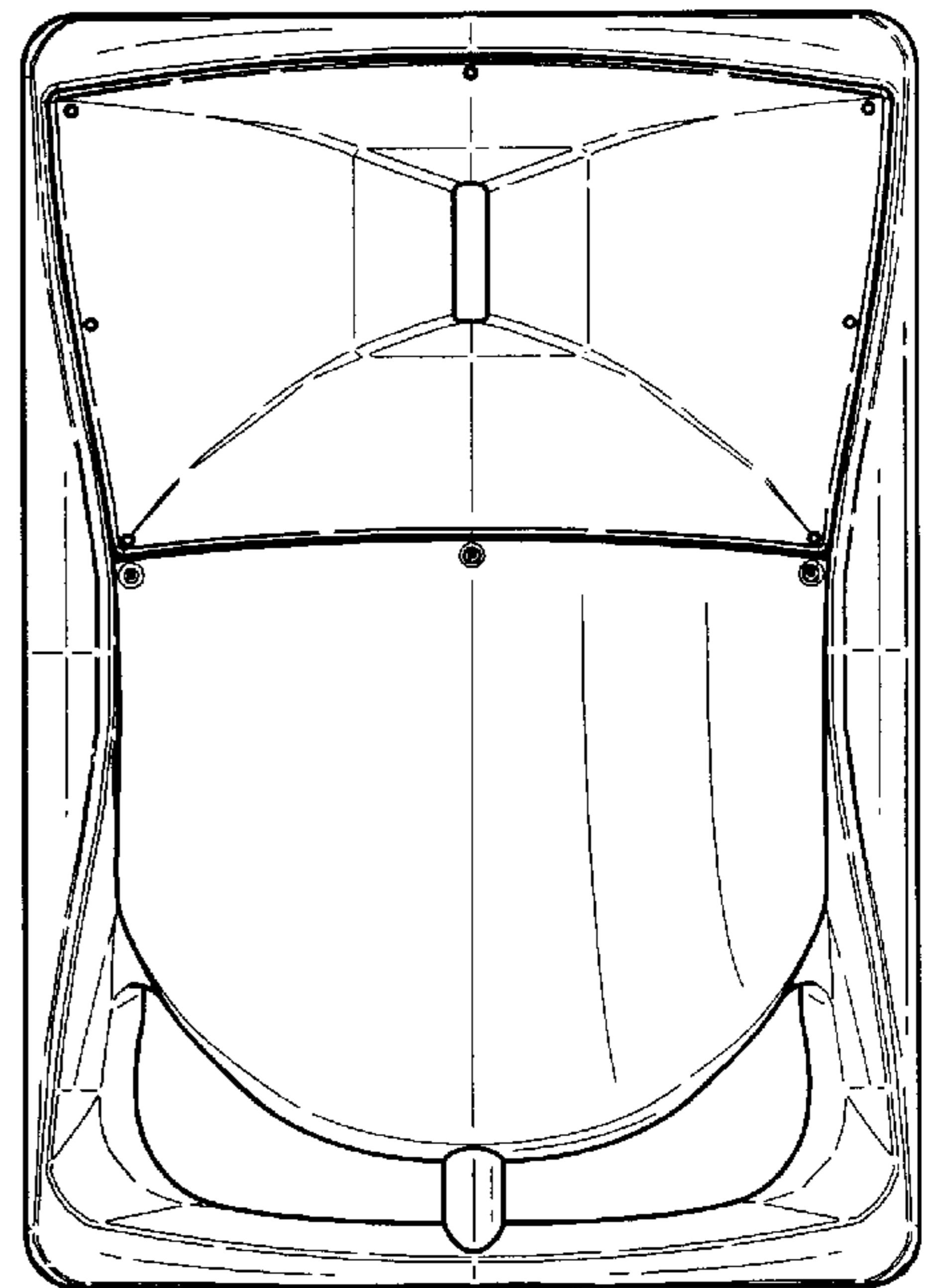

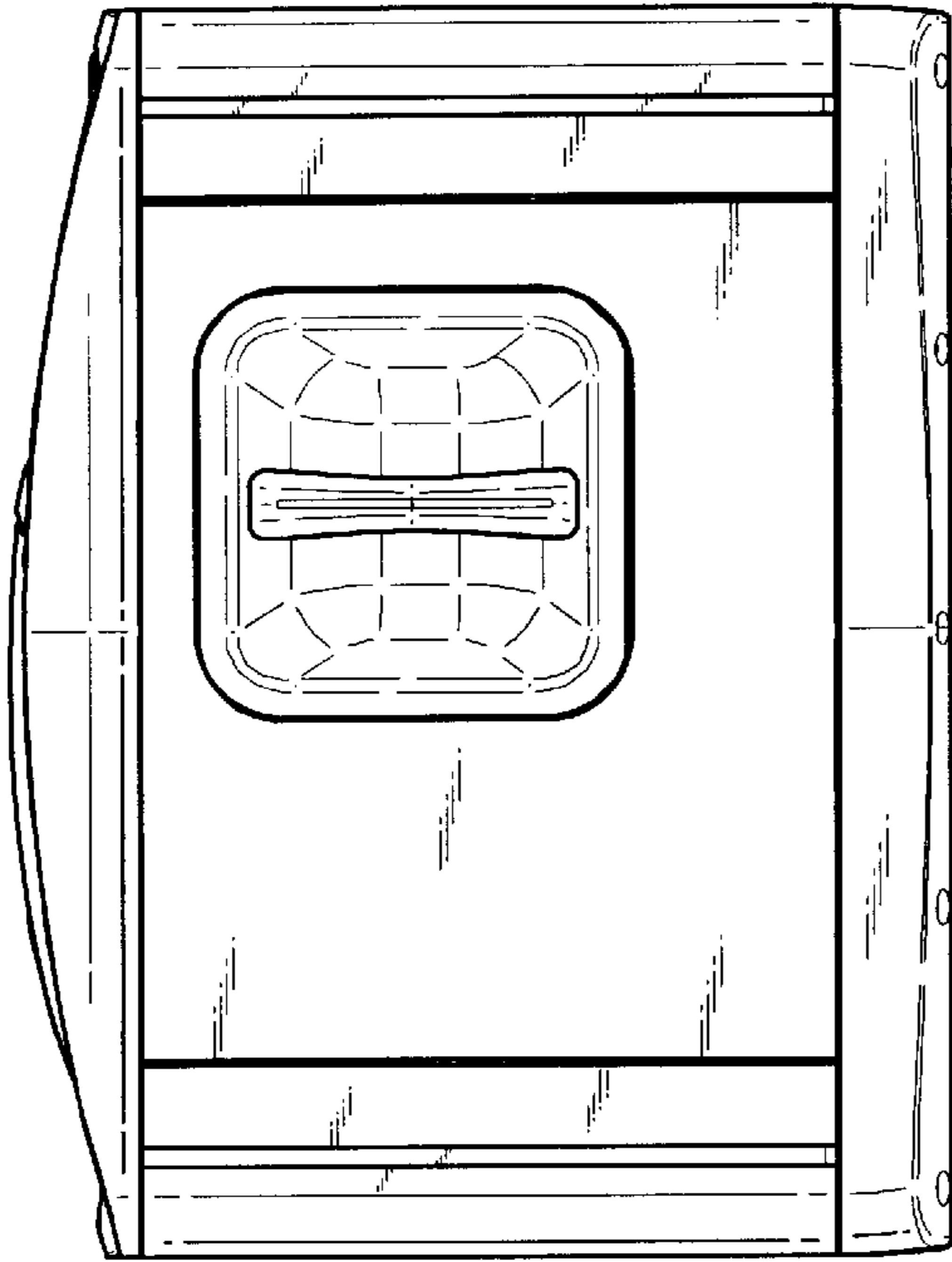

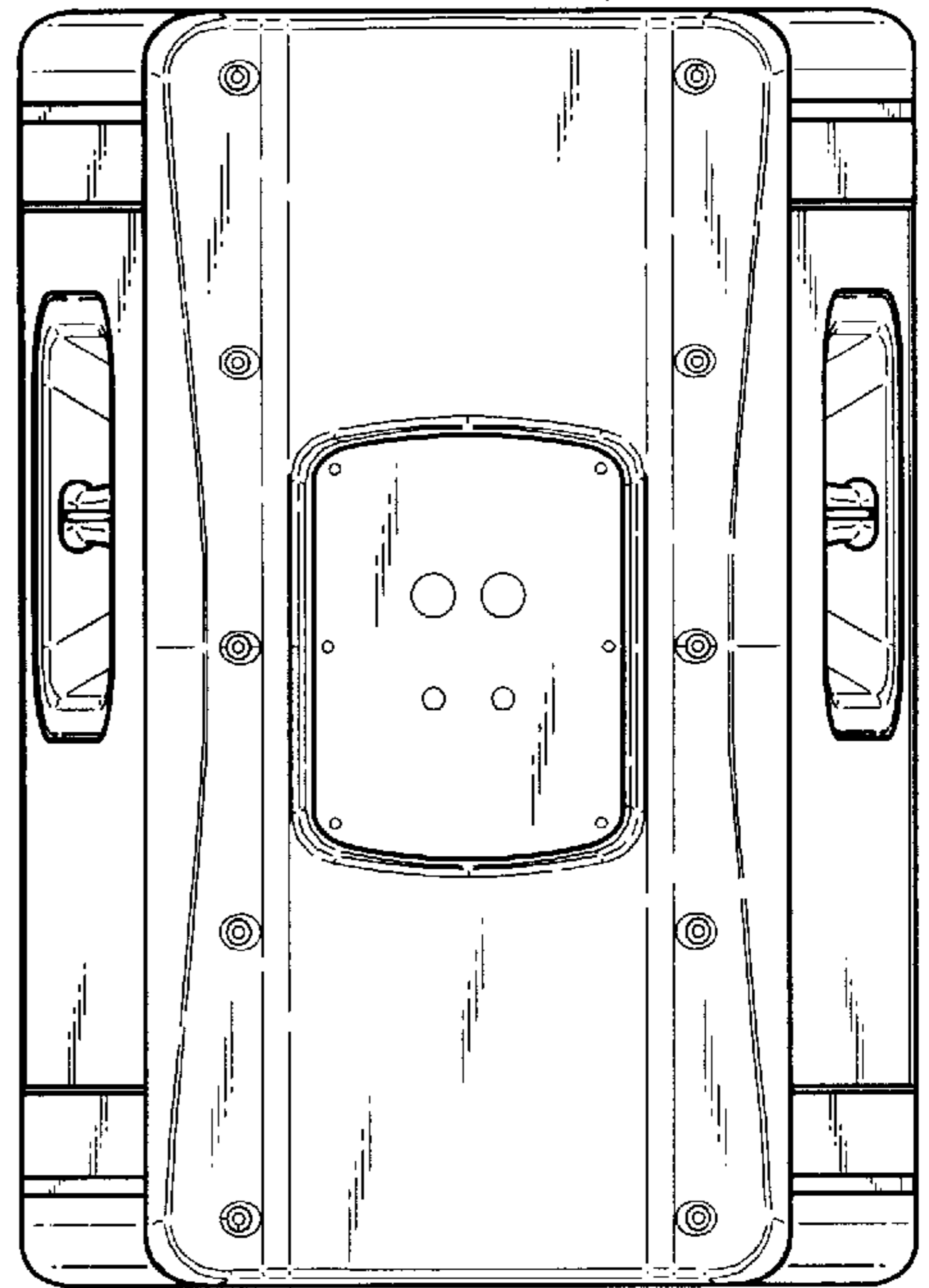

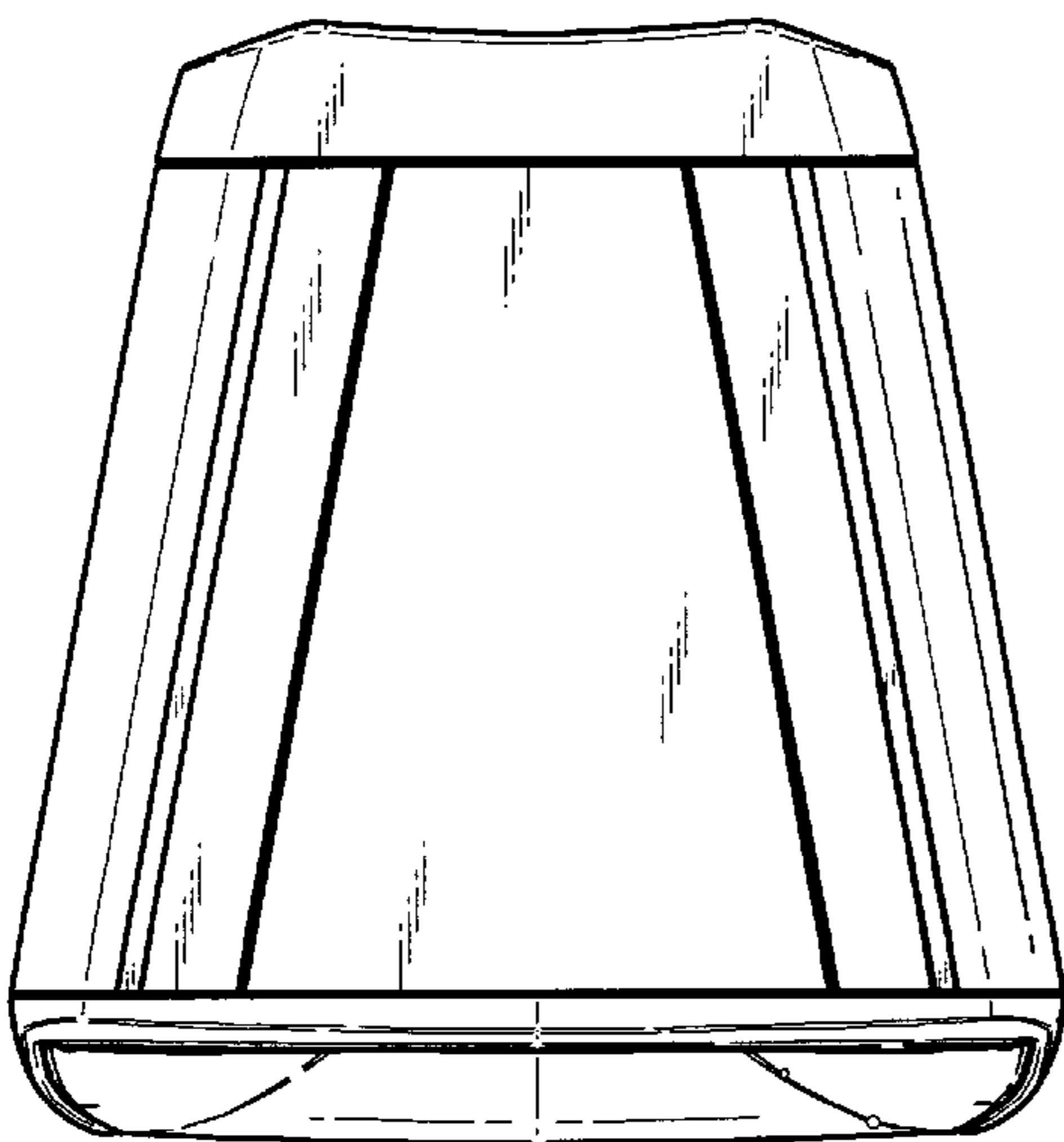

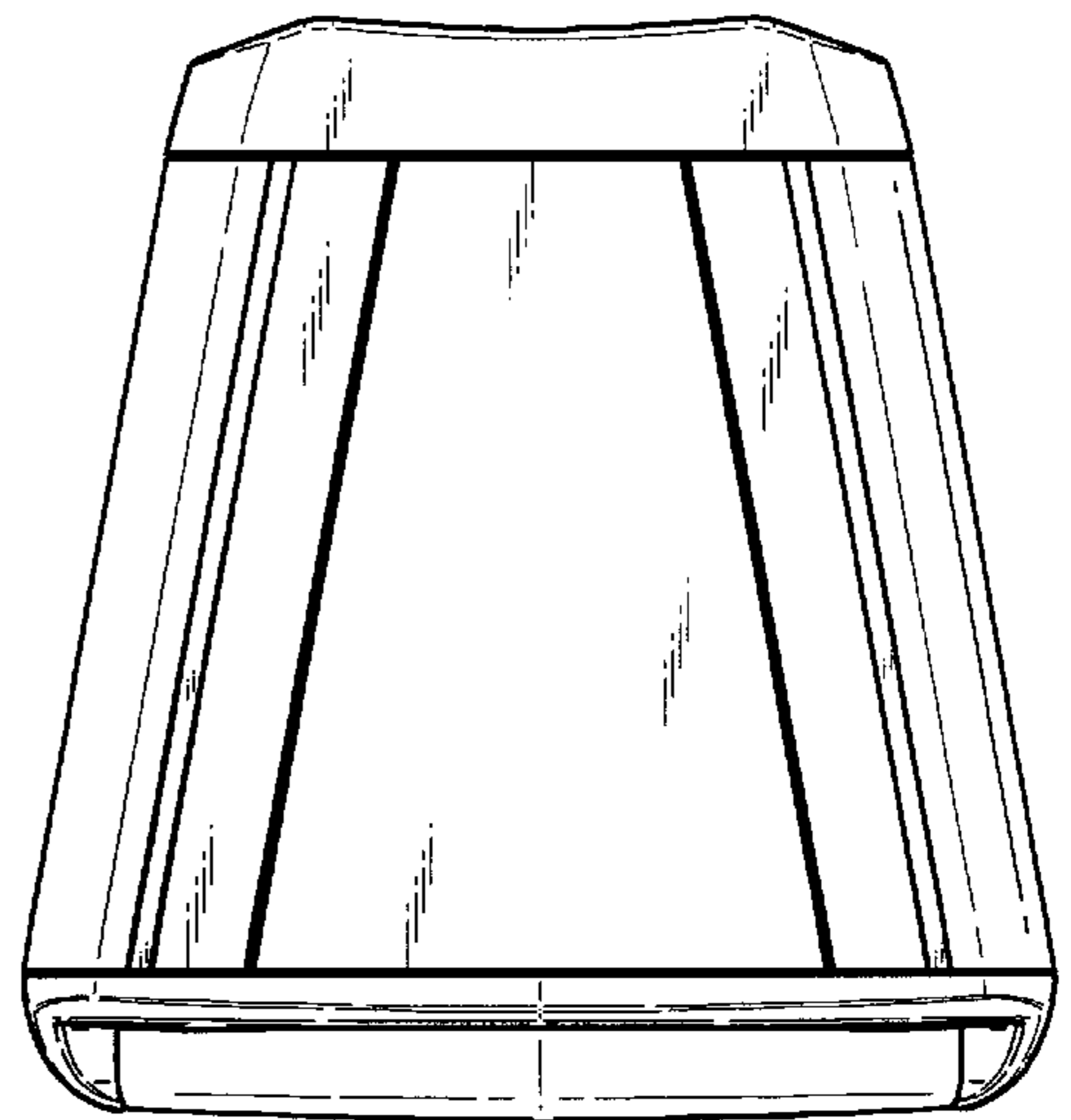

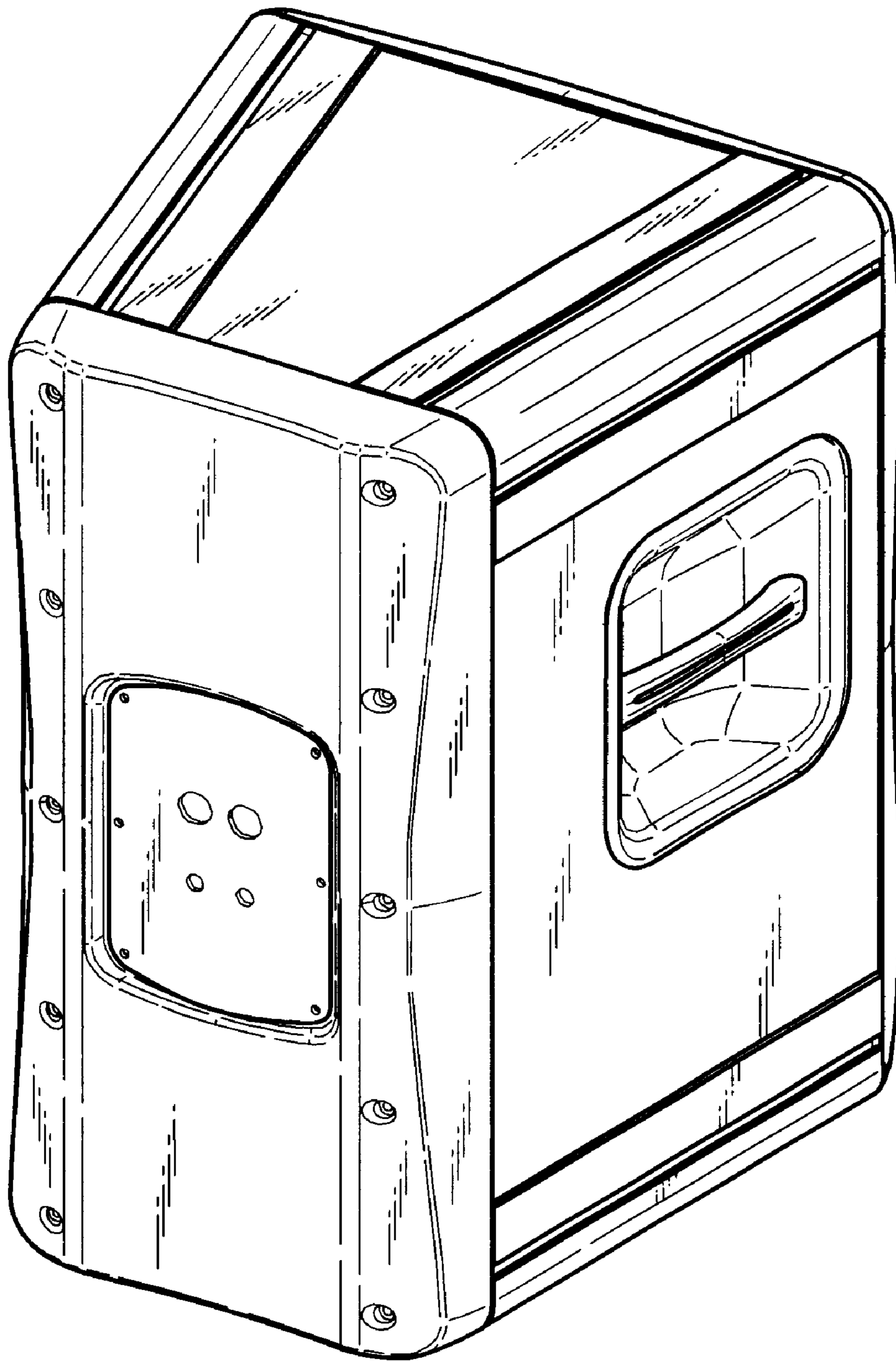
