(57) **CLAIM**

The ornamental design for a subwoofer surround and diaphragm assembly, as shown and described.

DESCRIPTION

FIG. 1 is a frontal perspective view of the subwoofer surround and diaphragm assembly showing our new design, the remainder of the subwoofer shown in broken lines;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a side elevational view thereof, the opposite side being identical;

FIG. 4 is a plan view thereof, the bottom being identical;

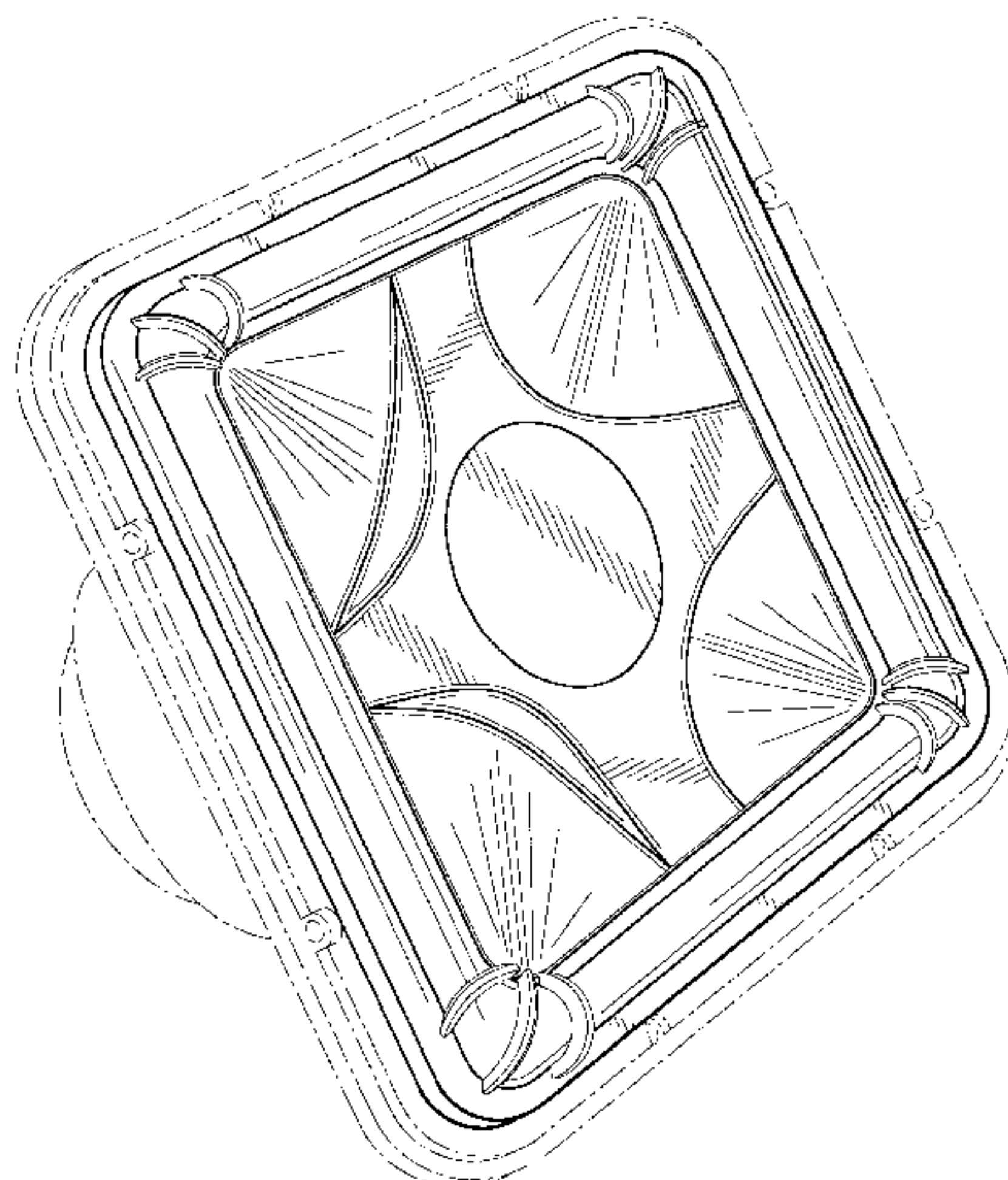
FIG. 5 shows a rear elevational view thereof.

FIG. 6 is a cross-sectional view of the subwoofer diaphragm and surround assembly taken along the line 6—6 in FIG. 2. The remainder of the subwoofer is not shown; and,

FIG. 7 is a cross-sectional view of the subwoofer diaphragm and surround assembly taken along the line 7—7 in FIG. 2. The remainder of the subwoofer is not shown.

The broken line showing of the remainder of the subwoofer in FIGS. 1-5 is for illustrative purposes only and forms no part of the claimed design.

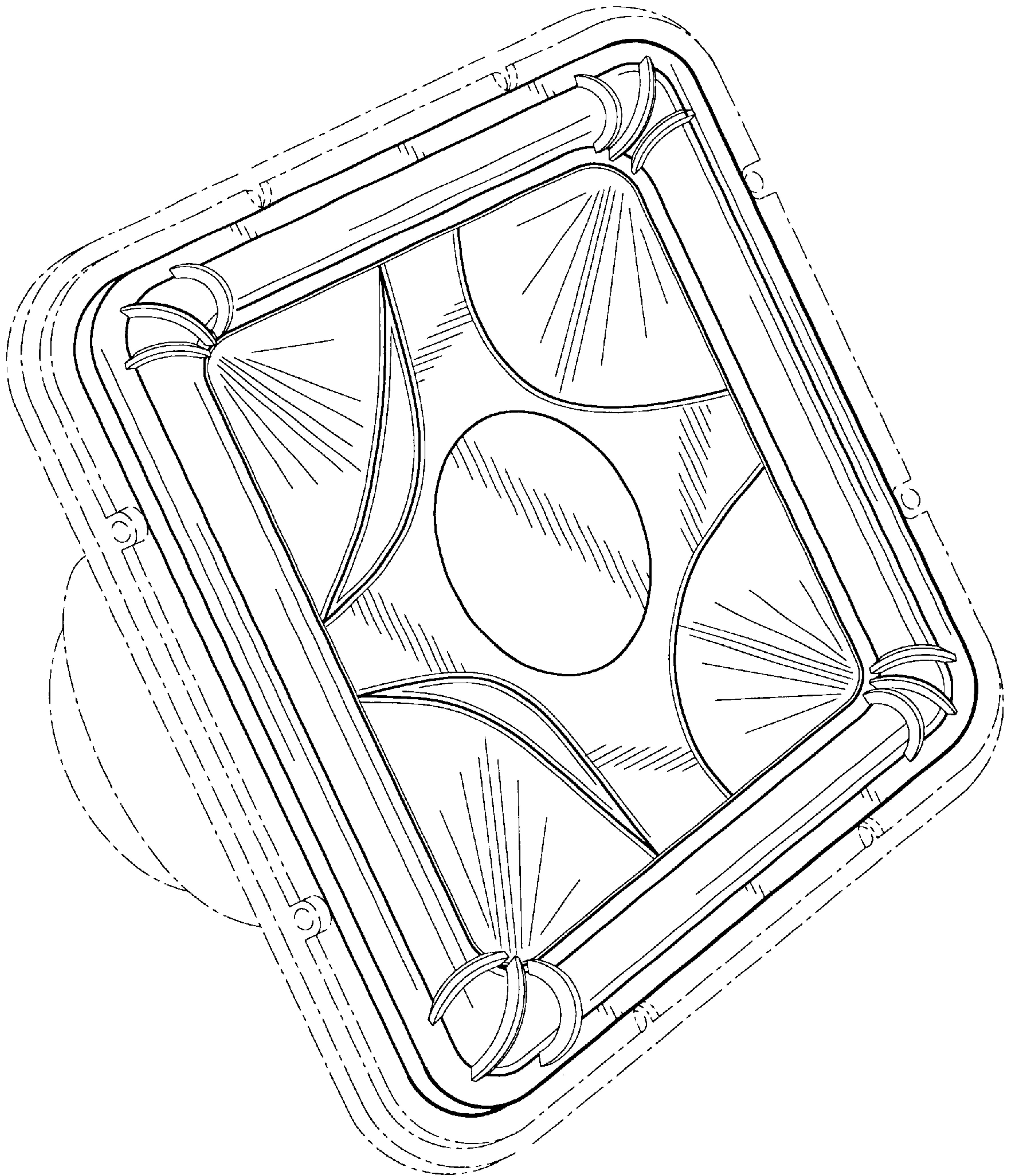
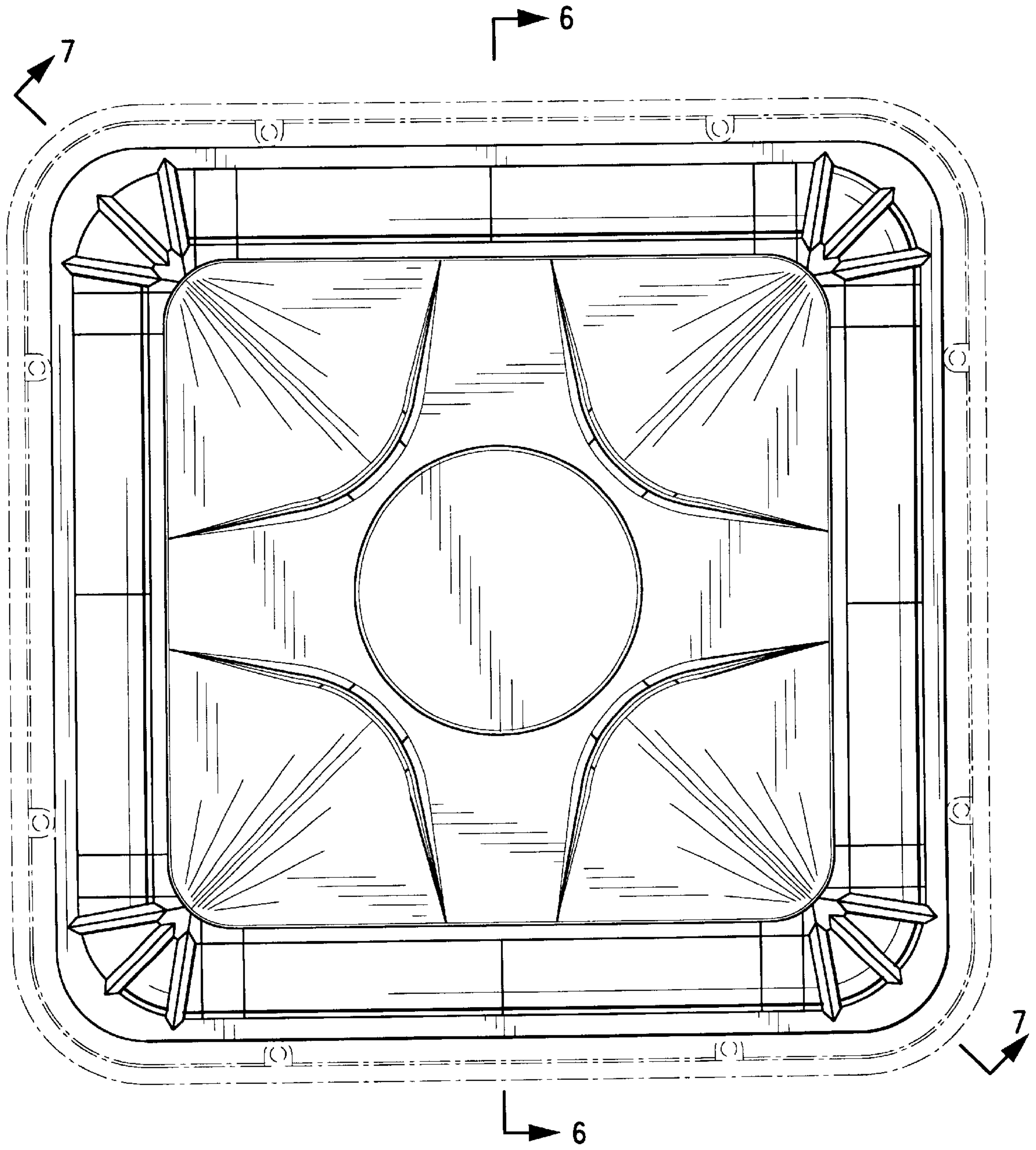

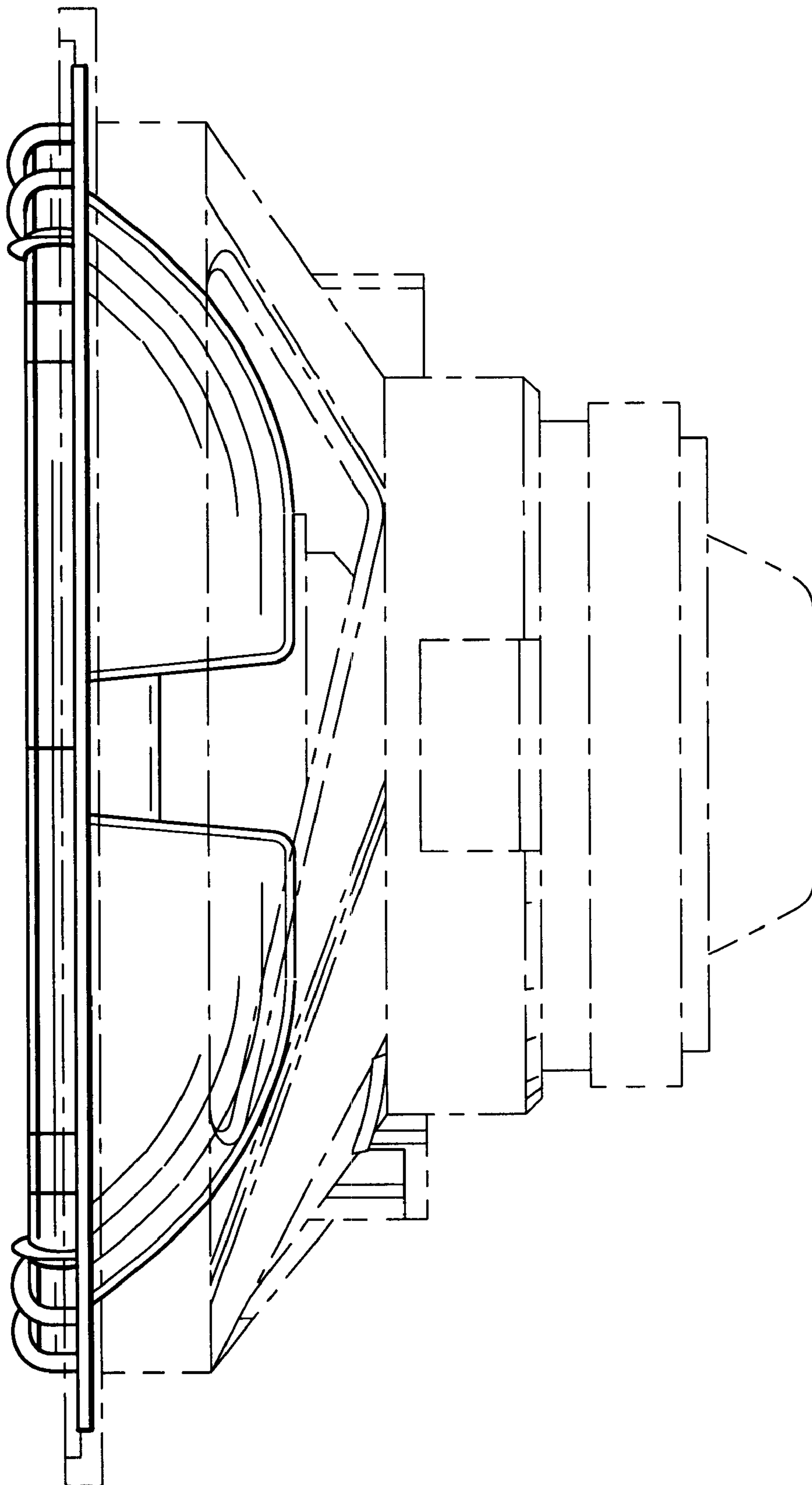

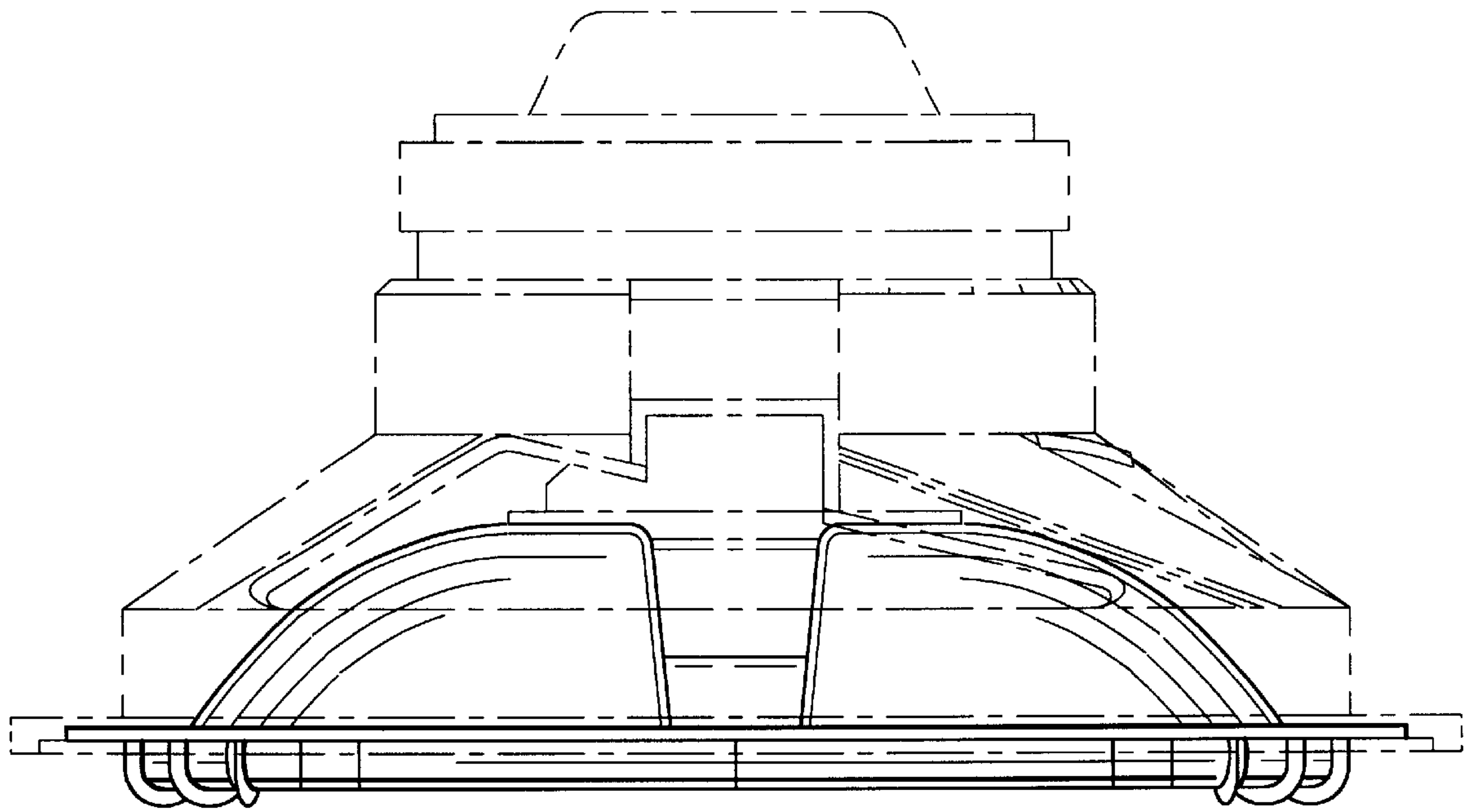

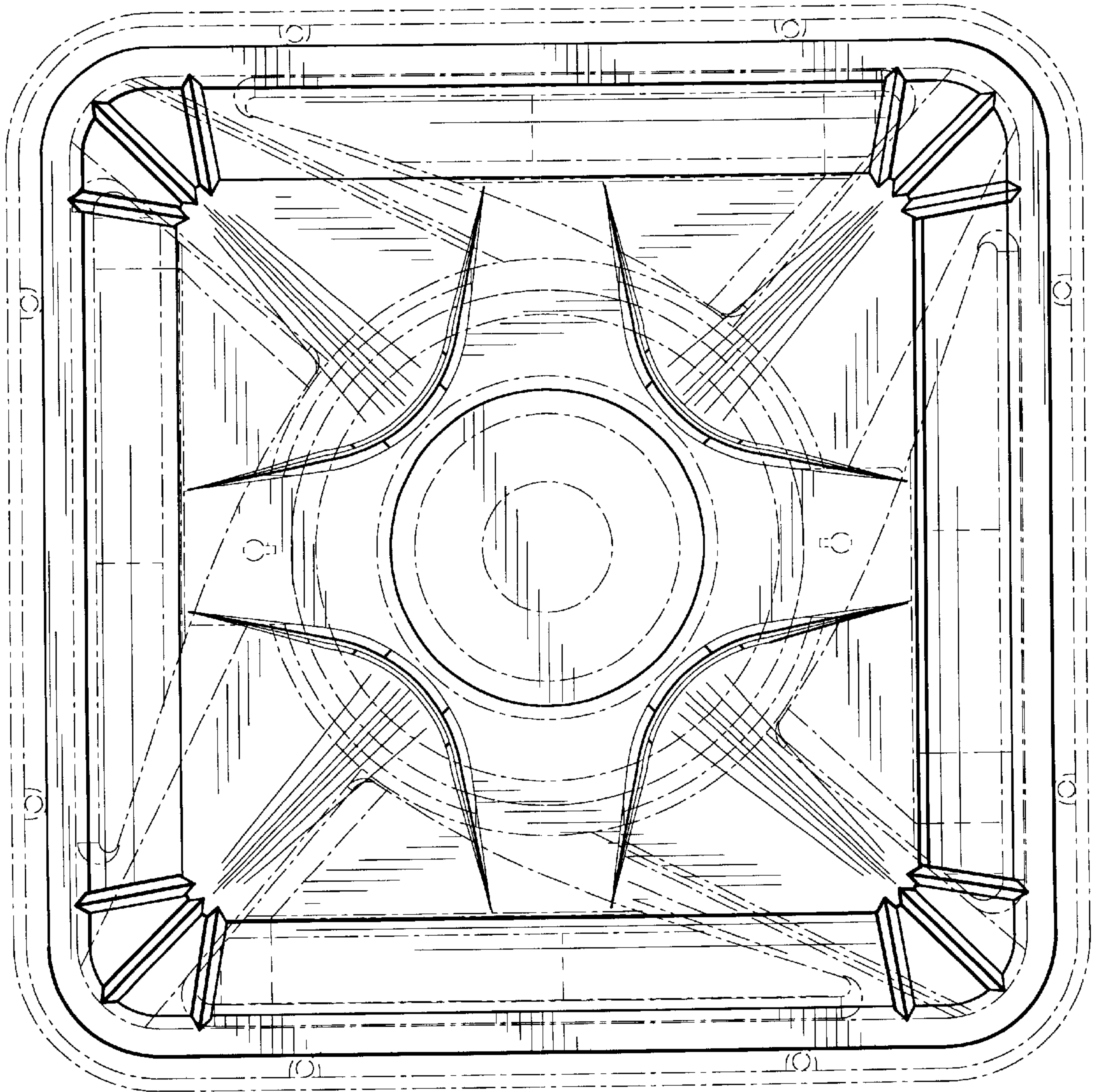

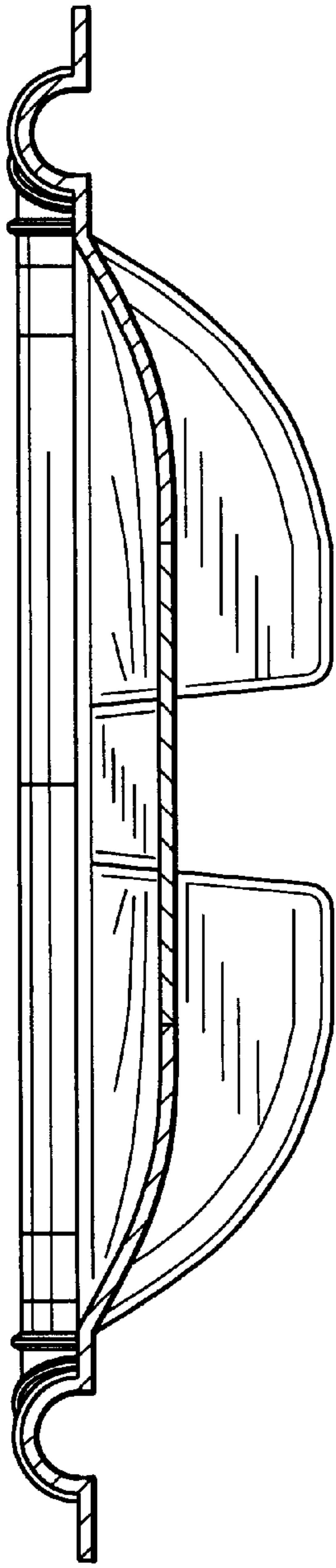

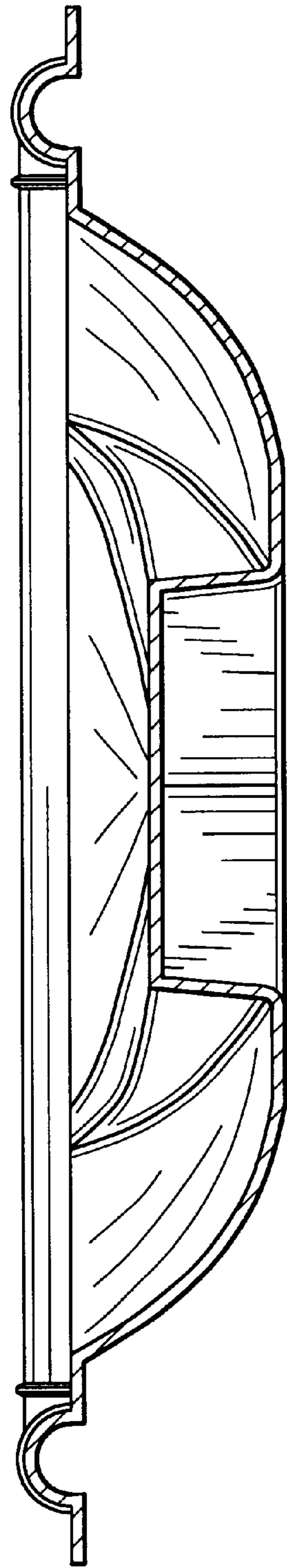
