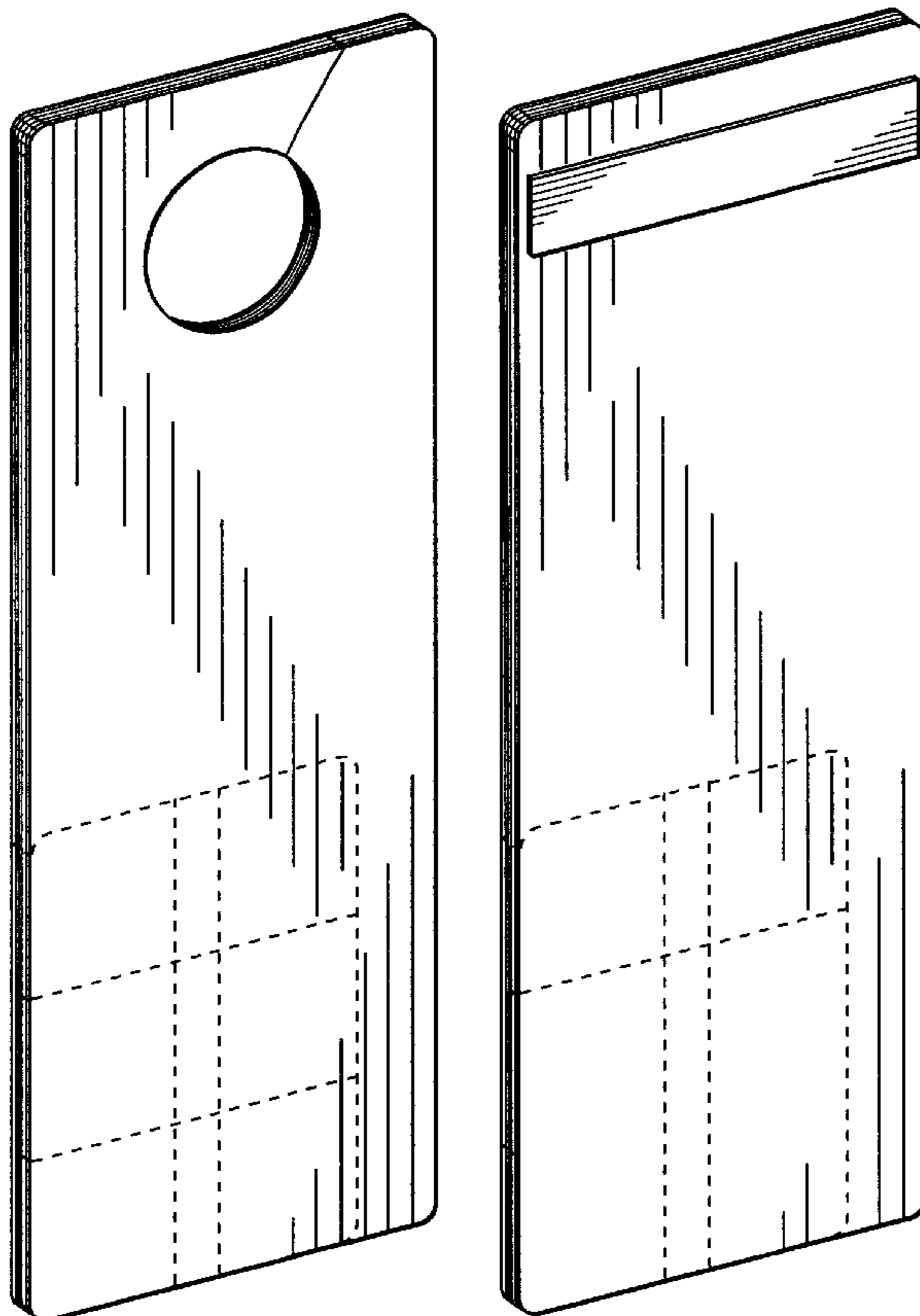
(57) **CLAIM**

The ornamental design for a hanger coupon card, as shown.

DESCRIPTION

FIG. 1 is a front, top and right side perspective view of a hanger coupon card embodying my new design;

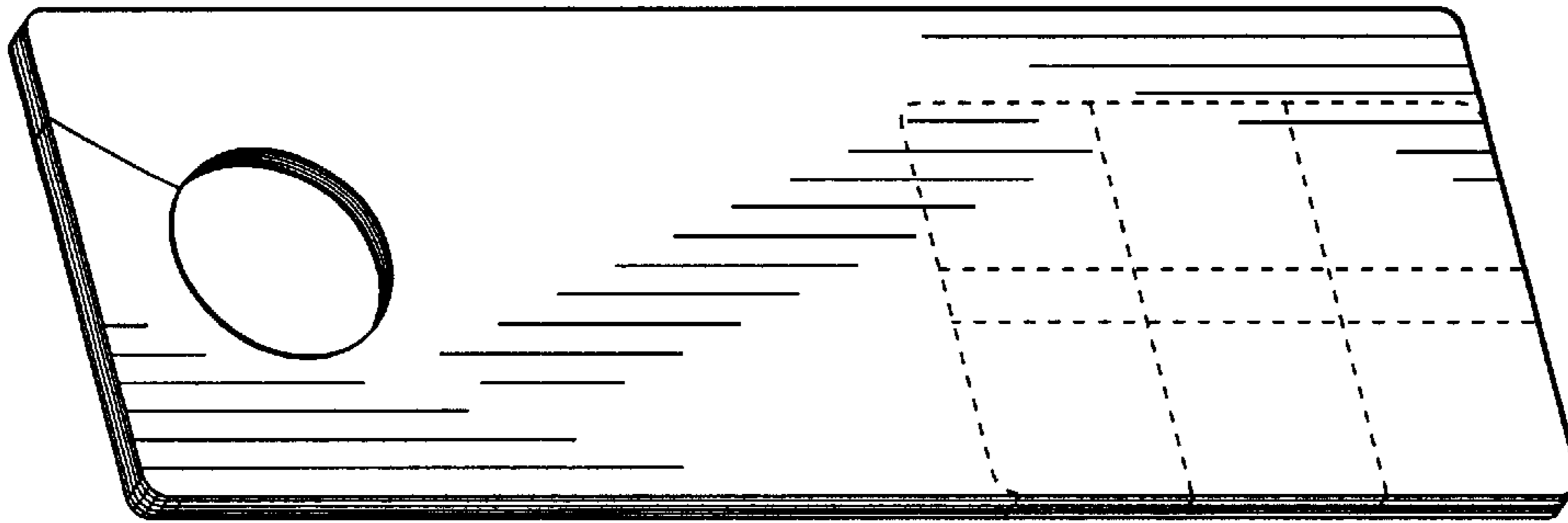

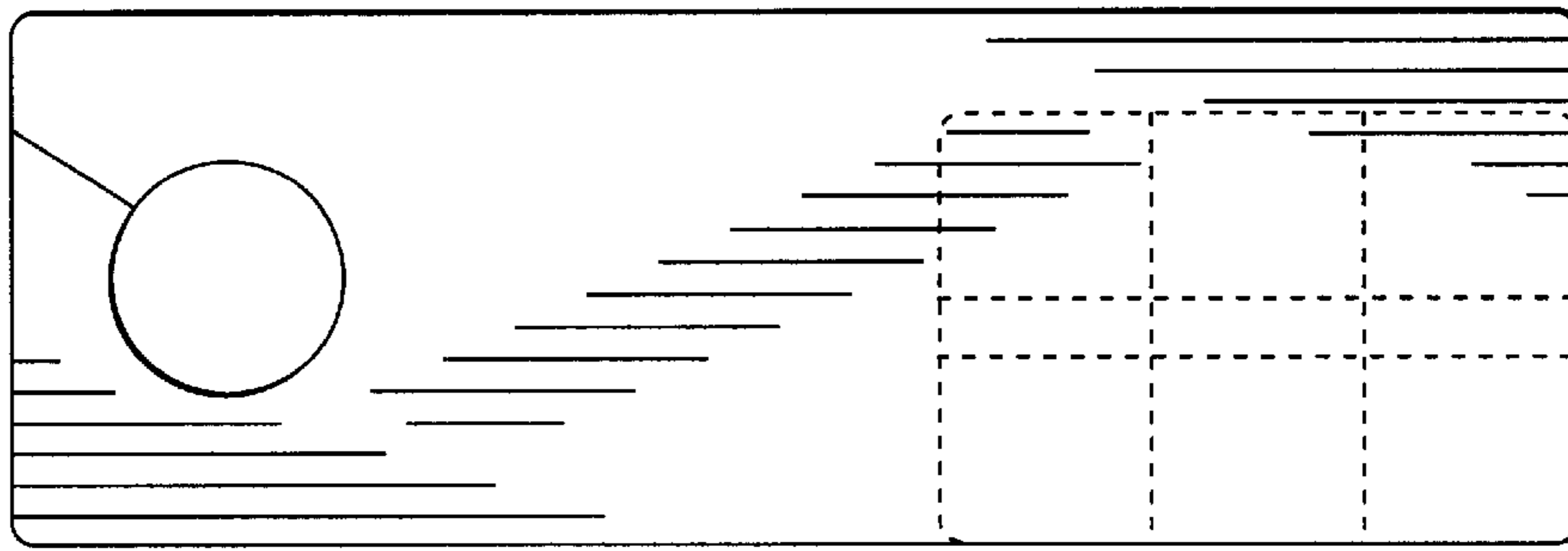

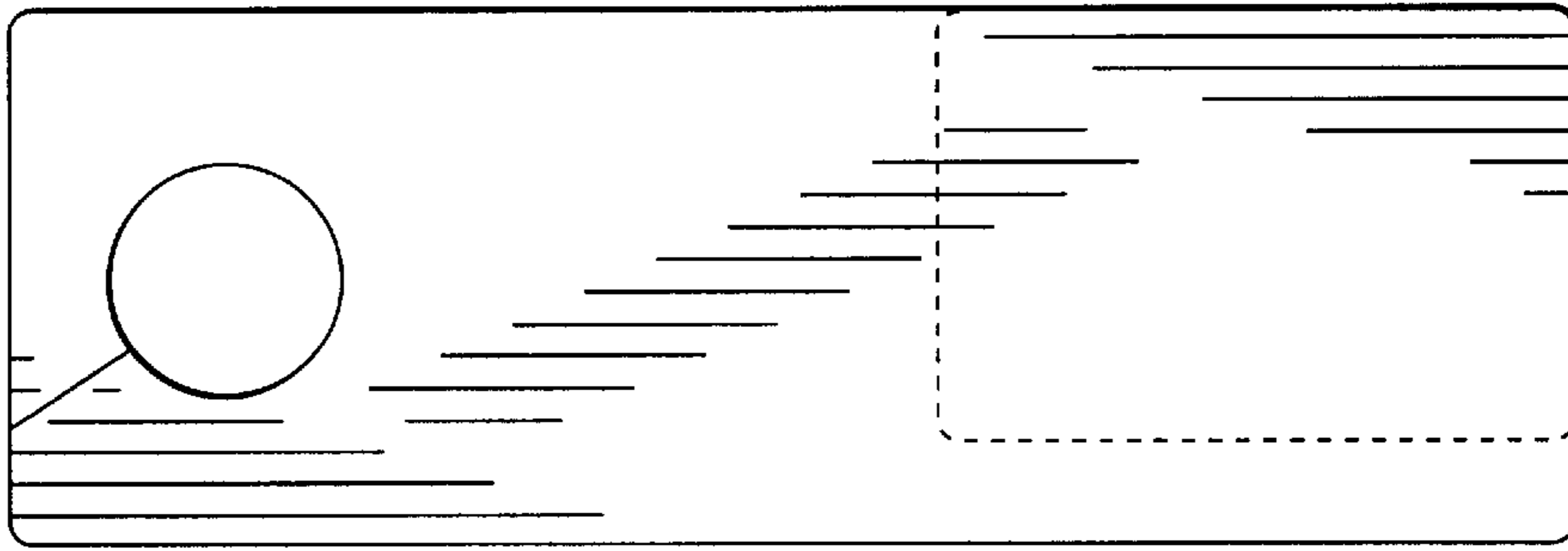

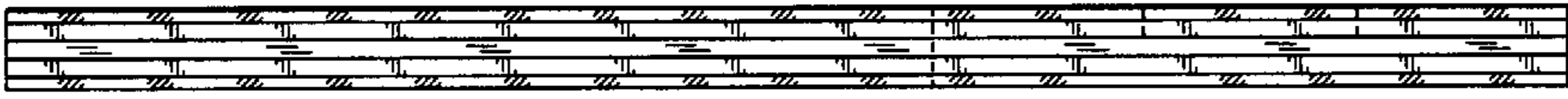

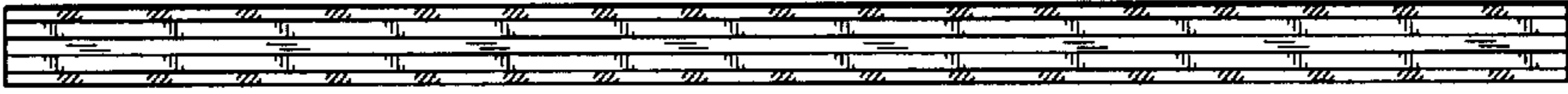

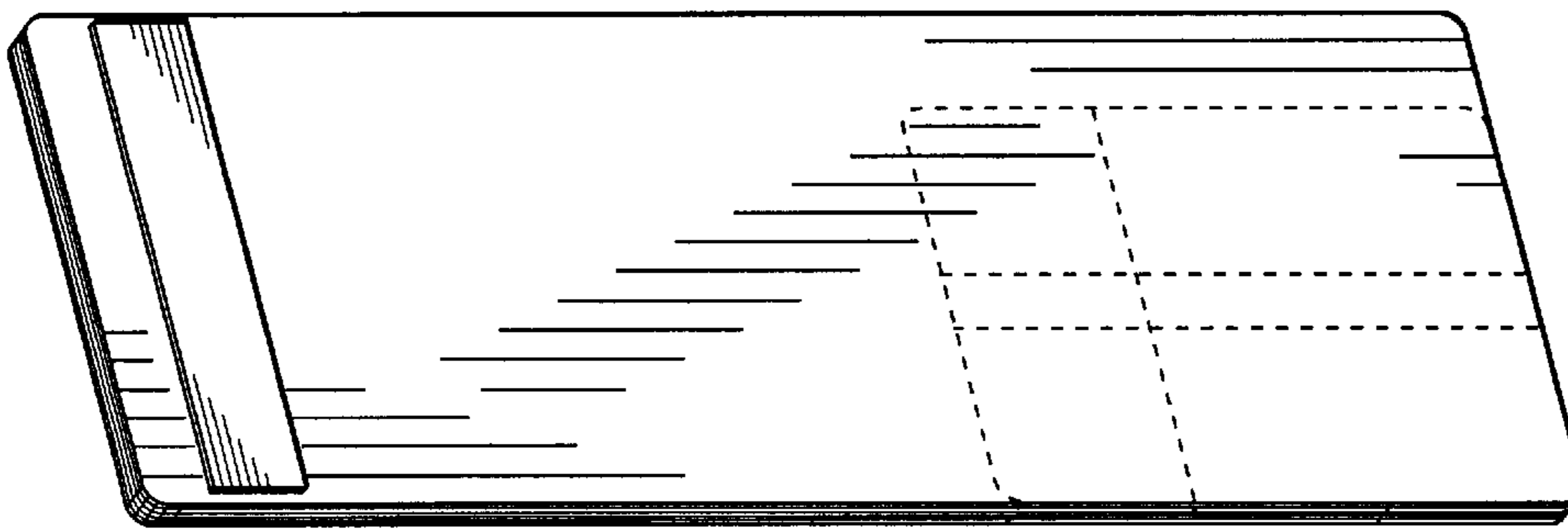

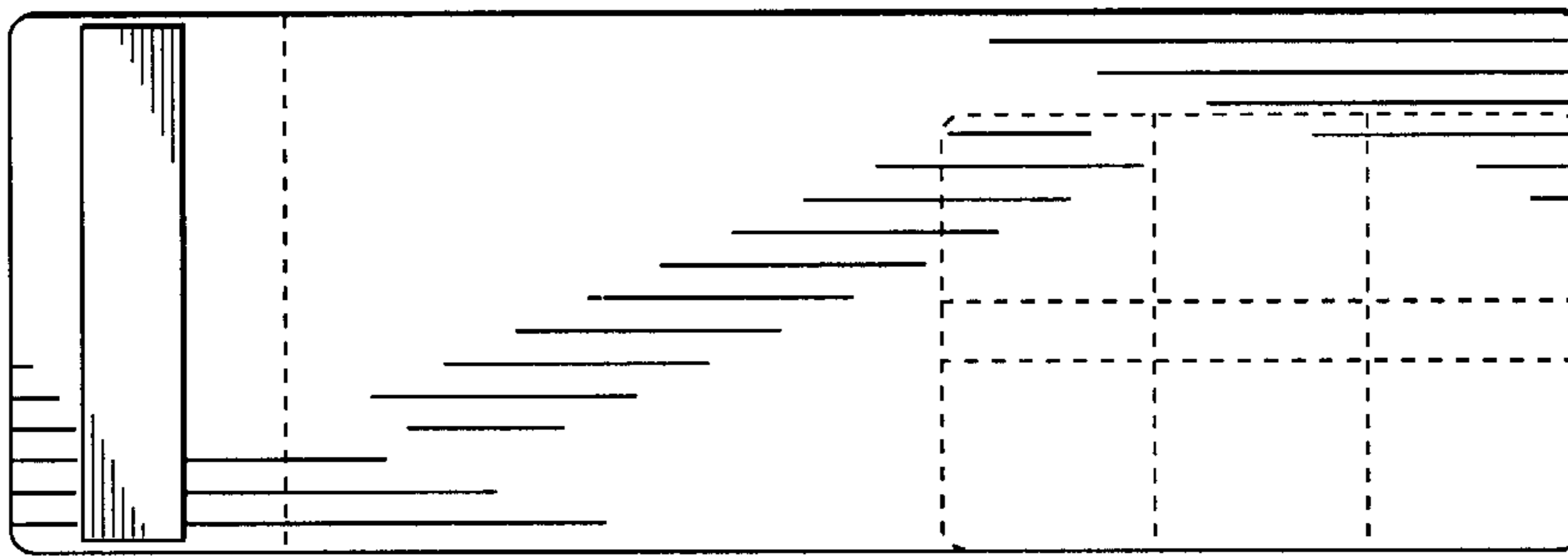

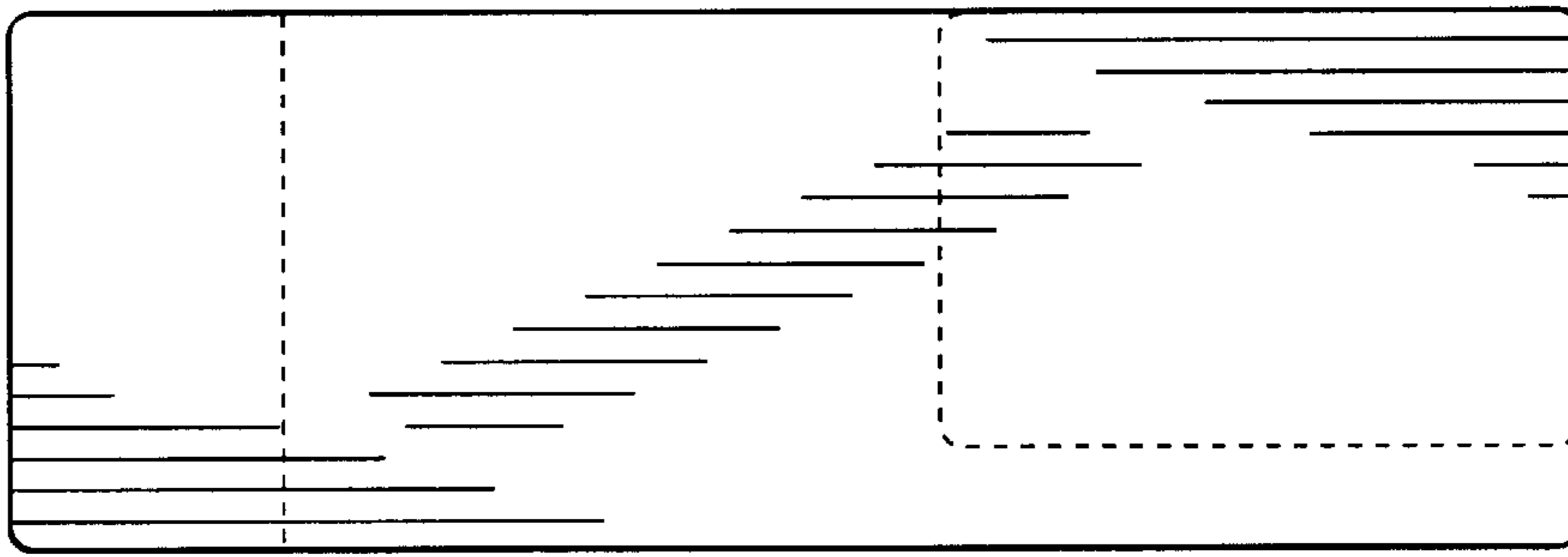

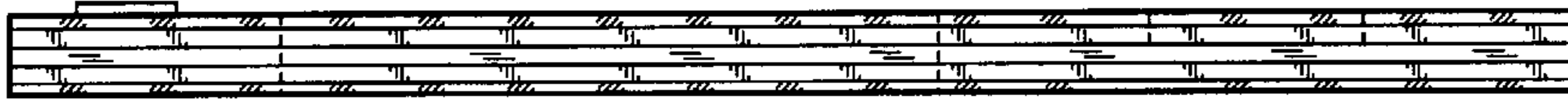

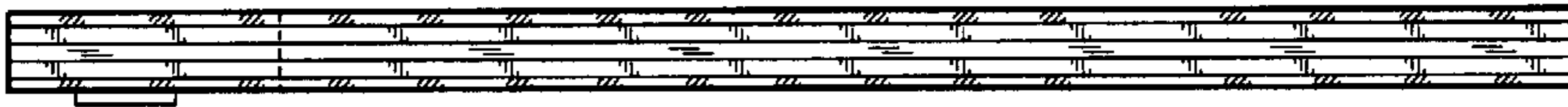
