We claim the ornamental design for a sport boot, such as for skating, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view, taken from the front and right side, showing our new design;
 FIG. 2 is a right side view thereof;
 FIG. 3 is a left side view thereof;
 FIG. 4 is a top view thereof;
 FIG. 5 is a bottom view thereof;
 FIG. 6 is a front end view thereof; and,
 FIG. 7 is a rear end view thereof.

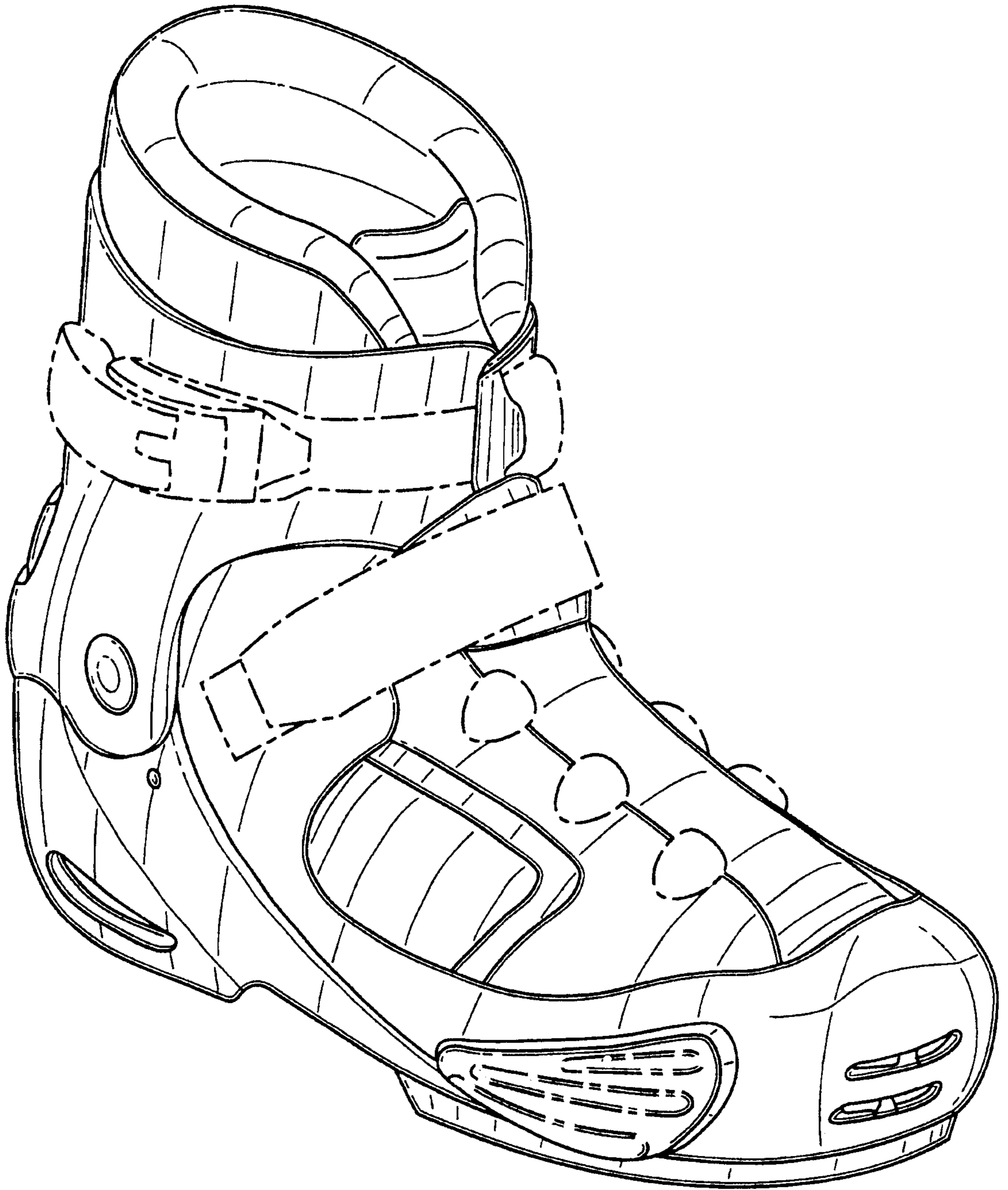

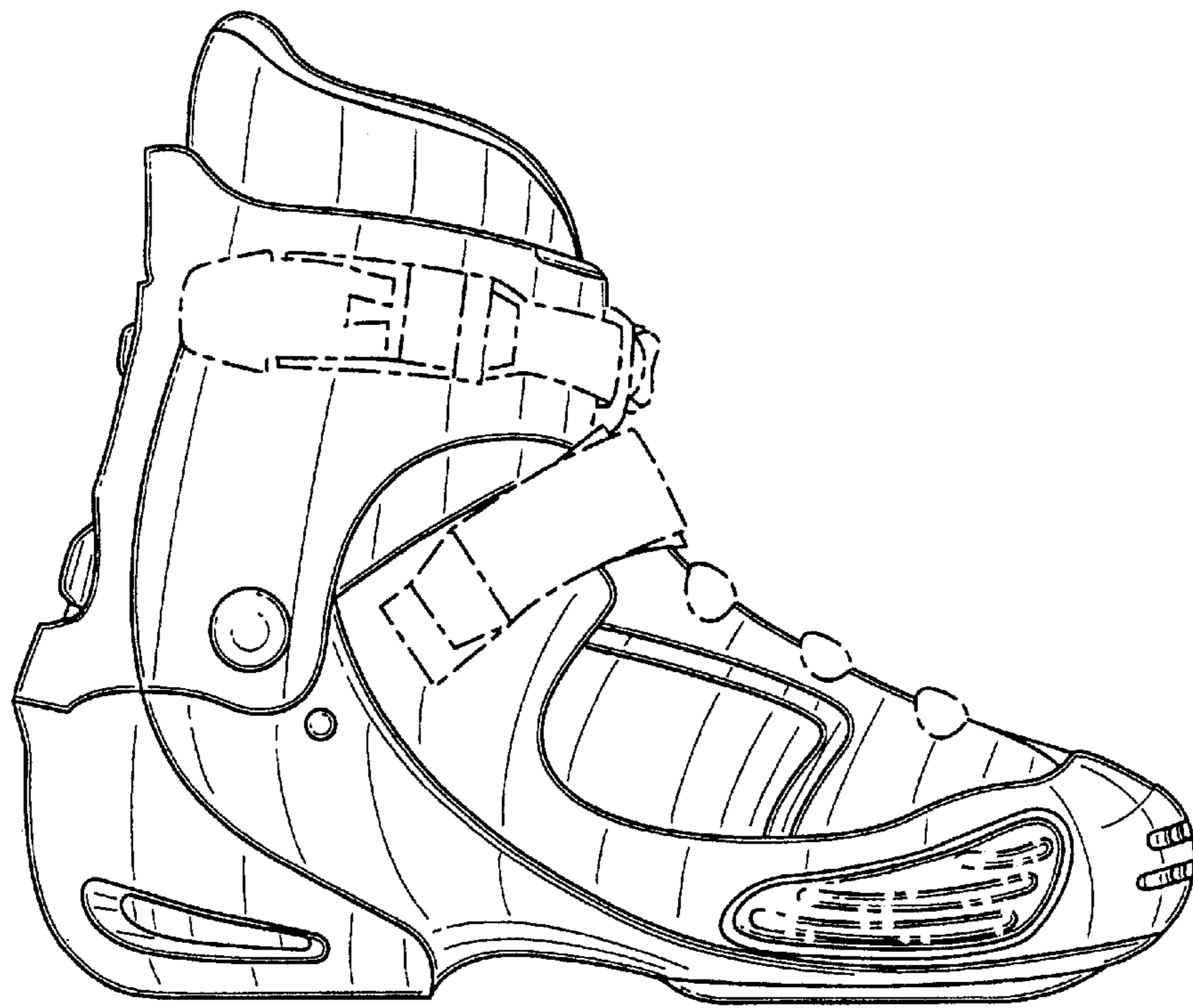

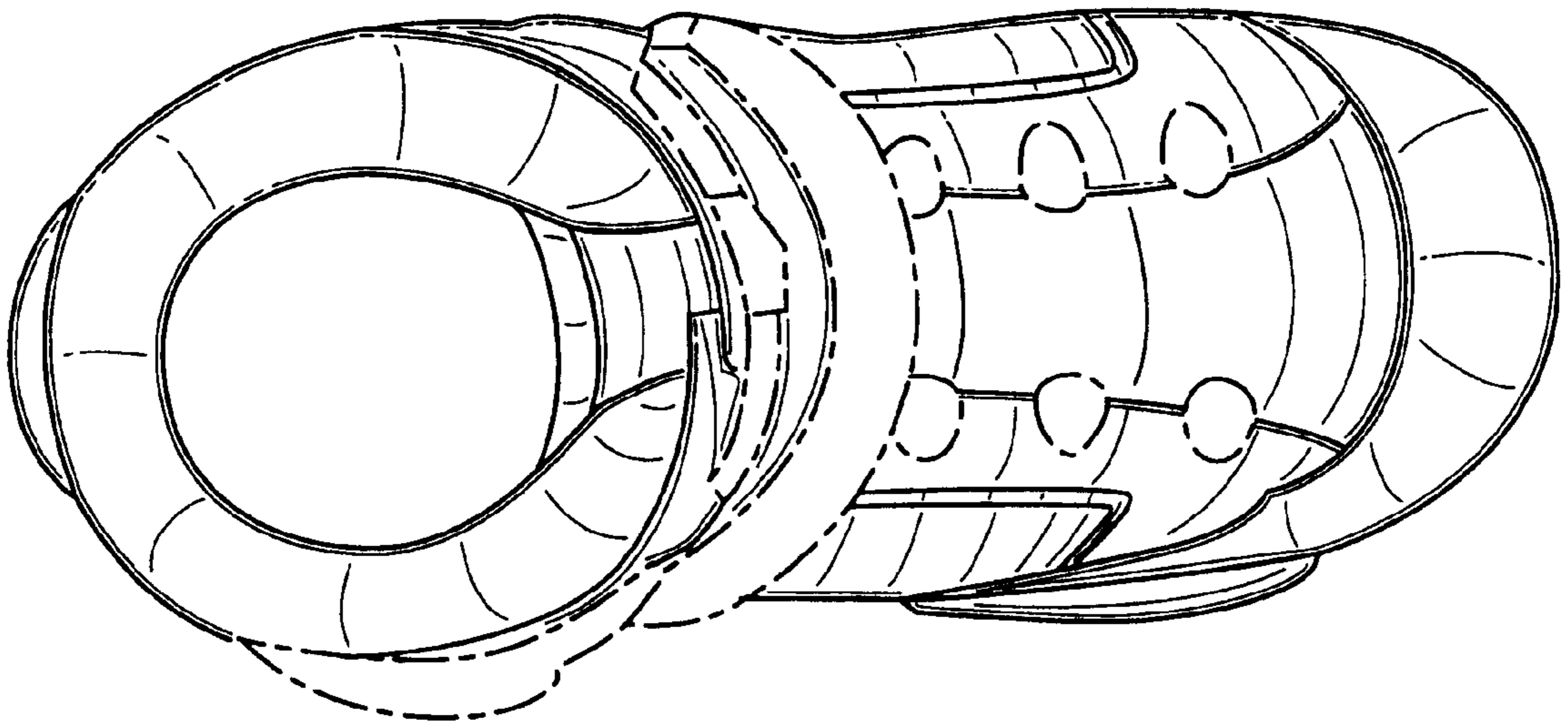

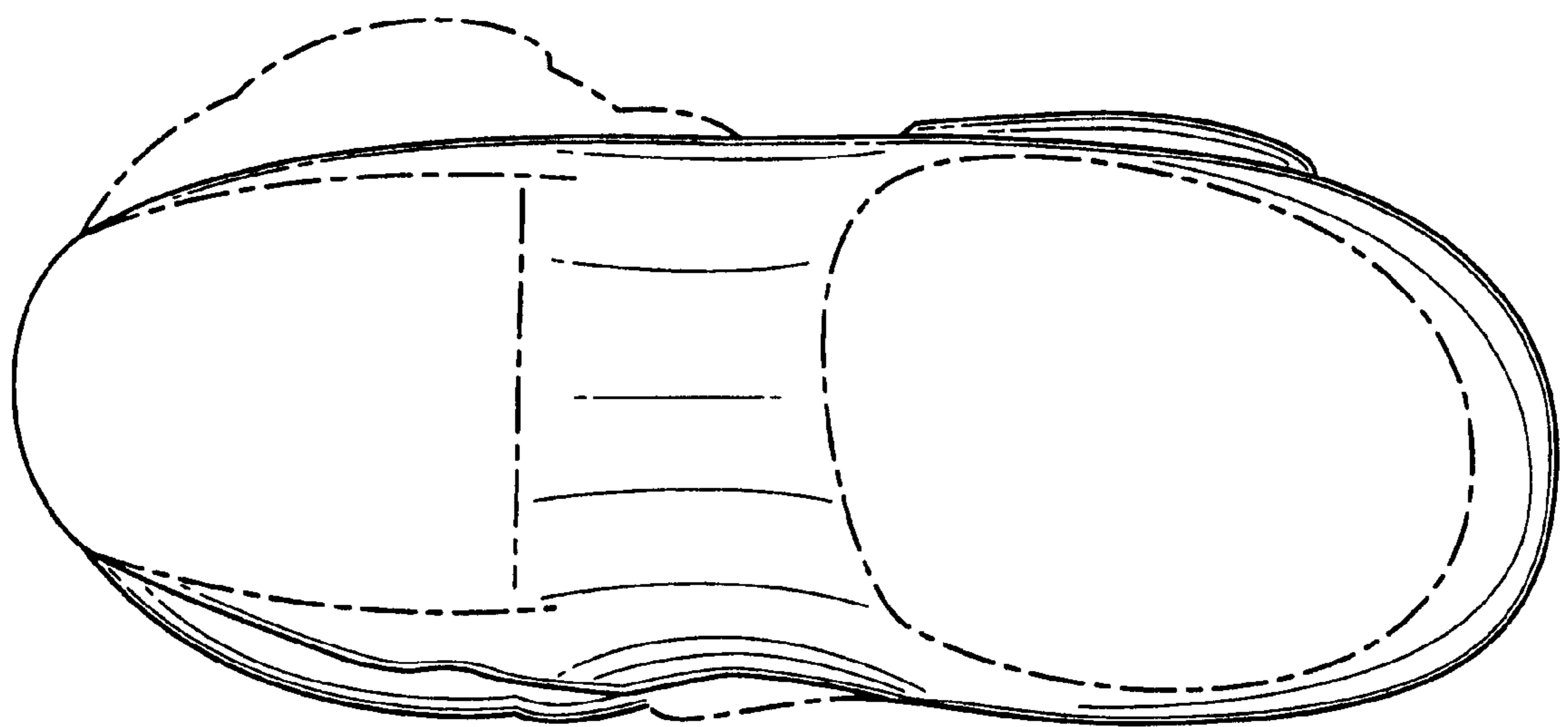

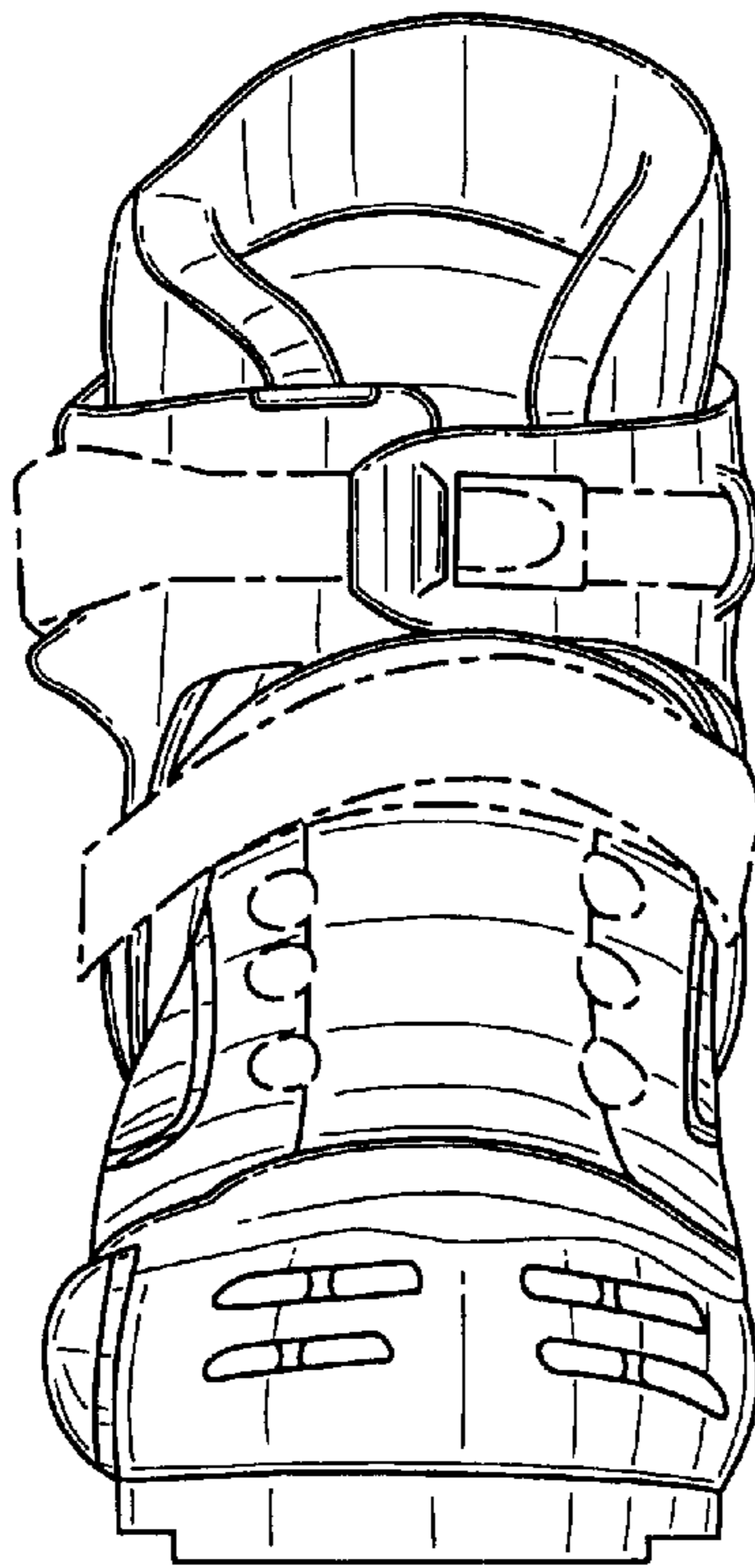

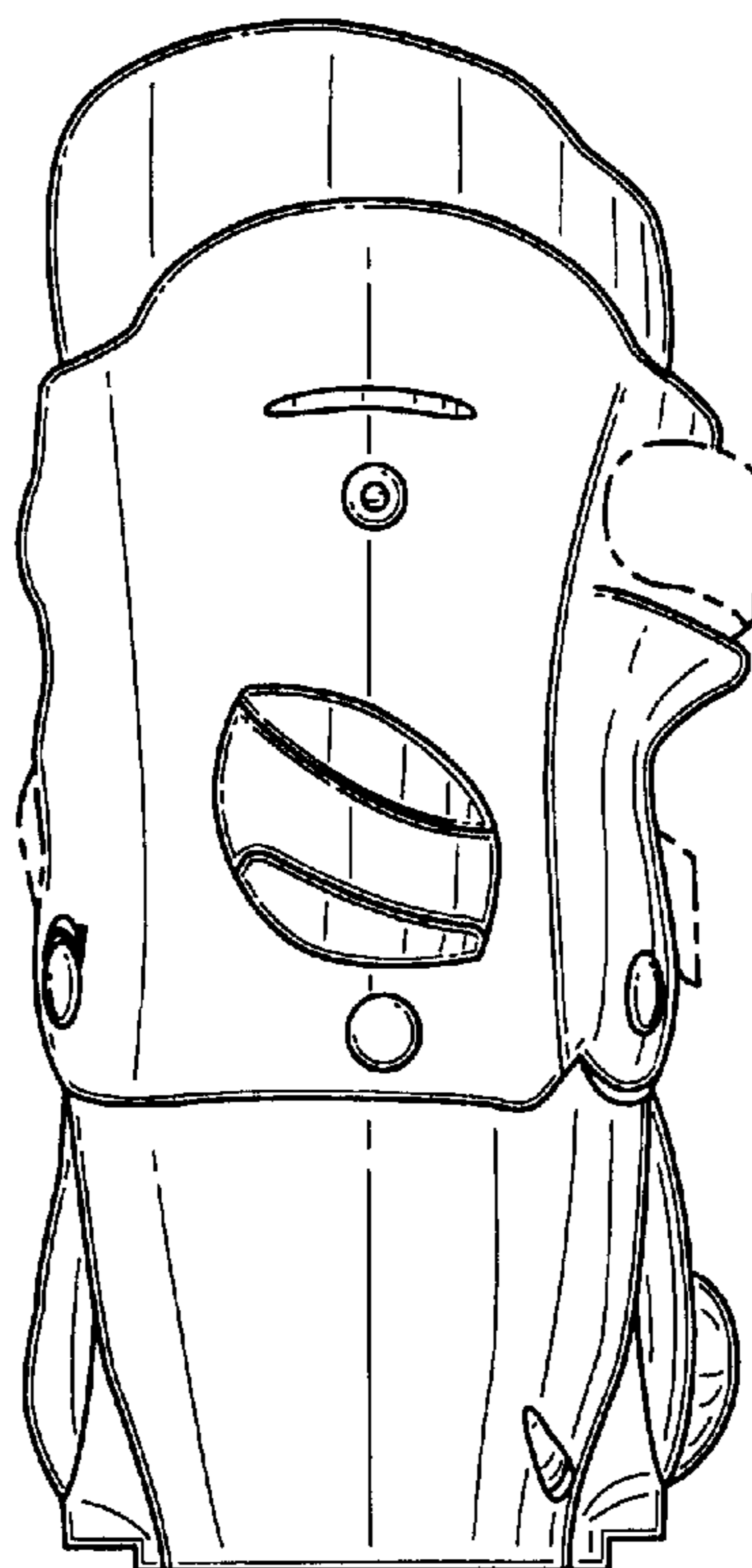
