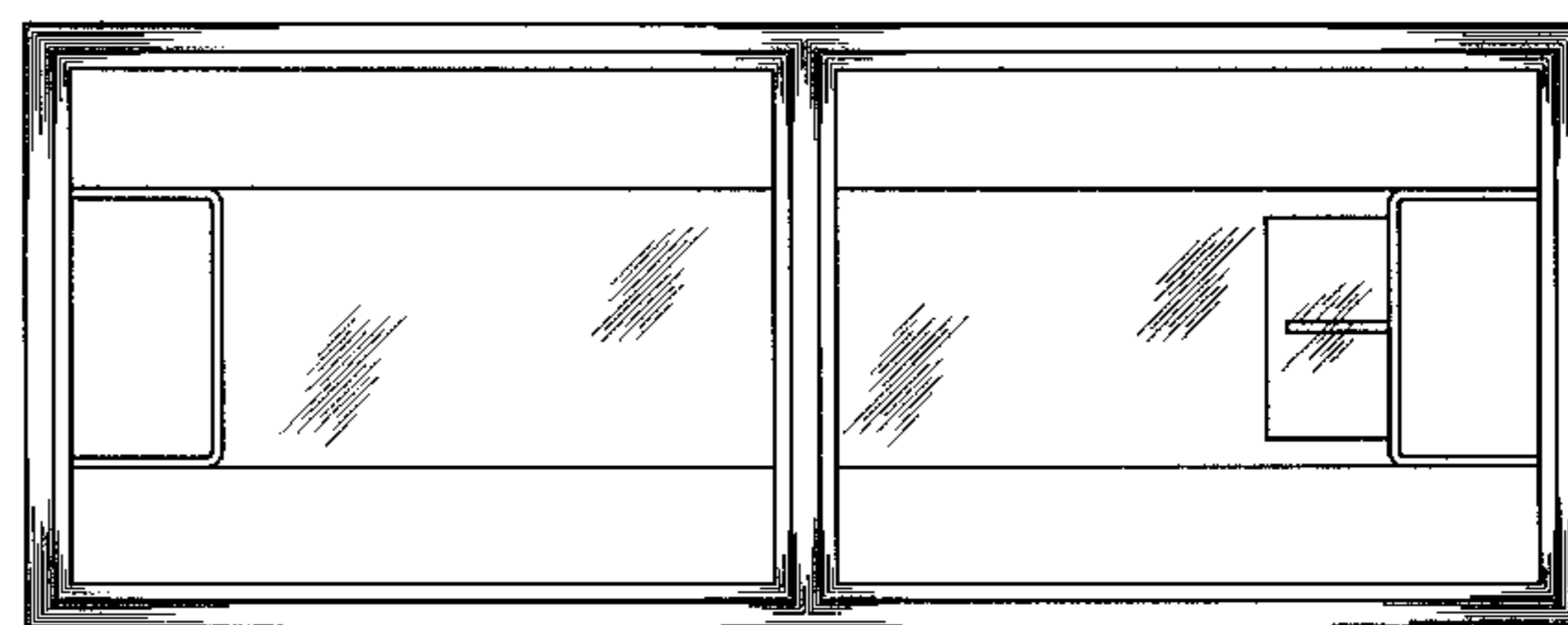
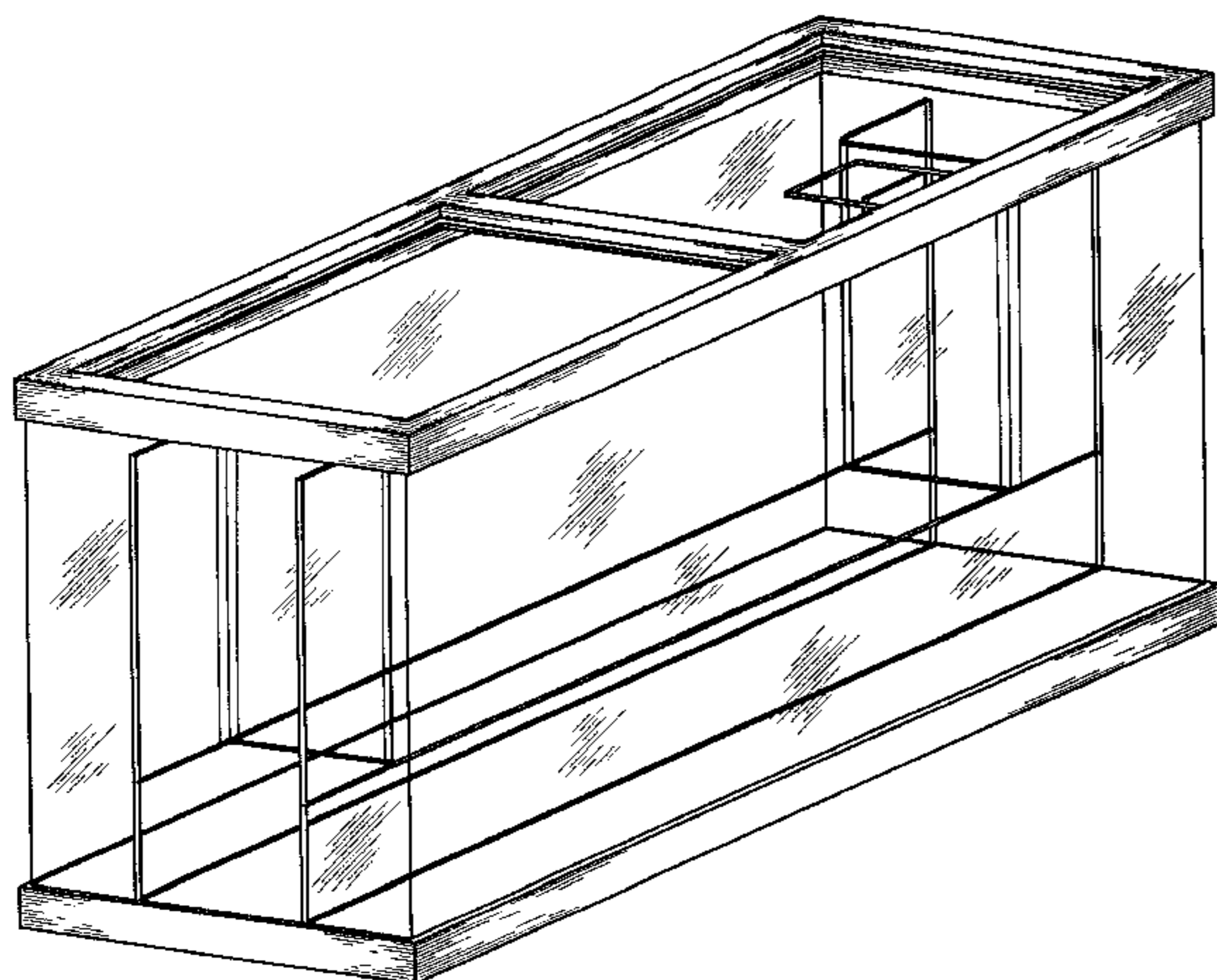
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a combined aquarium and terrarium showing my new design;
FIG. 2 is a right side elevational view thereof;

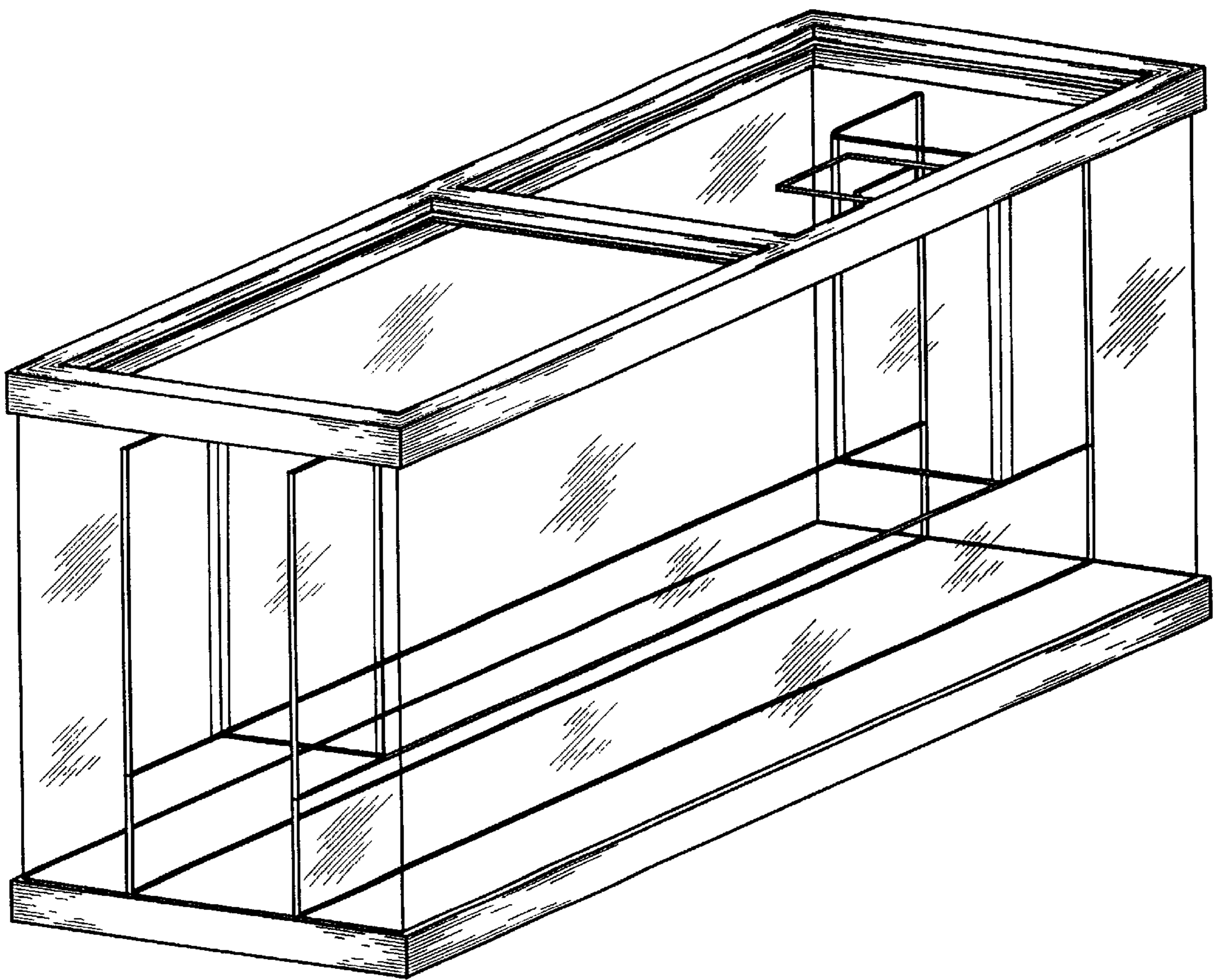

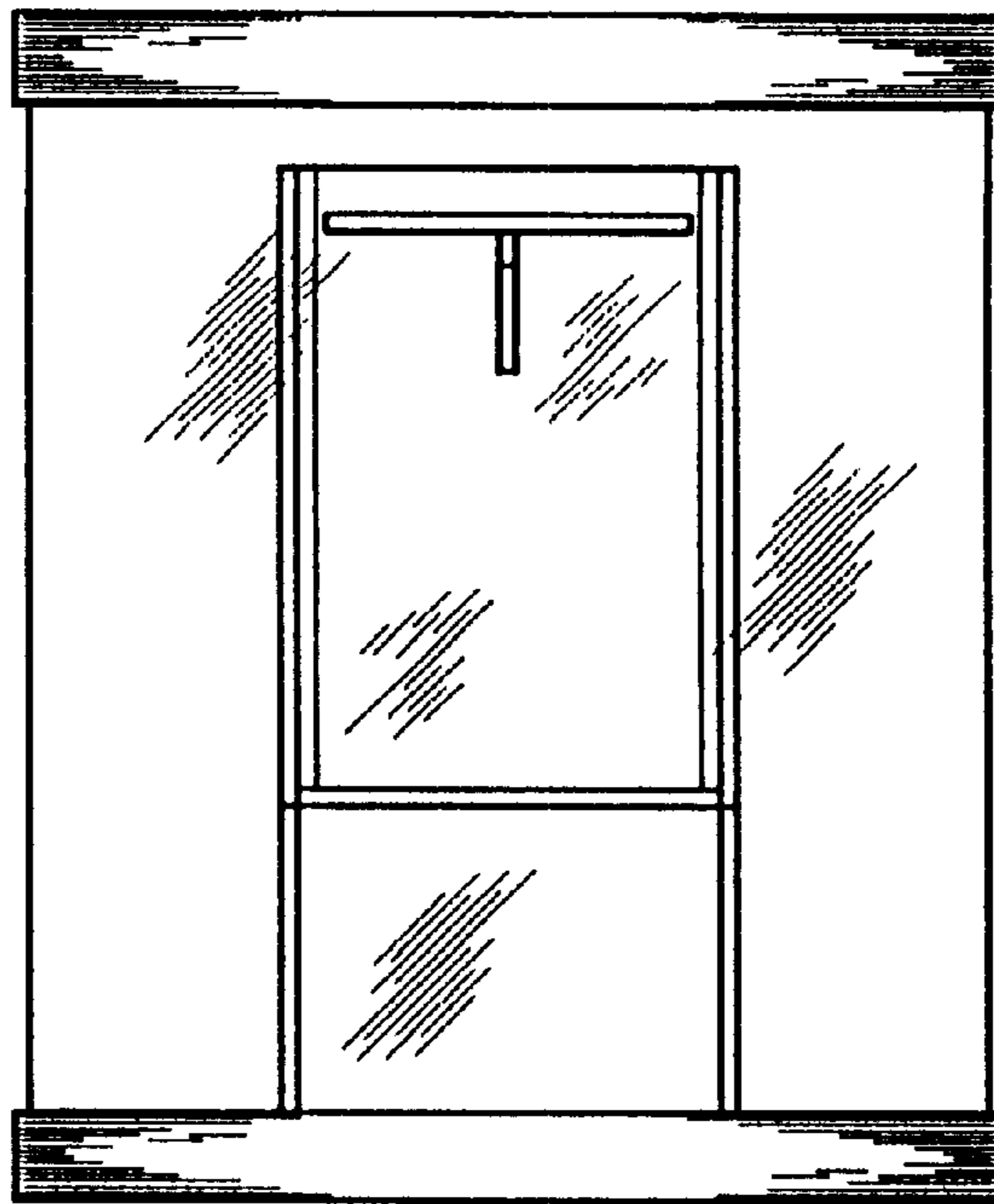

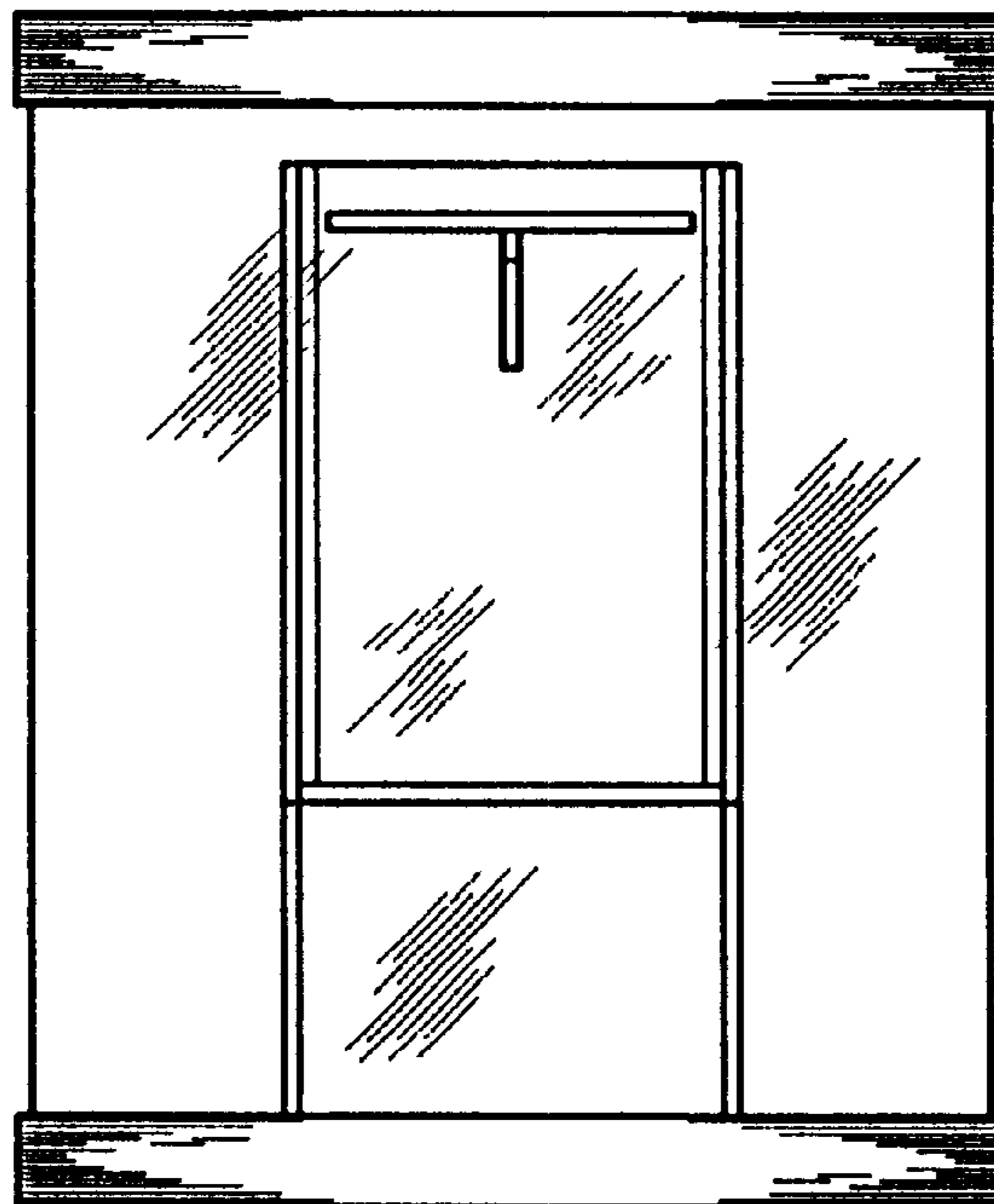

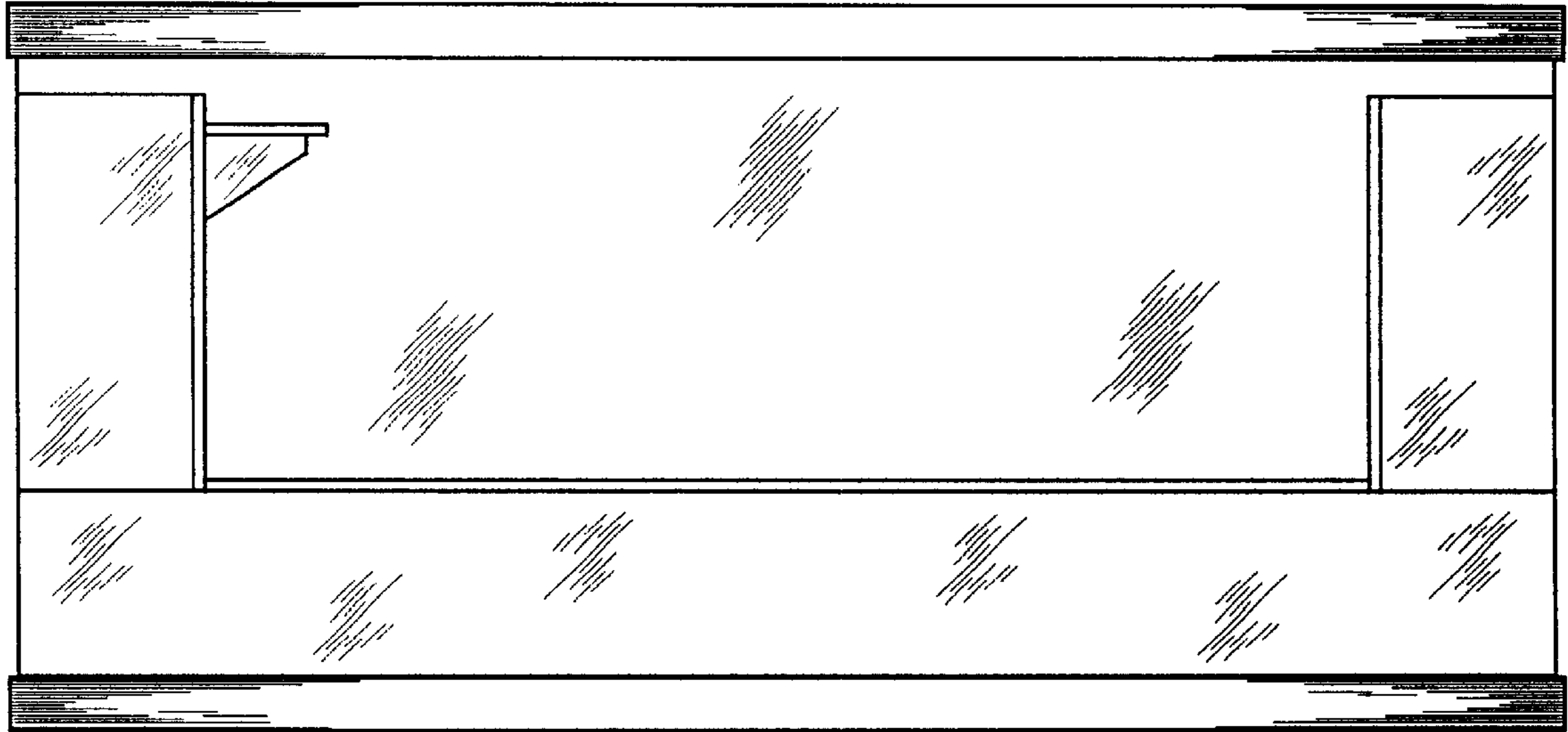

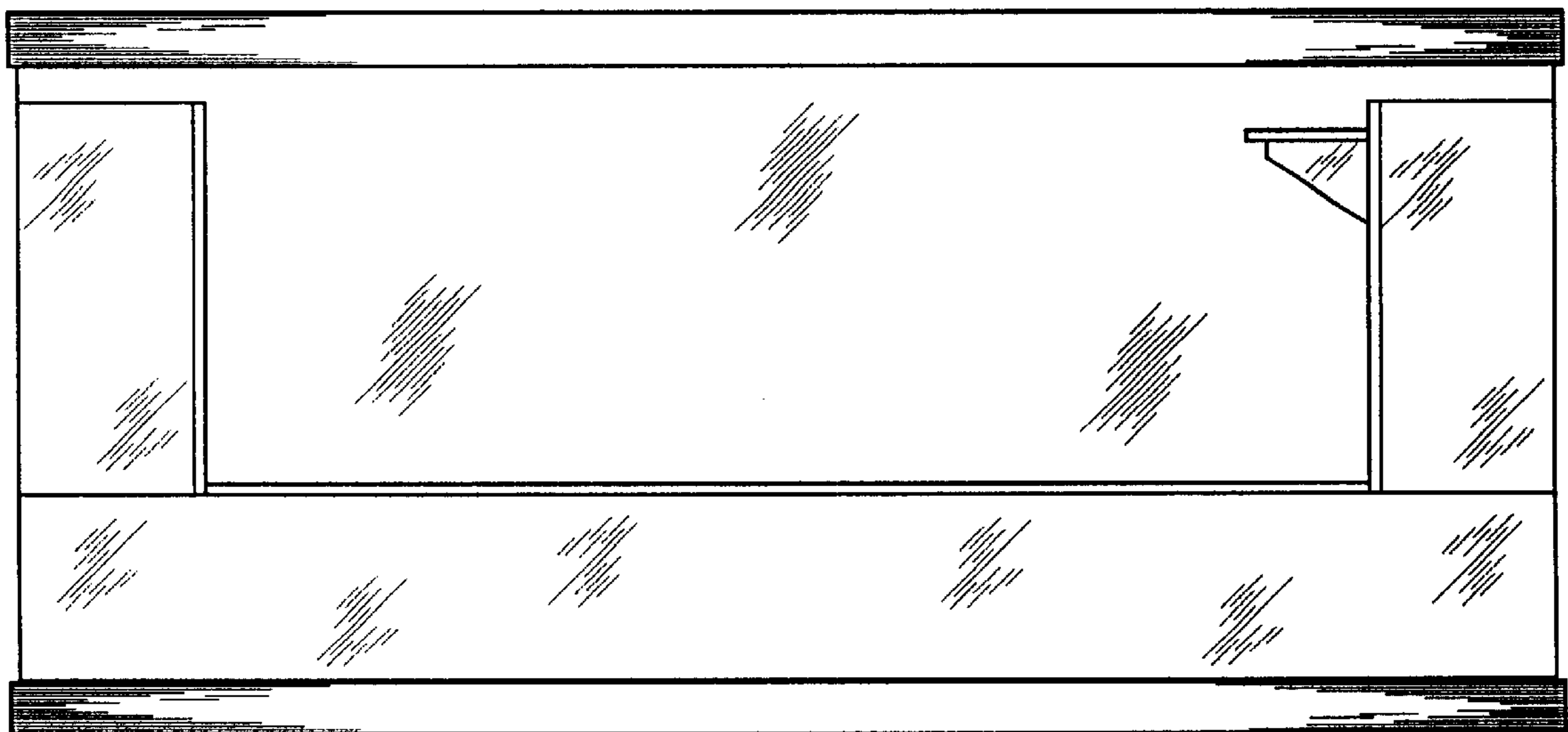

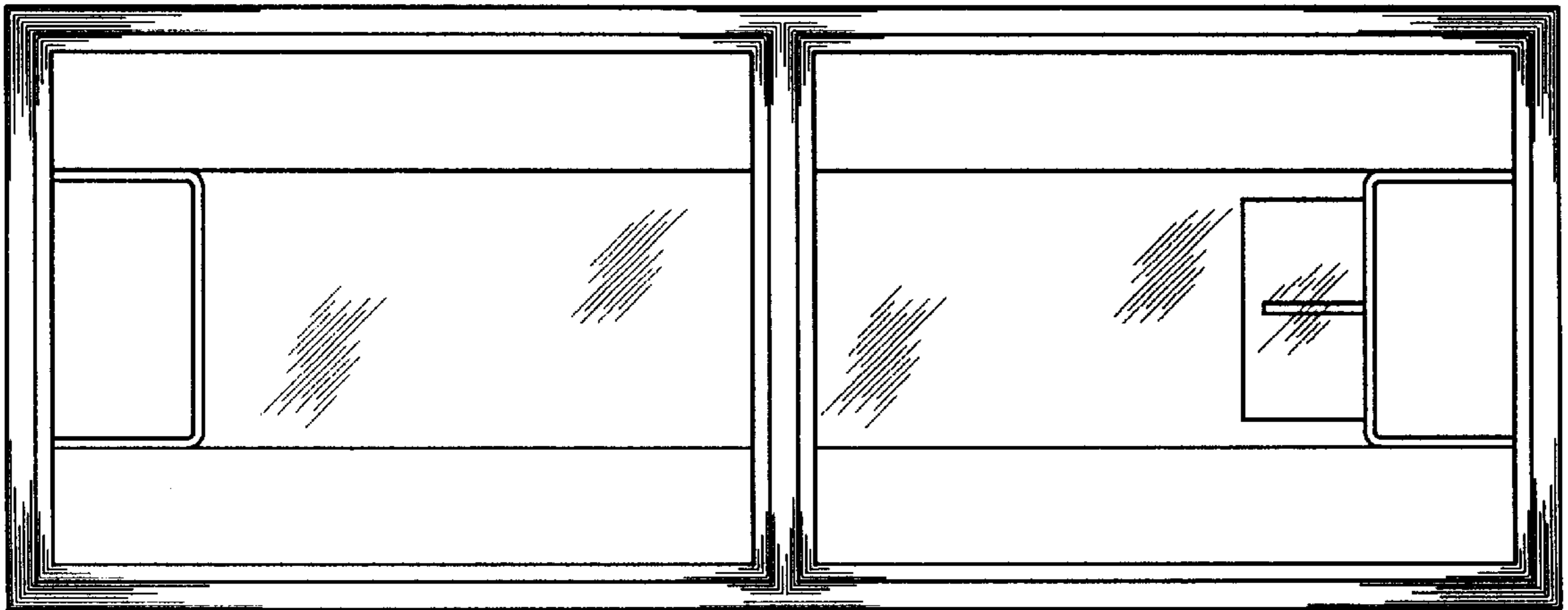

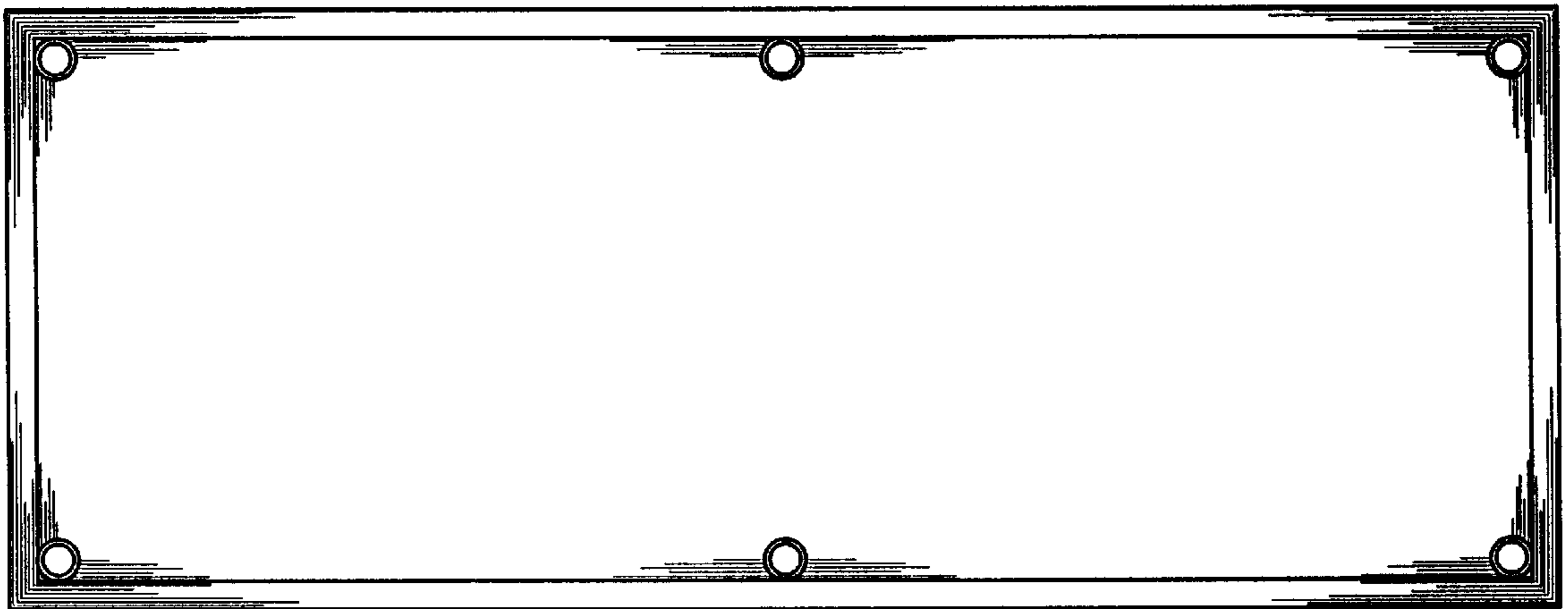
