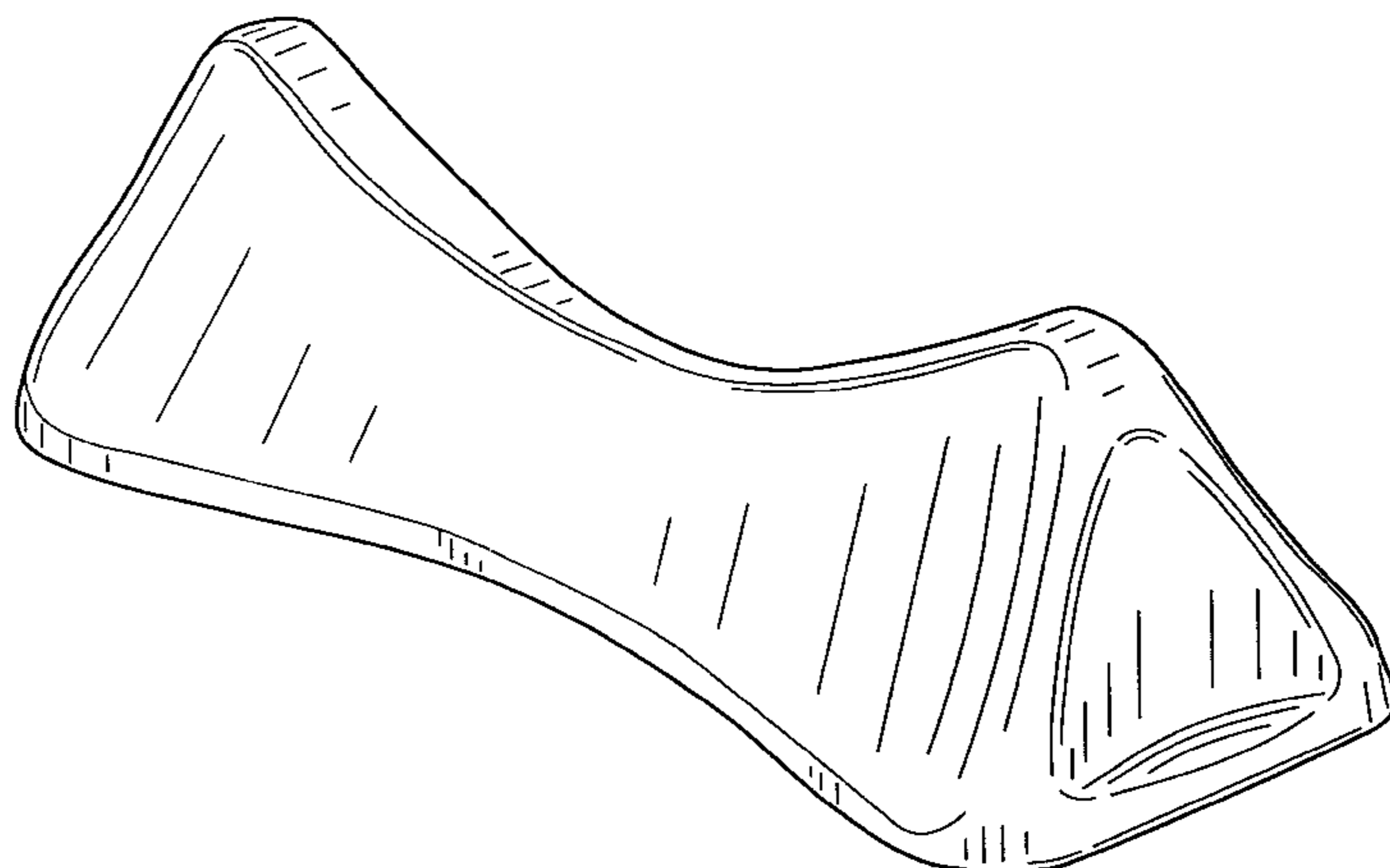
(57) **CLAIM**

The ornamental design for a pet chew, as shown and  
described.

**DESCRIPTION**

FIG. 1 is a perspective view of a pet chew showing my new  
design;  
FIG. 2 is a front elevational view of the pet chew;  
FIG. 3 is a rear elevational view of the pet chew;  
FIG. 4 is a top plan view of the pet chew;  
FIG. 5 is a bottom plan view of the pet chew;

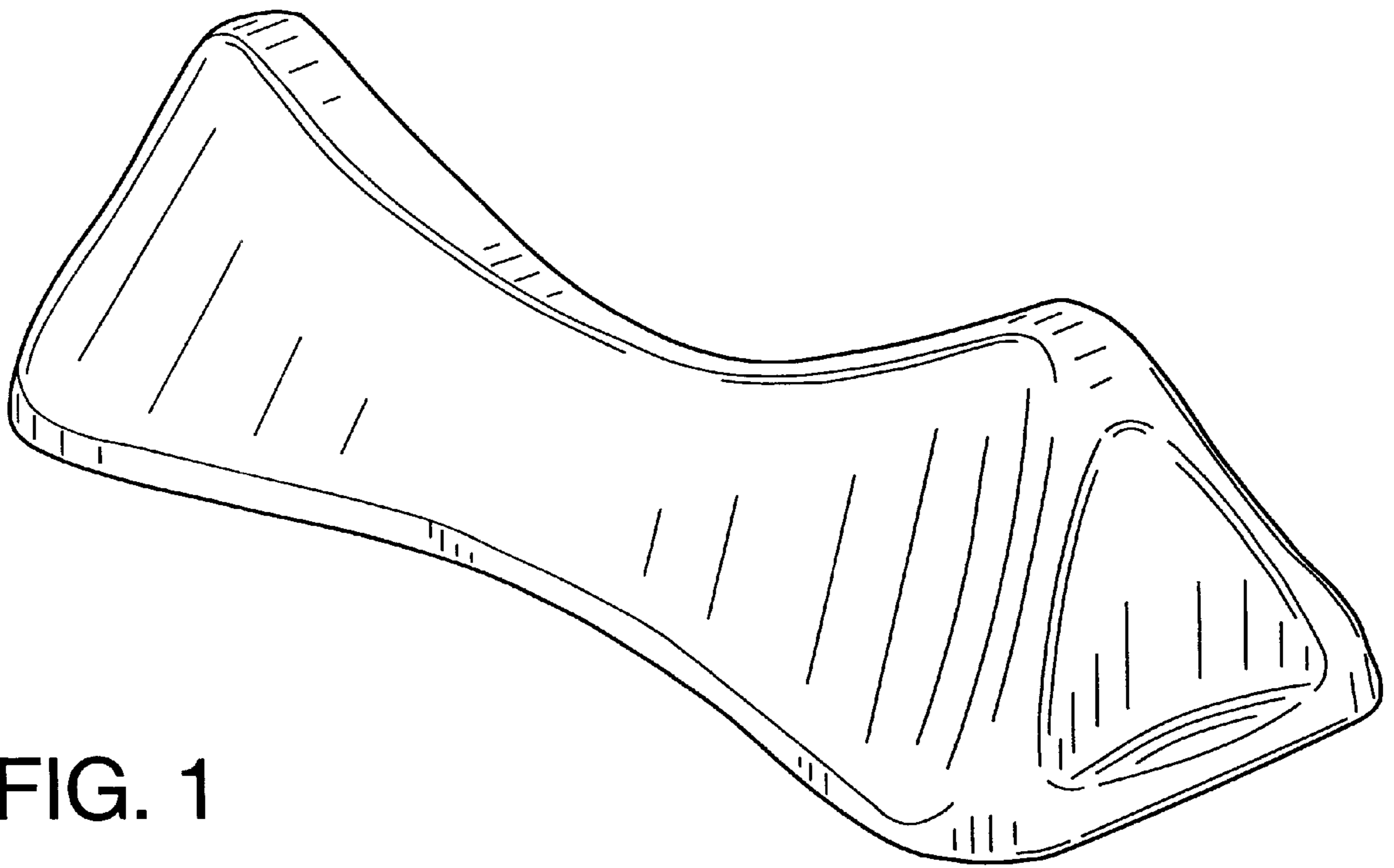

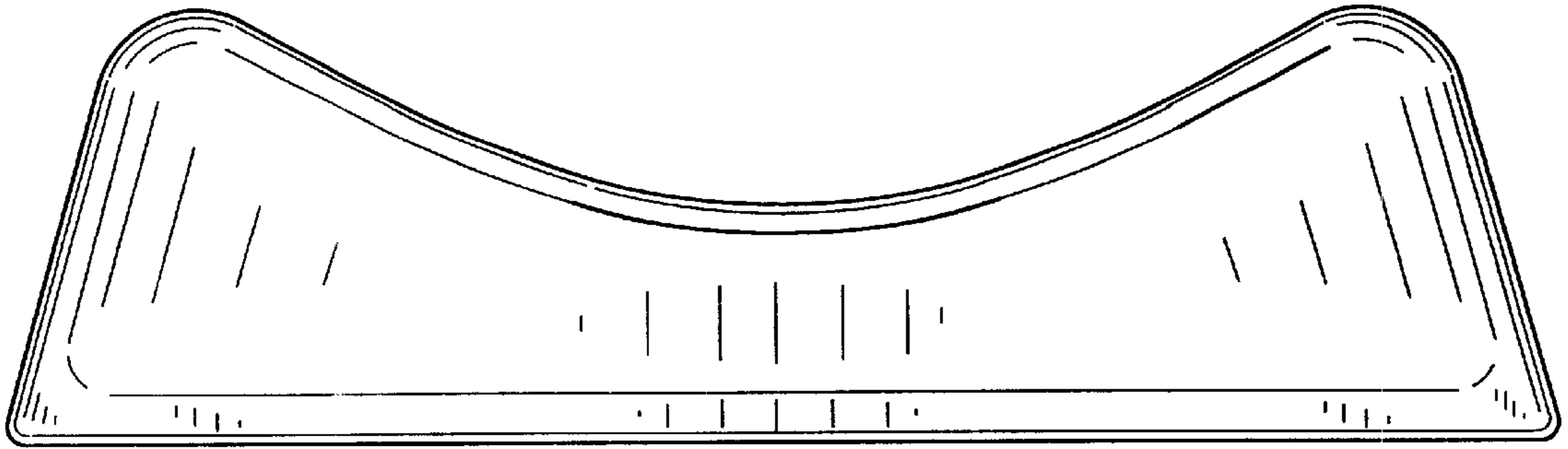

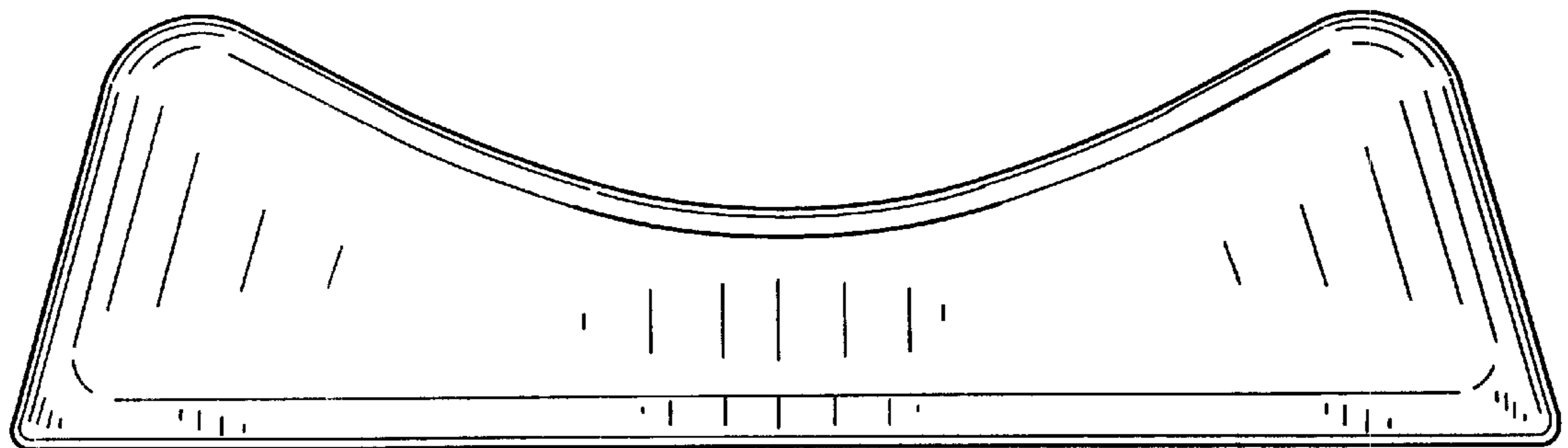

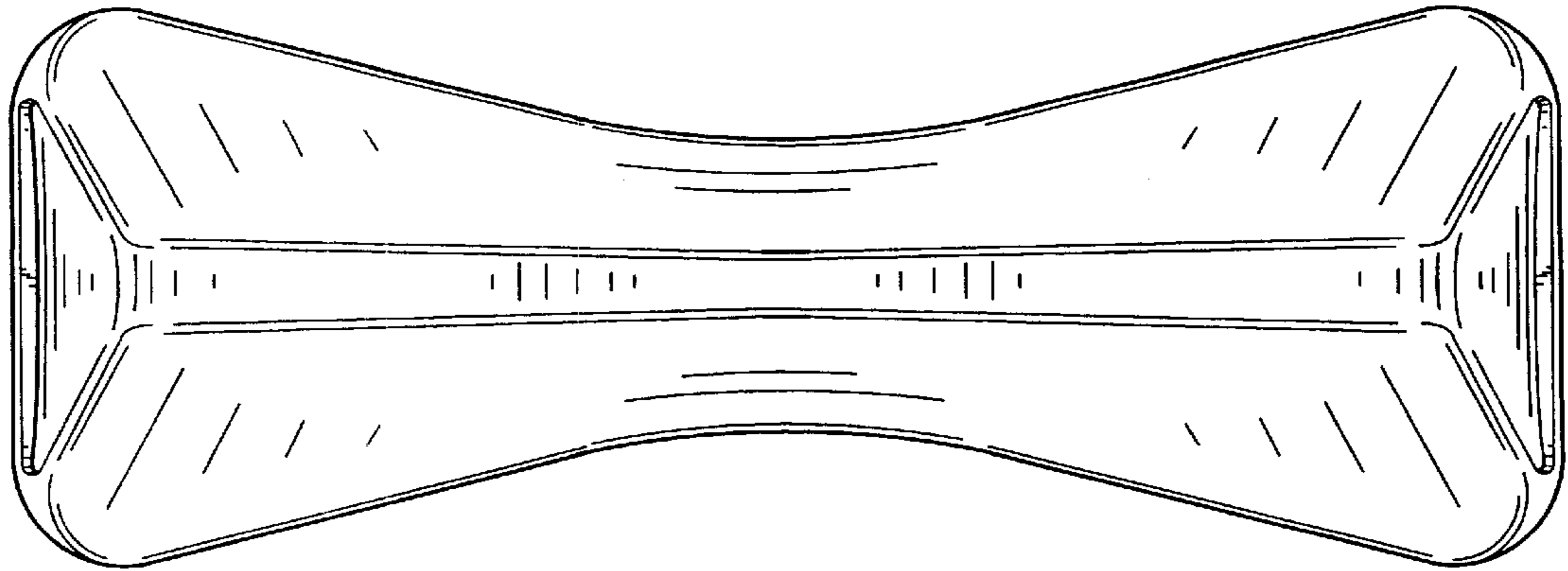

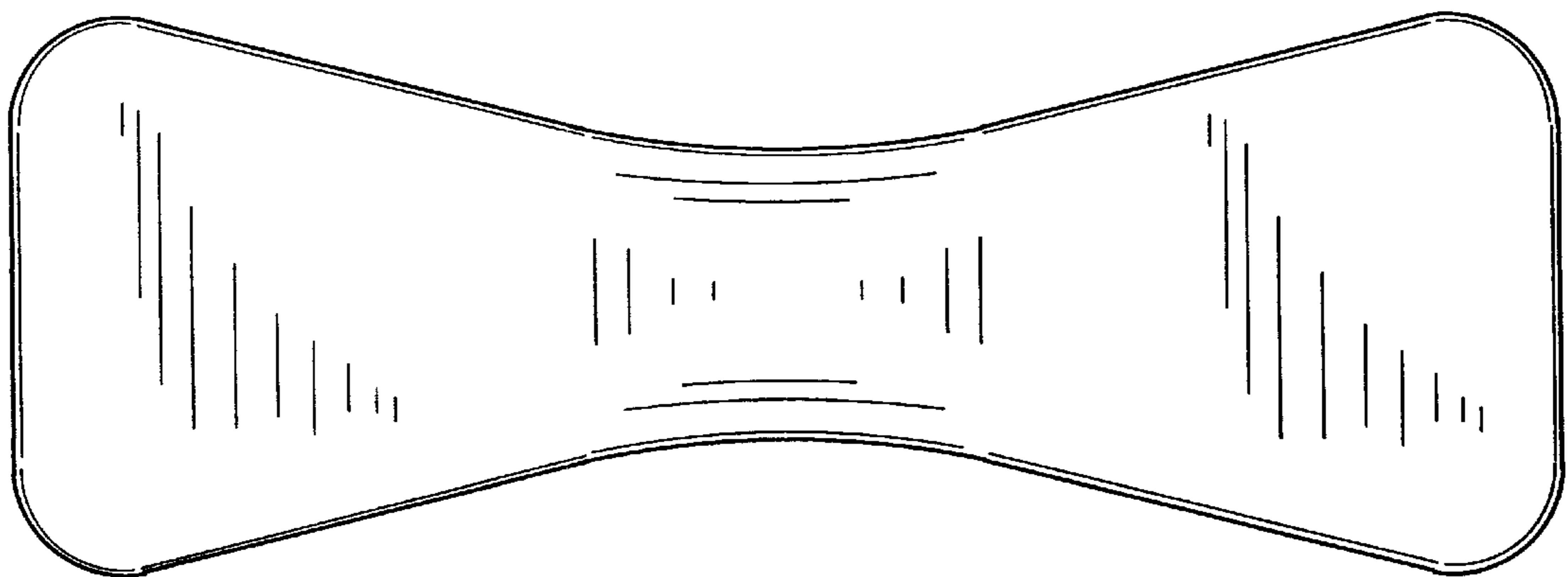

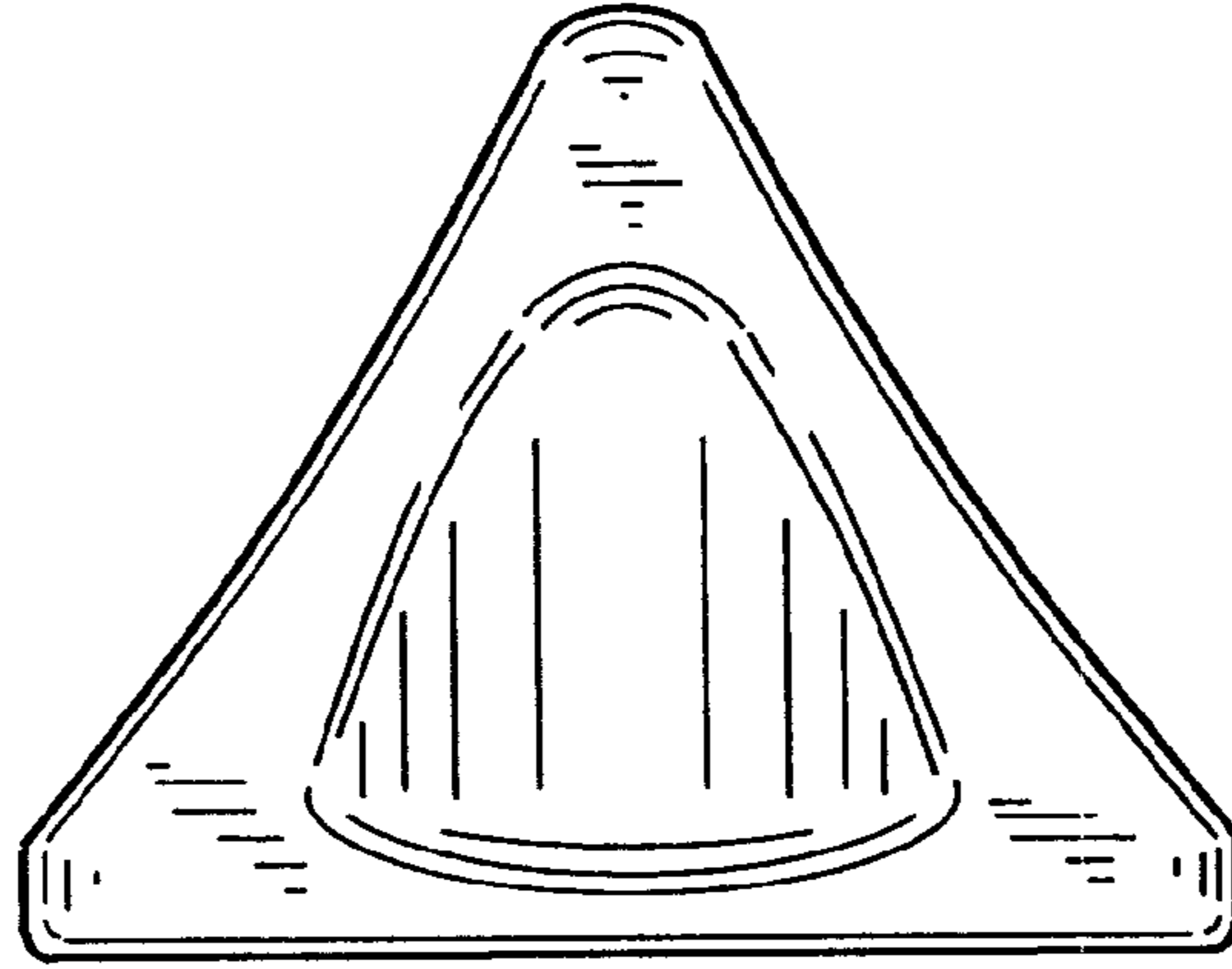

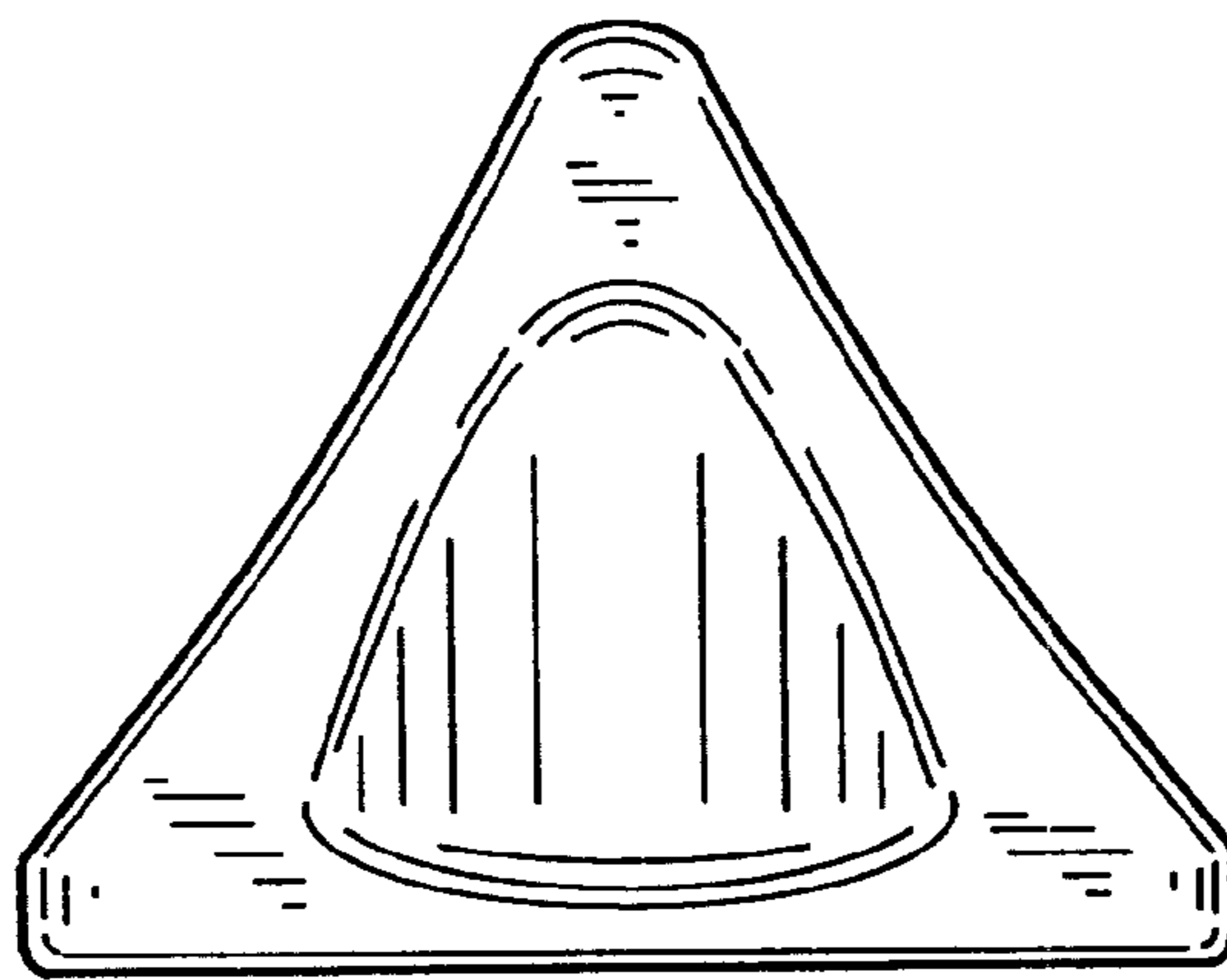
