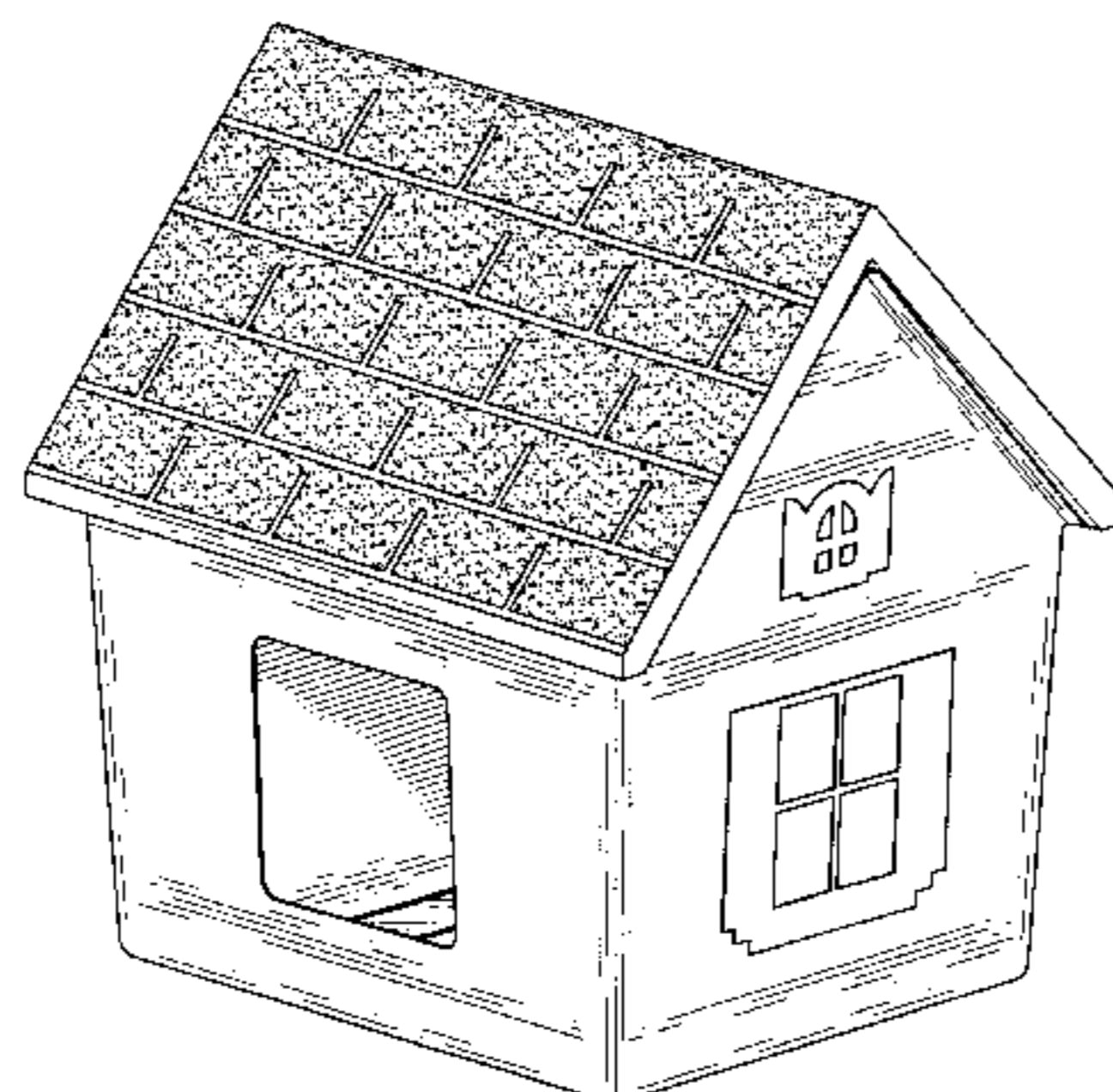
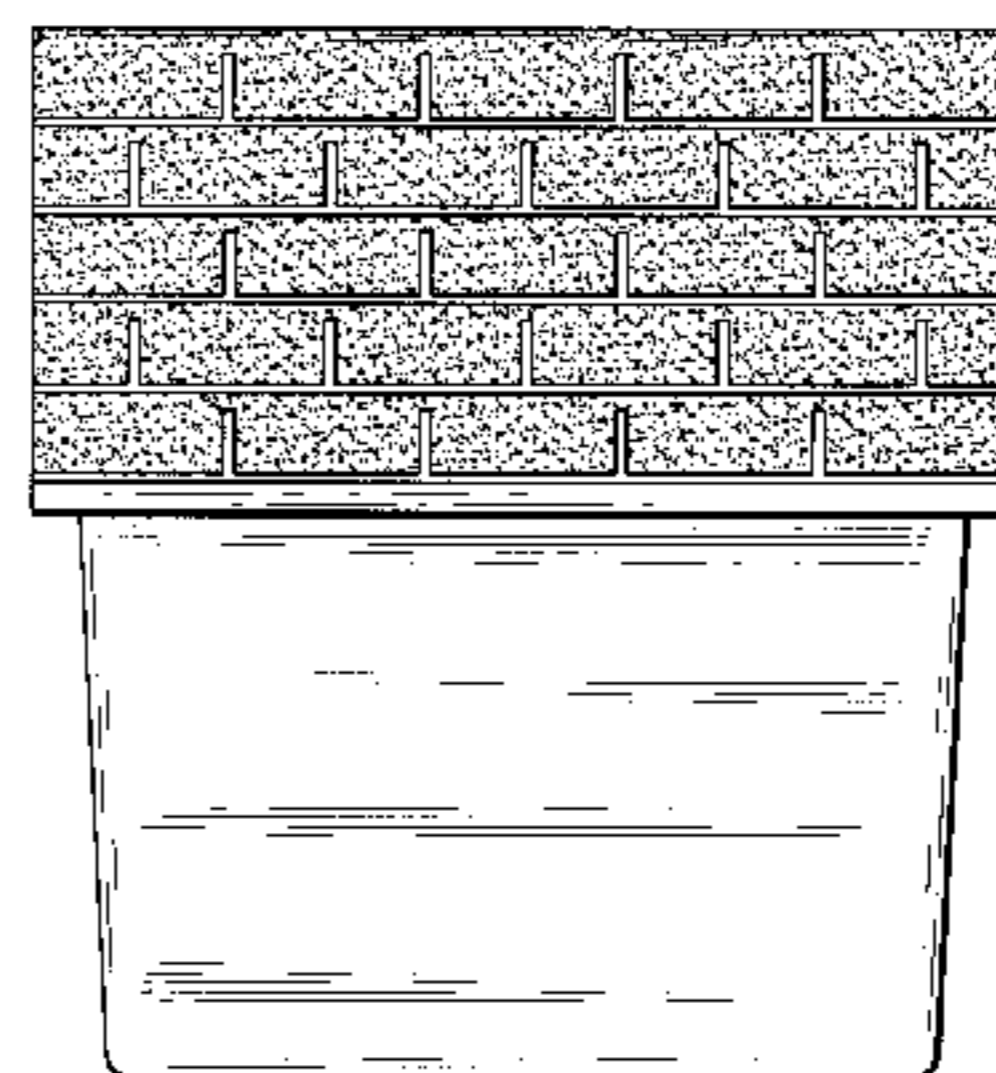
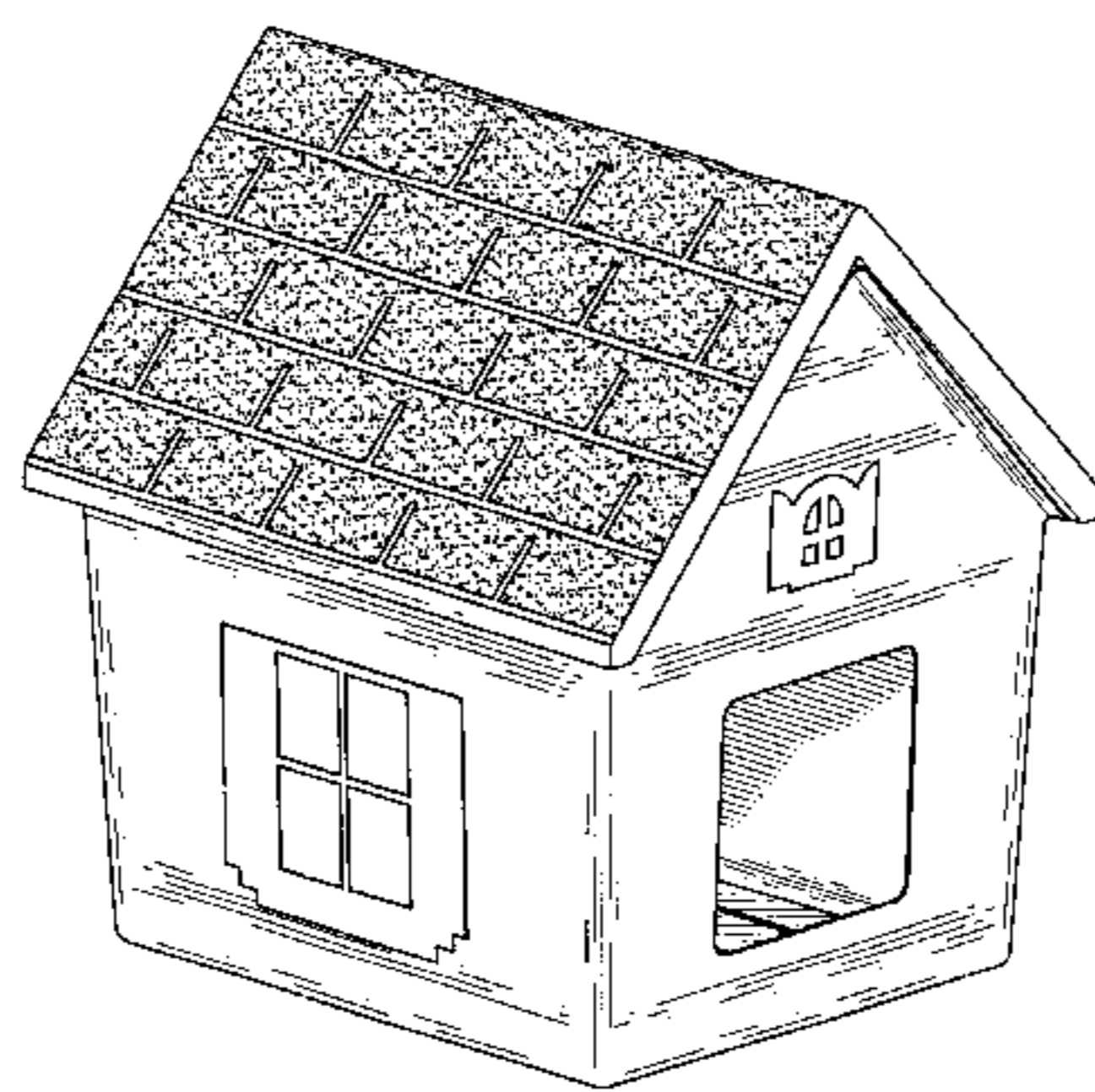
(57) **CLAIM**

The ornamental design for a cottage shaped litter box with  
removable peak roof, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the first embodiment;  
 FIG. 2 is a front view thereof;  
 FIG. 3 is a left side view thereof, the right side is a mirror  
 image;  
 FIG. 4 is a top plan view thereof;  
 FIG. 5 is a rear view thereof;  
 FIG. 6 is a bottom plan view thereof;  
 FIG. 7 is a front elevational view of the roof, the rear  
 elevational view being a mirror image;  
 FIG. 8 is a bottom perspective inside view of the roof;  
 FIG. 9 is a bottom plan view of the roof;  
 FIG. 10 is a top perspective view thereof without the roof;  
 FIG. 11 is the top plan view of FIG. 10;  
 FIG. 12 is a front and left perspective view of a second  
 embodiment;  
 FIG. 13 is a right side view of the second embodiment;  
 FIG. 14 is a top plan view of FIG. 12; and,  
 FIG. 15 is a side view of a third embodiment.

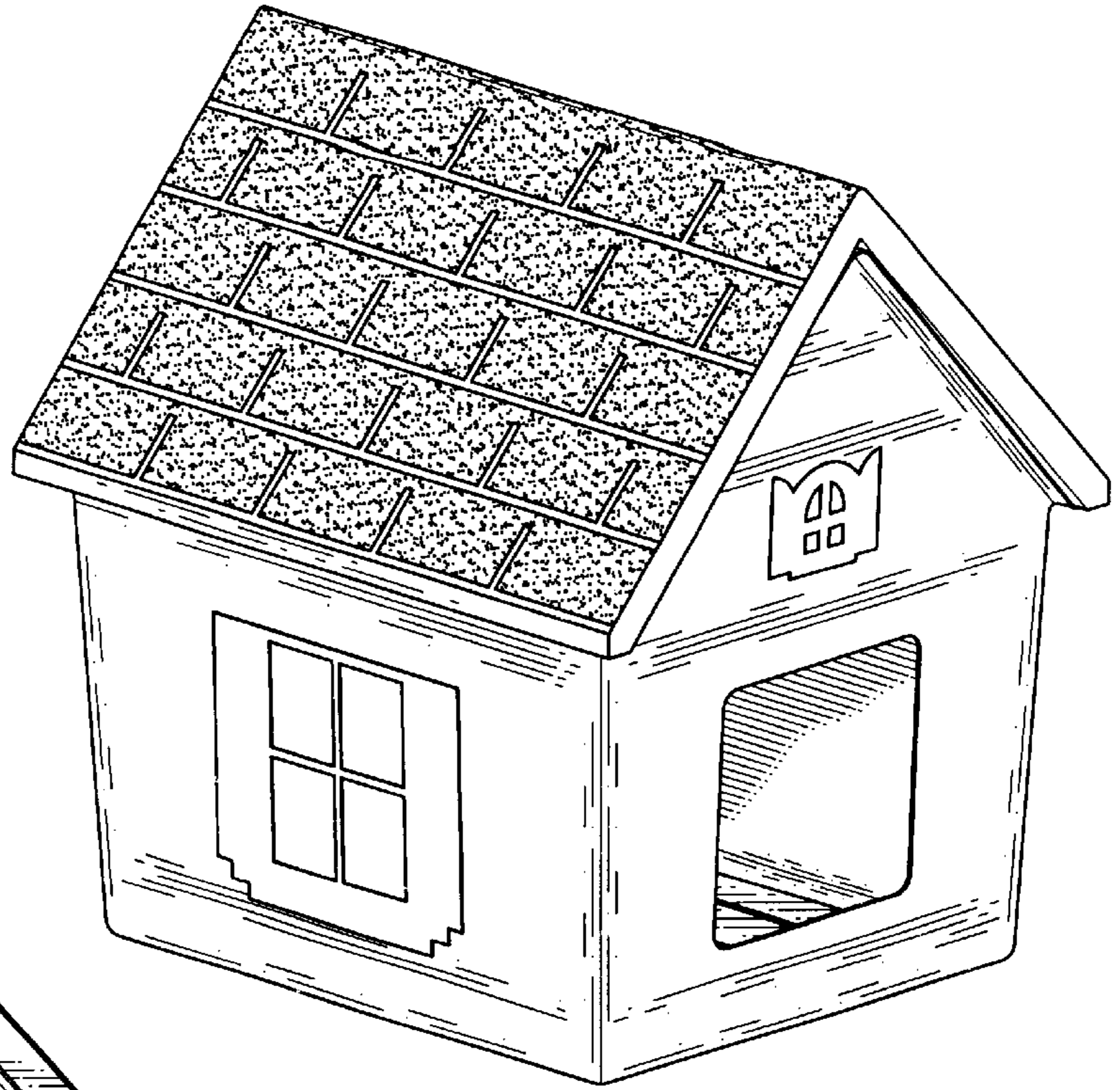

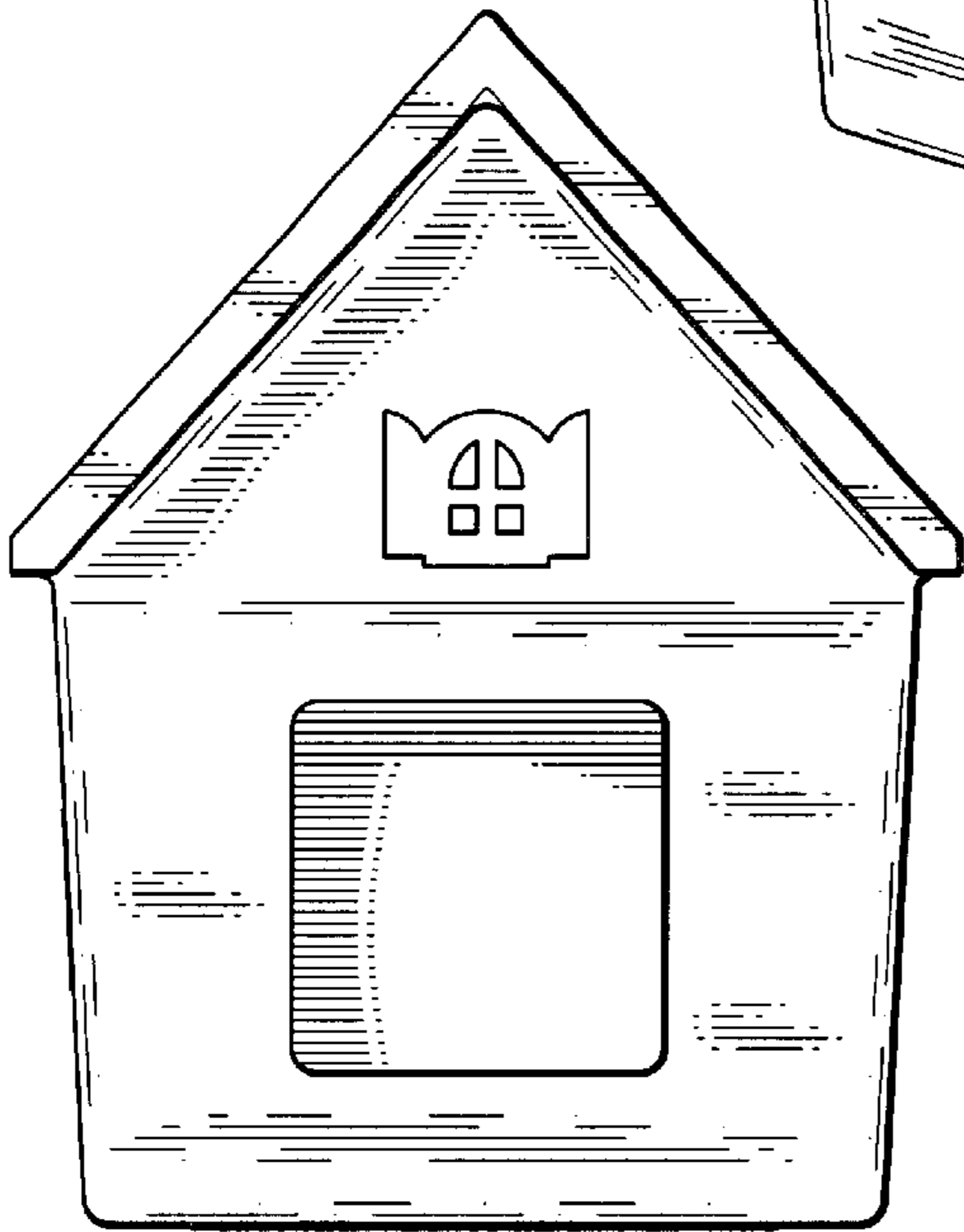

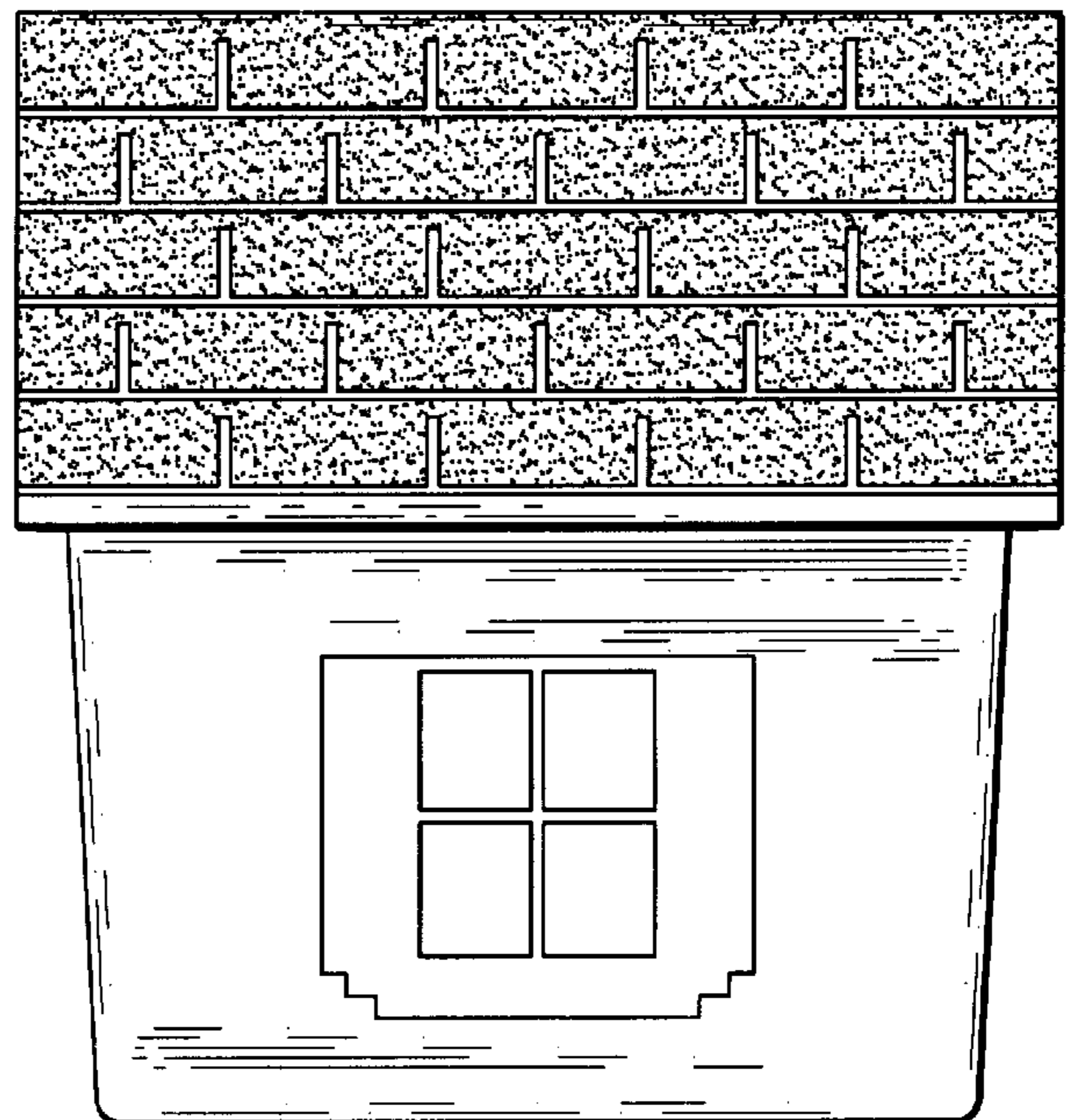
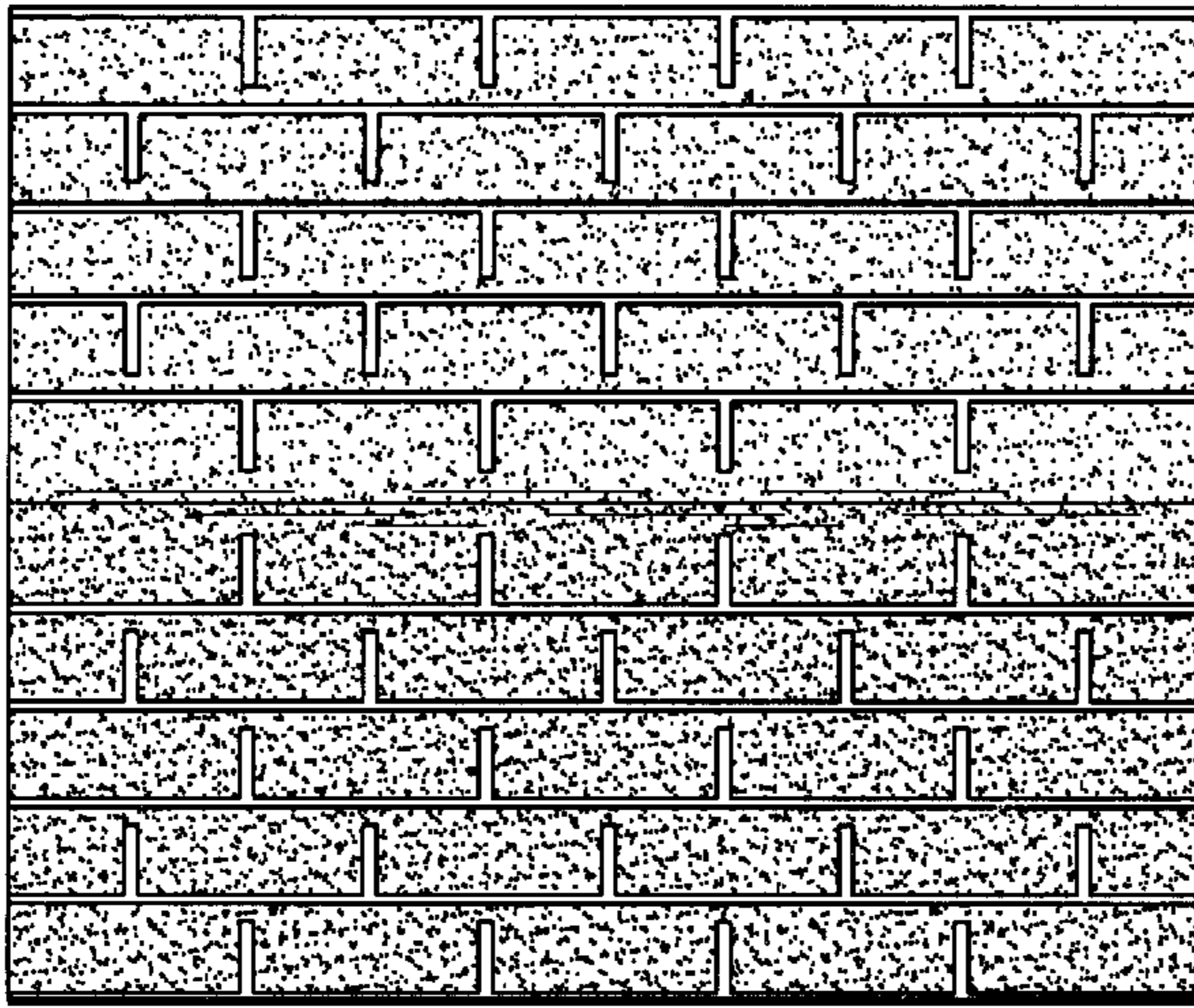
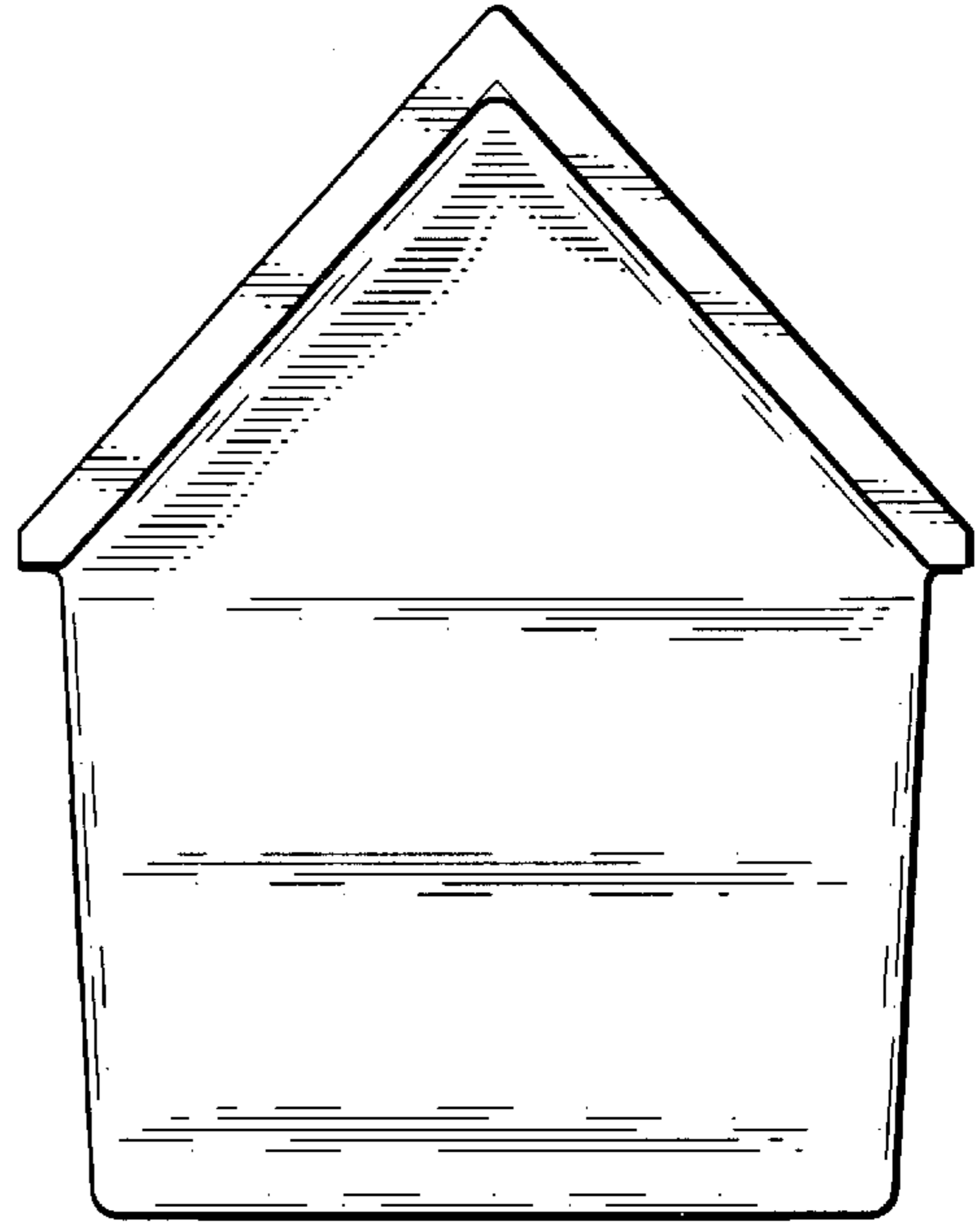

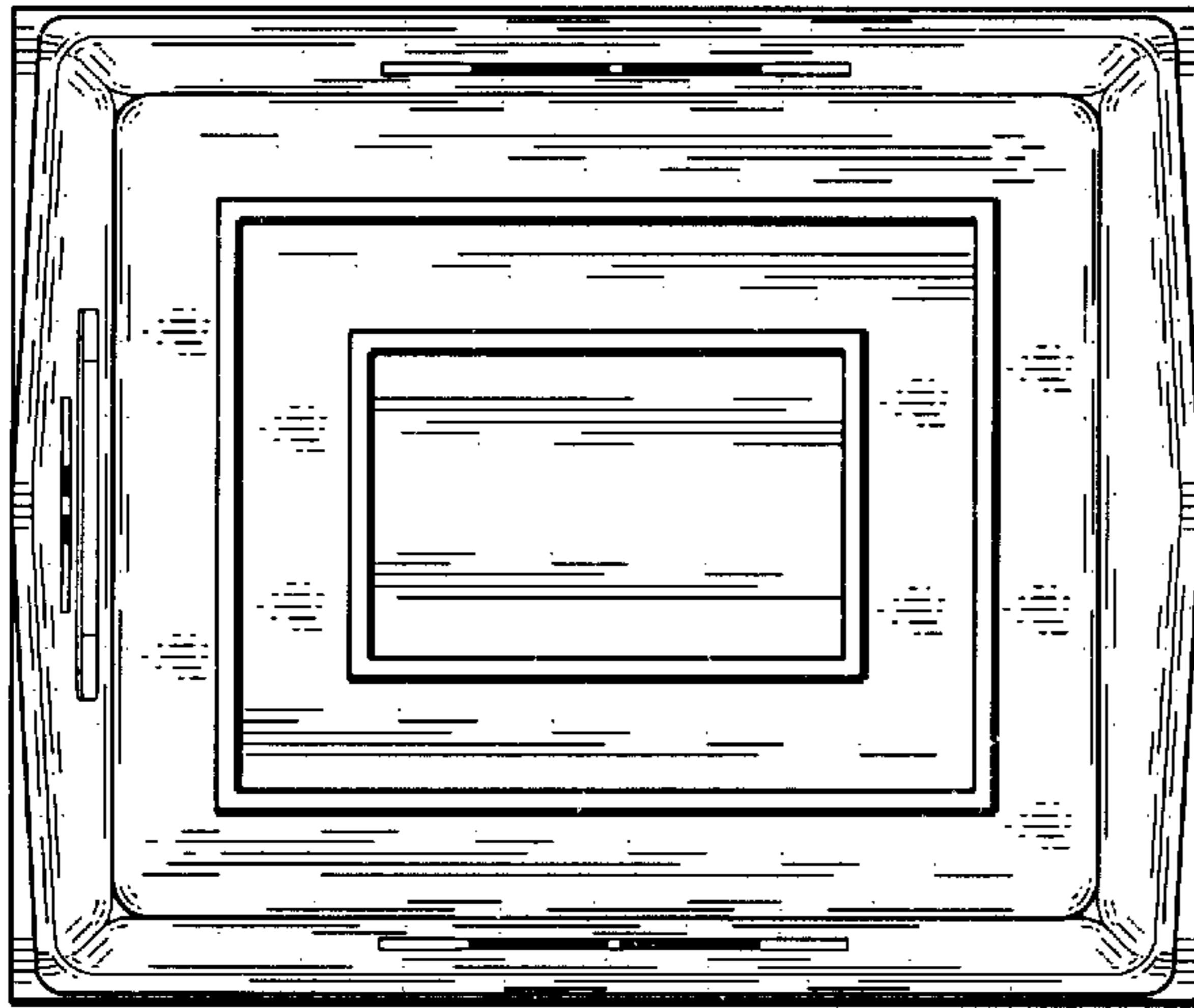




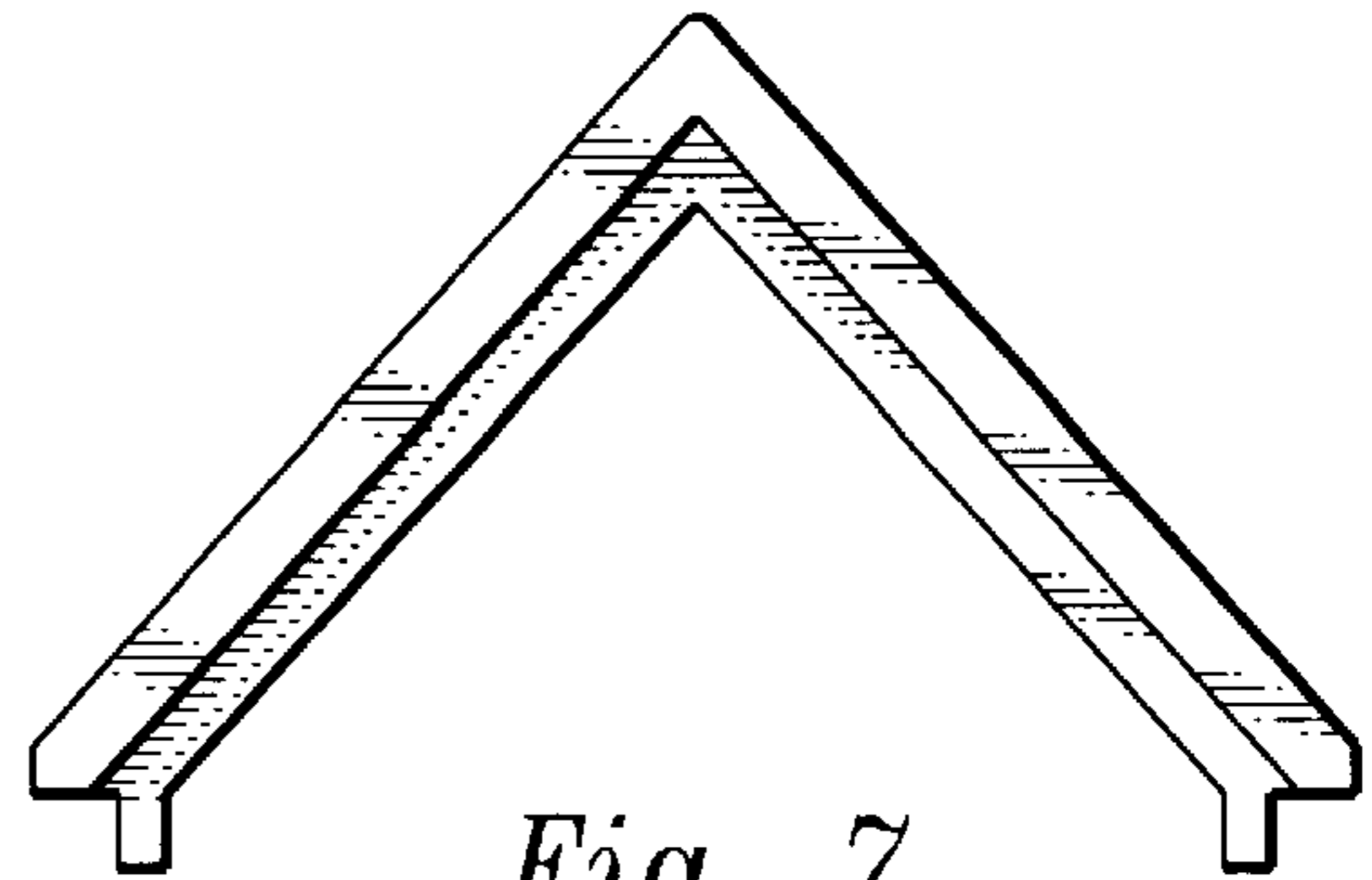

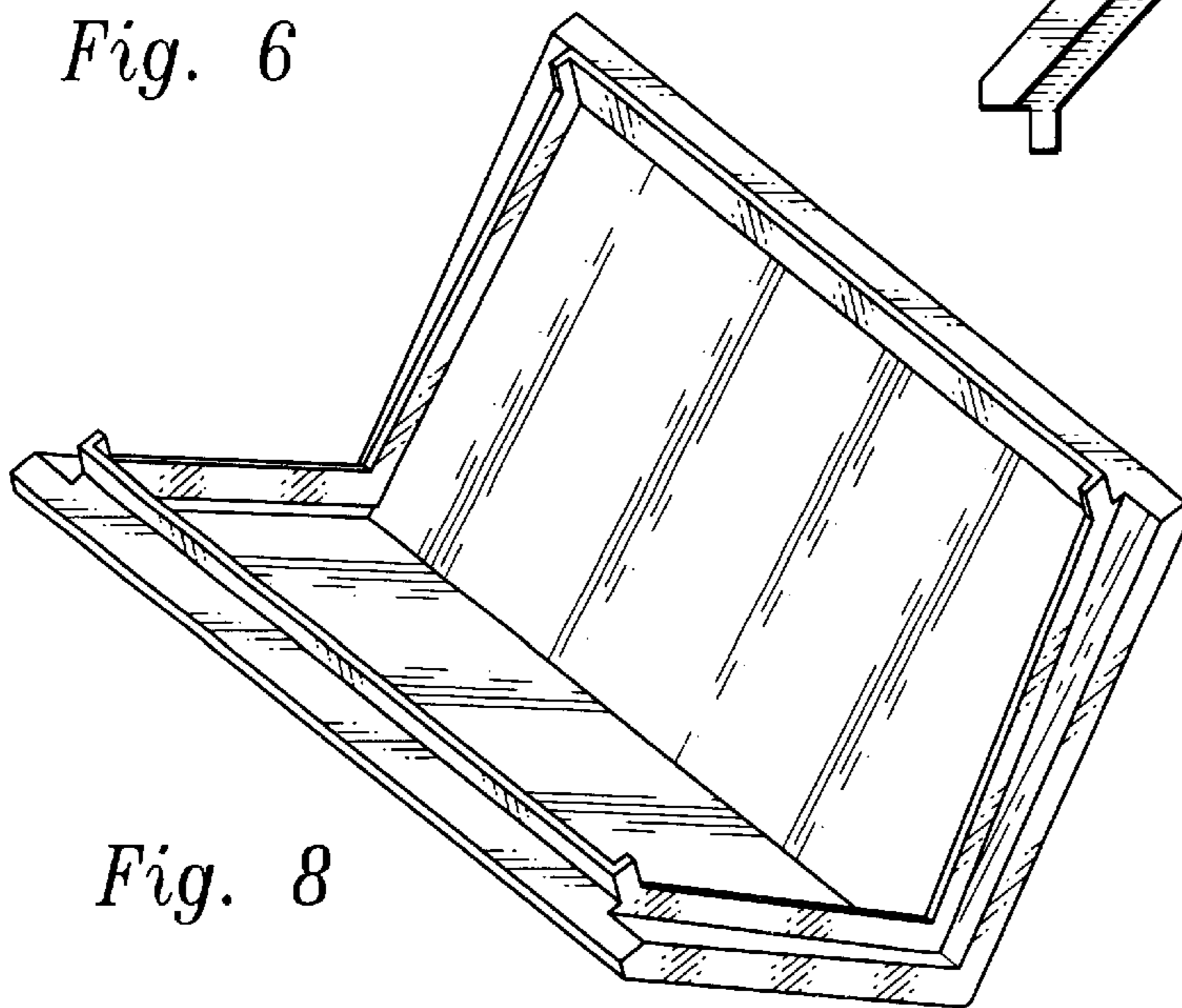

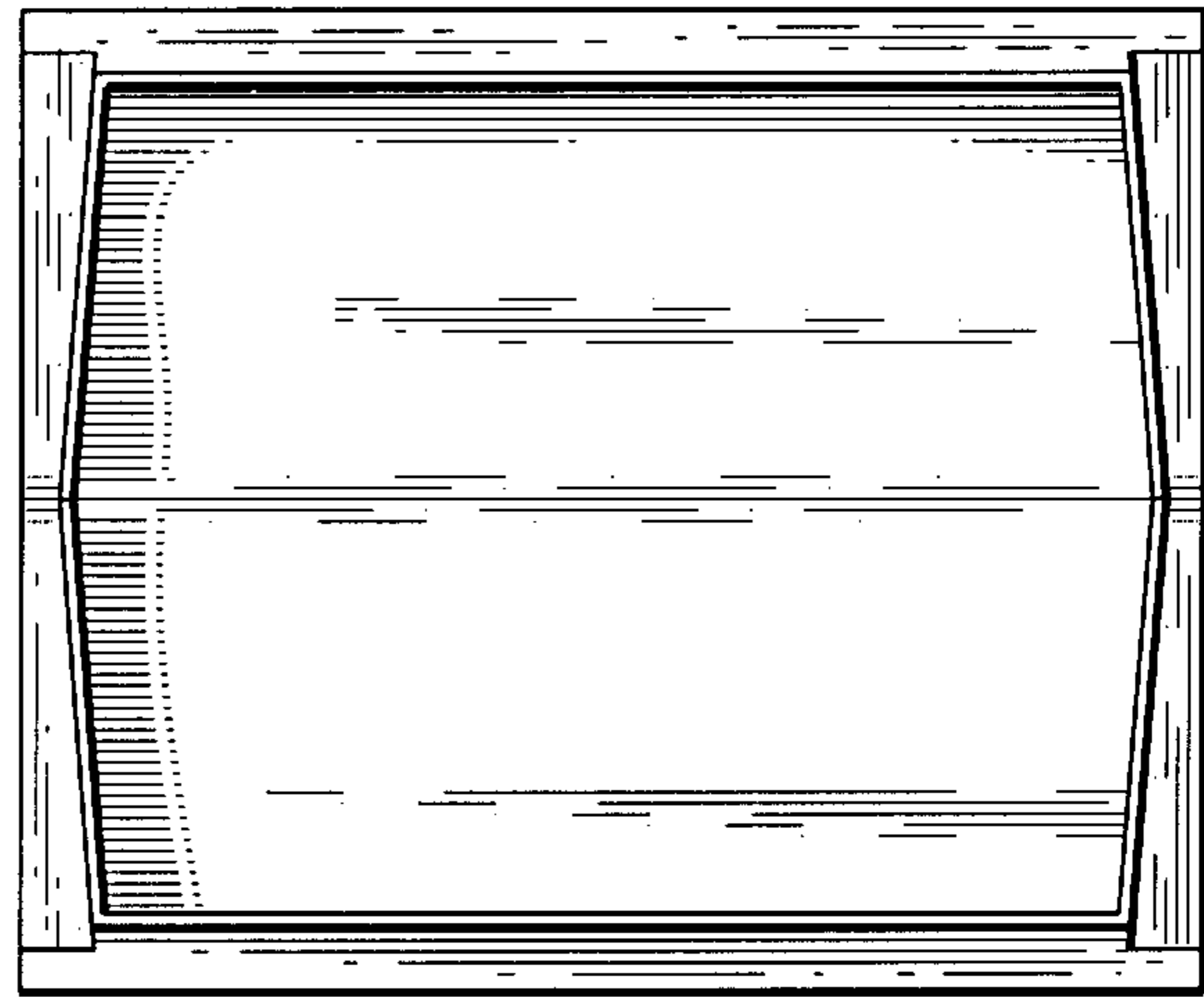

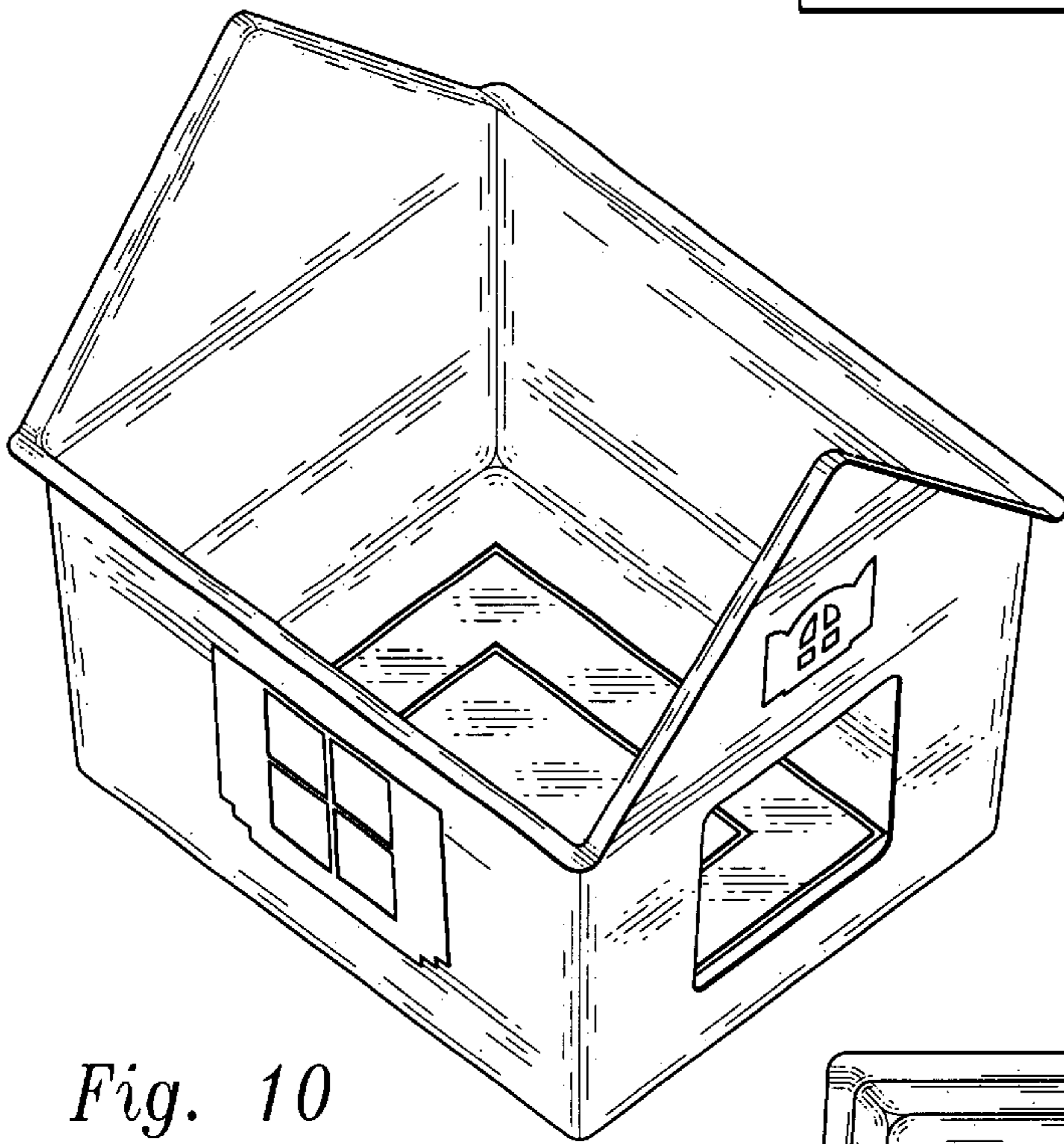

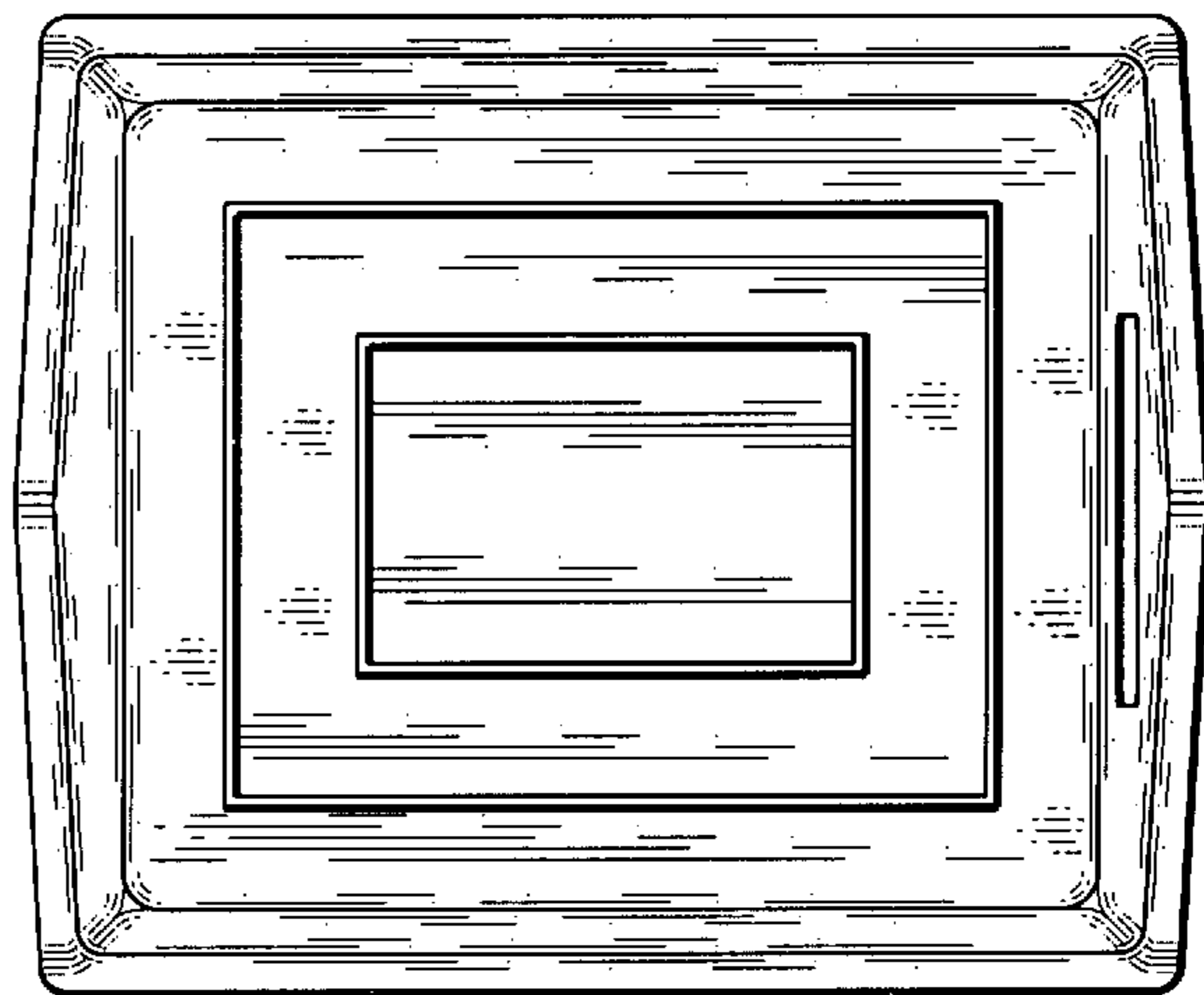

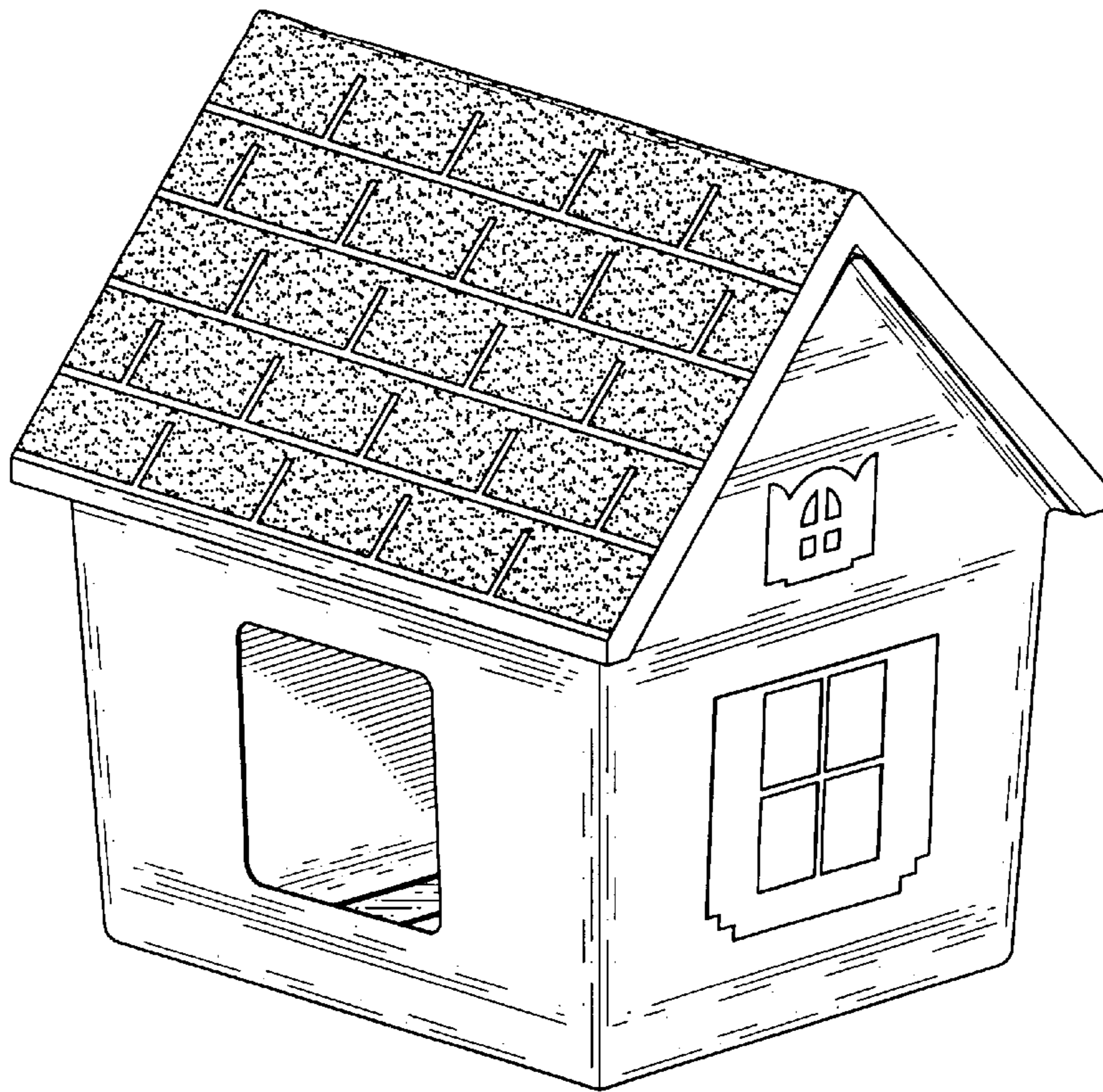

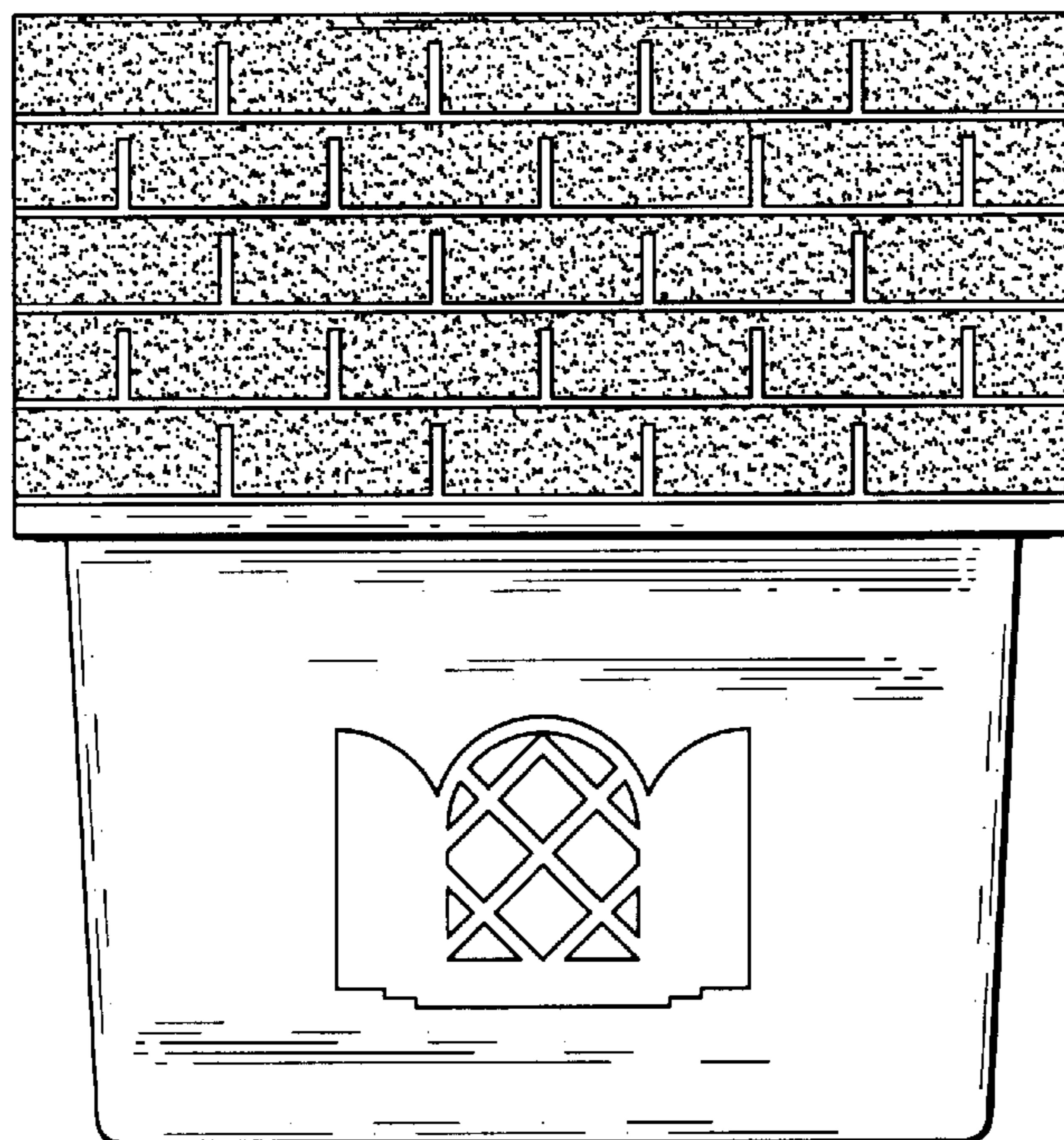

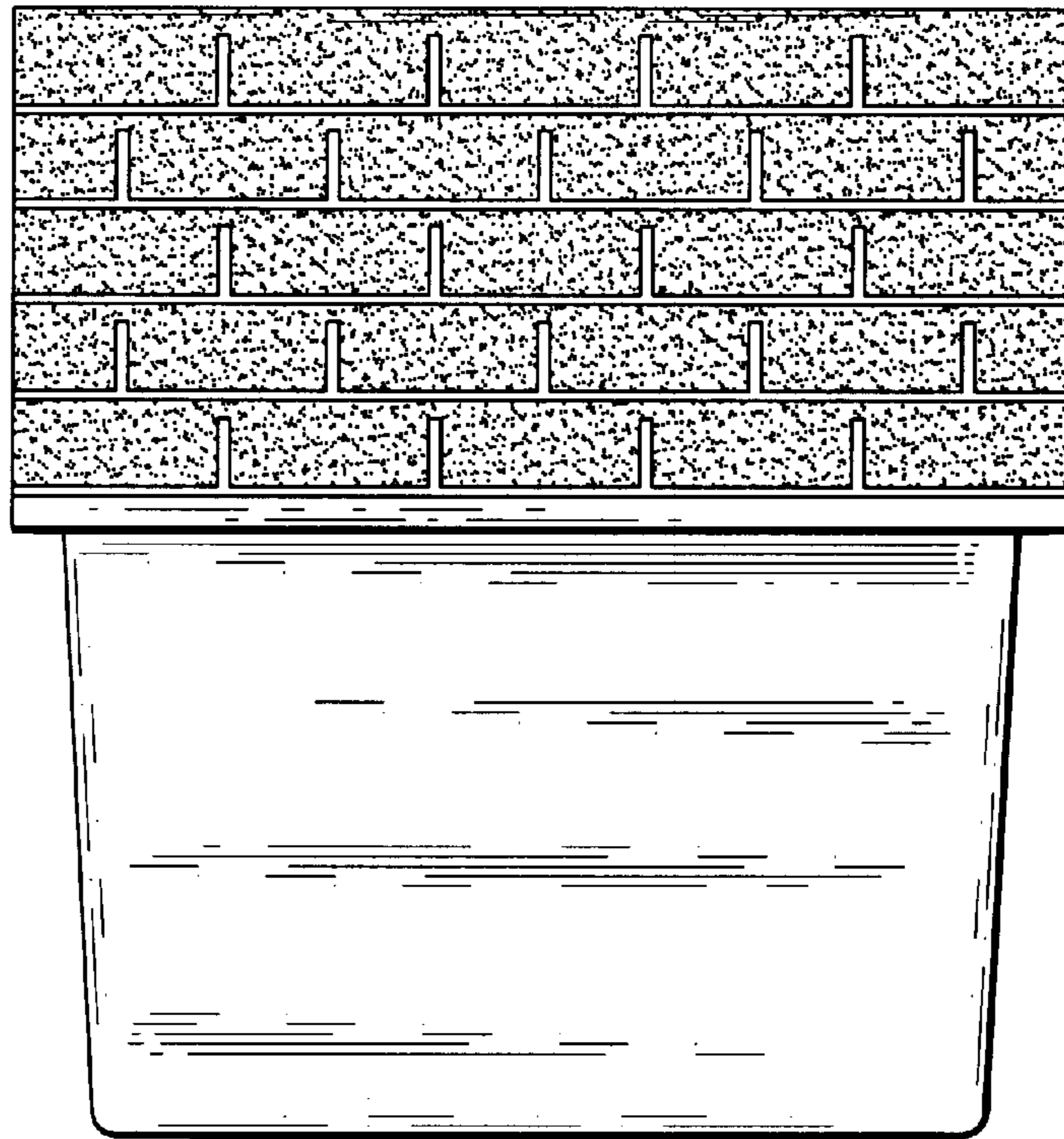




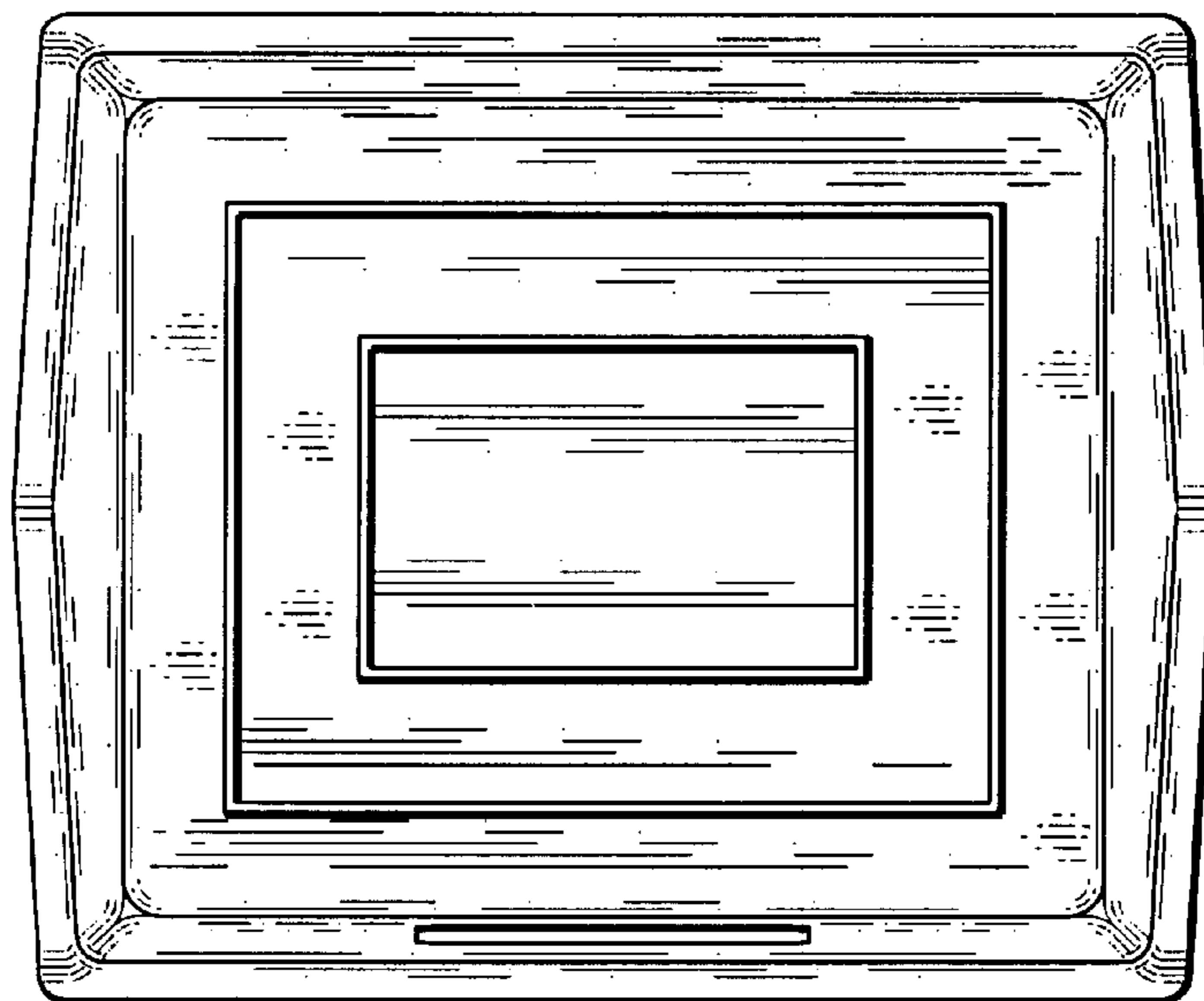
