The ornamental design of breast feeding clothes, as shown and described.

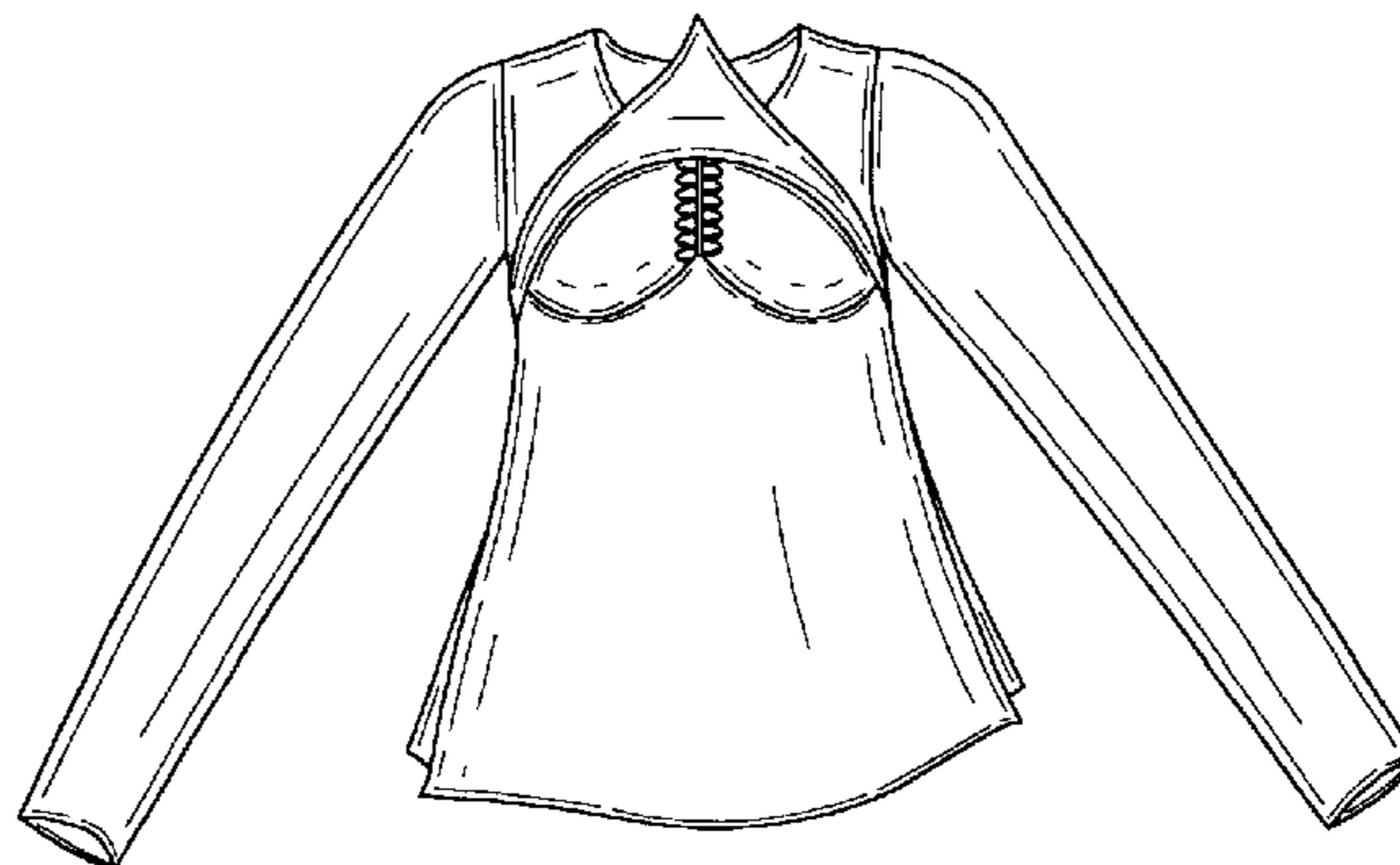
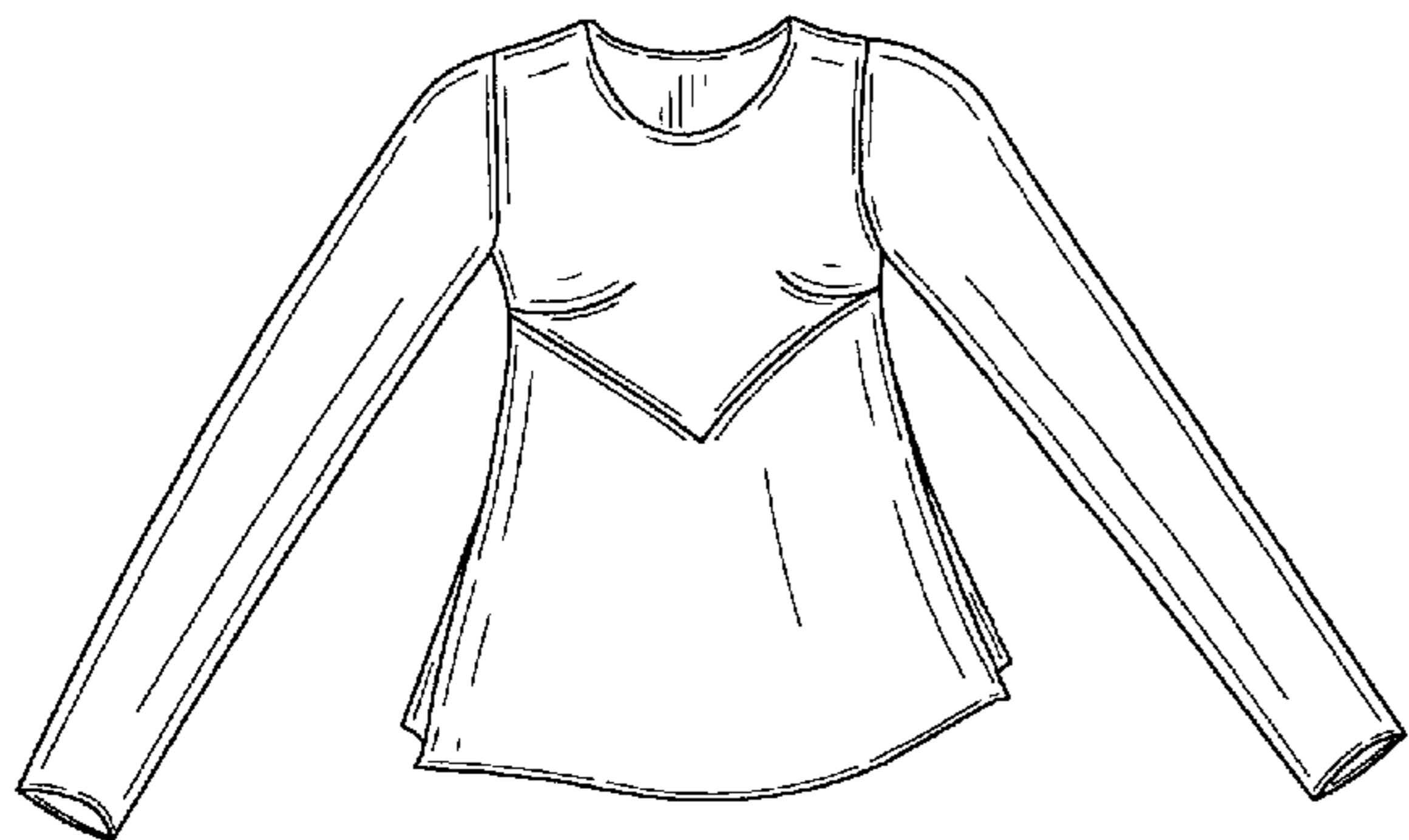
**DESCRIPTION**

FIG. 1 is a front elevational view of breast feeding clothes in accordance with the subject invention;

FIG. 2 is a front elevational view of the breast feeding clothes of FIG. 1, with the front panel in a partly open condition; and,

FIG. 3 is a front elevational view of the breast feeding clothes of FIGS. 1 and 2 but showing the front panel in a fully open condition.

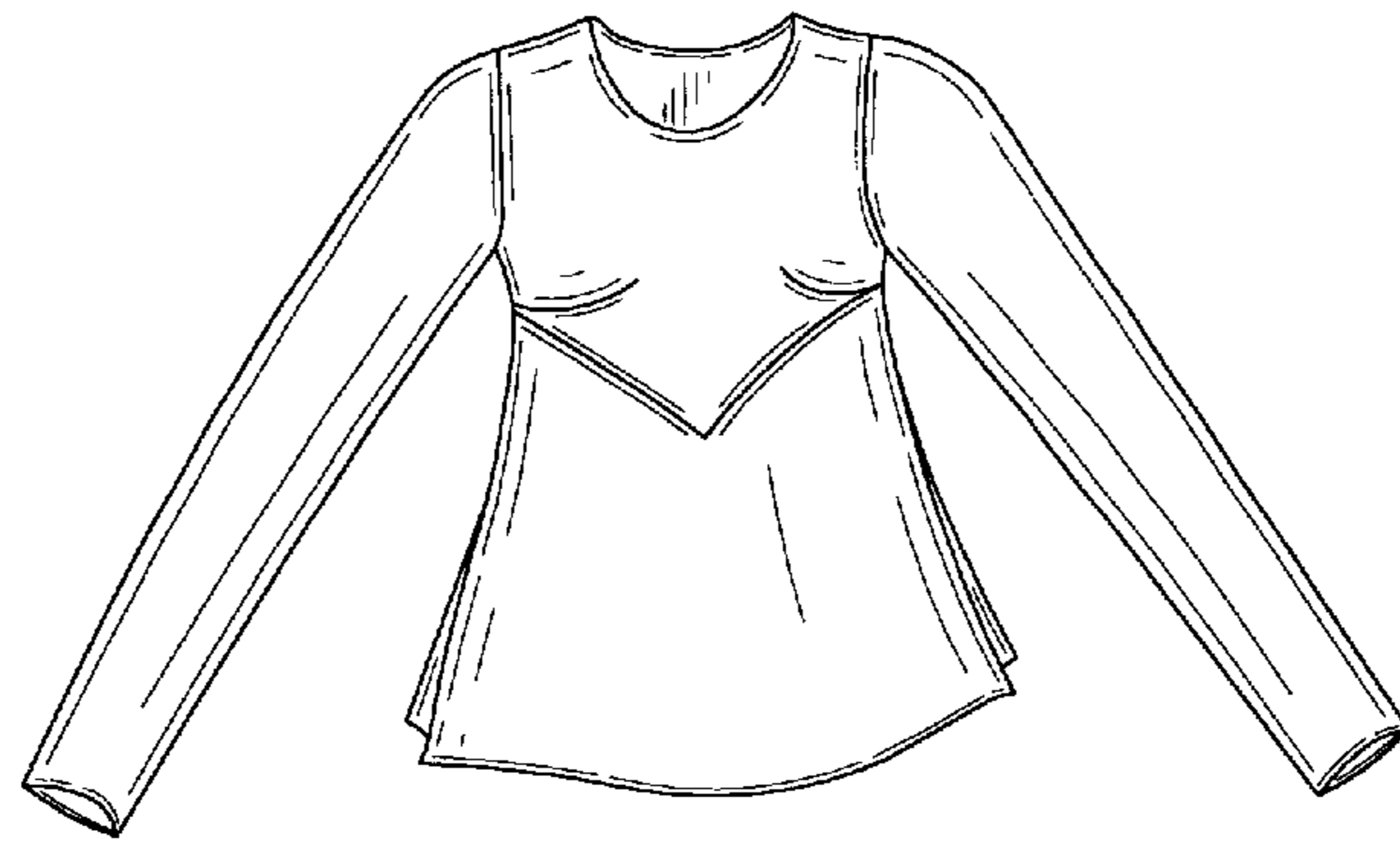

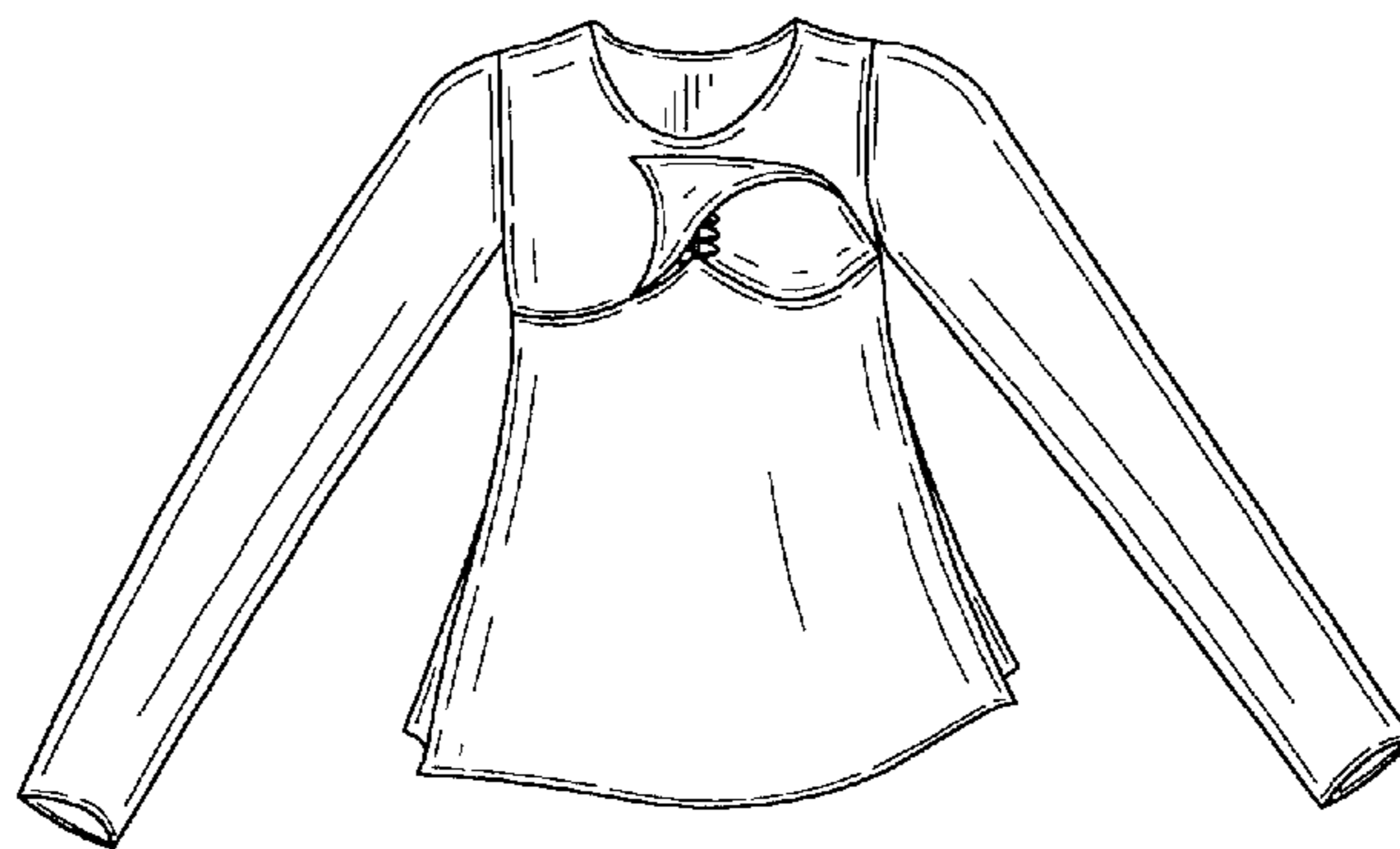

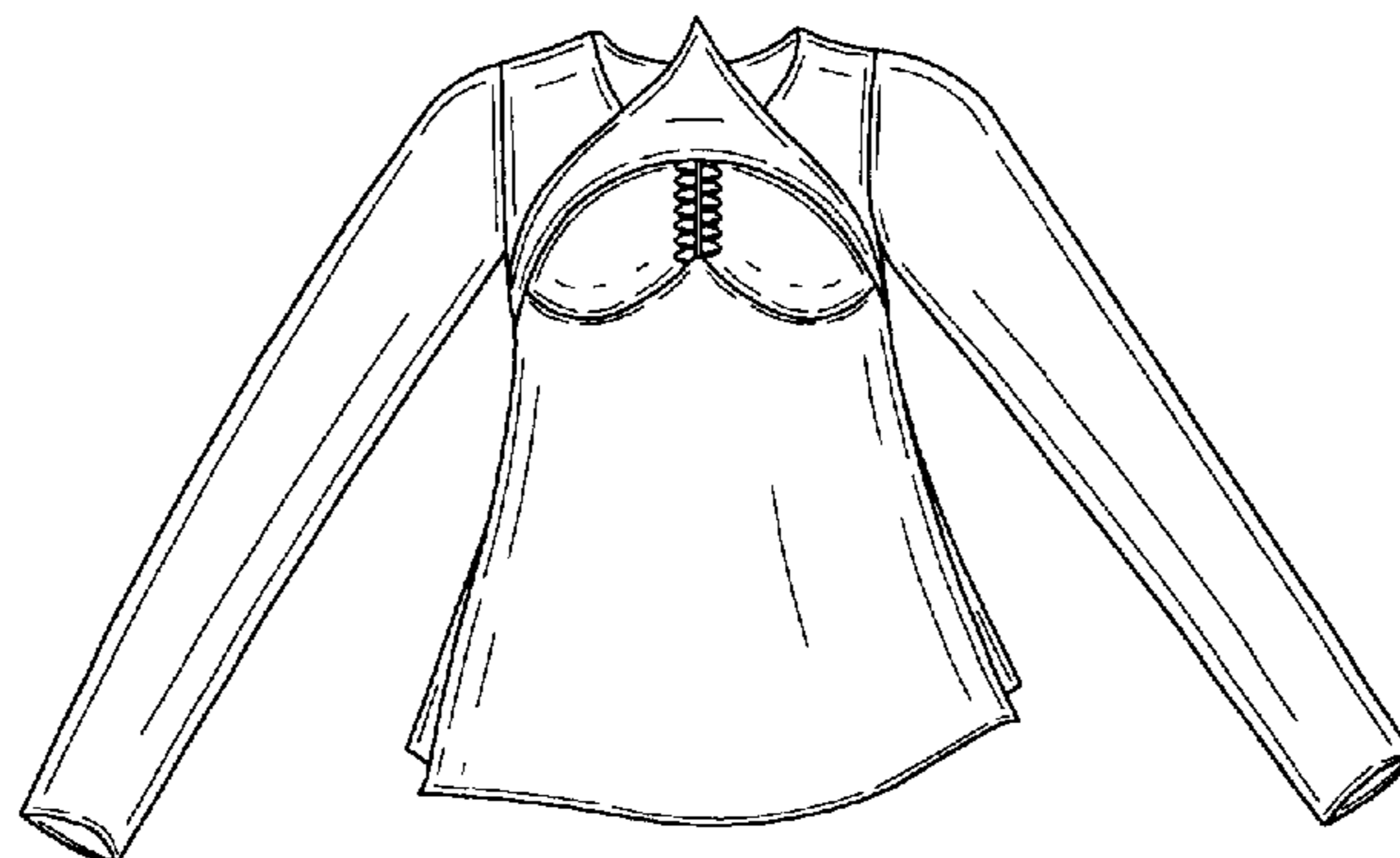
