**DESCRIPTION**

FIG. 5 is a left side view of a second embodiment showing my new design, the right side view being a mirror image;

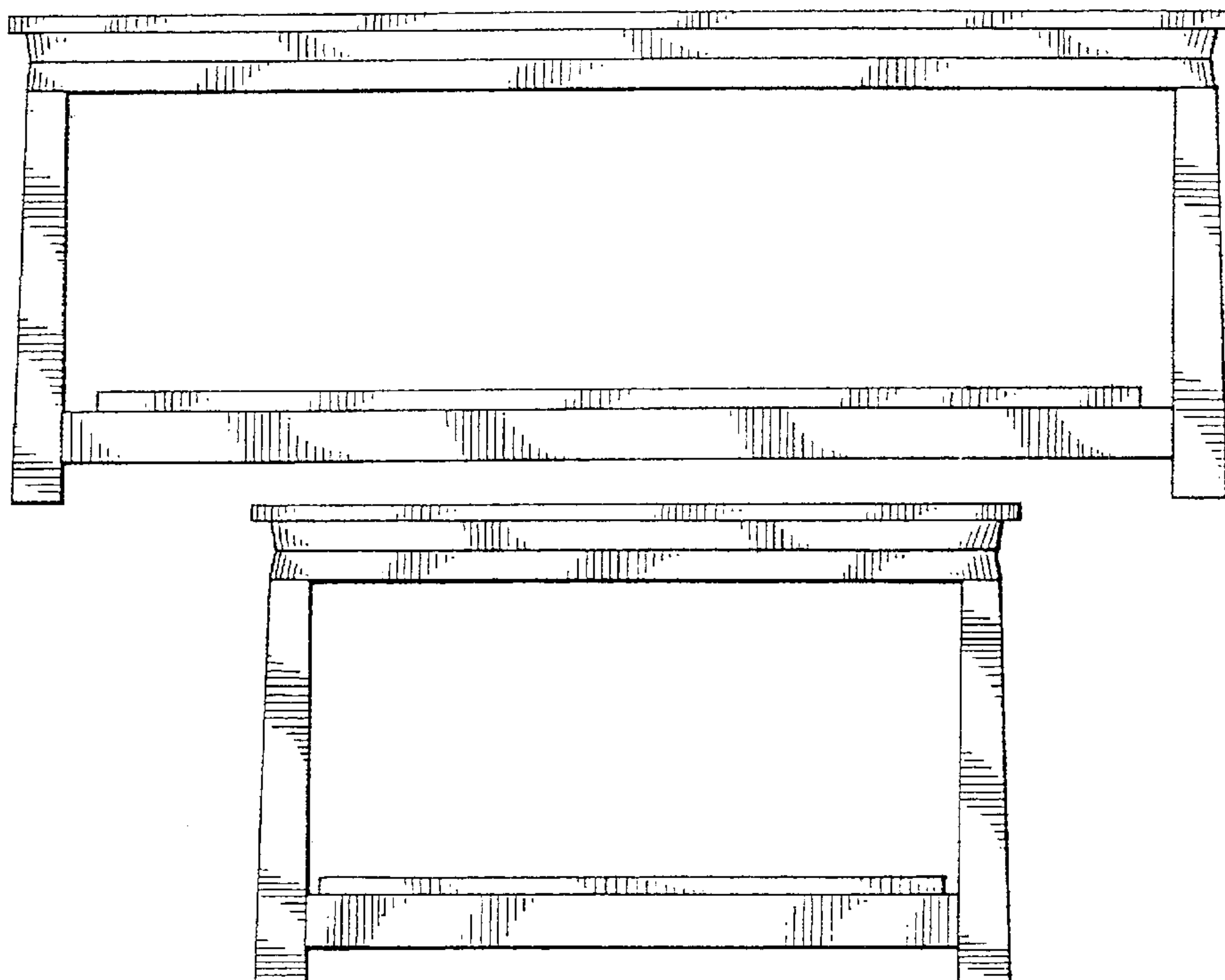
FIG. 6 is a front view thereof, the rear view being a mirror image;

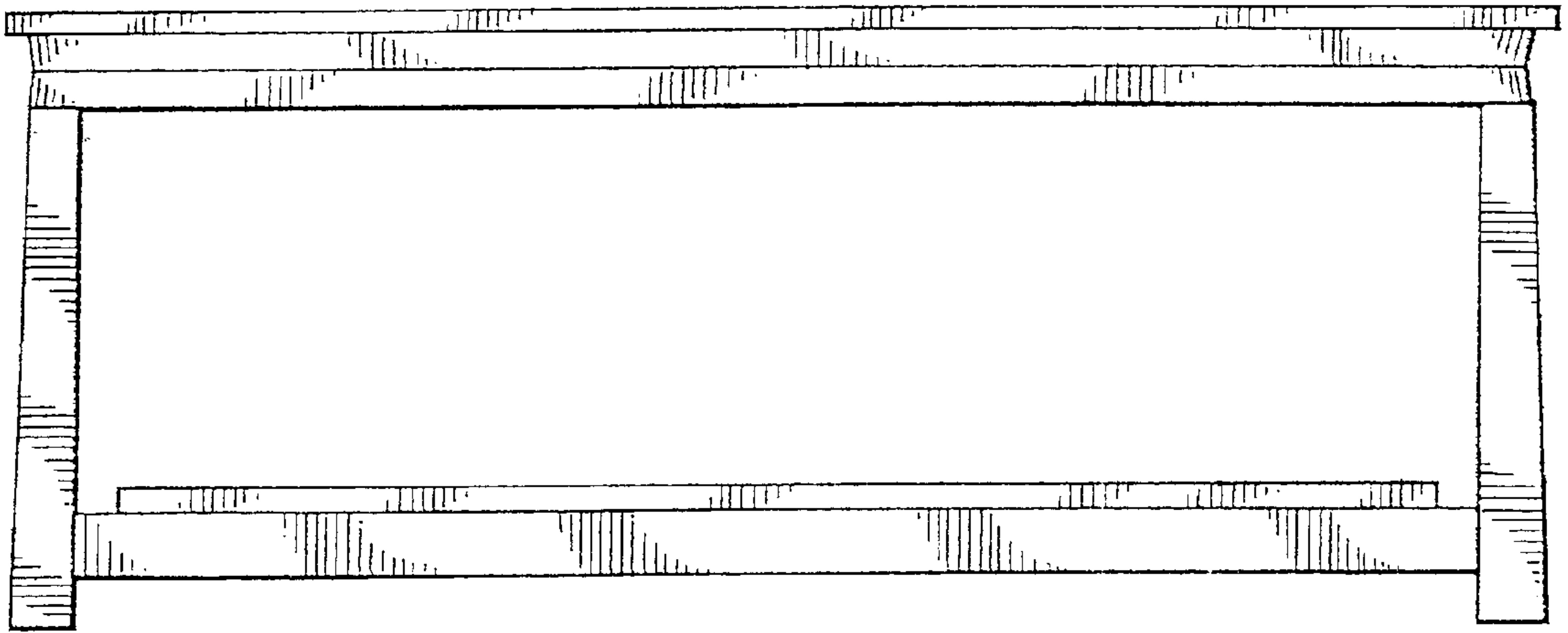
FIG. 7 is a bottom view thereof; and,

FIG. 8 is a top view thereof.

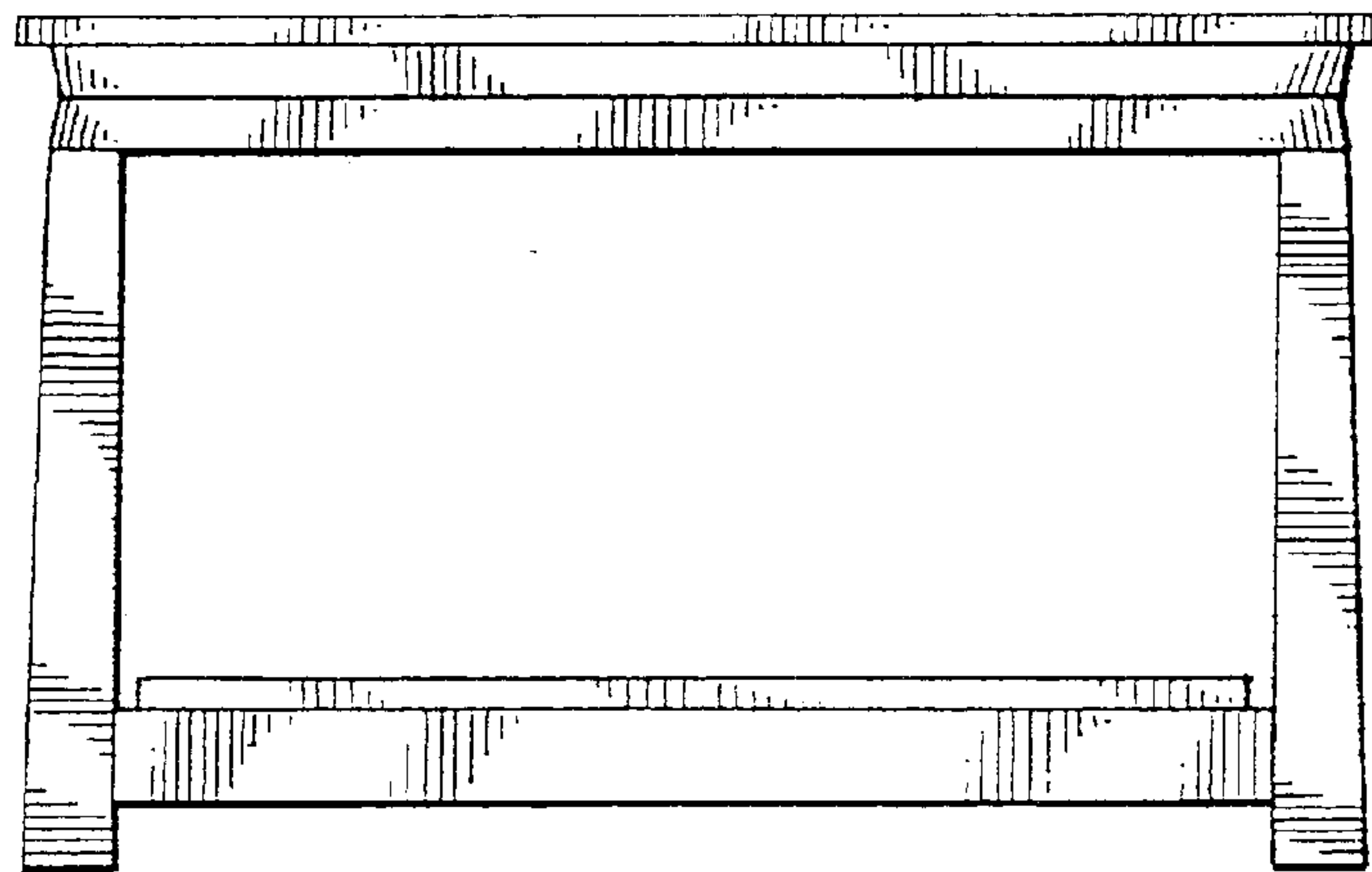
The dashed lines in FIGS. 3 and 7 are shown for environmental purposes only and form no part of the claimed design.

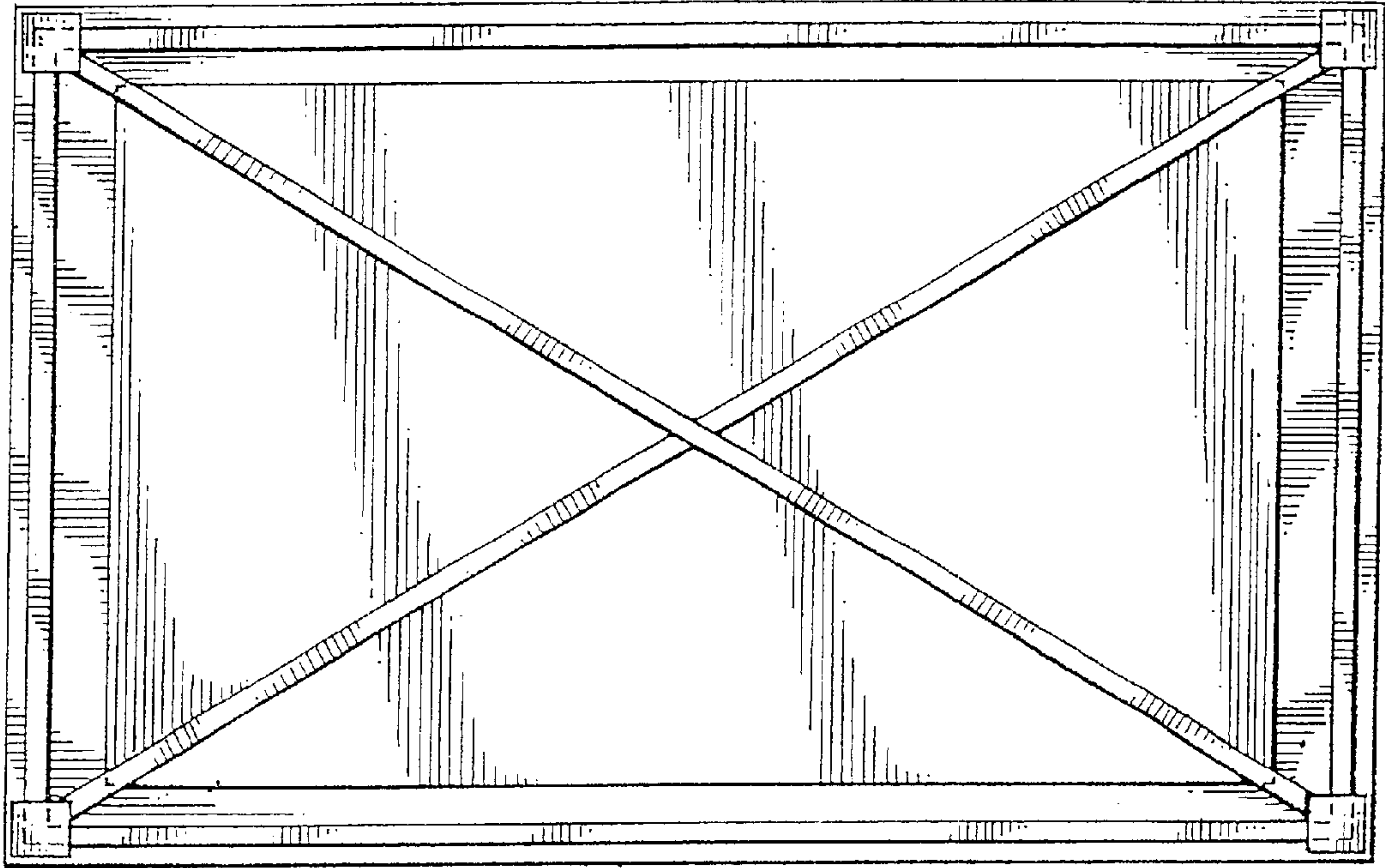




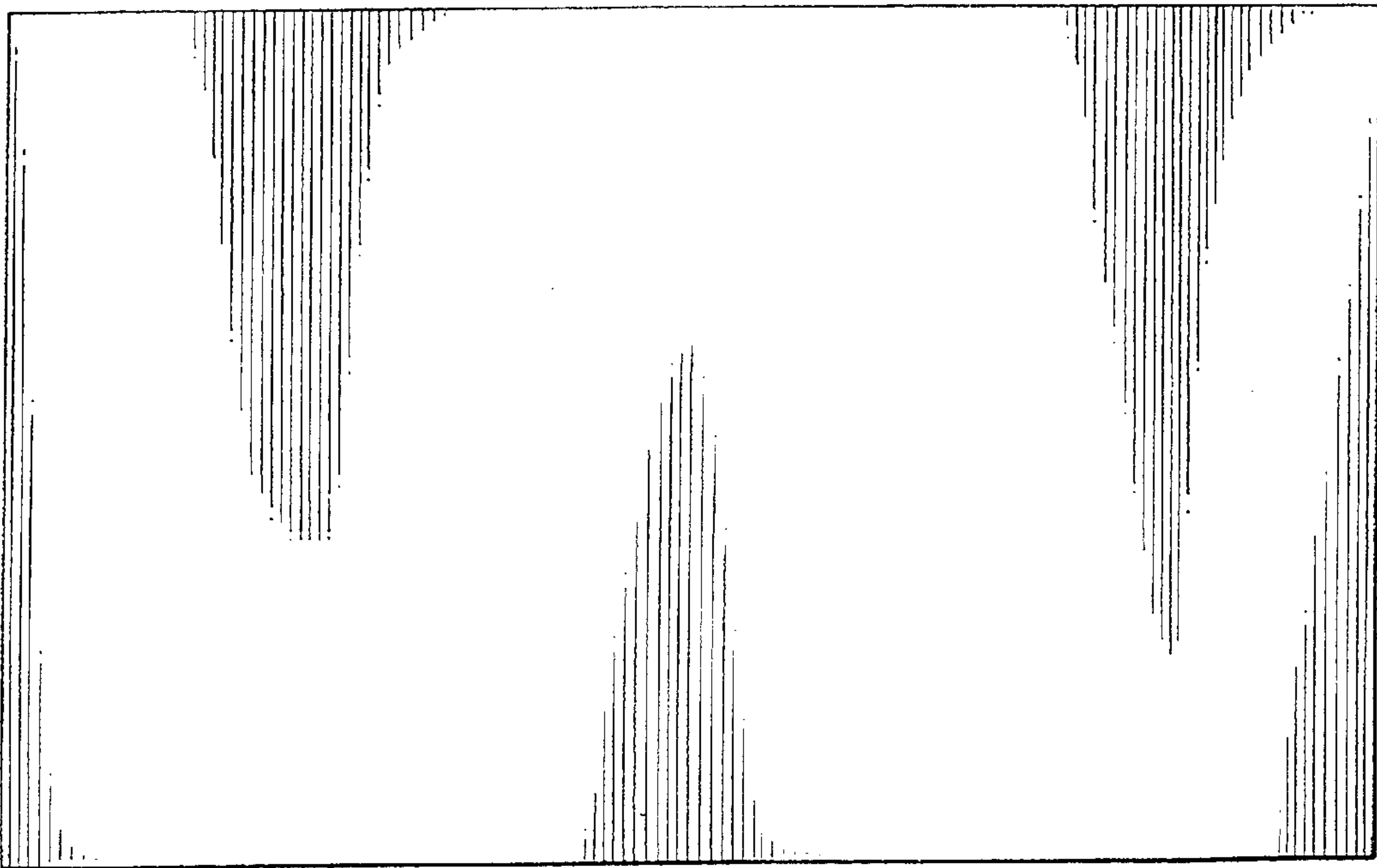

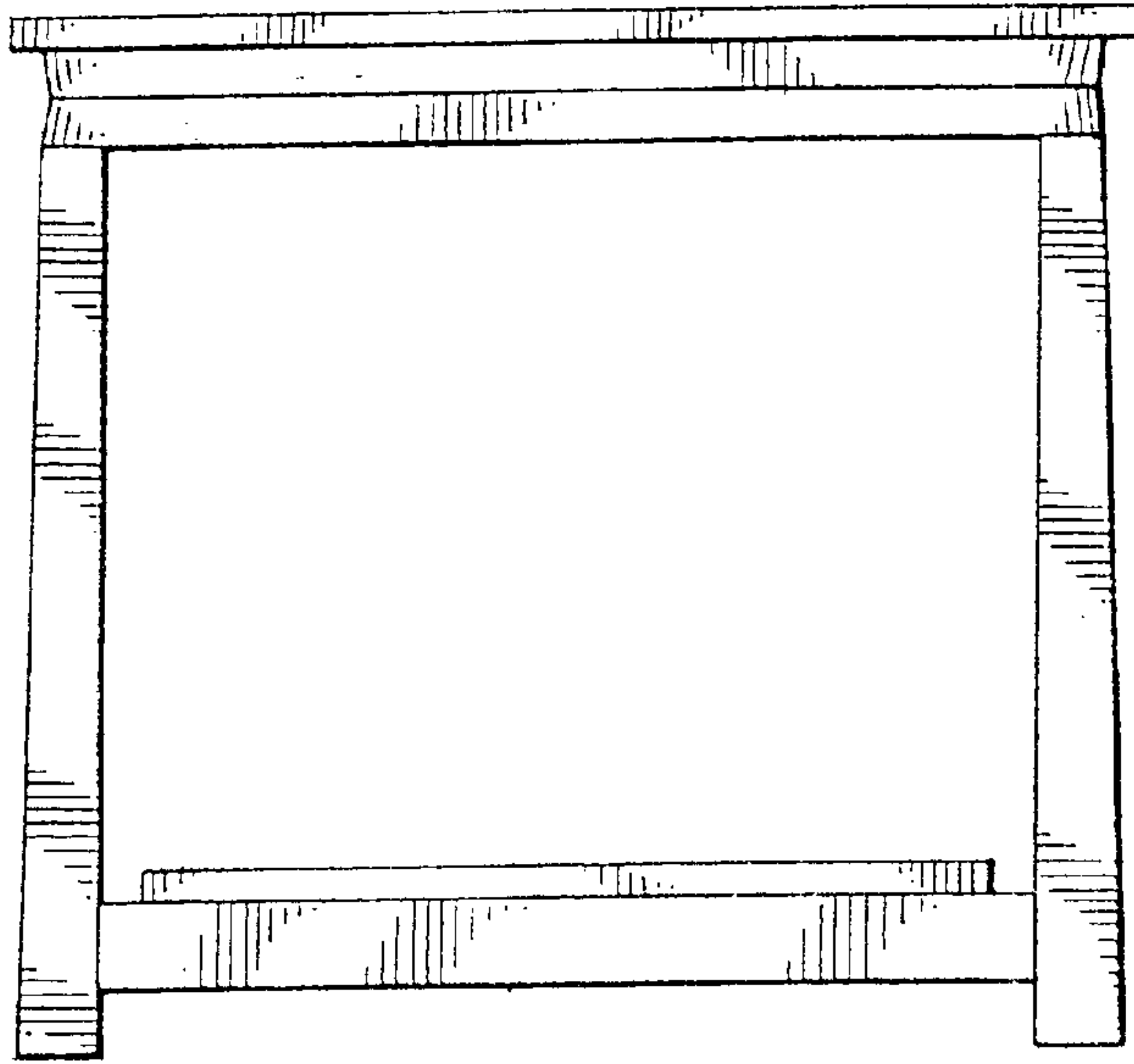

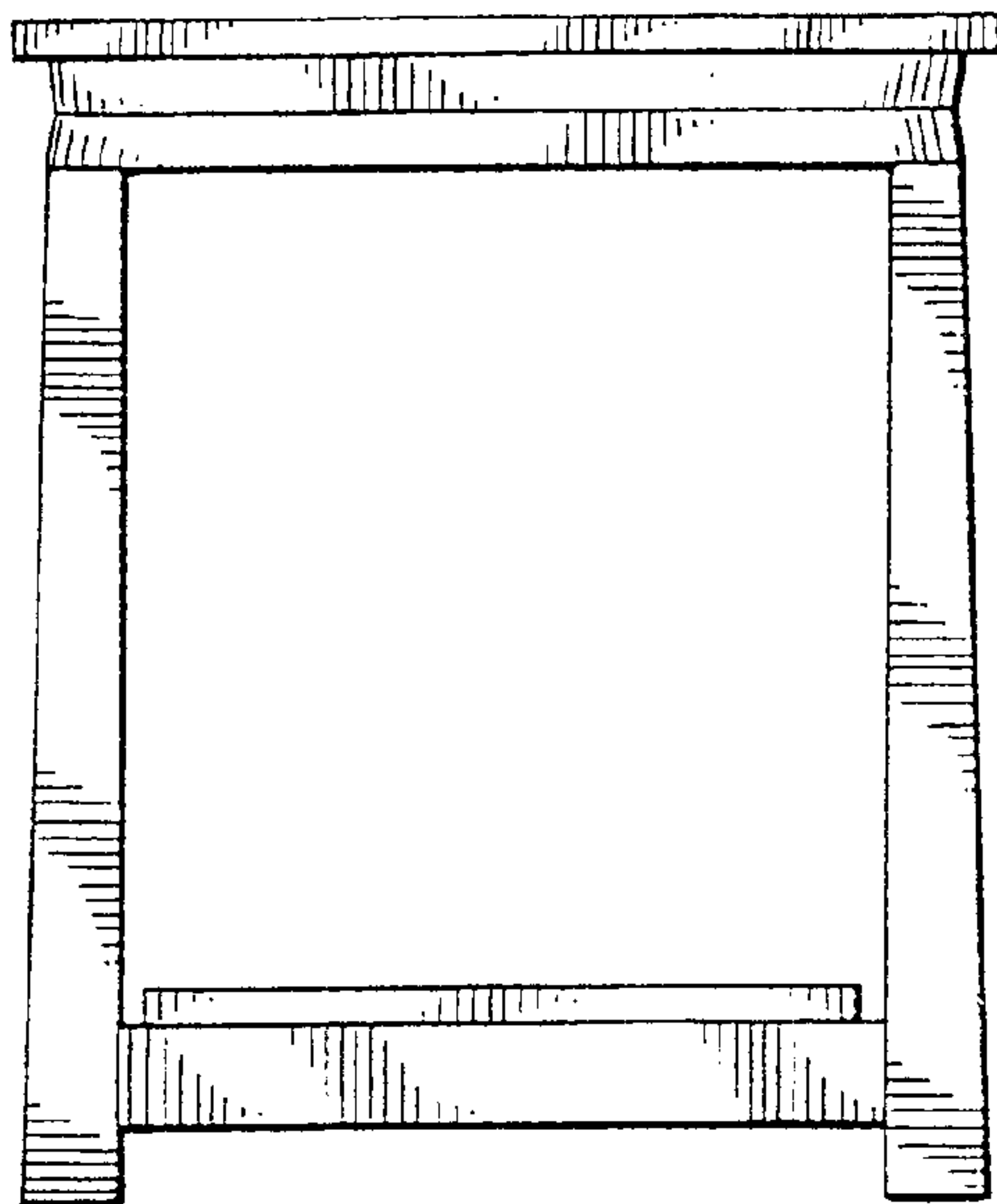

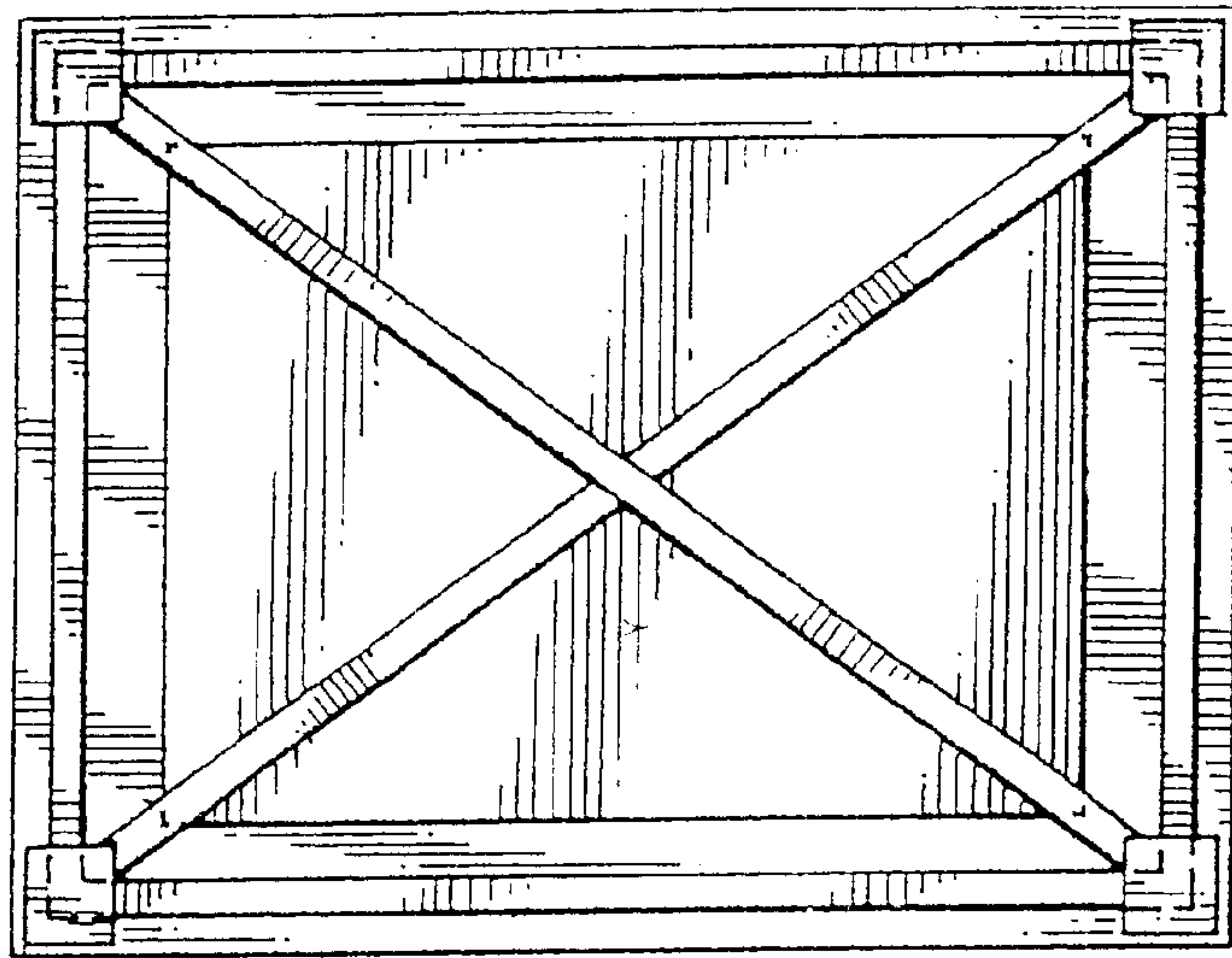

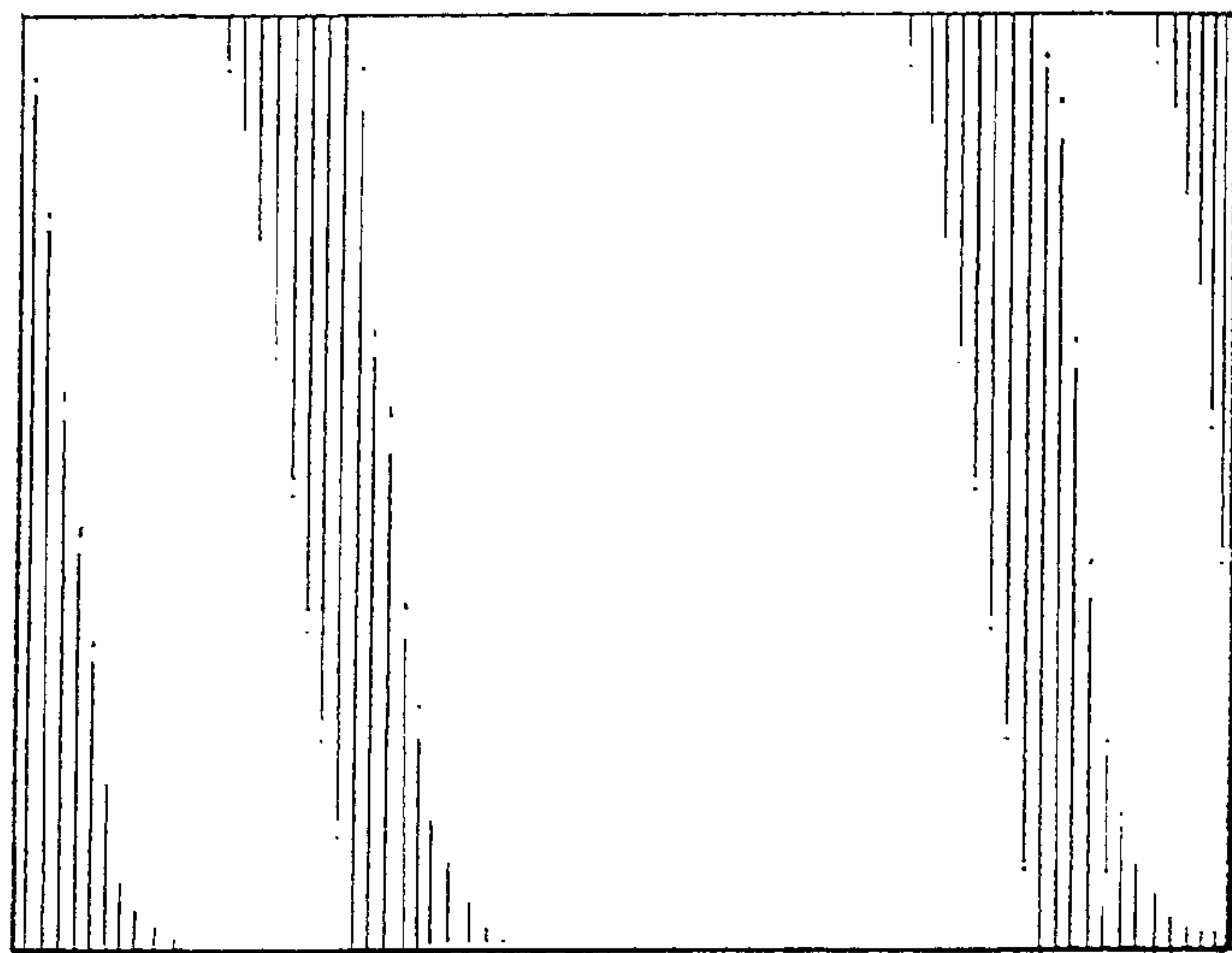
