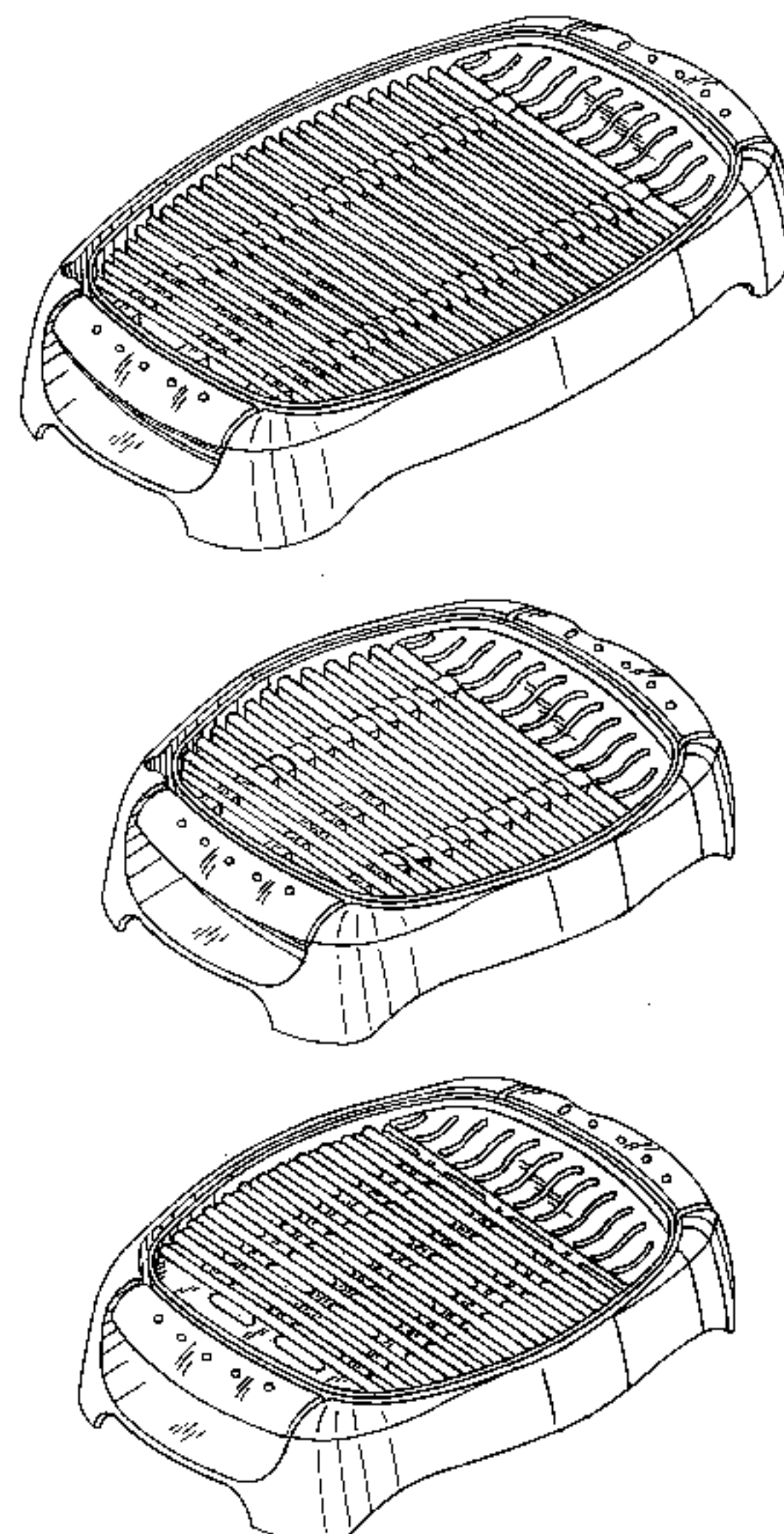
The ornamental design for a household electric grill, as shown and described.

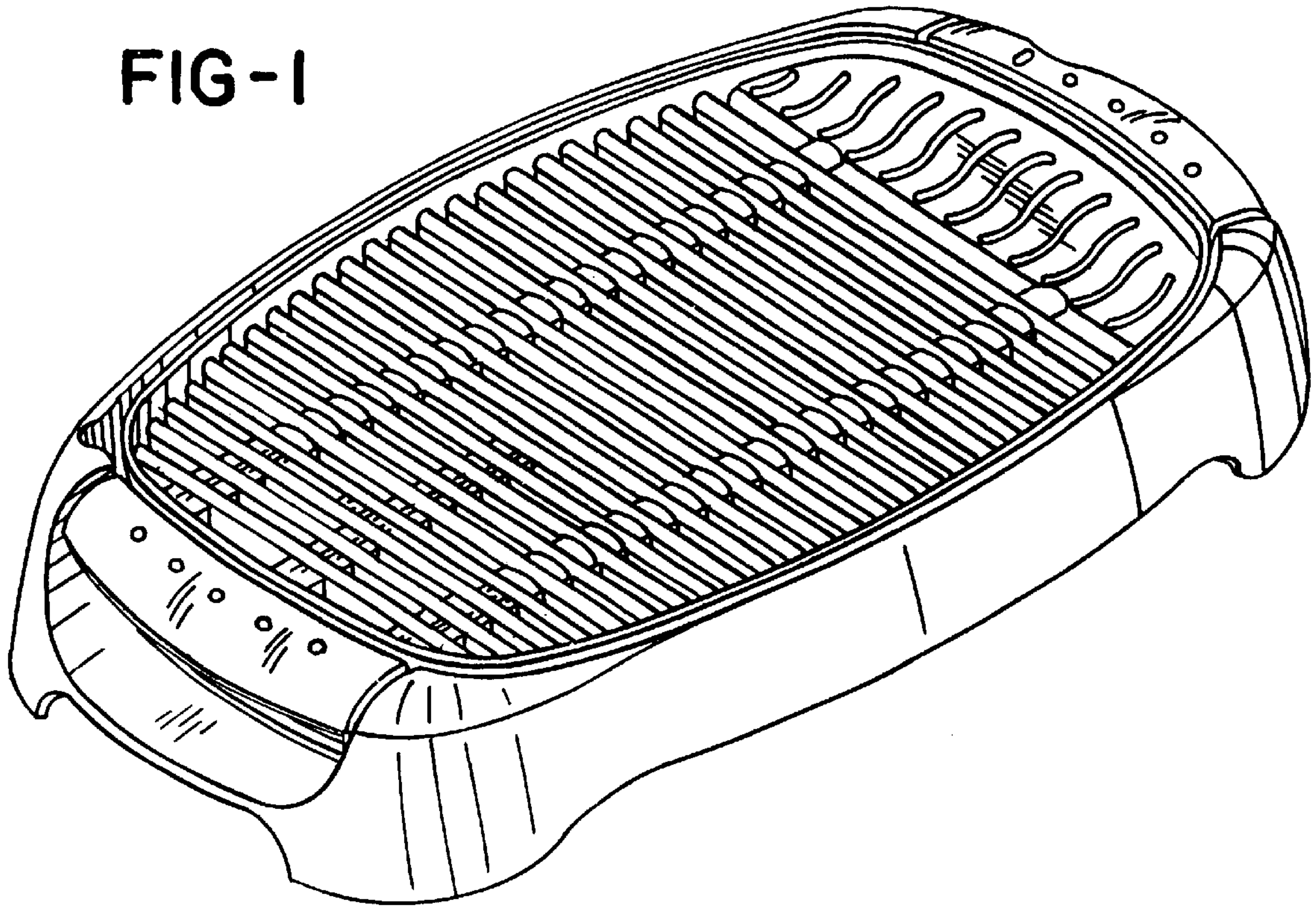

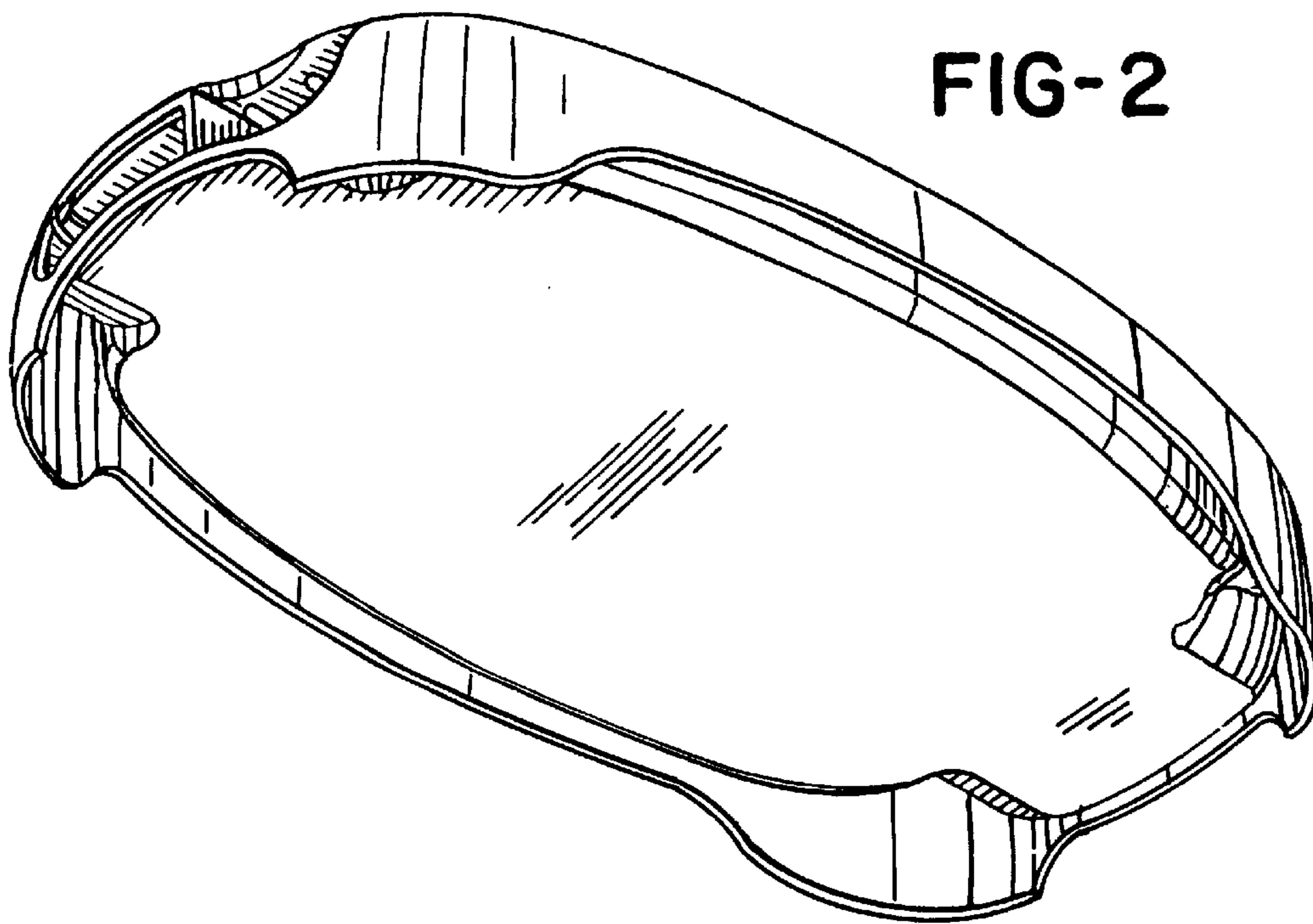

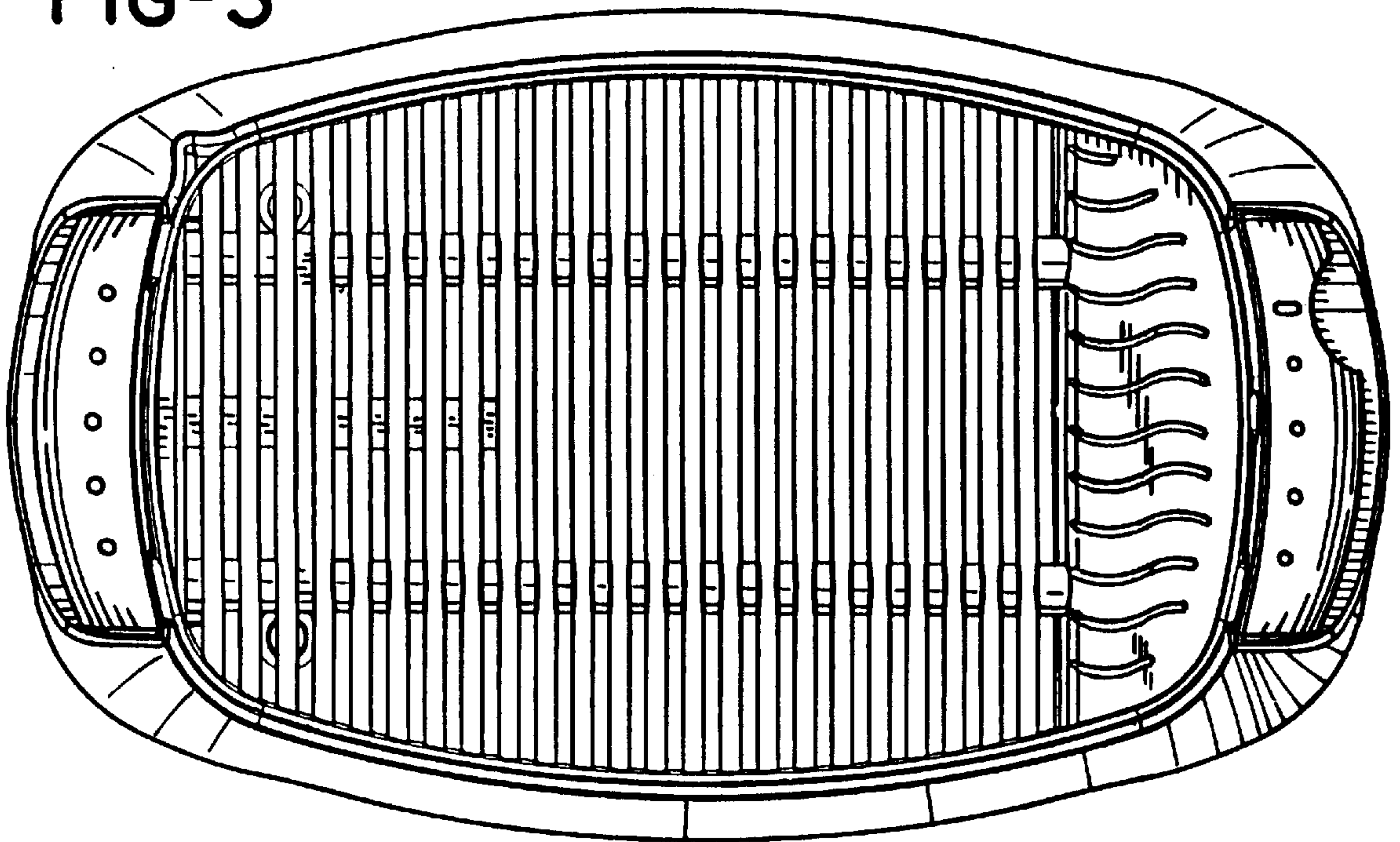

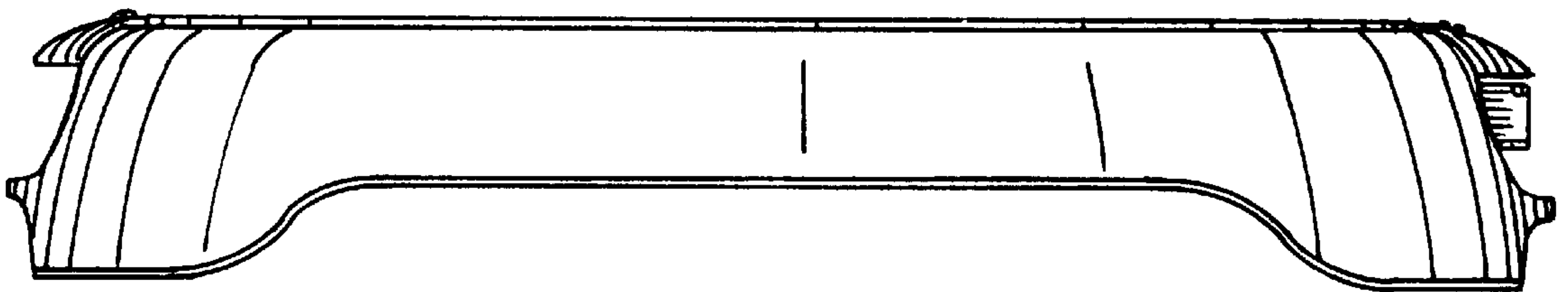

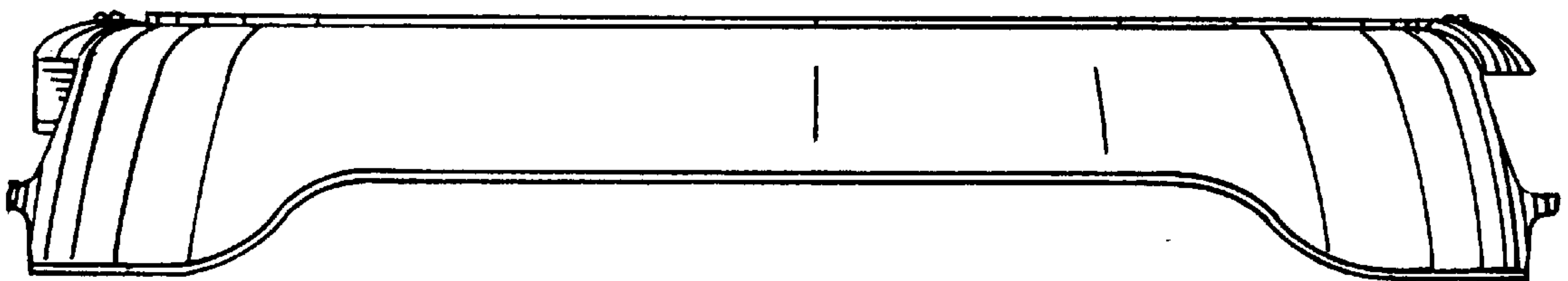

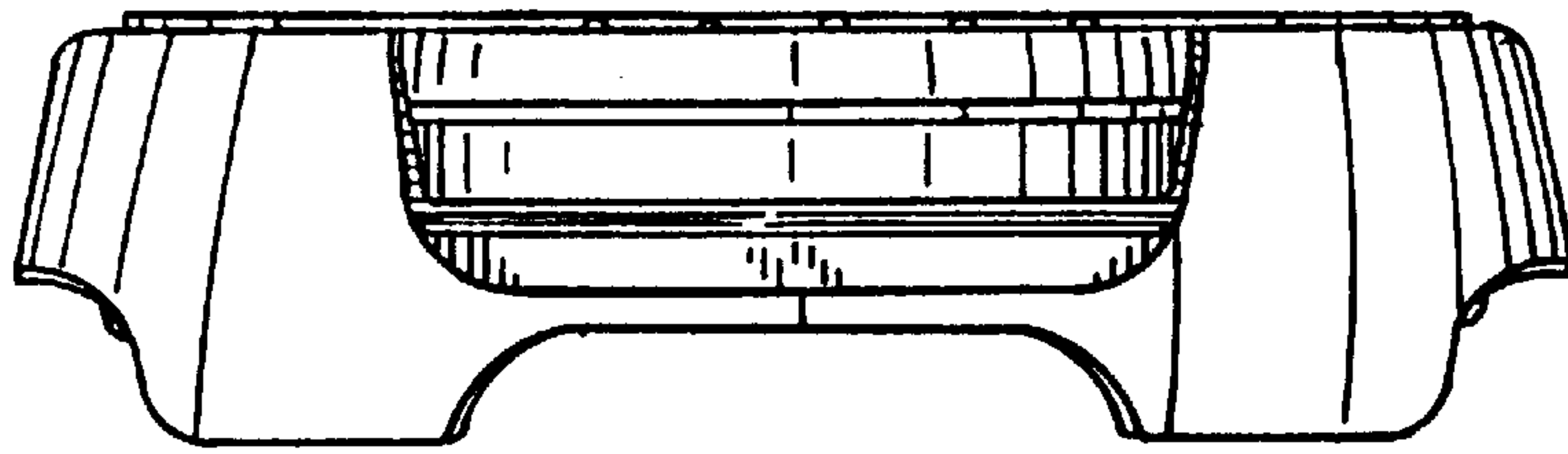

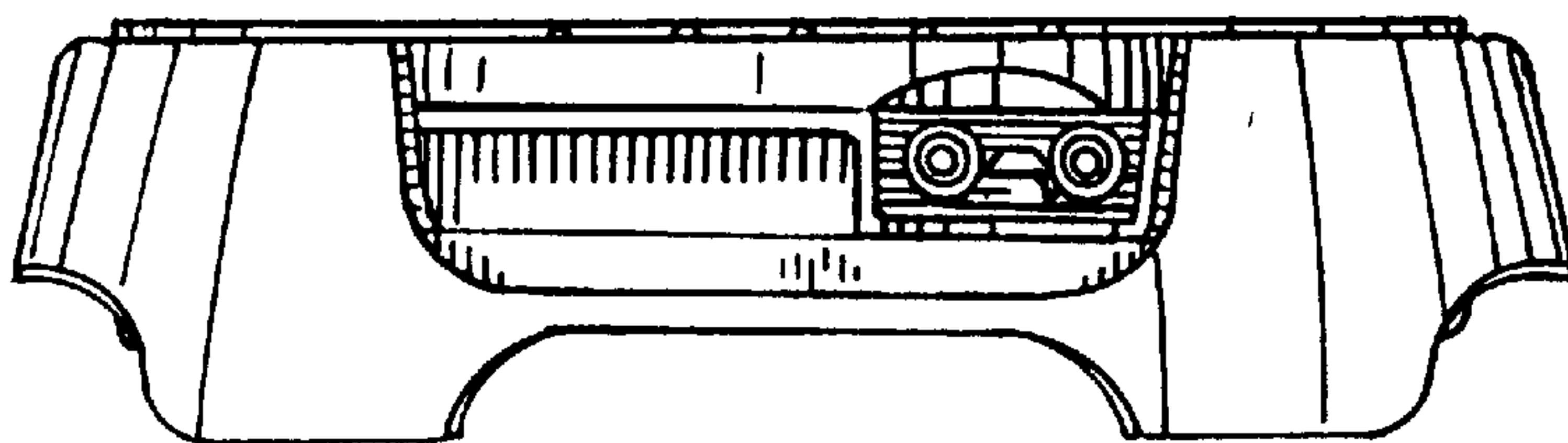

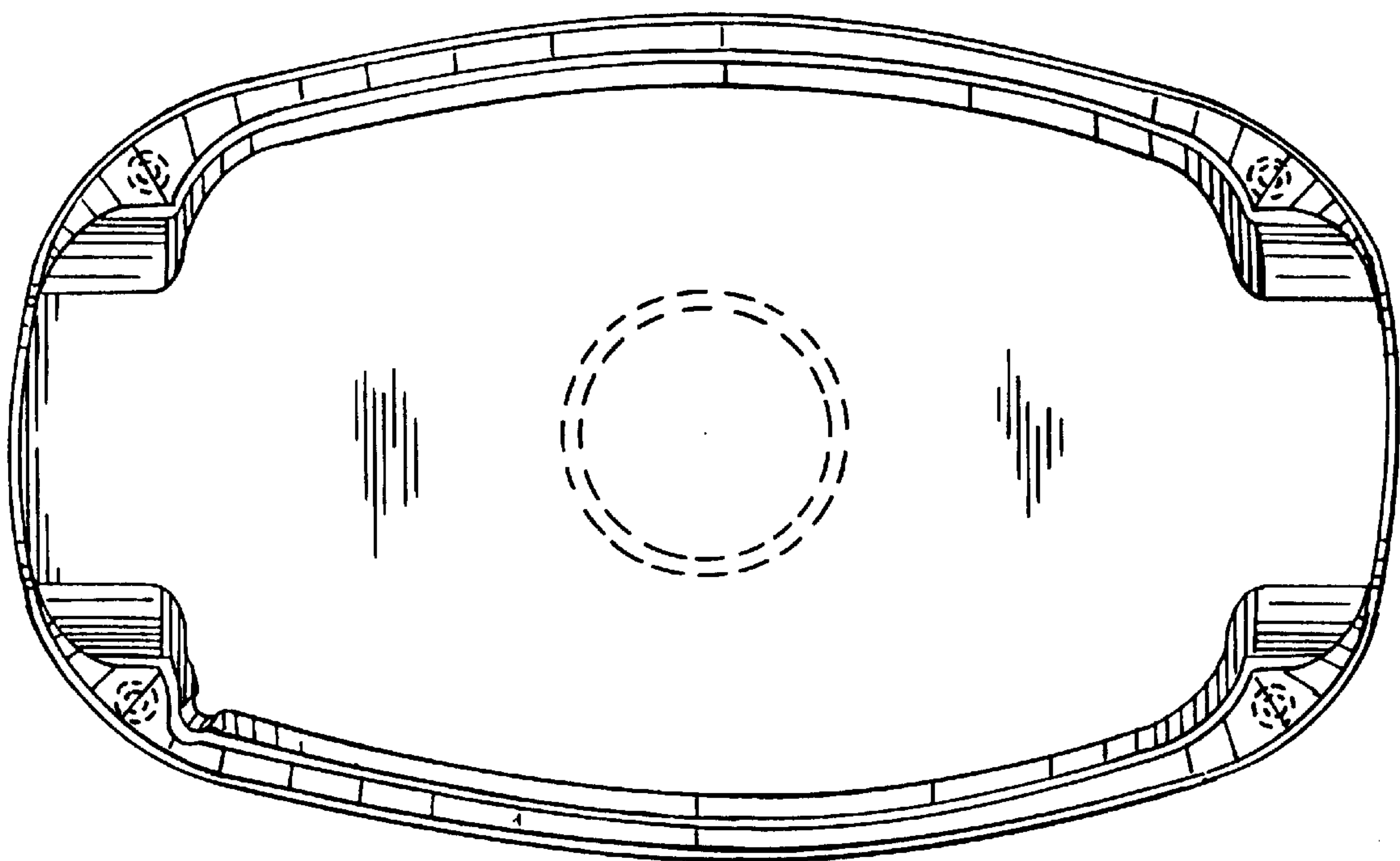

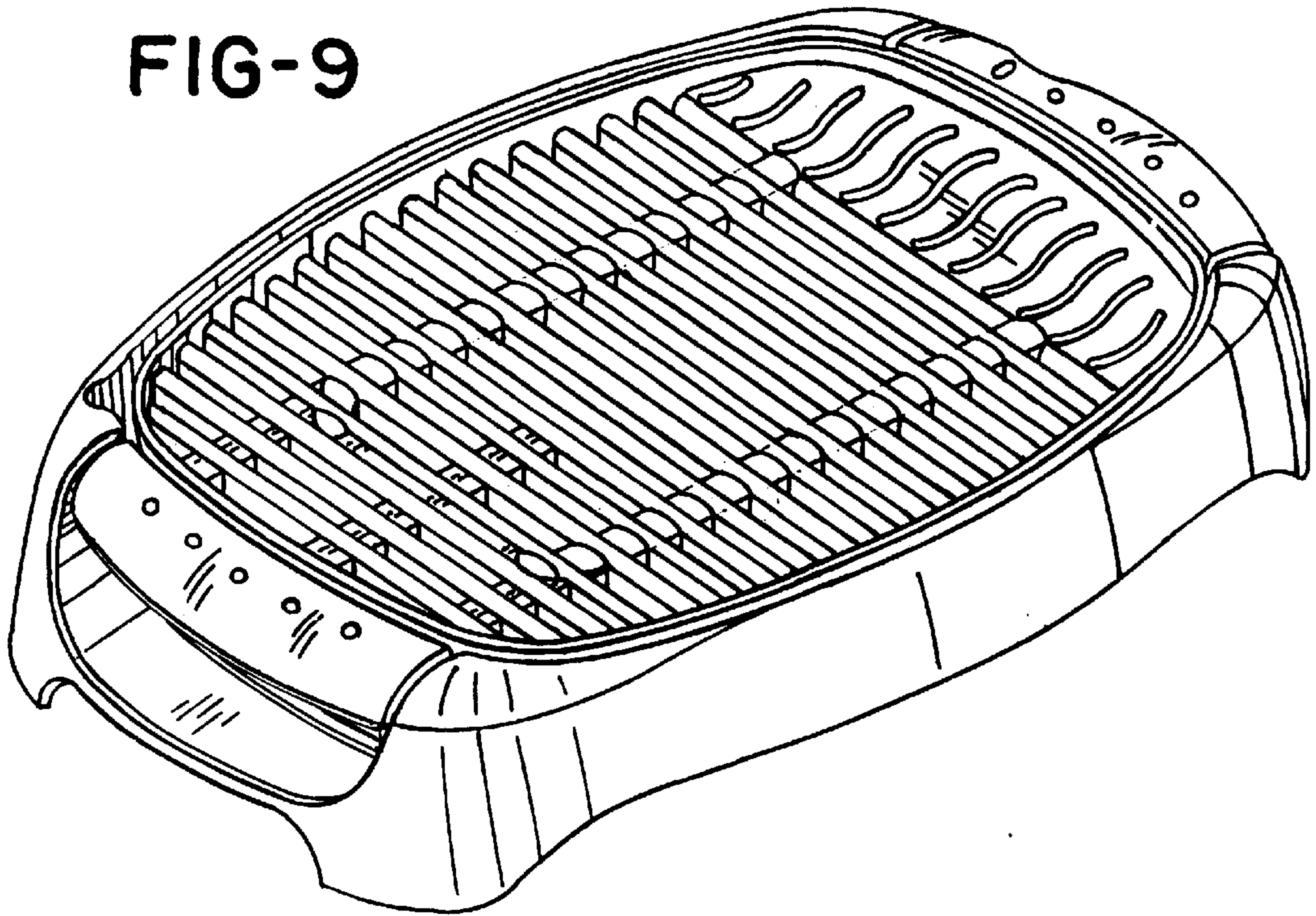

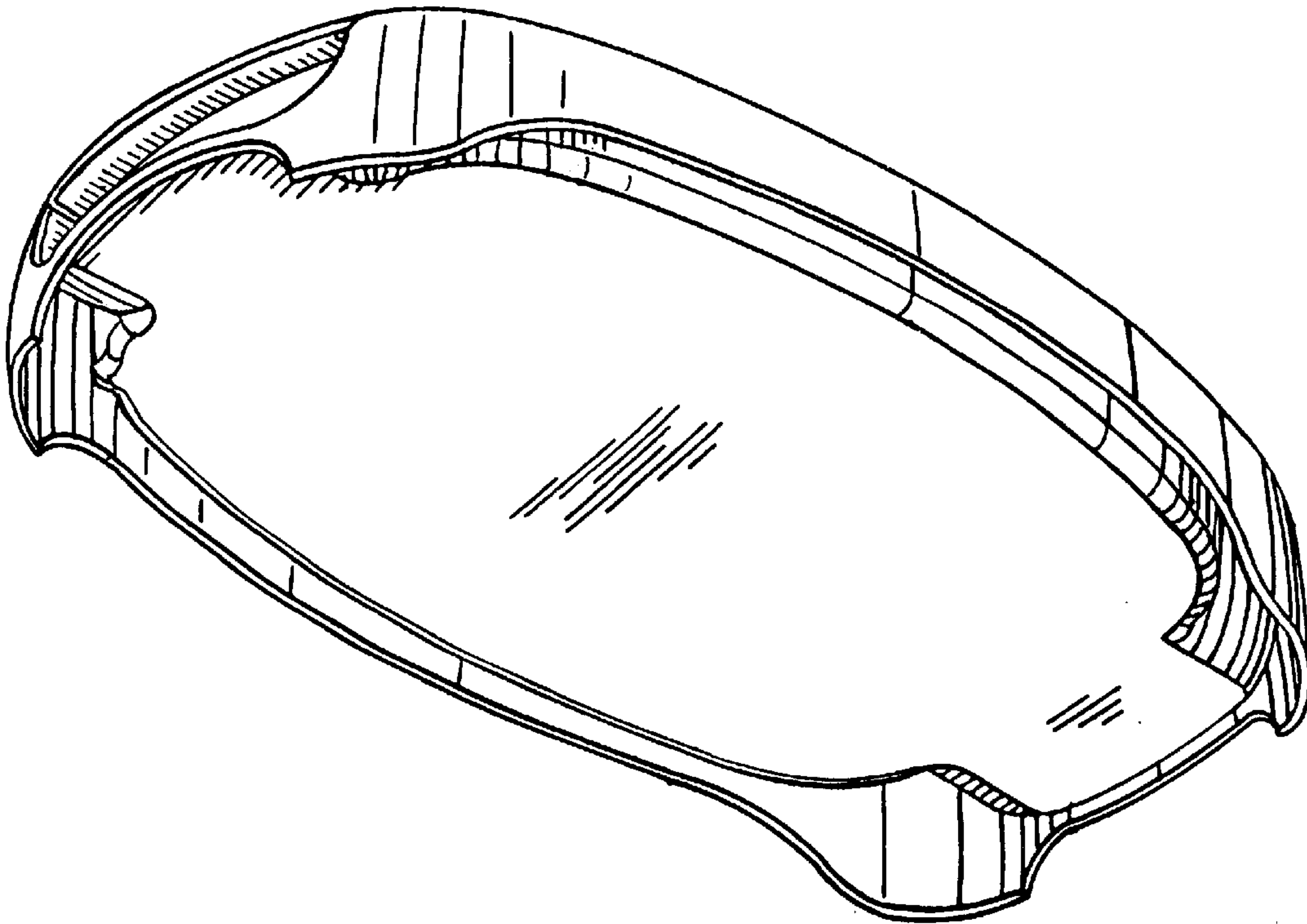

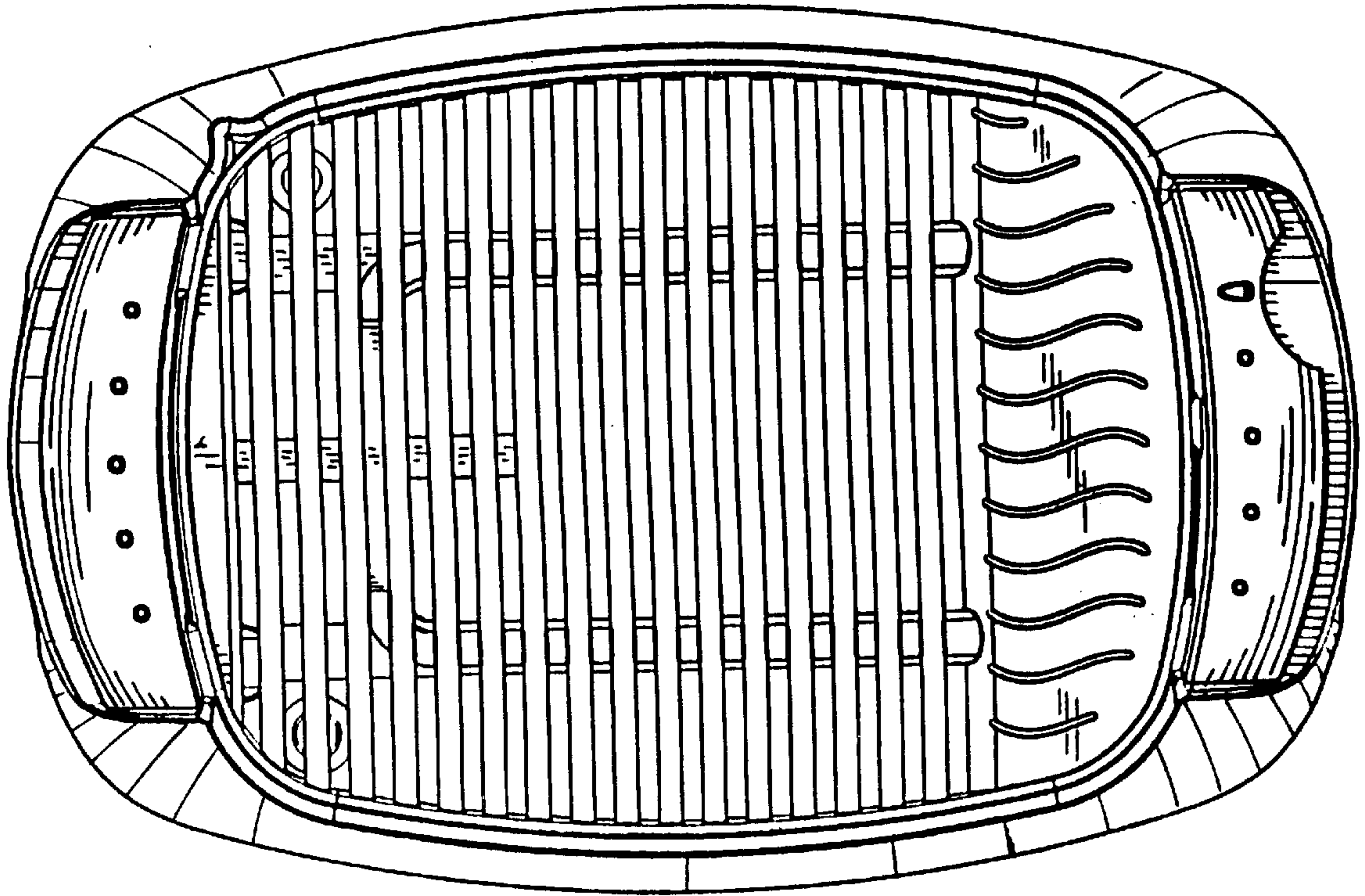

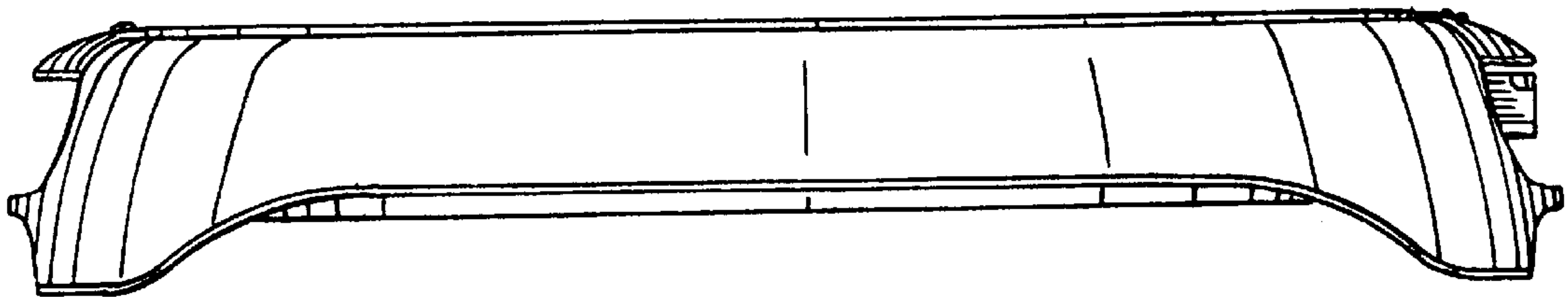

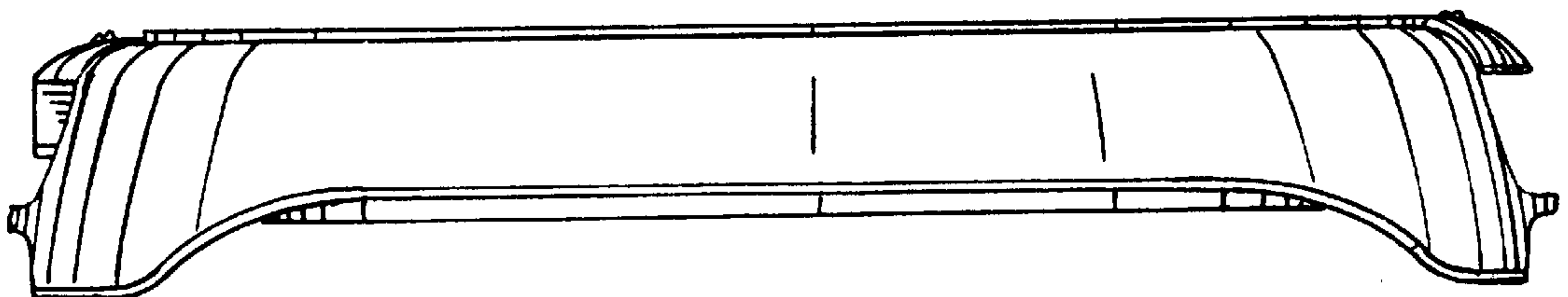

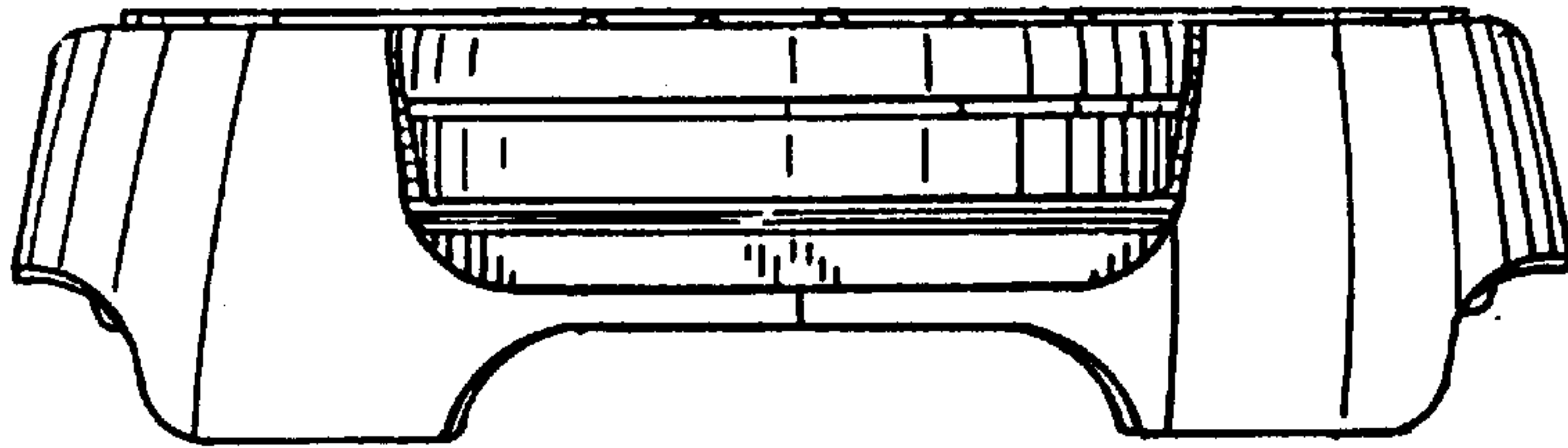

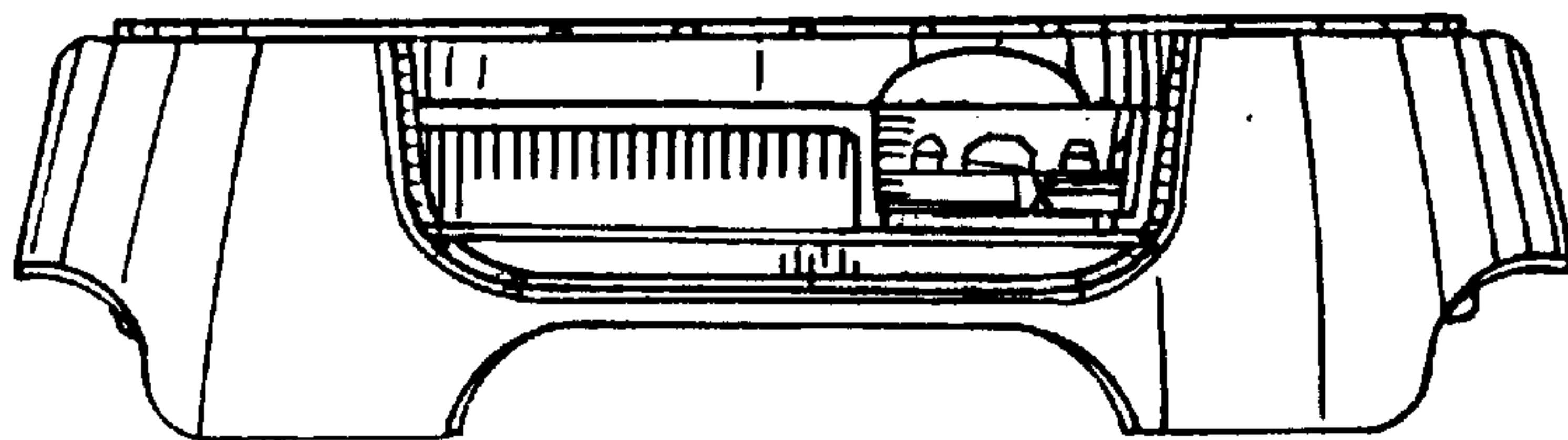

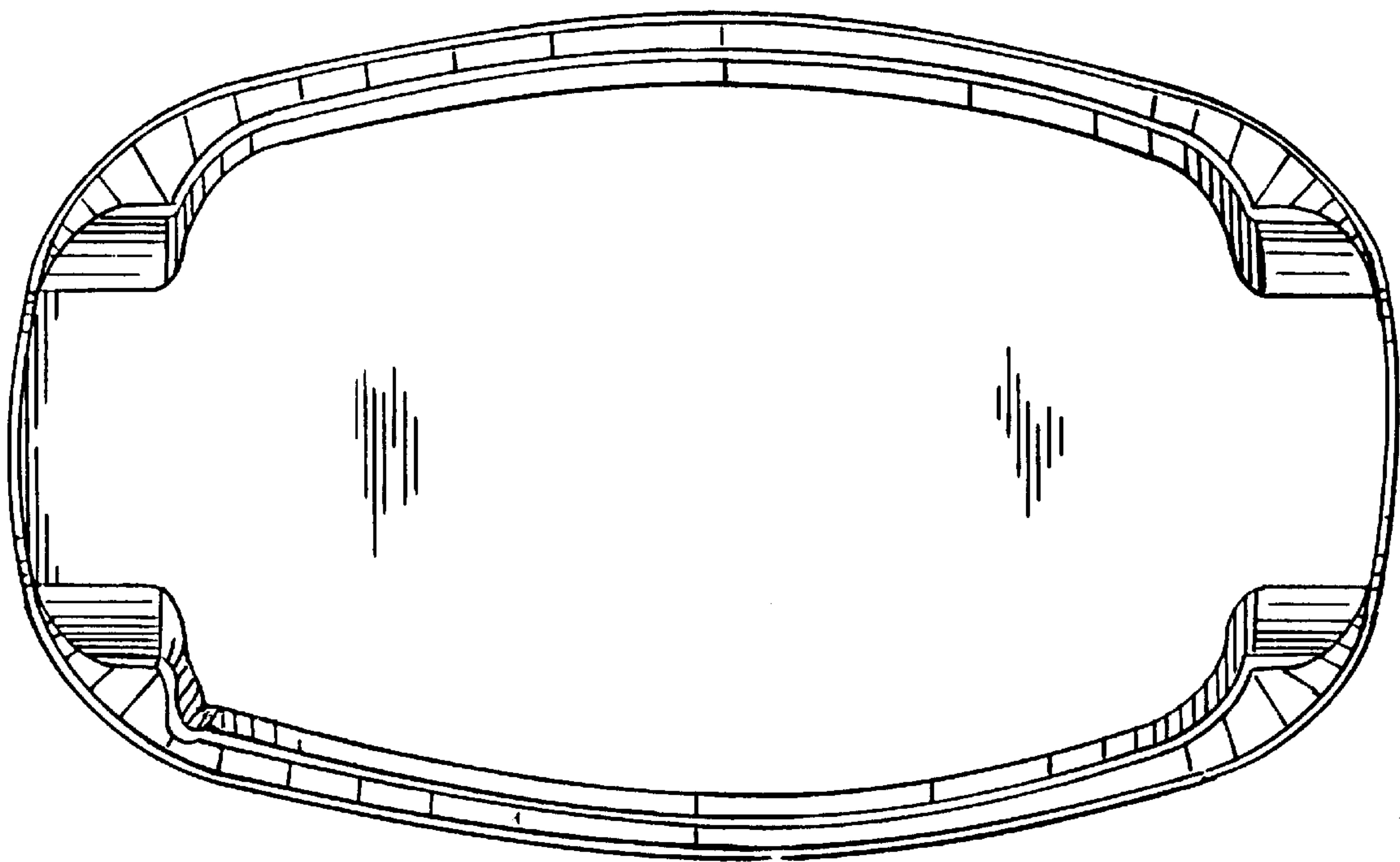

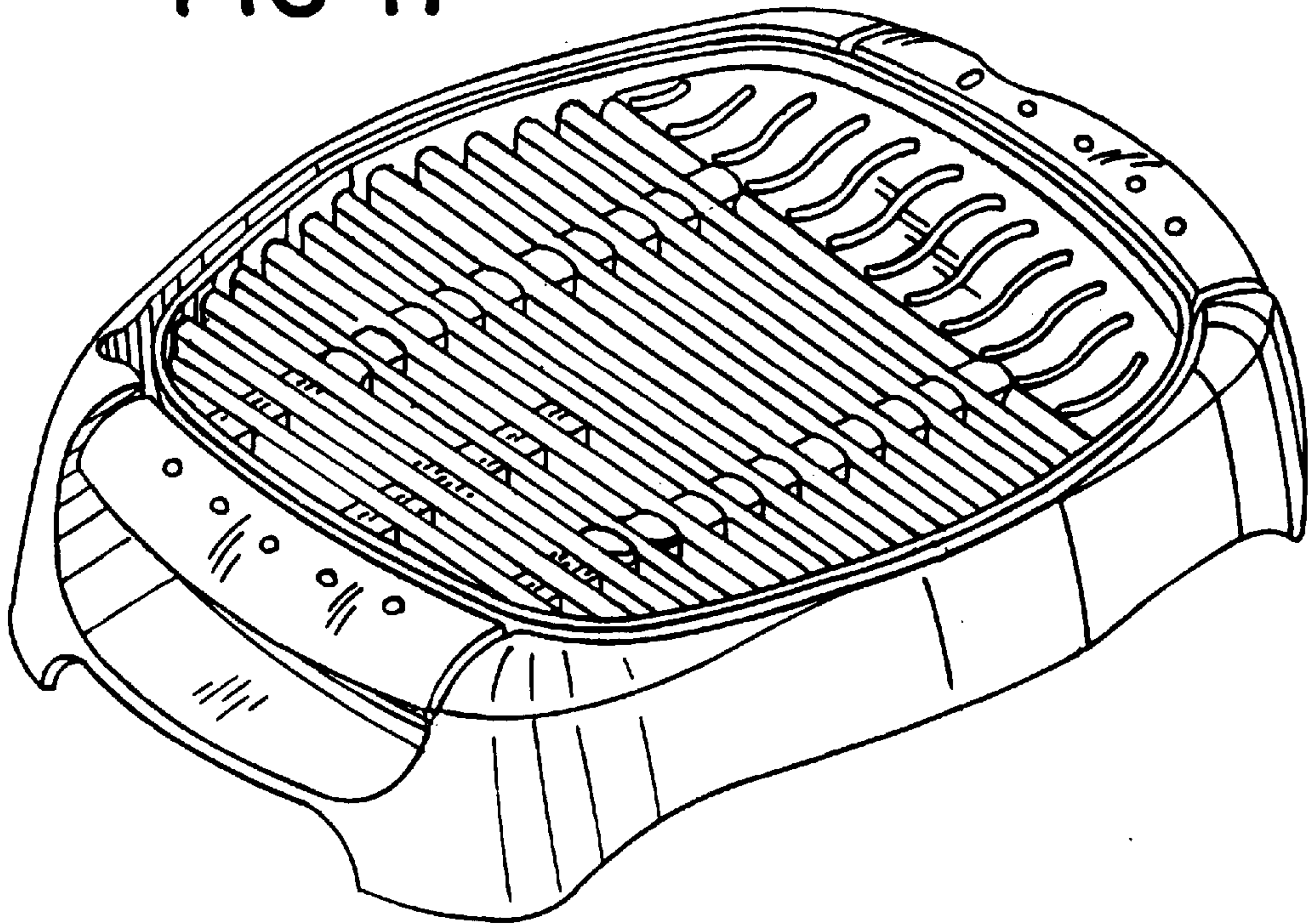

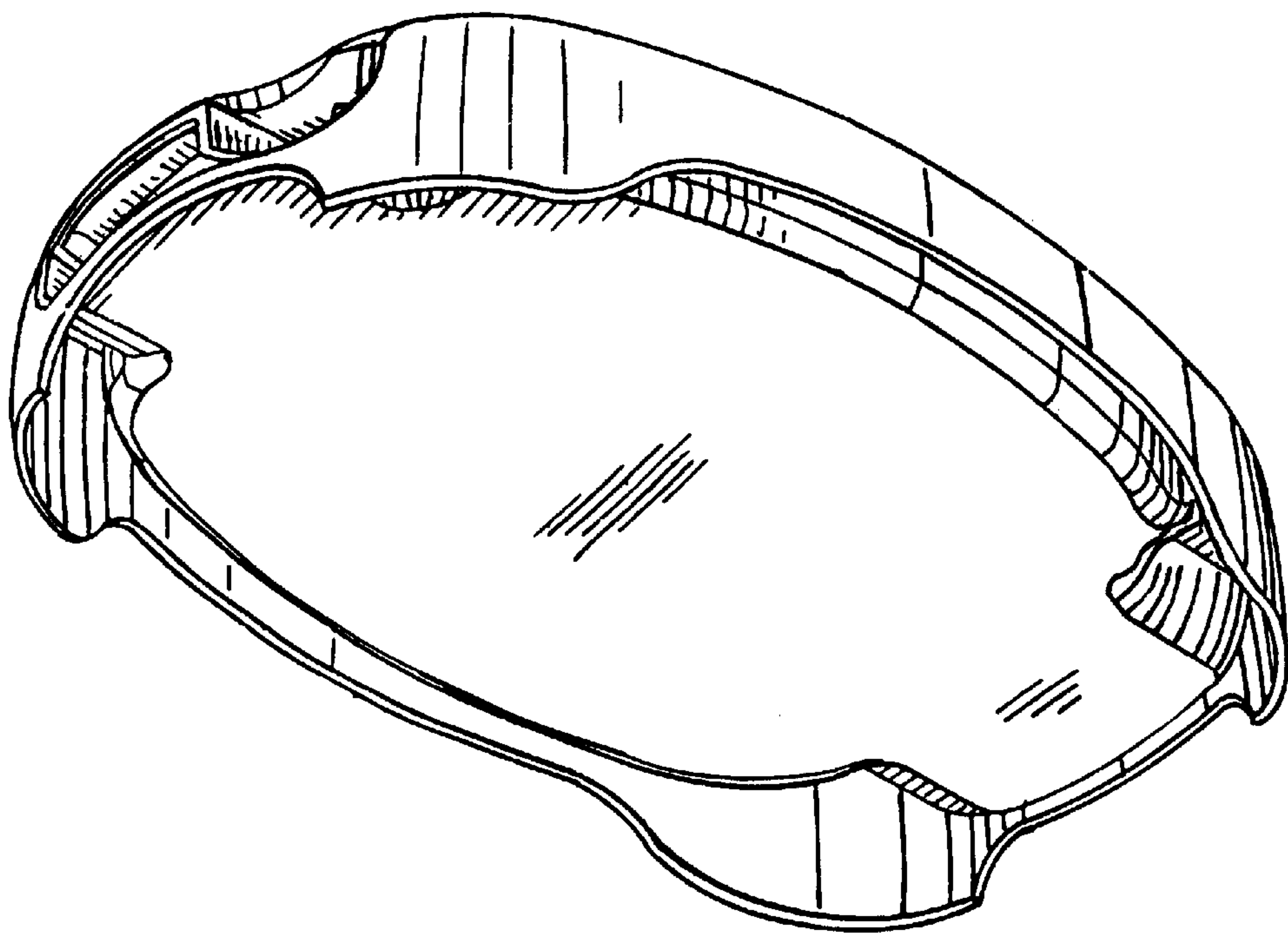

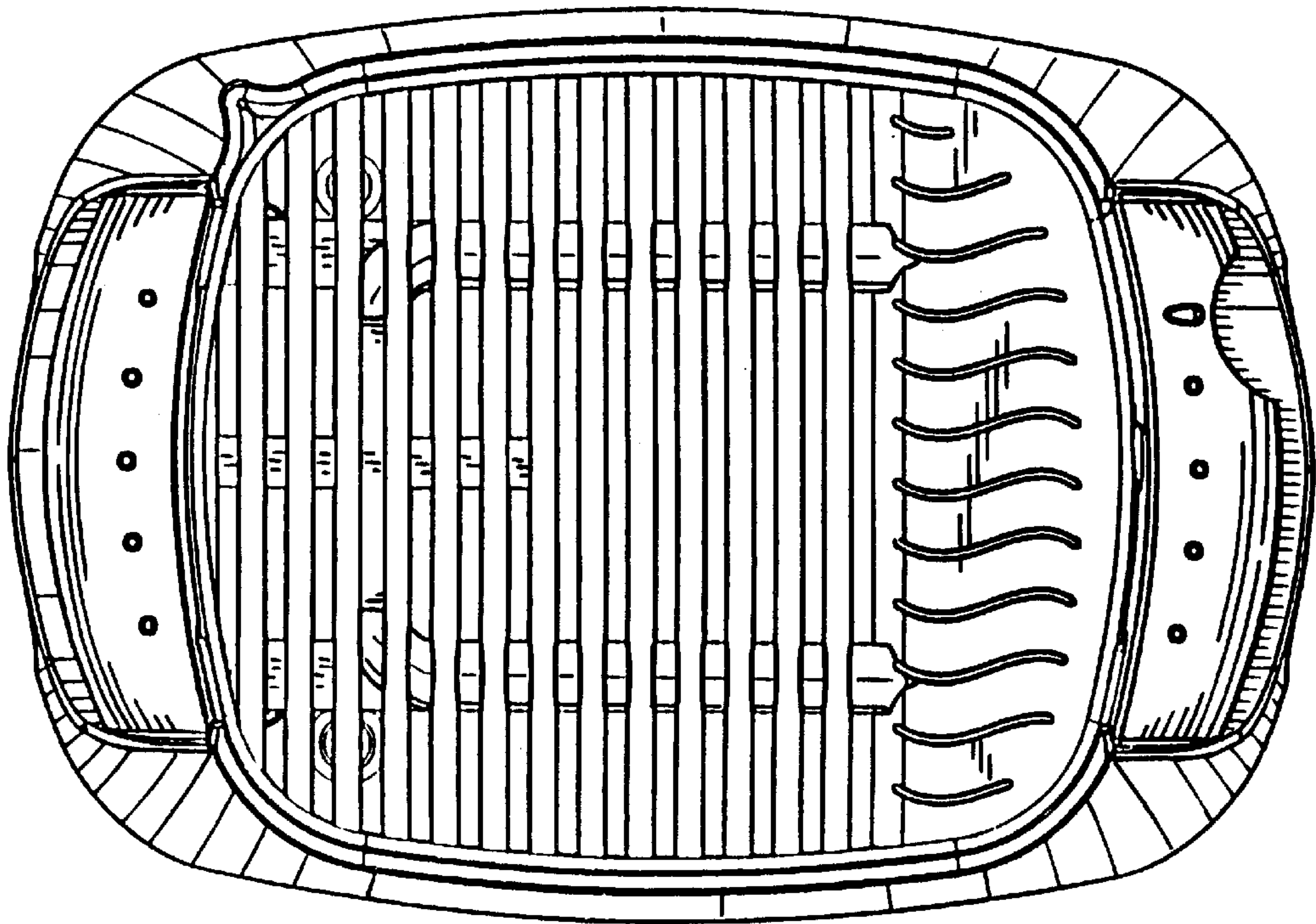

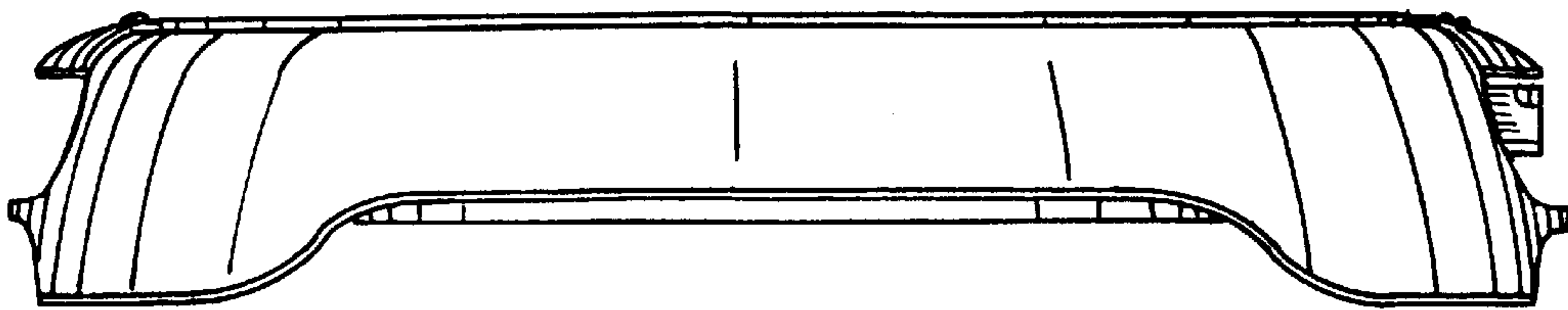

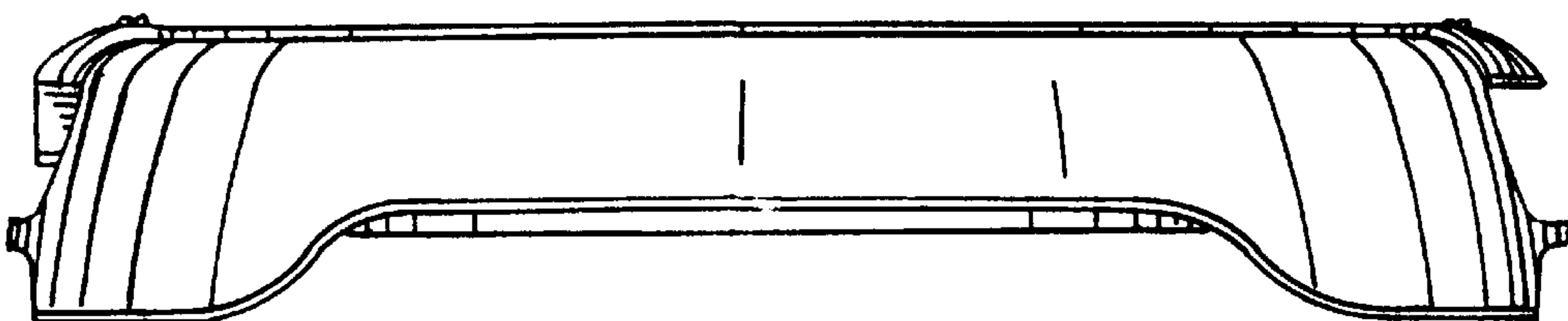

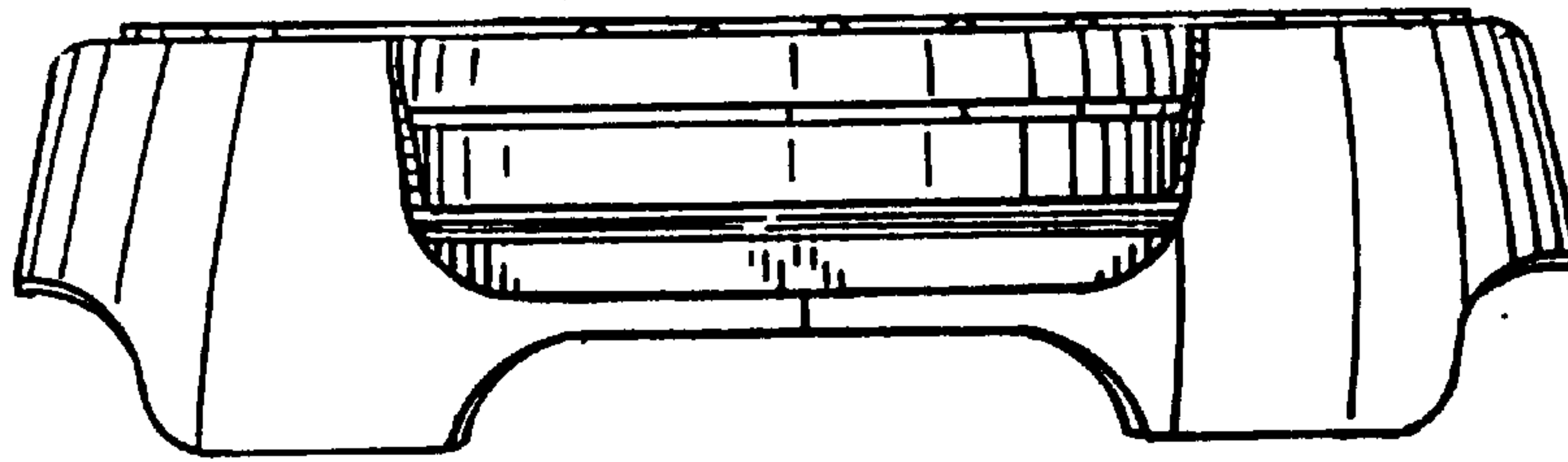

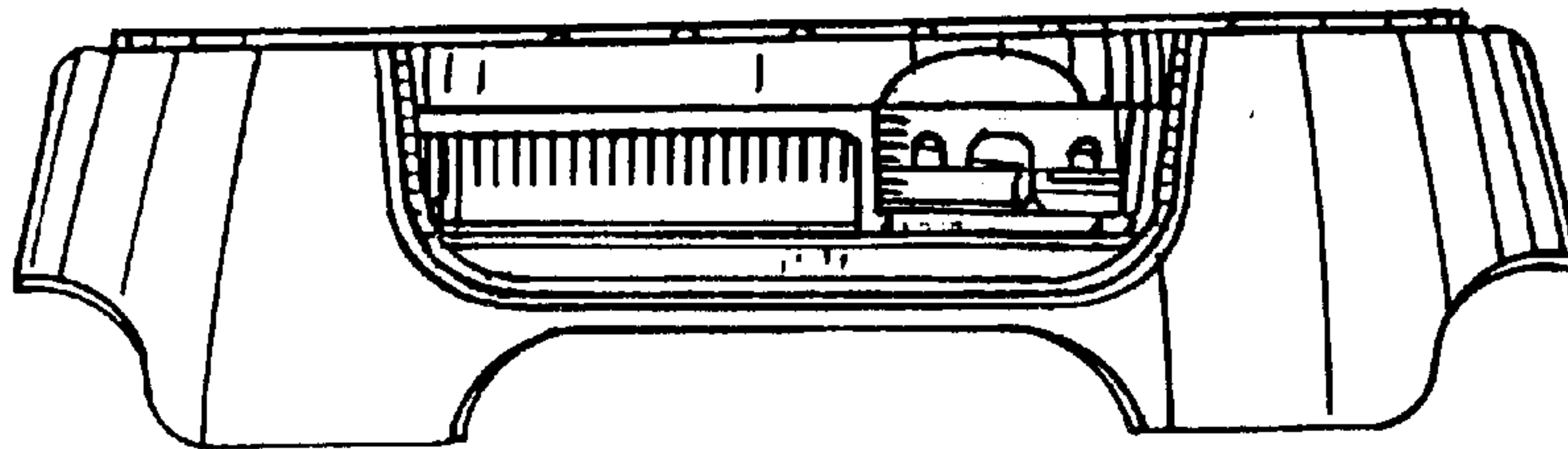

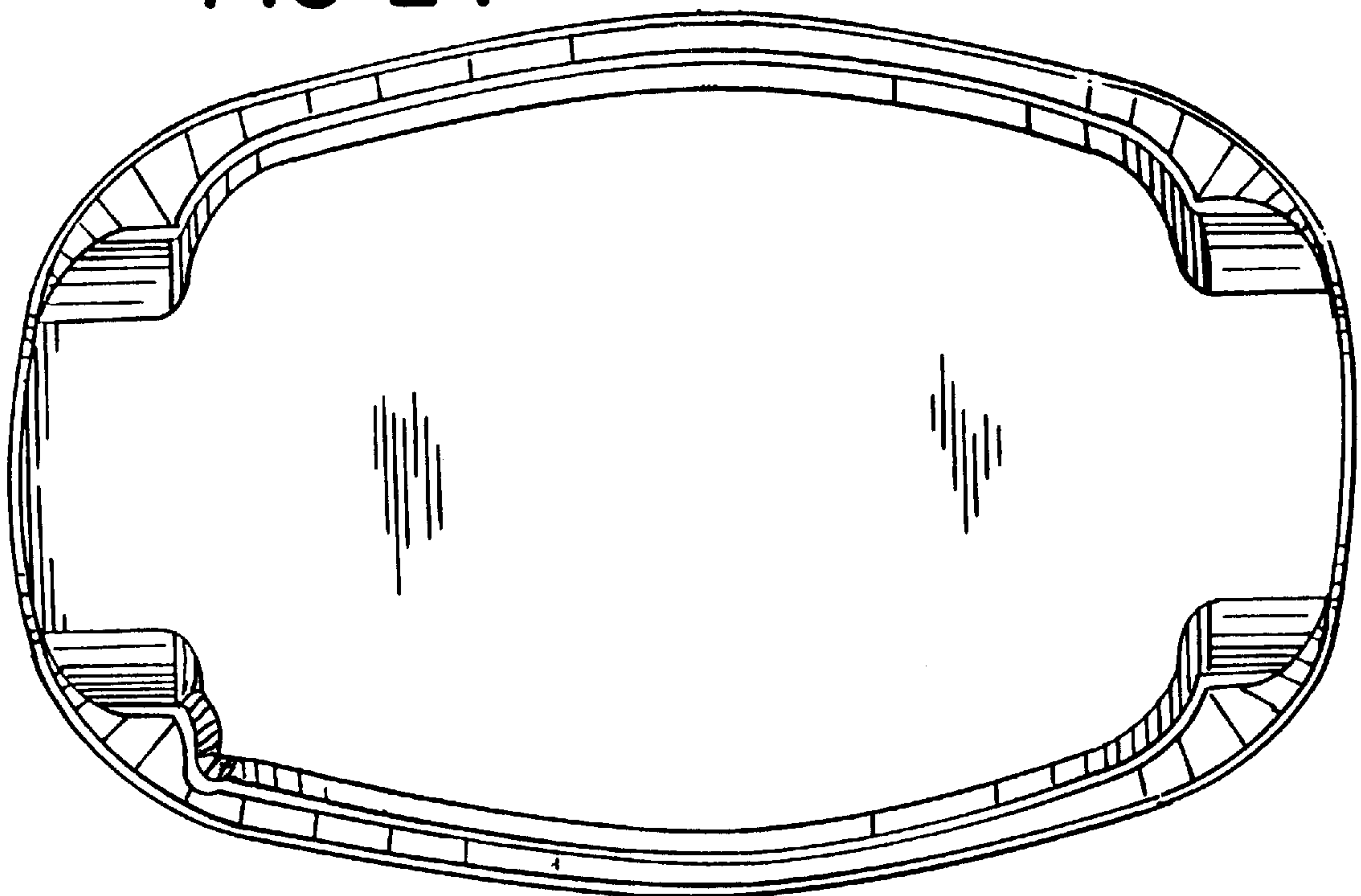

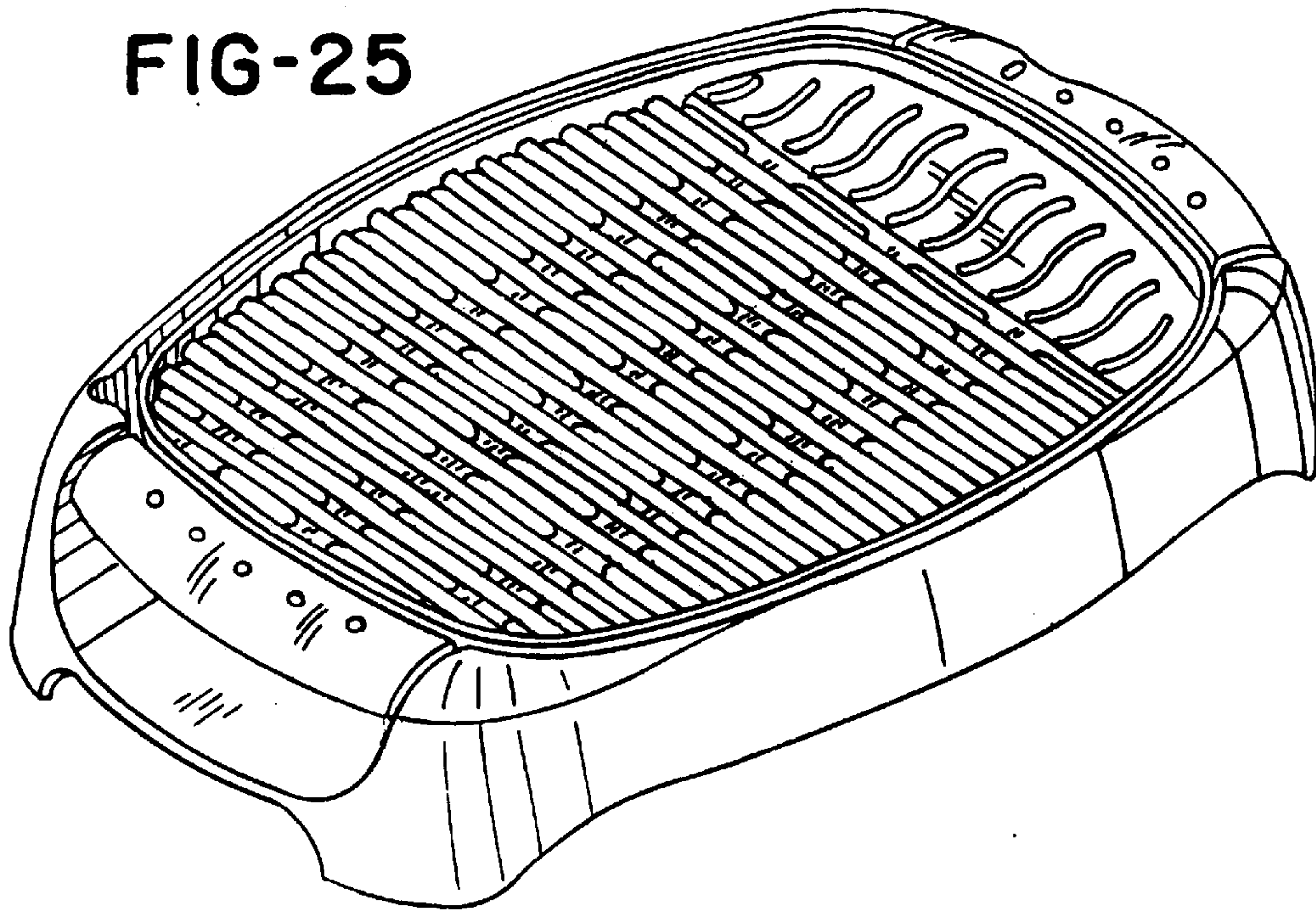

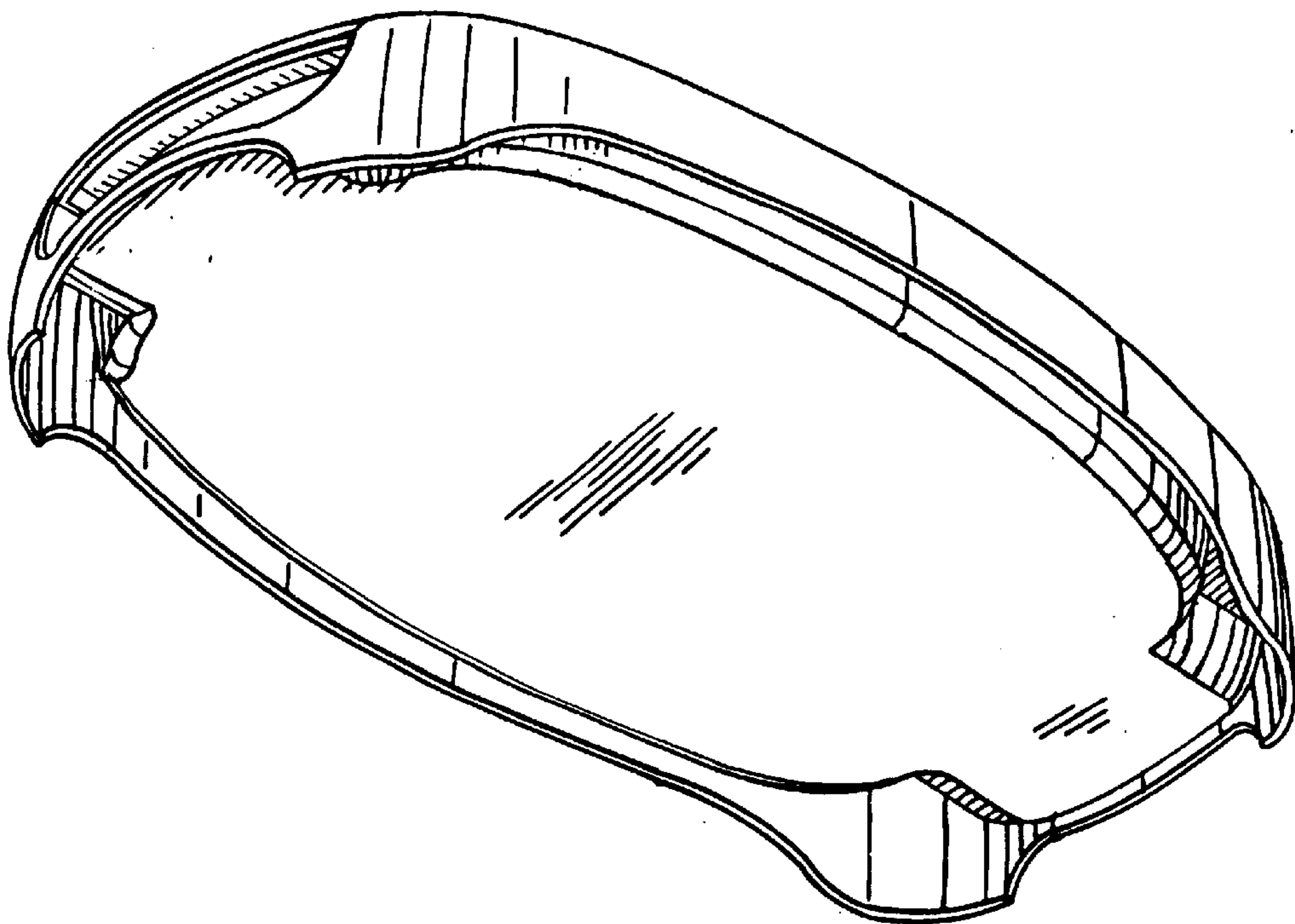

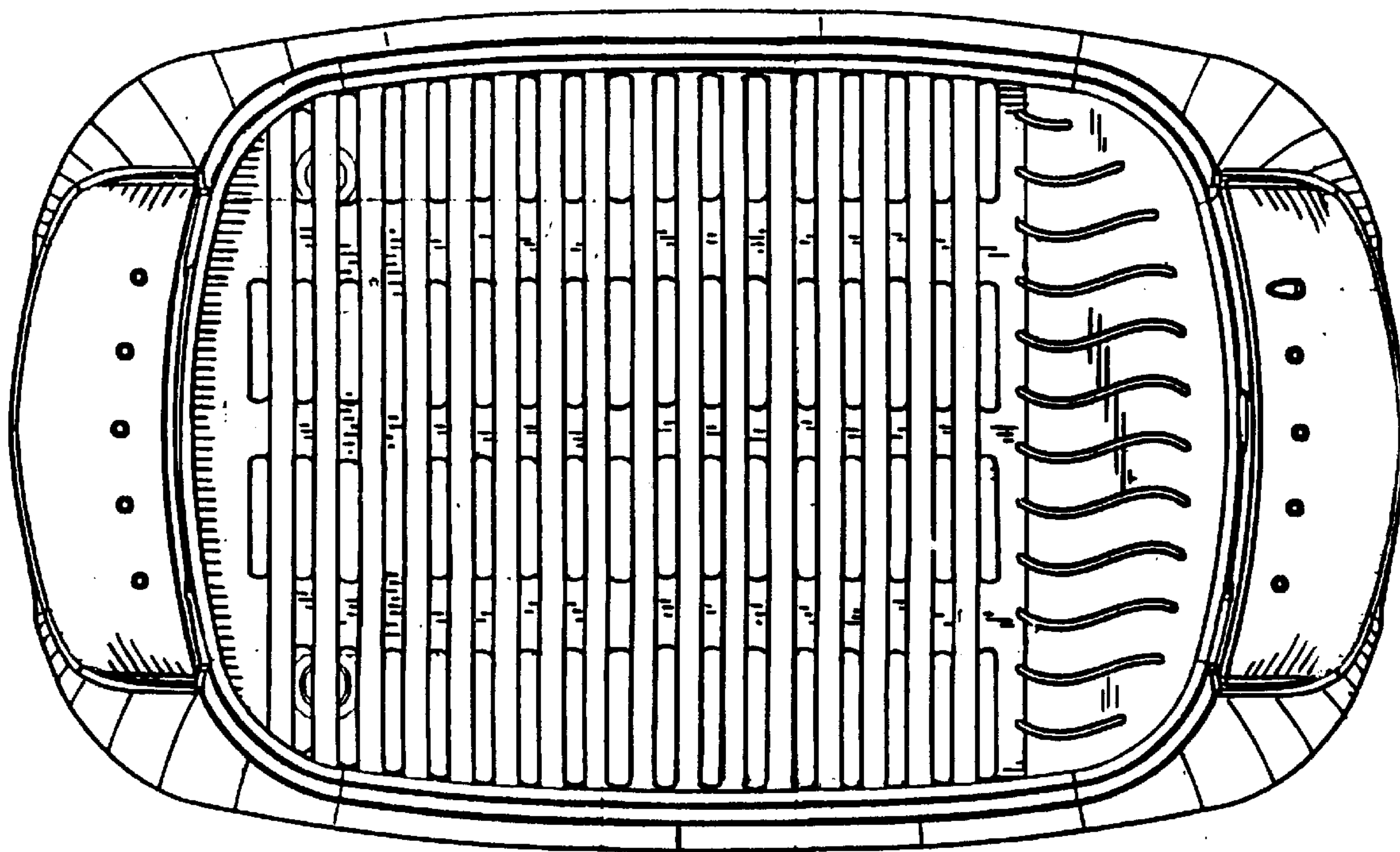

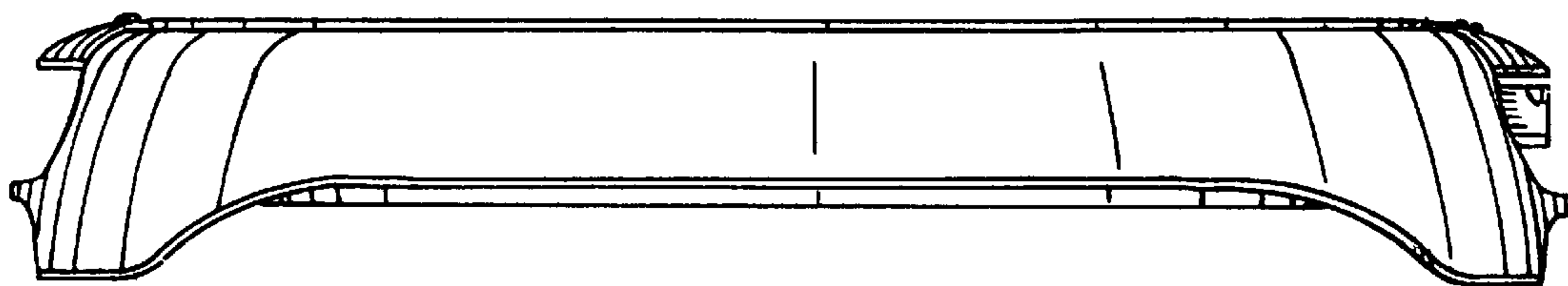

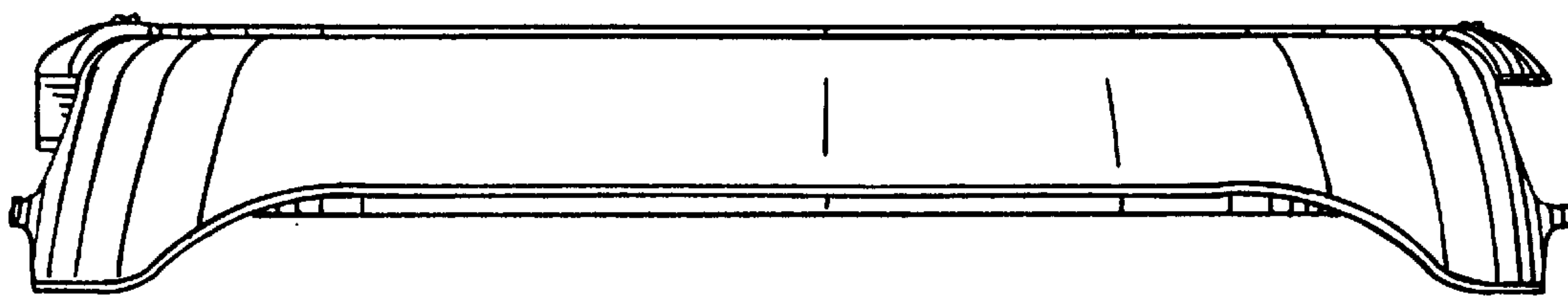

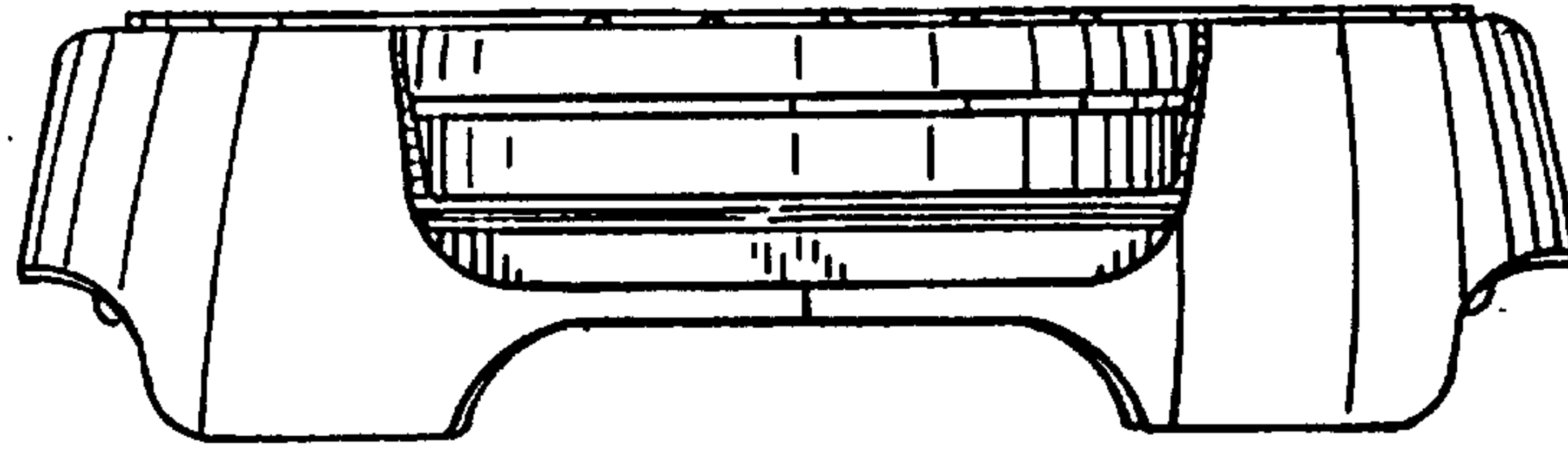

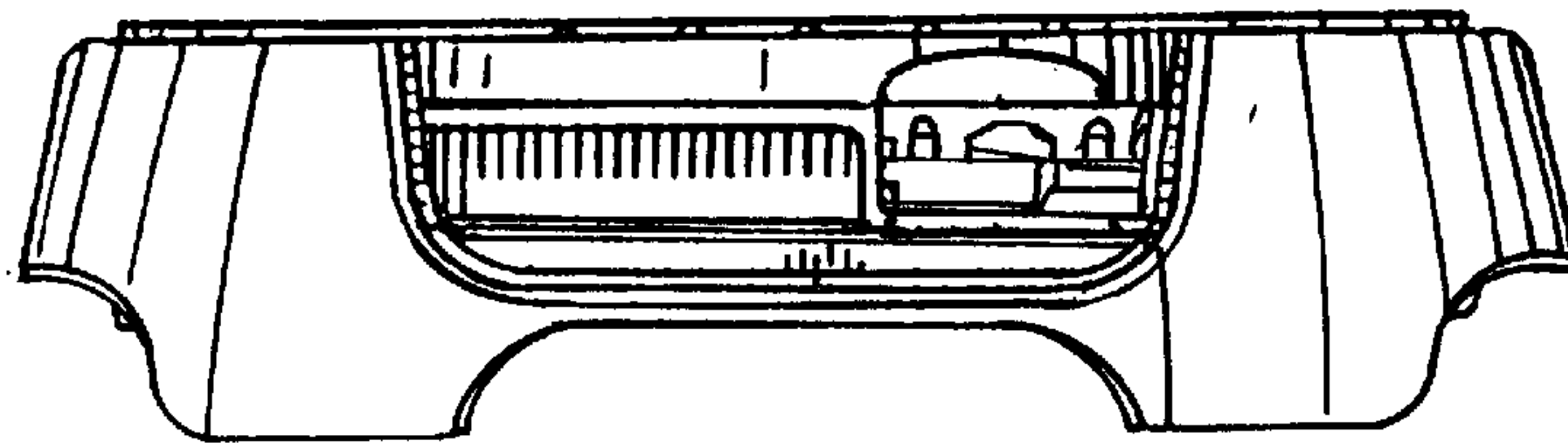

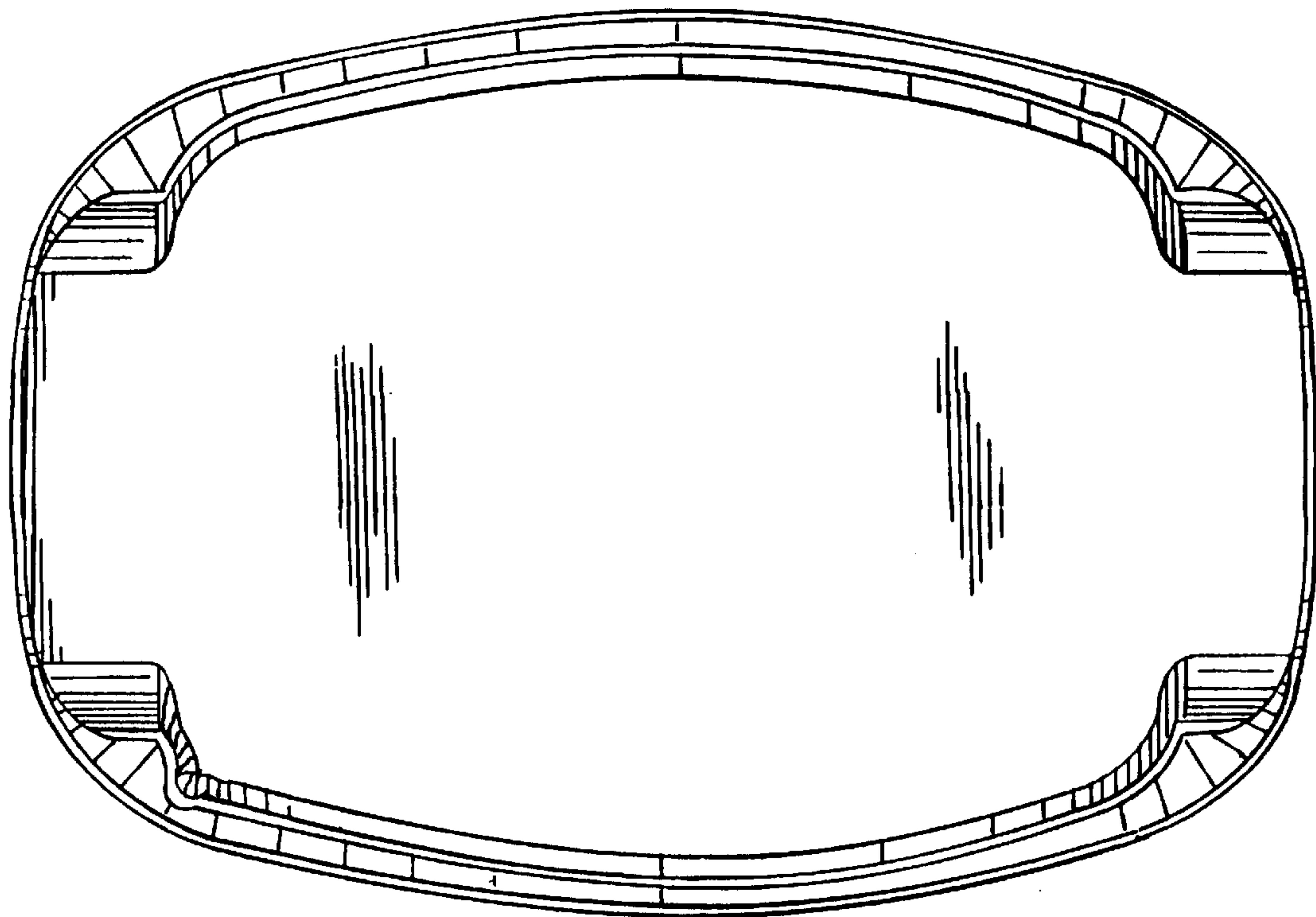

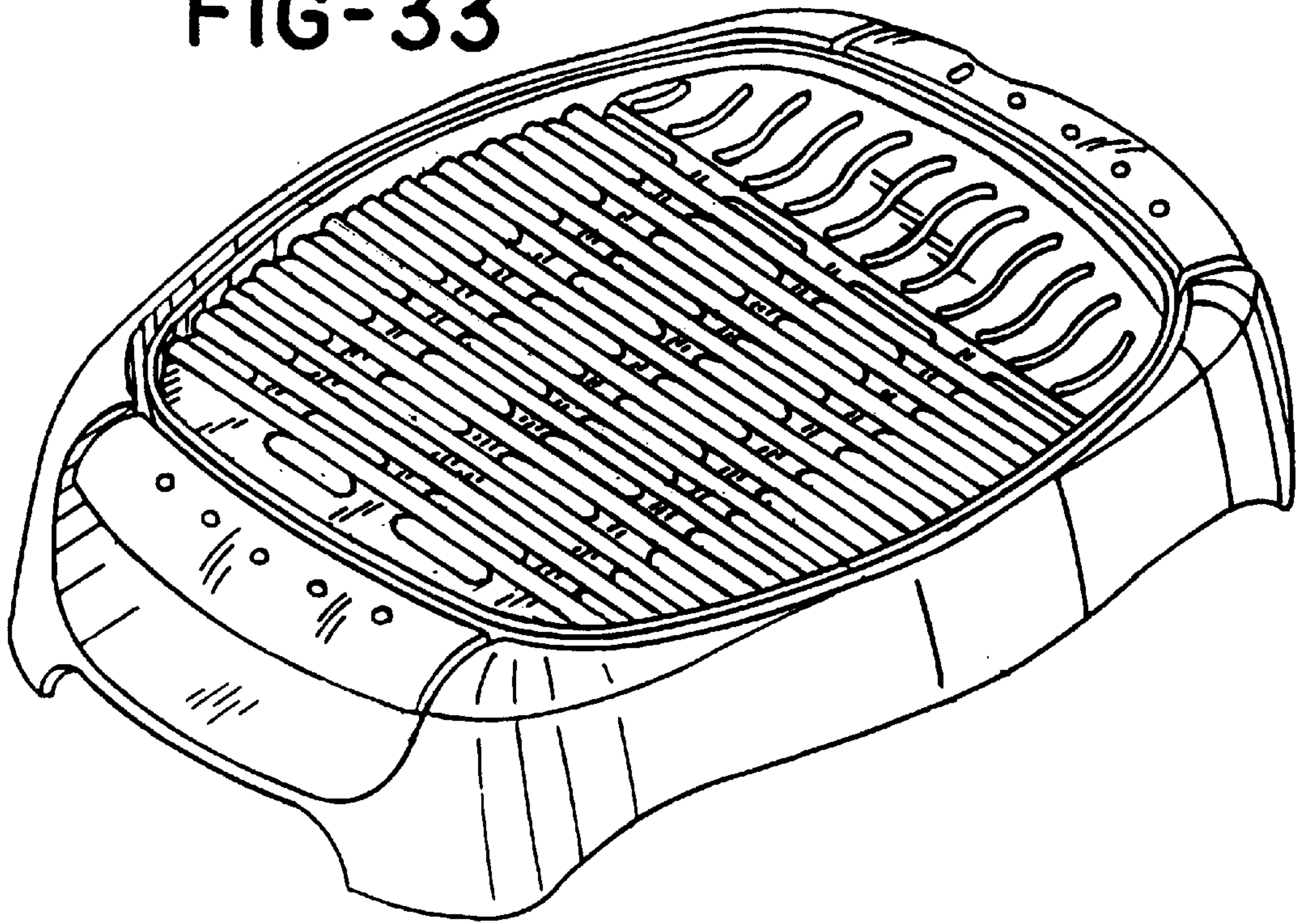

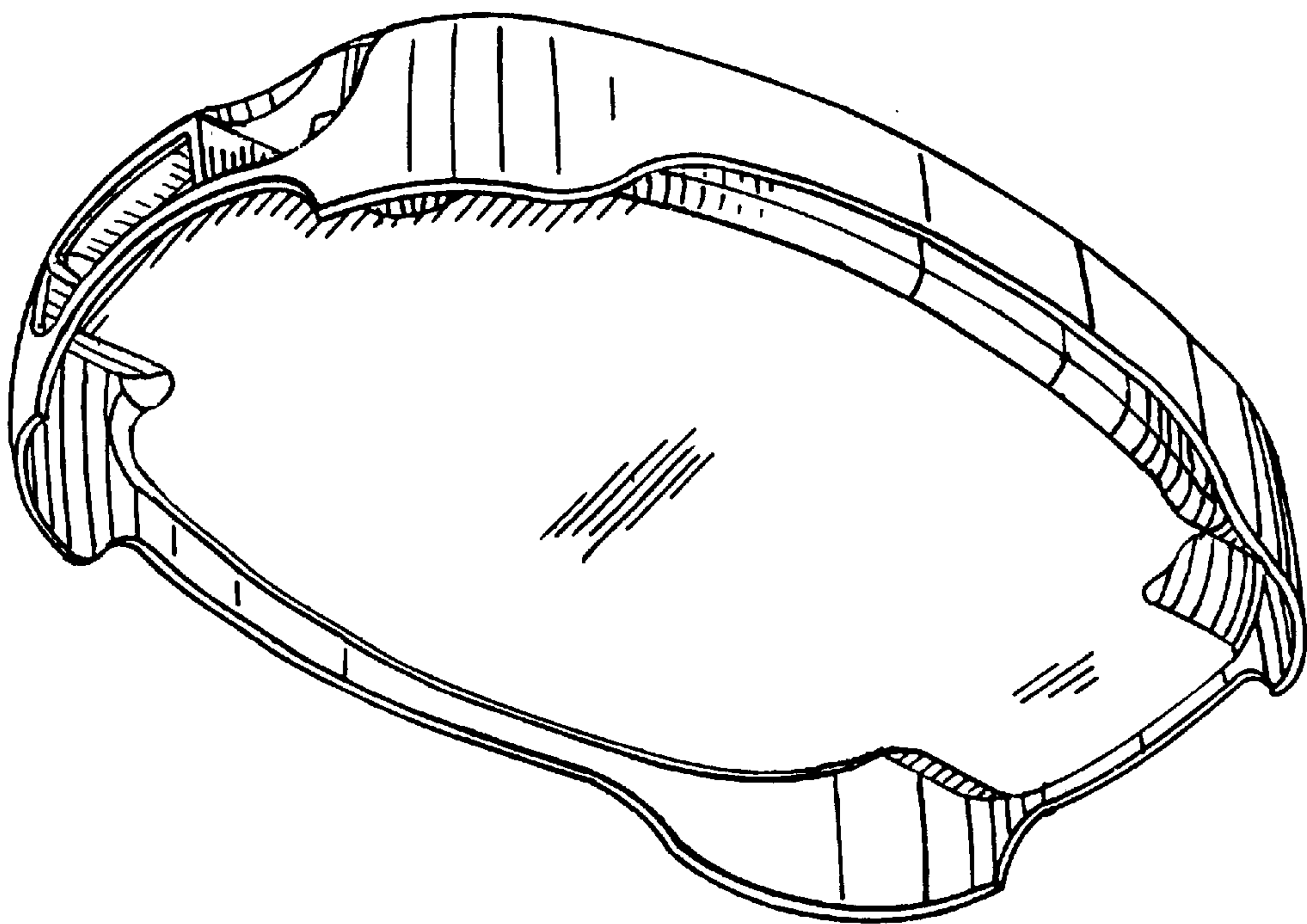

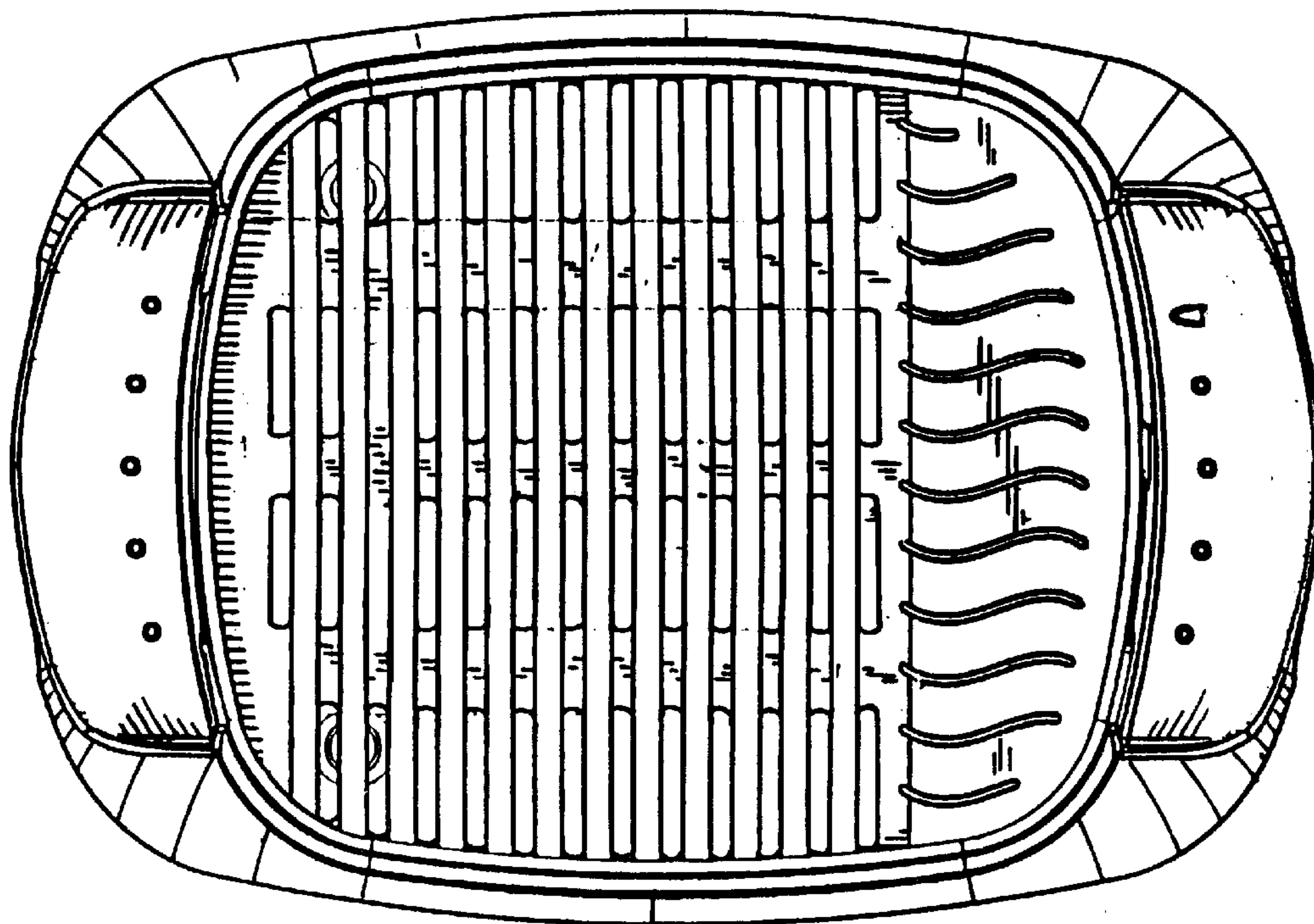

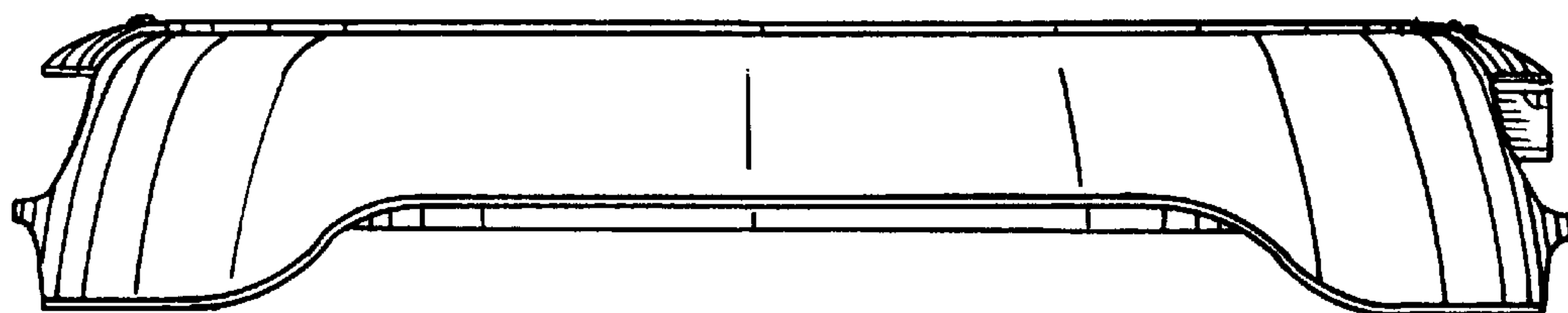

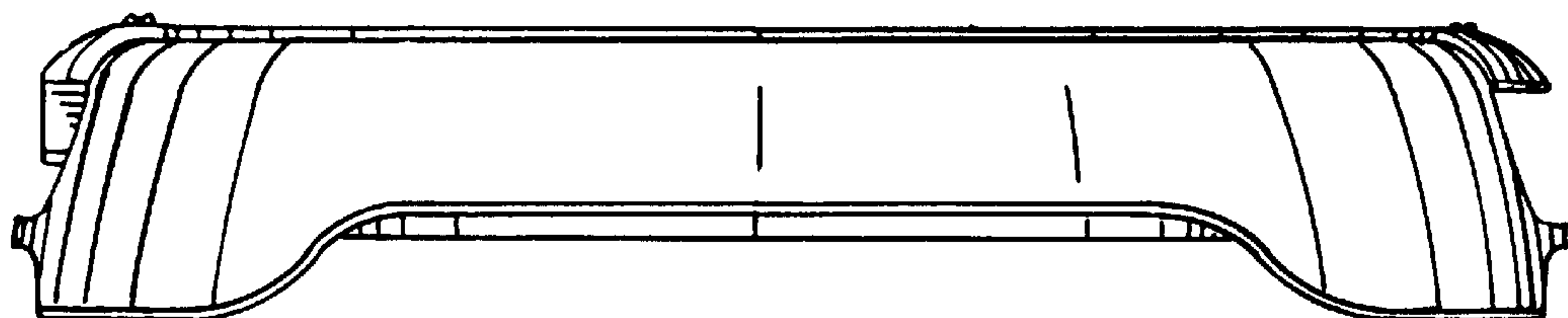

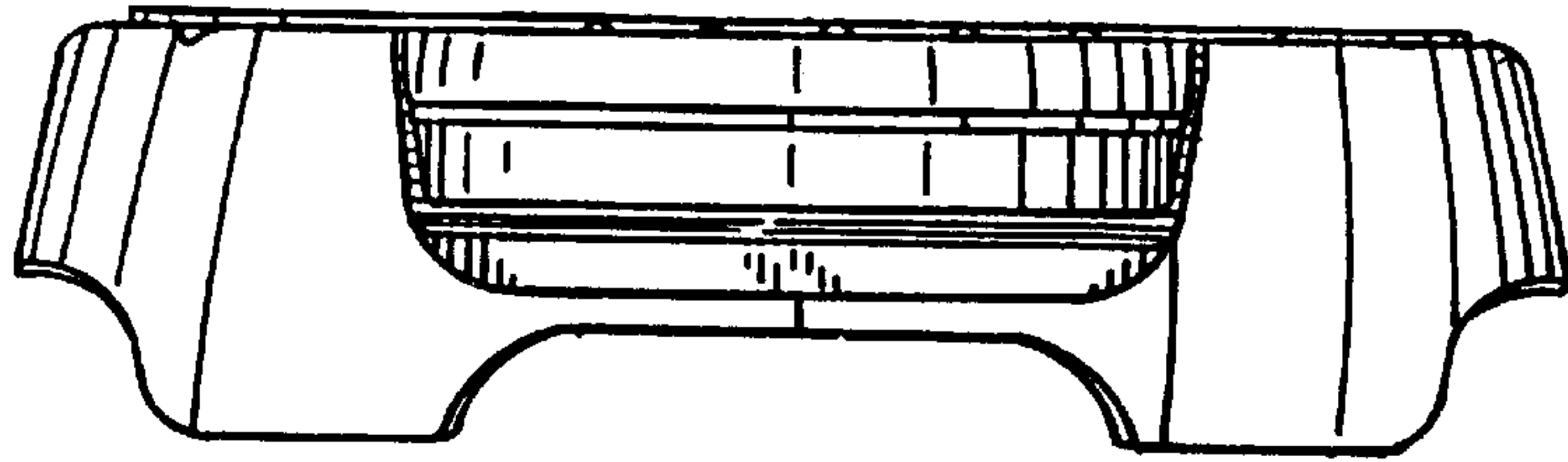

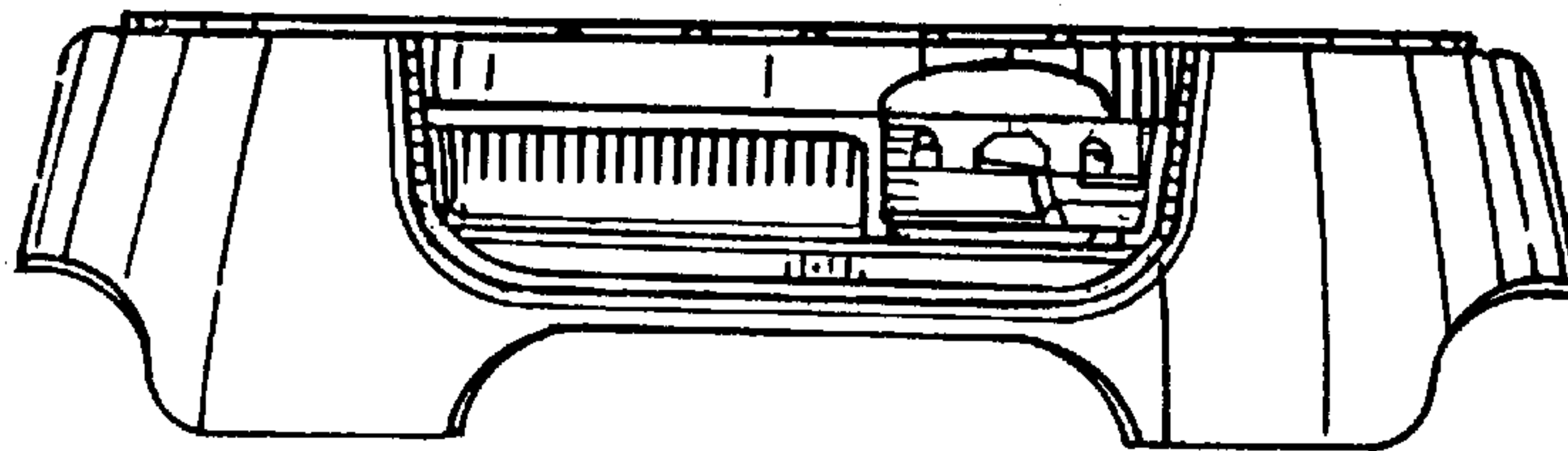
