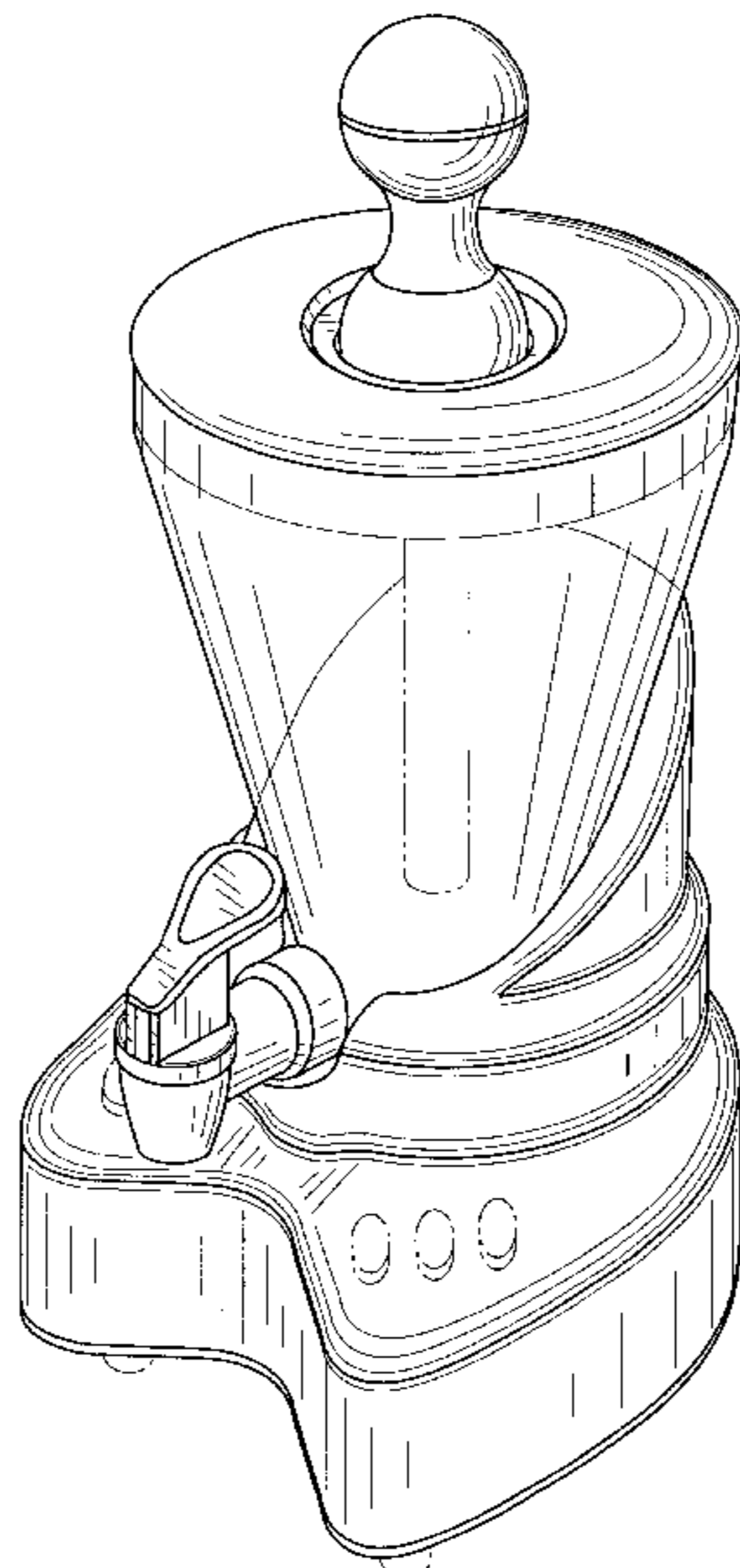
The ornamental design for a smoothie maker, as shown and described.

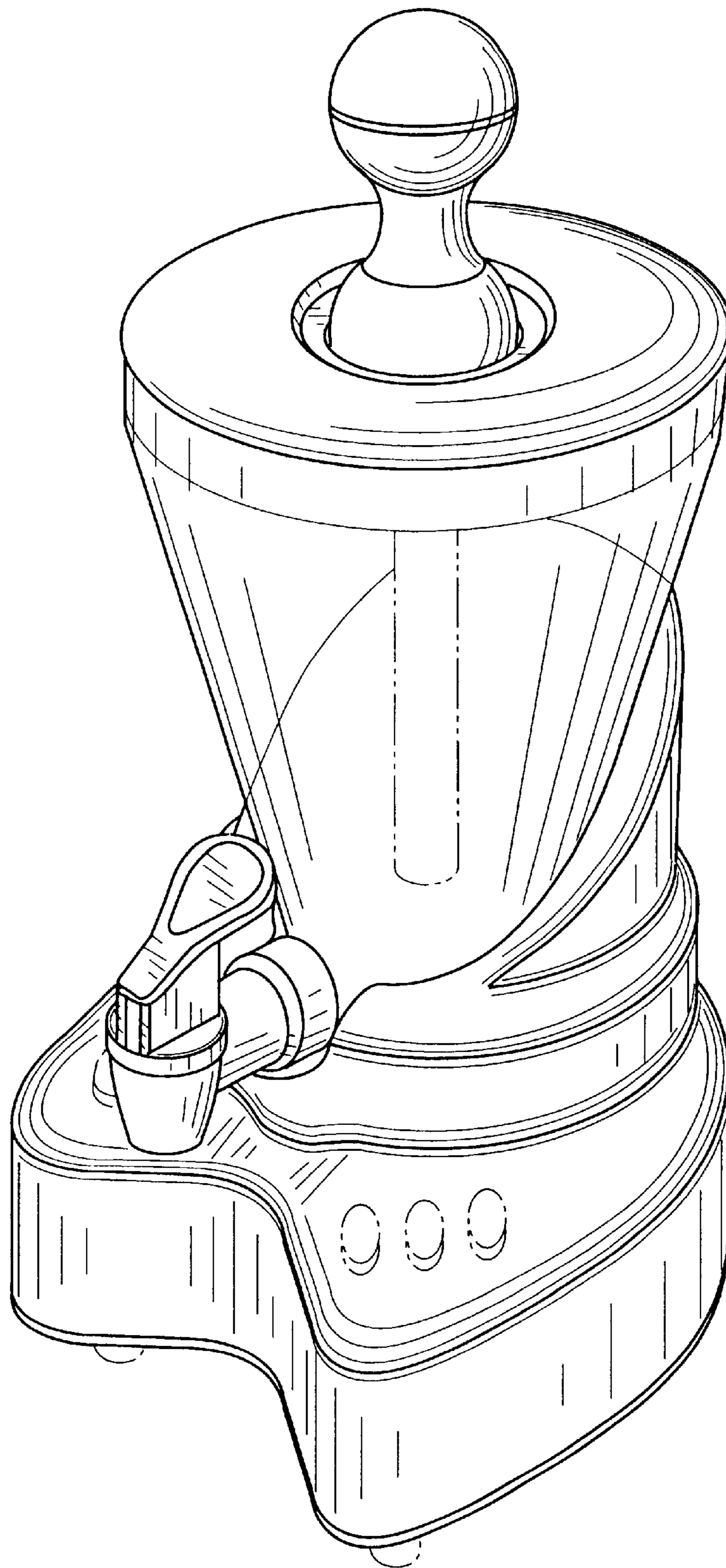
**DESCRIPTION**

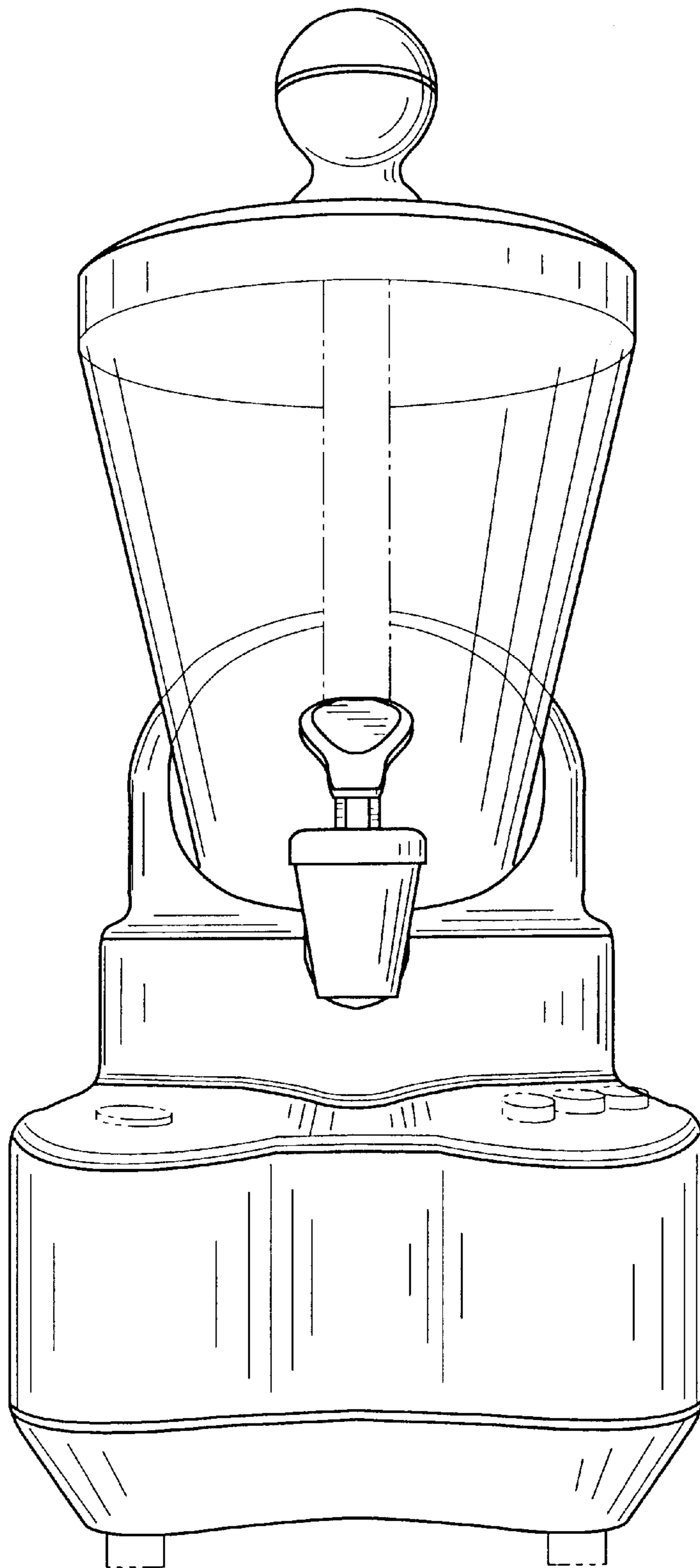
The broken lines shown in FIGS. 1-7 are for illustrative purposes only and form no part of the claimed design.

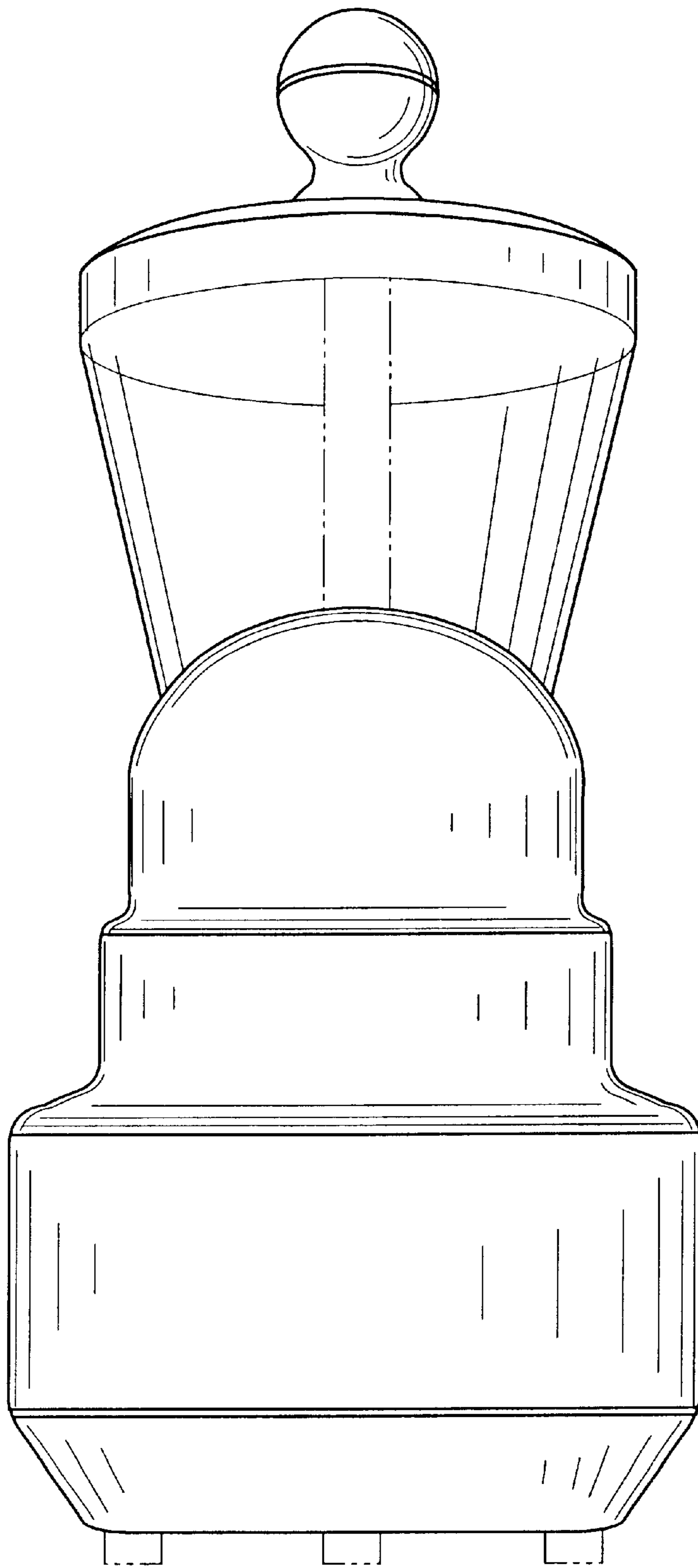




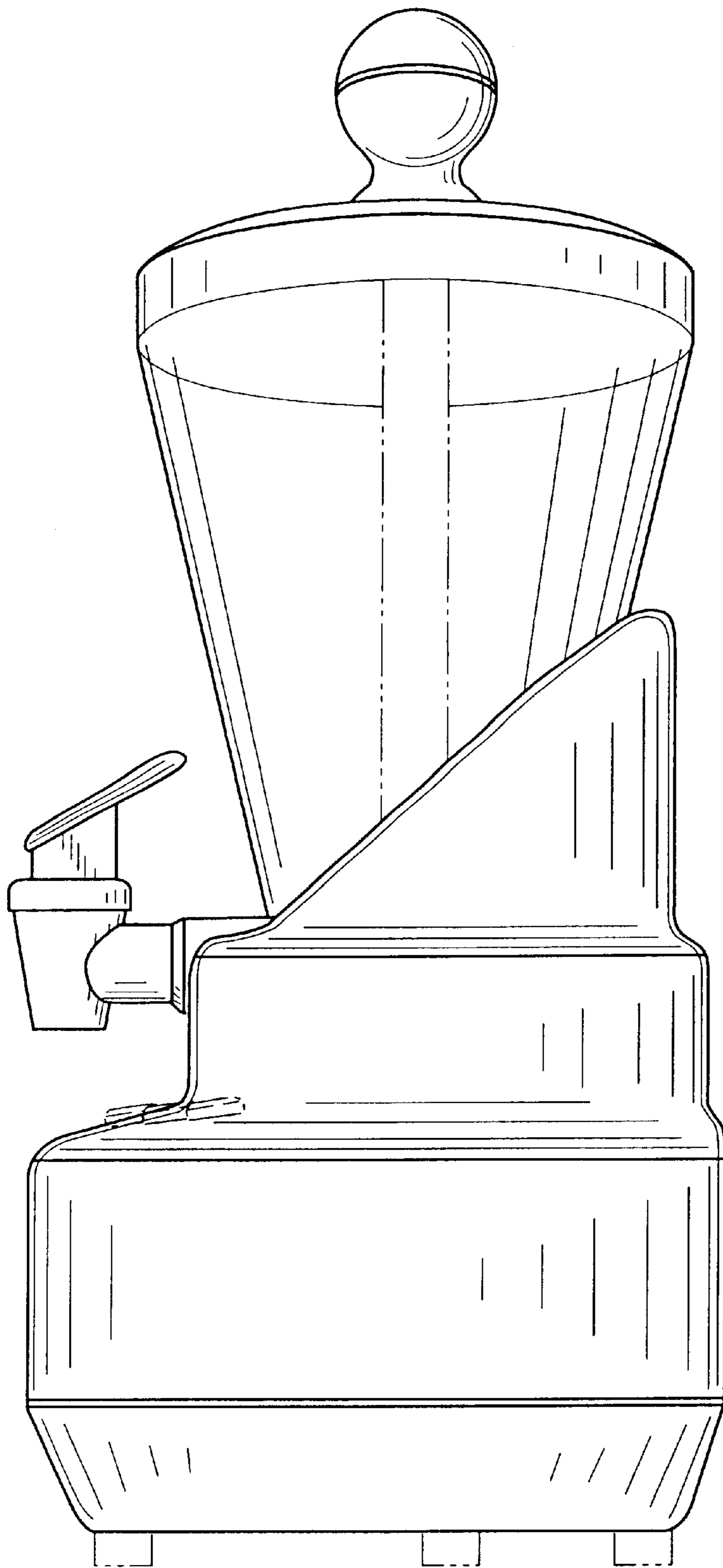

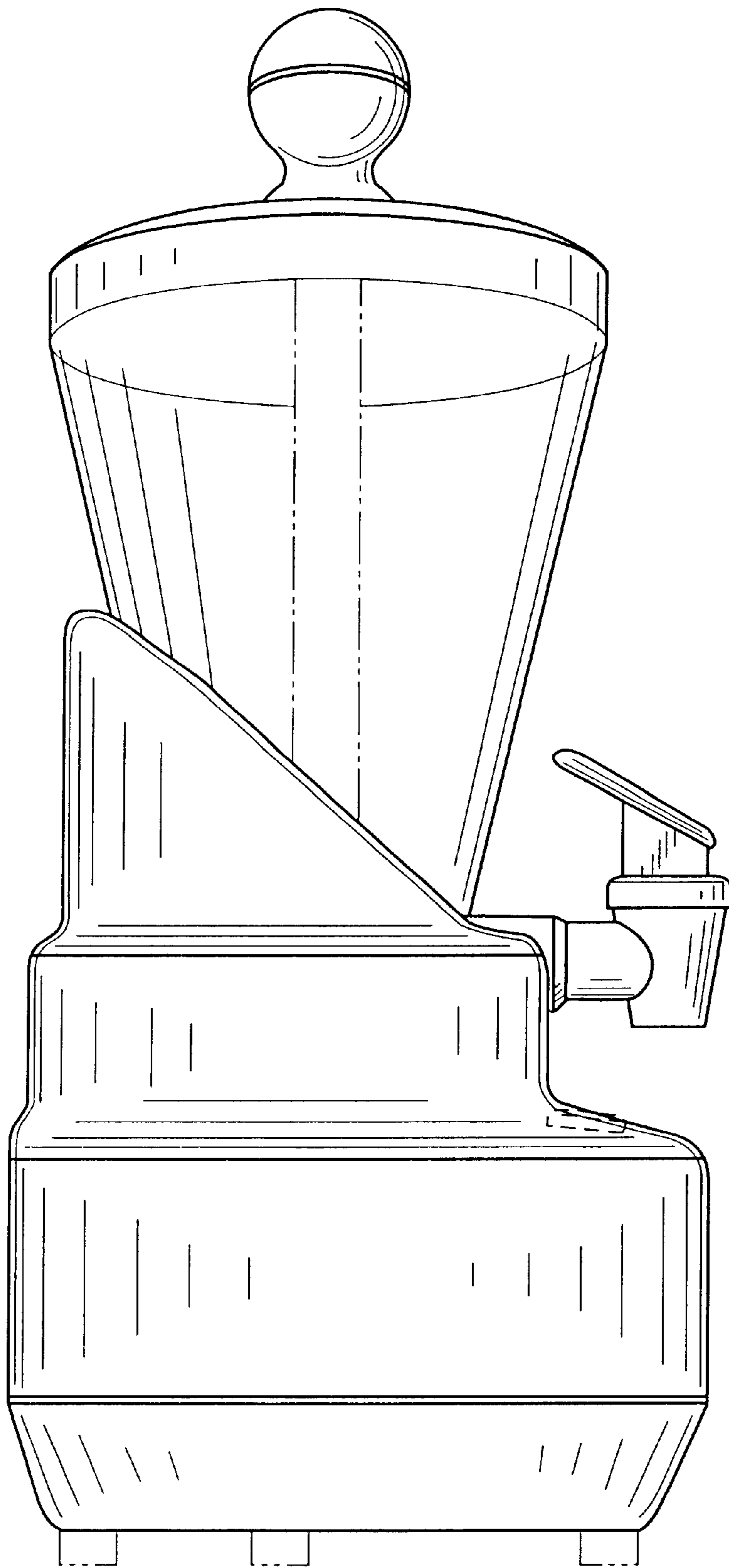

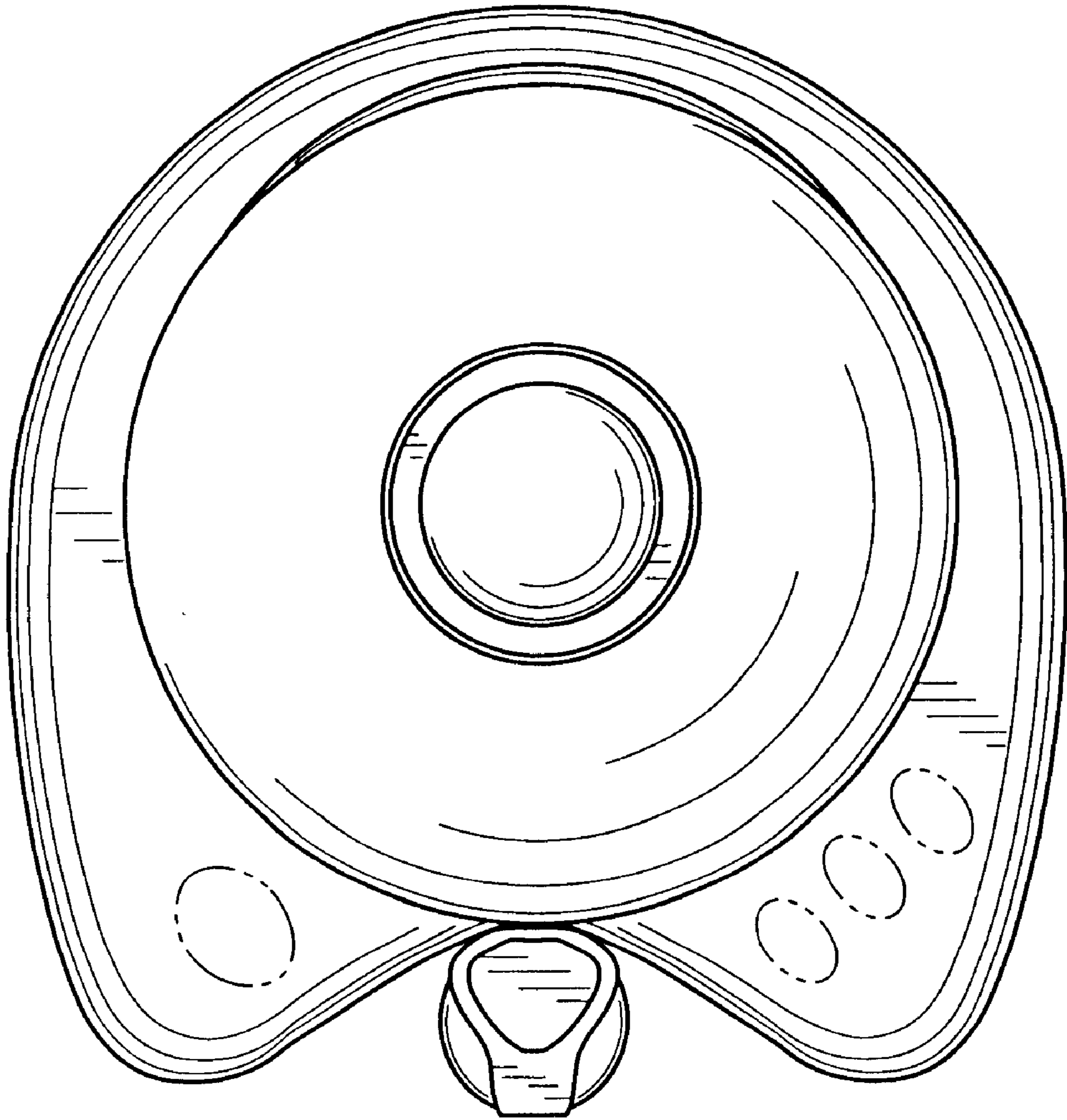

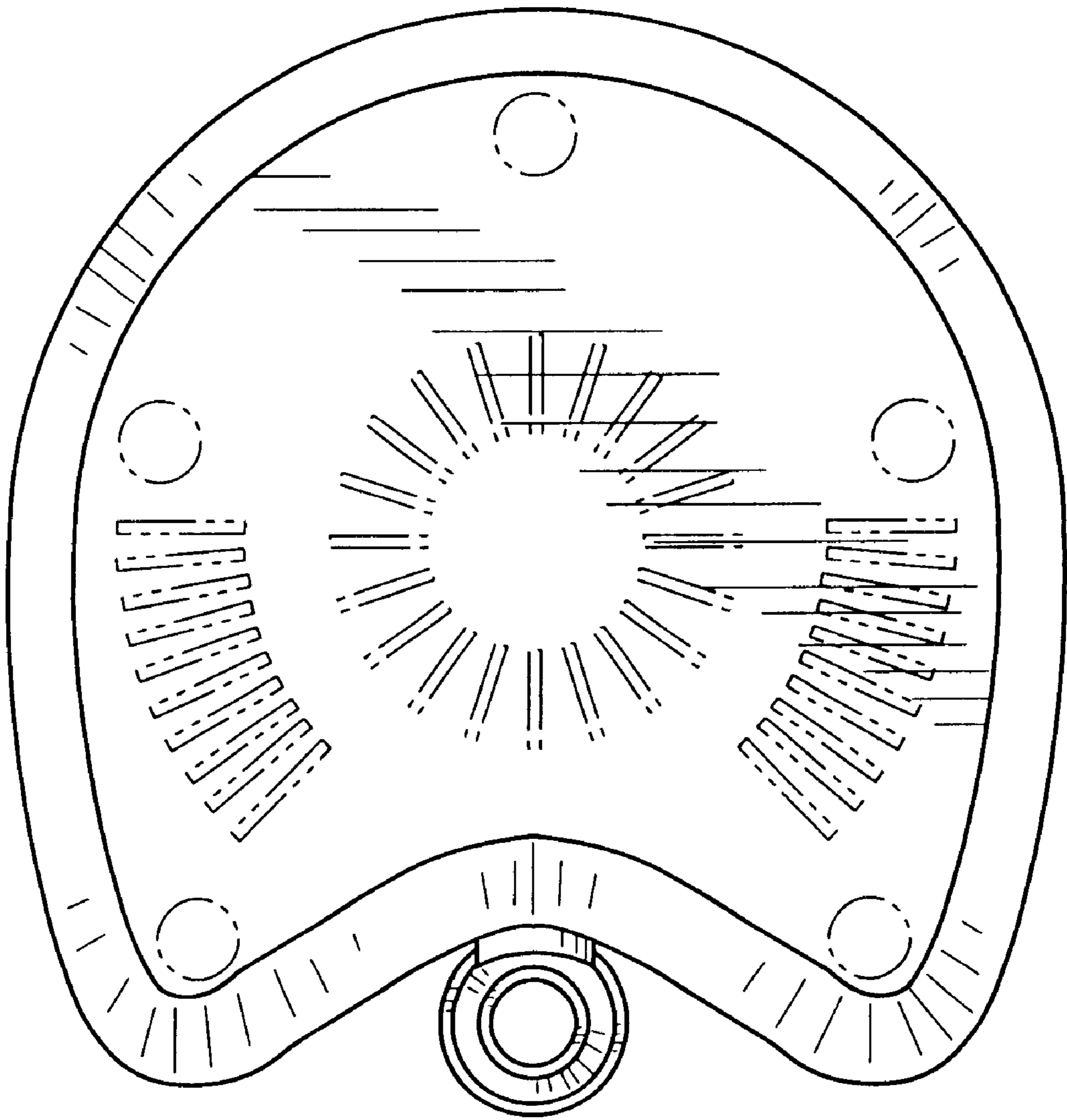
