**DESCRIPTION**

FIG. 1 is a perspective view of the front and one side of a wristwatch showing my new design;  
 FIG. 2 is a front view thereof;  
 FIG. 3 is a rear view thereof;  
 FIG. 4 is a side view of said one side thereof;  
 FIG. 5 is a side view of an opposite side thereof;  
 FIG. 6 is an end view of one end thereof; and,  
 FIG. 7 is an end view of an opposite end thereof.

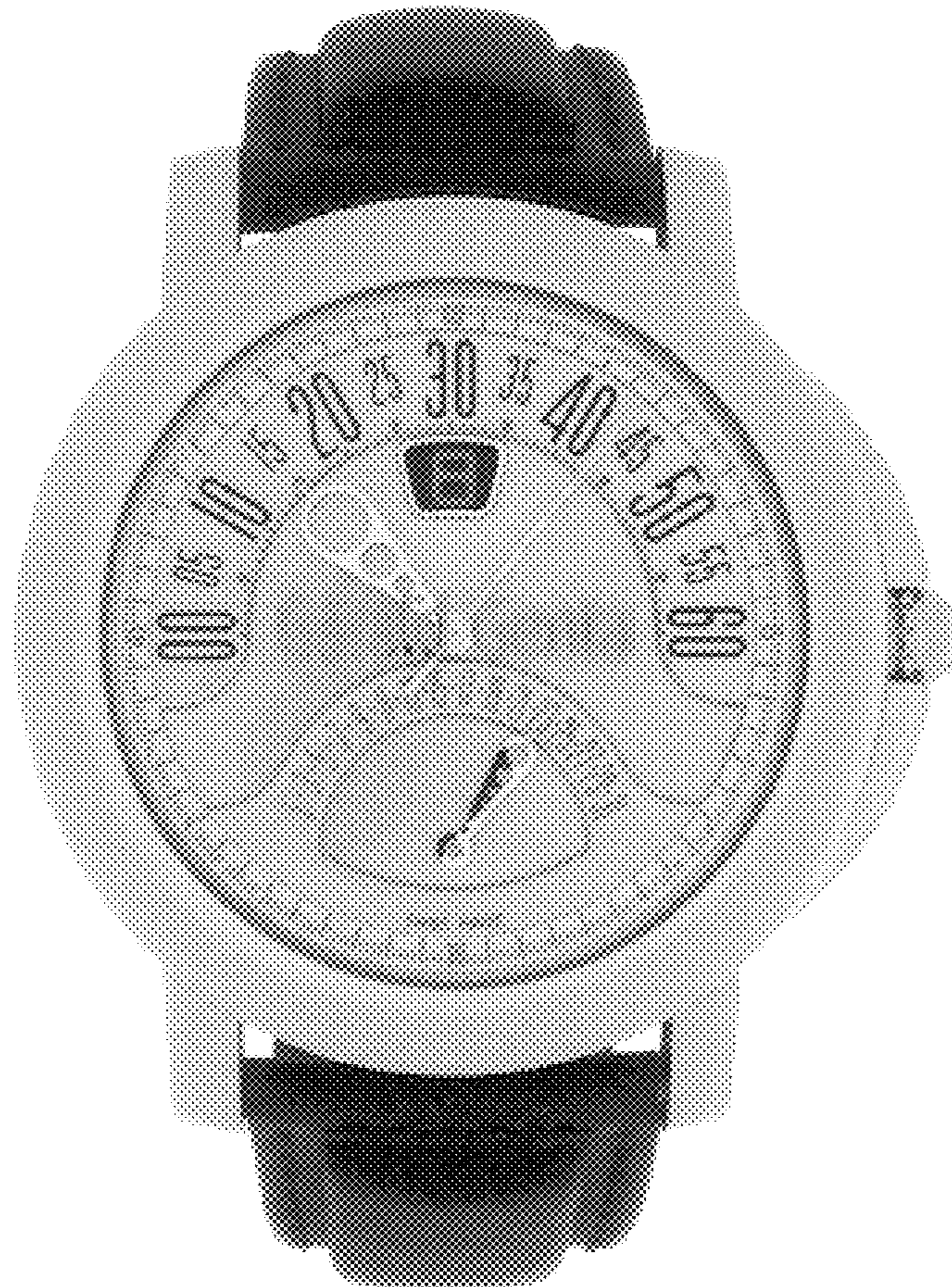

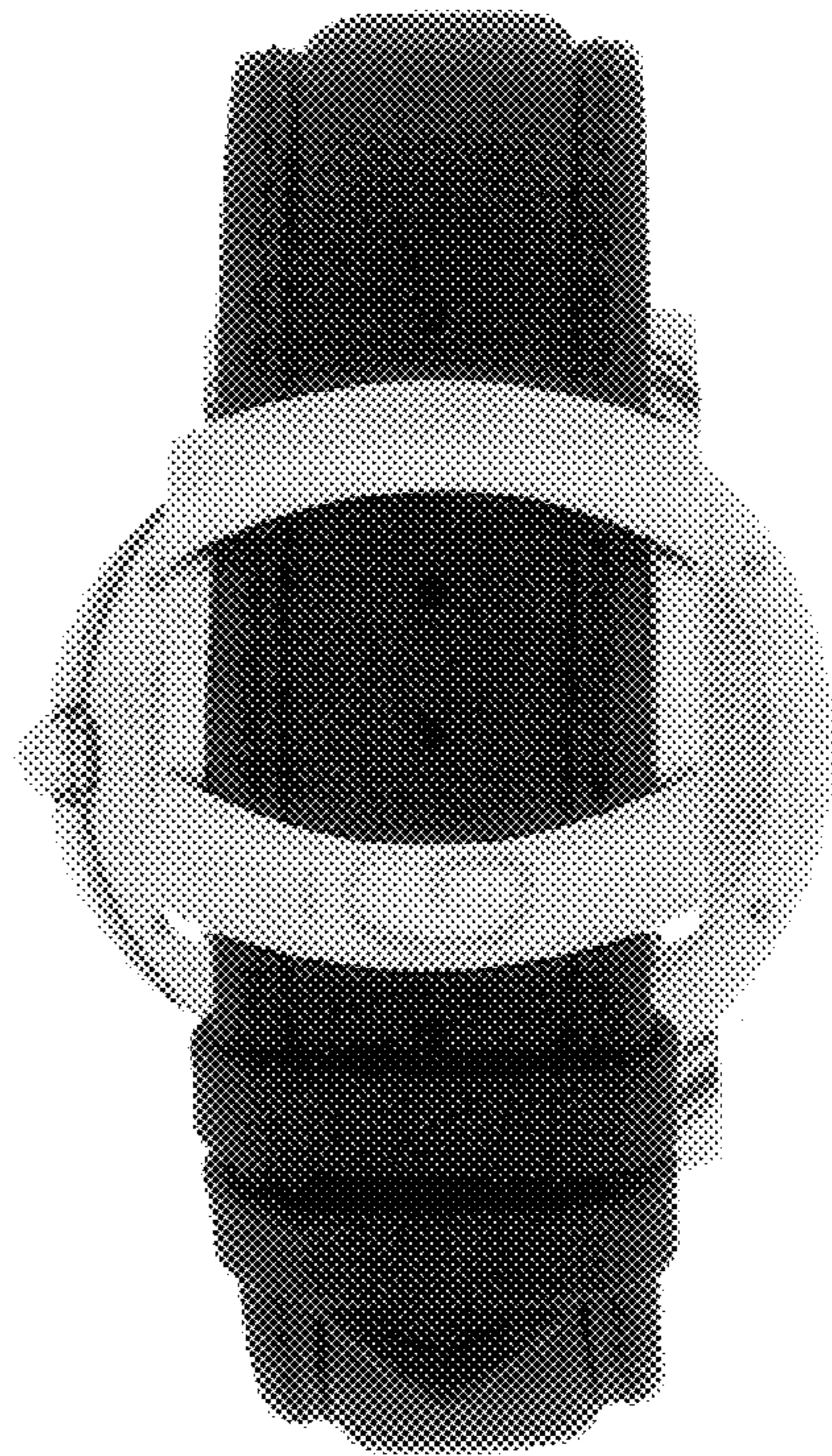

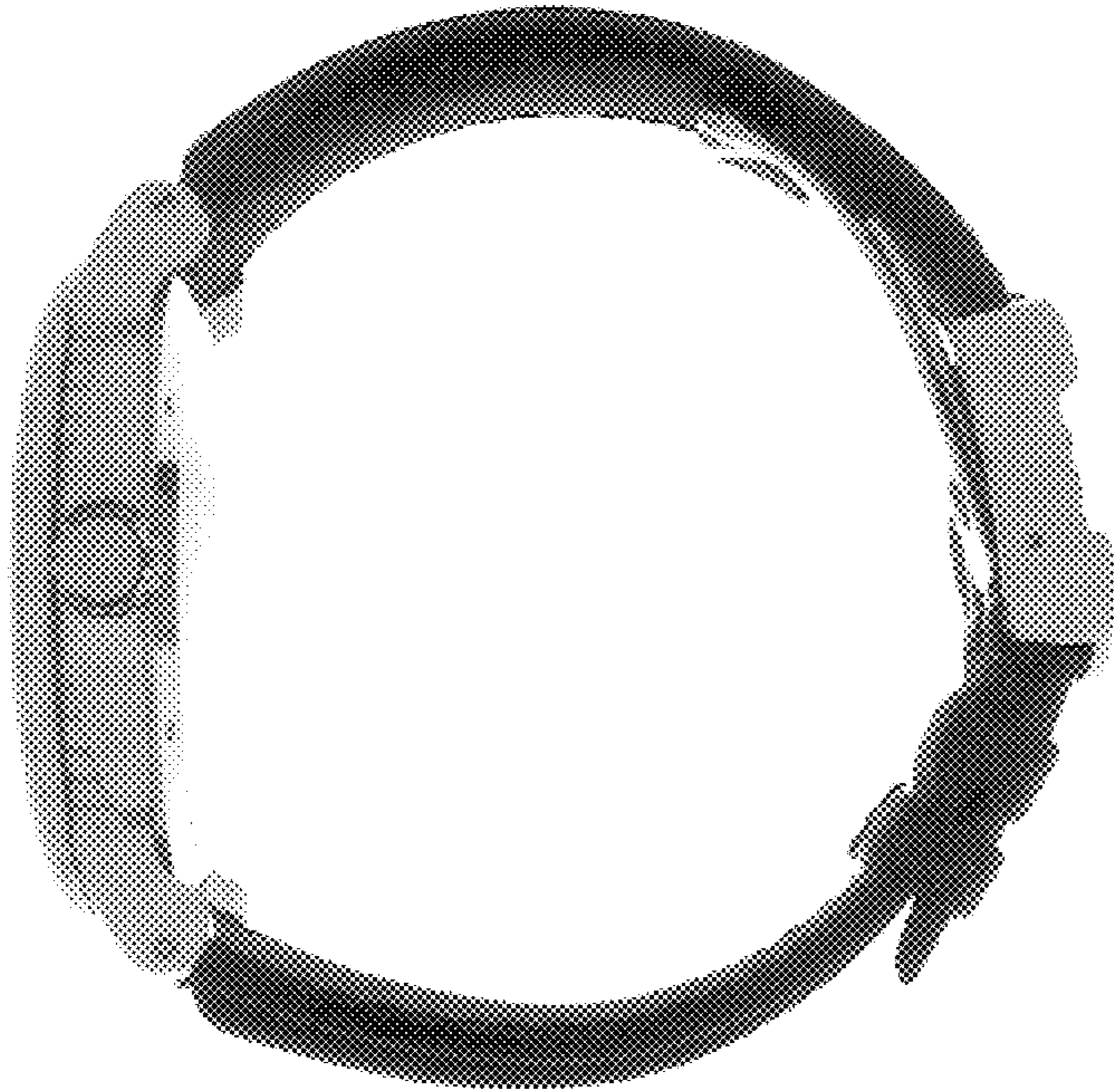

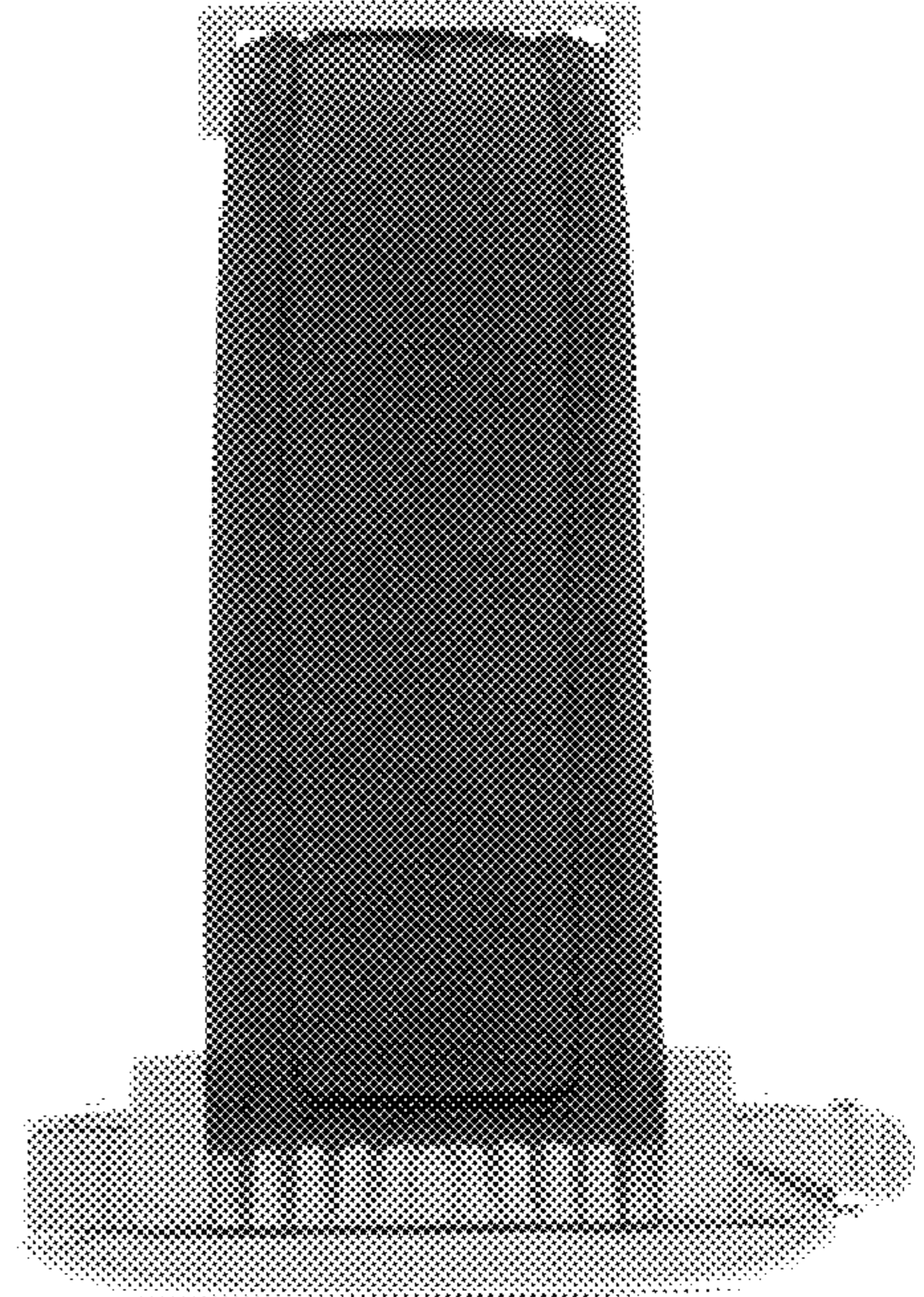

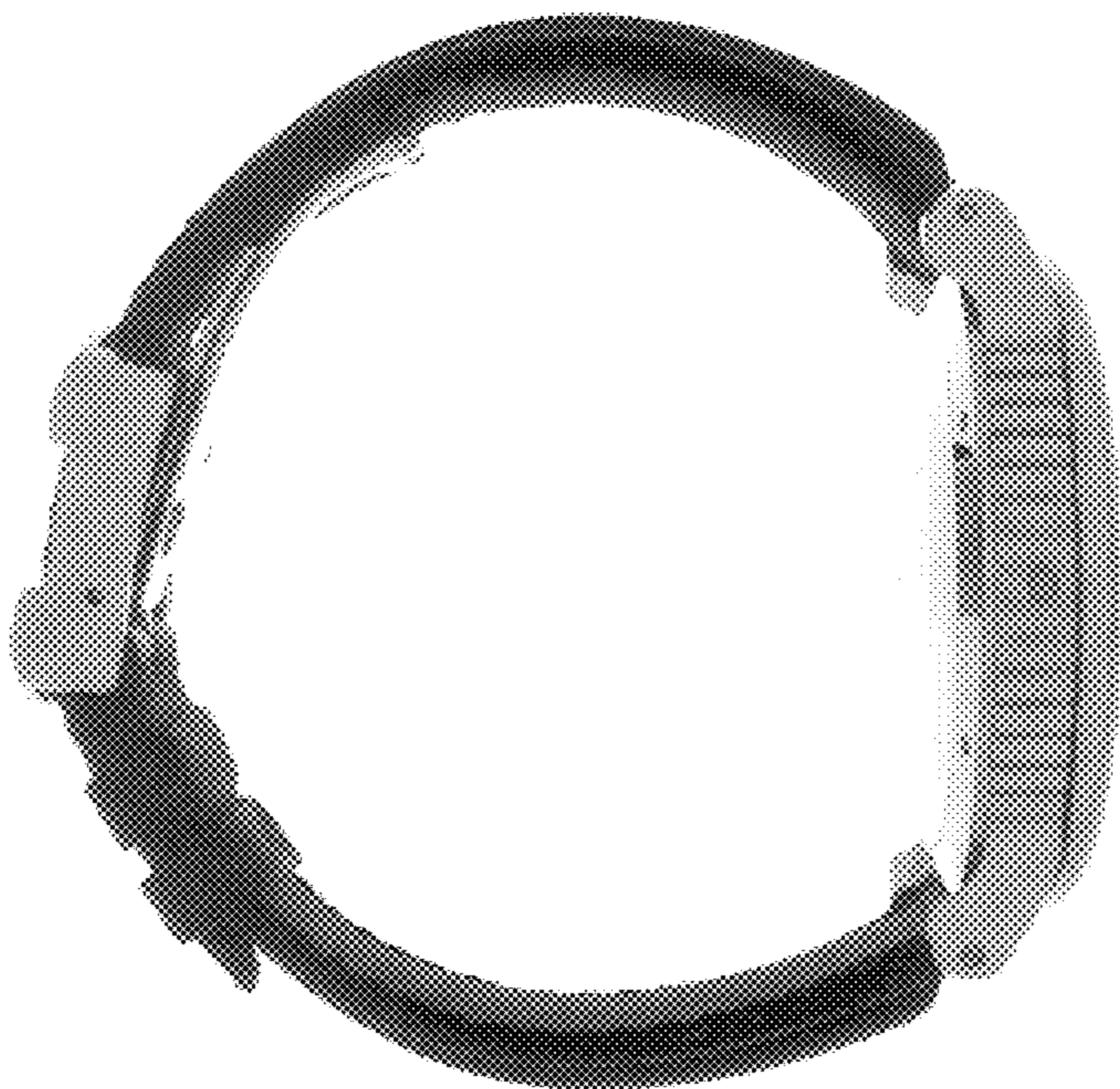
