(57) **CLAIM**

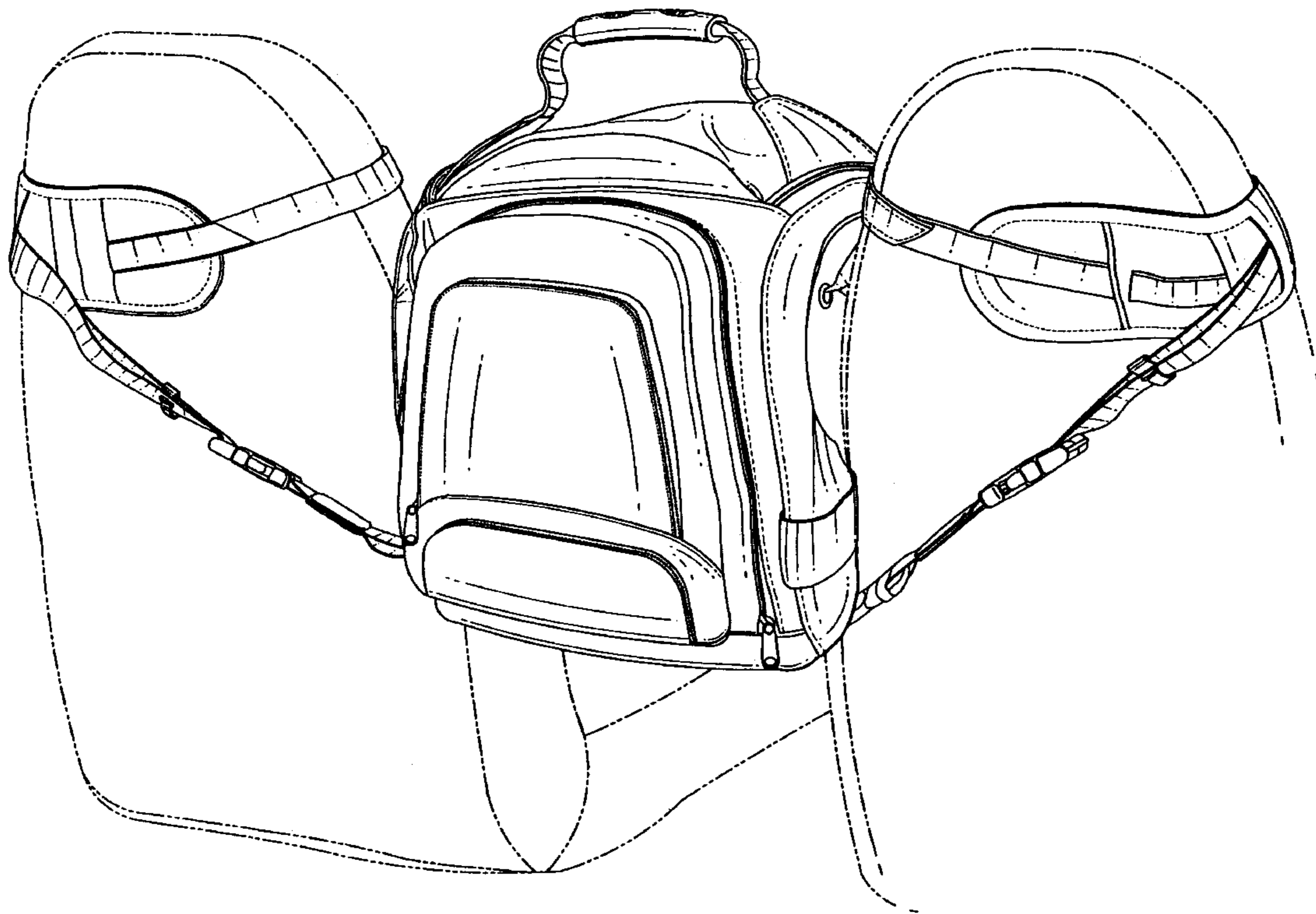
The ornamental design for an equipment carrying case, as shown and described.

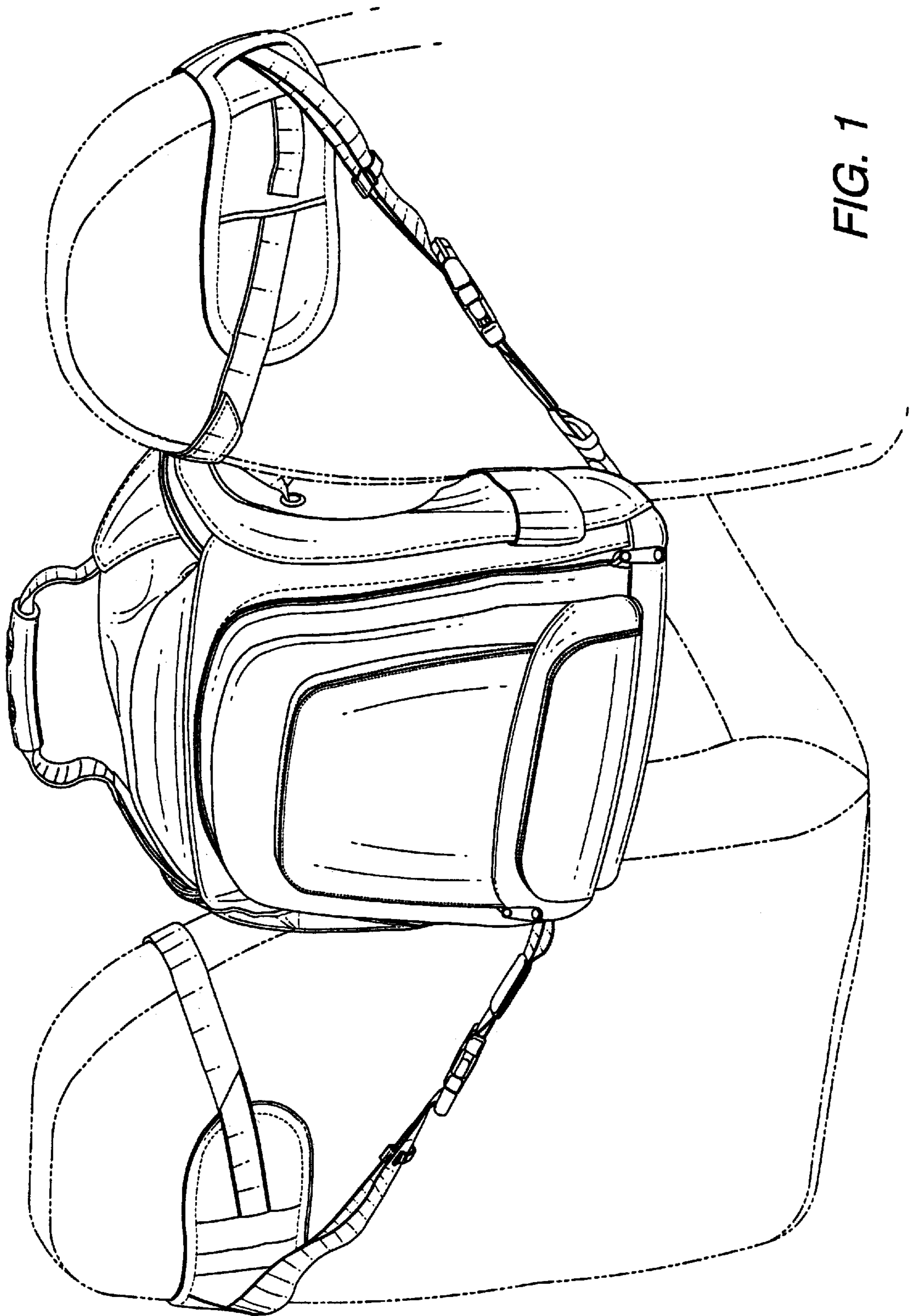

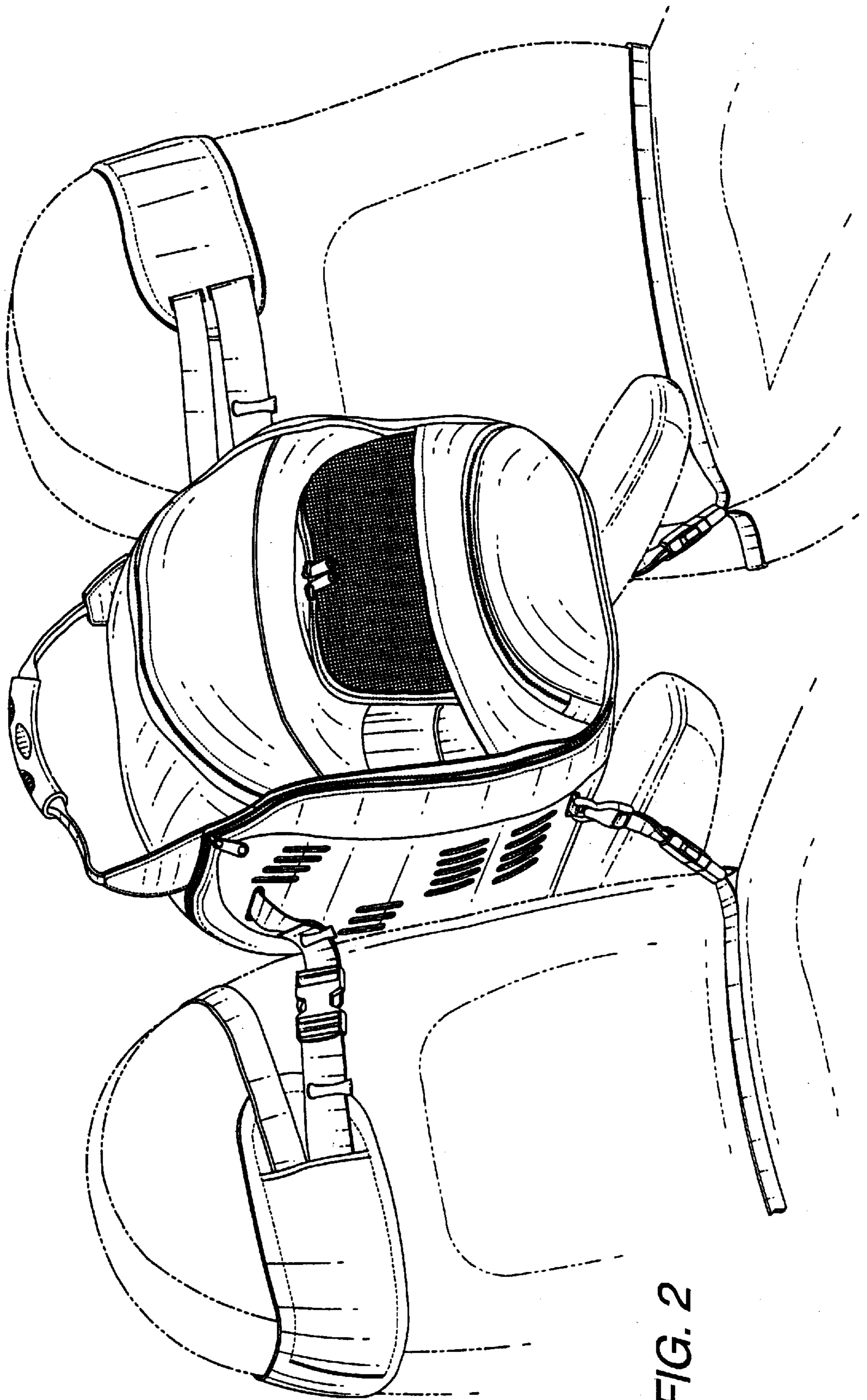

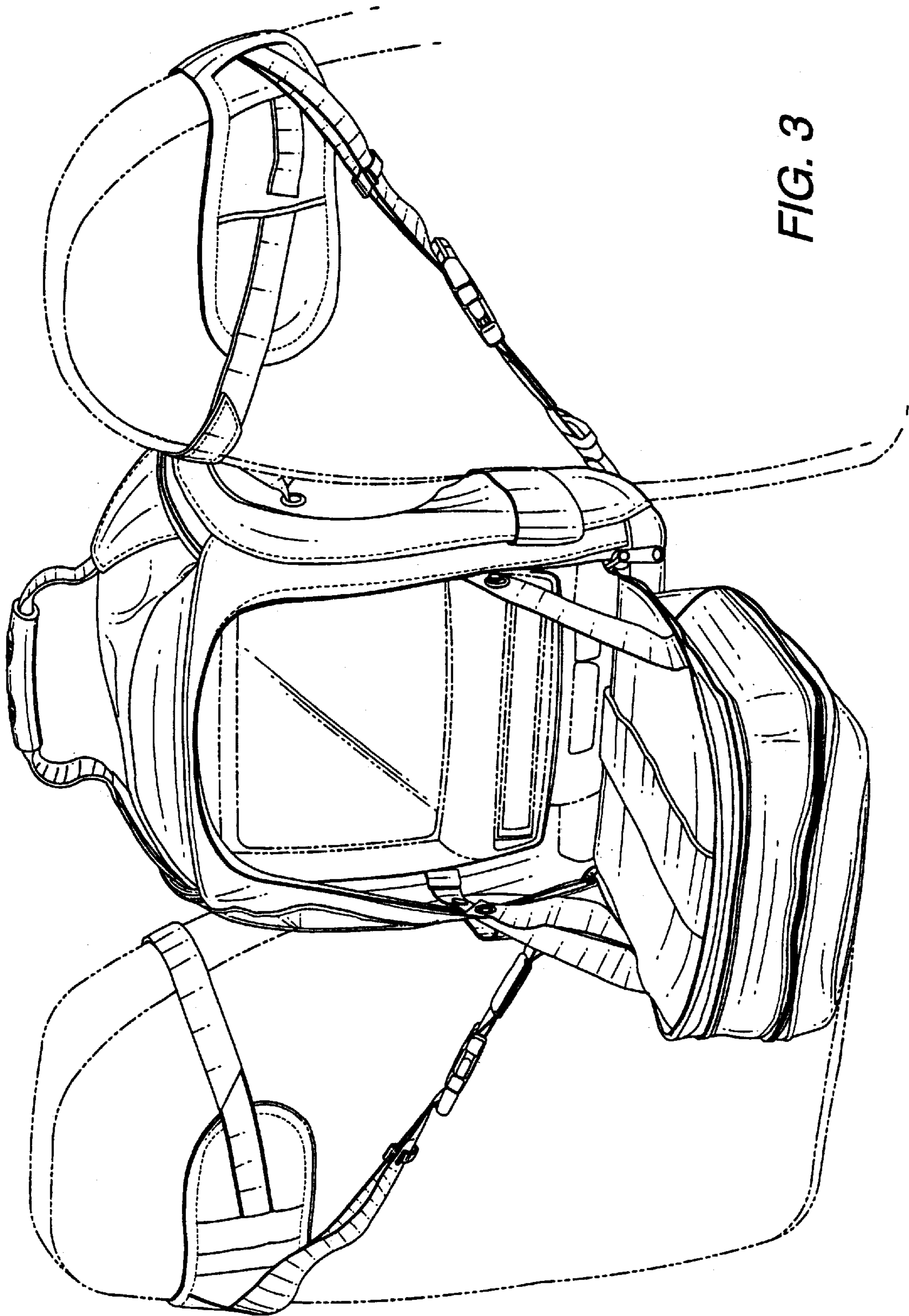
