(57) **CLAIM**

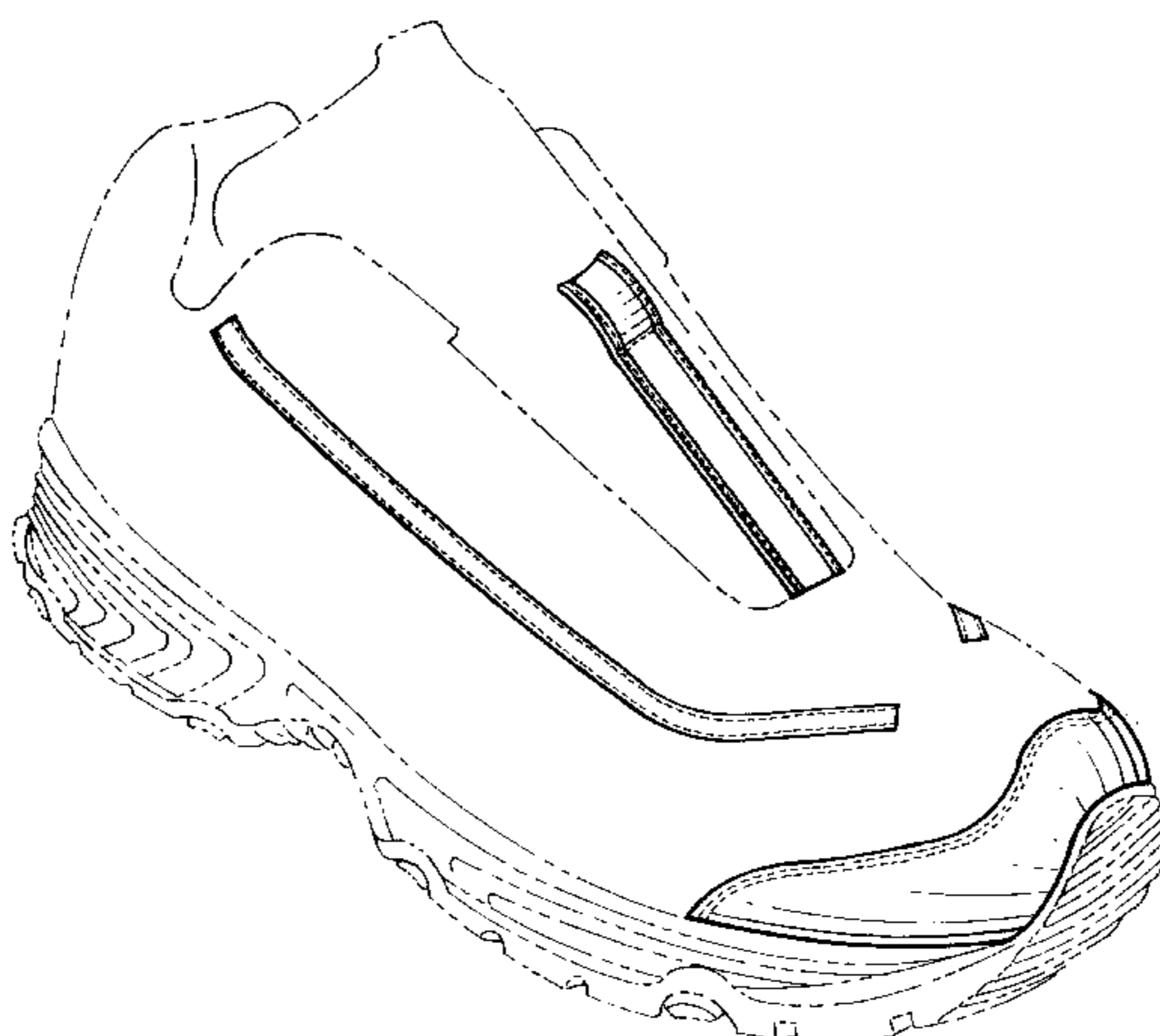
The ornamental design for a portion of a shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the front, left and top of a shoe upper showing my new design; FIG. 2 is a top plain elevational view thereof; FIG. 3 is a left side view thereof; FIG. 4 is a right side elevational view thereof; and, FIG. 5 is a front elevational view thereof.

The broken line showing the sole in the figures is for illustrative purposes only and forms no part of the claimed design.

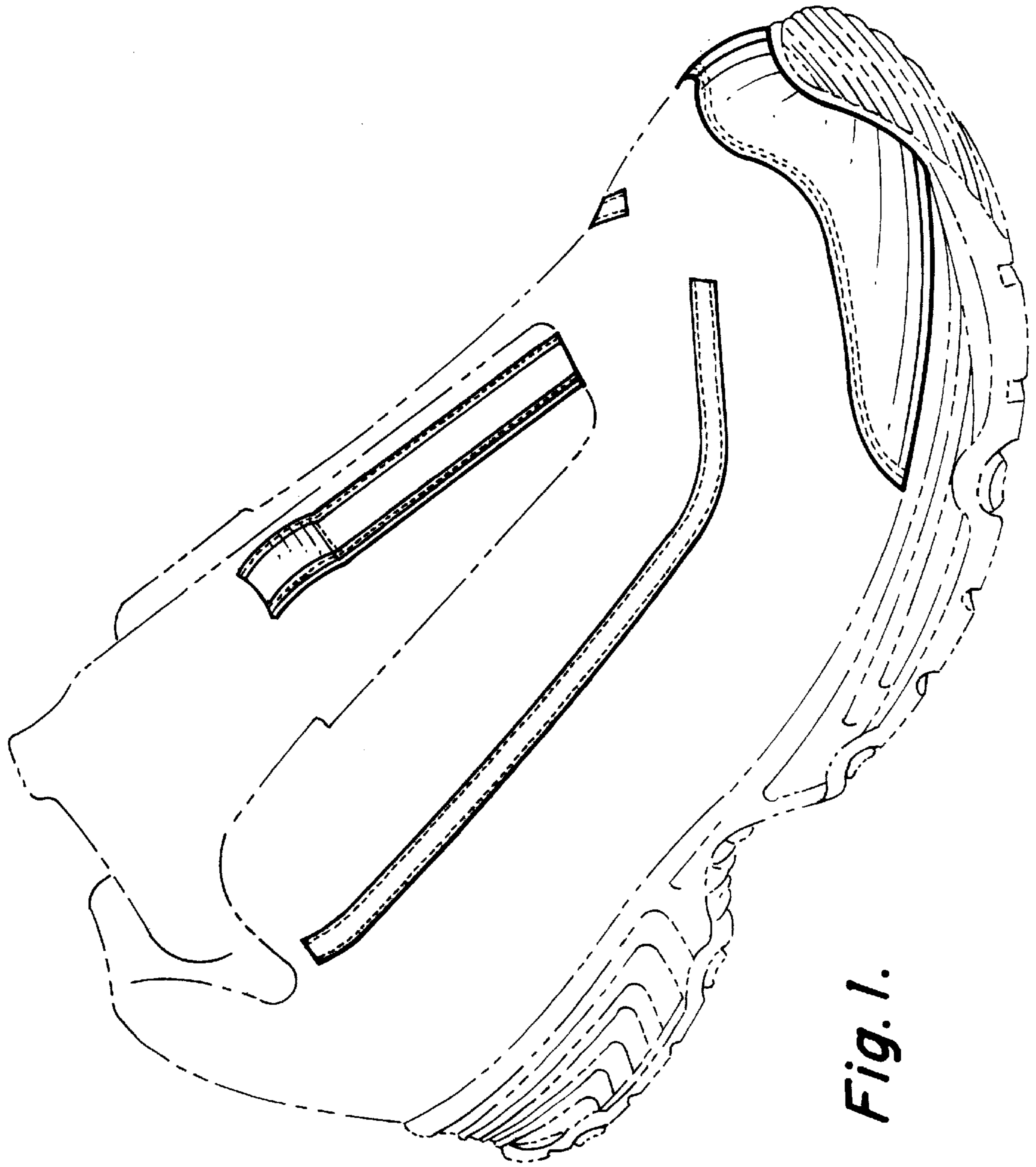

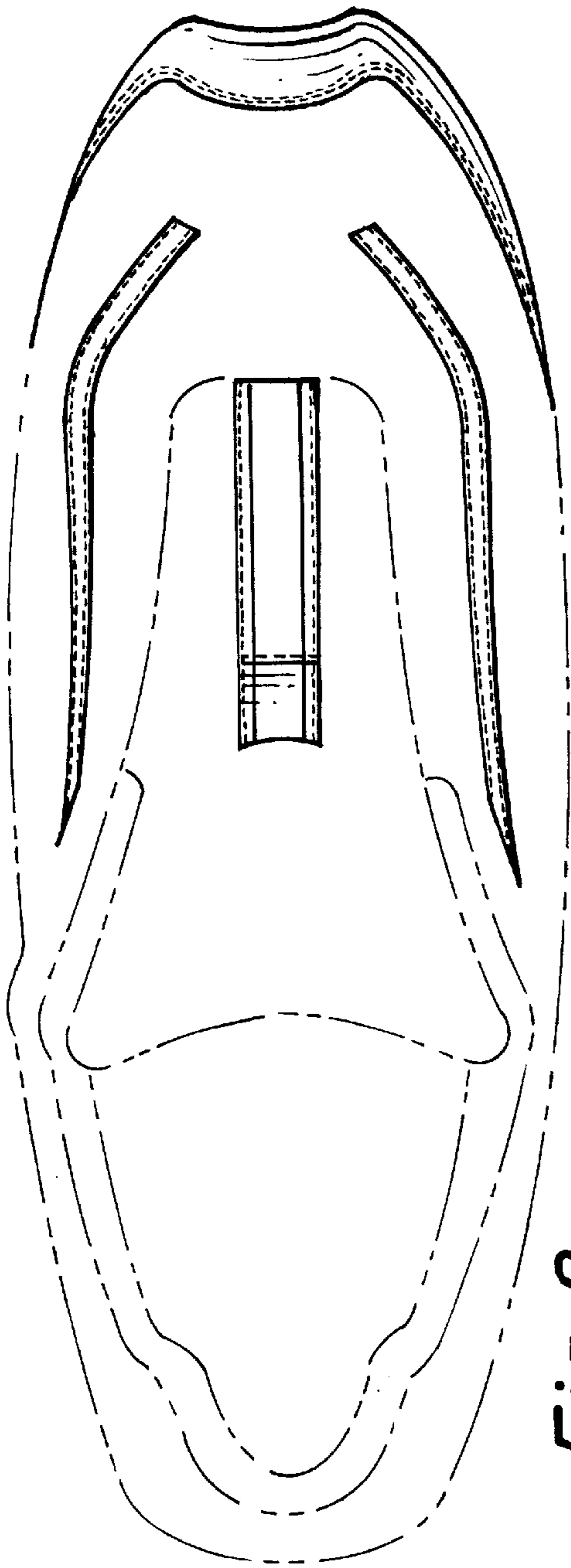

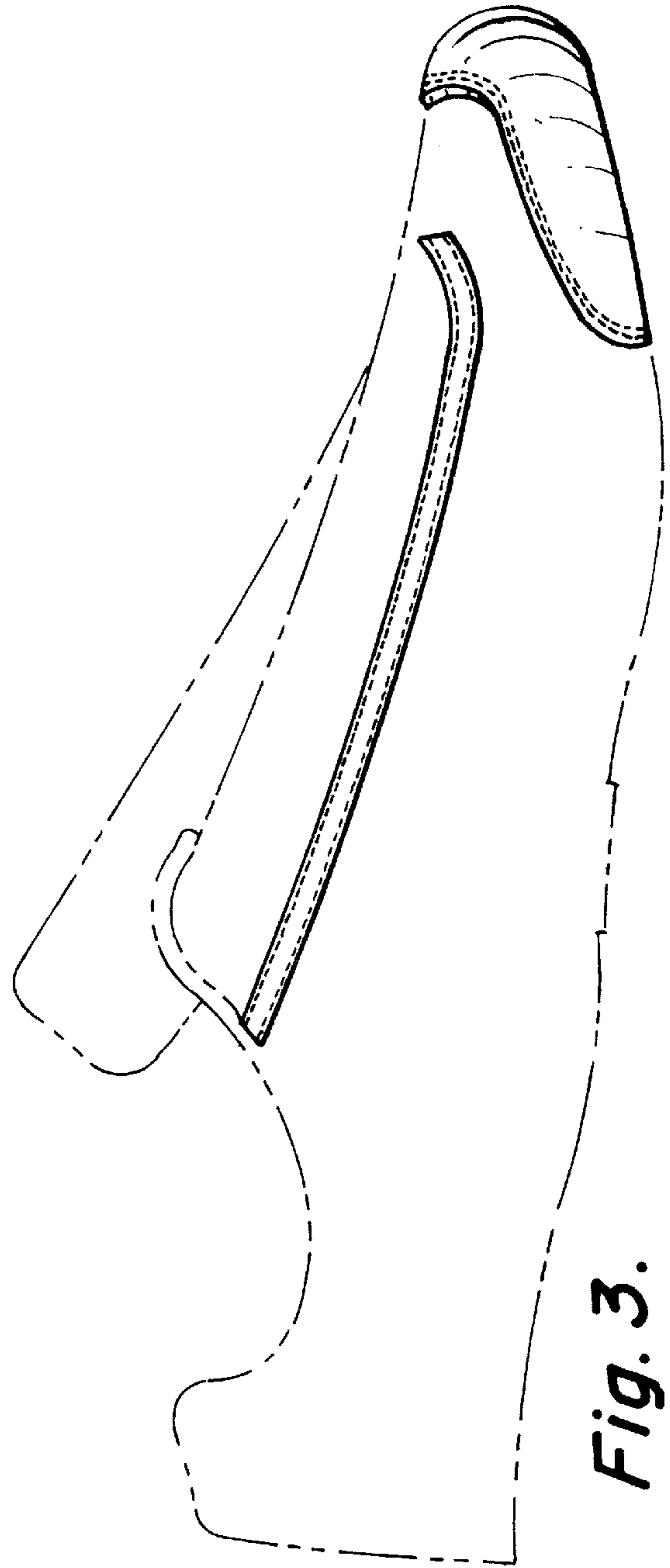

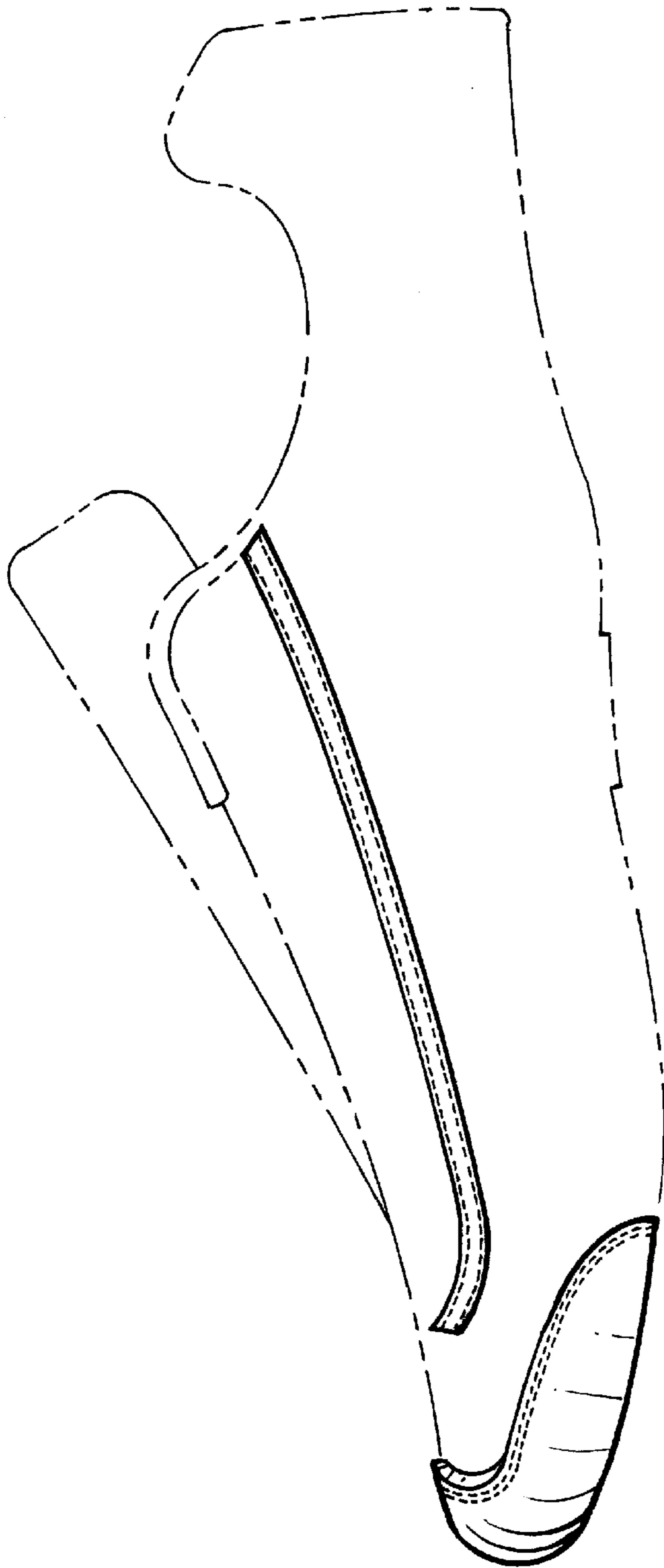

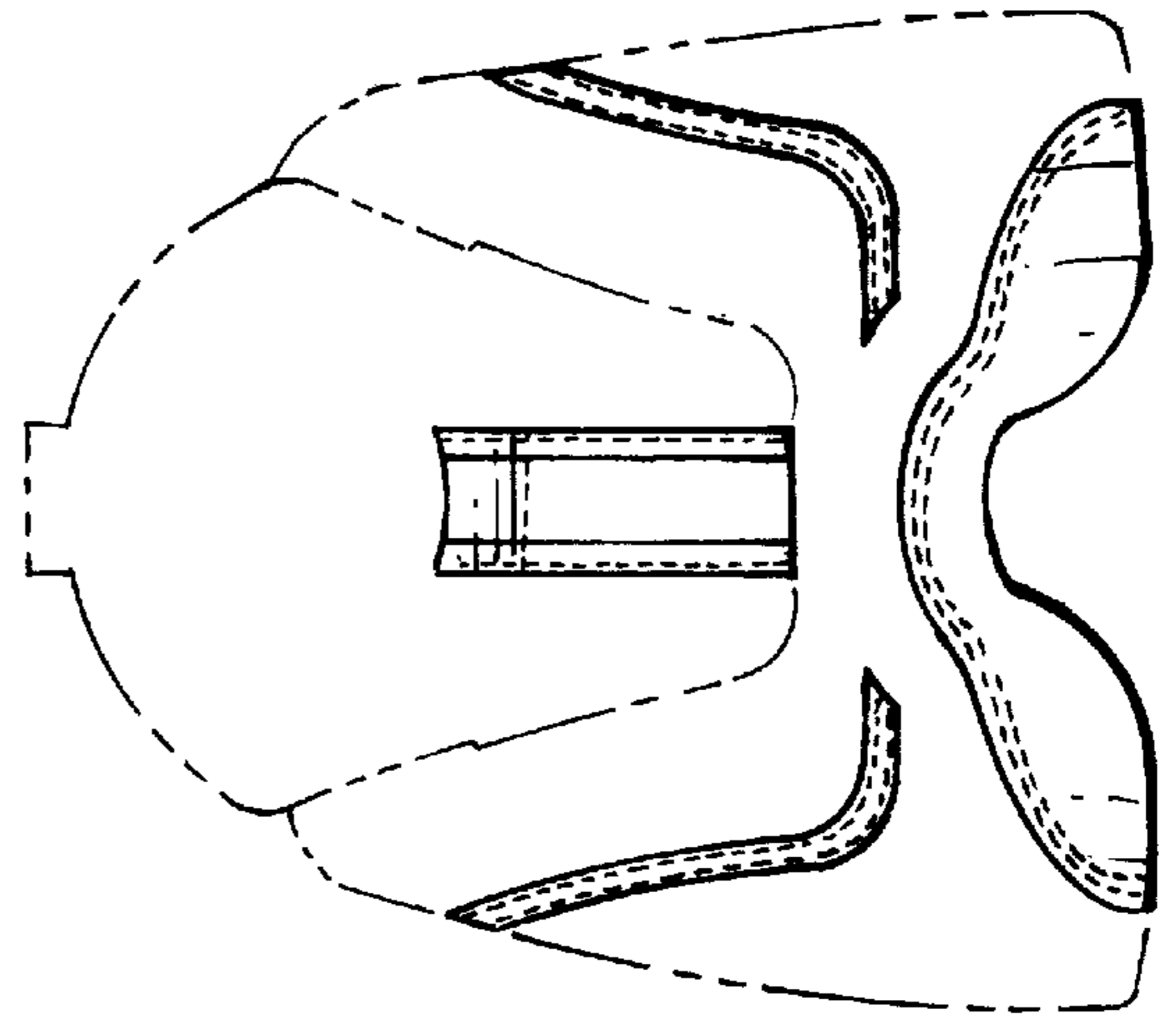
