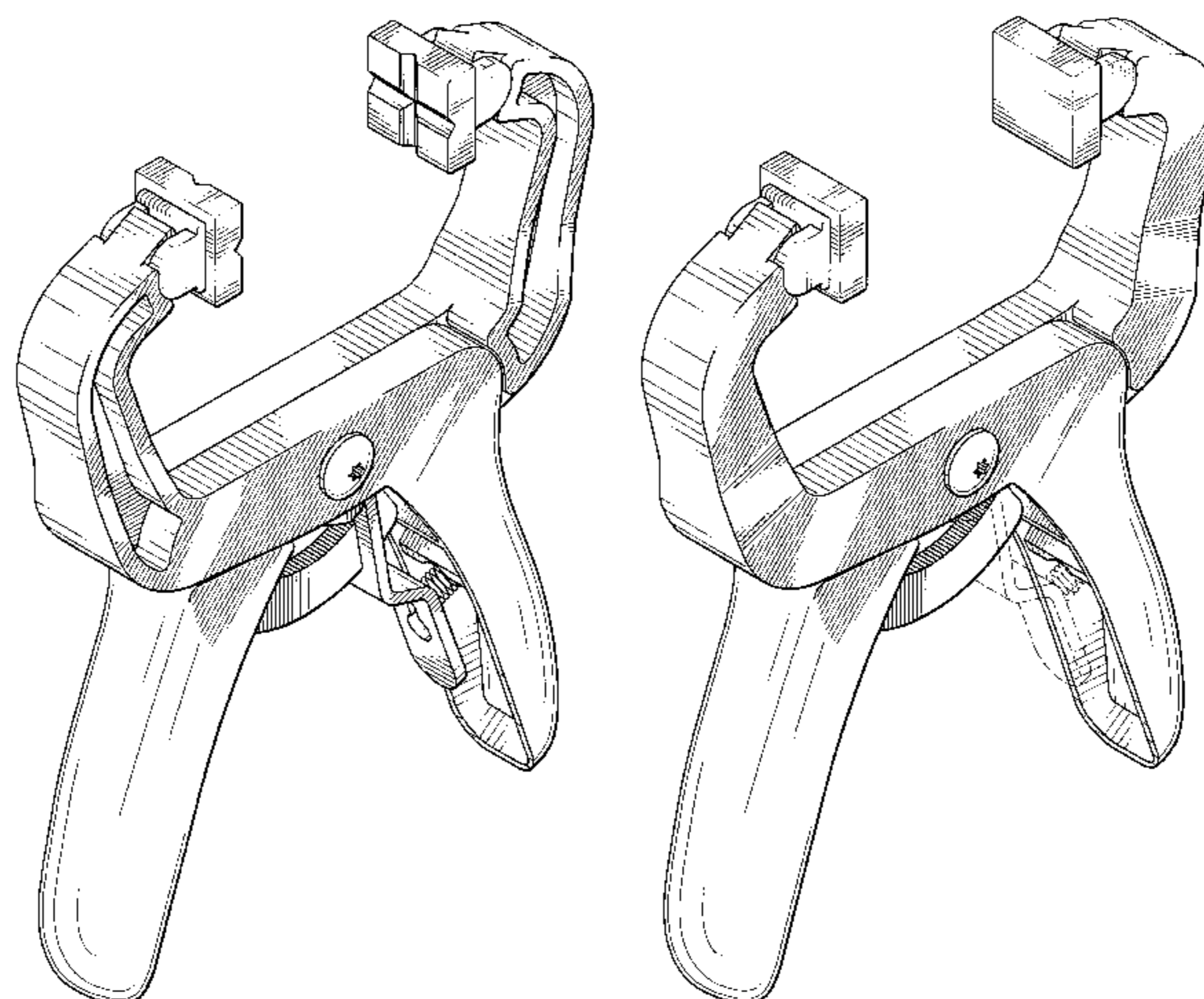
(57) **CLAIM**

The ornamental design for a clamp device, as shown and described.

DESCRIPTION

FIG. 1 shows a perspective view of a first embodiment of the hand clamp in the open position, according to our design; FIG. 2 shows a front plan view thereof; FIG. 3 shows a top plan view thereof; FIG. 4 shows a rear plan view thereof; FIG. 5 shows a left side plan view thereof. The opposite side is a substantially identical, but mirror image thereof; FIG. 6 shows a bottom plan view thereof; FIG. 7 shows a perspective view of the first embodiment of the hand clamp in the closed position; FIG. 8 shows a front plan view thereof; FIG. 9 shows a top plan view thereof; FIG. 10 shows a rear plan view thereof; FIG. 11 shows a left side plan view thereof; FIG. 12 shows a right side plan view thereof; FIG. 13 shows a bottom plan view thereof; FIG. 14 shows a perspective view of a second embodiment of the hand clamp in the open position, according to our design; FIG. 15 shows a front plan view thereof; FIG. 16 shows a top plan view thereof; FIG. 17 shows a rear plan view thereof; FIG. 18 shows a left side plan view thereof. 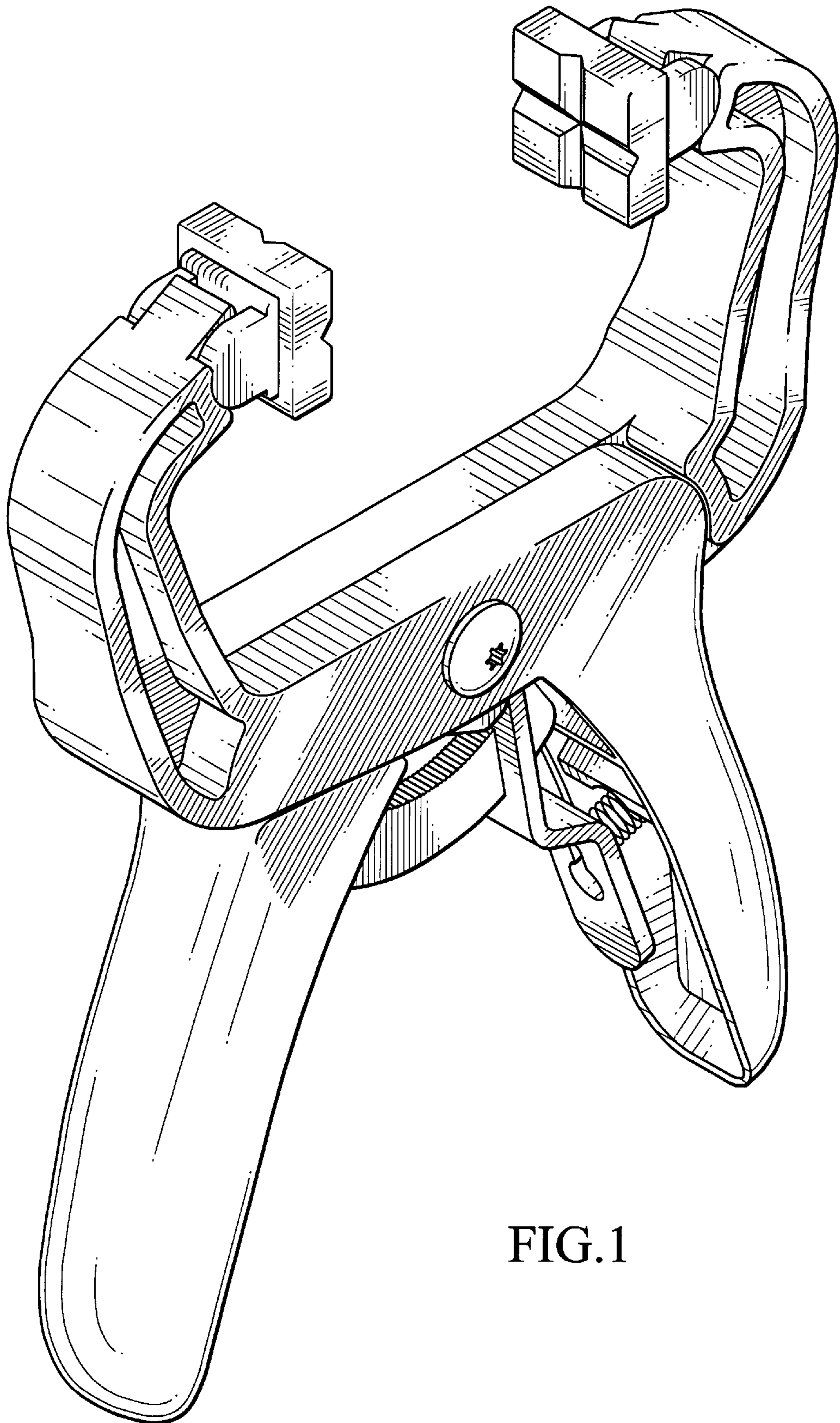

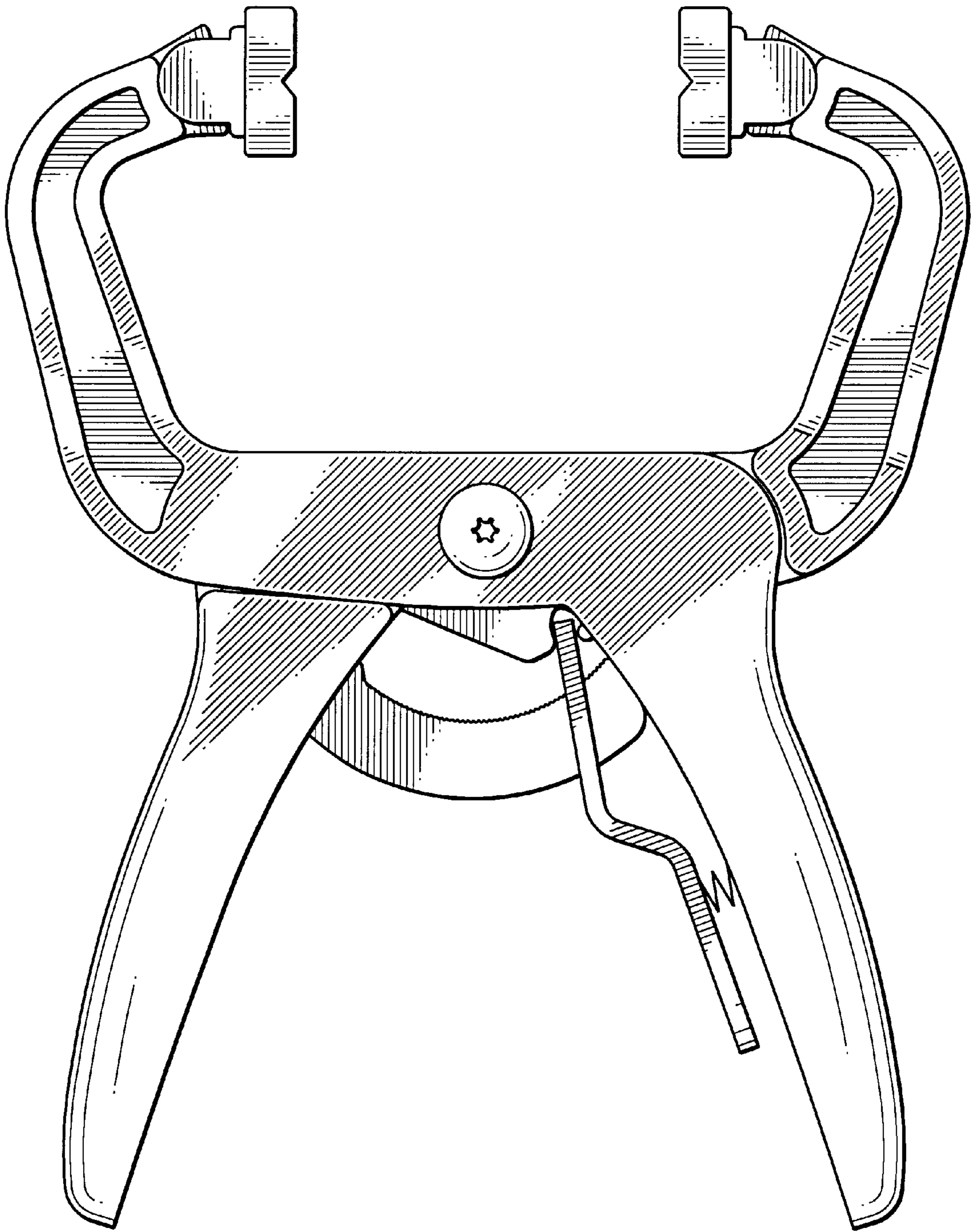

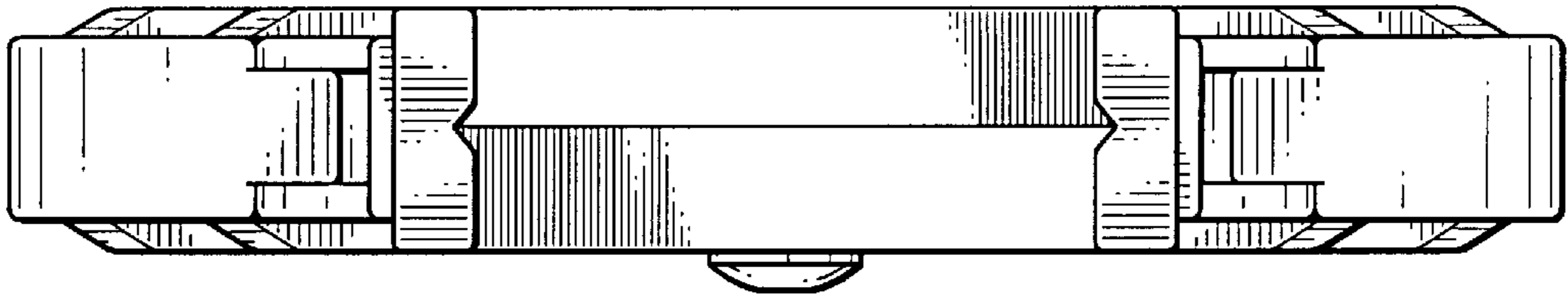

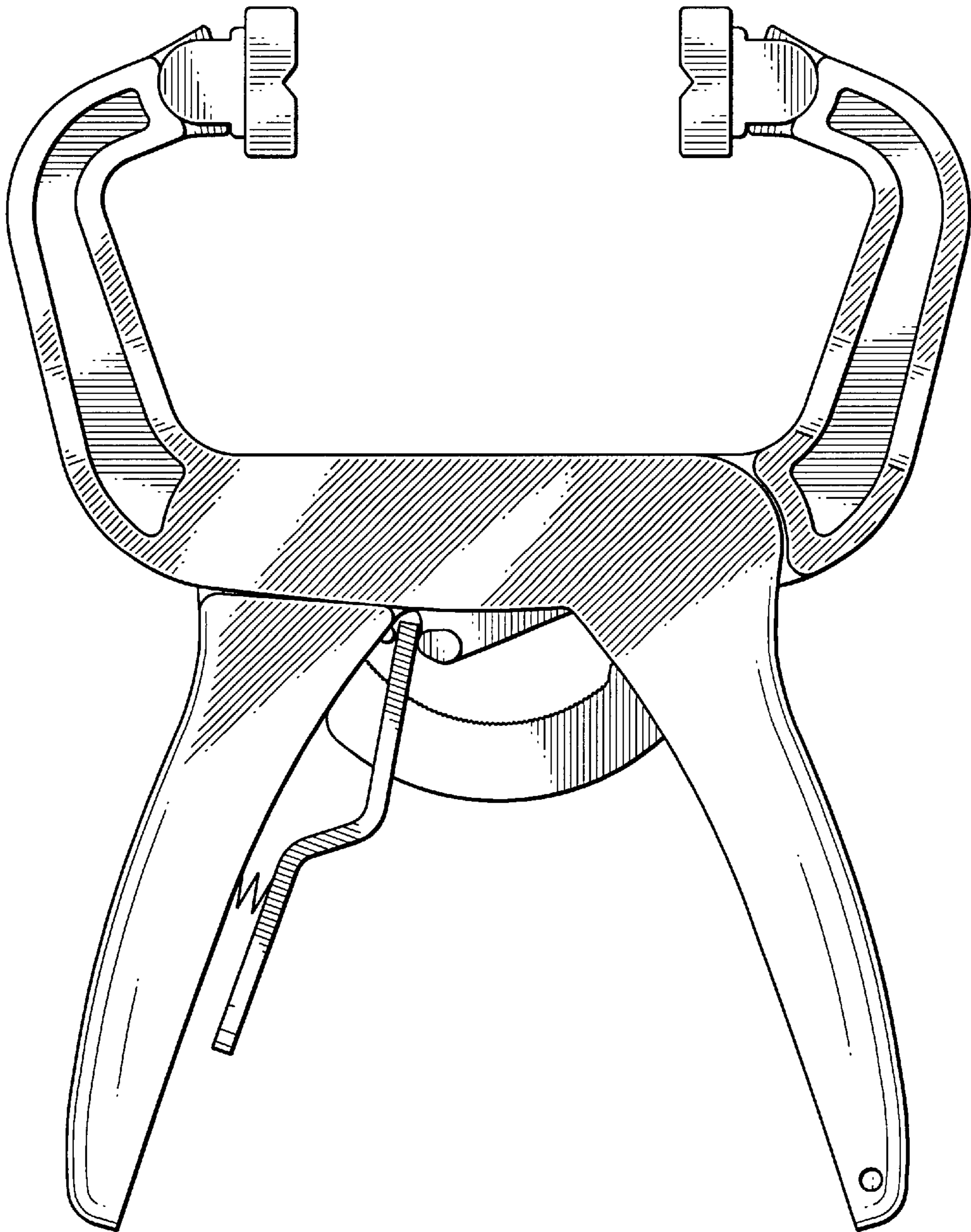

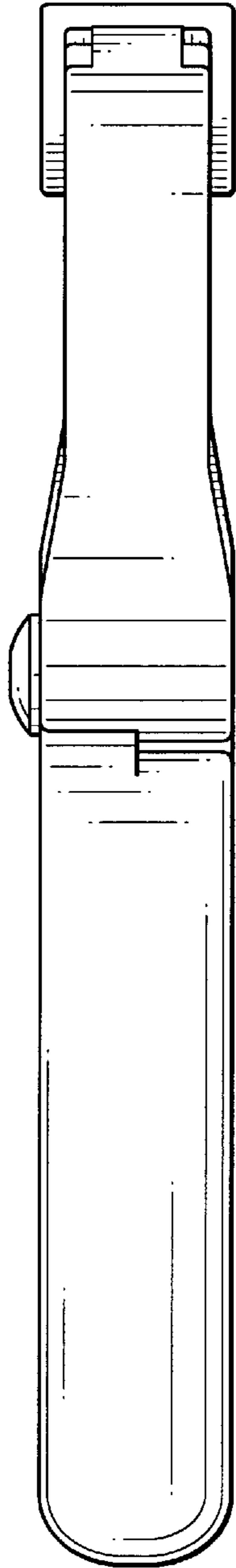

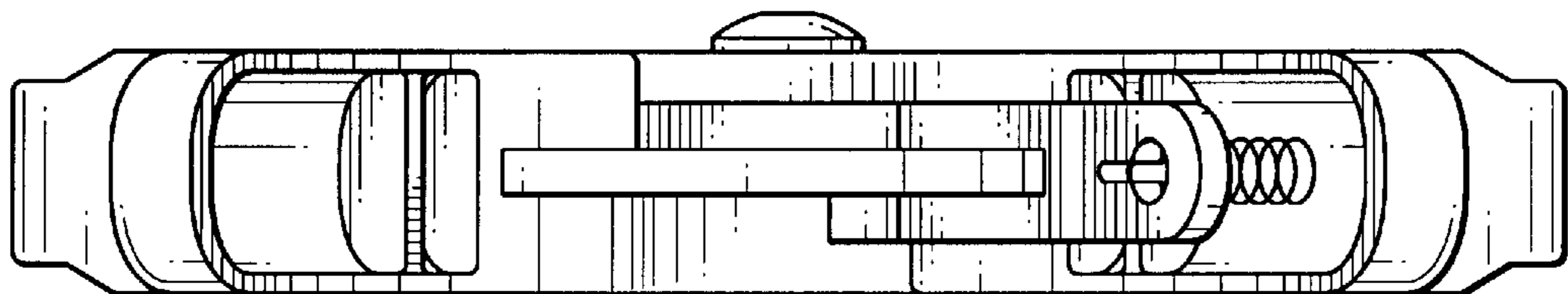

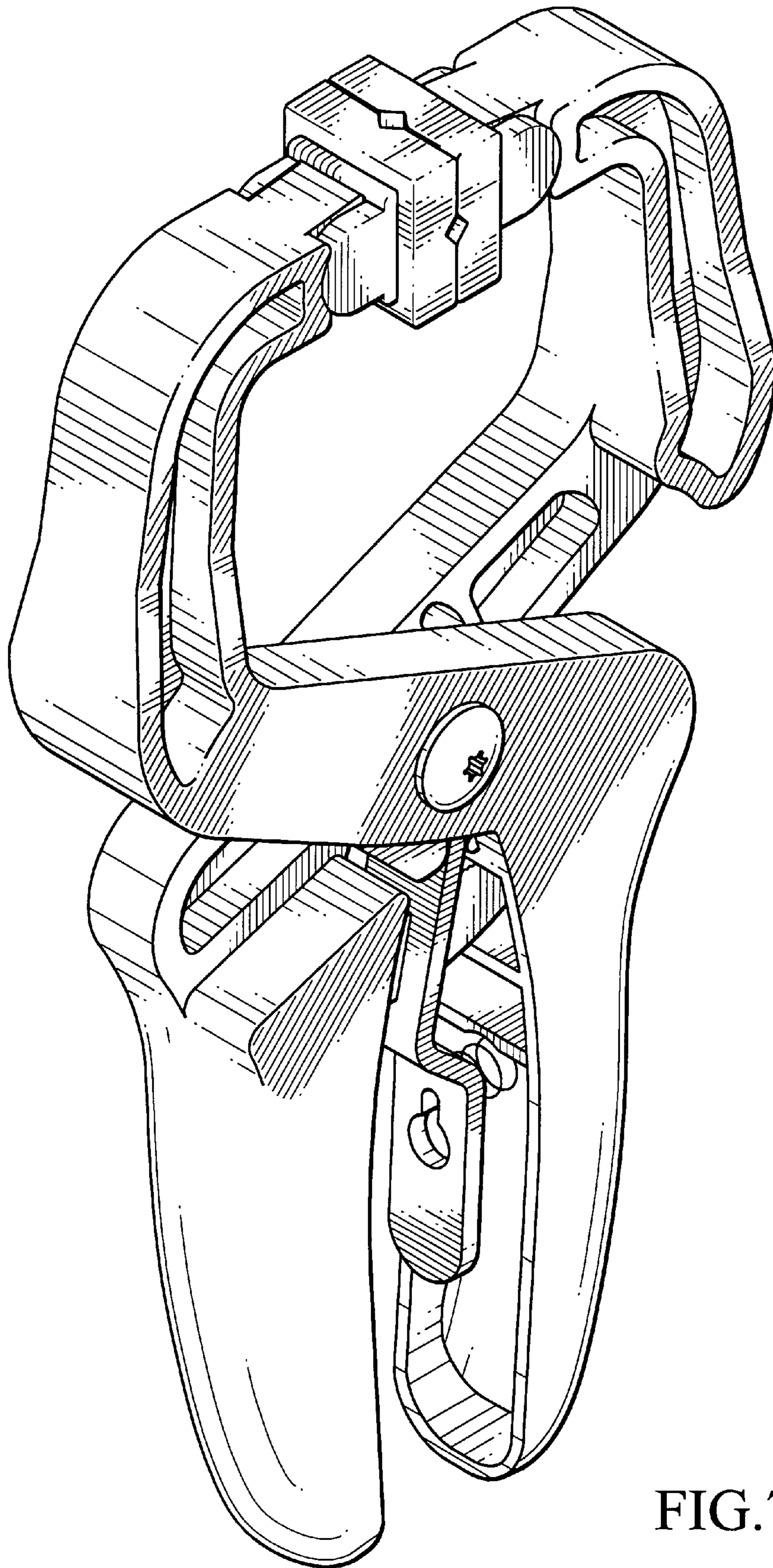

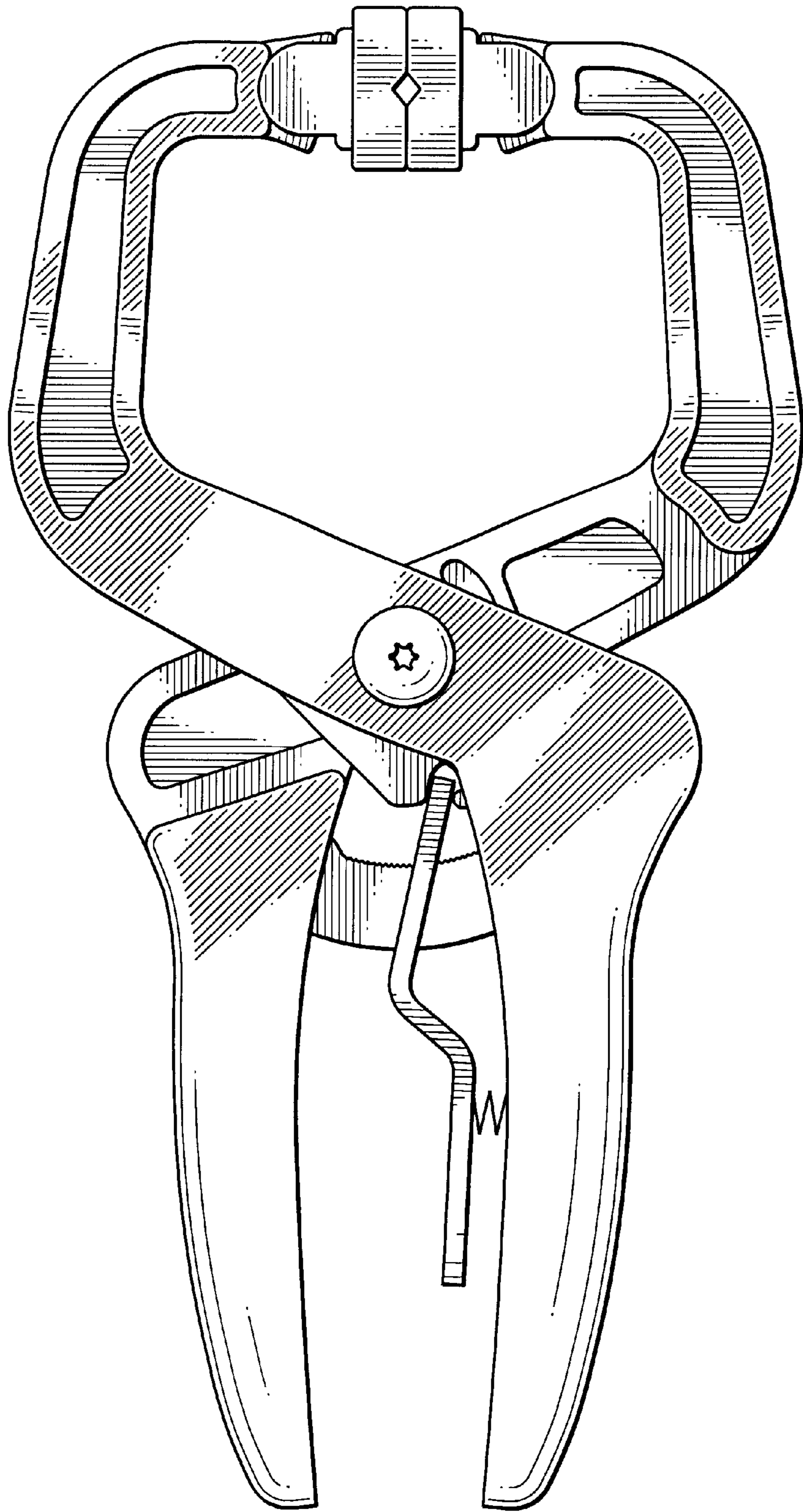

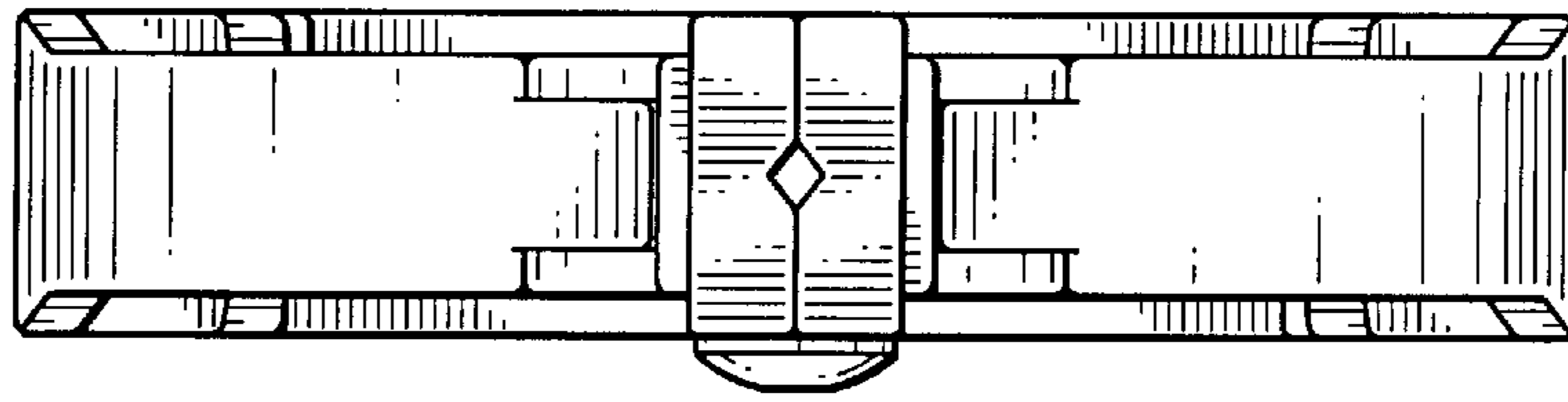

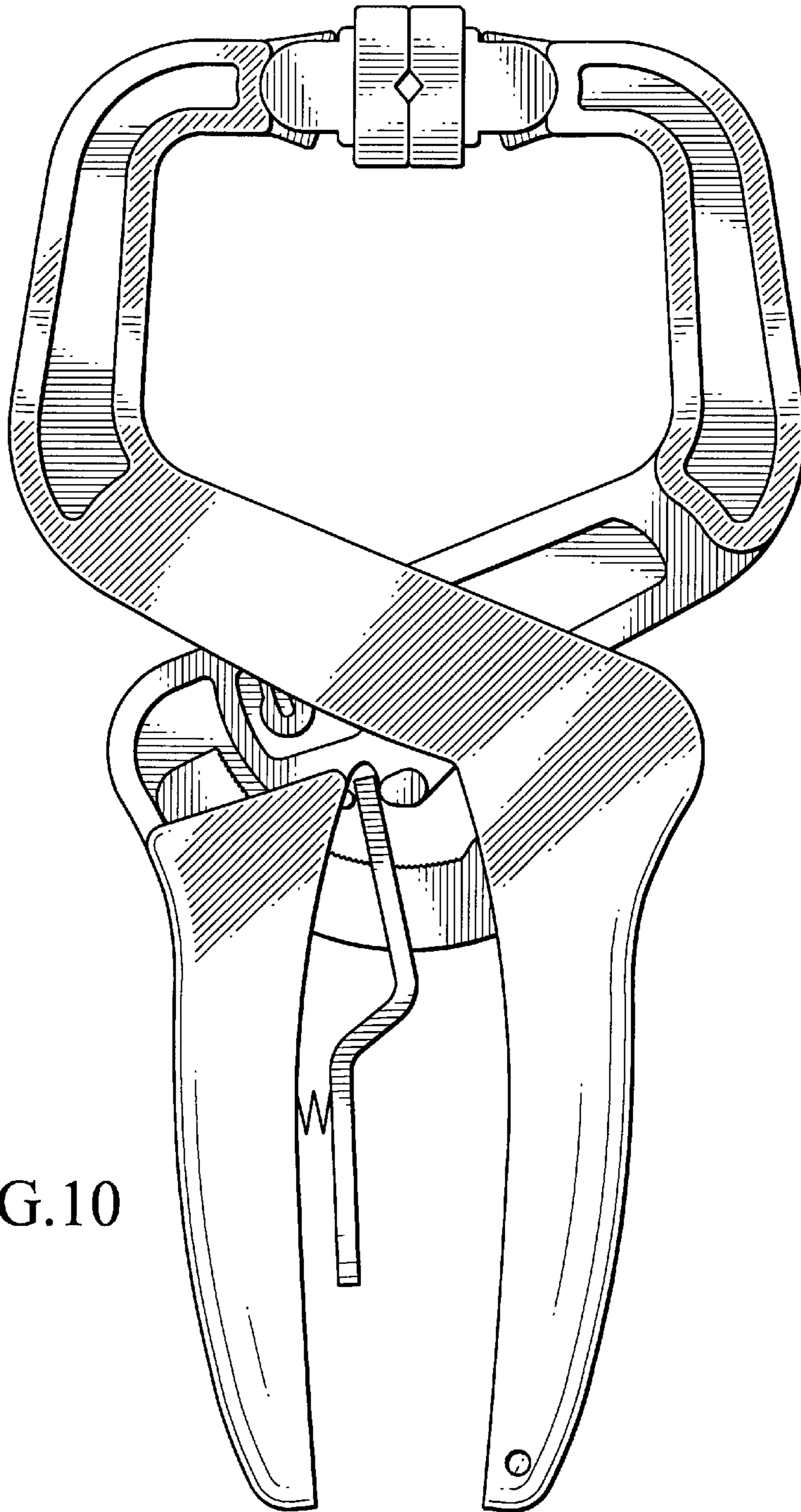

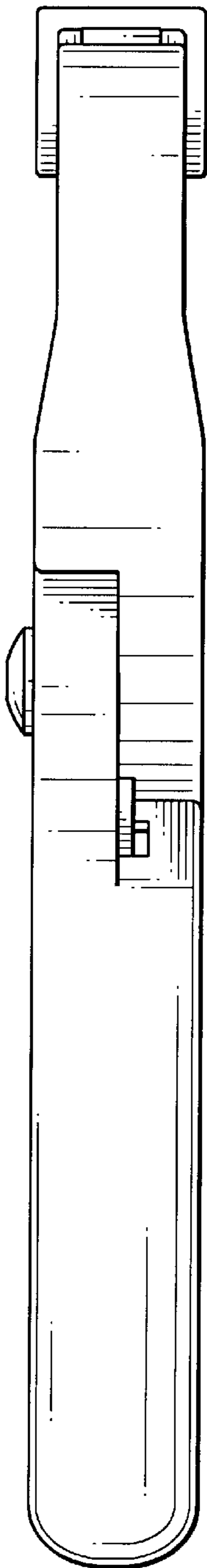

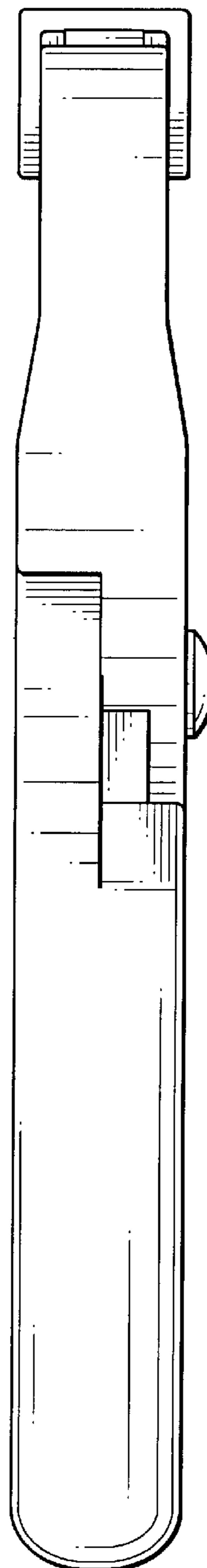

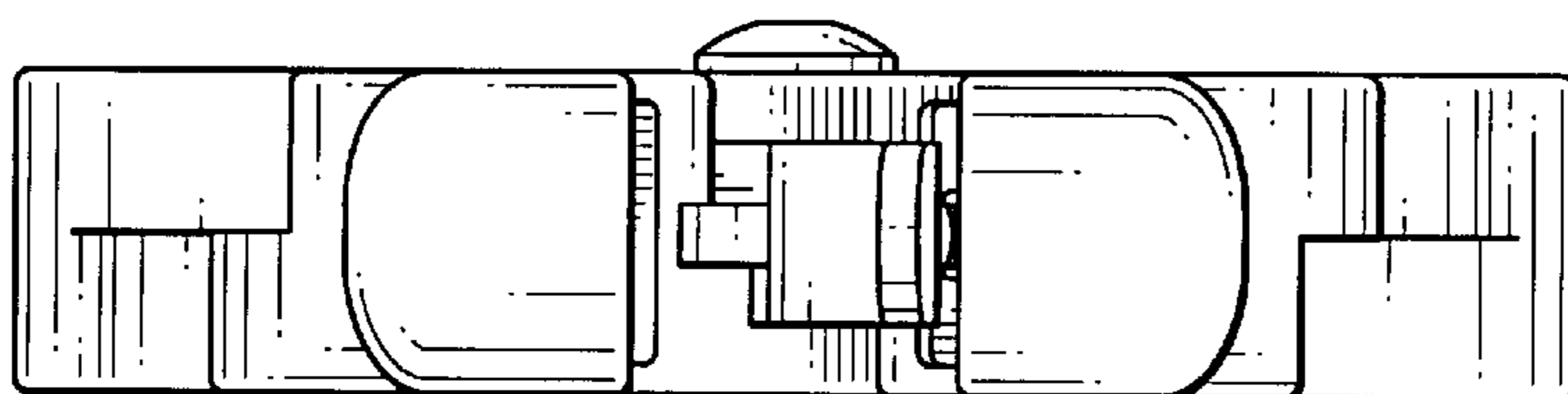

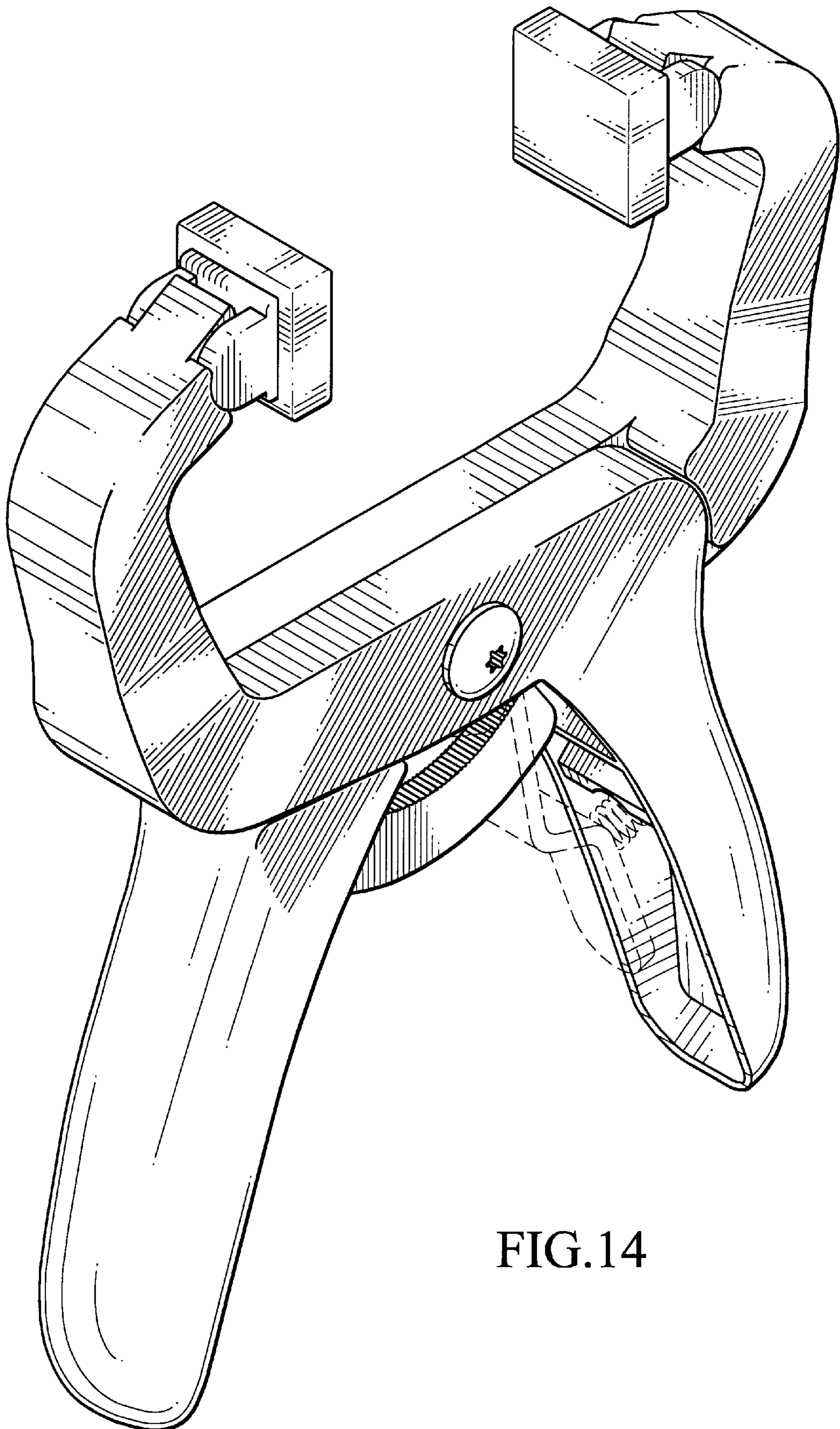

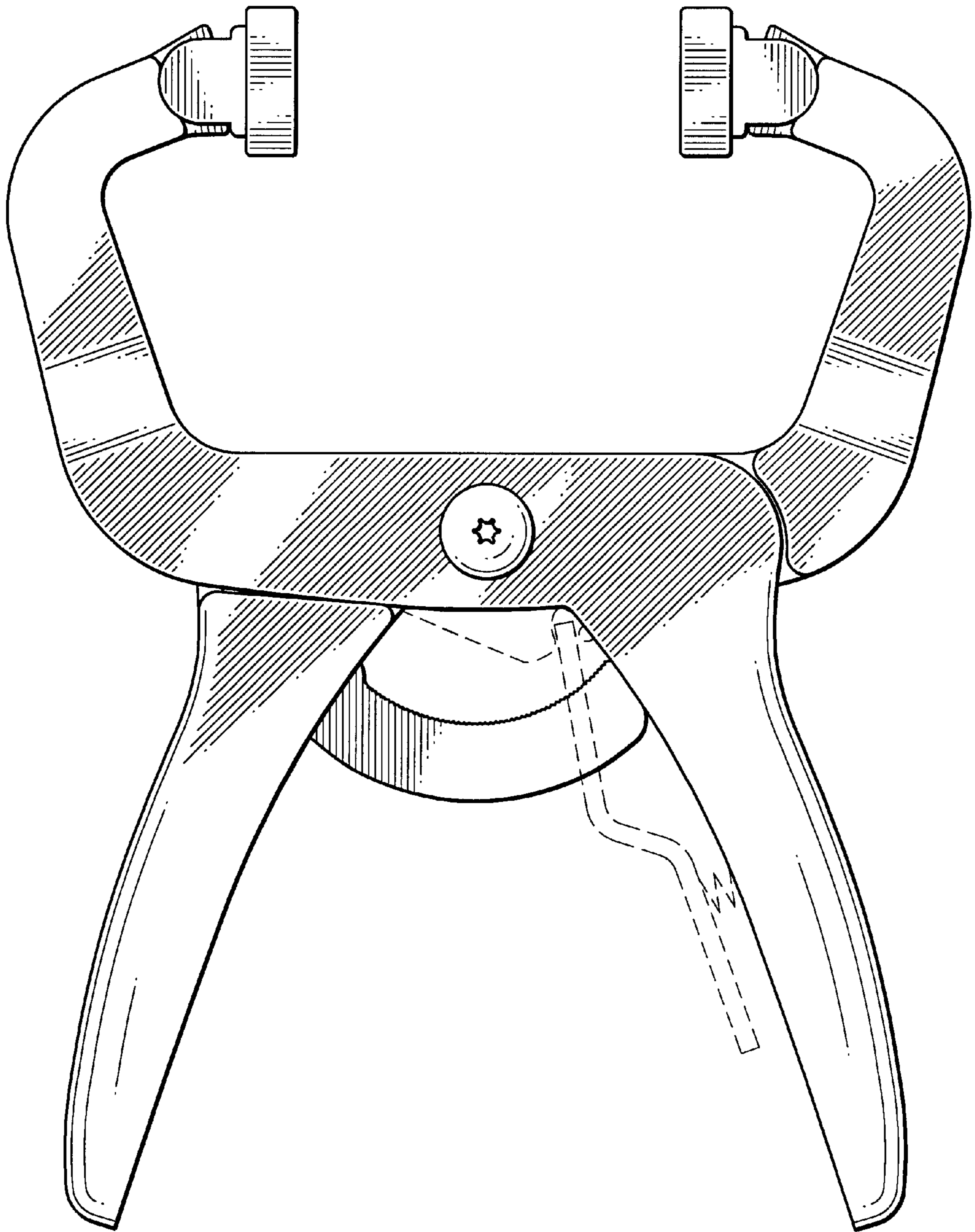

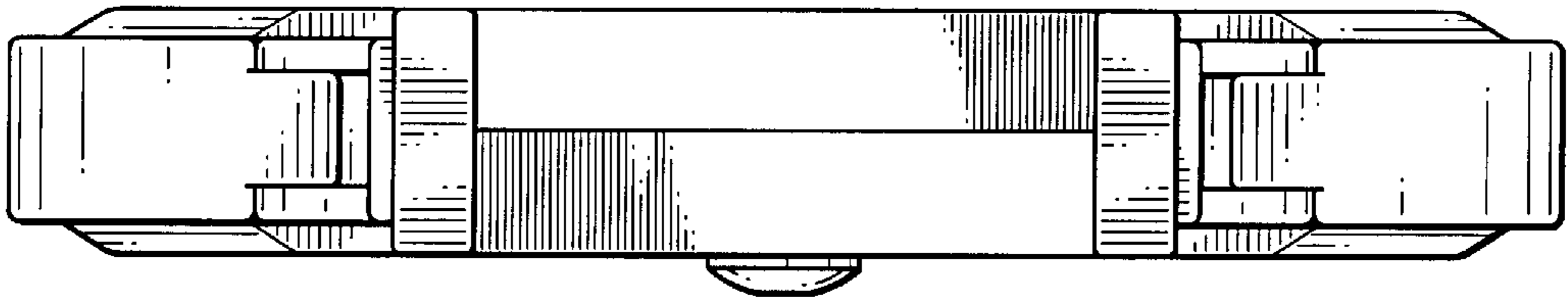

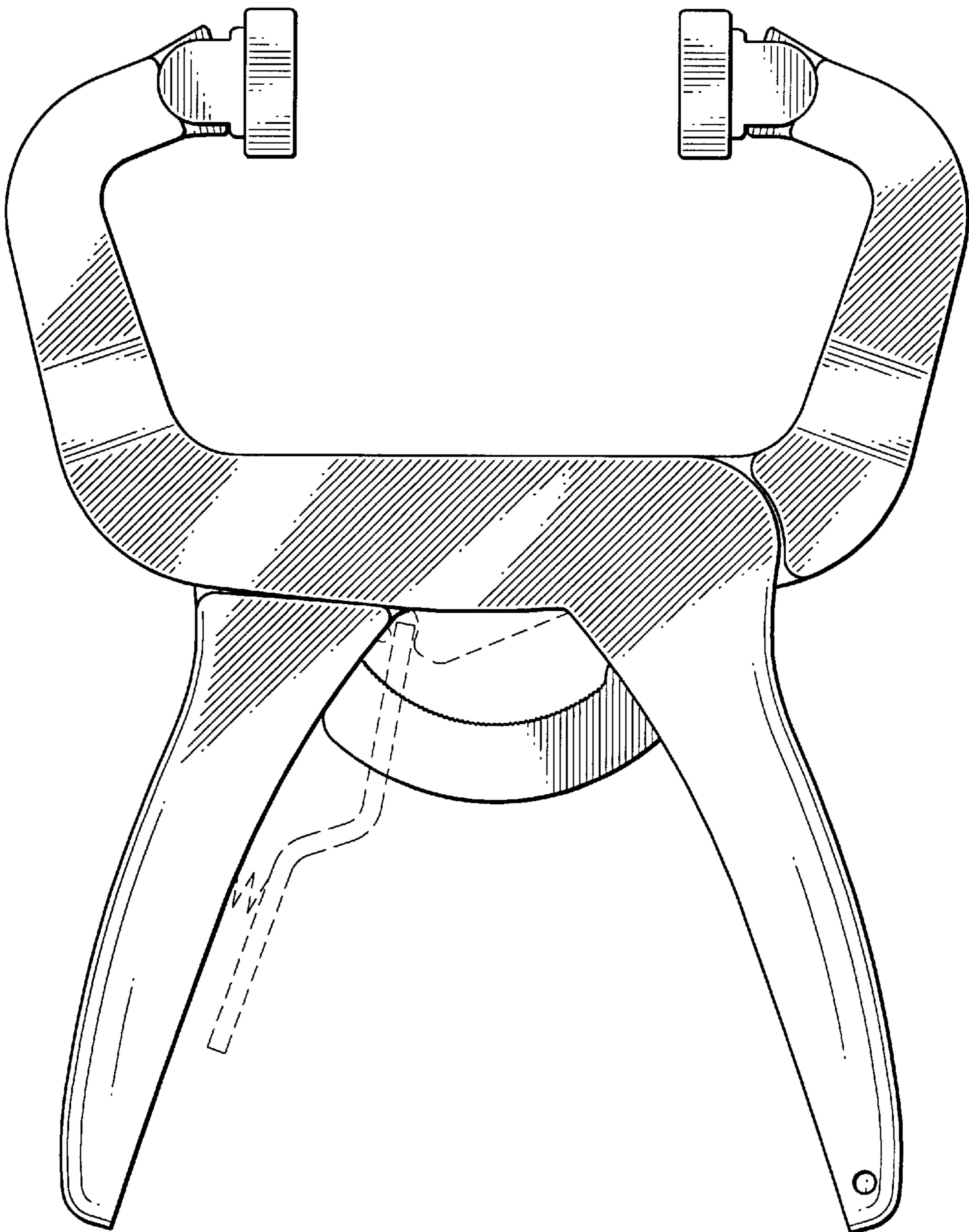

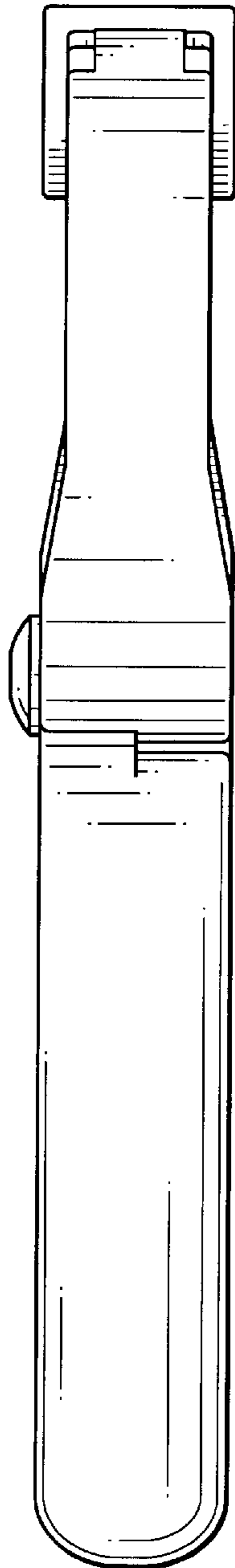

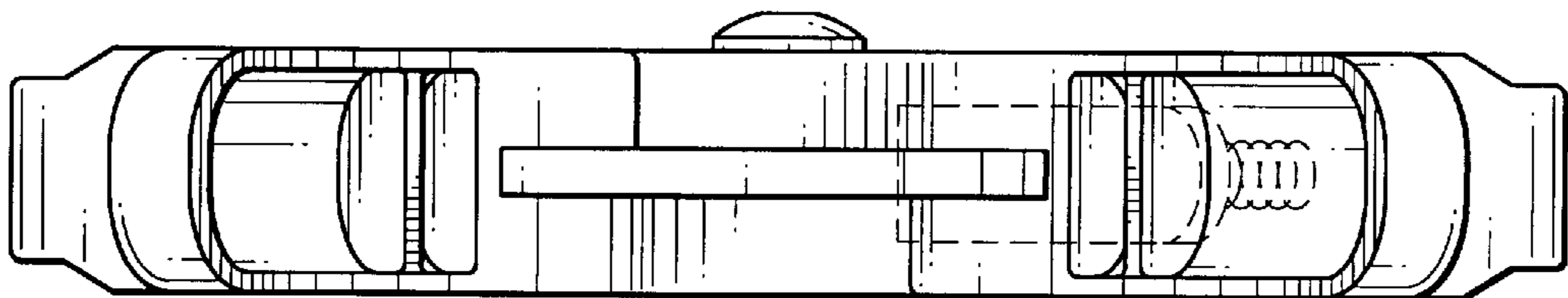

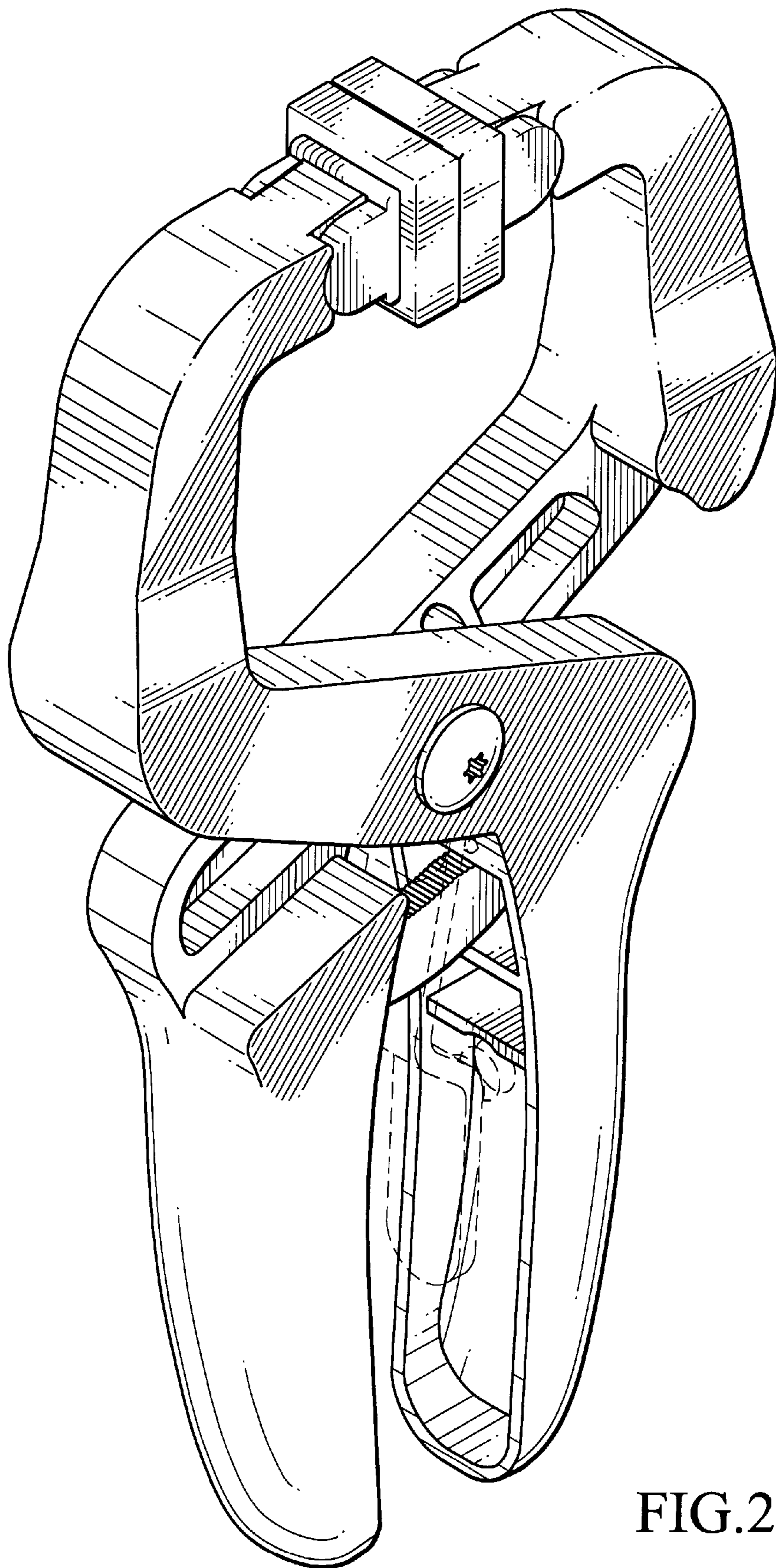

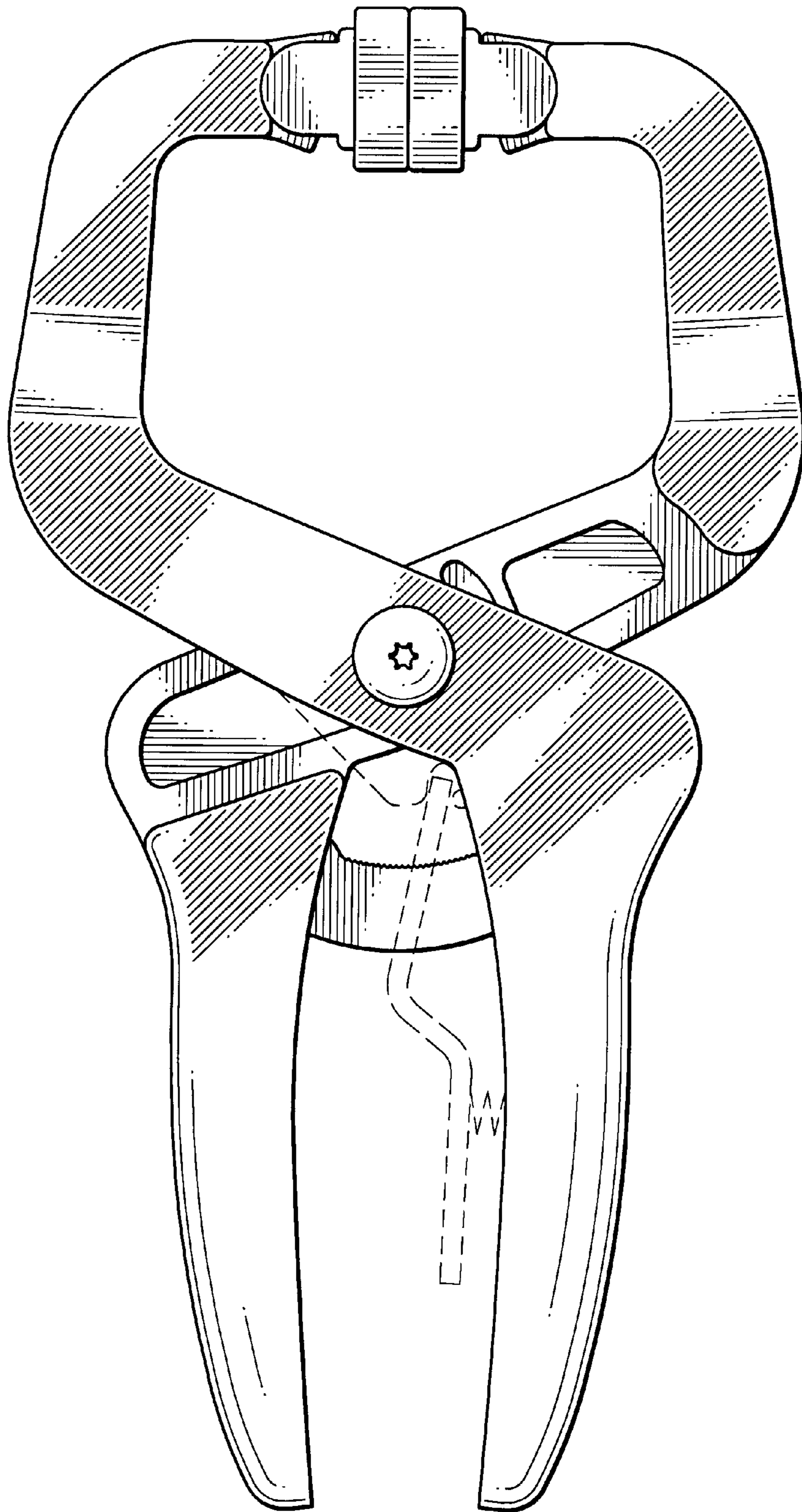

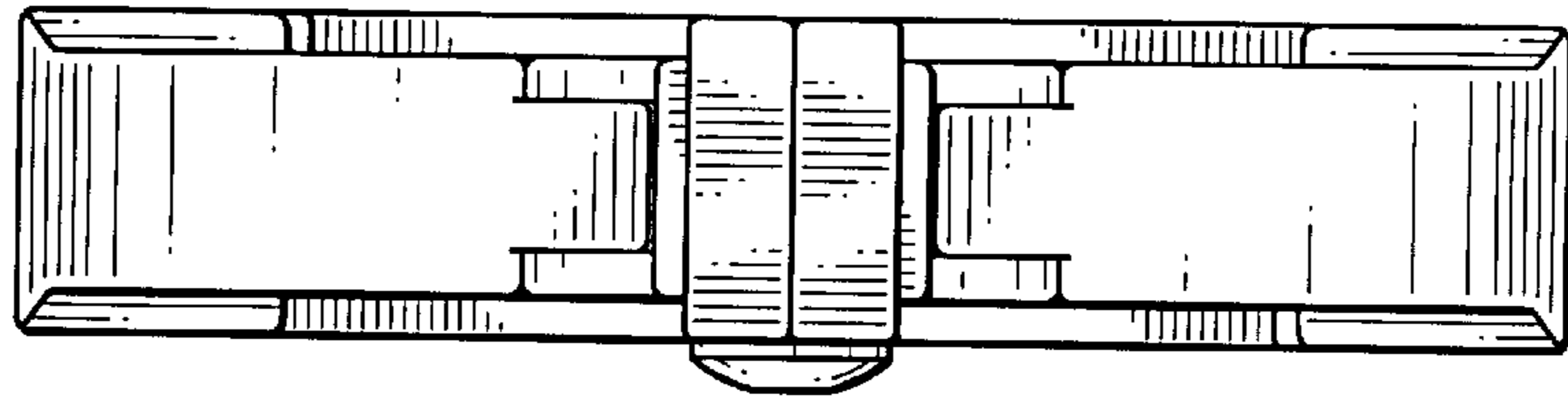

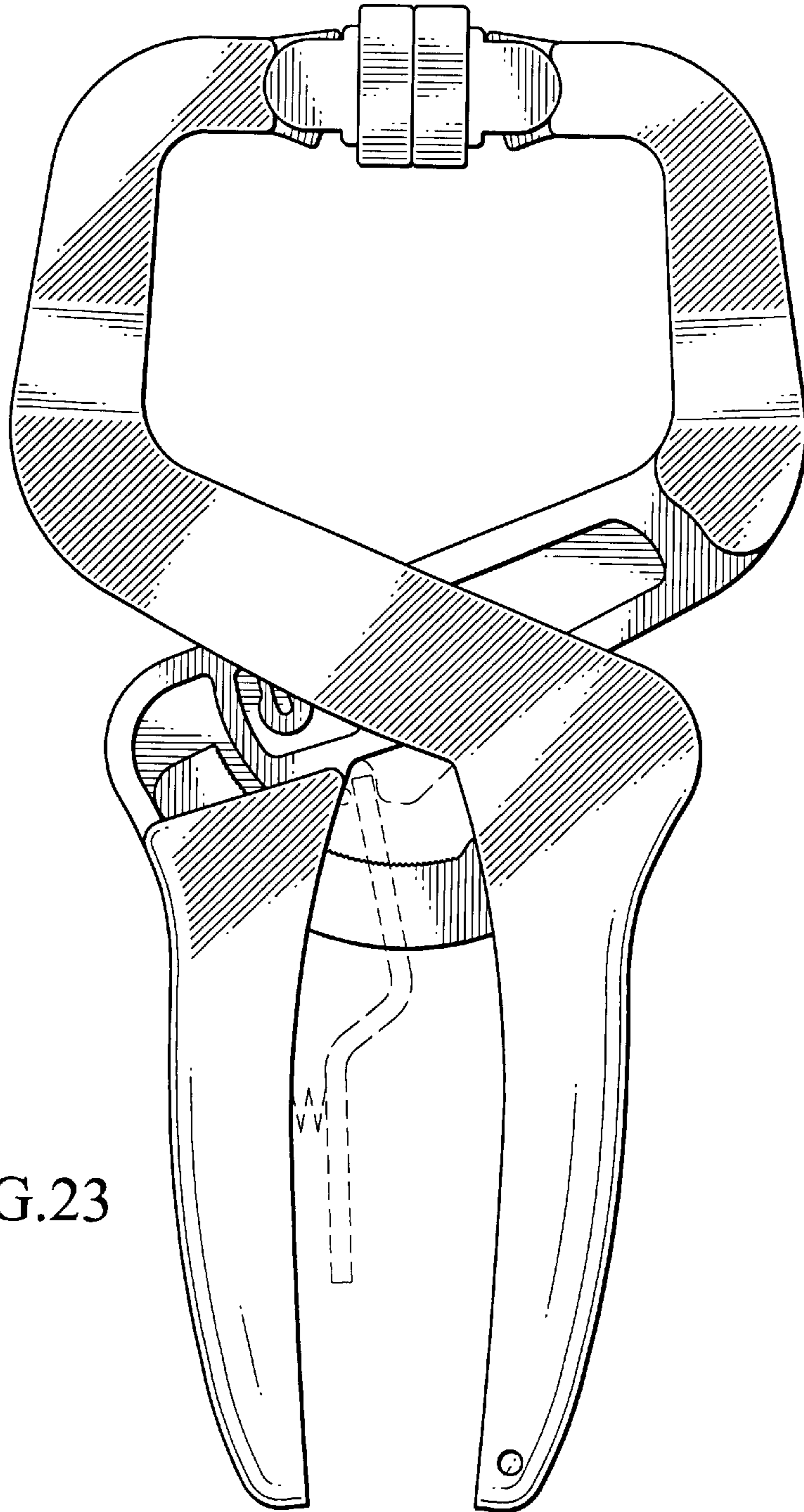

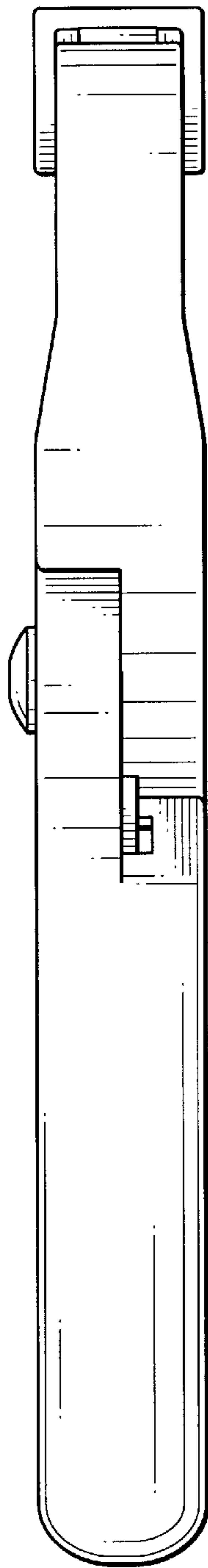

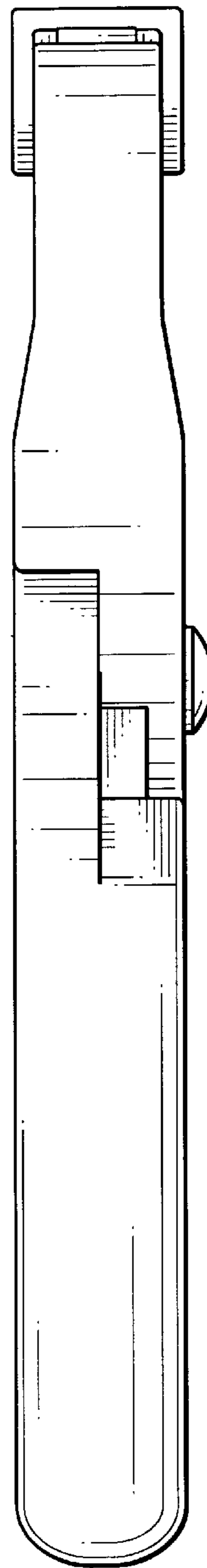

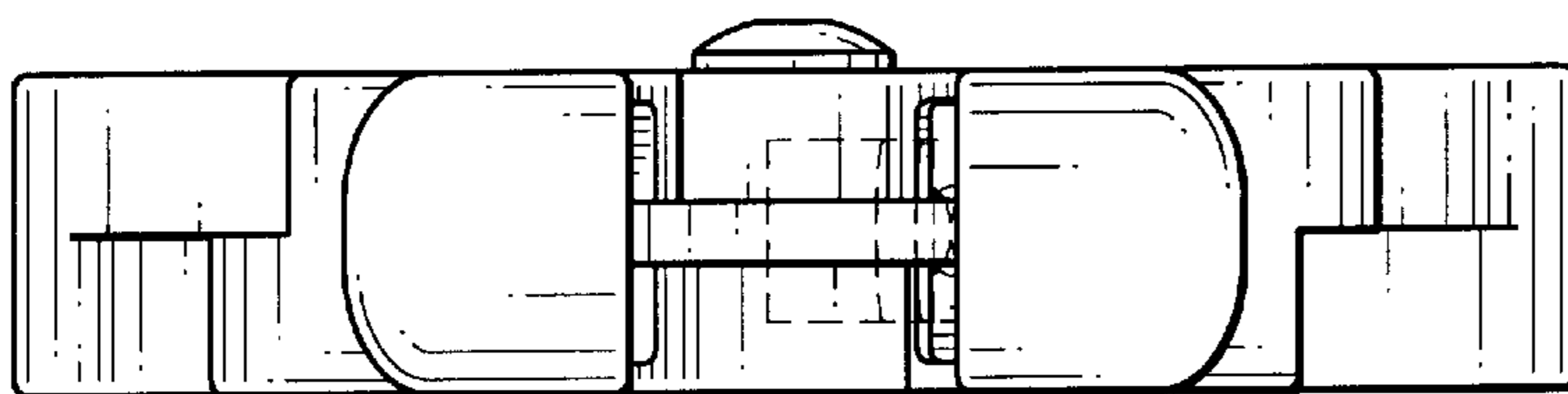
