FIG. 4 is a side view thereof;

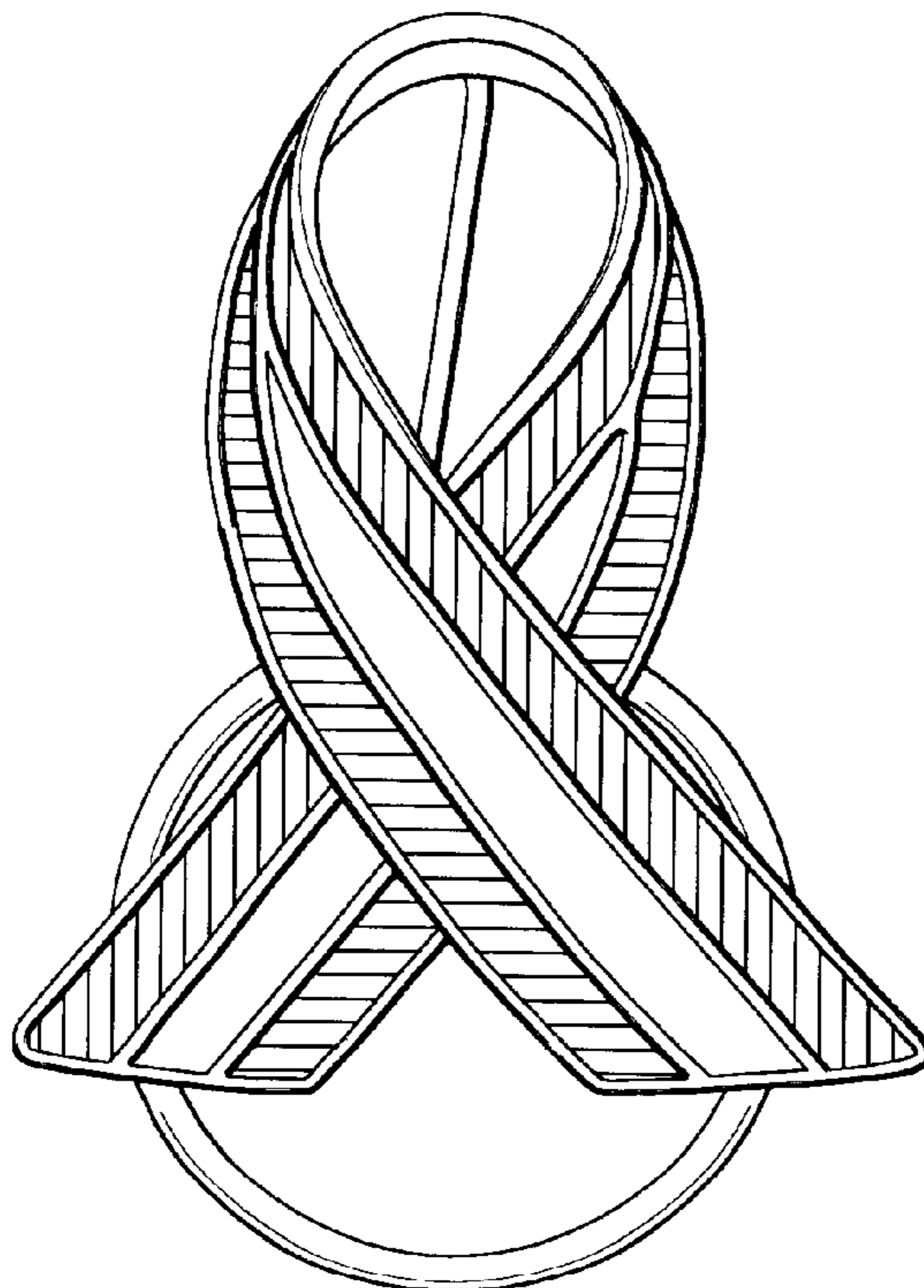
FIG. 5 is a view of the opposite side thereof;

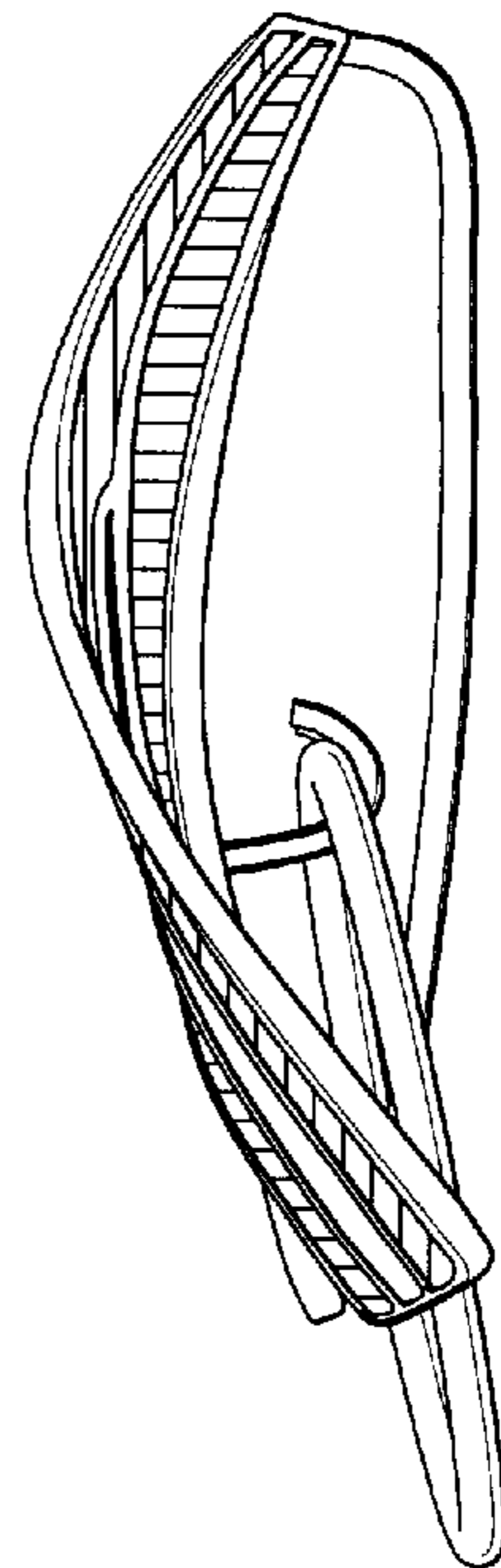
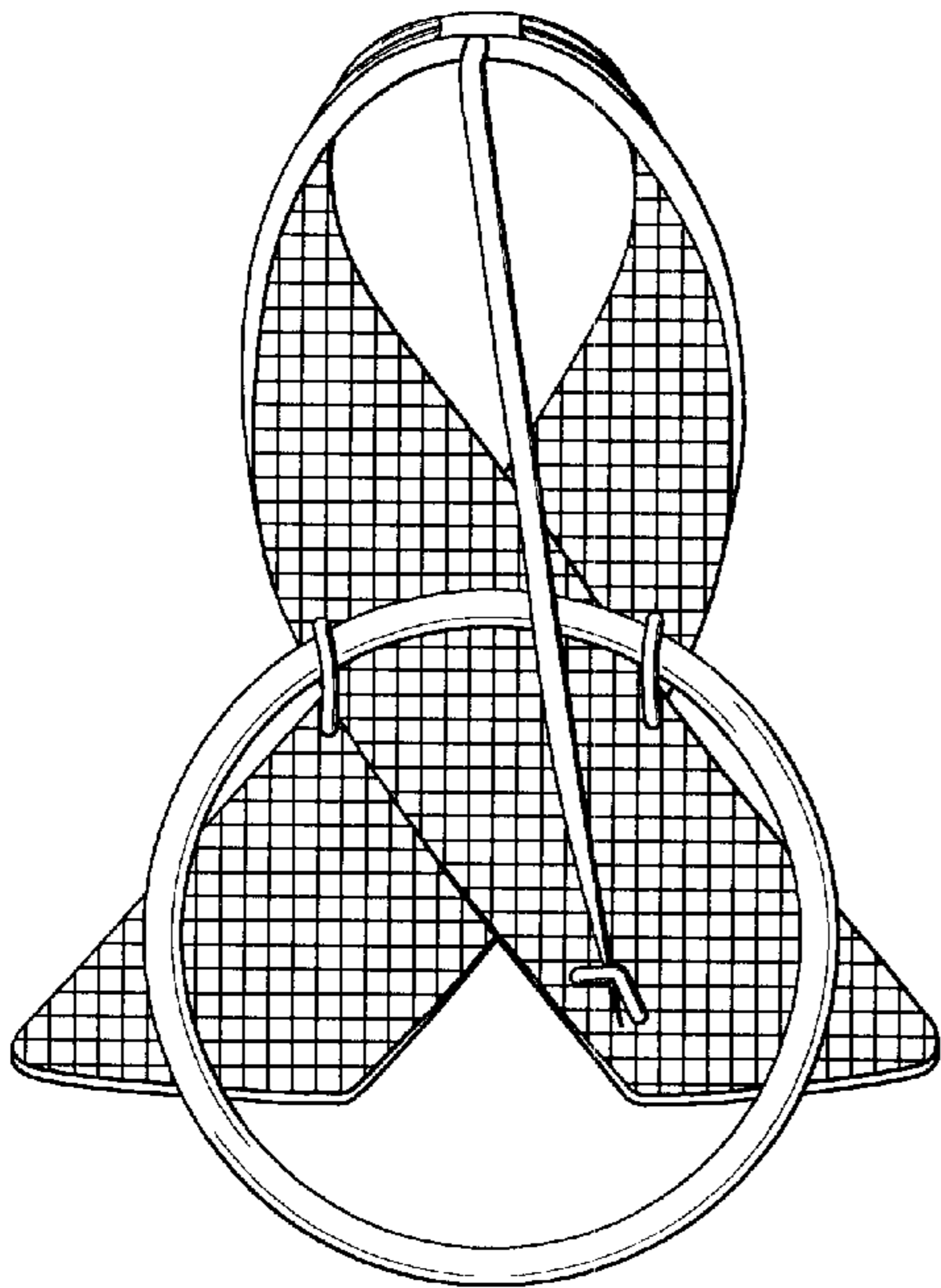
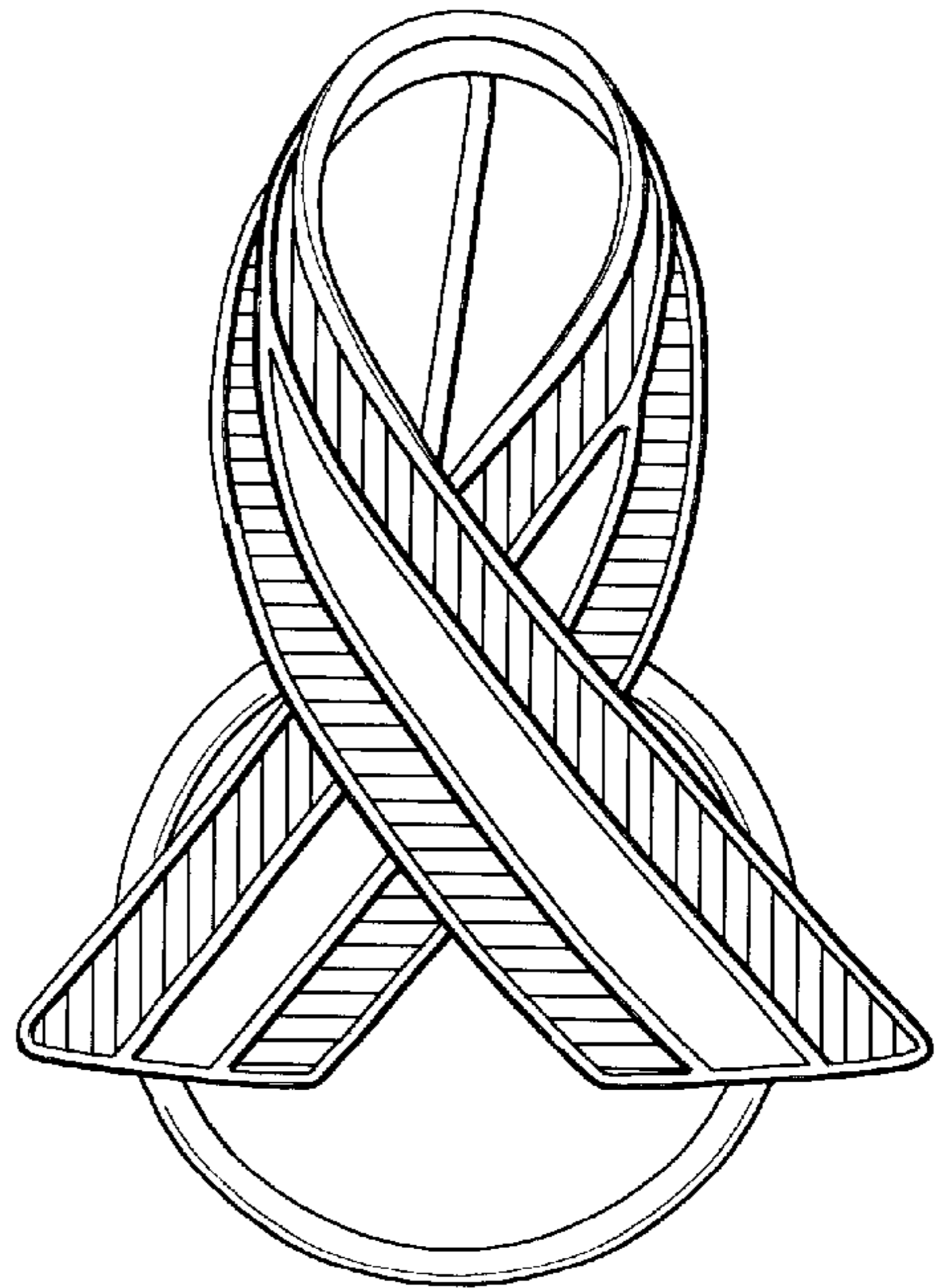
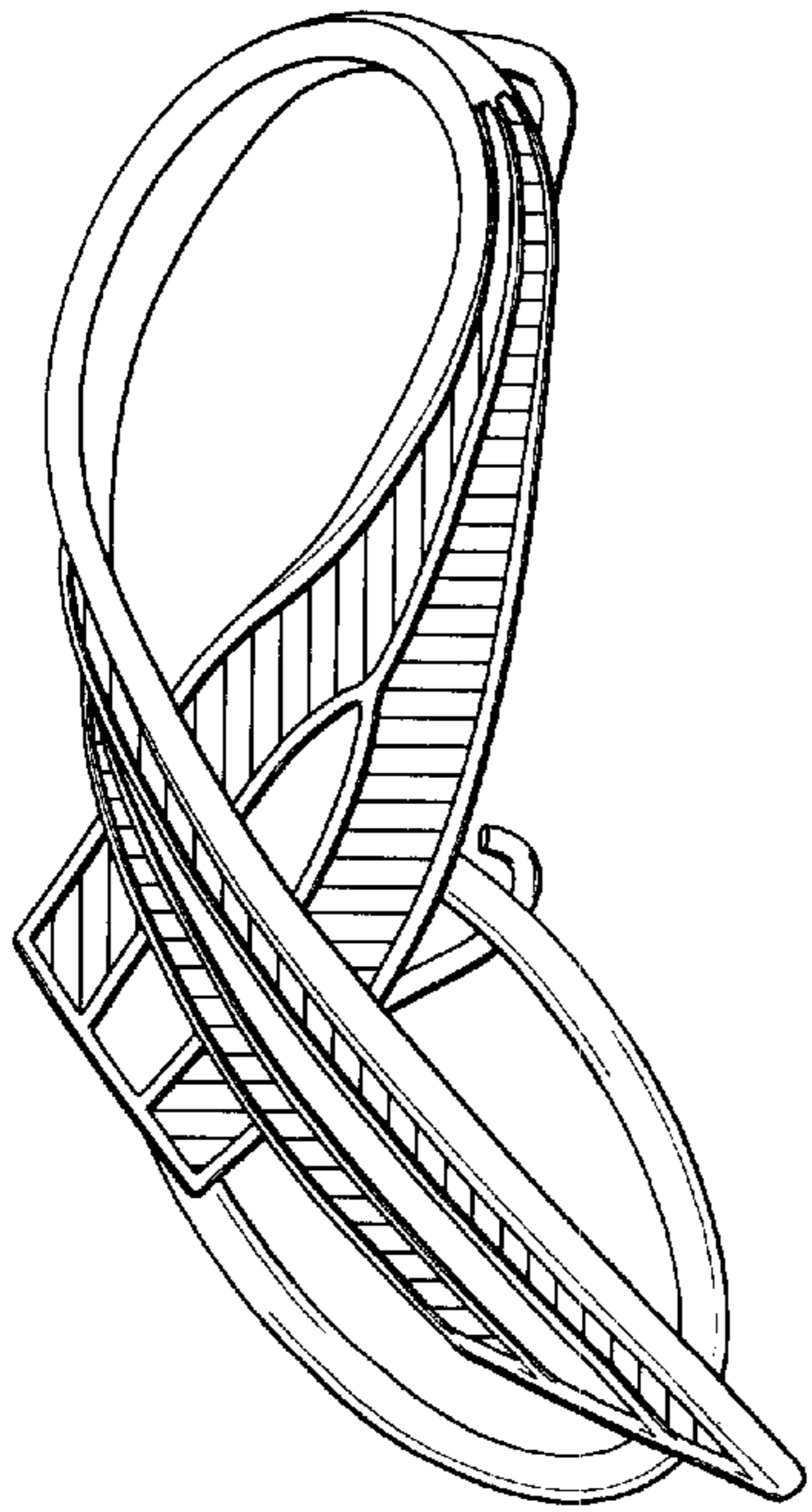
FIG. 6 is a top view thereof; and,

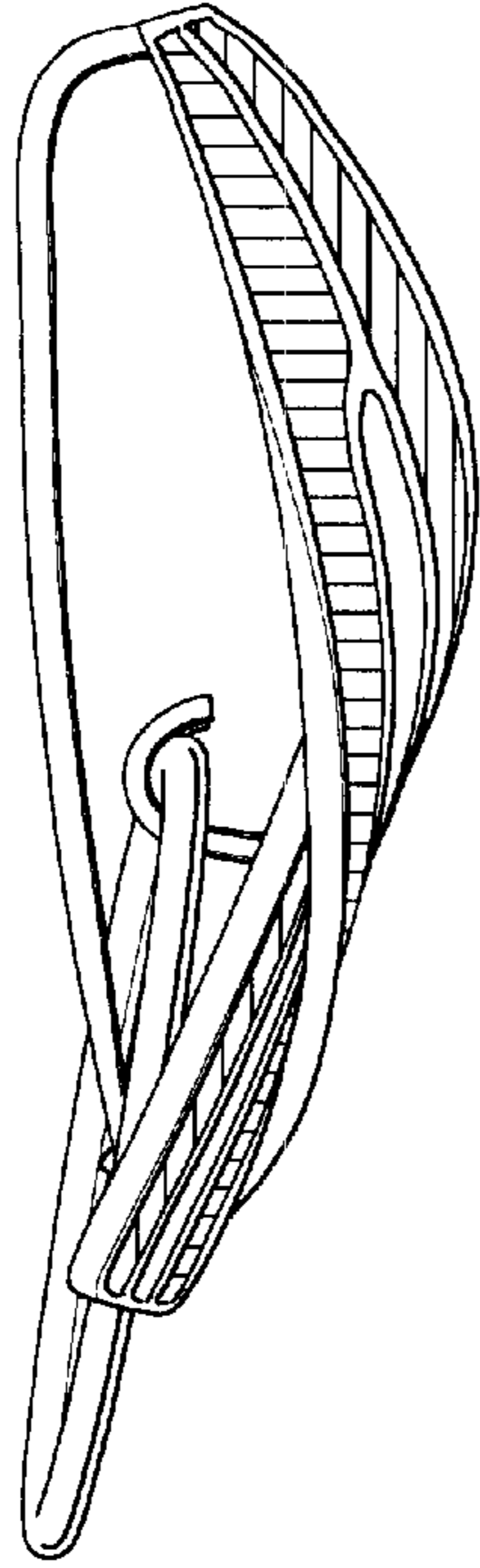

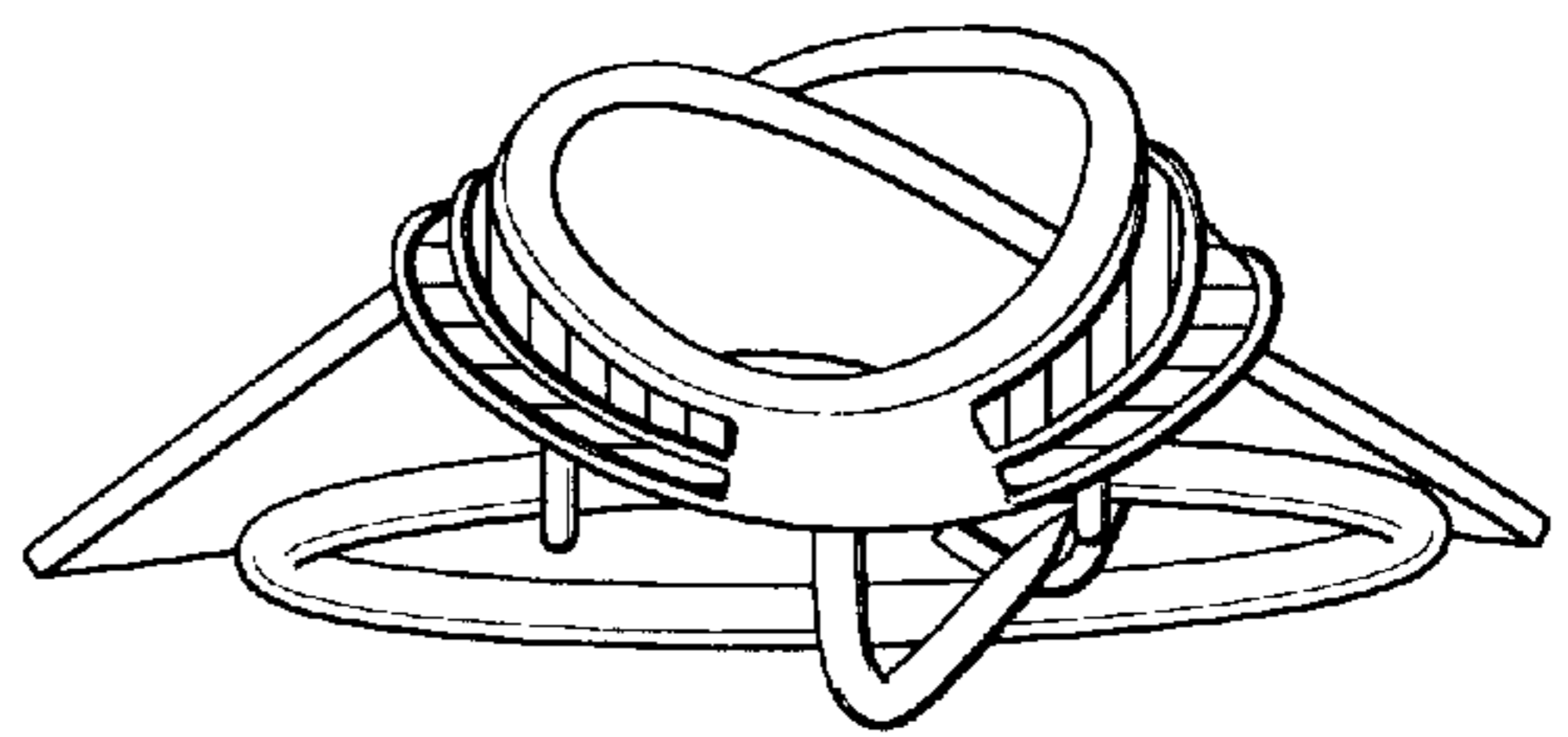

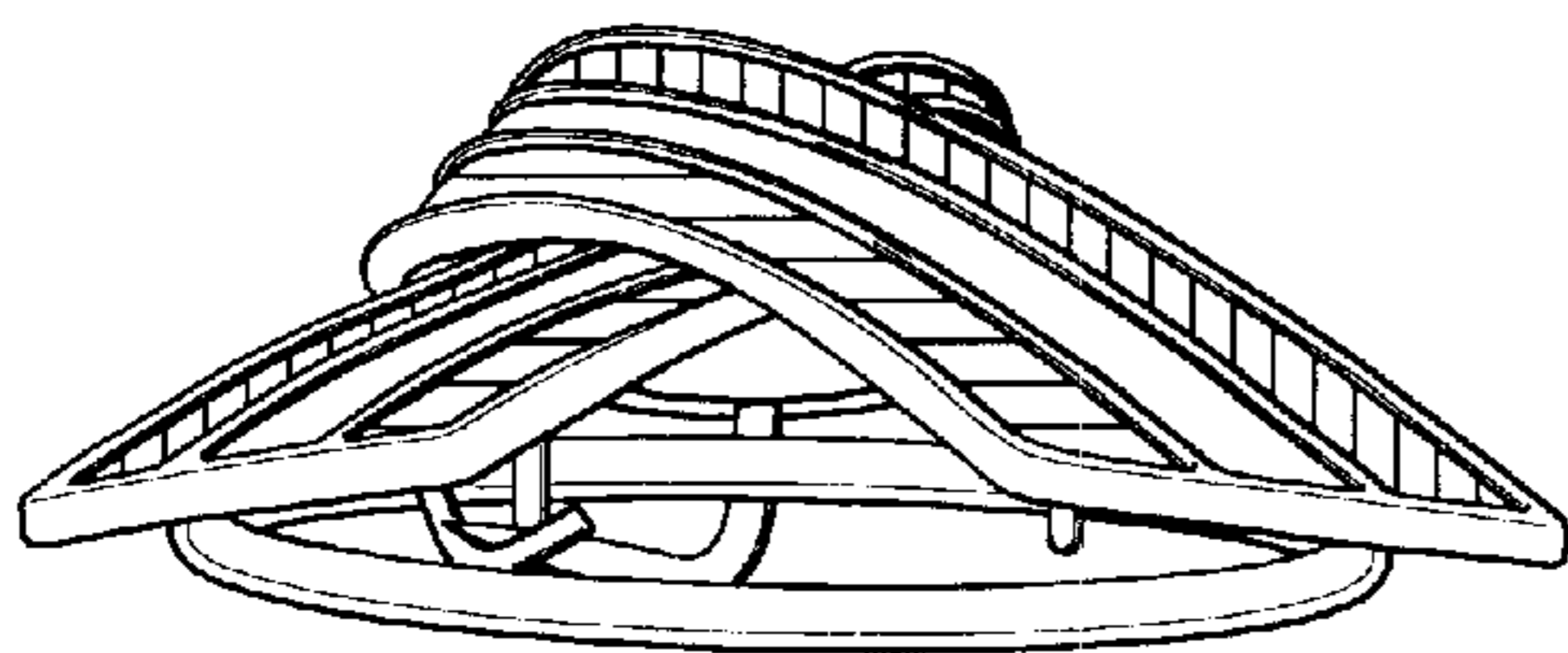
