The ornamental design for a combined indicating device for vehicles, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, left side perspective view of the combined indicating device for vehicles of the present invention; FIG. 2 is an enlarged front perspective view thereof; FIG. 3 is an enlarged left side view thereof; FIG. 4 is an enlarged right side view thereof; and, FIG. 5 is an enlarged top view thereof.

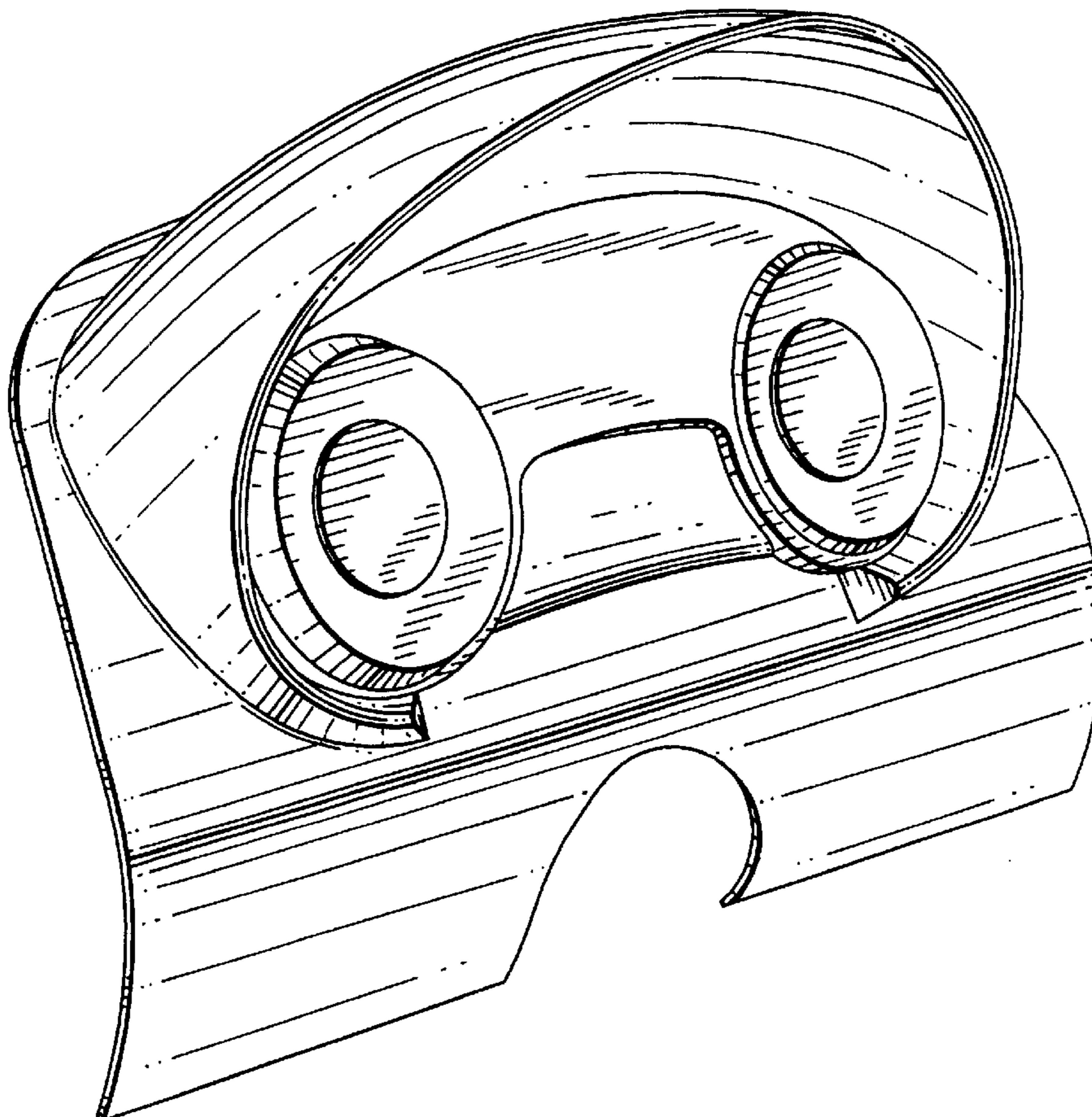
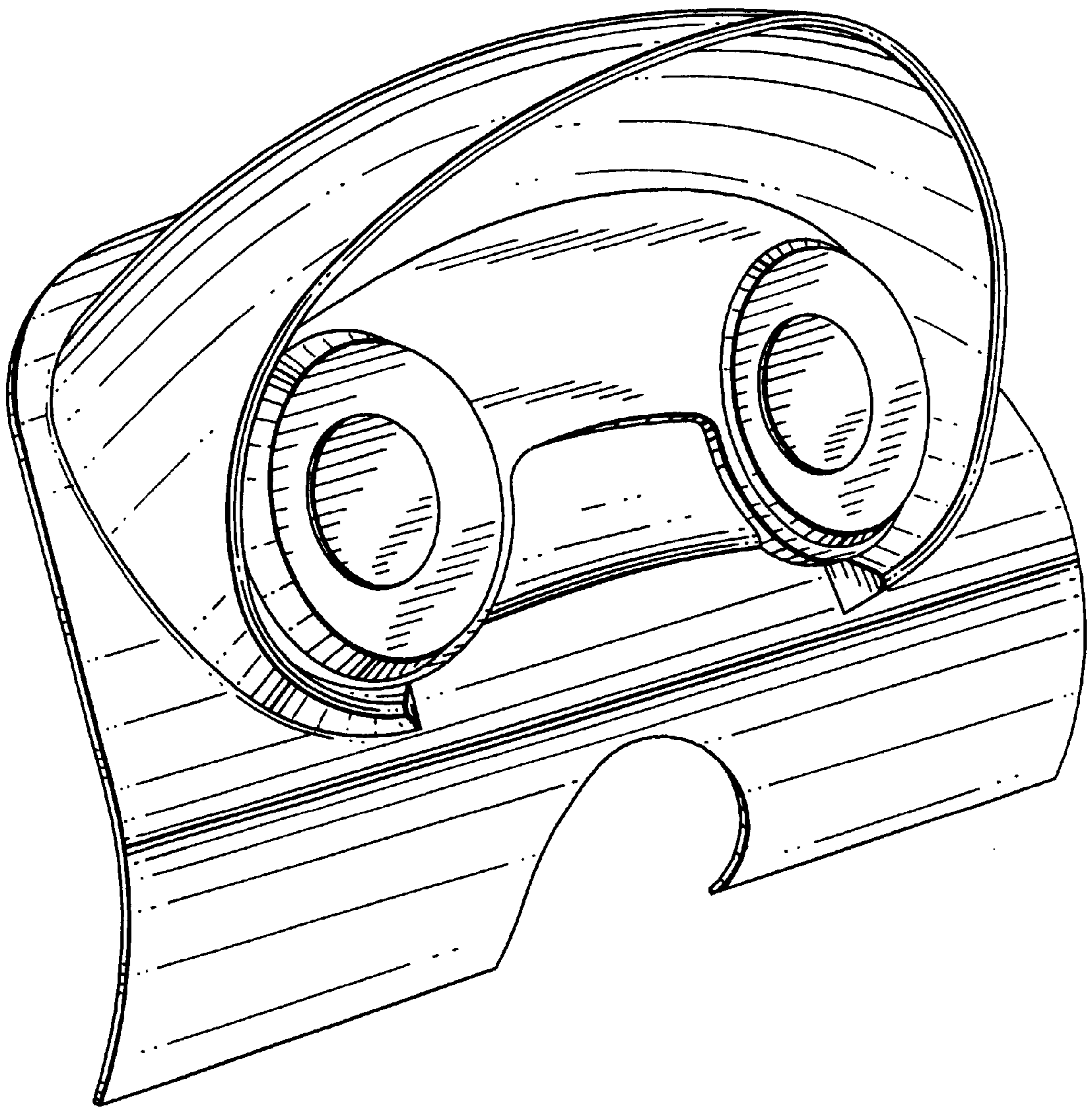

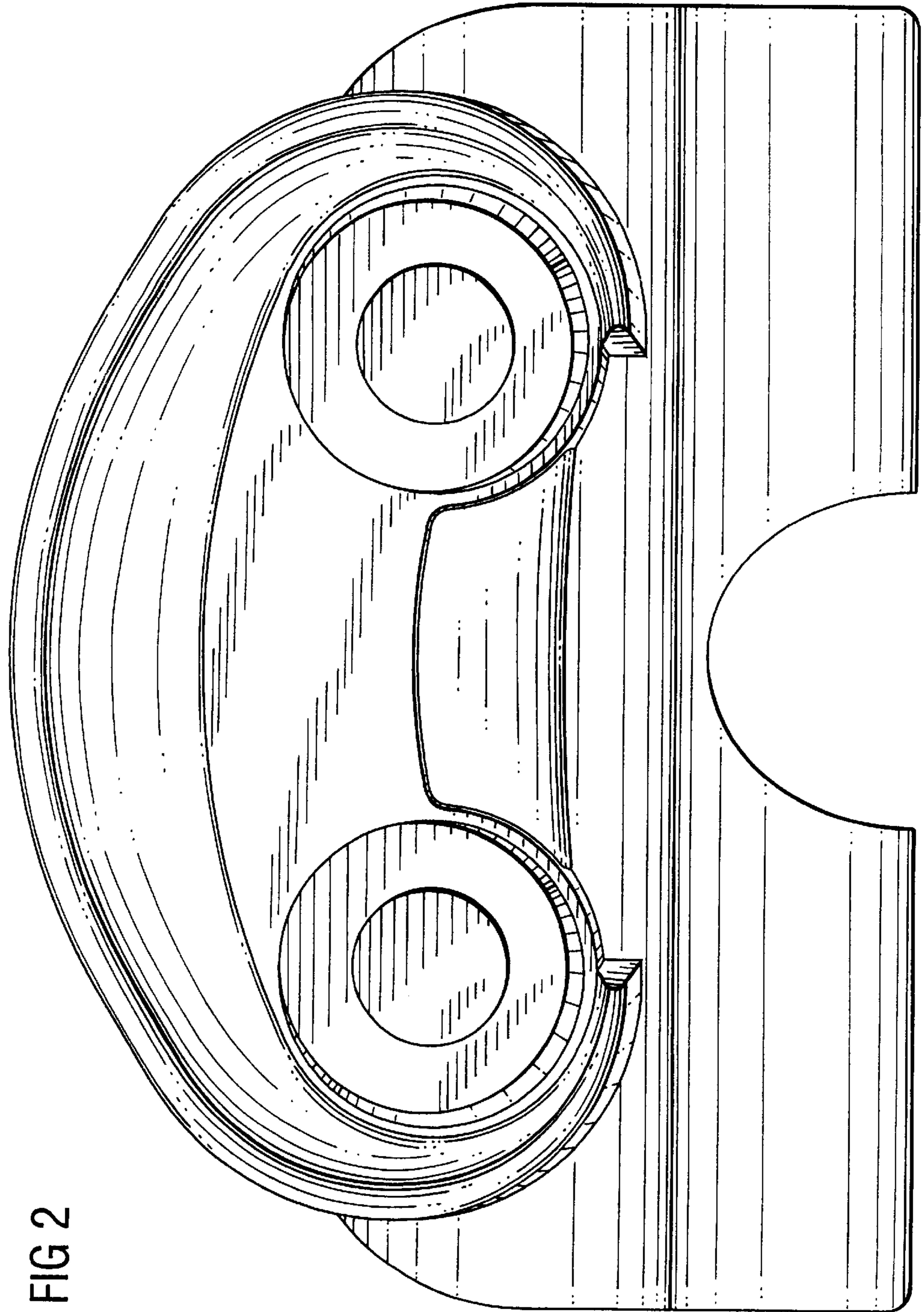

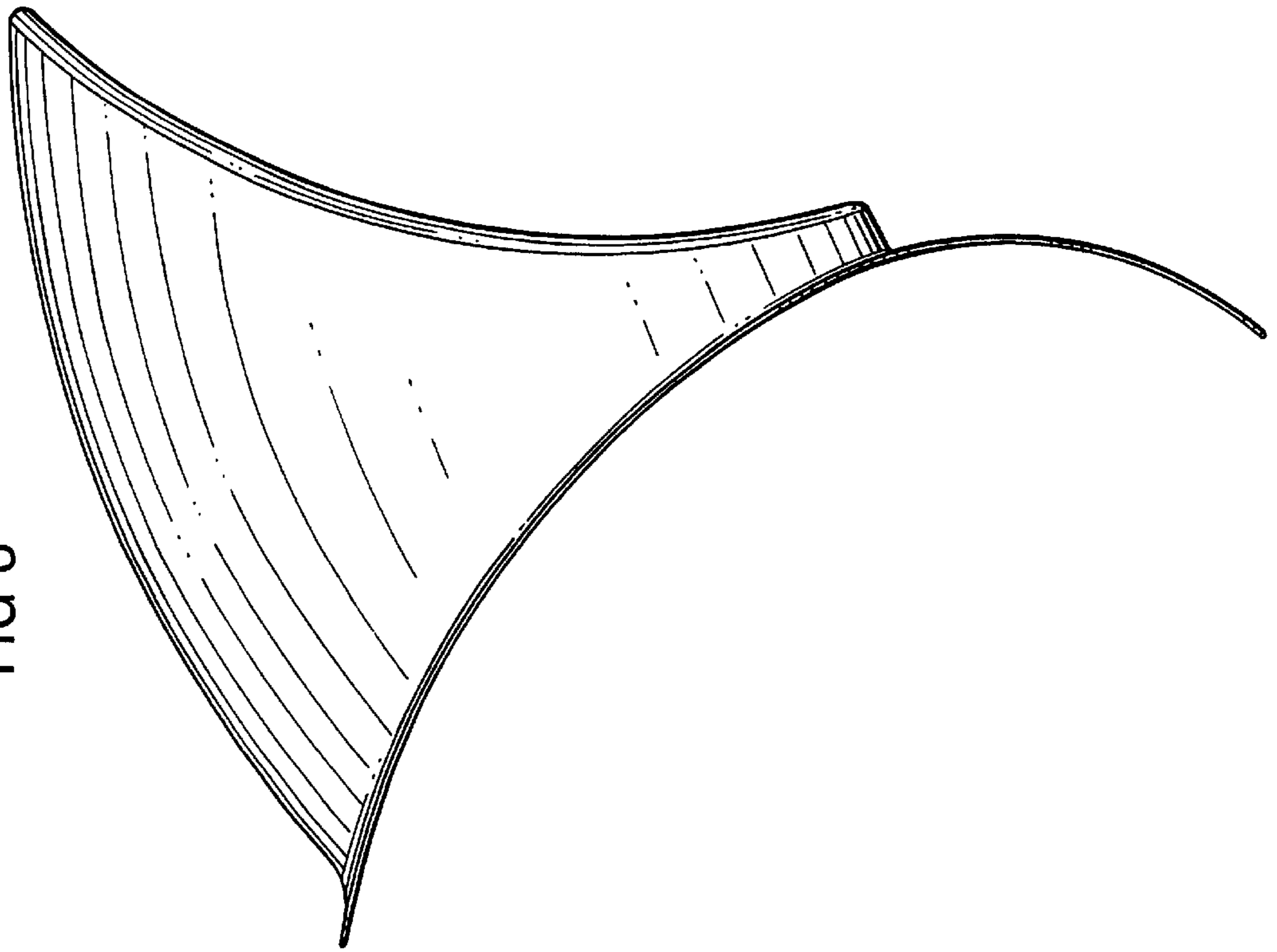
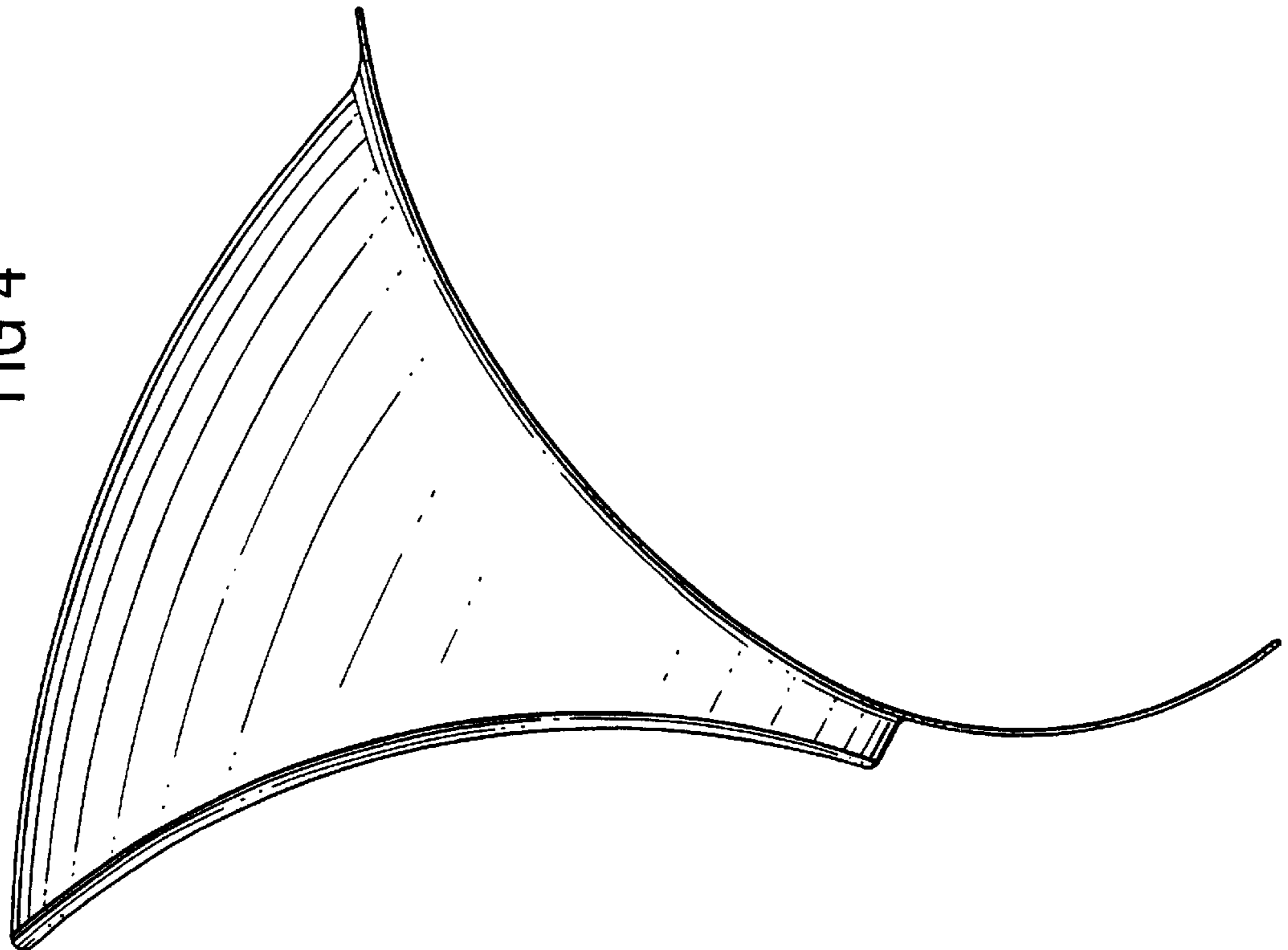

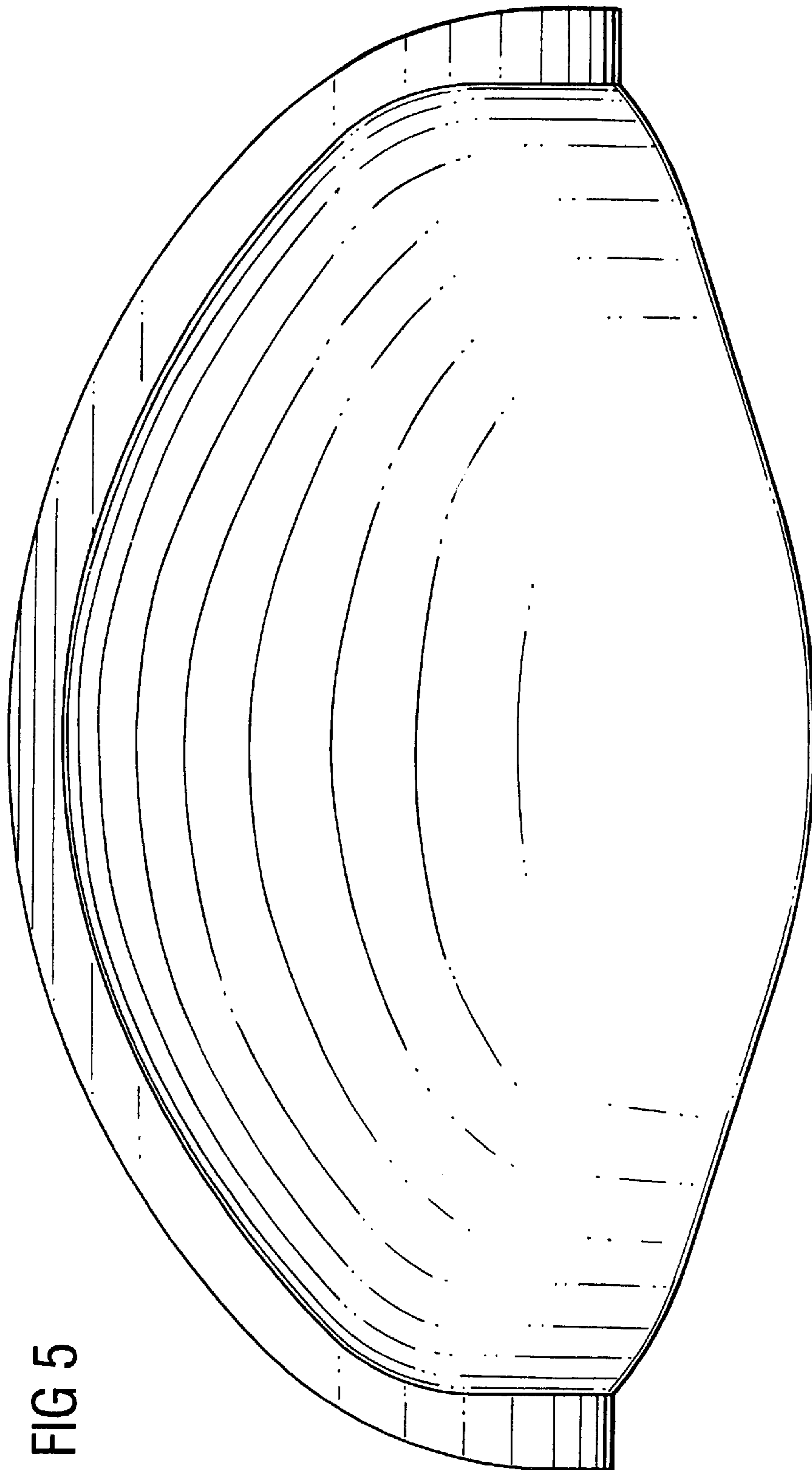
