DESCRIPTION

FIG. 1 is a front elevational view of the decorative light of
the present invention;

FIG. 2 is a rear elevational view of the decorative light of
FIG. 1;

FIG. 3 is a right side elevational view of the decorative light
of FIG. 1;

FIG. 4 is a left side elevational view of the decorative light
of FIG. 1;

FIG. 5 is a top plan view of the decorative light of FIG. 1;
and,

FIG. 6 is a bottom plan view of the decorative light of FIG.
1.

The cord ends are shown broken away to depict indetermi-
nate length.

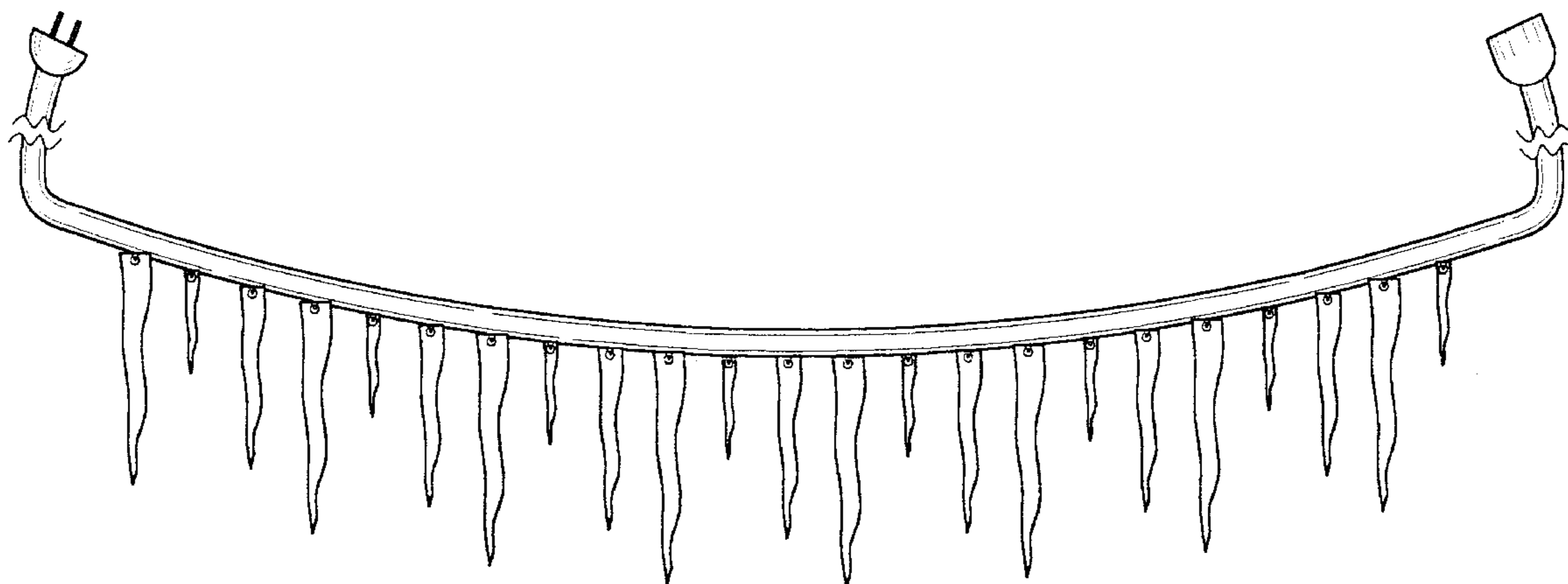

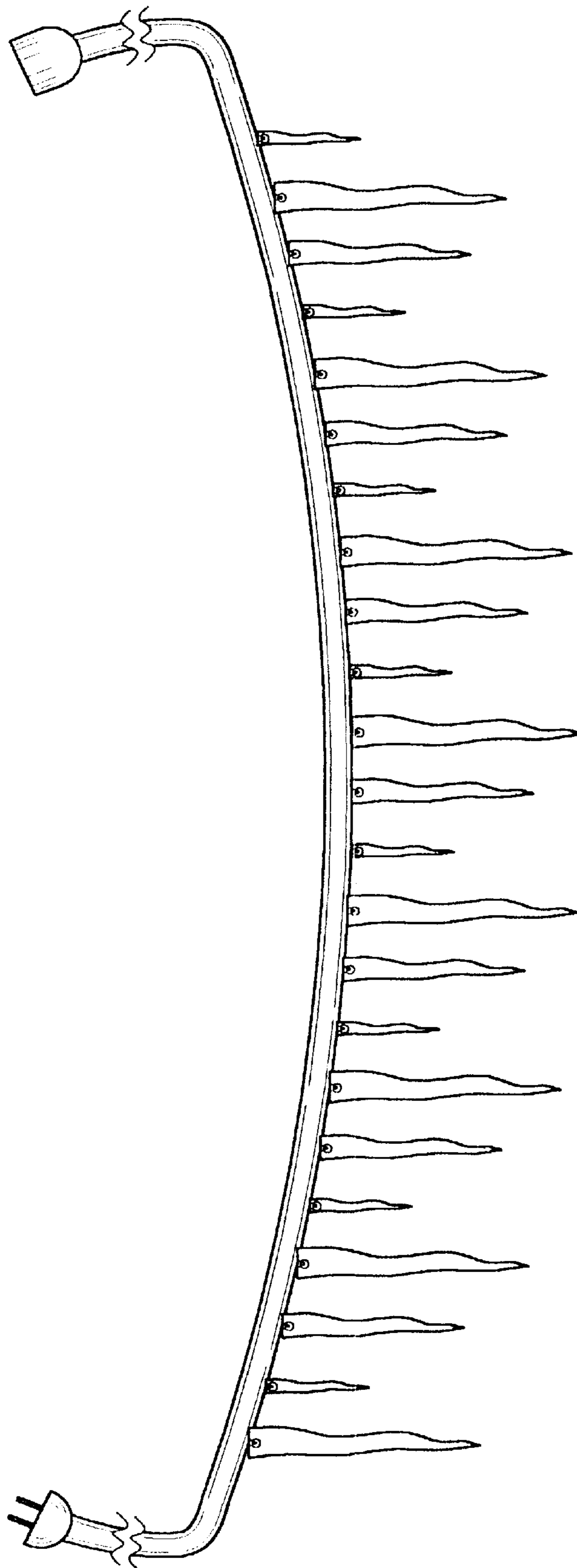

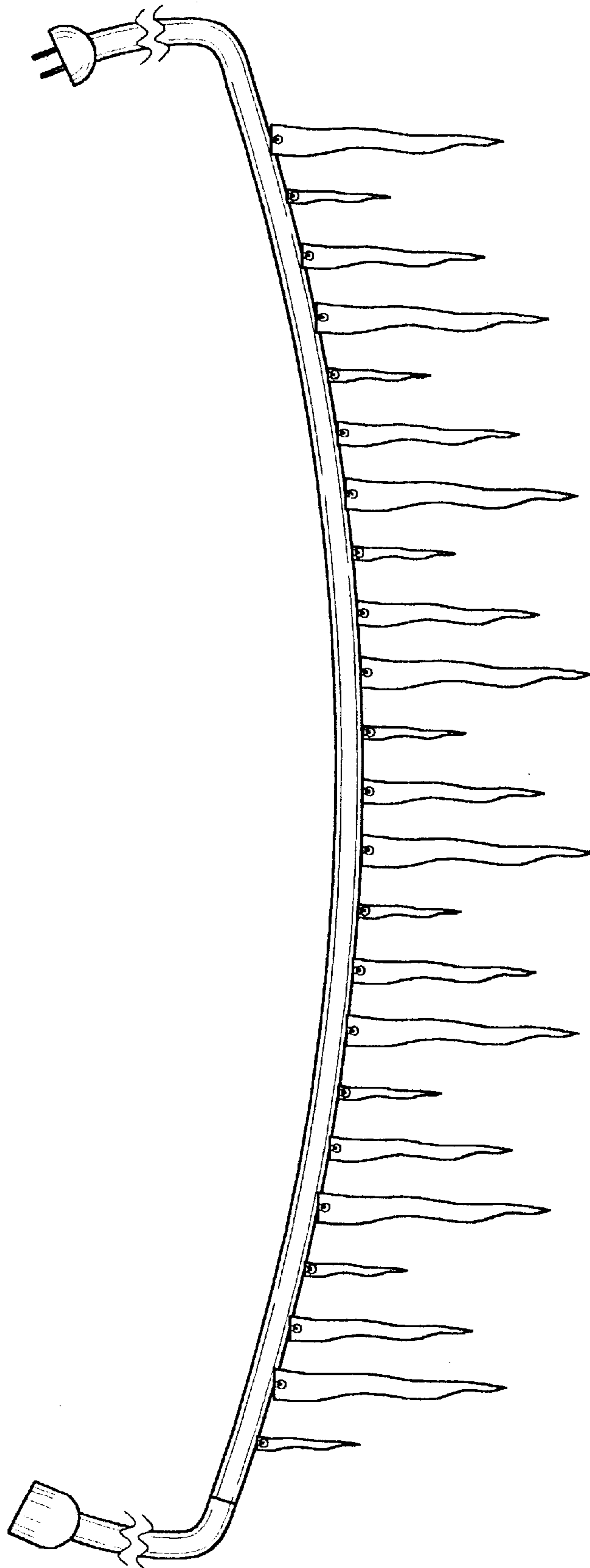

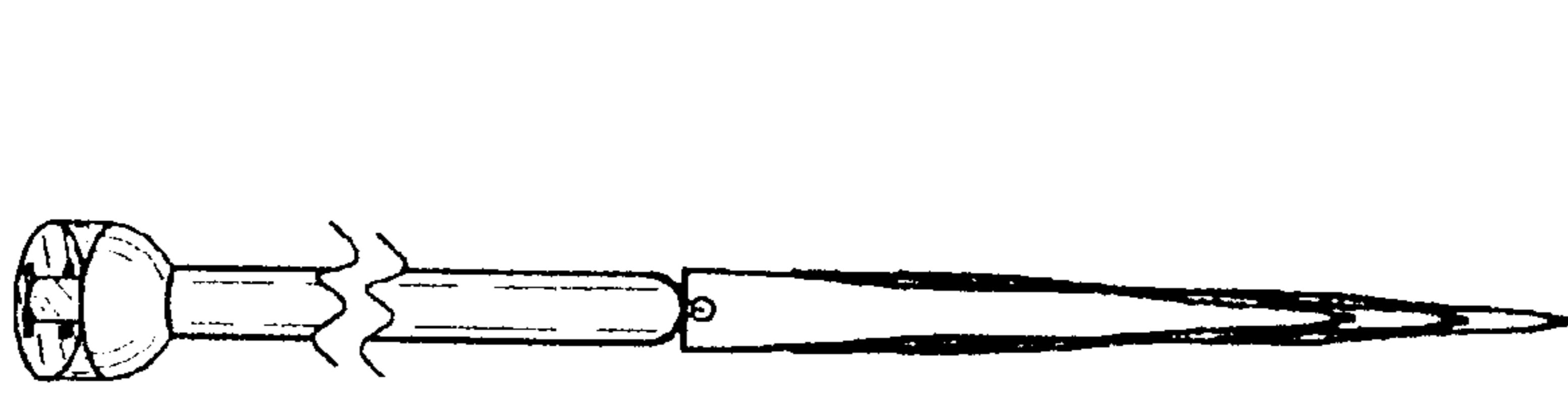

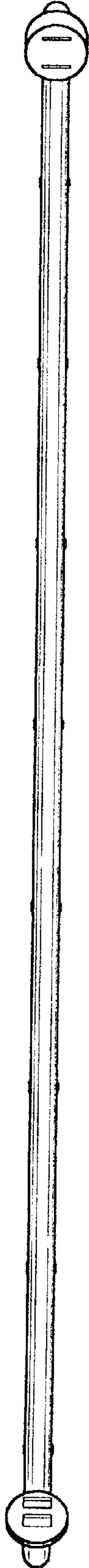

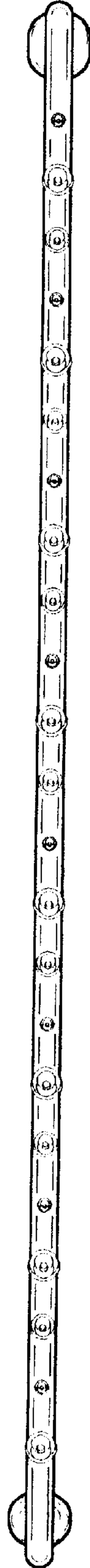
