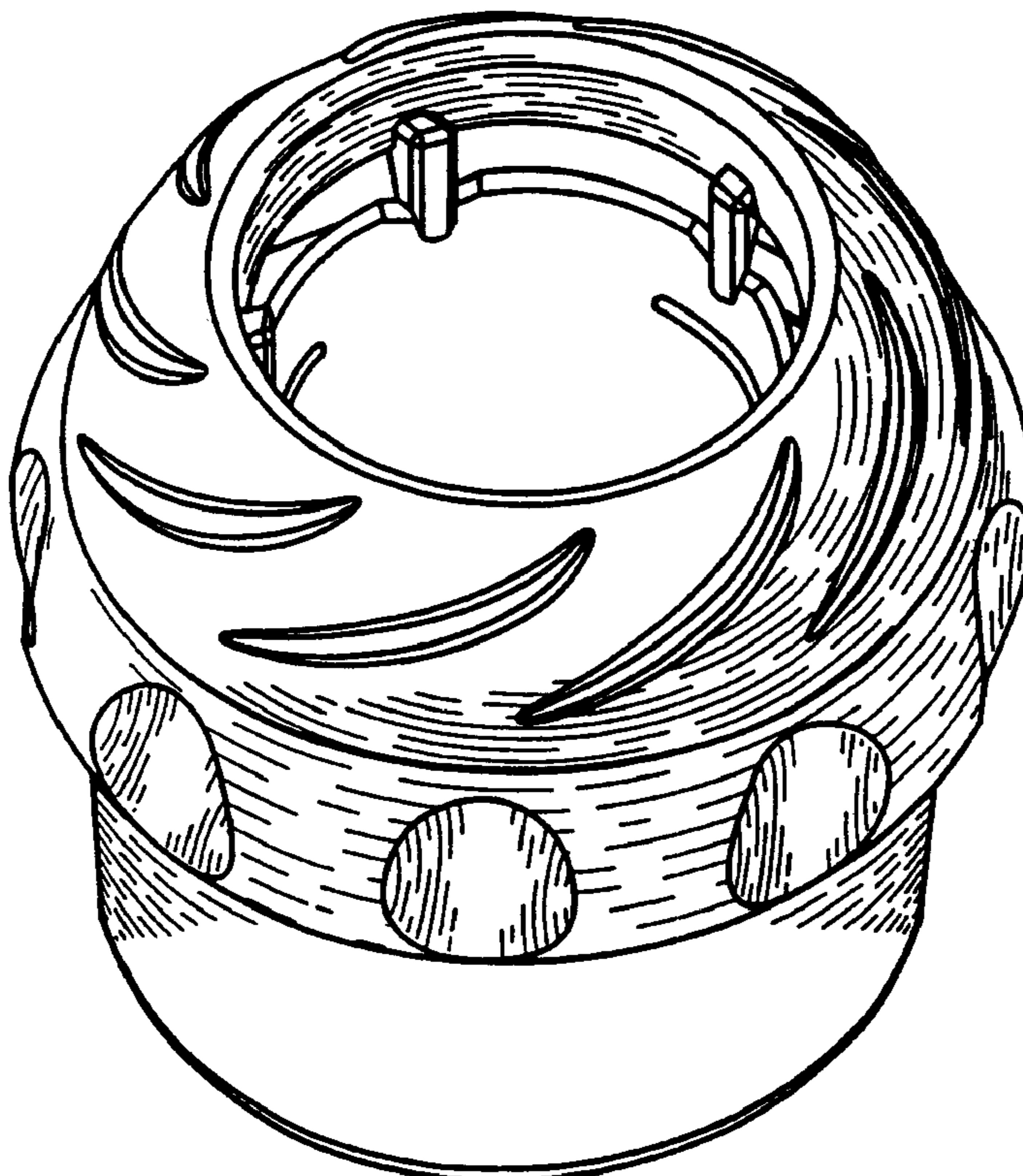
(57) **CLAIM**

We claim the ornamental design for a fabric softener dispenser, substantially as shown.

DESCRIPTION

FIG. 1 is a pictorial view of the fabric softener dispenser. FIG. 2 is a top plan view thereof. FIG. 3 is a front elevational view thereof, the side and rear views being the same; and, FIG. 4 a bottom plan view thereof.

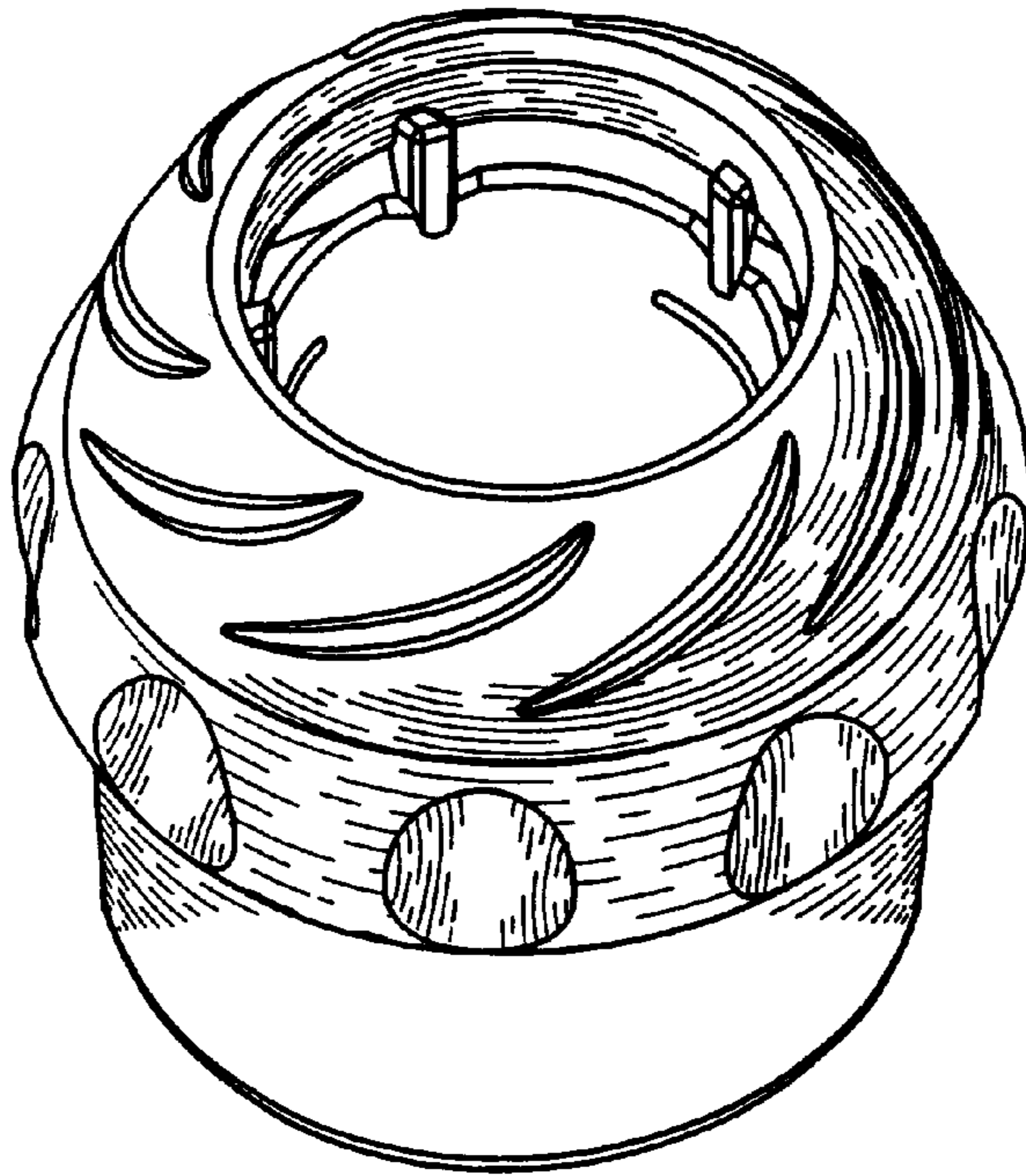

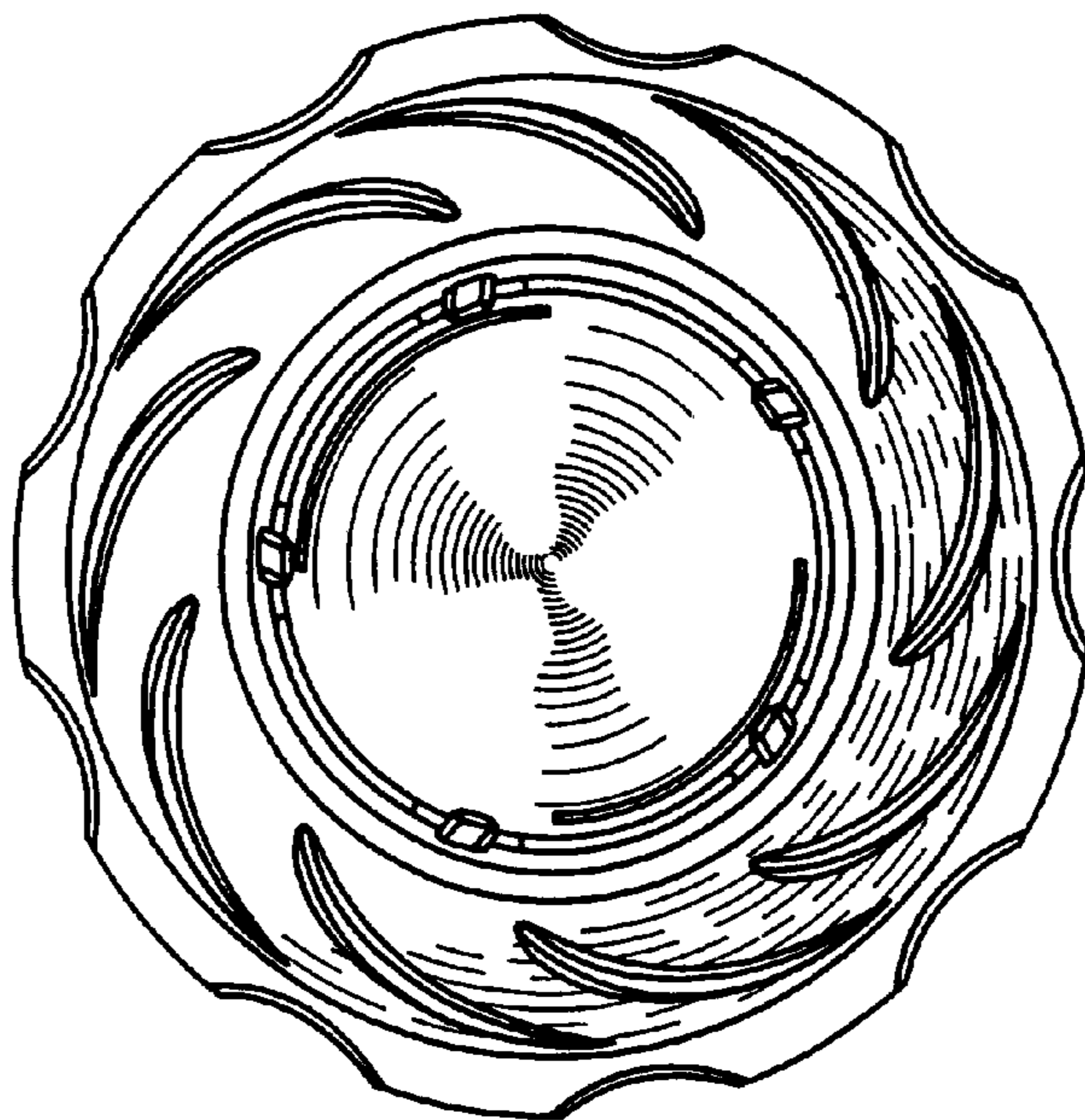

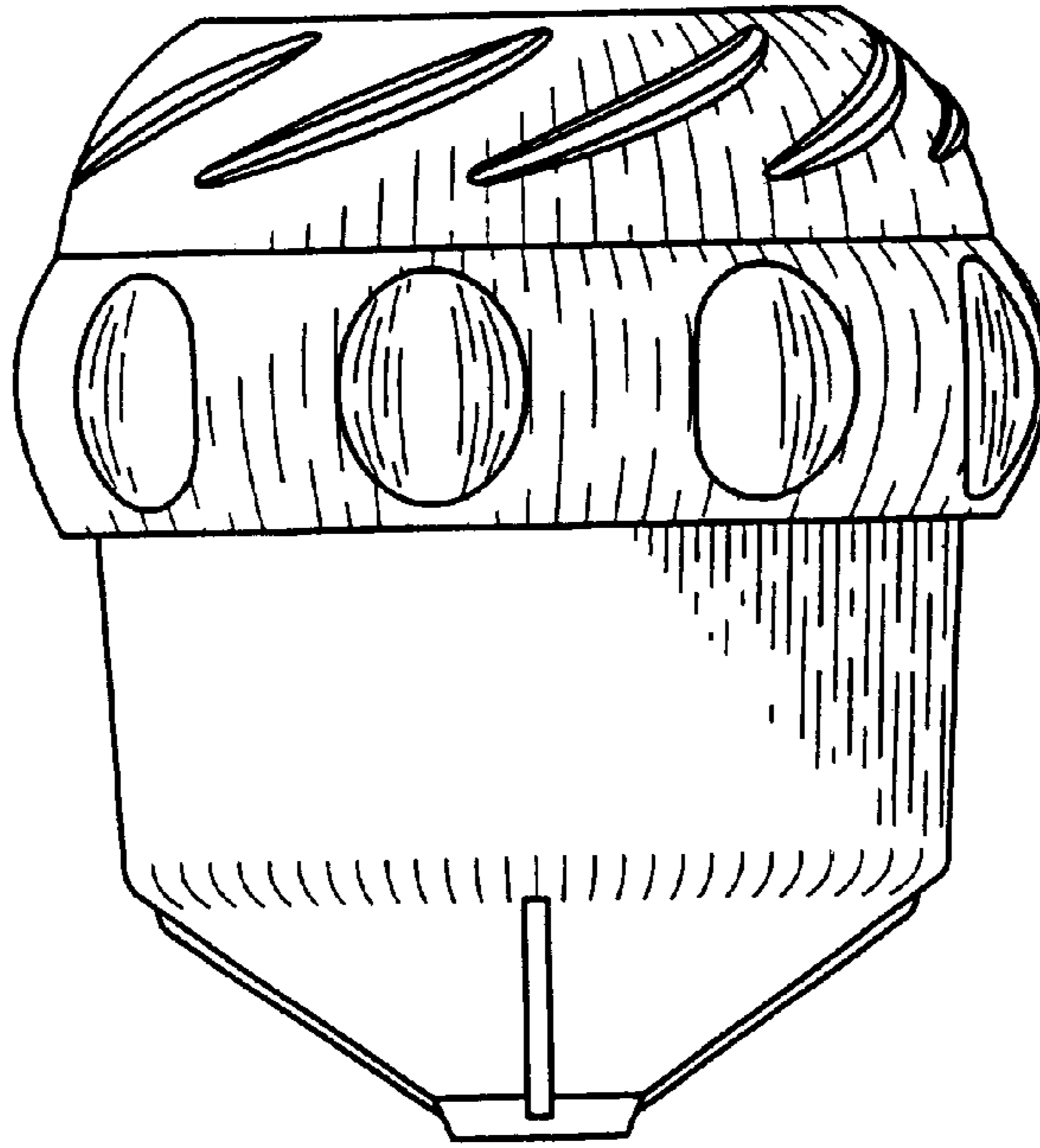

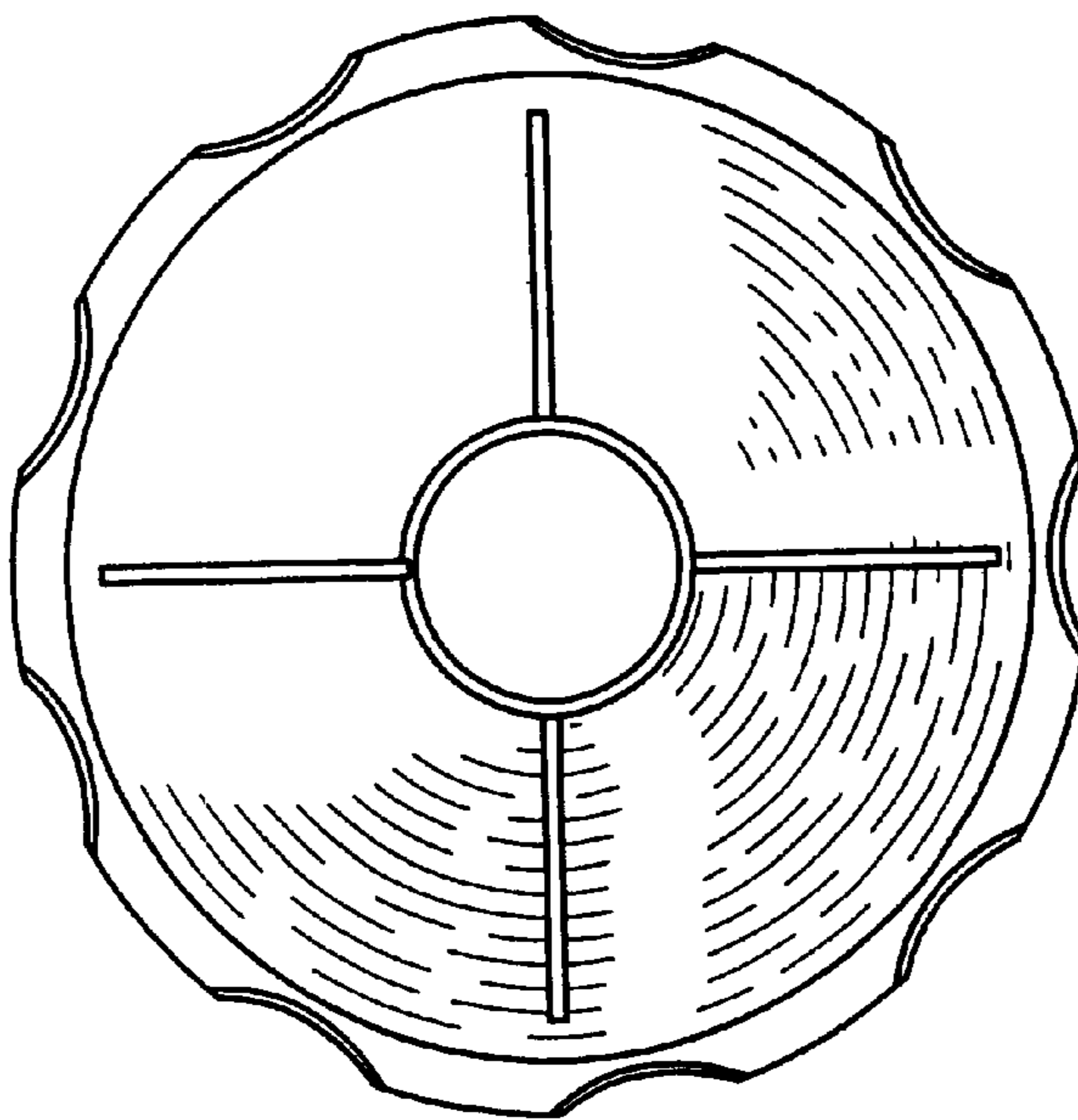
