The ornamental design for a carving set case, as shown.

DESCRIPTION

FIG. 1 is a perspective view of the inventive design; FIG. 2 is an end elevational view of the design of FIG. 1; FIG. 3 is an opposite end elevational view of the design of FIG. 1;

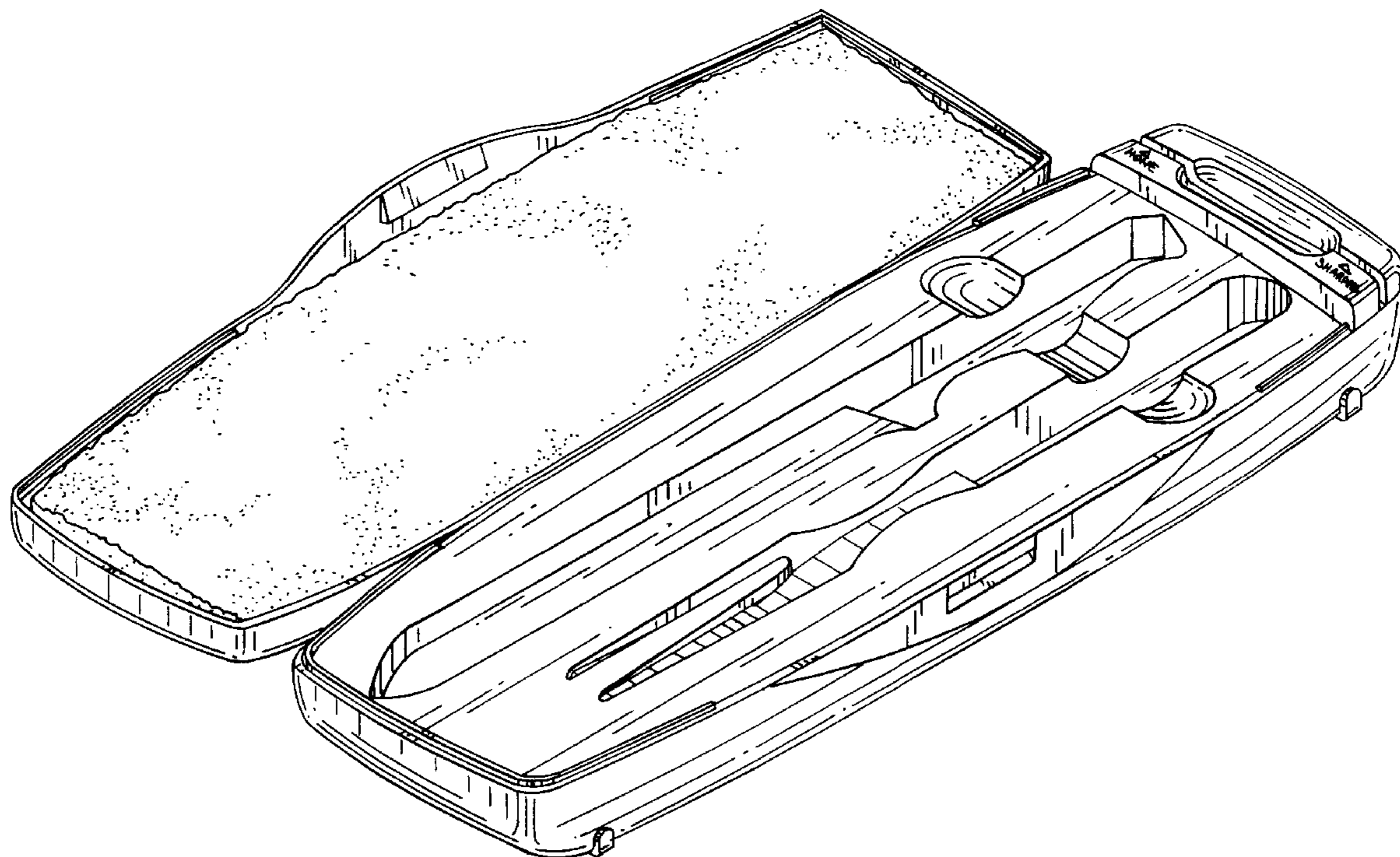

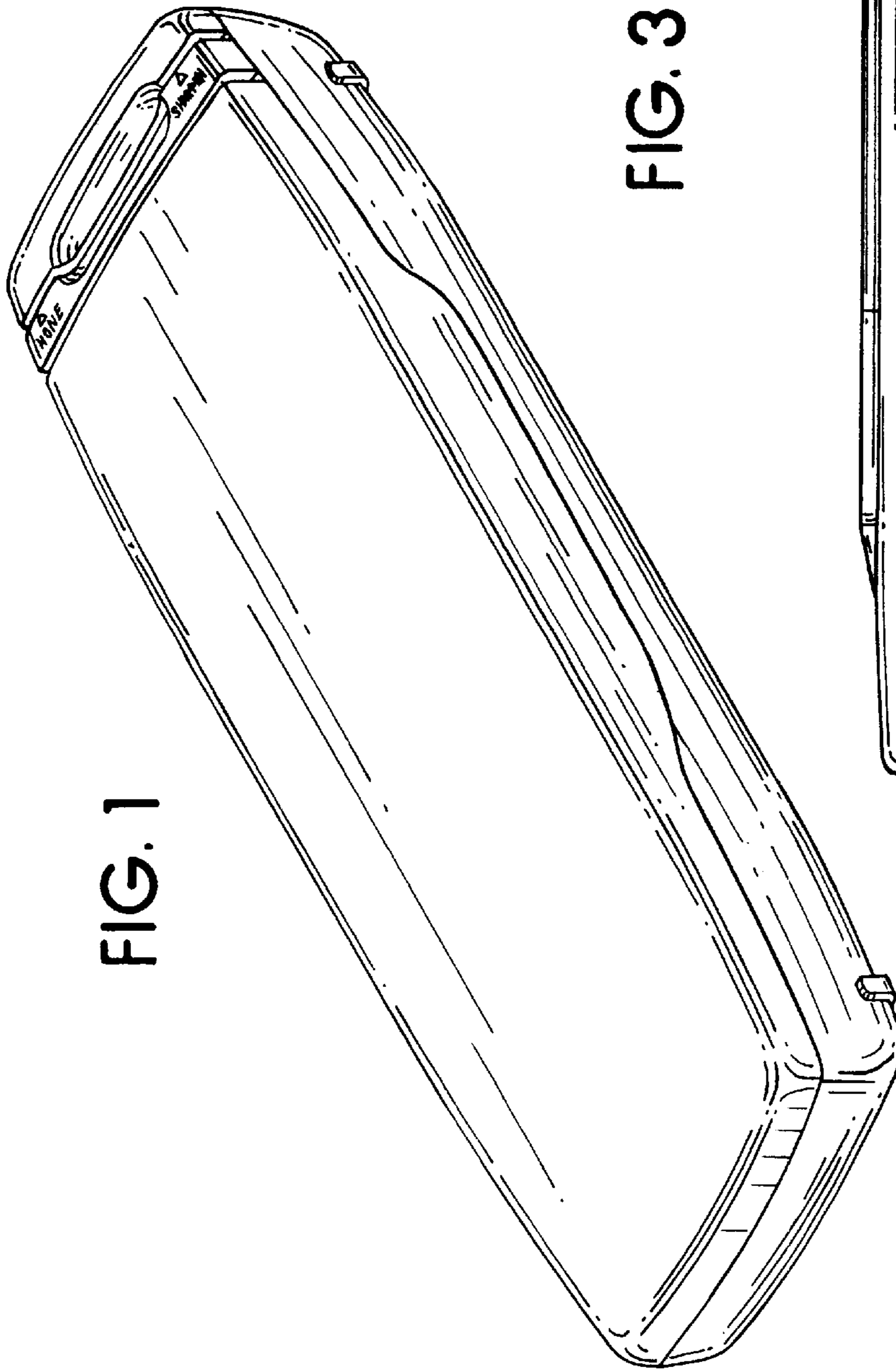

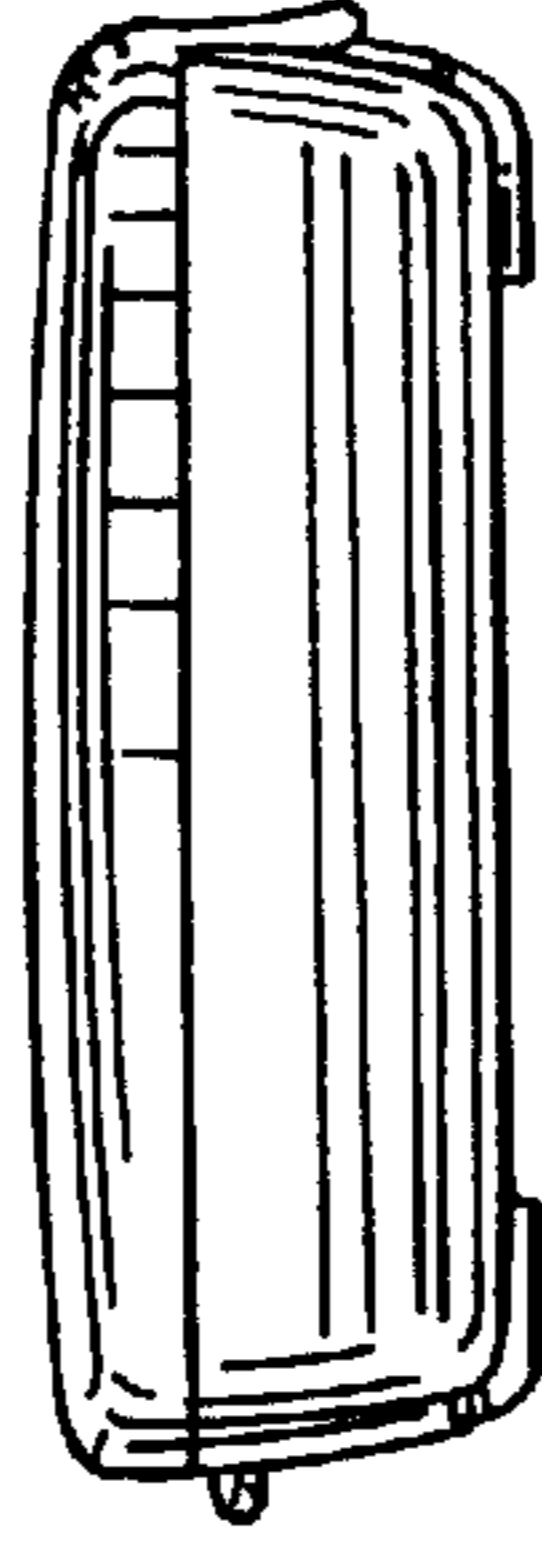

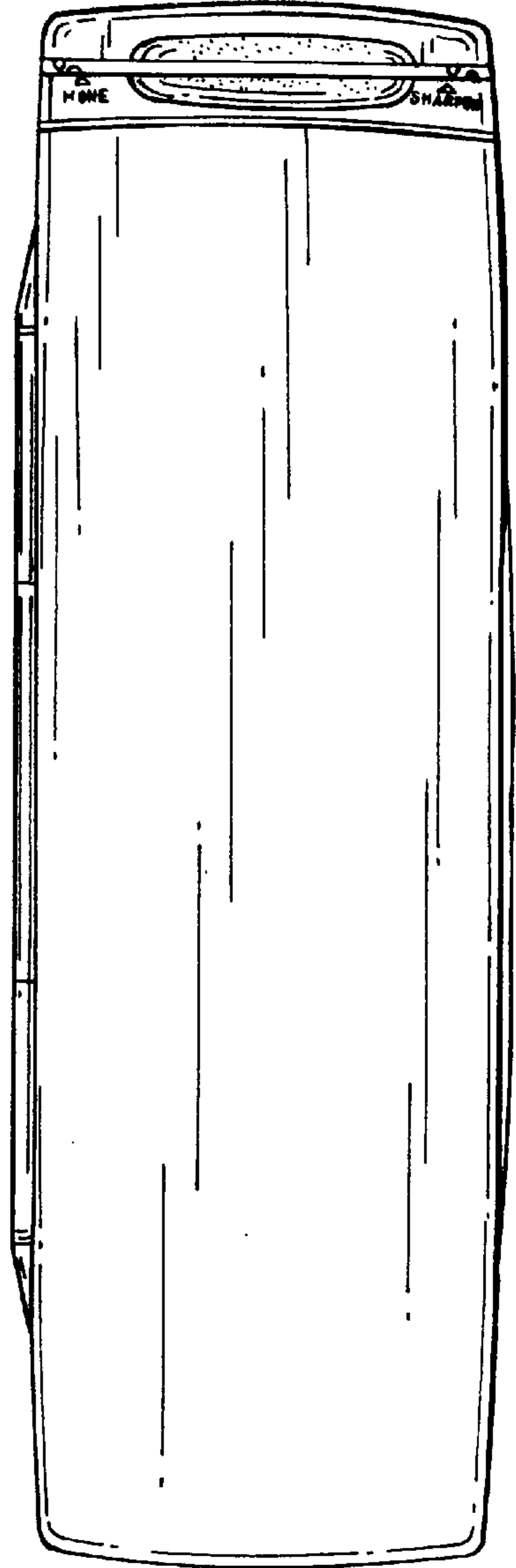
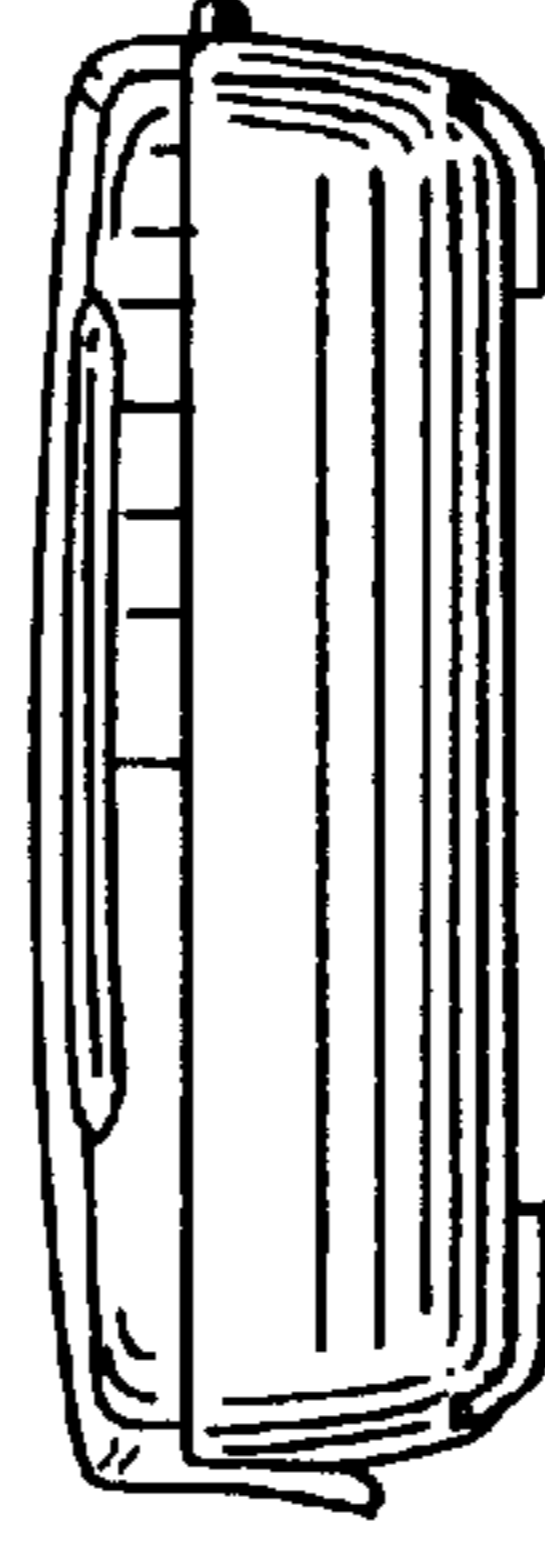

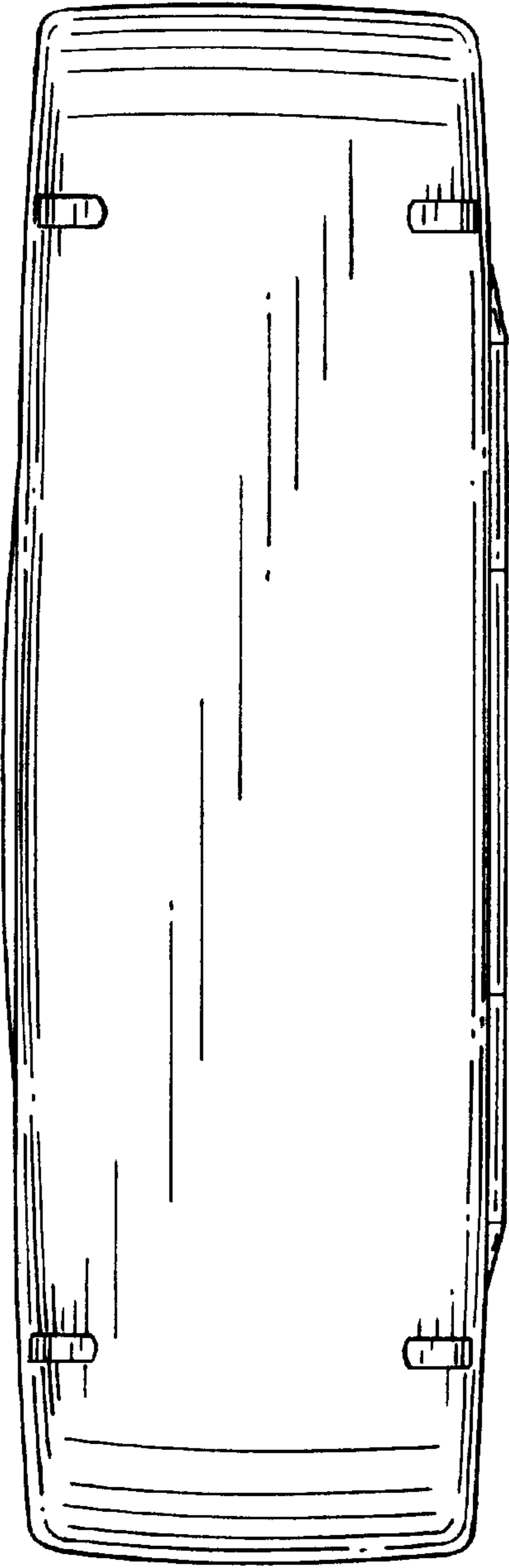

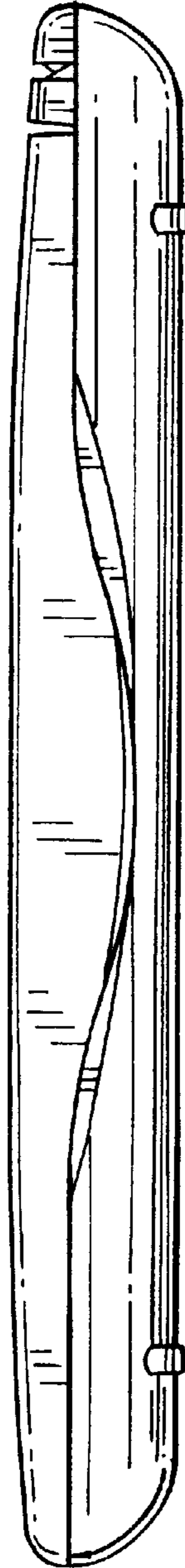
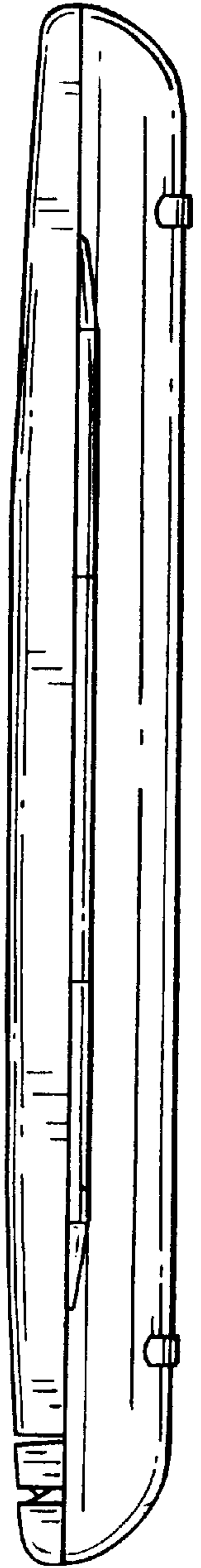

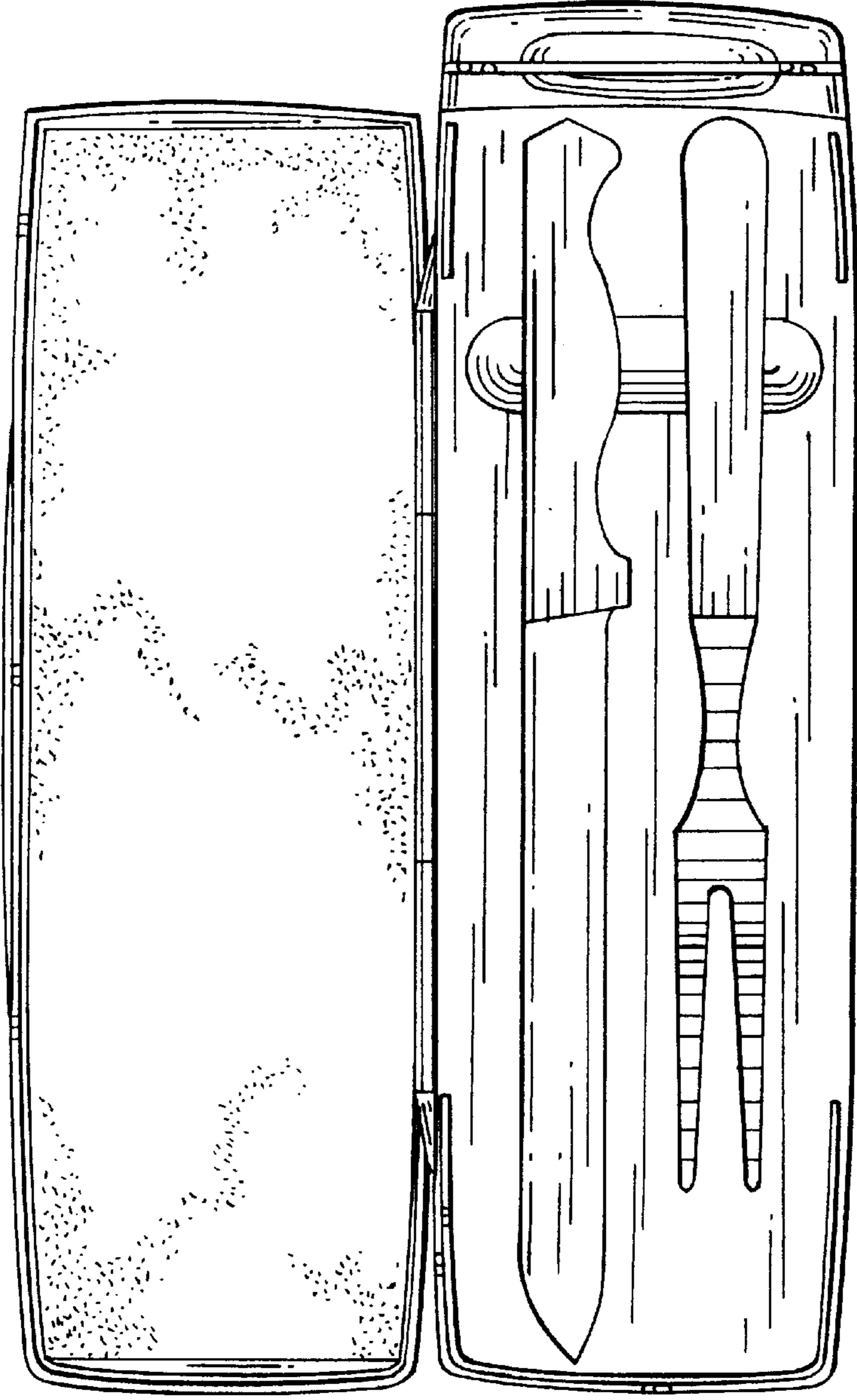

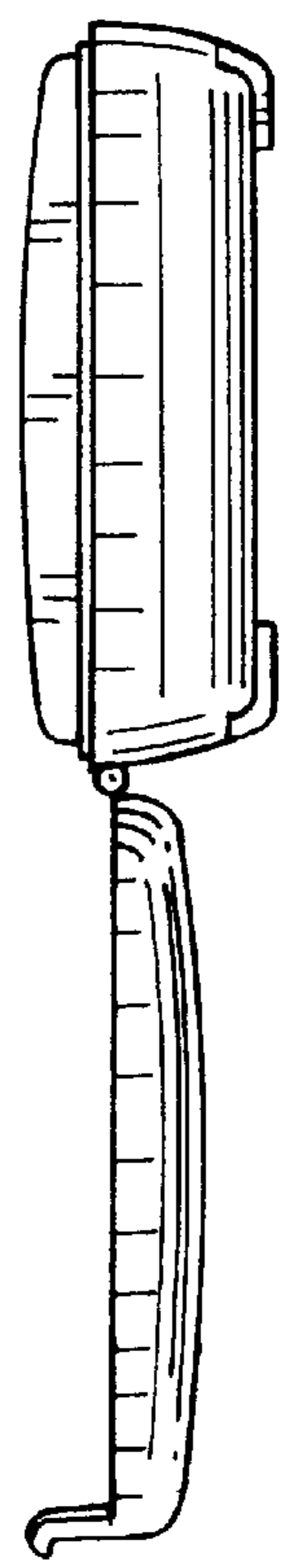
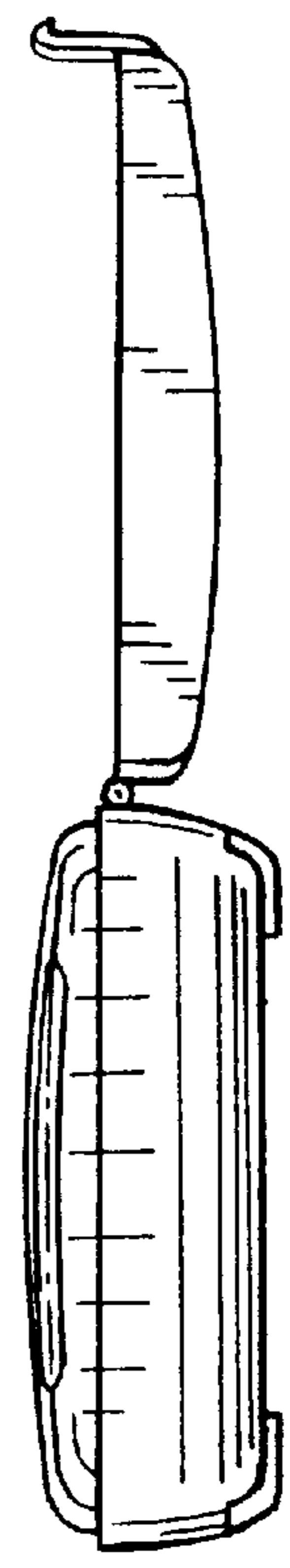

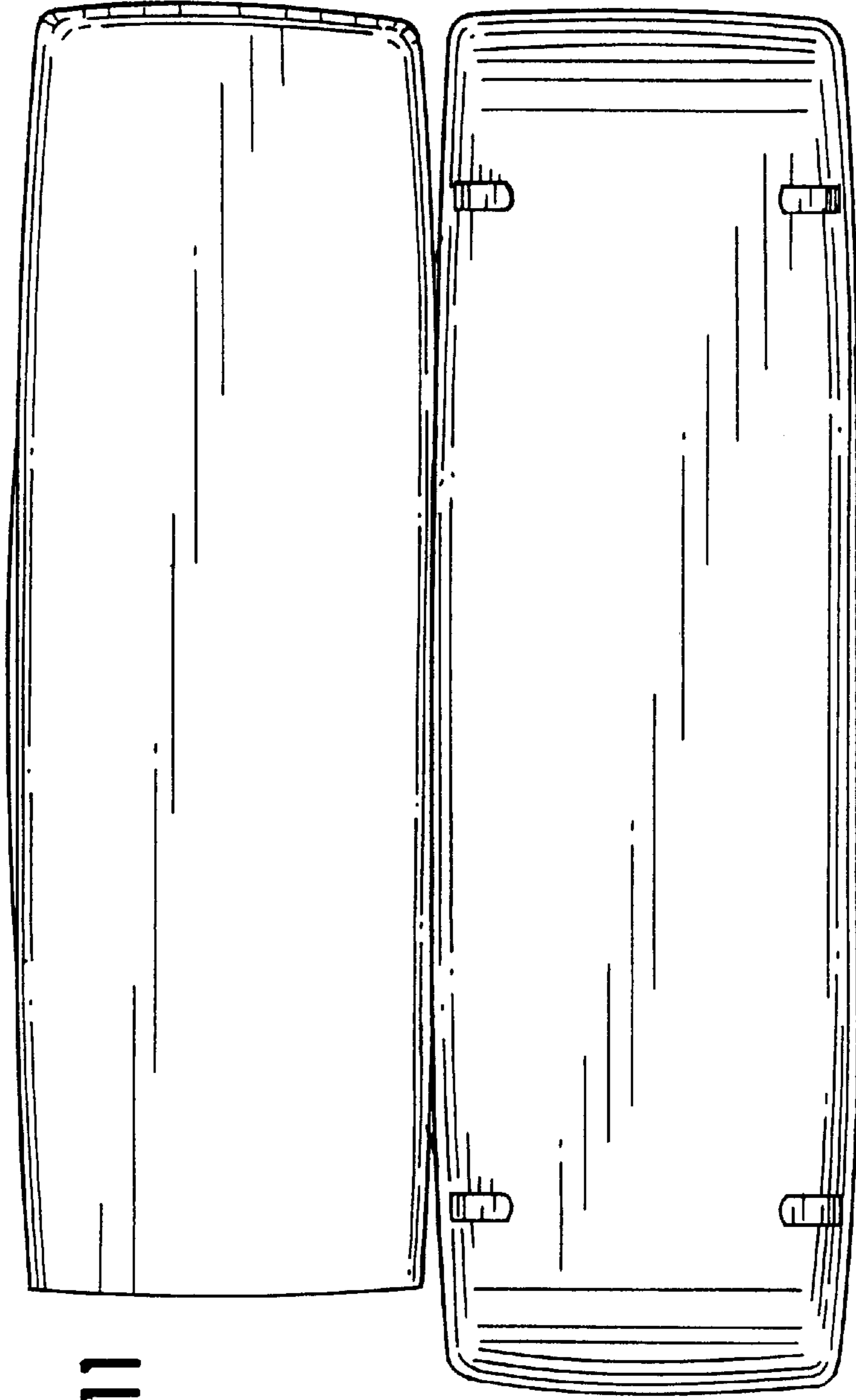

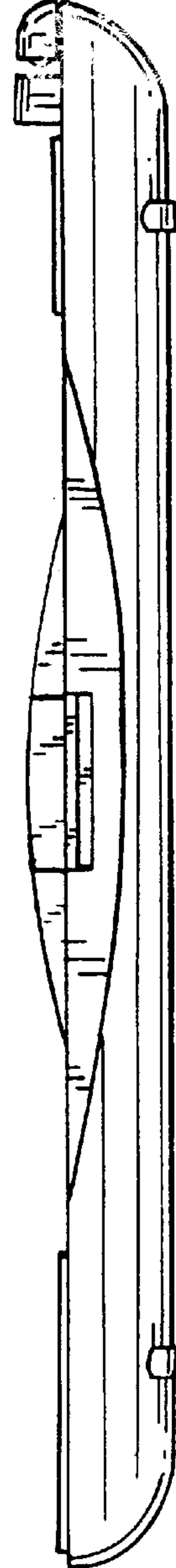

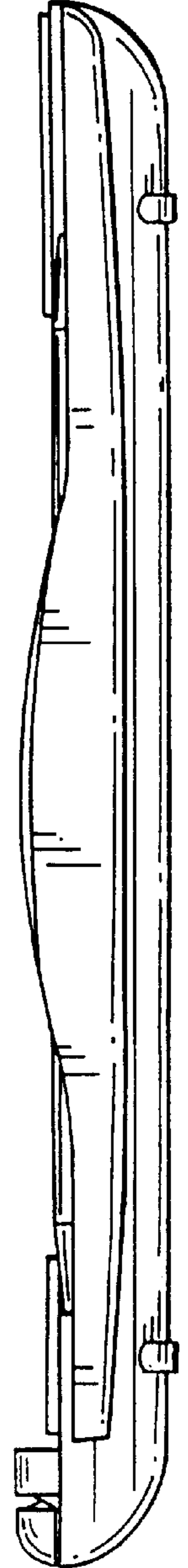
