(57) **CLAIM**

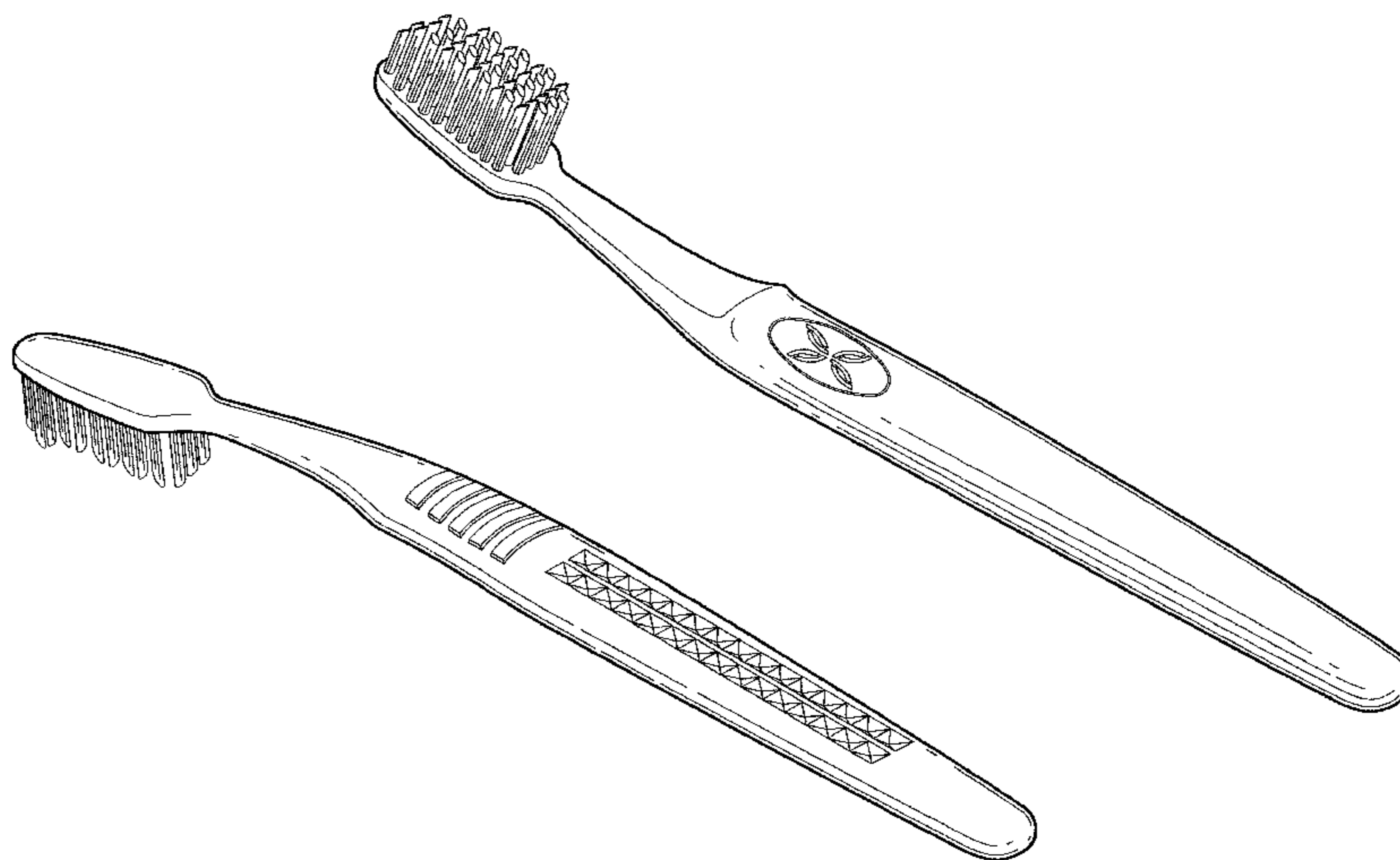
The ornamental design for a toothbrush, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a toothbrush of my new design;
FIG. 2 is a left side elevation view thereof; the right side elevation being a mirror image;
FIG. 3 is a back elevation view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a front perspective view, as viewed from the bottom left side thereof;
FIG. 7 is a back perspective view, as viewed from the bottom right side thereof;

FIG. 8 is a front elevation view of a second alternative embodiment of the toothbrush of my new design;
FIG. 9 is a left side elevation view thereof; the right side elevation being a mirror image;
FIG. 10 is a back elevation view thereof;
FIG. 11 is a top plan view thereof;
FIG. 12 is a bottom plan view thereof;
FIG. 13 is a front perspective view, as viewed from the bottom left side thereof;
FIG. 14 is a back perspective view, as viewed from the bottom right side thereof;
FIG. 15 is a front elevation view of a third alternative embodiment of the toothbrush of my new design having a transparent handle;
FIG. 16 is a left side elevation view thereof; the right side elevation being a mirror image;
FIG. 17 is a back elevation view thereof;
FIG. 18 is a top plan view thereof;
FIG. 19 is a bottom plan view thereof;
FIG. 20 is a front perspective view, as viewed from the bottom left side thereof;
FIG. 21 is a back perspective view, as viewed from the bottom right side thereof;
FIG. 22 is a front elevation view of a fourth alternative embodiment of the toothbrush of my new design having a transparent handle;
FIG. 23 is a left side elevation view thereof; the right side elevation being a mirror image;
FIG. 24 is a back elevation view thereof;
FIG. 25 is a top plan view thereof;
FIG. 26 is a bottom plan view thereof;
FIG. 27 is a front perspective view, as viewed from the bottom left side thereof; and,
FIG. 28 is a back perspective view, as viewed from the bottom right side thereof.
The bristle patterns of FIGS. 8-14 and 22-28 are shown in broken lines for illustrative purposes only and form no part of the claimed design.

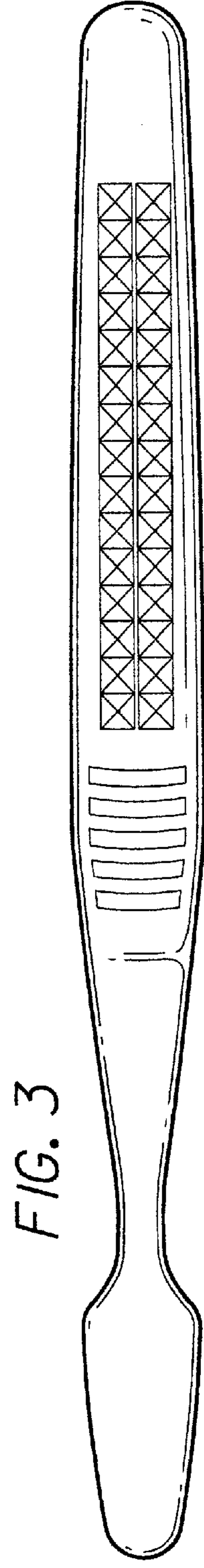
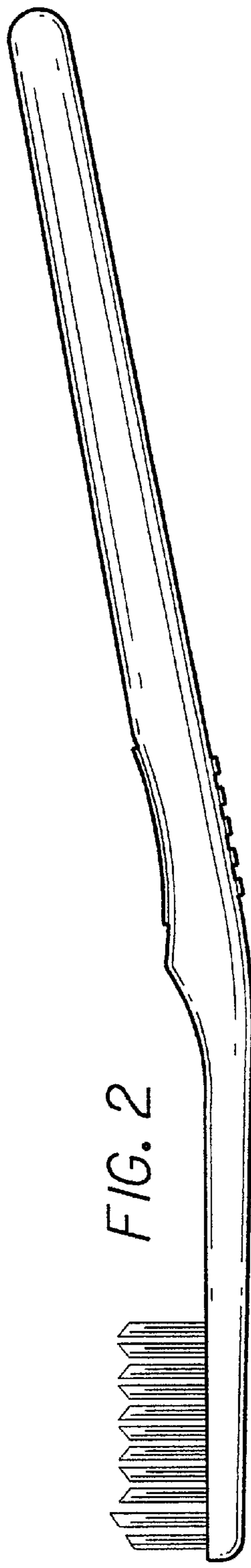
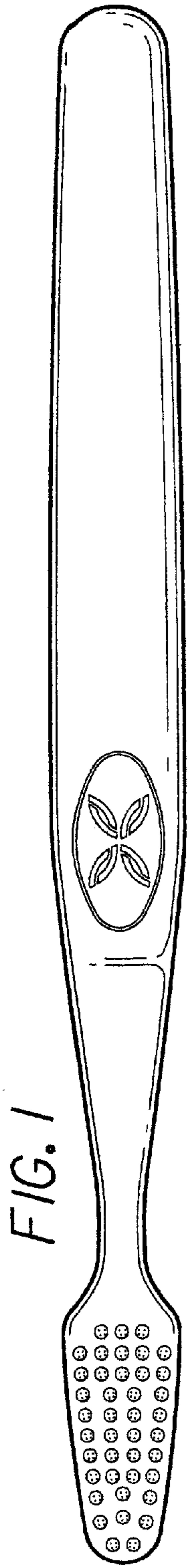

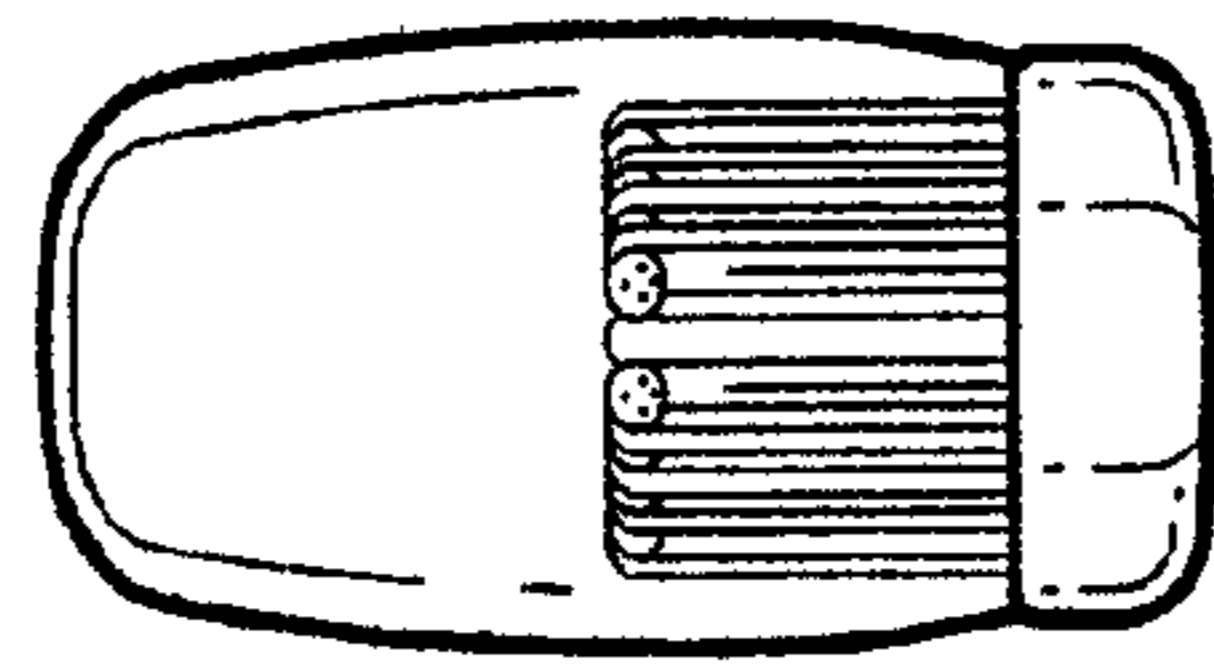
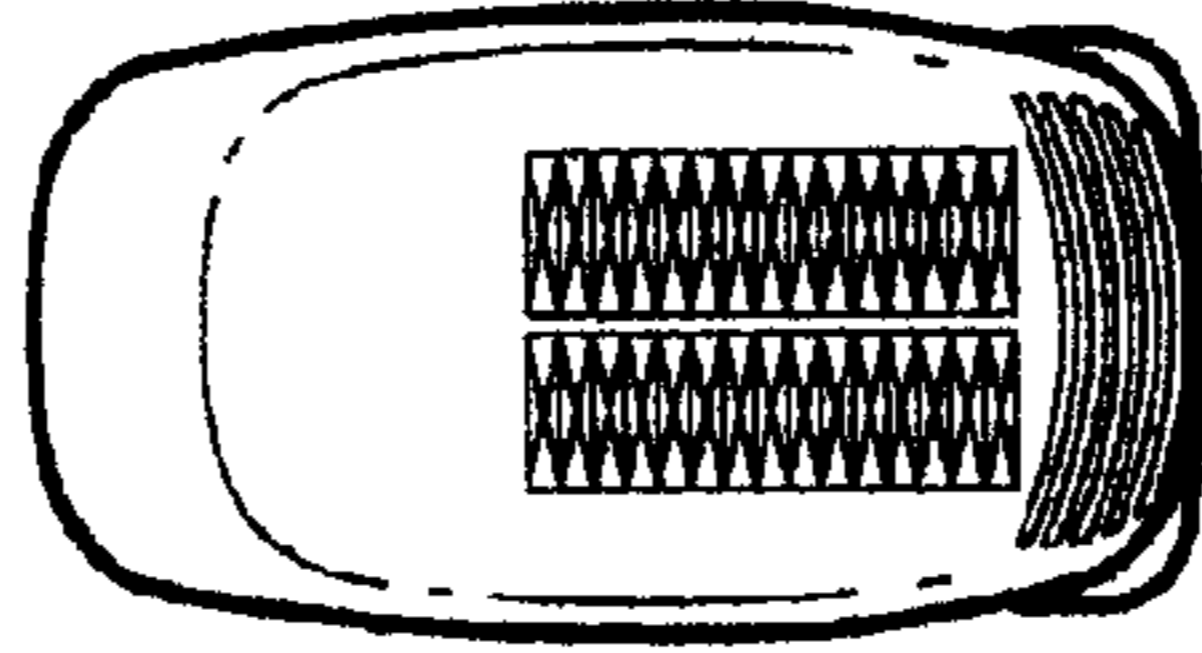
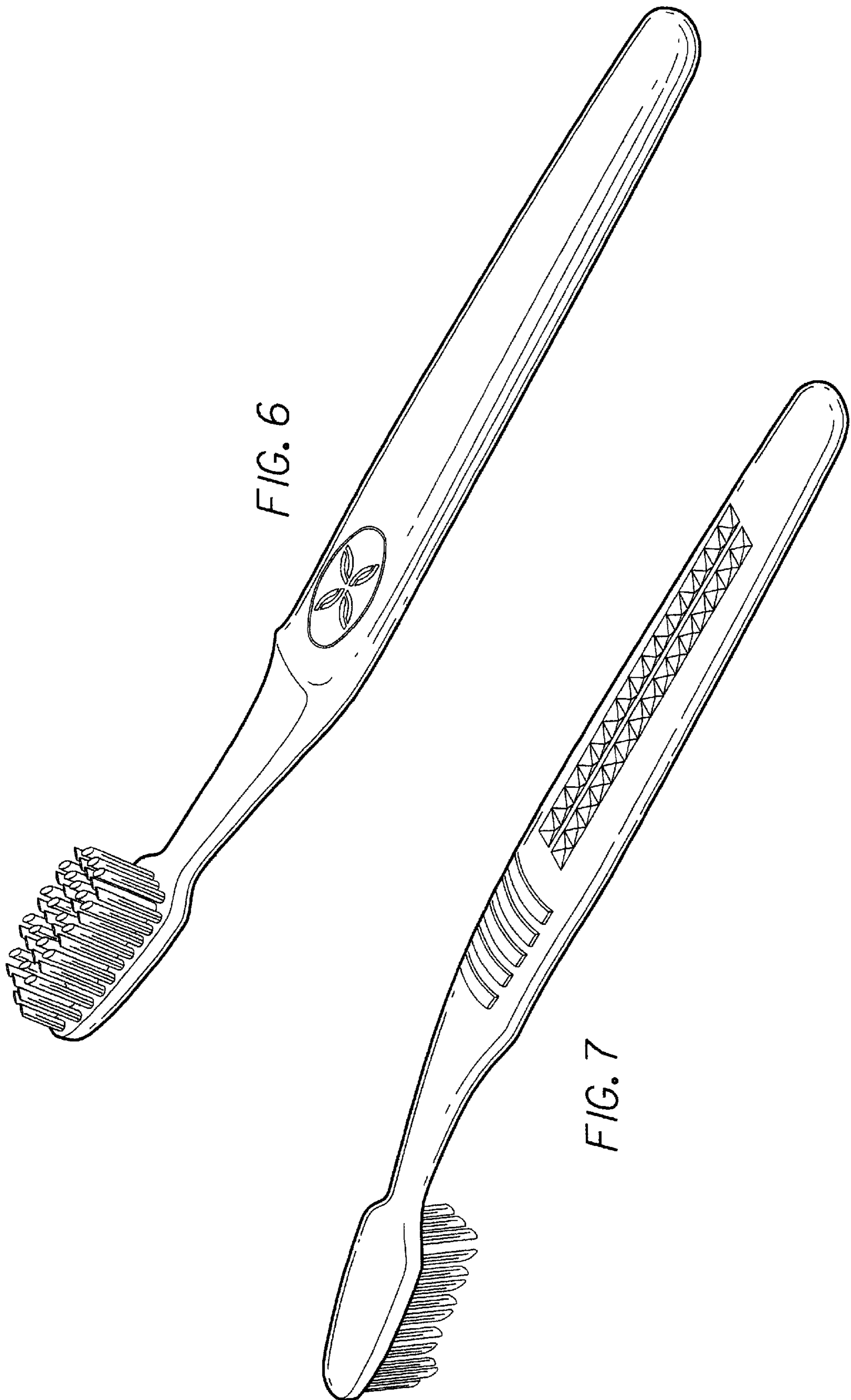

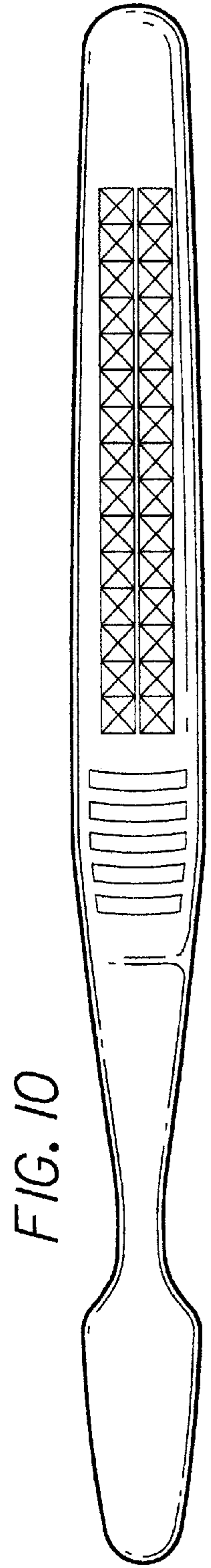
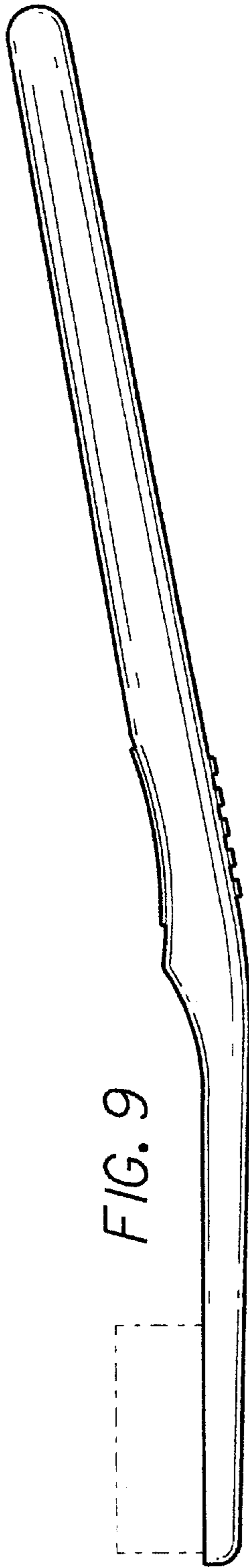
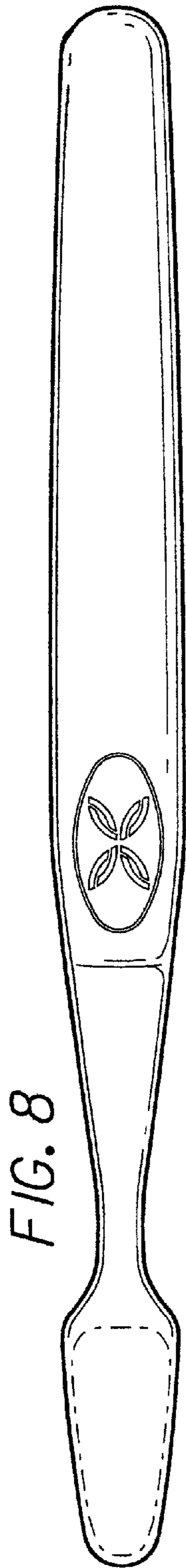

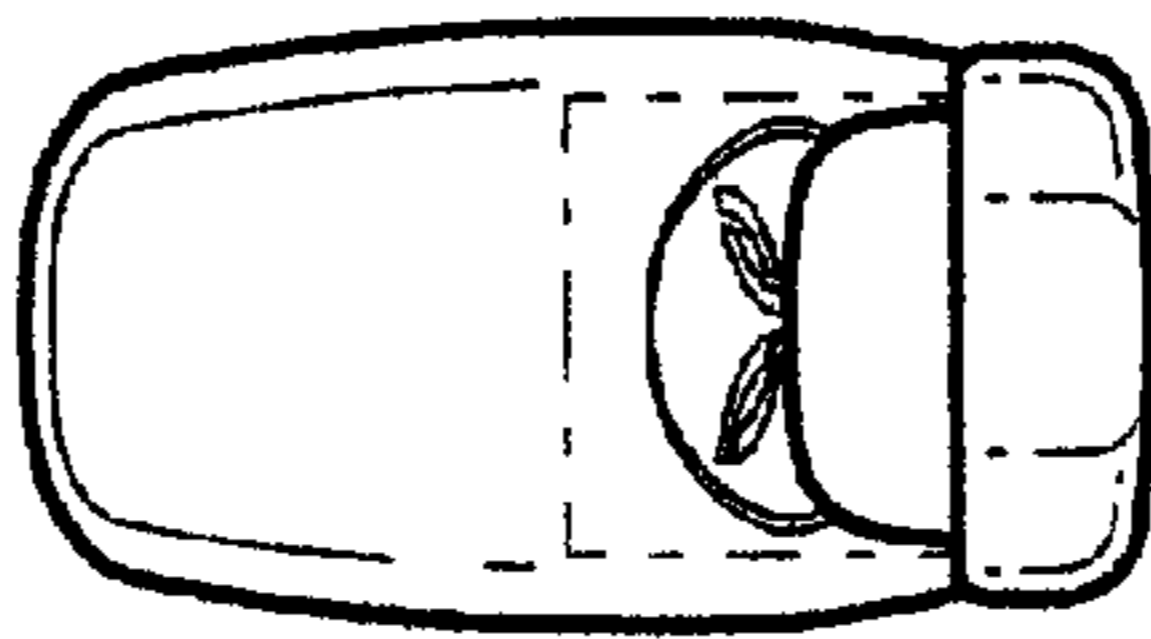
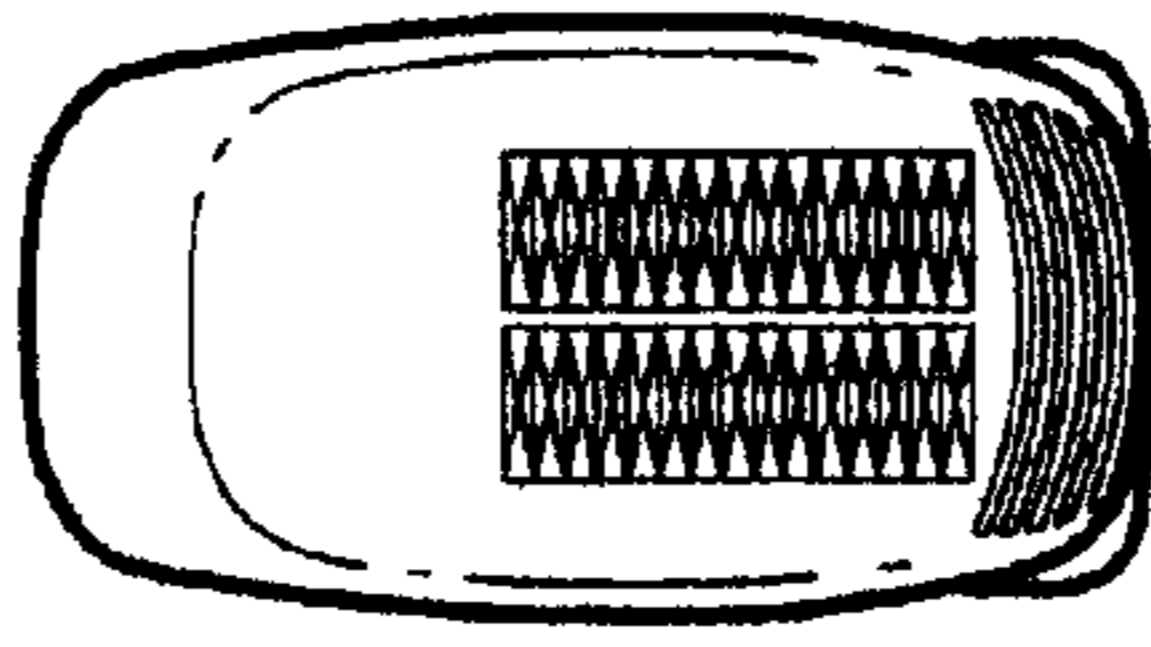
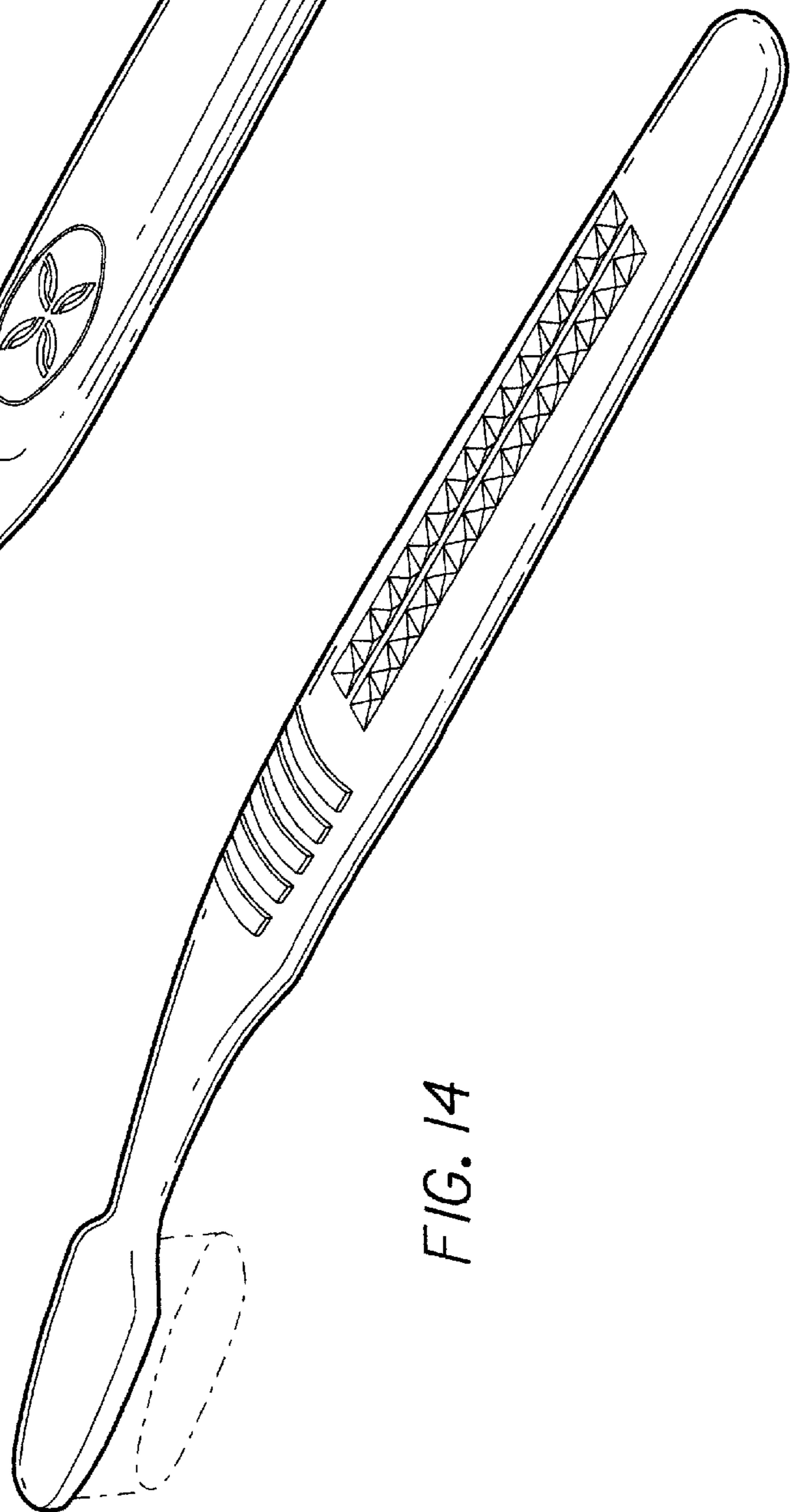
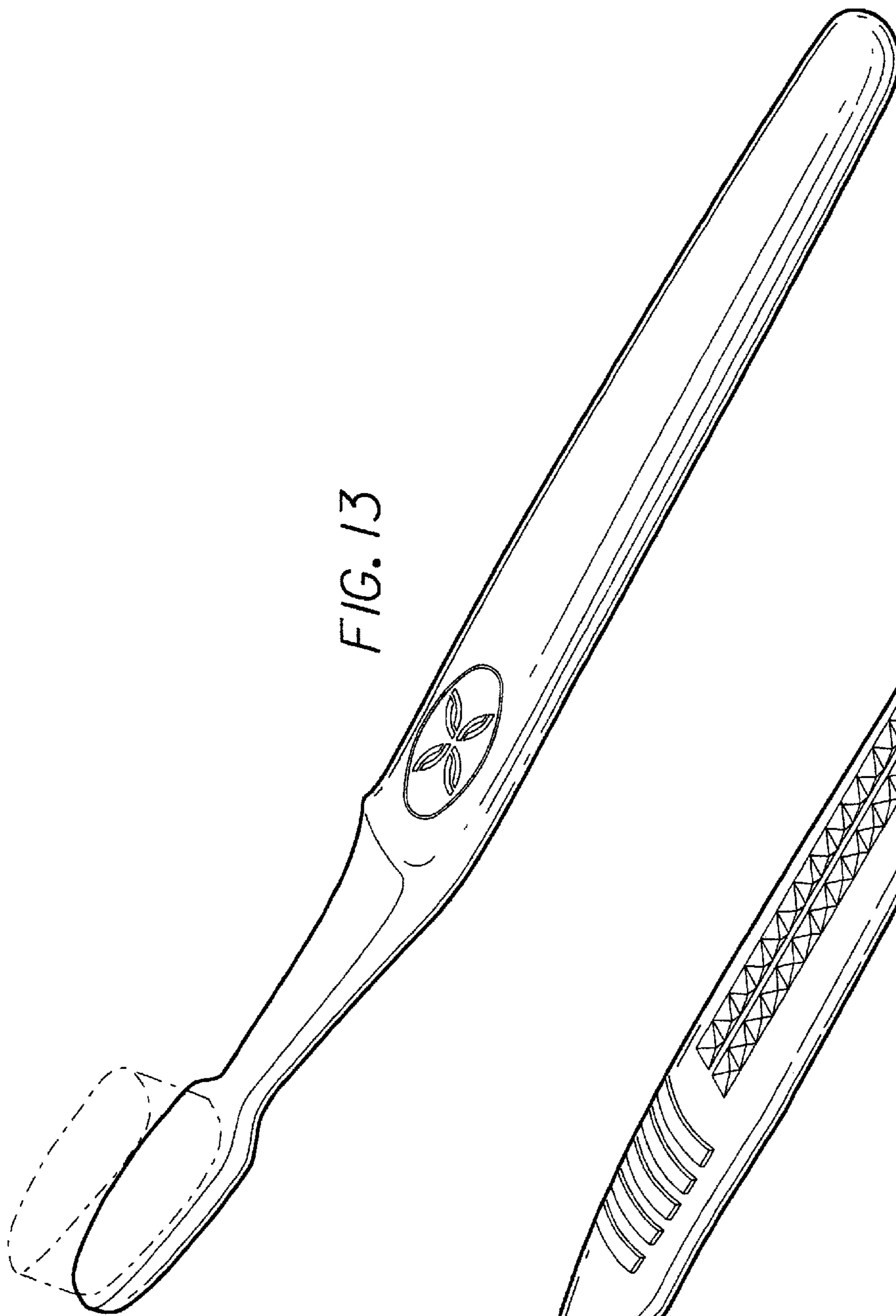

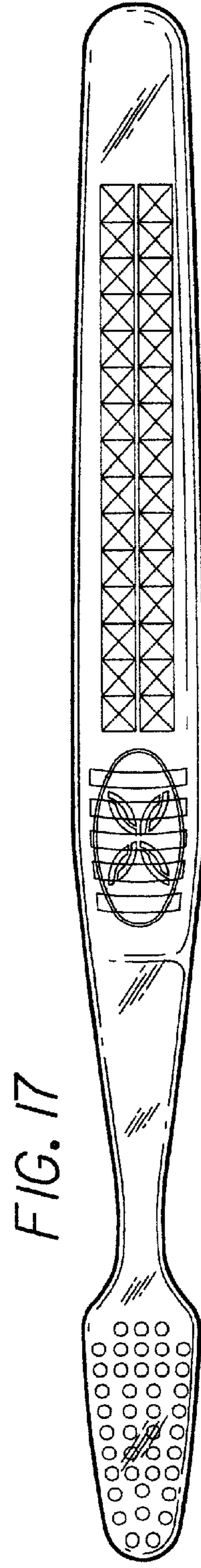
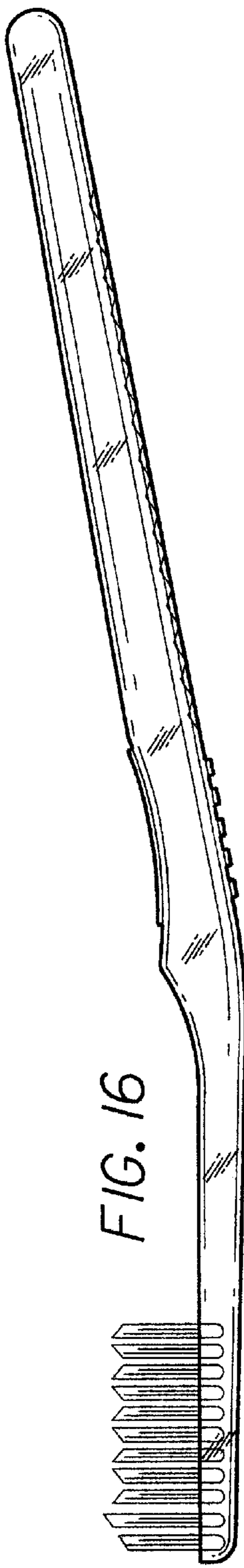
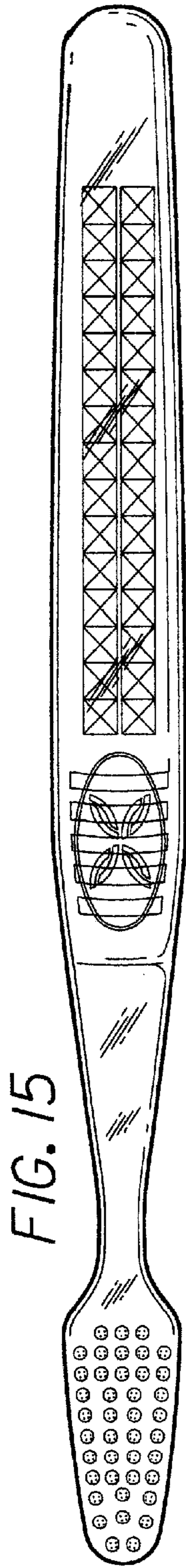

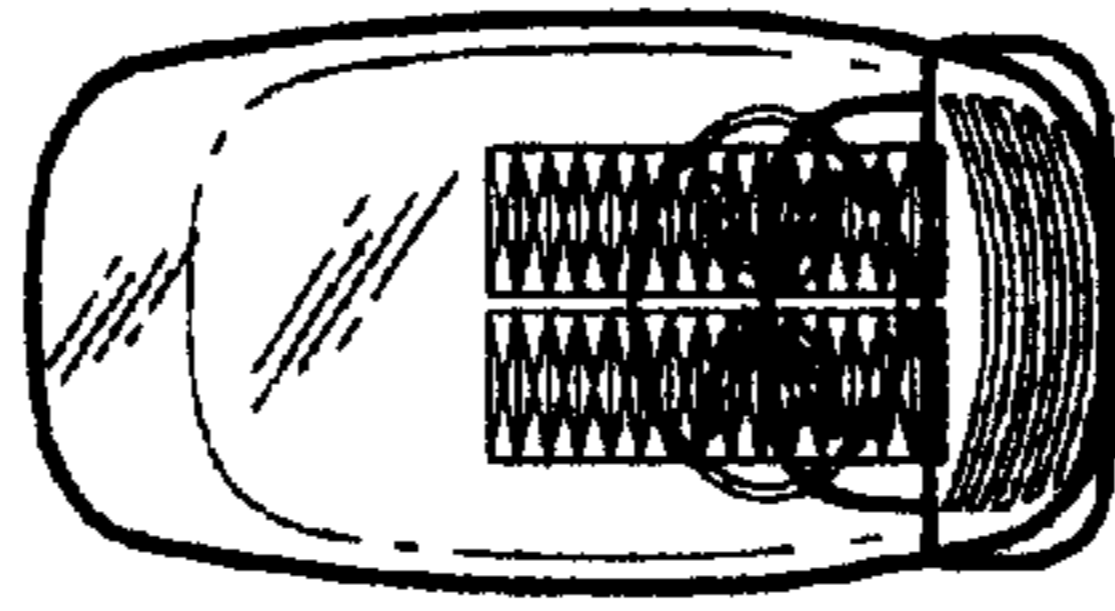
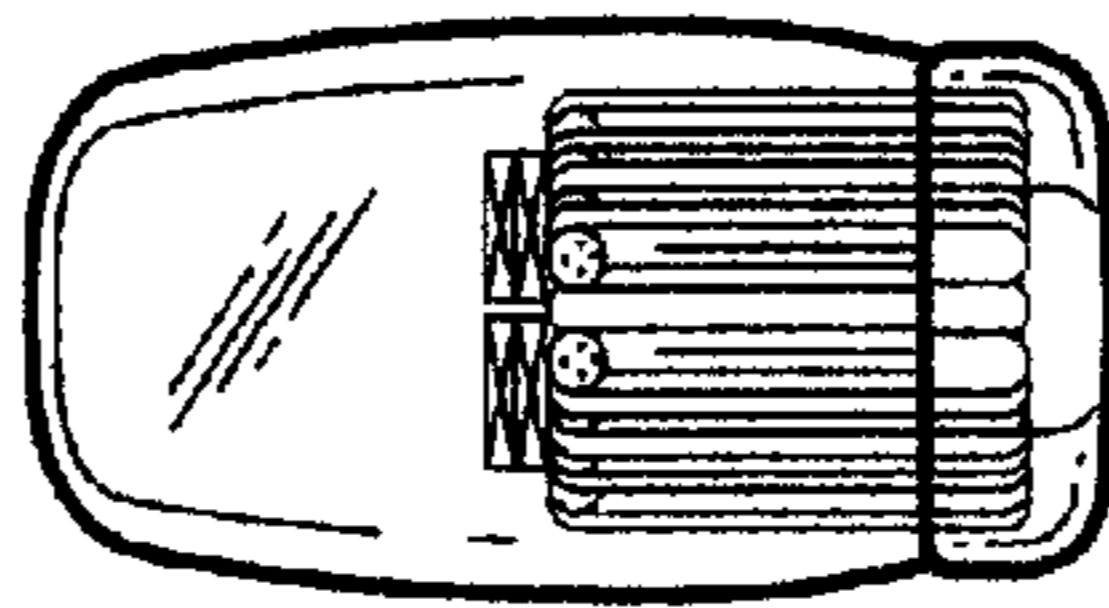

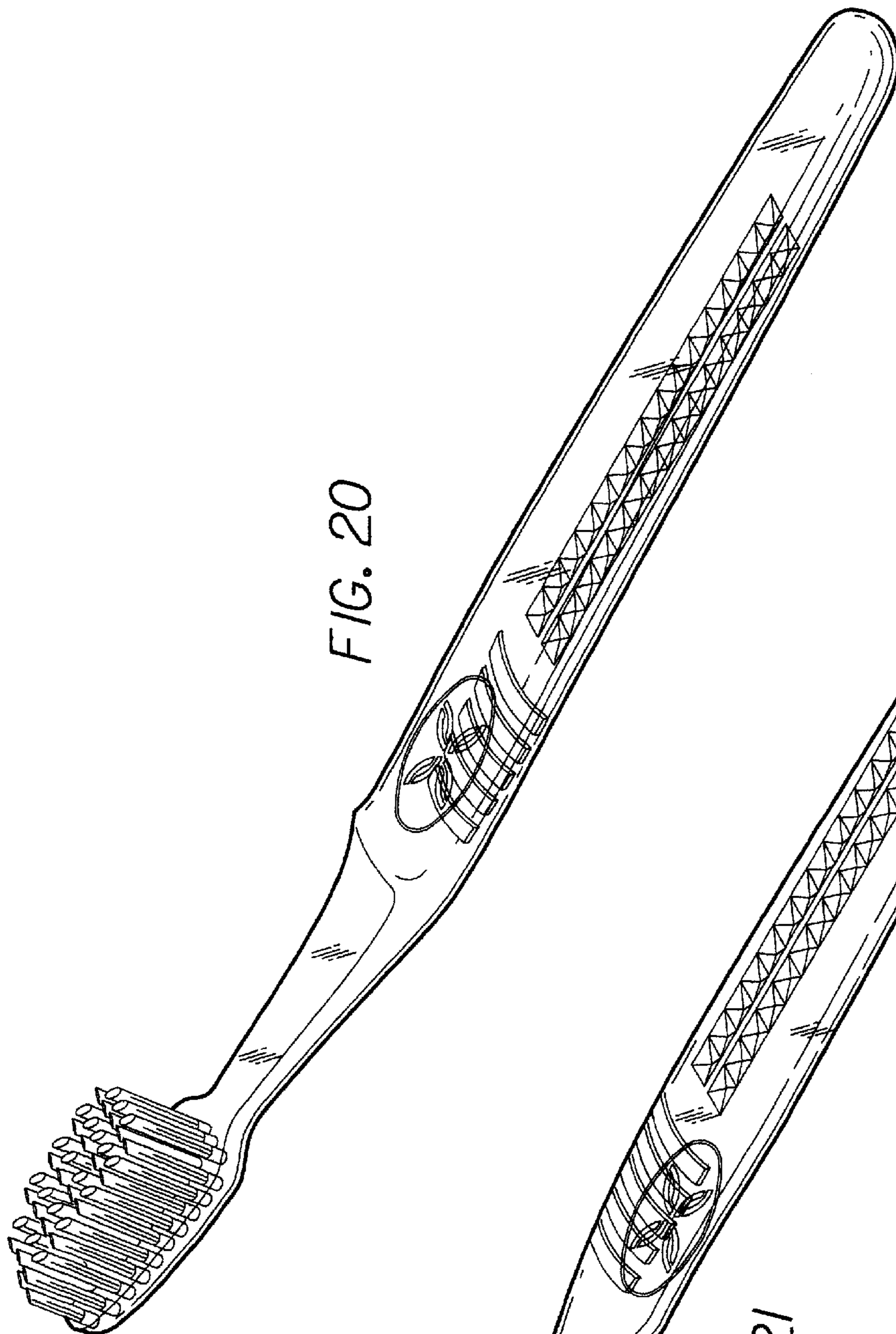

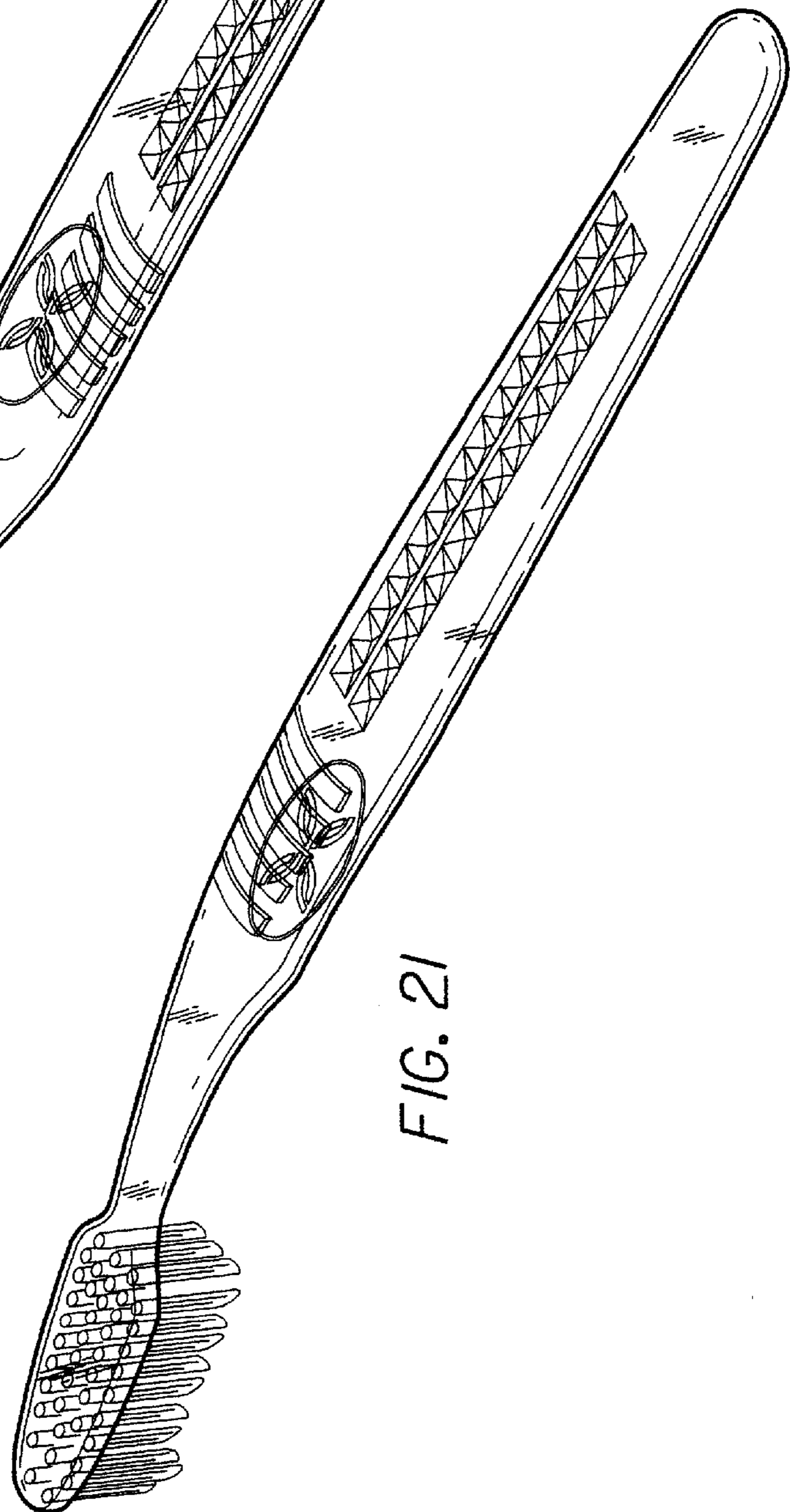
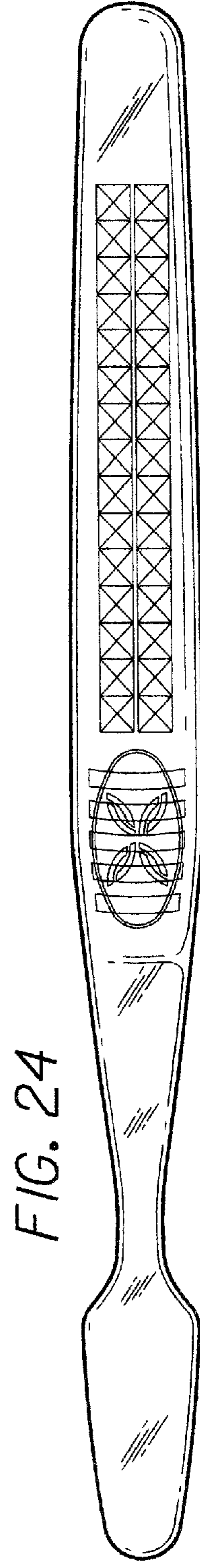
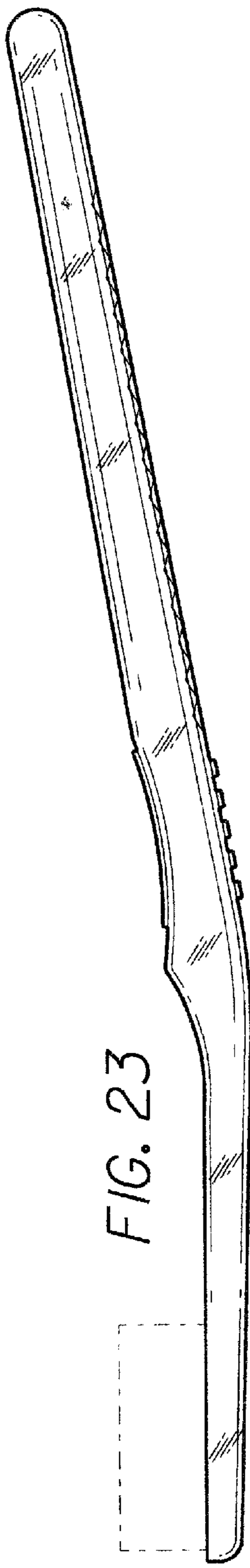
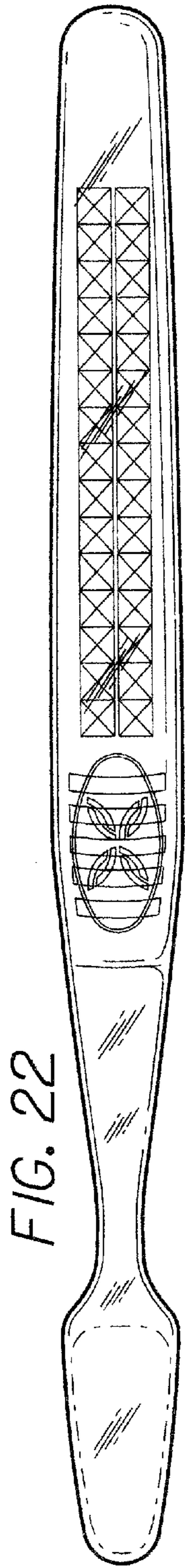

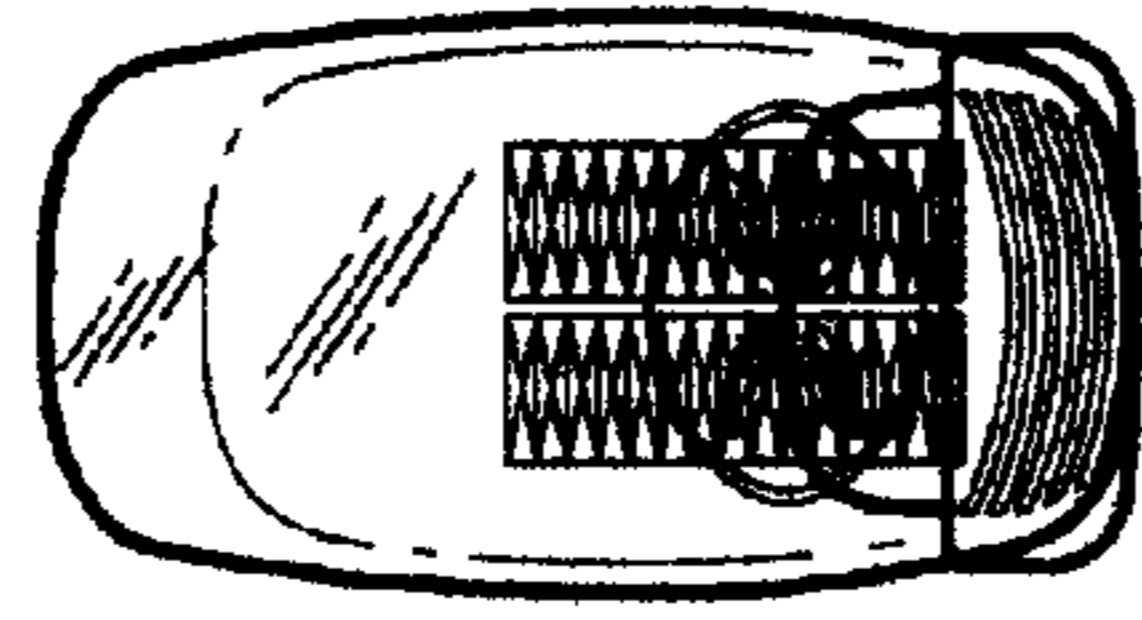
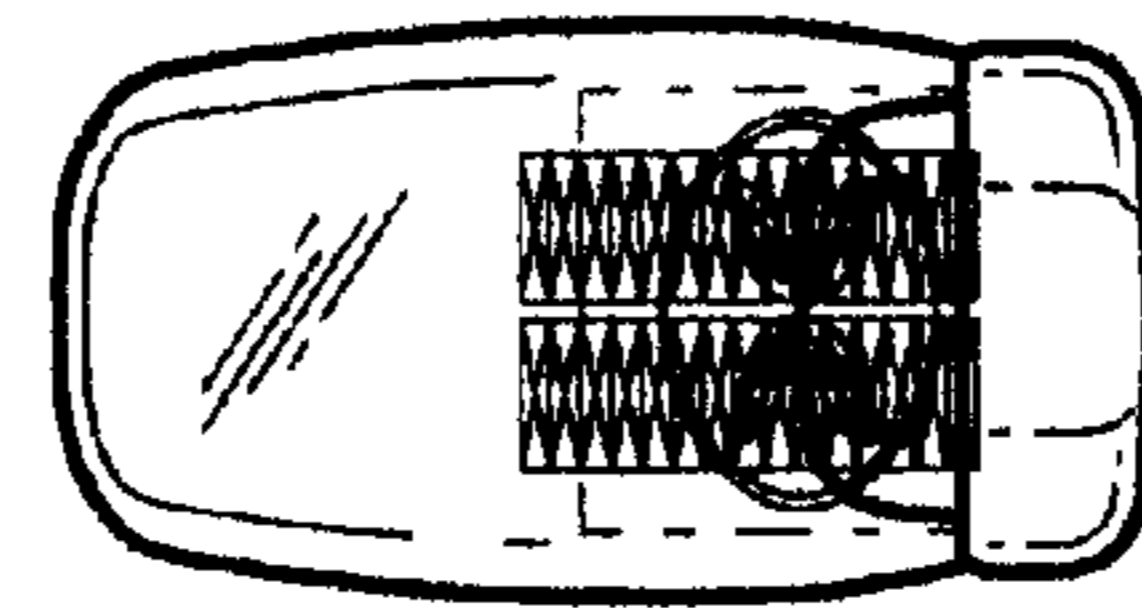

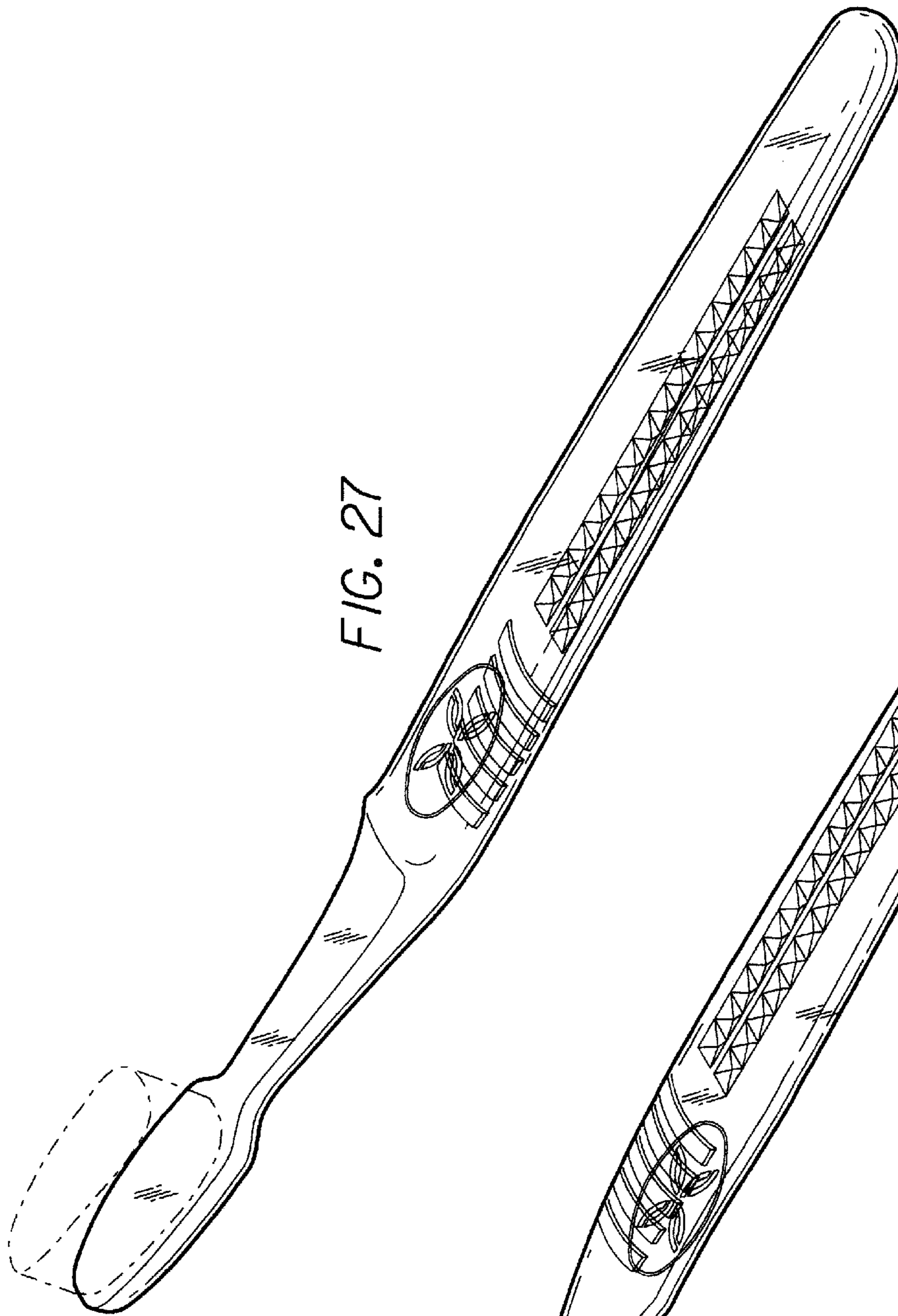

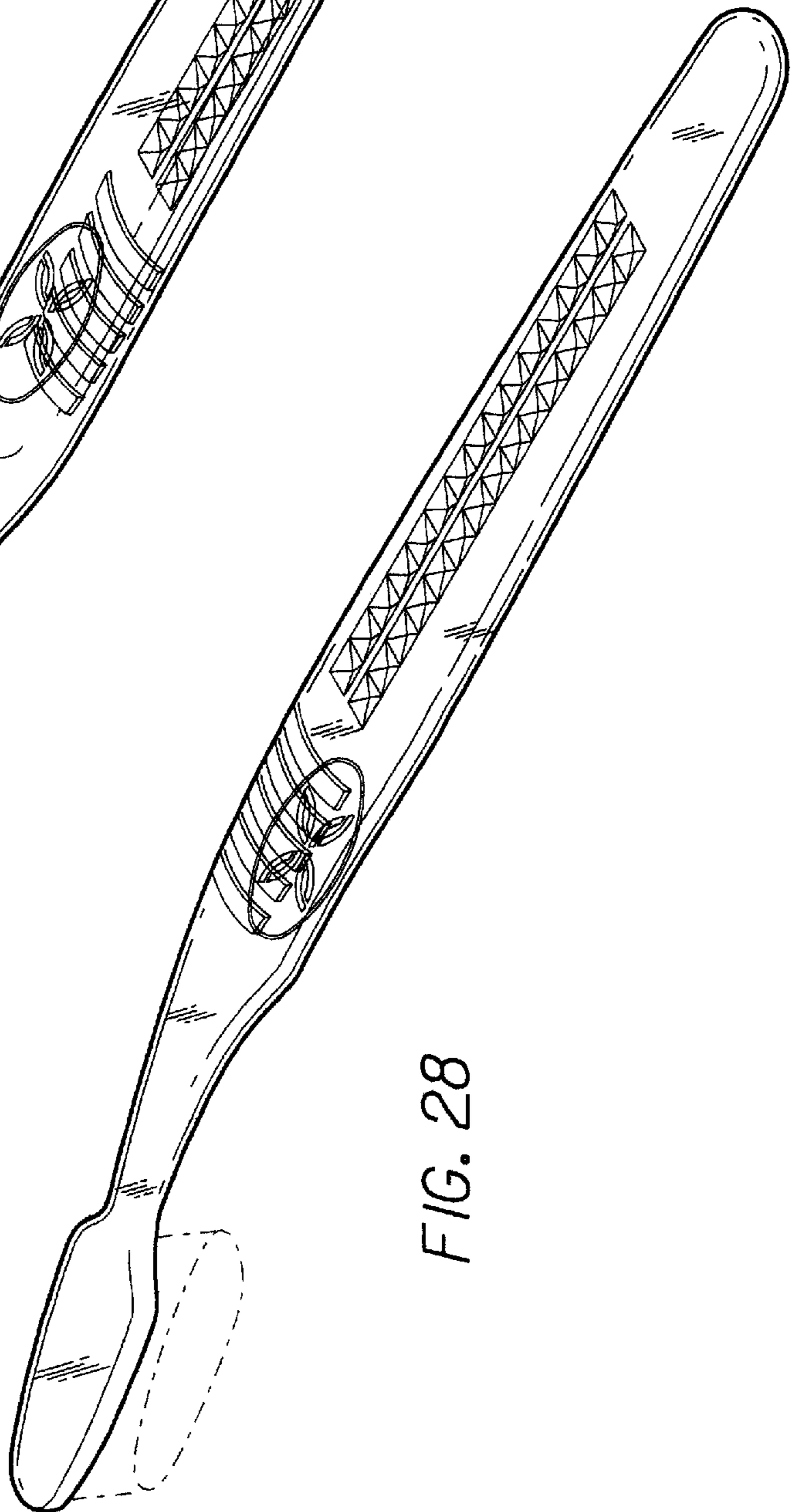
