(57) **CLAIM**

The ornamental design for a drinking tumbler with undulating base, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, side and front perspective view of a first embodiment of a drinking tumbler with undulating base showing the new design;

FIG. 10 is a rear elevation view thereof;

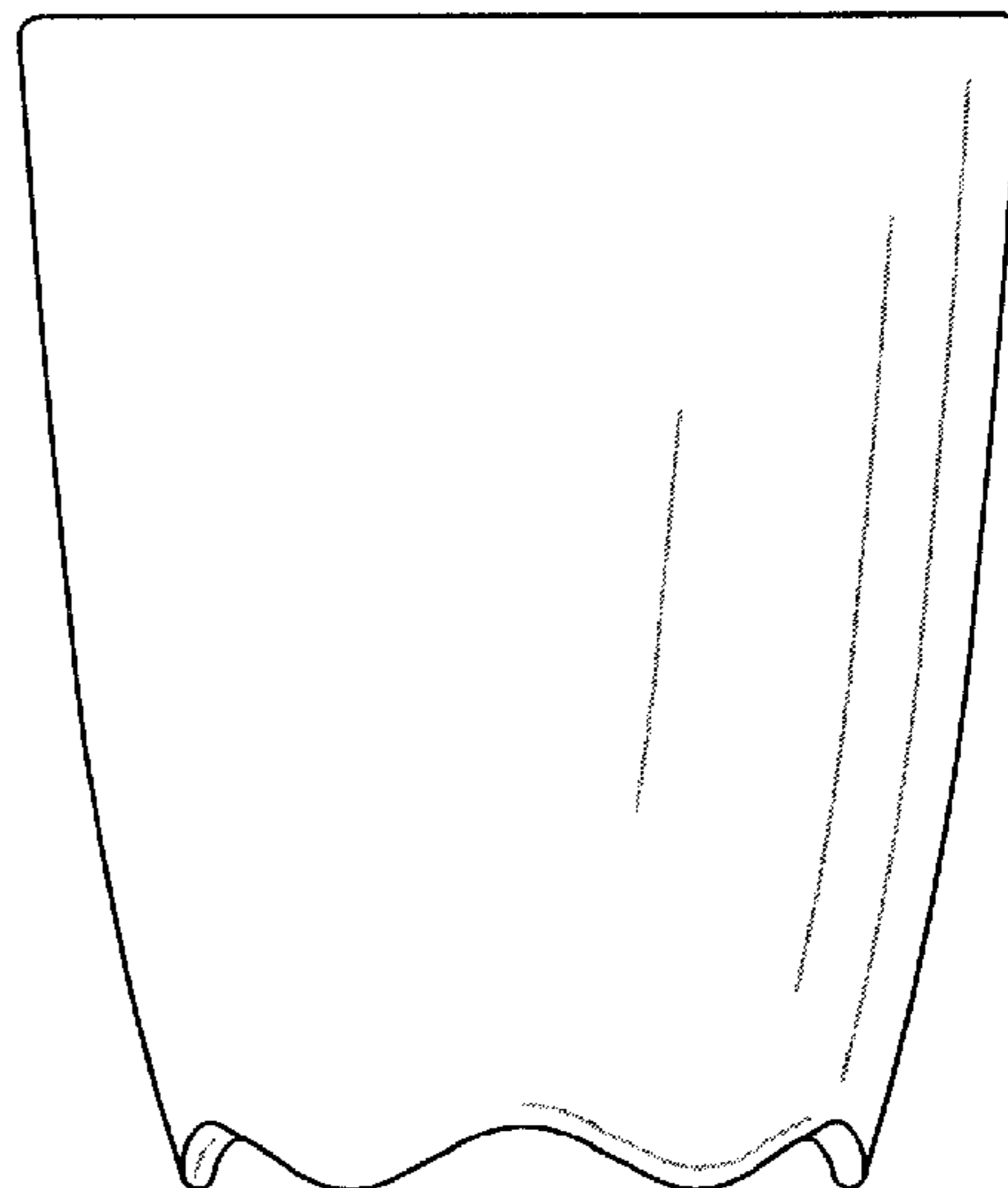
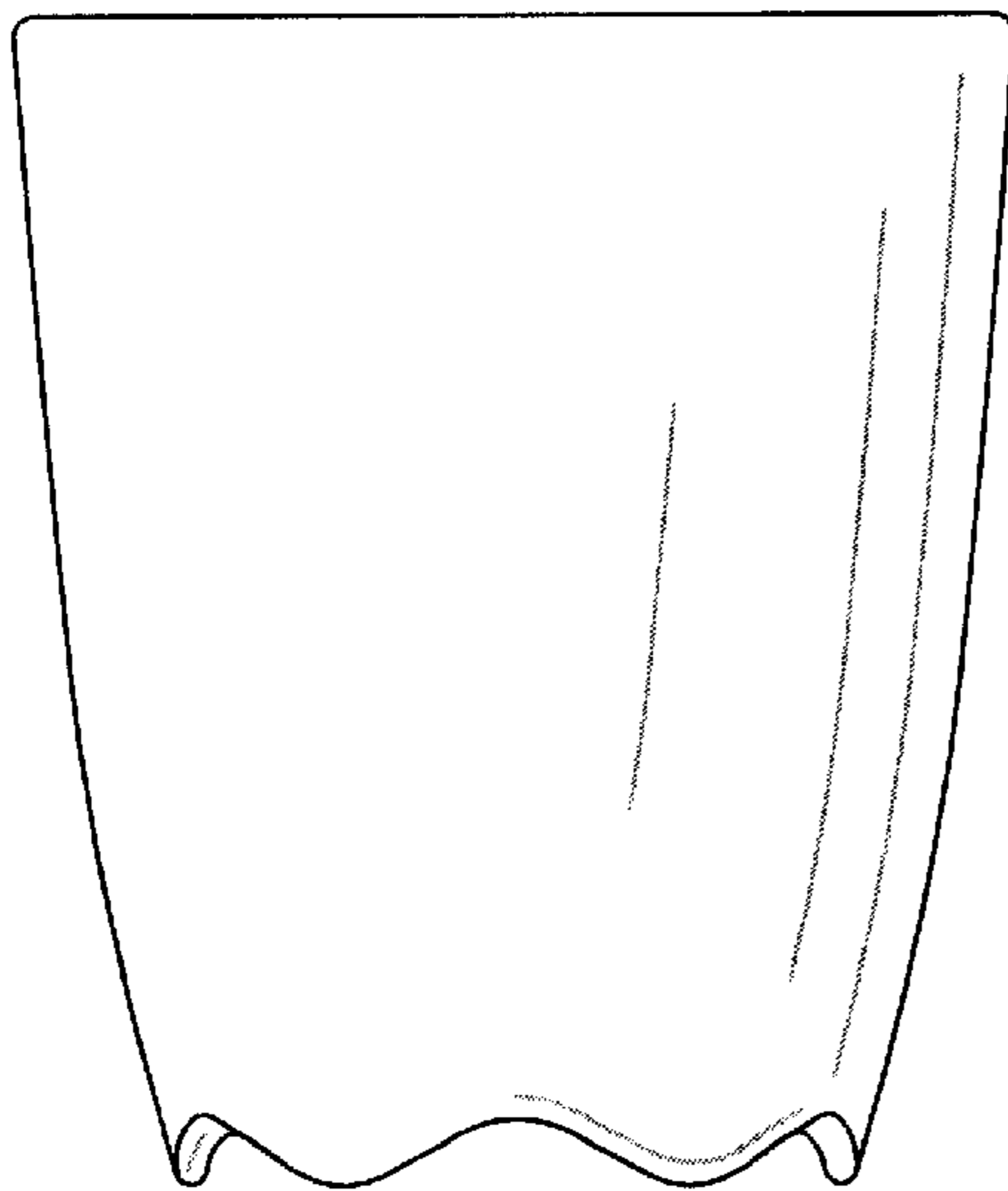
FIG. 11 is a right side elevation view thereof;

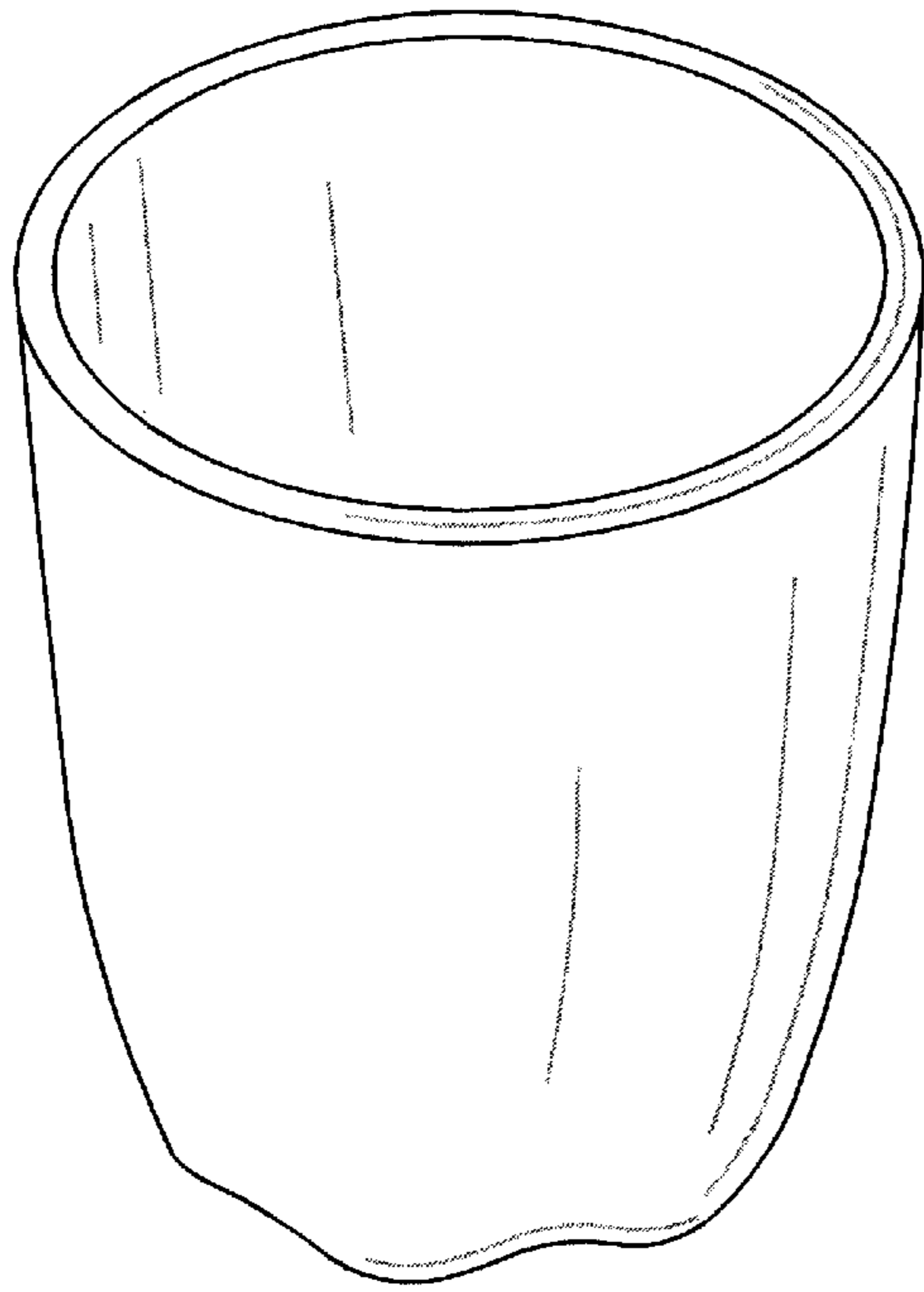

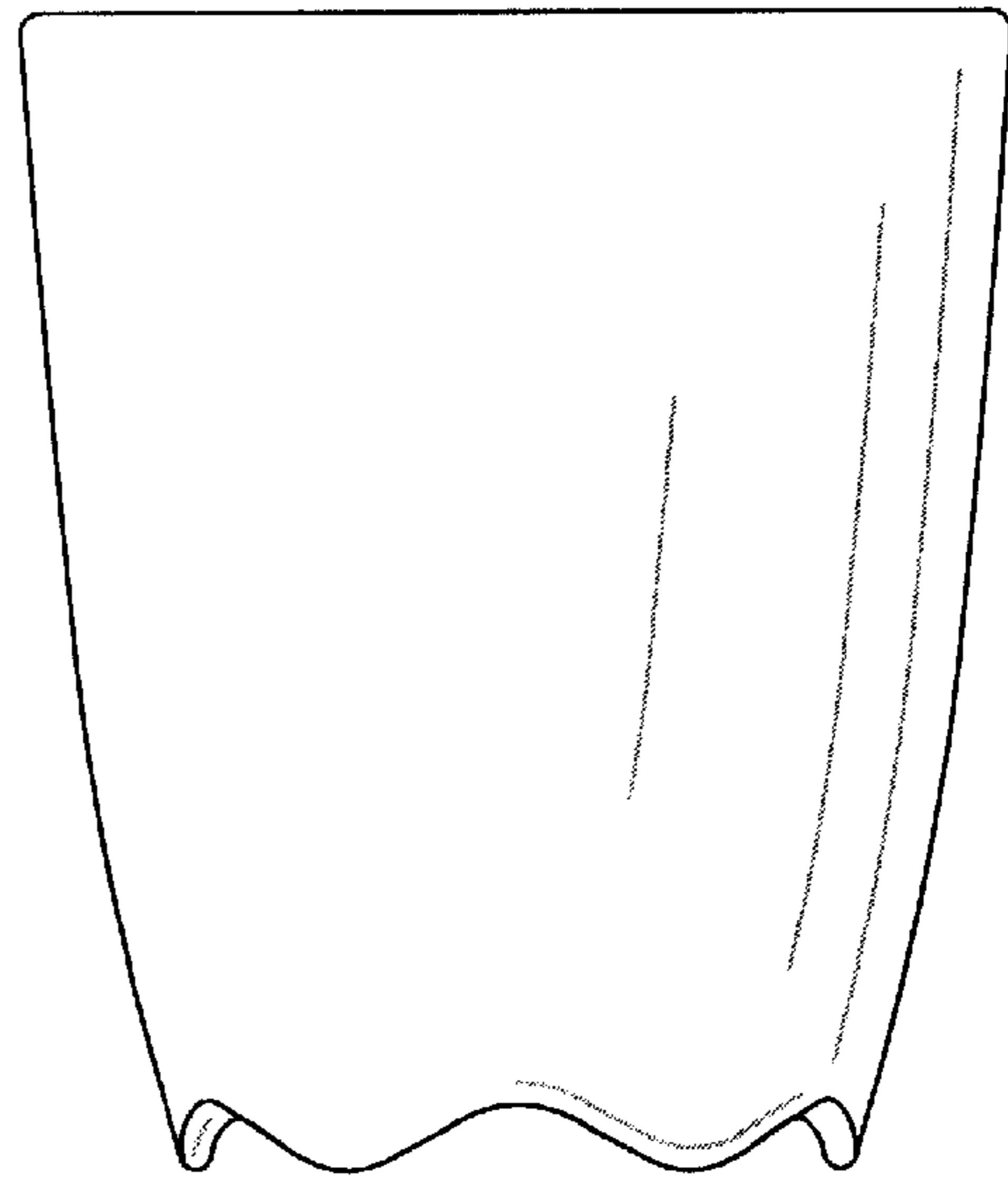

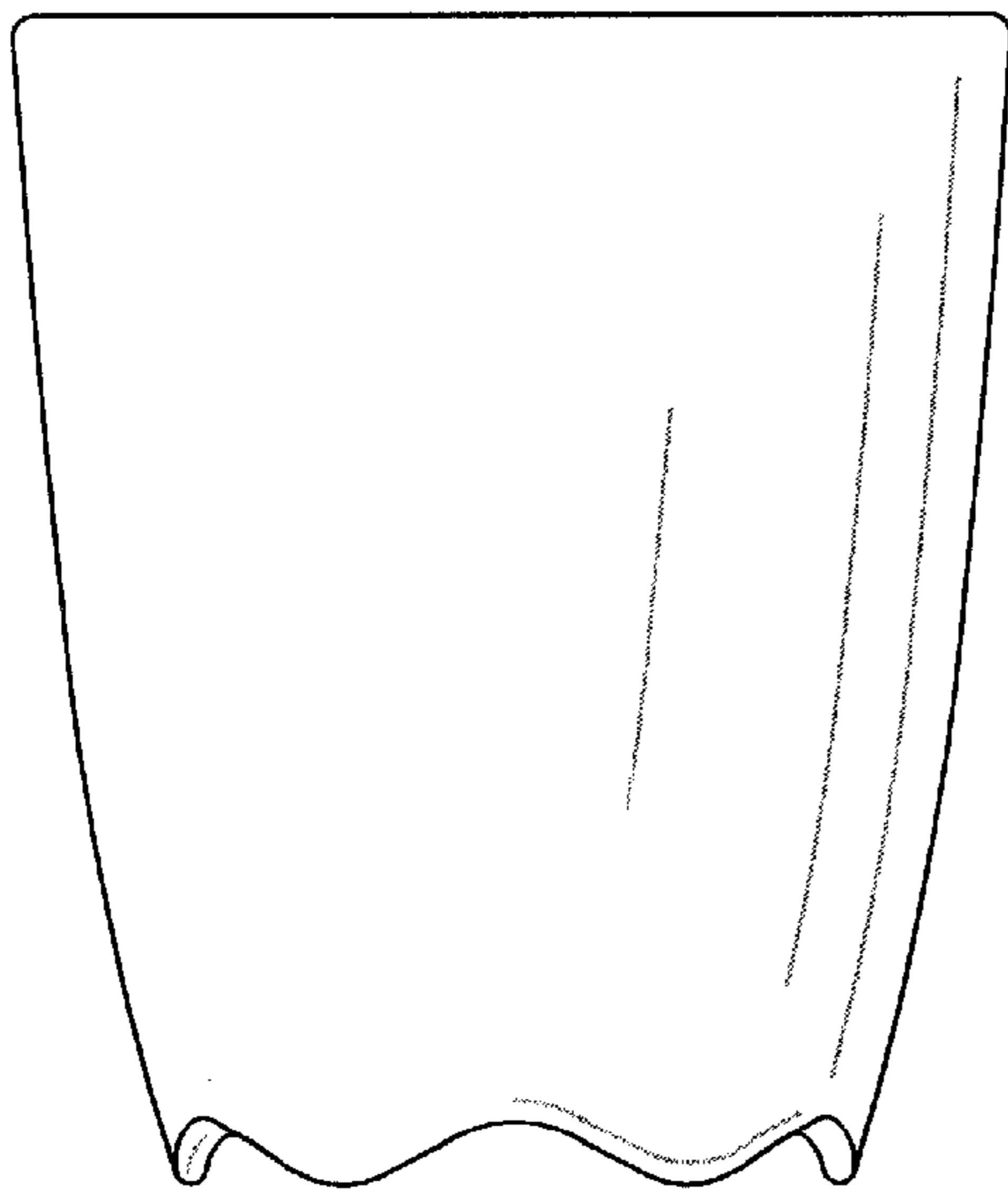

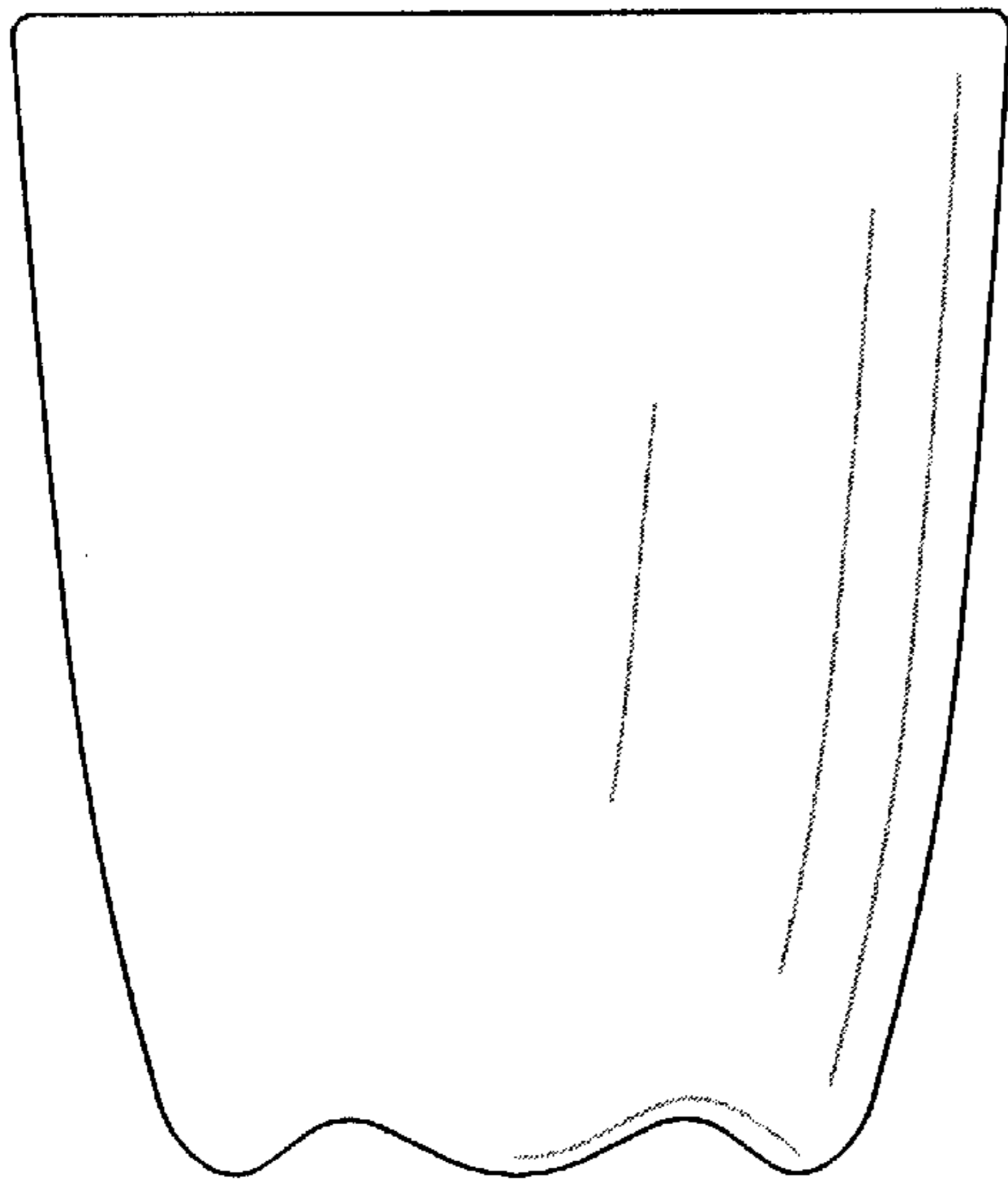

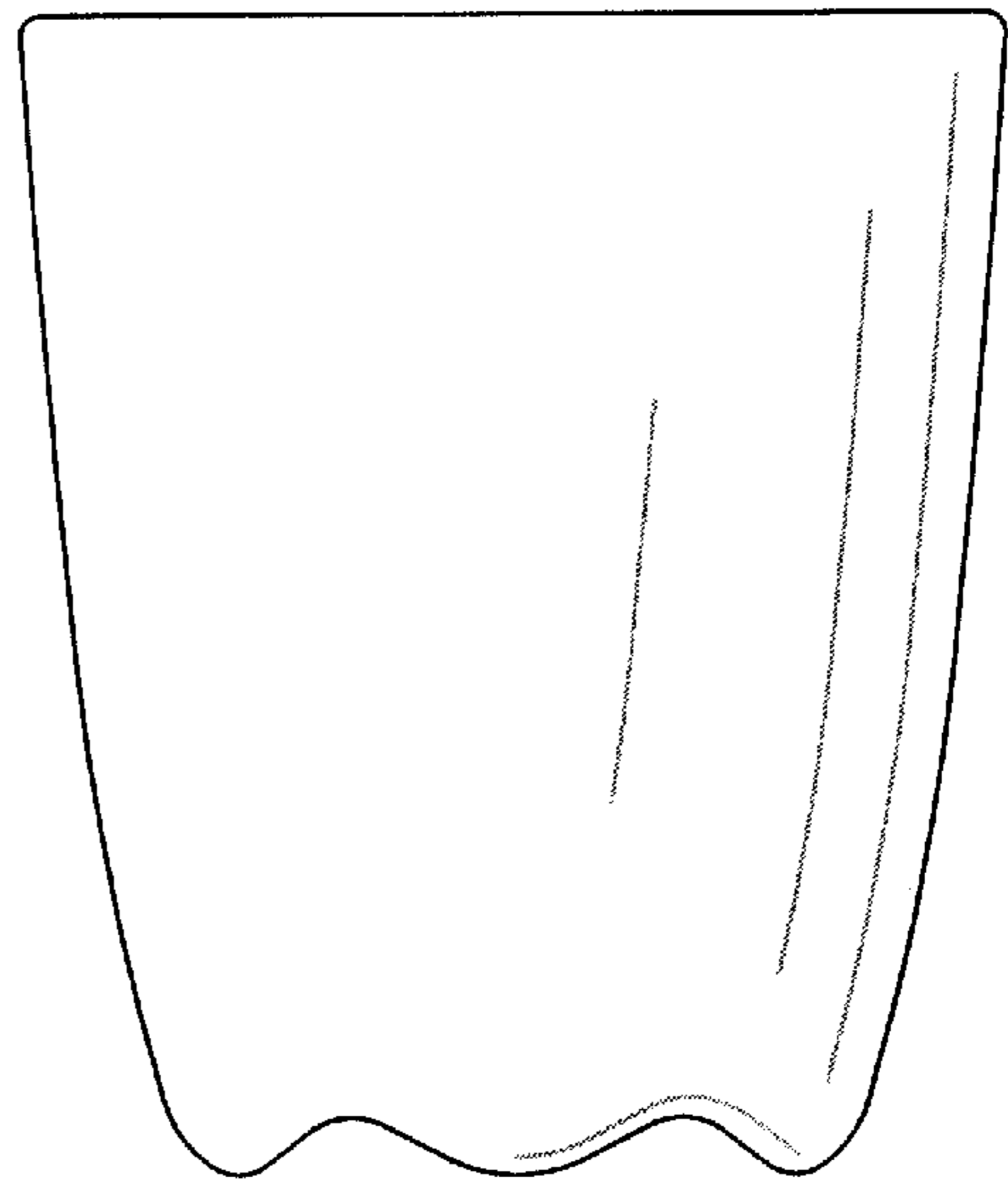

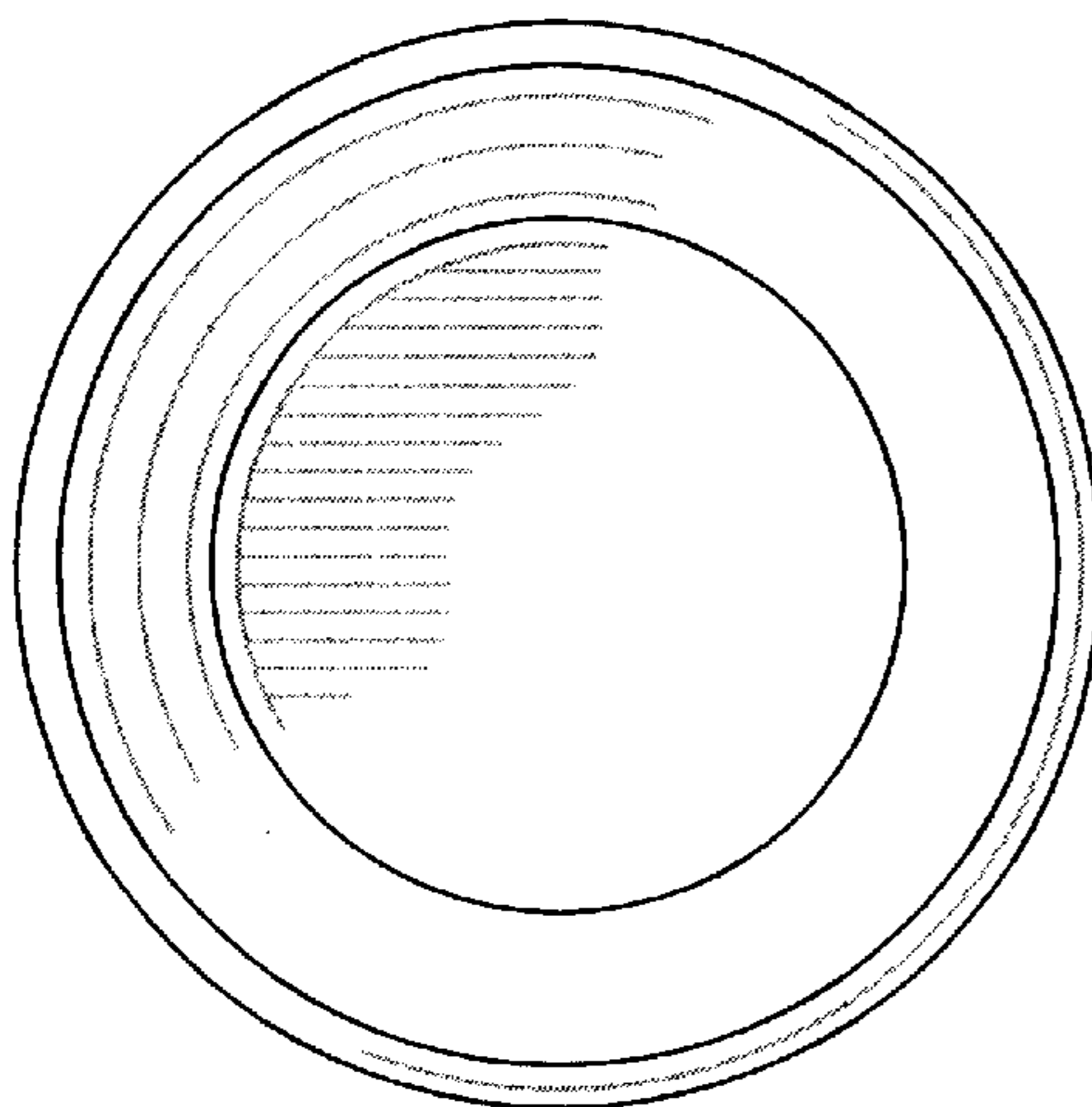

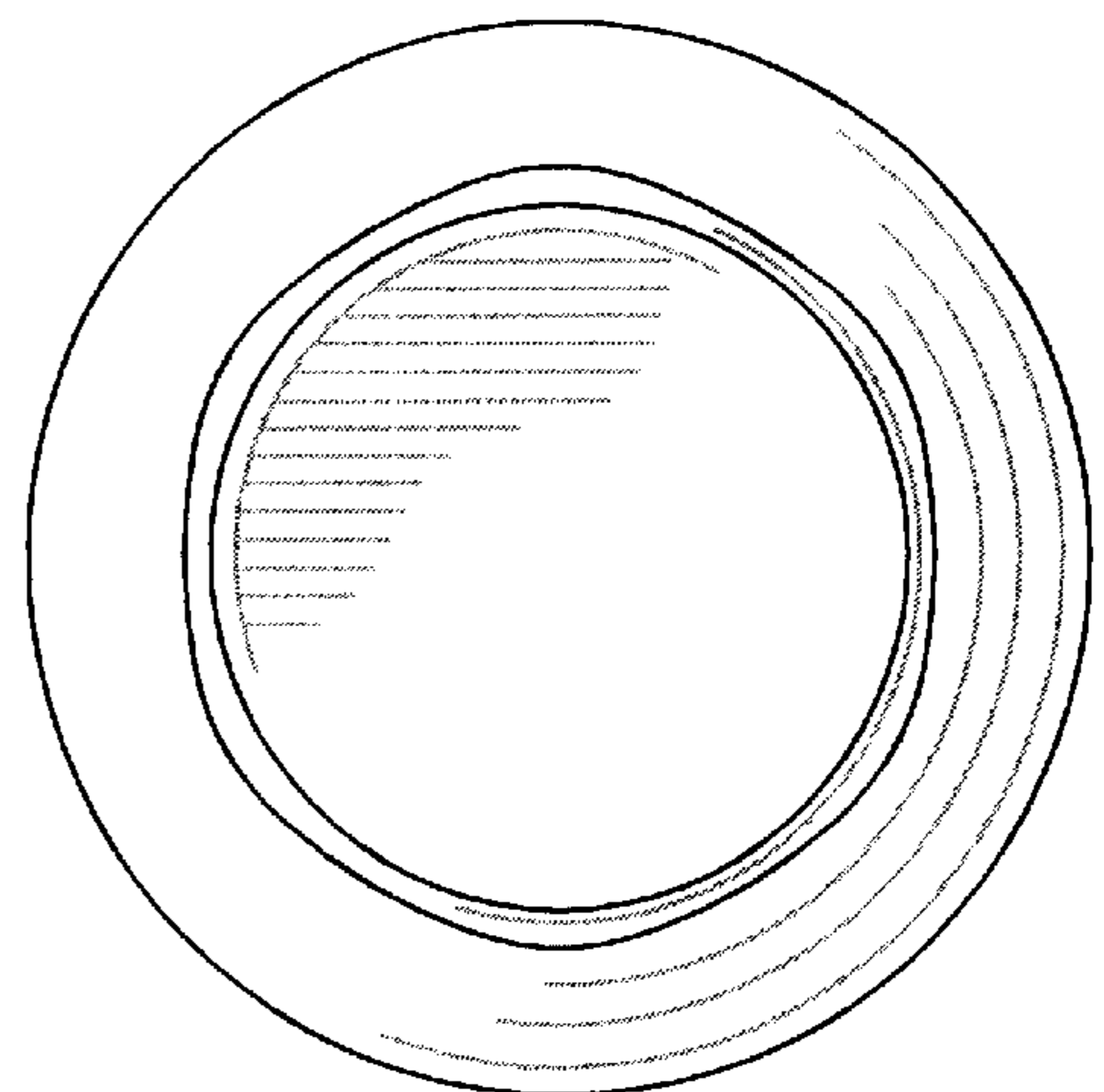
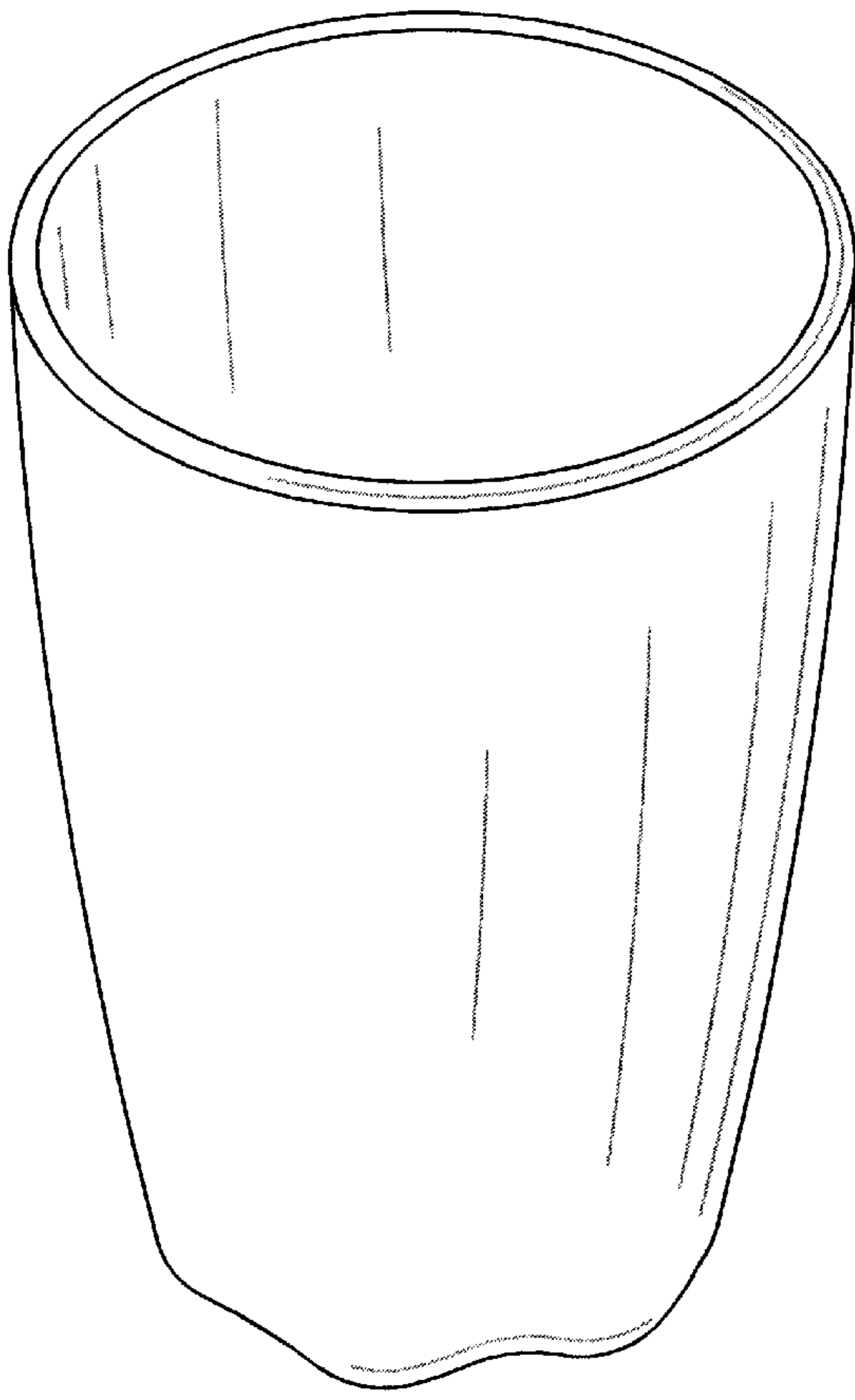
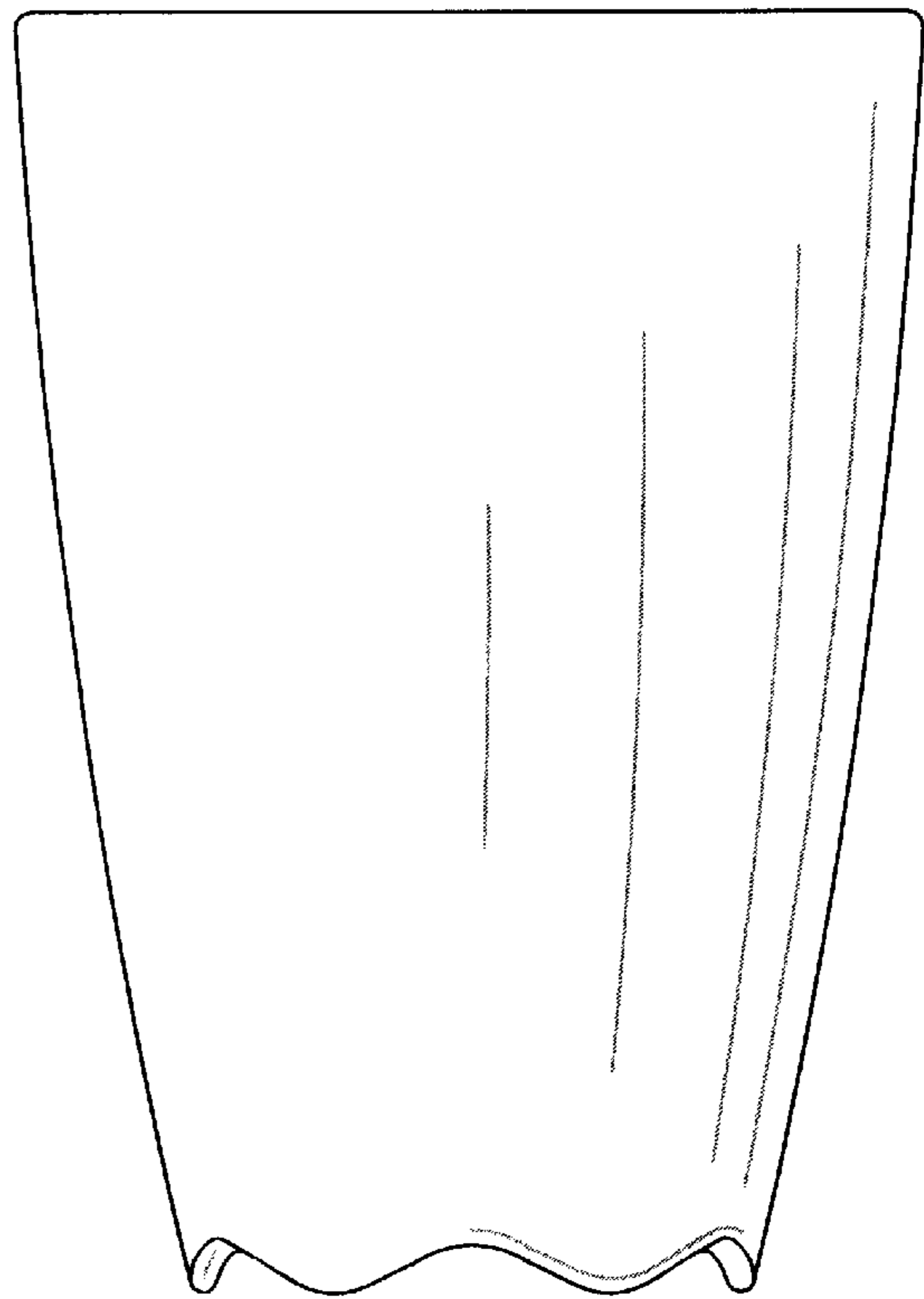


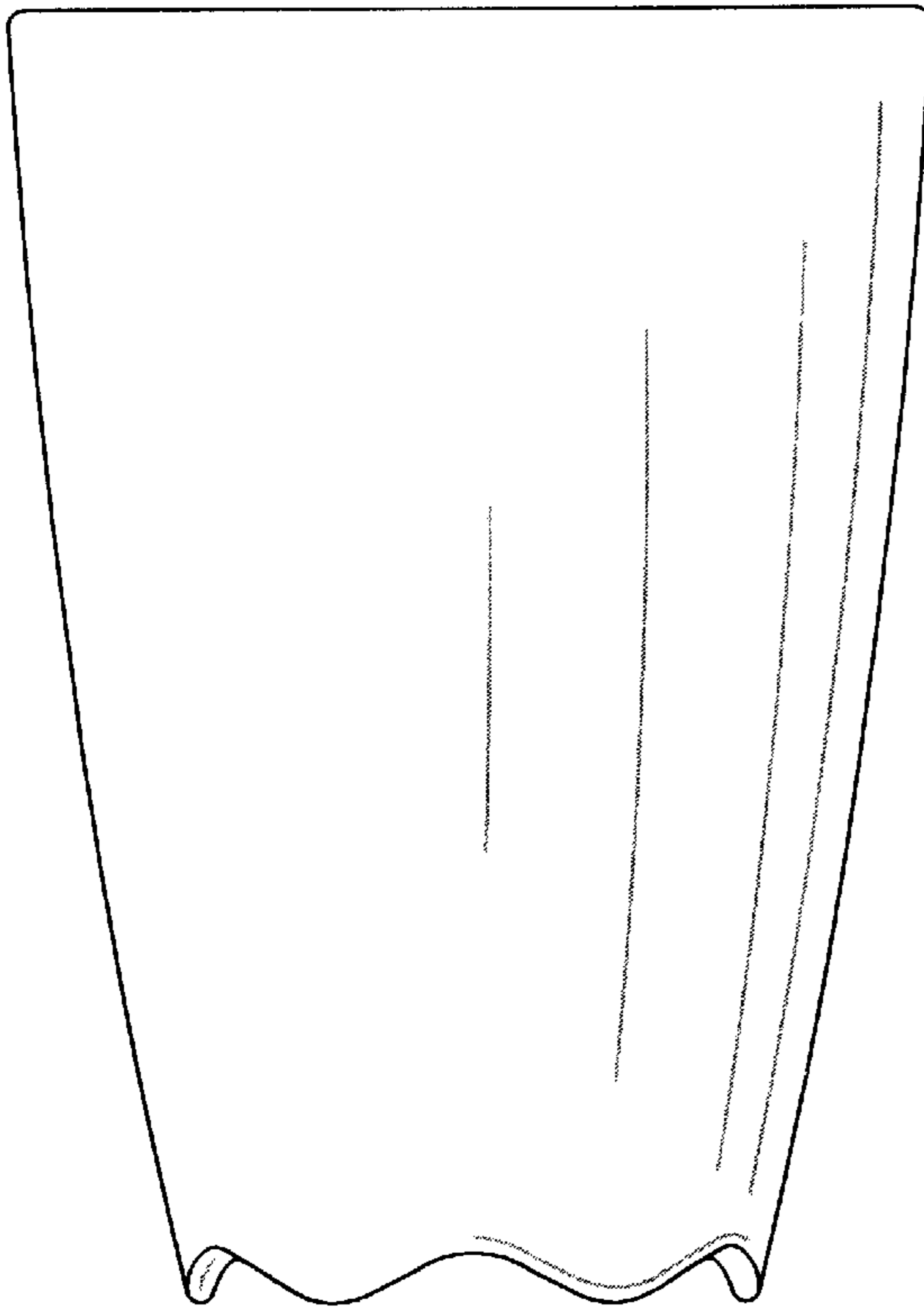

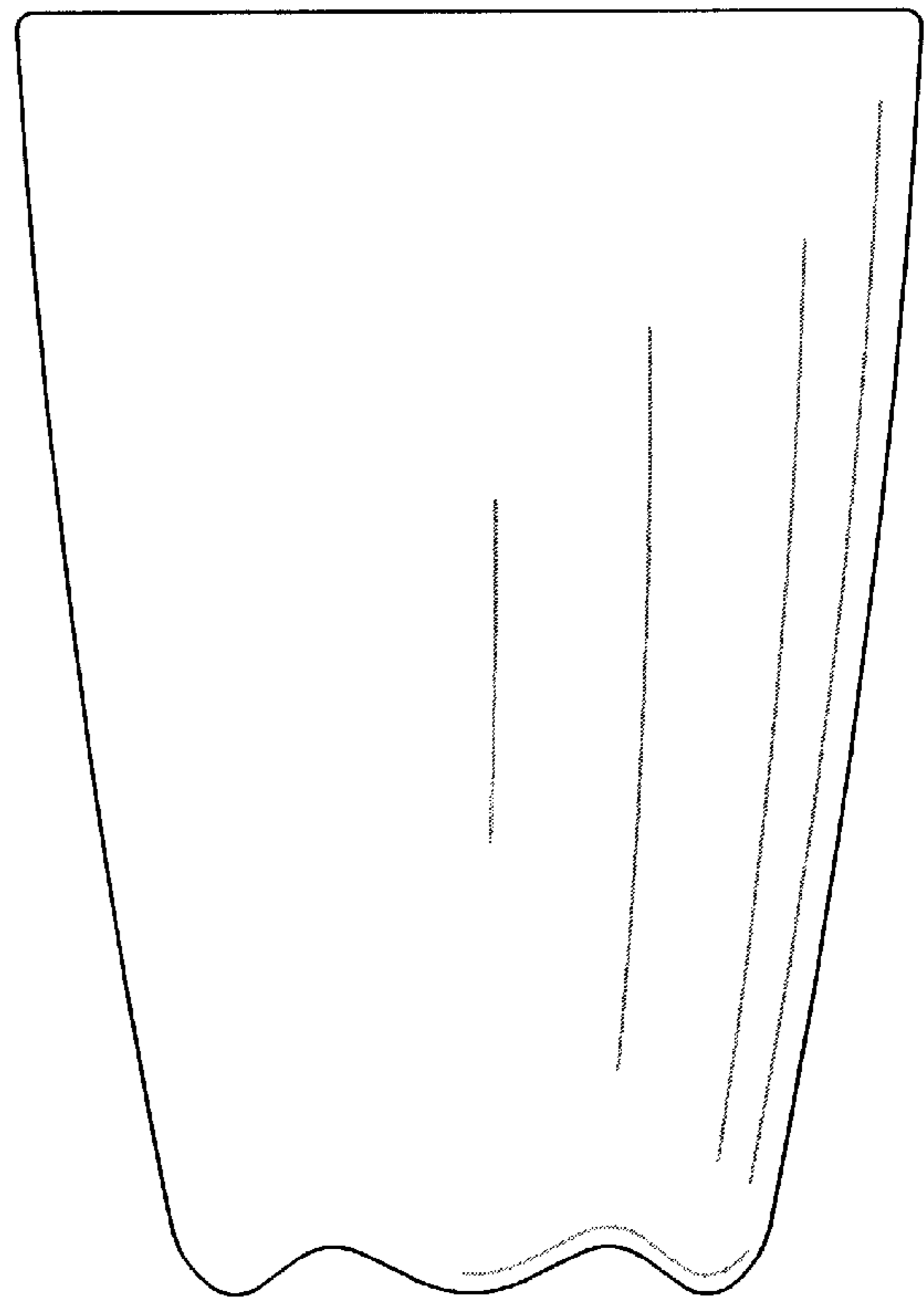

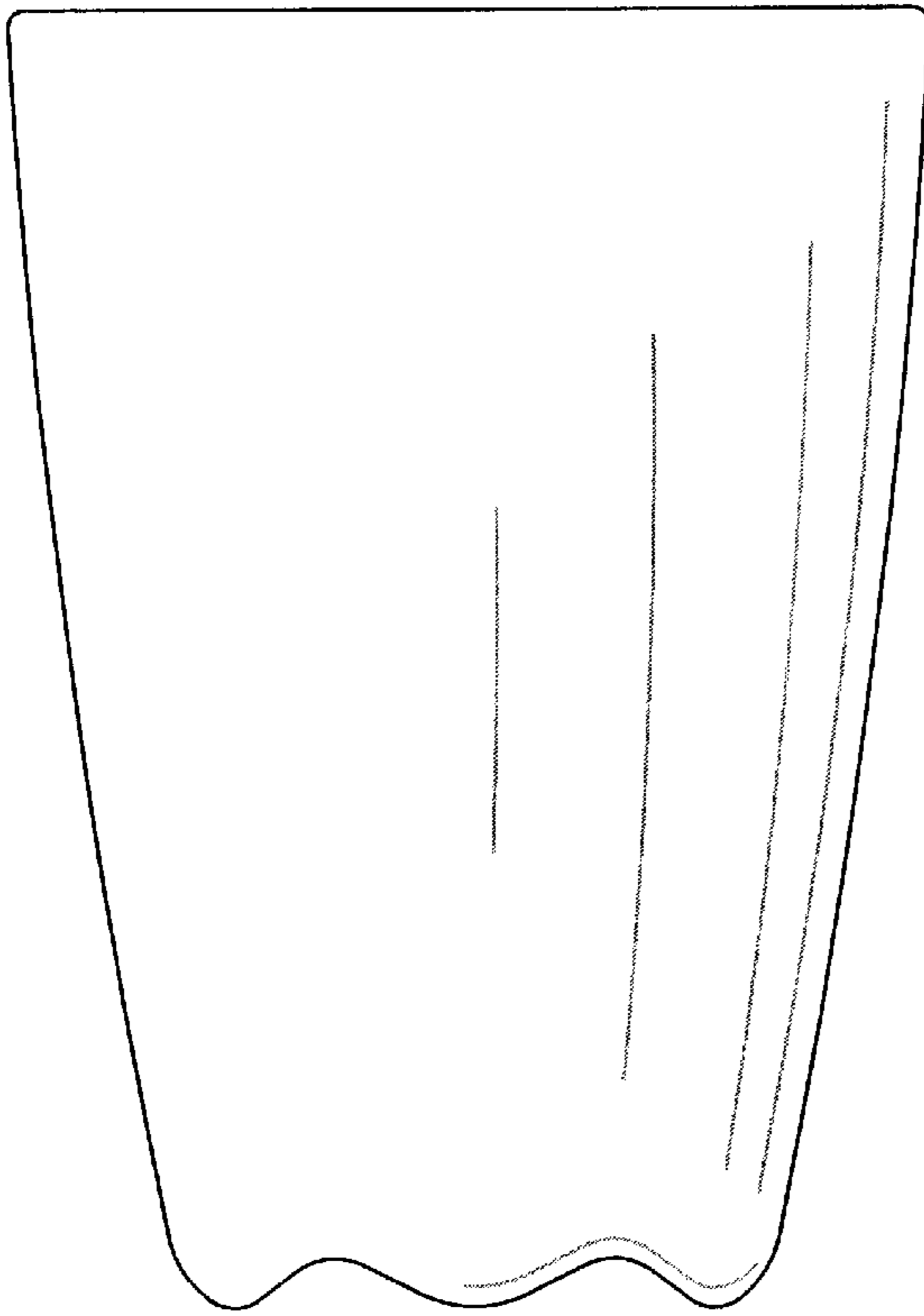

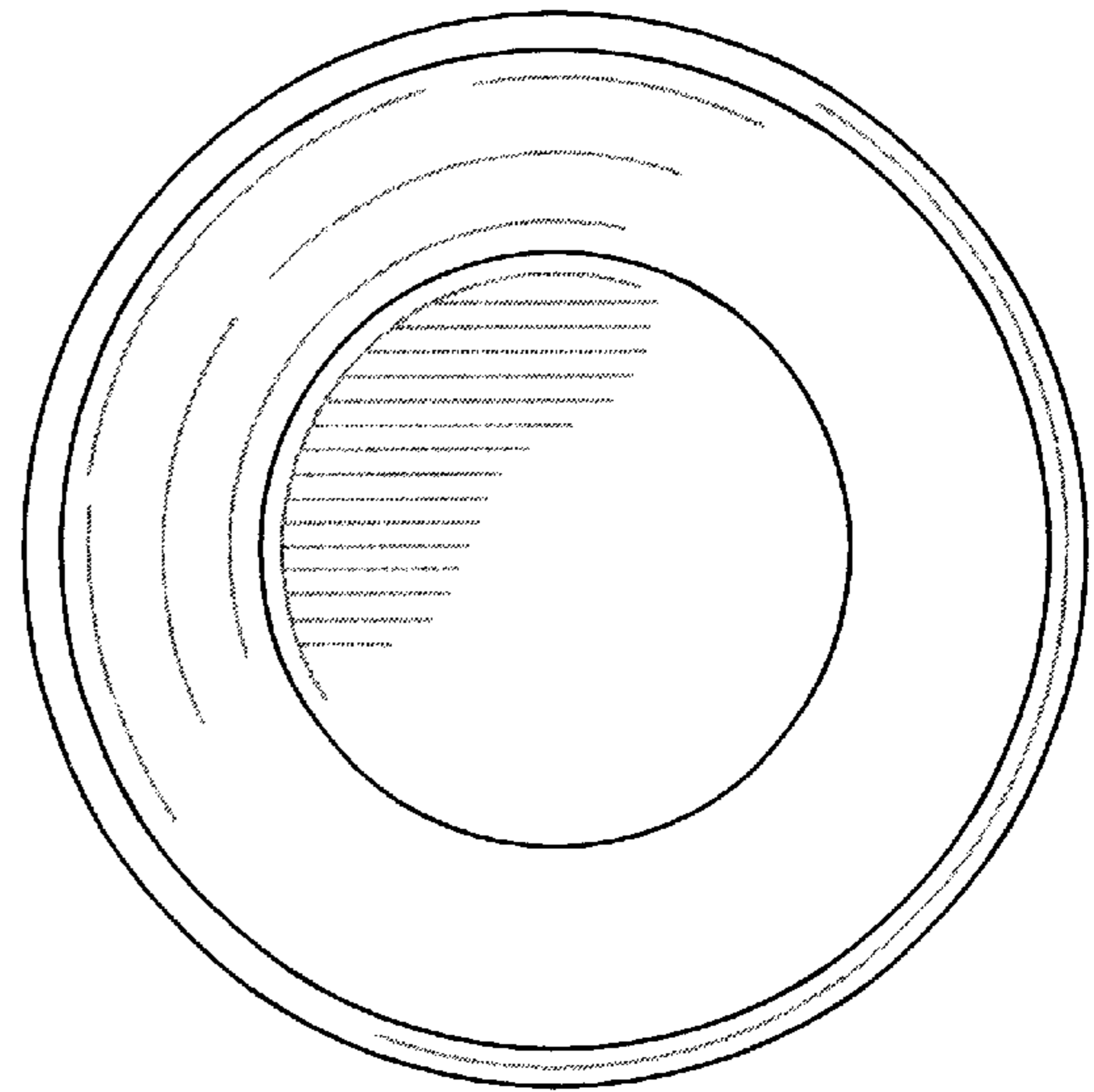

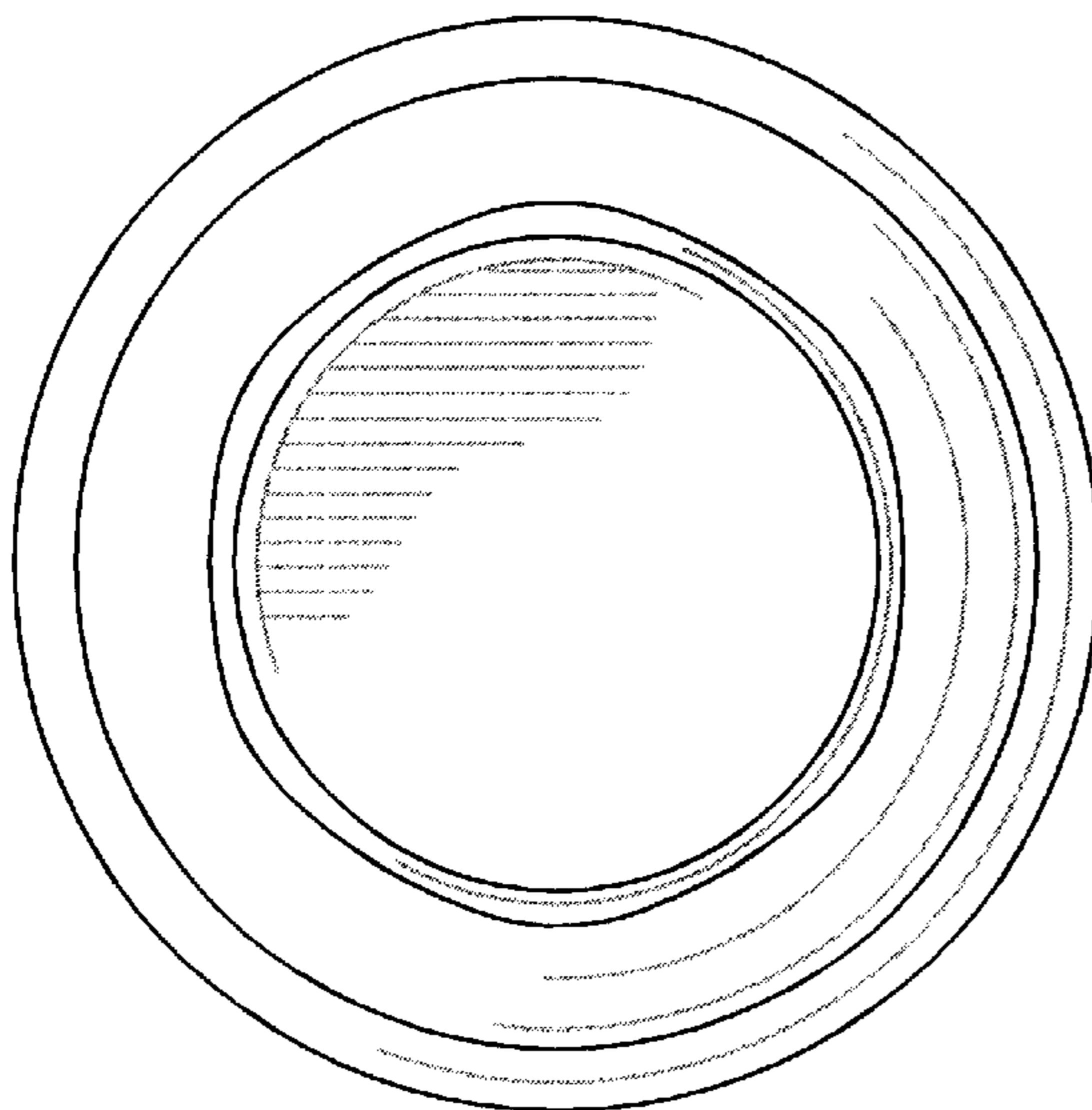
