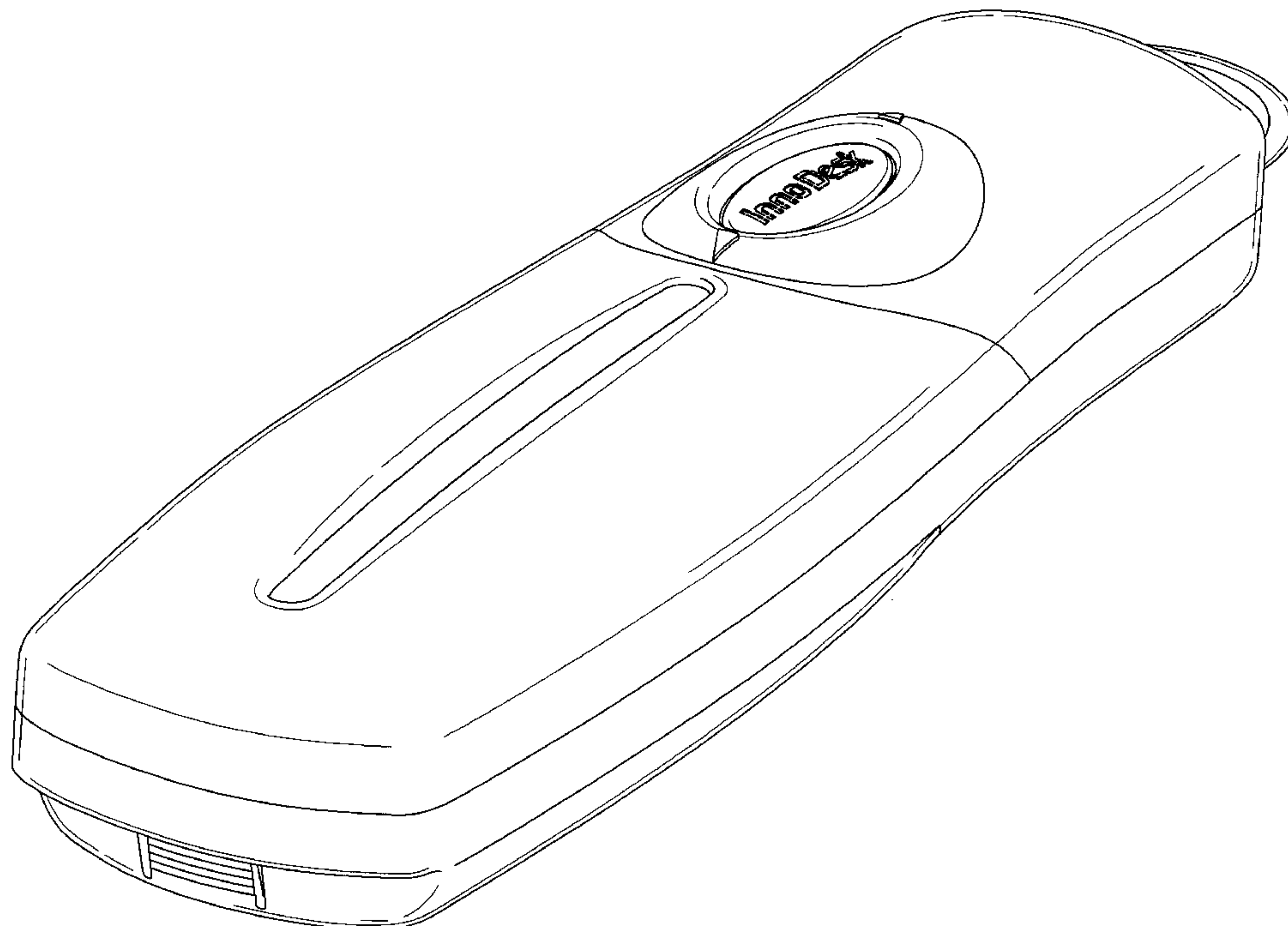
(57) **CLAIM**

The ornamental design for a hand-held paper shredder, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the hand-held paper shredder; FIG. 2 is right side view of the hand-held paper shredder, the opposite side being a mirror image thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a front elevational view thereof; and, FIG. 6 is a rear elevational view thereof. The indicia depicted by means of broken lines in FIGS. 1 and 3 has been shown for illustrative purposes only and forms no part of the claimed design.

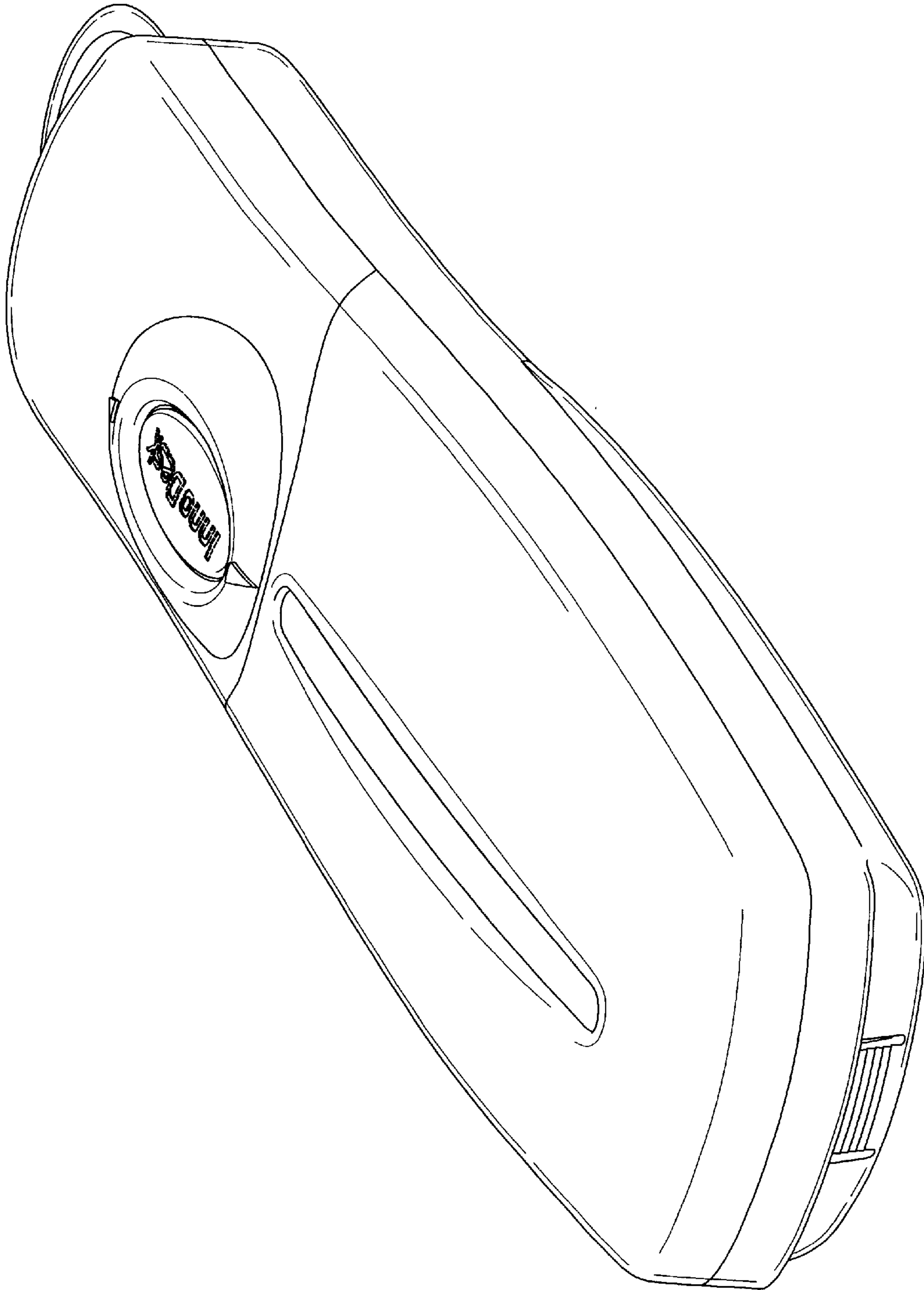

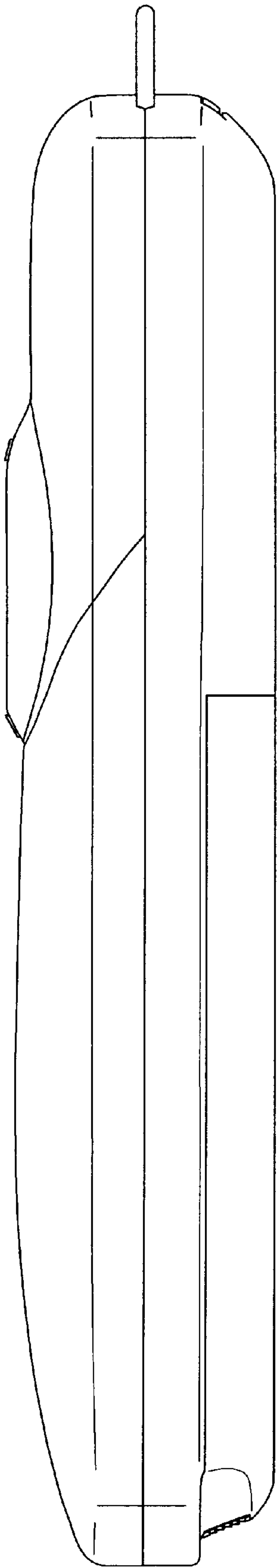

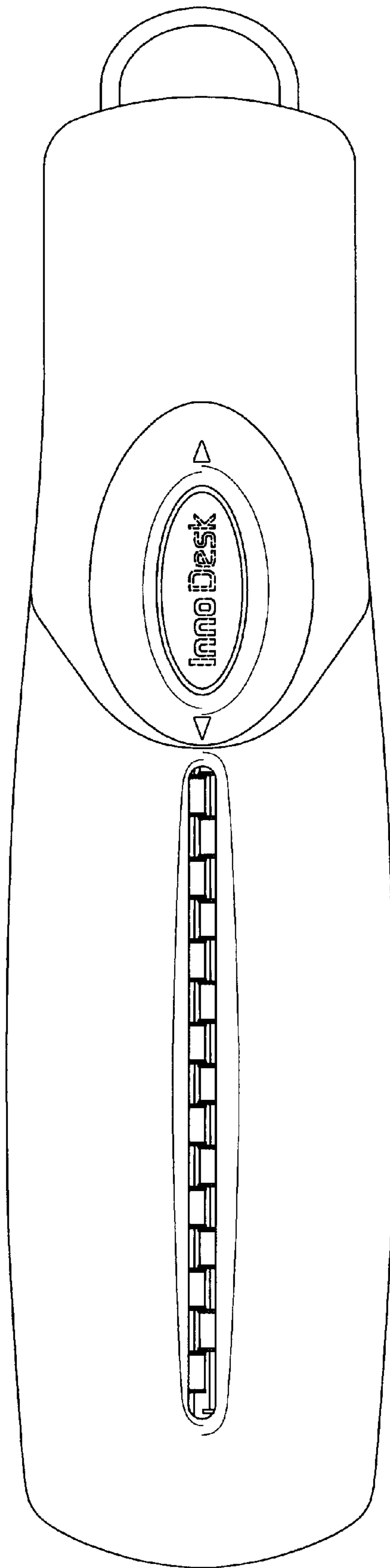

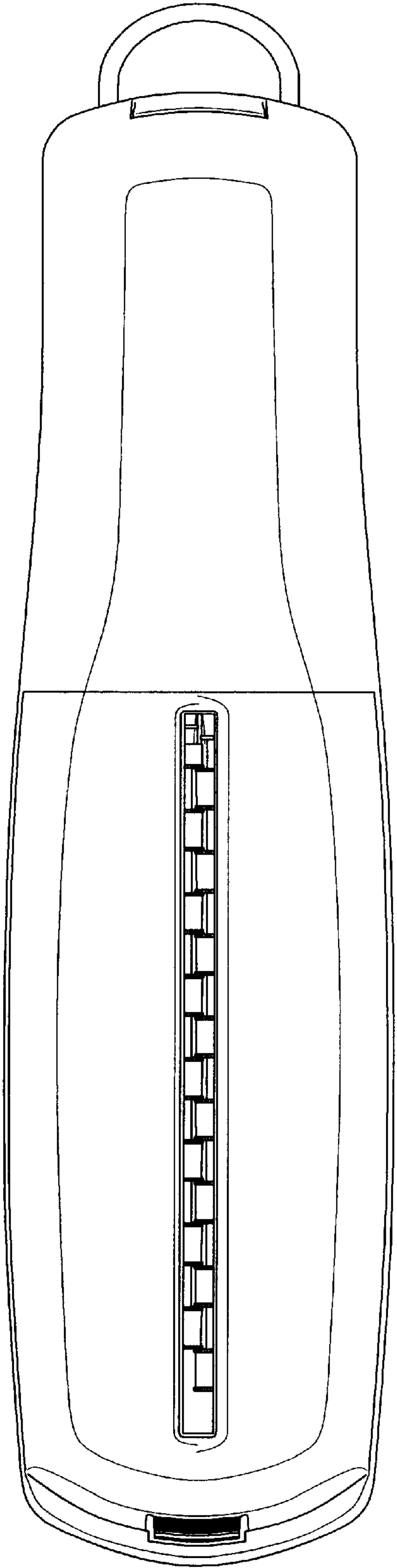

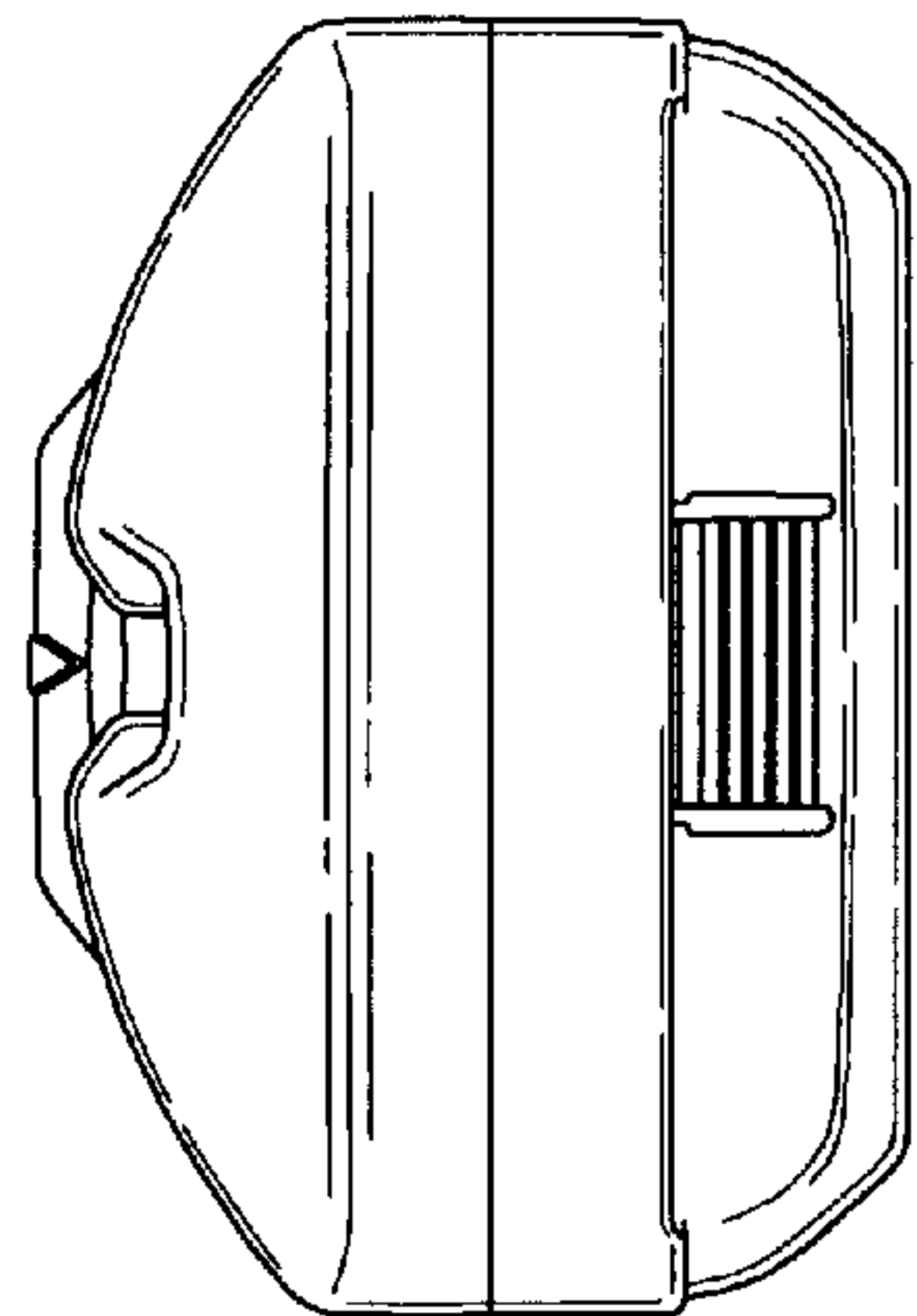

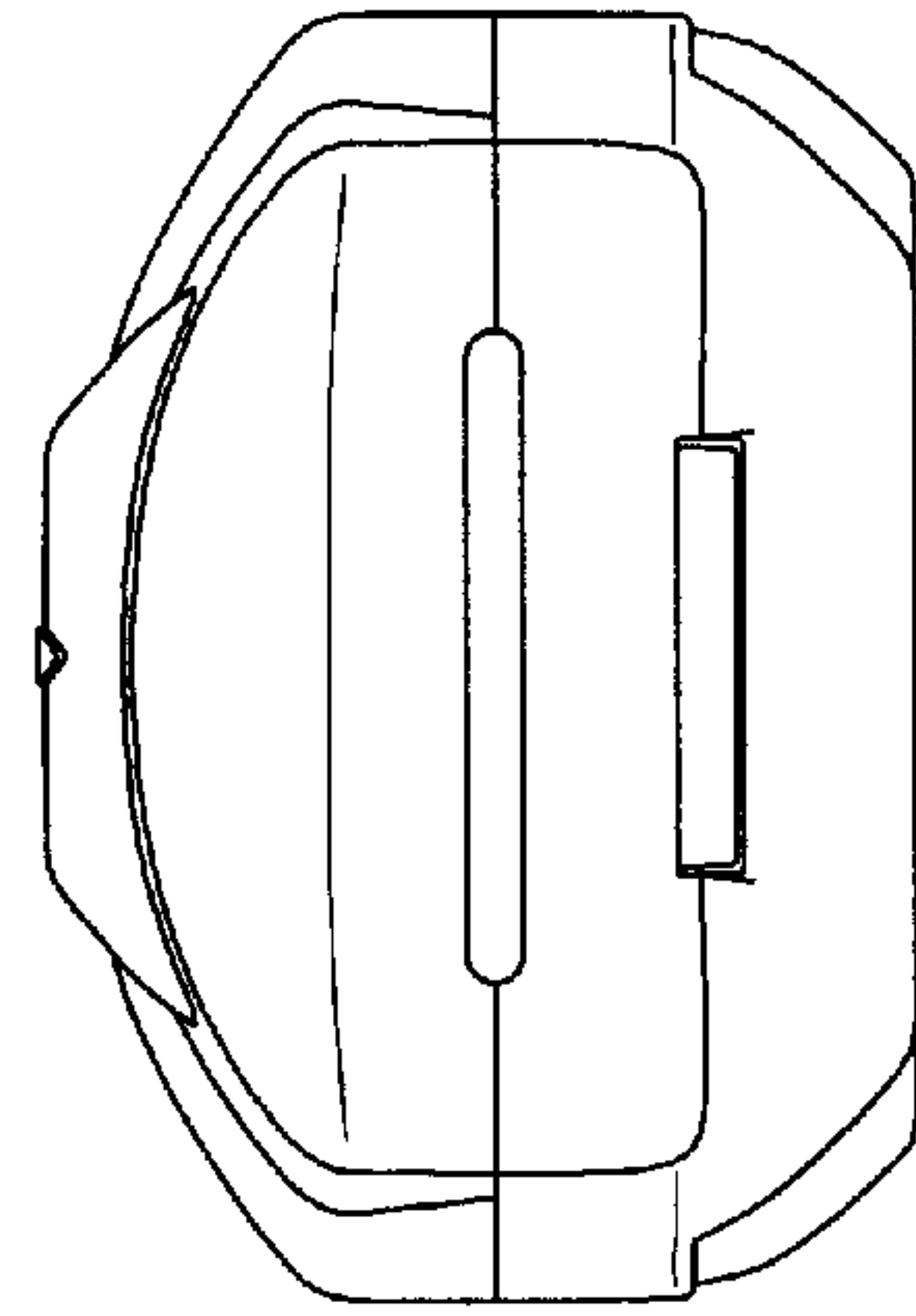
