DESCRIPTION

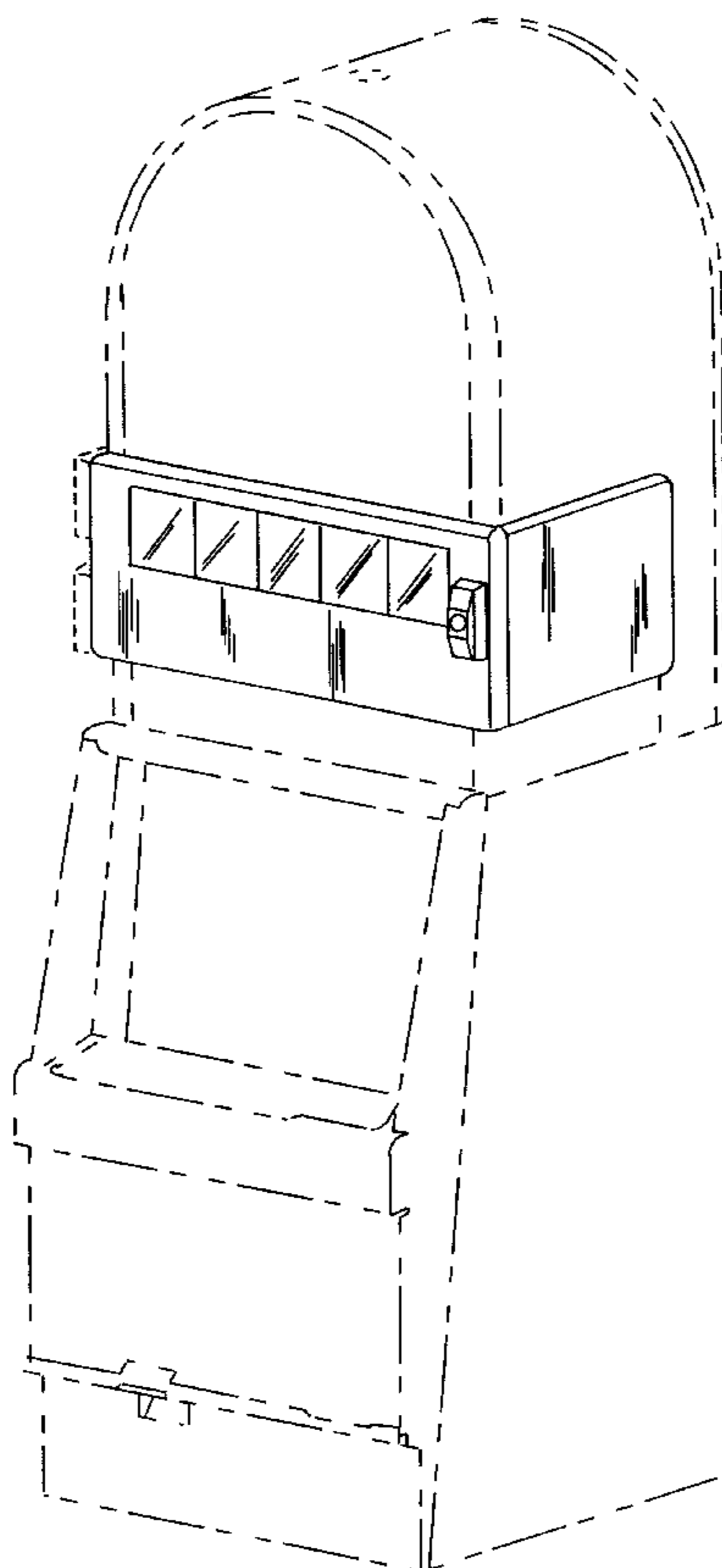
FIG. 1 is a front elevation view of the gaming device vault according to one embodiment.

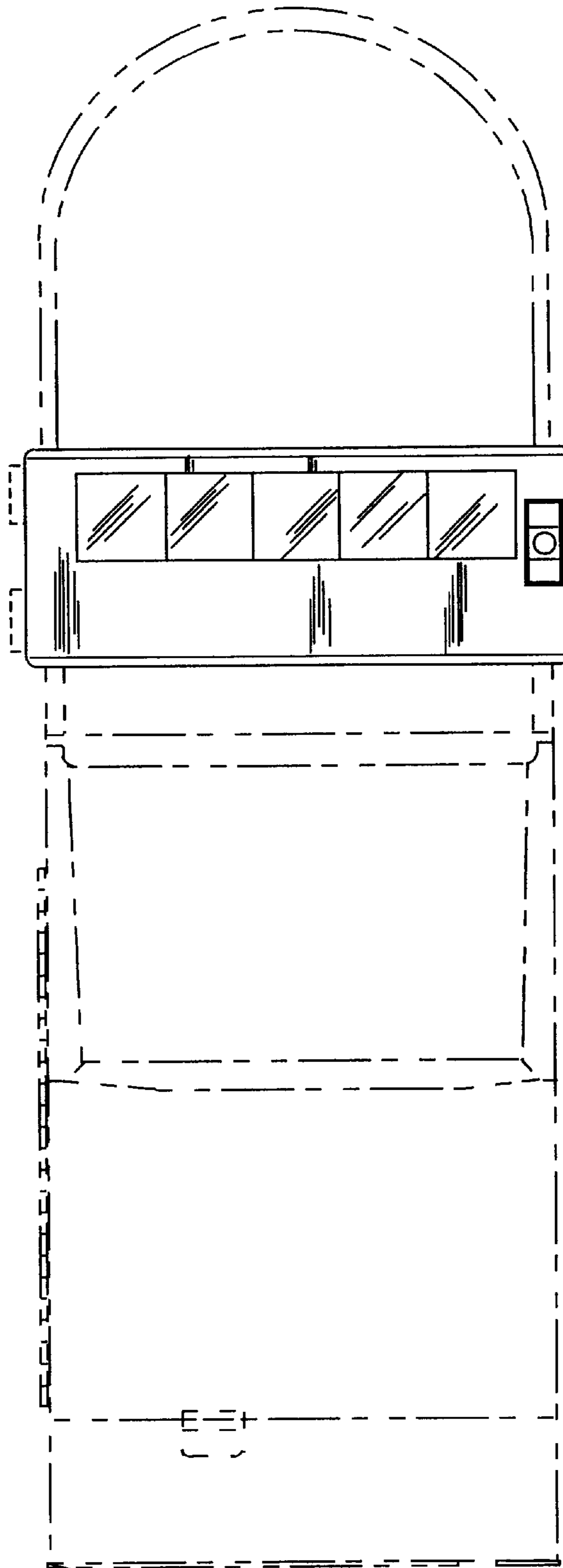

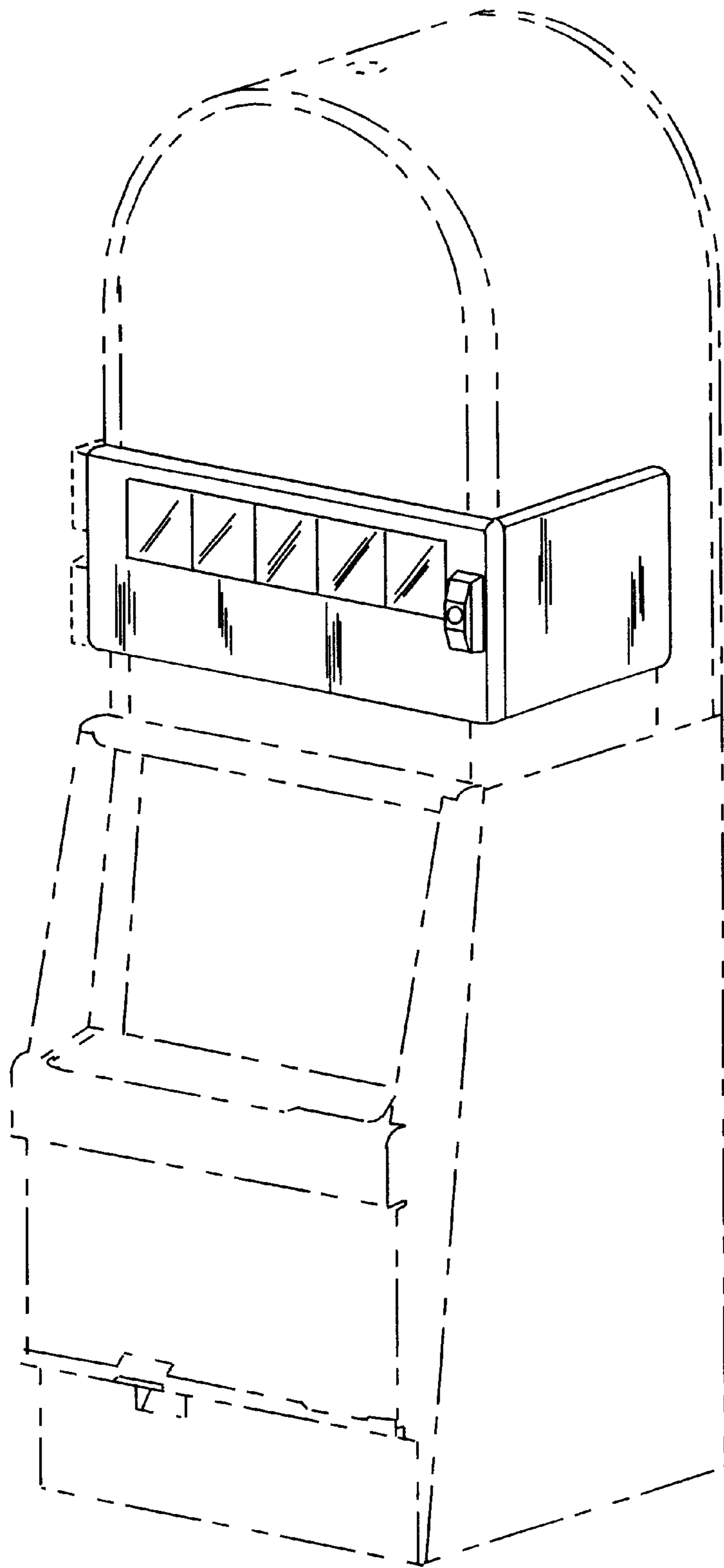

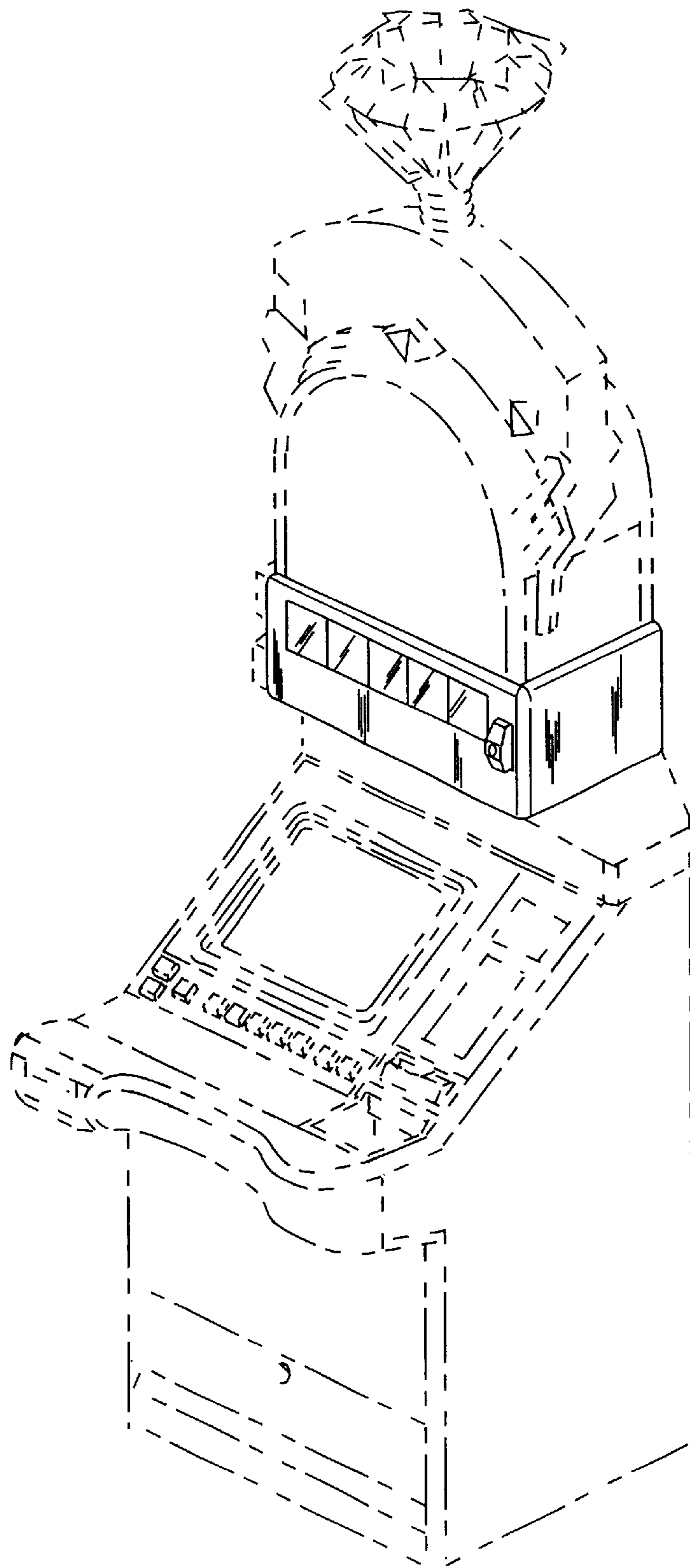
