FIG. 3 is a right elevational view of FIG. 1; a left elevational view is same image as FIG. 3

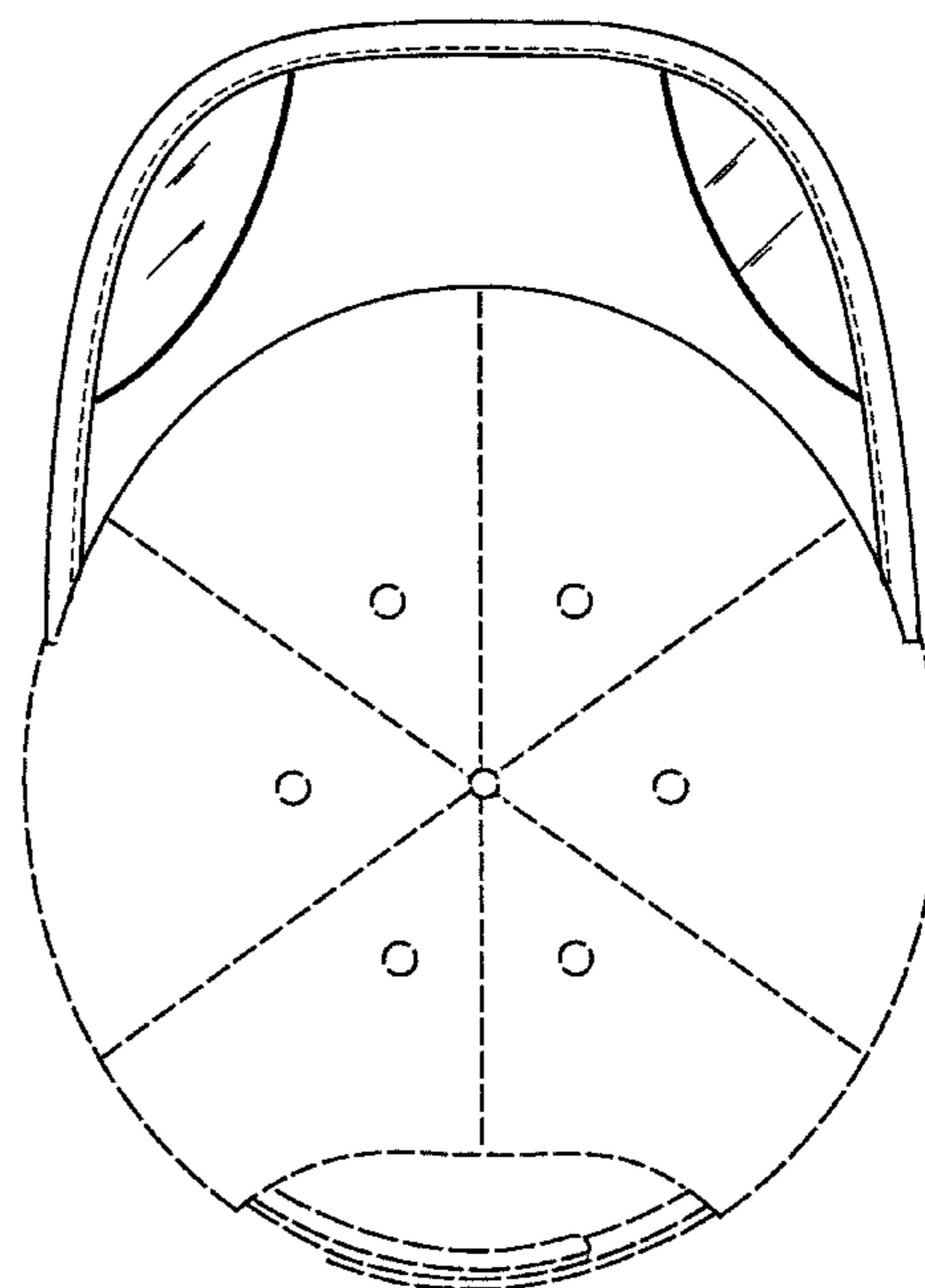
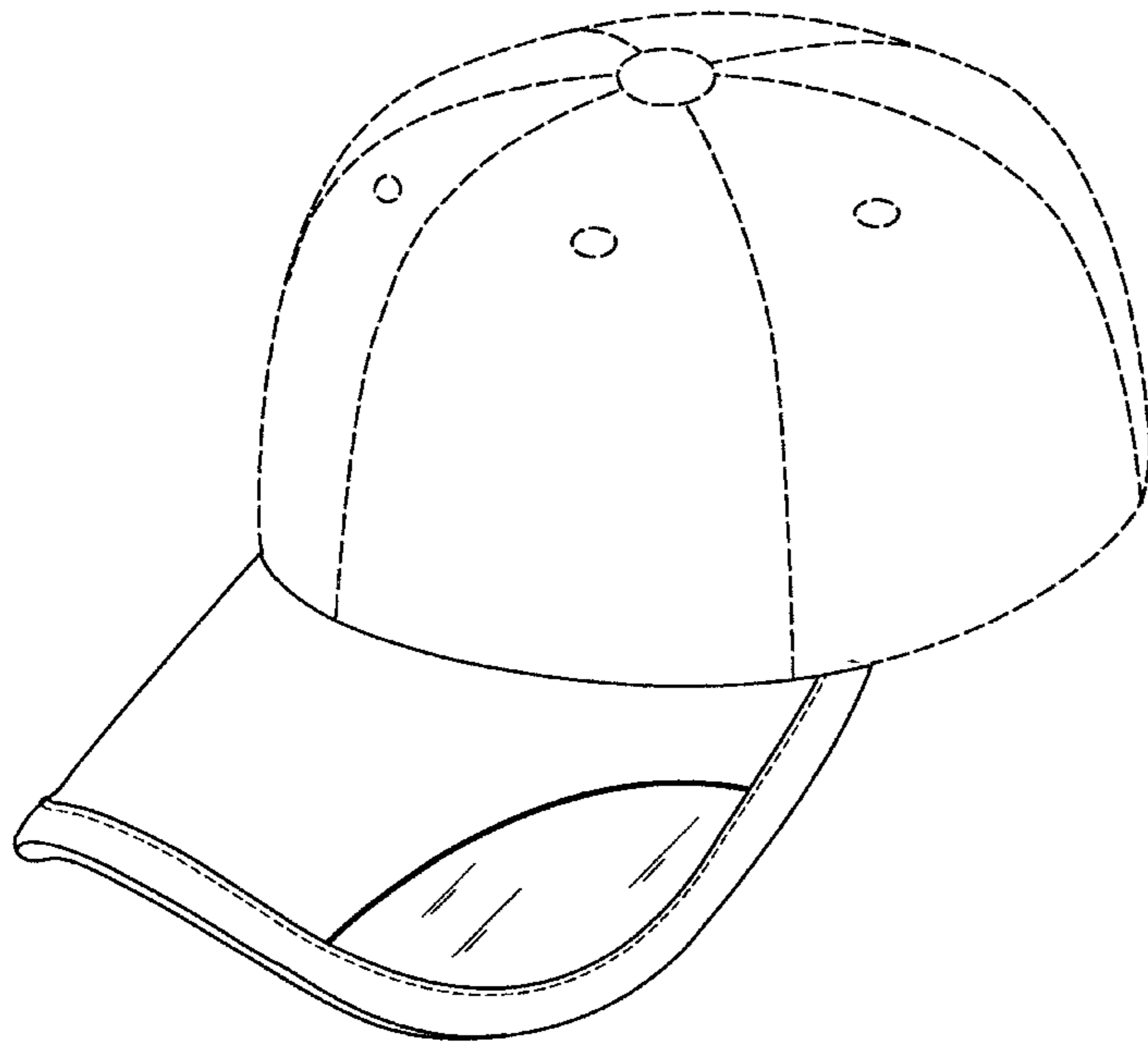
FIG. 4 is a top plan view of FIG. 1

FIG. 5 is a bottom plan view of FIG. 1; and,

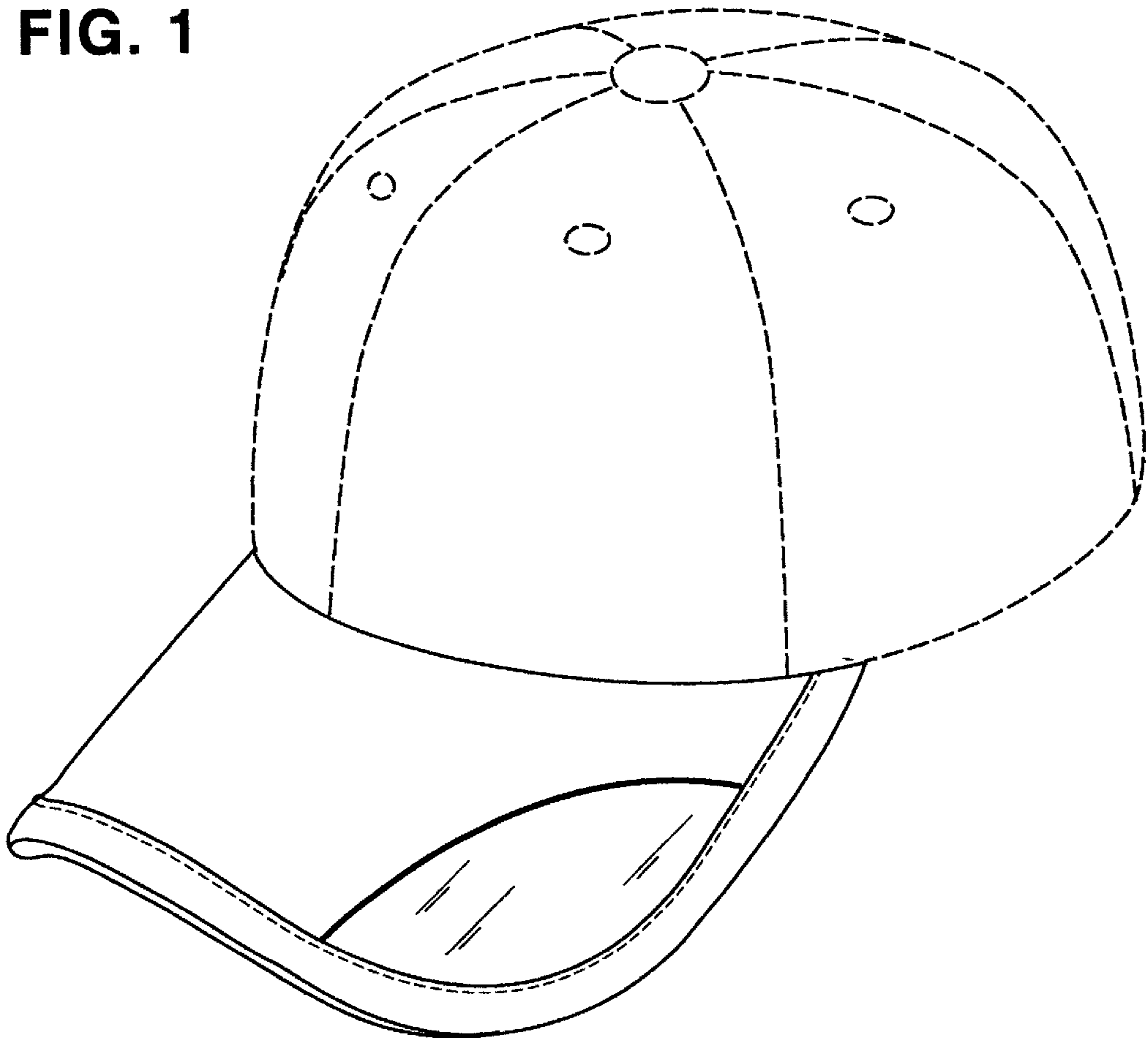
FIG. 6 is a rear elevational view of FIG. 1.

The broken lines showing of a cap in the drawing are for illustrative purposes only and form no part of the claimed design and the broken line shown on the visor is intended to represent stitching.

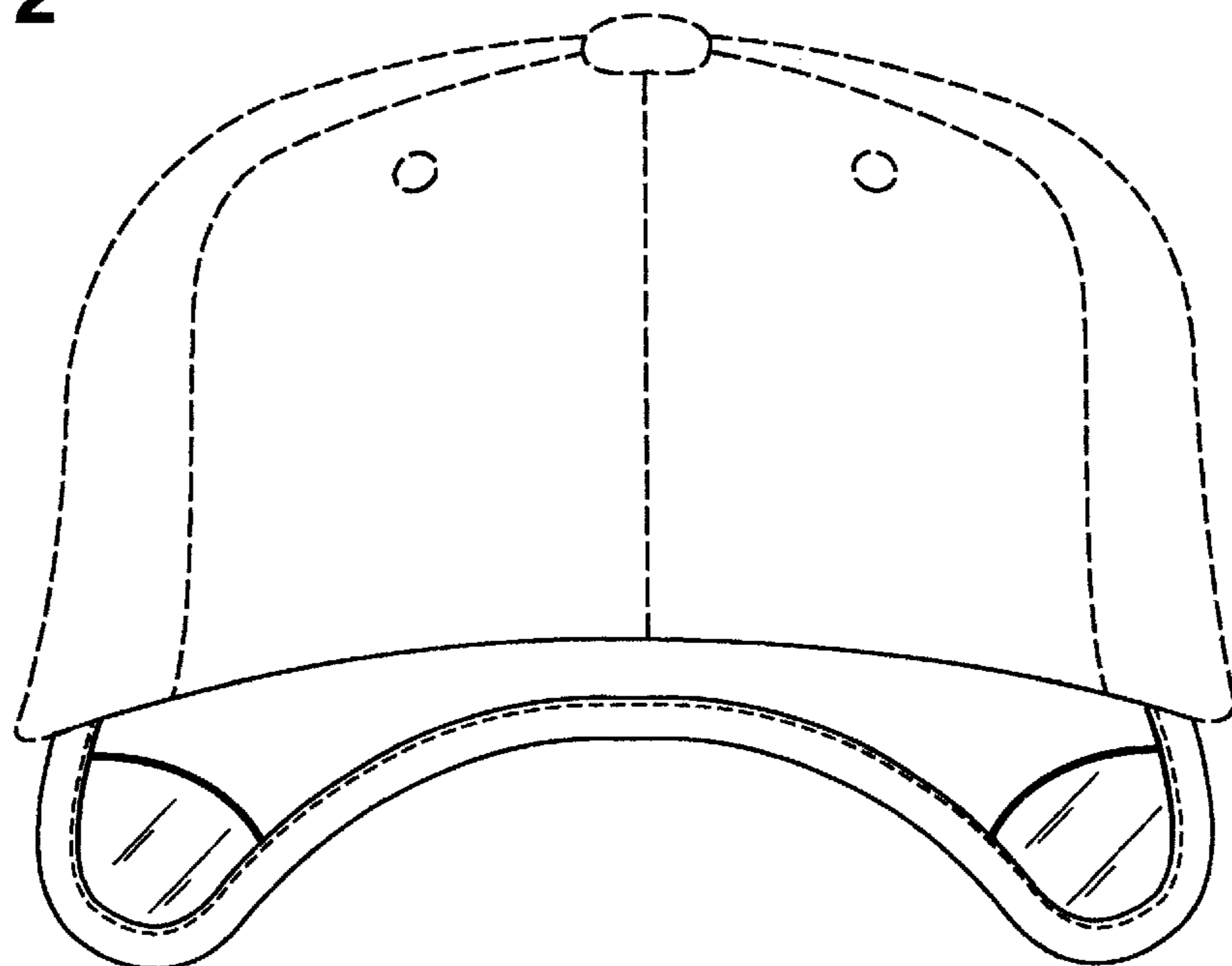

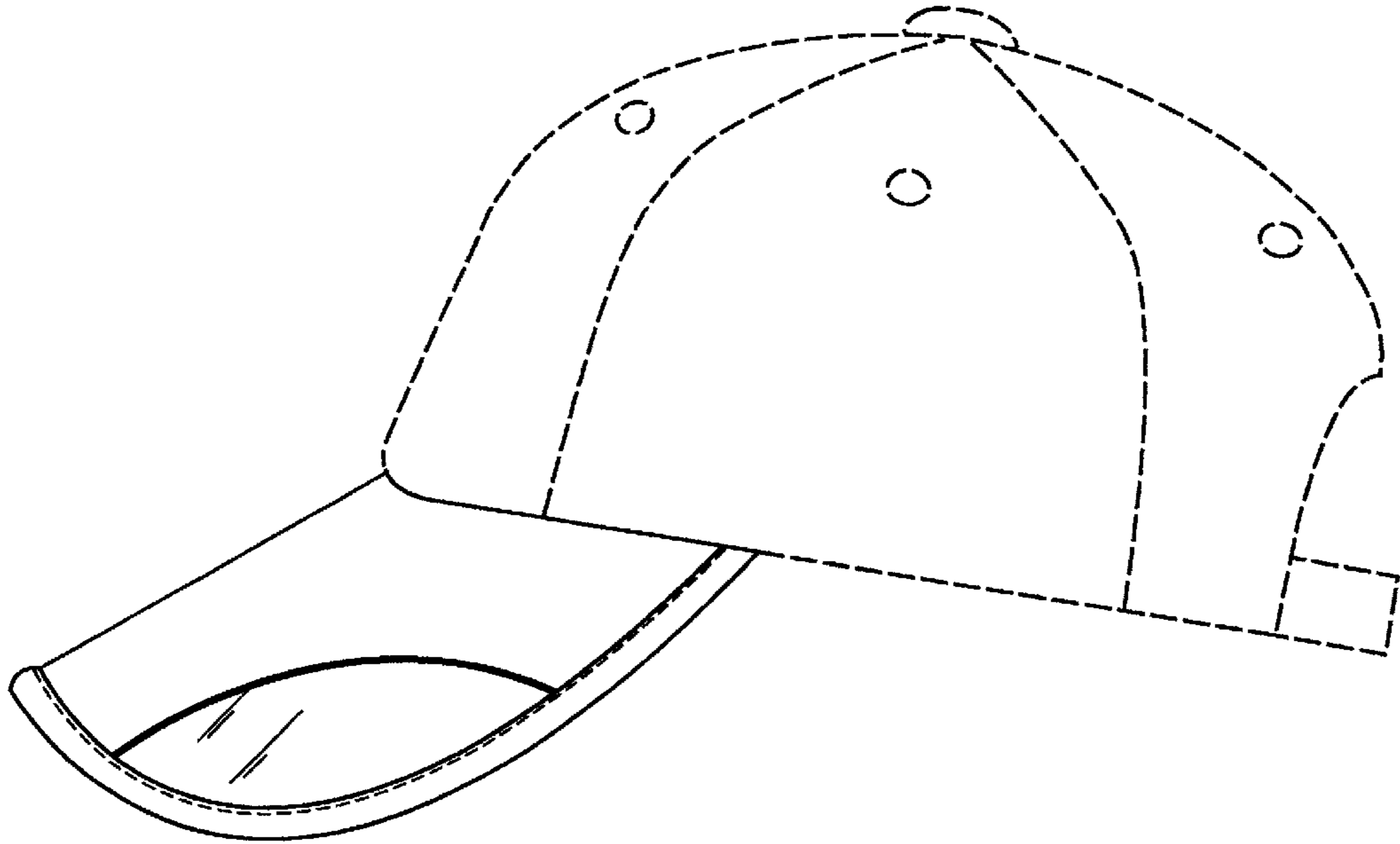

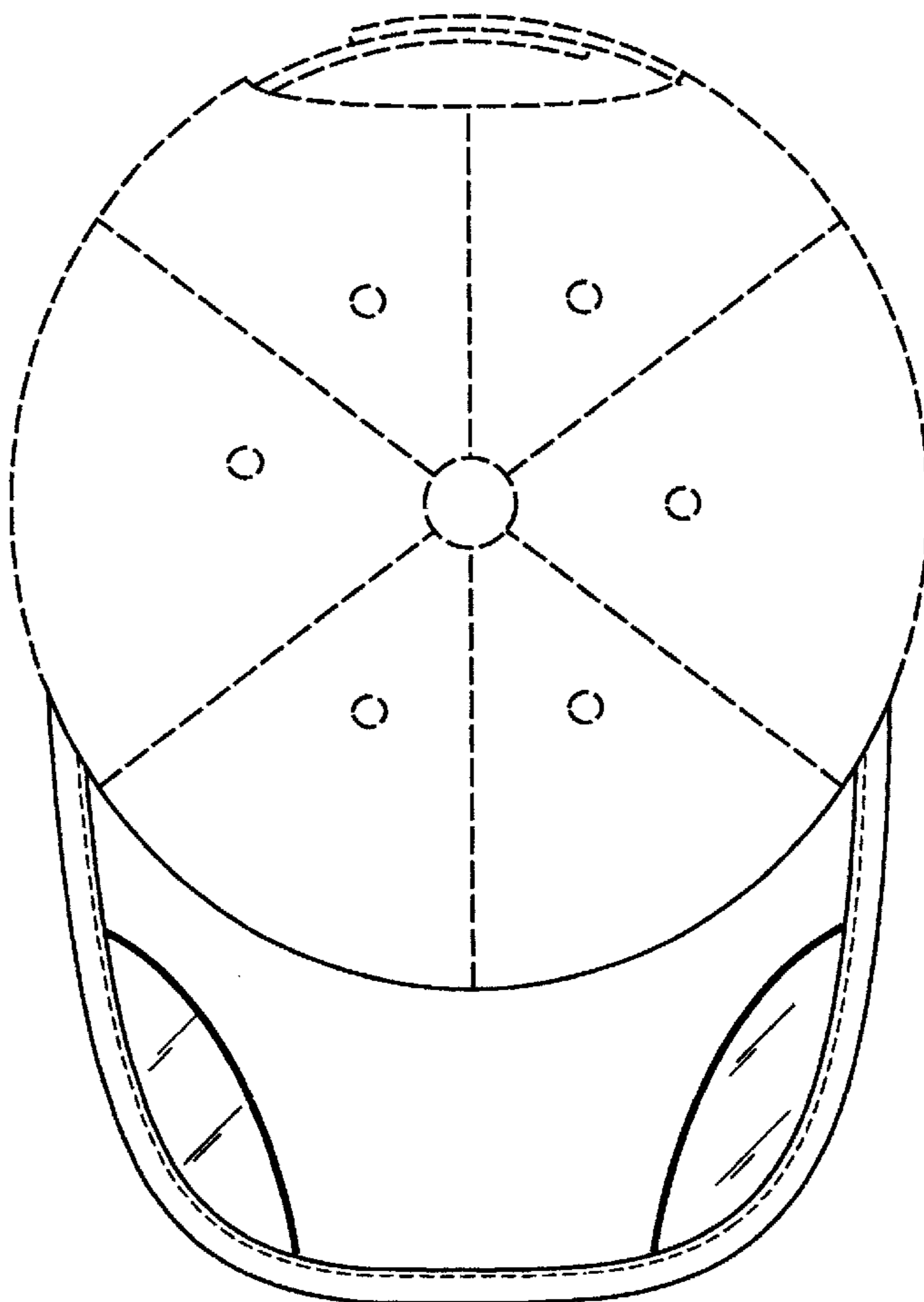

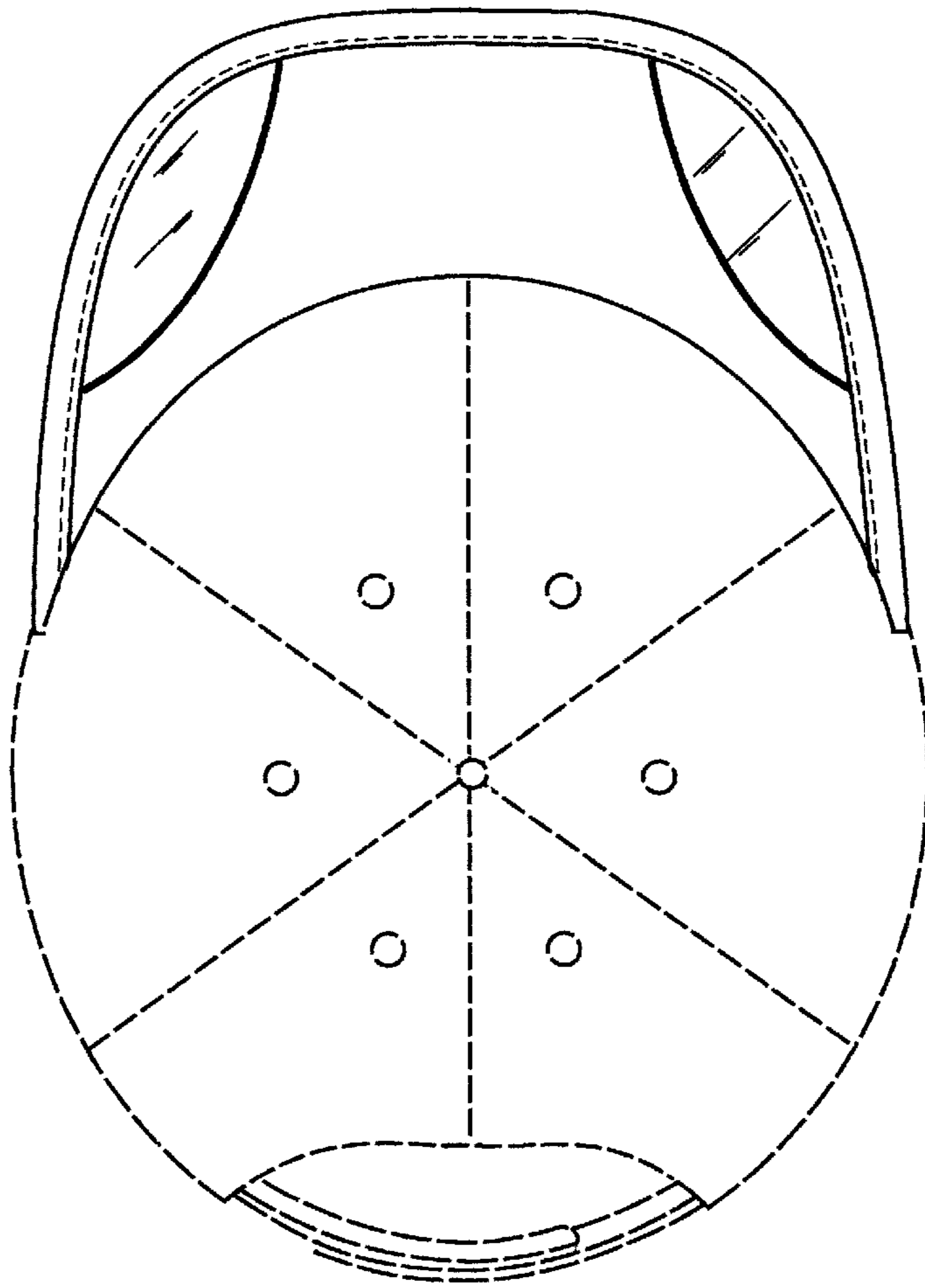
