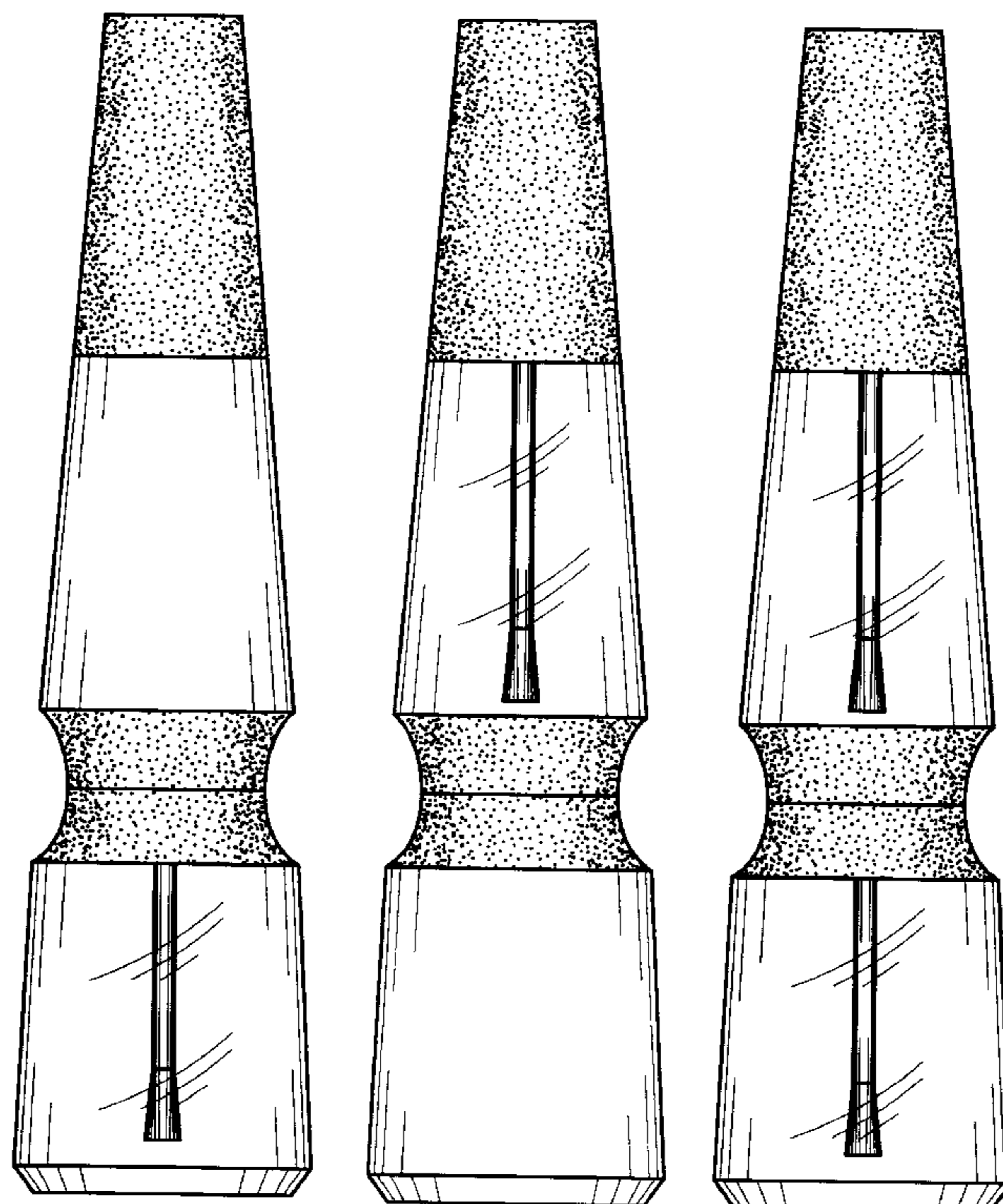

DESCRIPTION

FIG. 1 is a side elevational view of a frusto-conical container with brush showing our new design;
FIG. 2 is a side elevational view of a second embodiment of the frusto-conical container with brush;
FIG. 3 is a side elevational view of a third embodiment of the frusto-conical container with brush; and,
FIG. 4 is a side elevational view of a fourth embodiment of the frusto-conical container with brush.

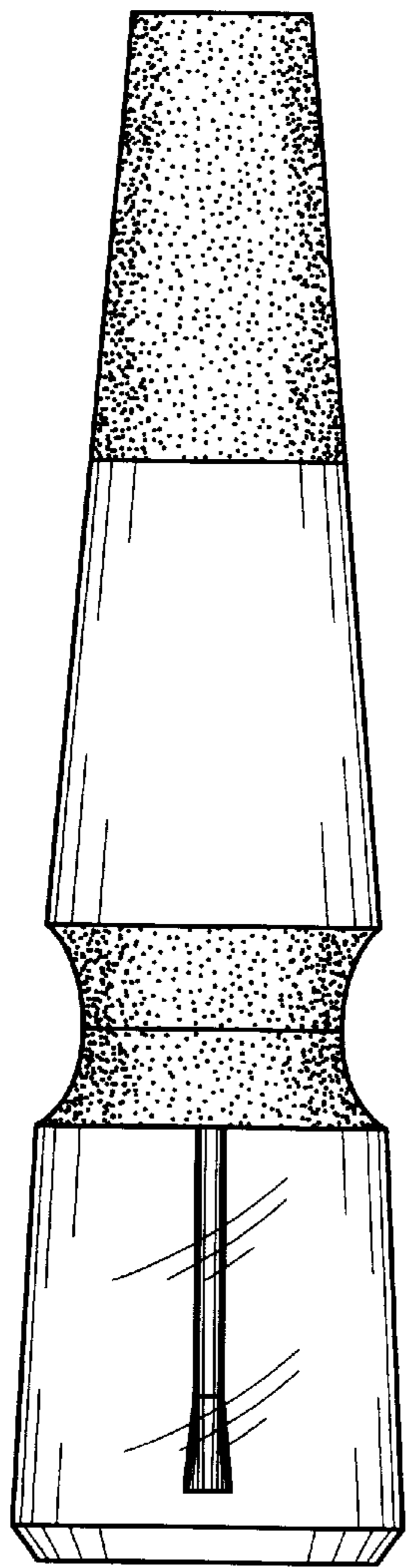

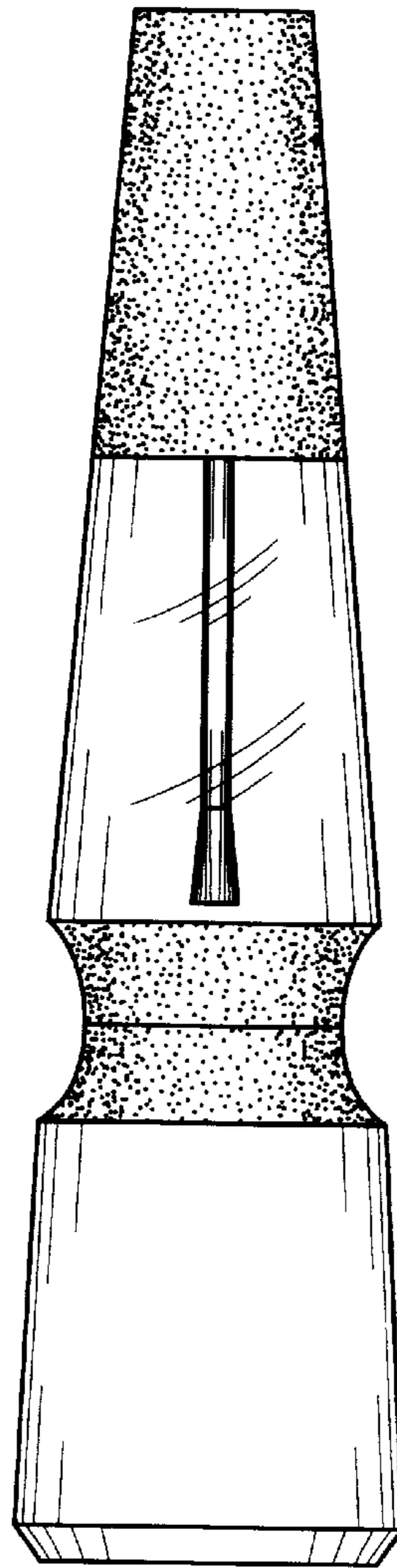

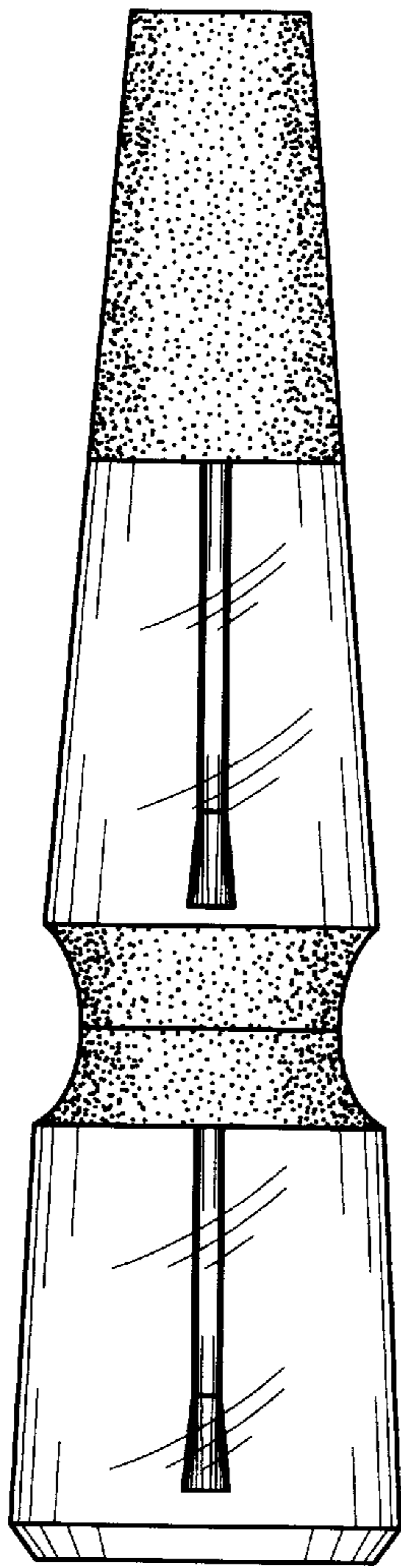

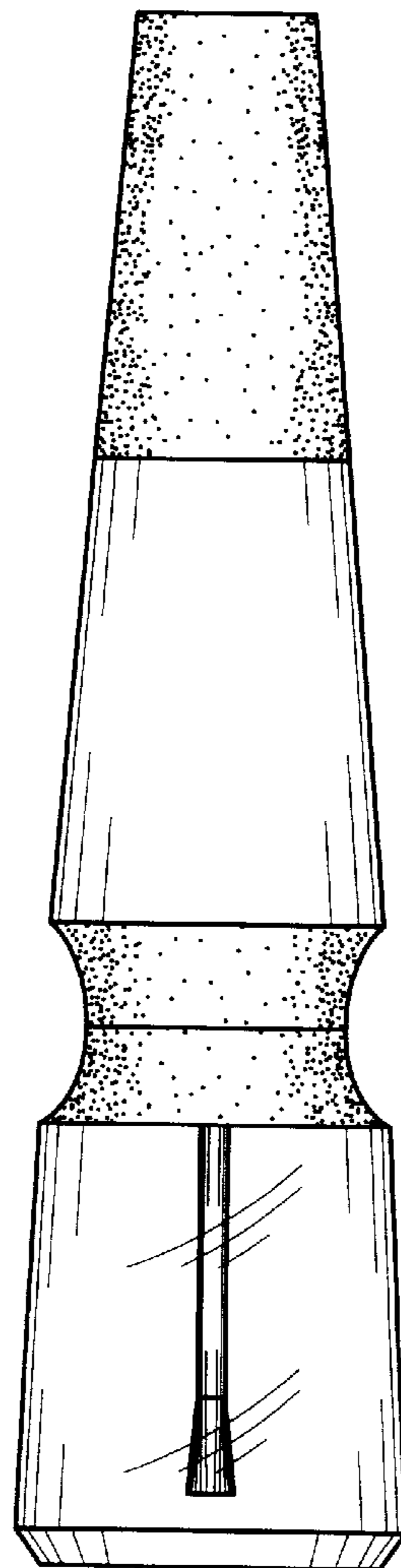
