(57) **CLAIM**

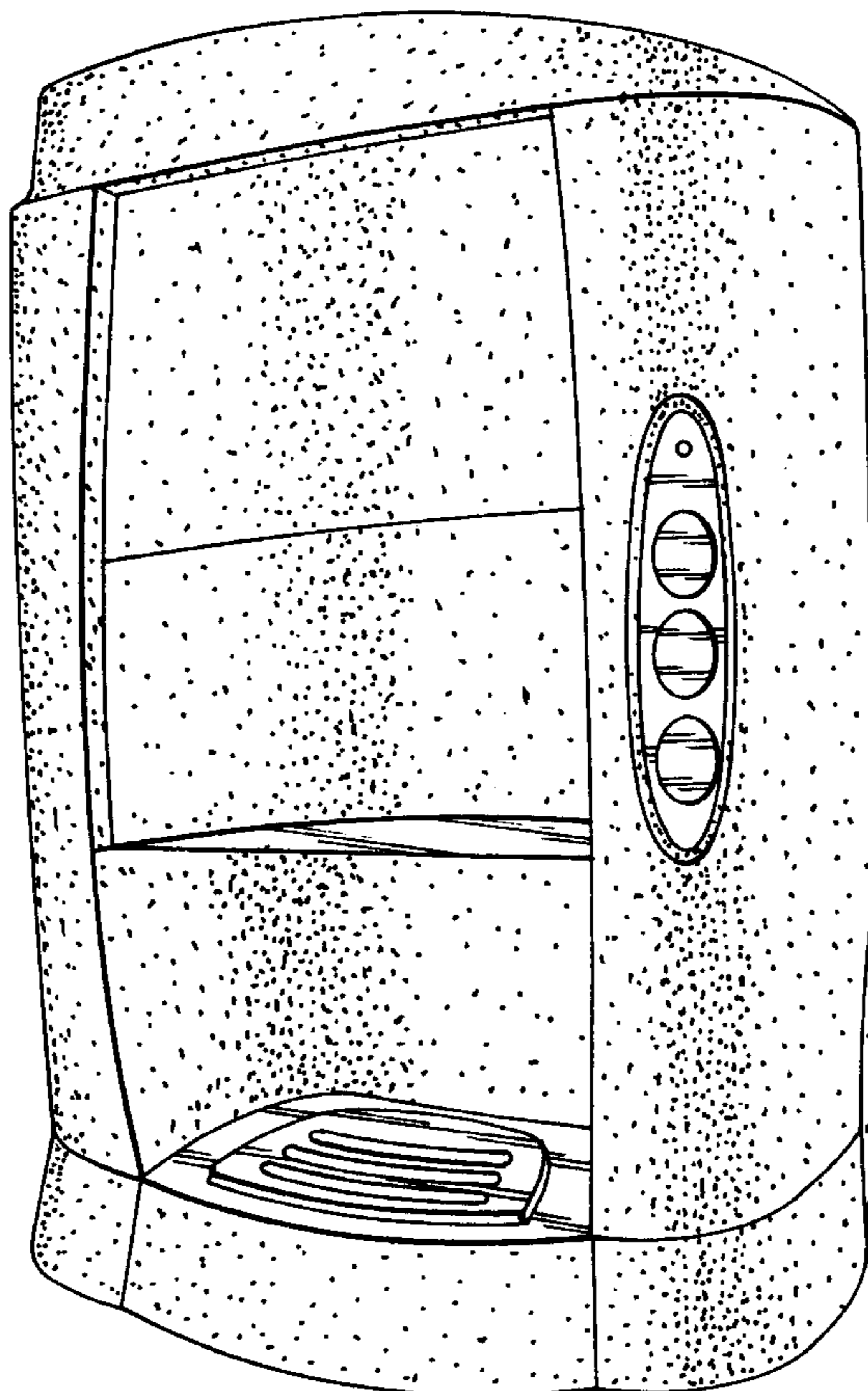
The ornamental design for a coffee machine, as shown and described.

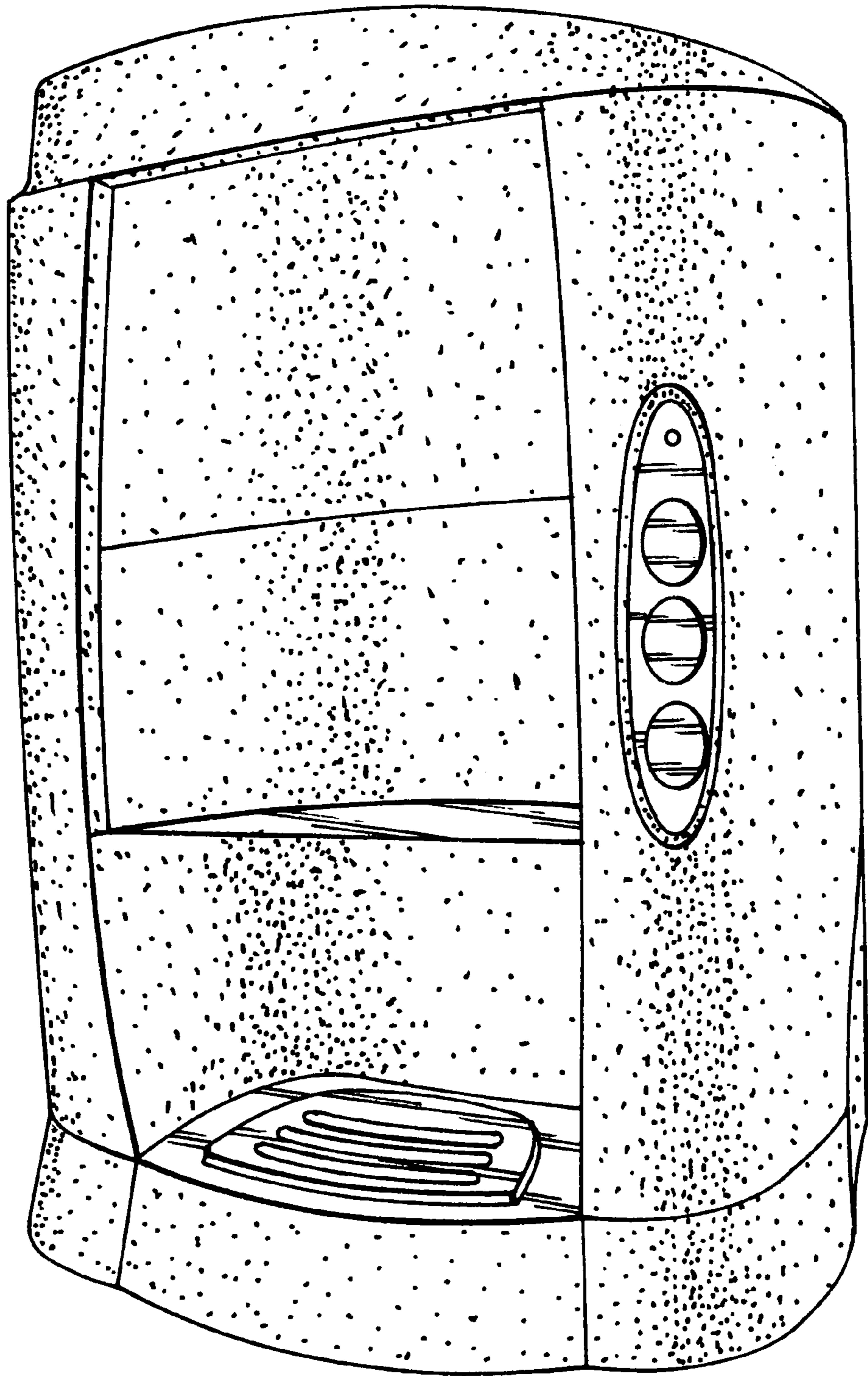

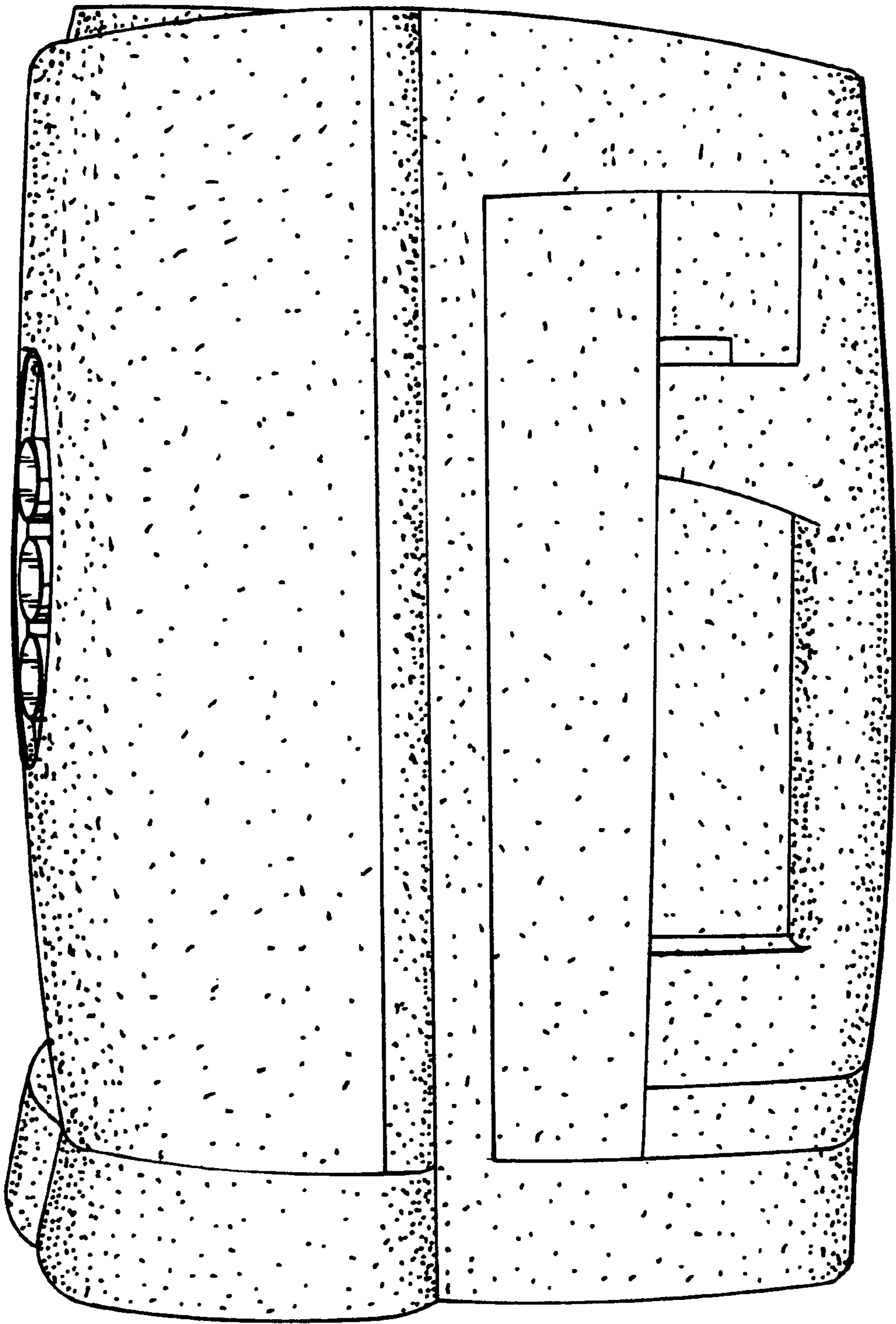

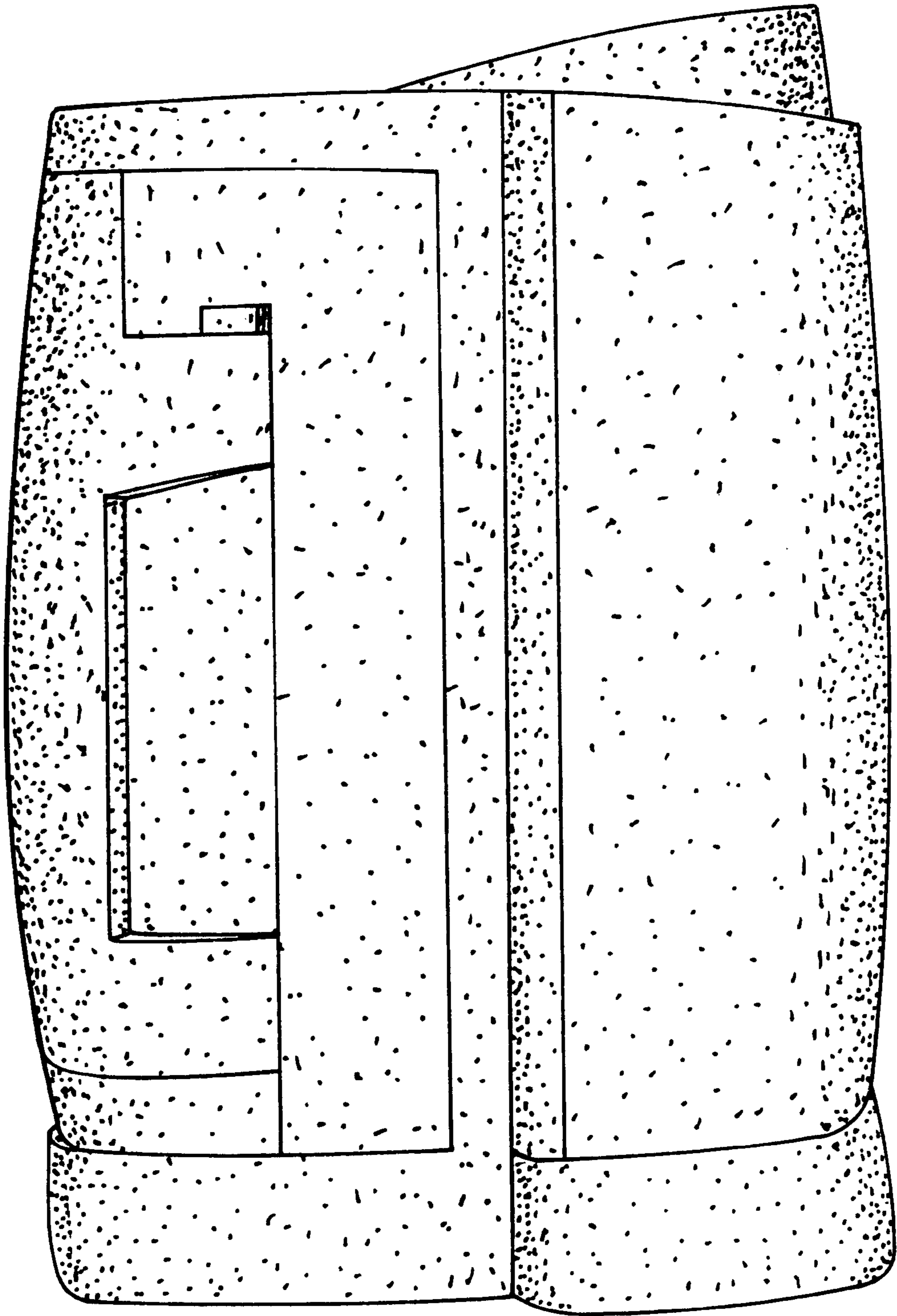

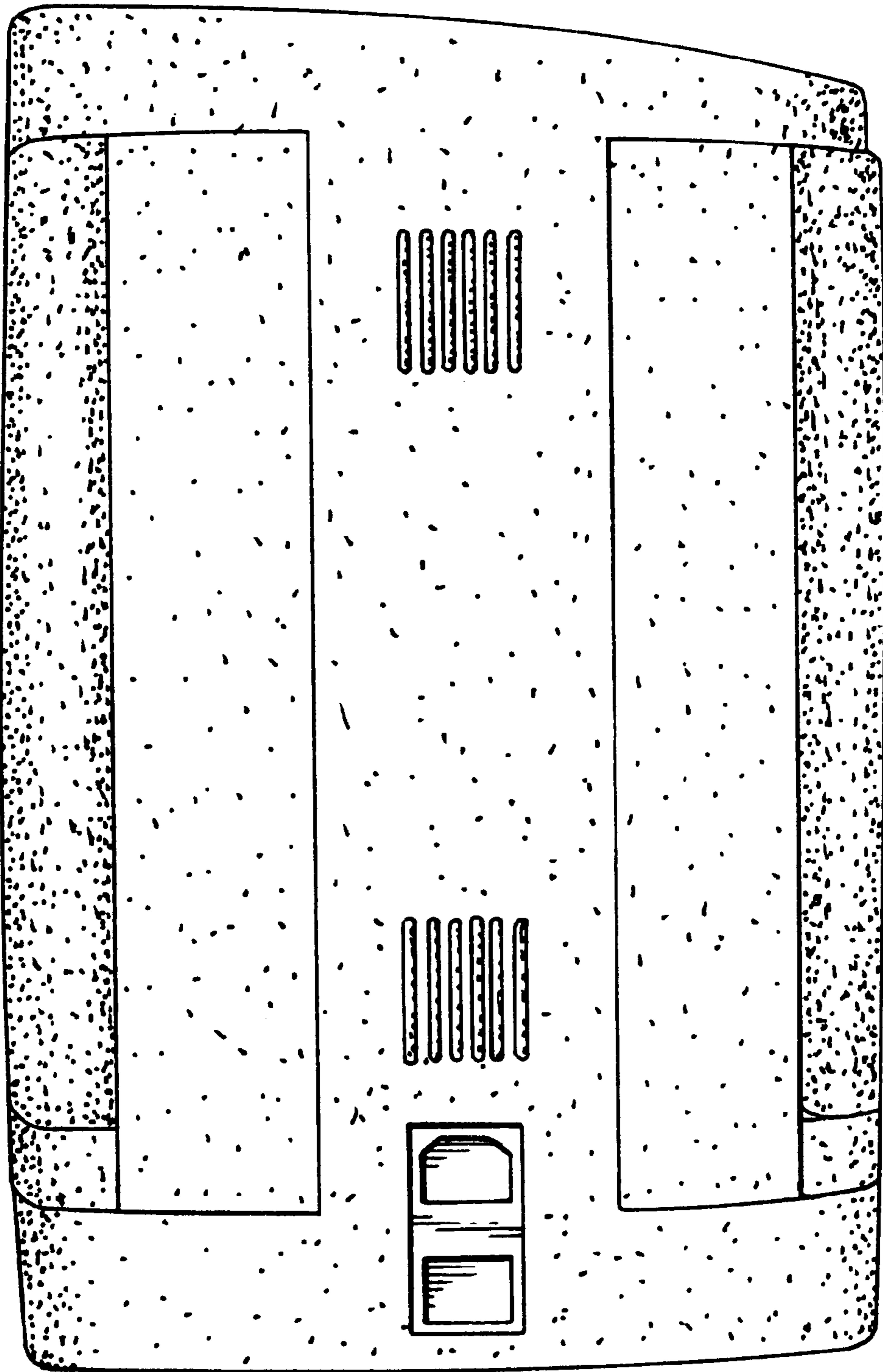

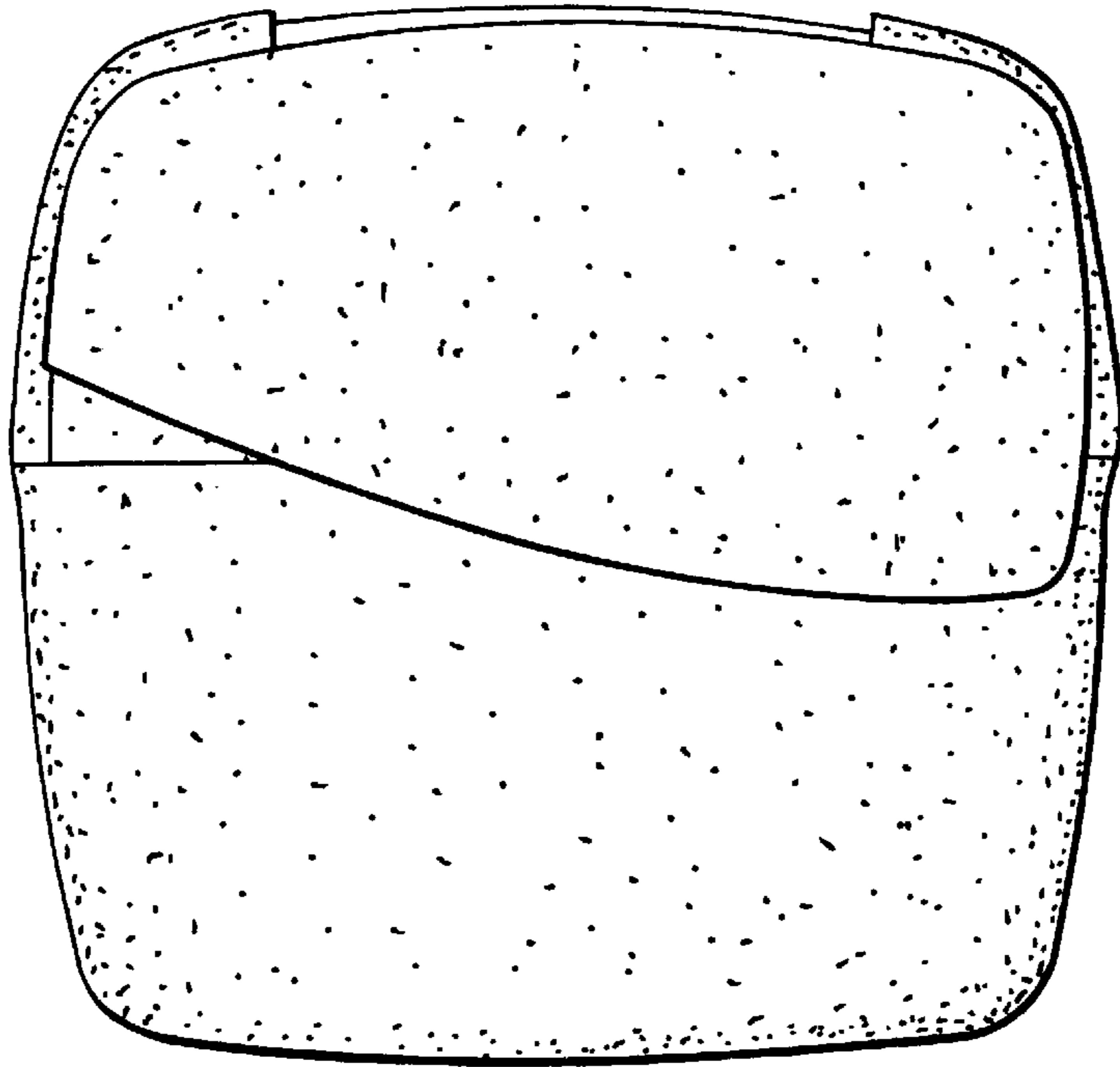

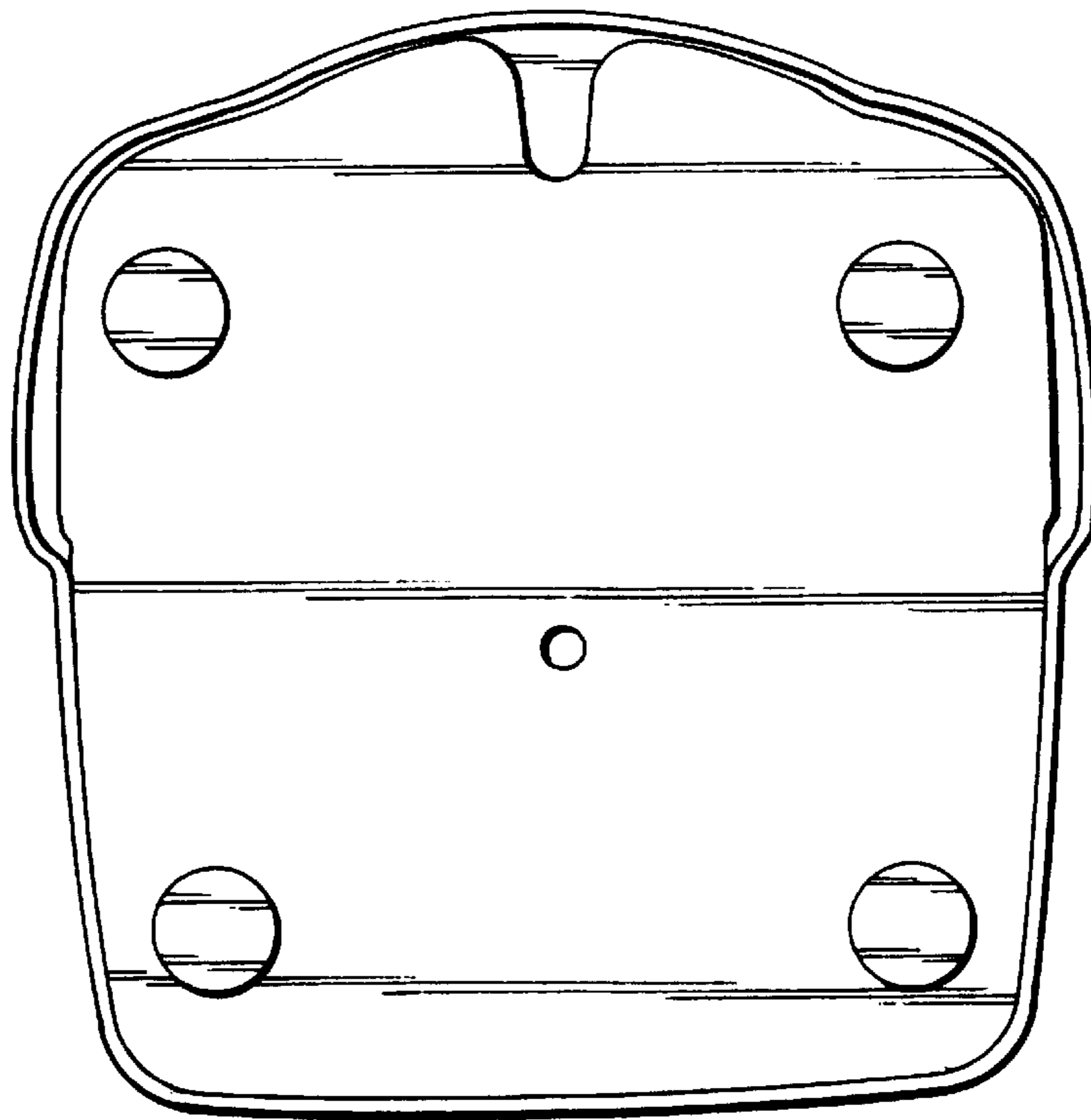
