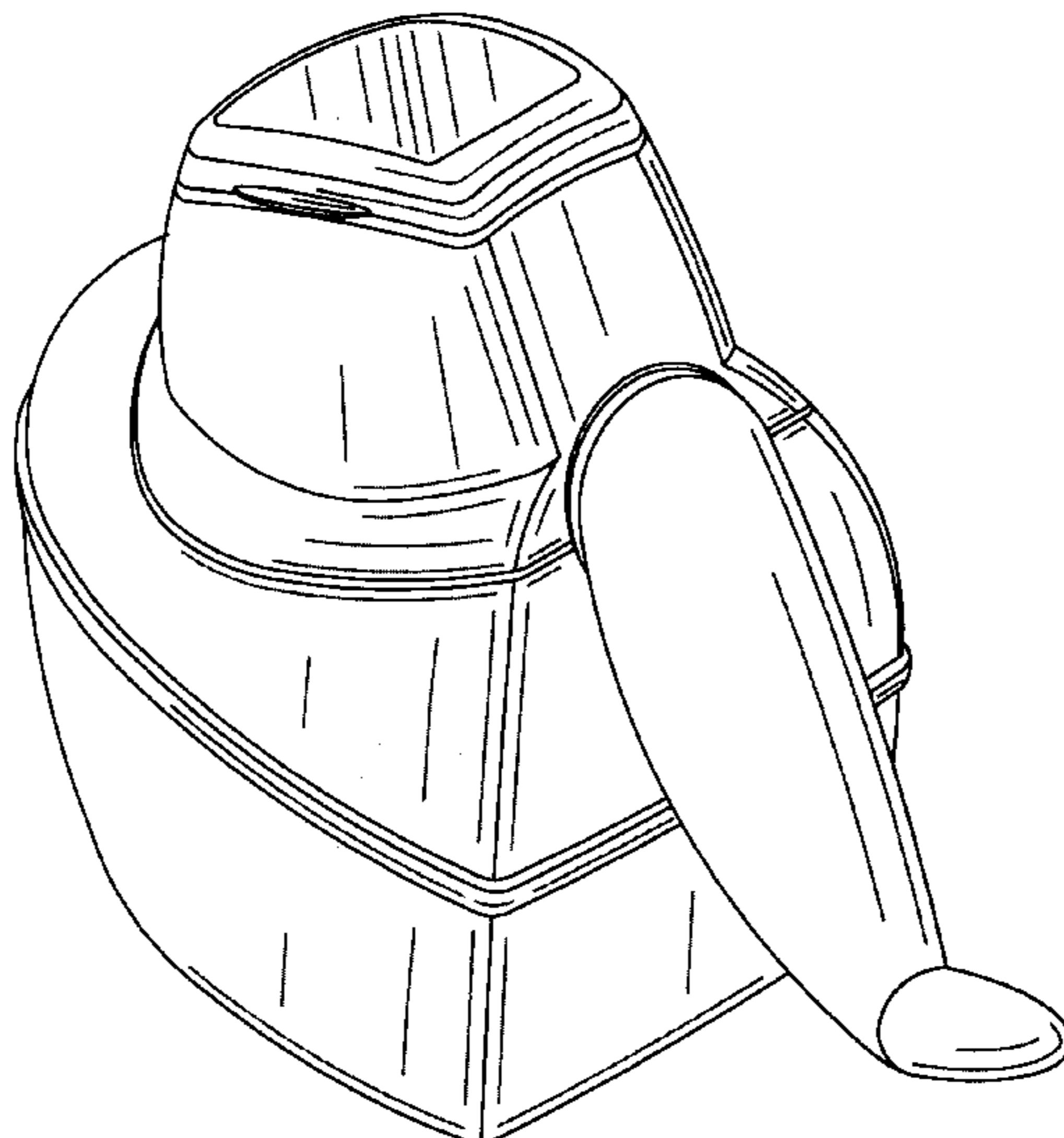
(57) **CLAIM**

The ornamental design for a manual crank food grinder, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, side and front perspective view of a manual crank food grinder showing the new design; FIG. 2 is a right side elevation view thereof; FIG. 3 is a left side elevation view thereof; FIG. 4 is a rear side elevation view thereof; FIG. 5 is a front side elevation view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof.

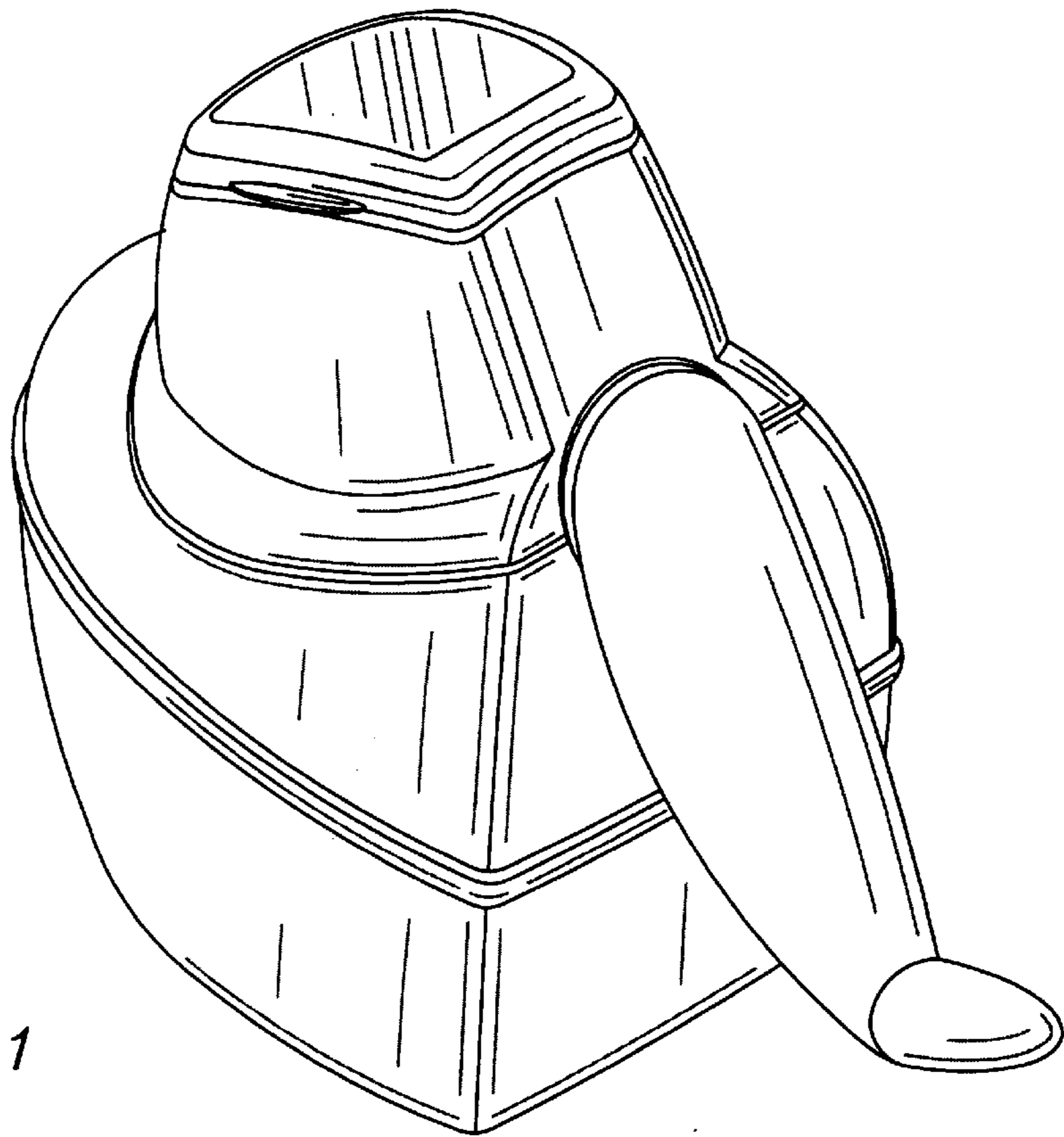

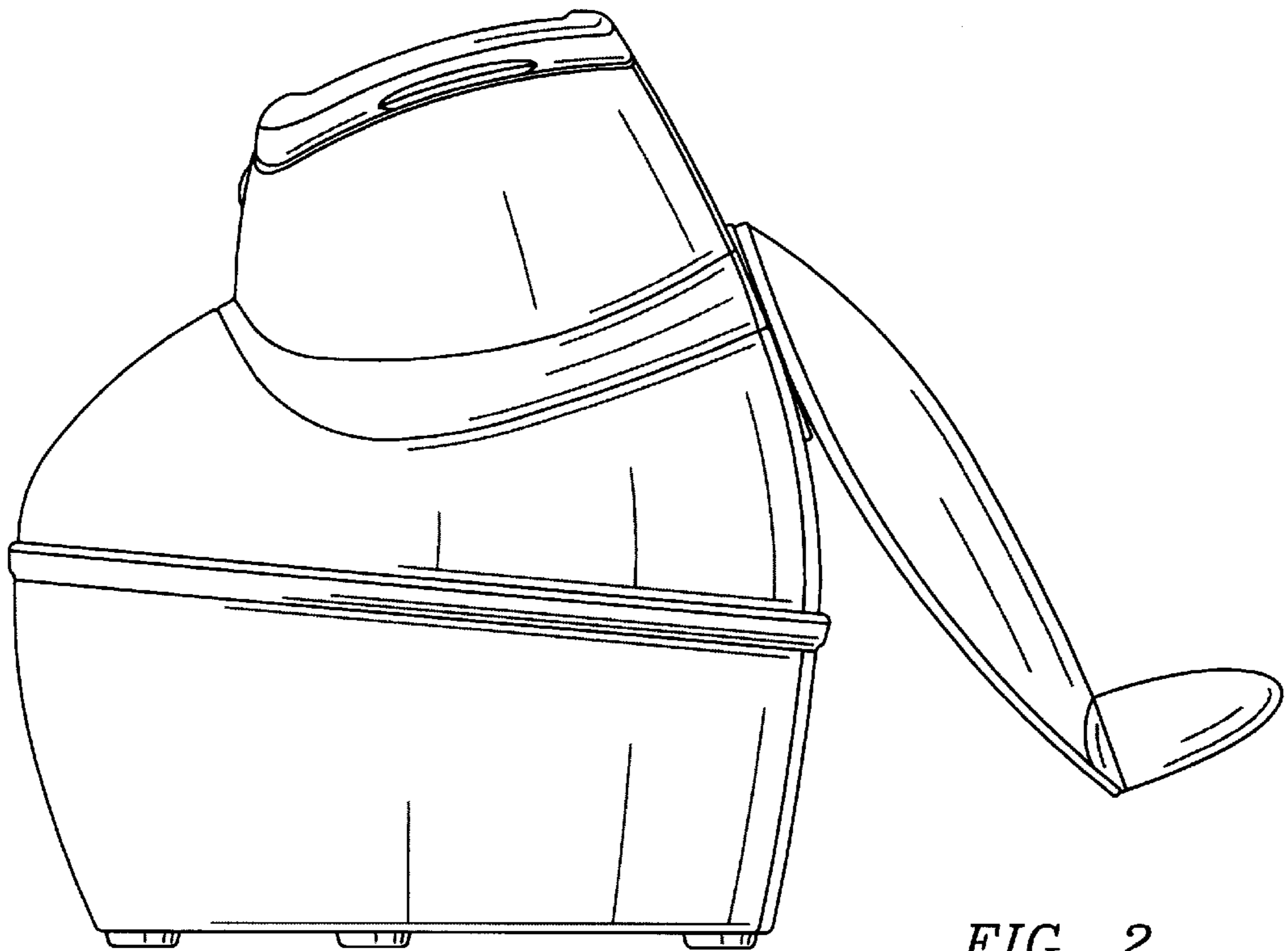

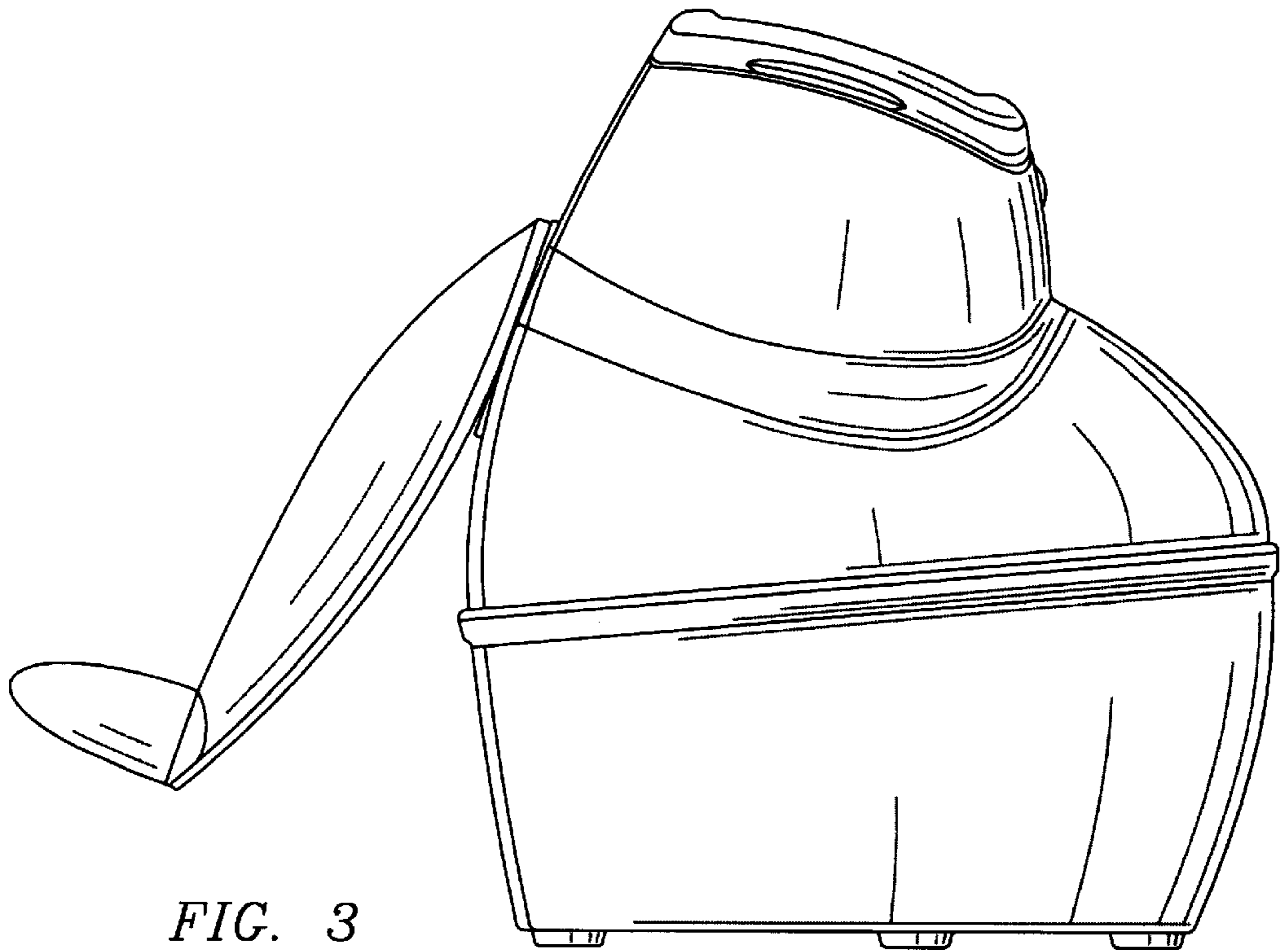

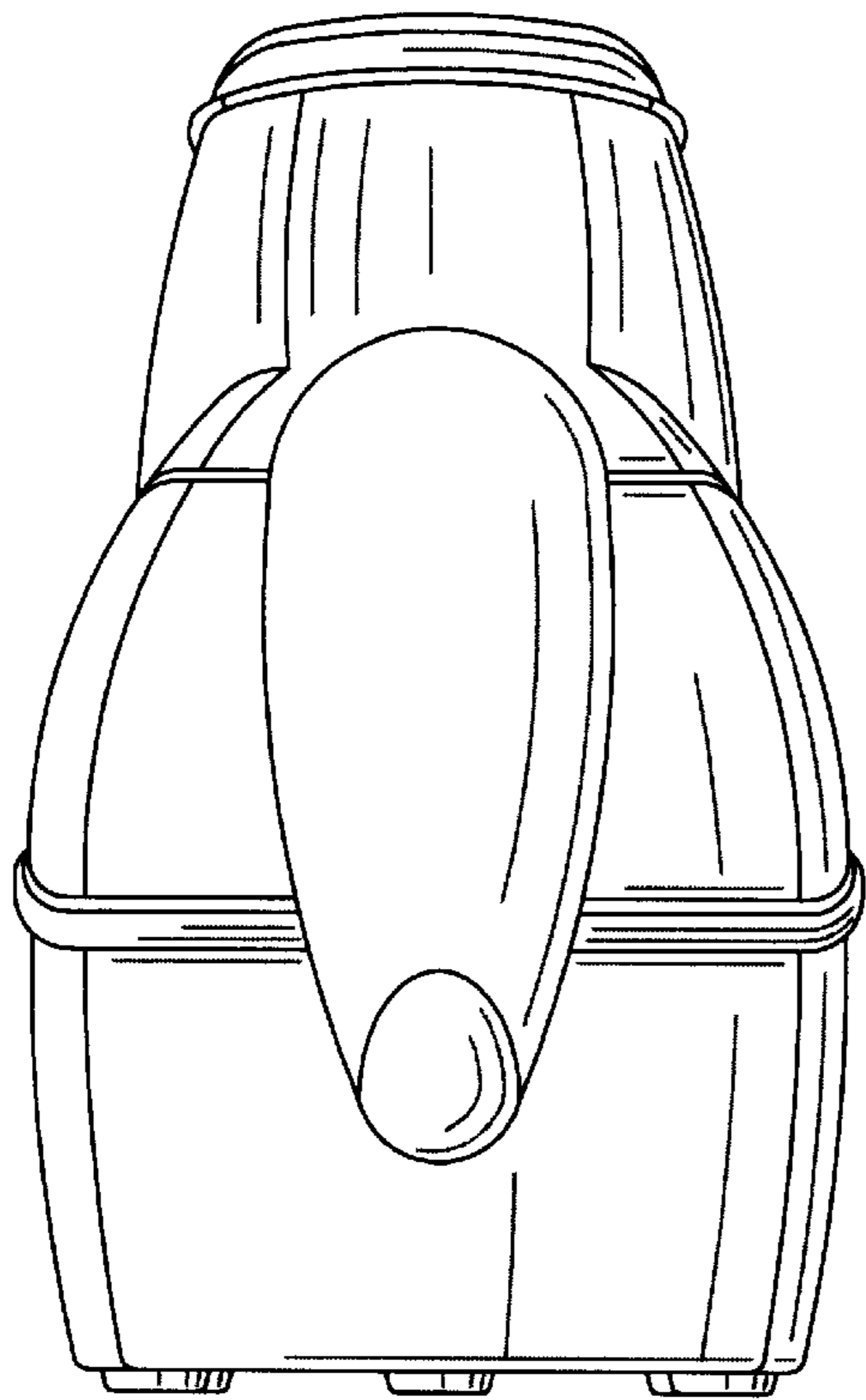

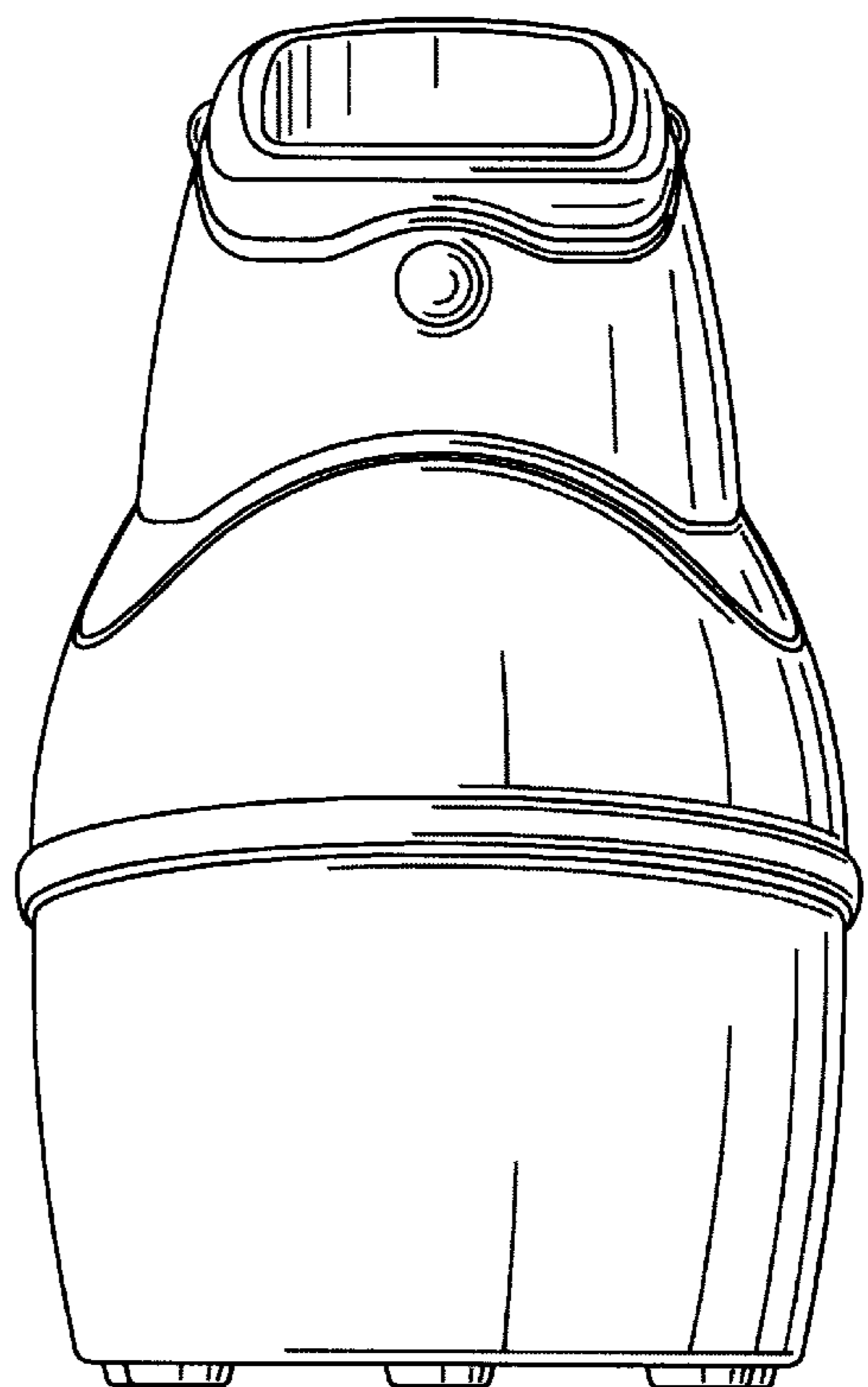

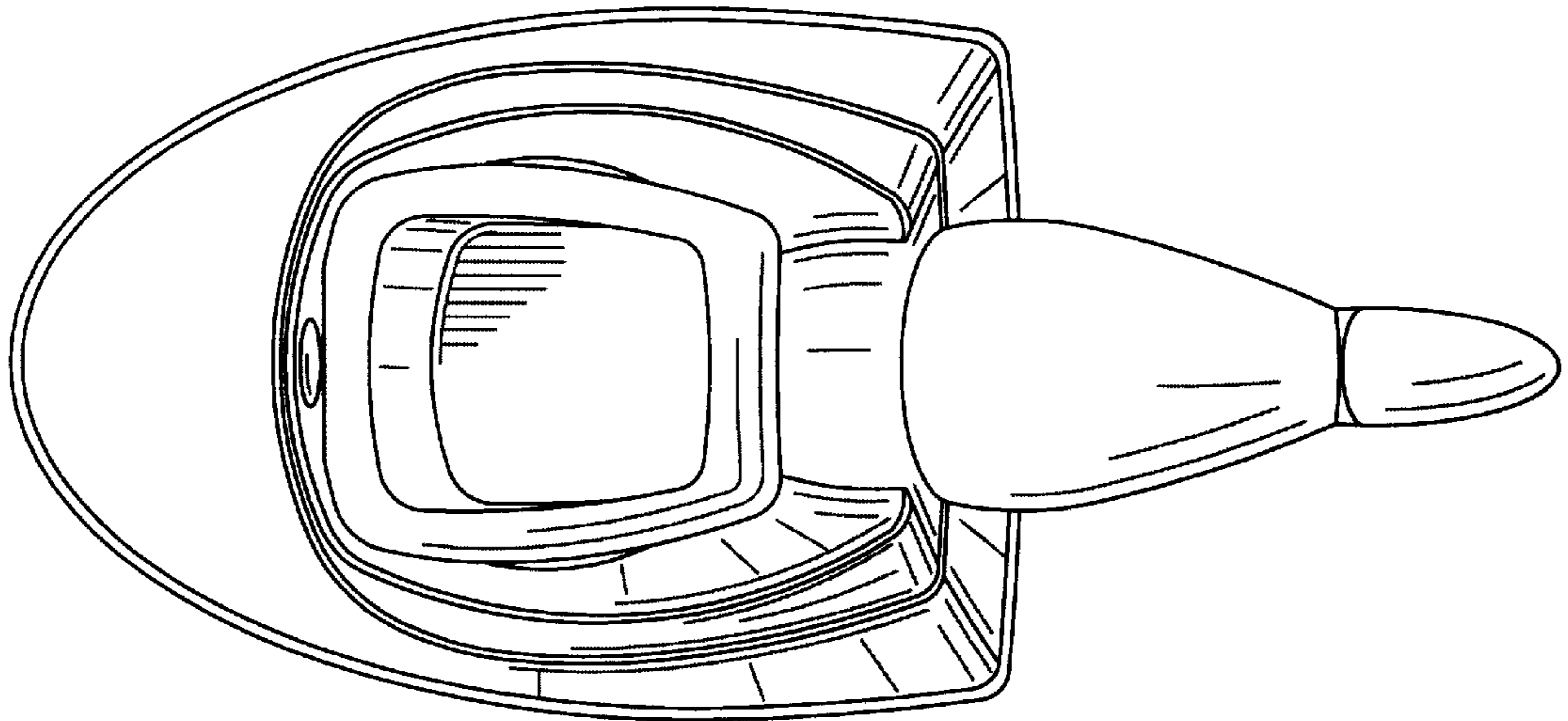

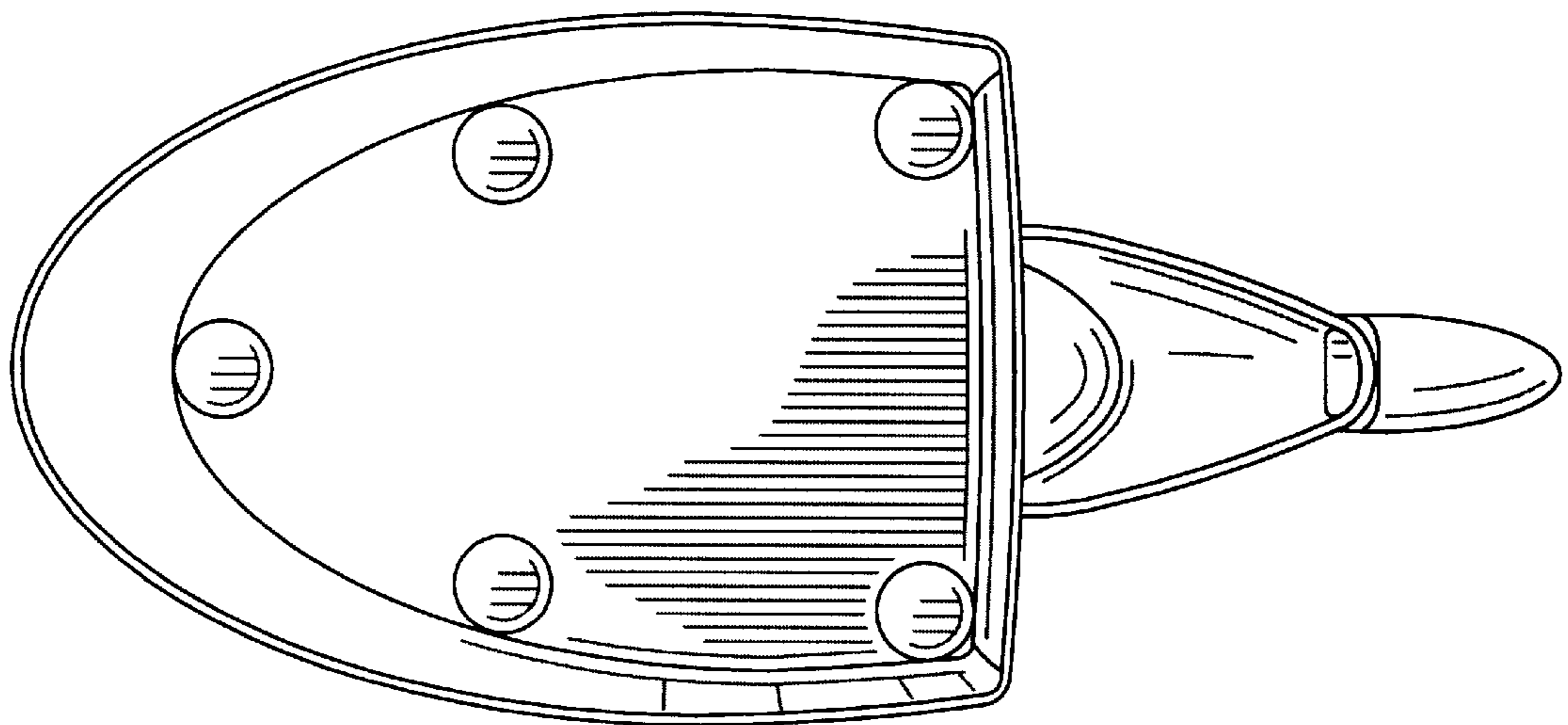
