DESCRIPTION

FIG. 1 is a side elevational view of a utility knife showing my new design.

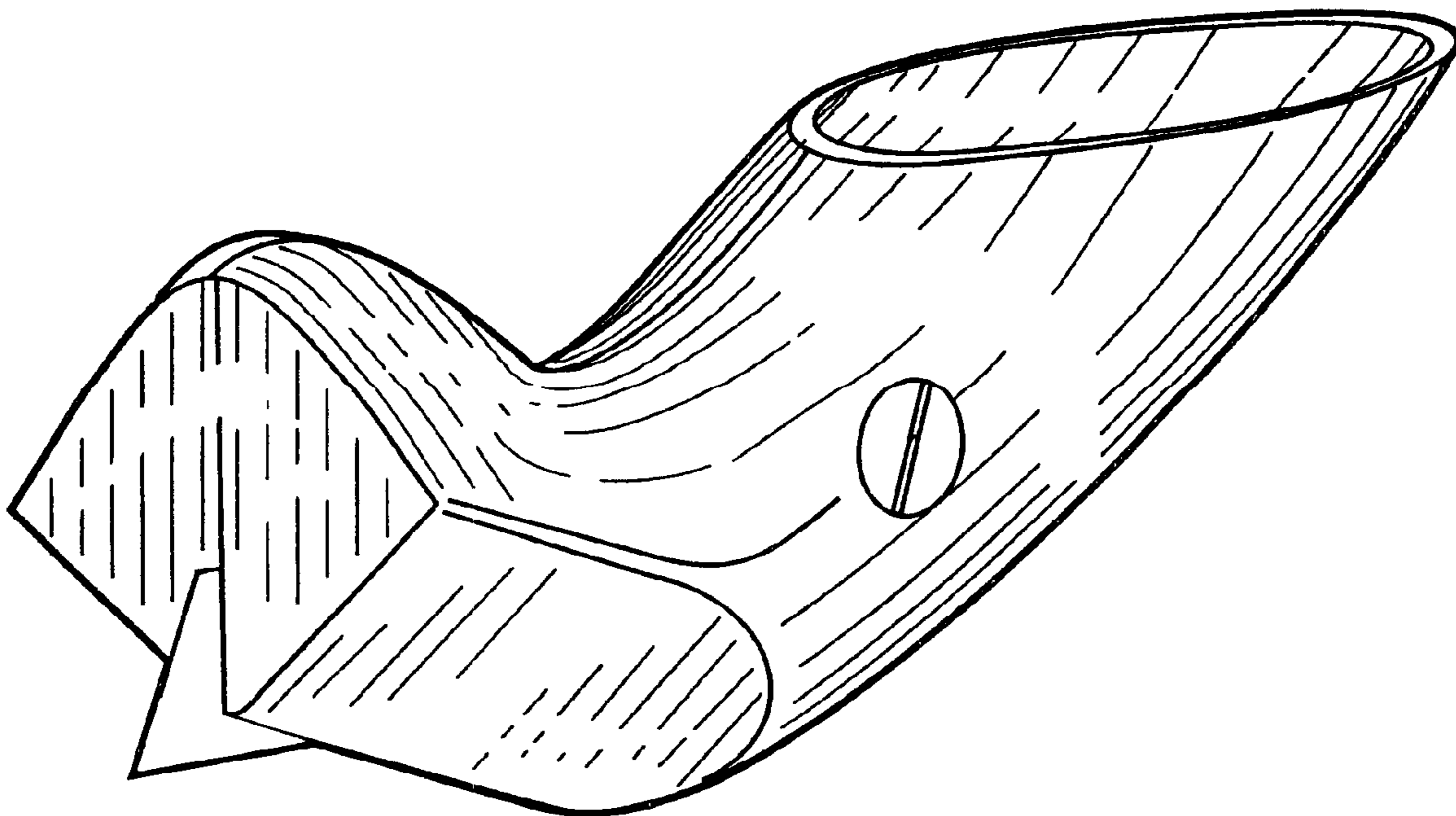

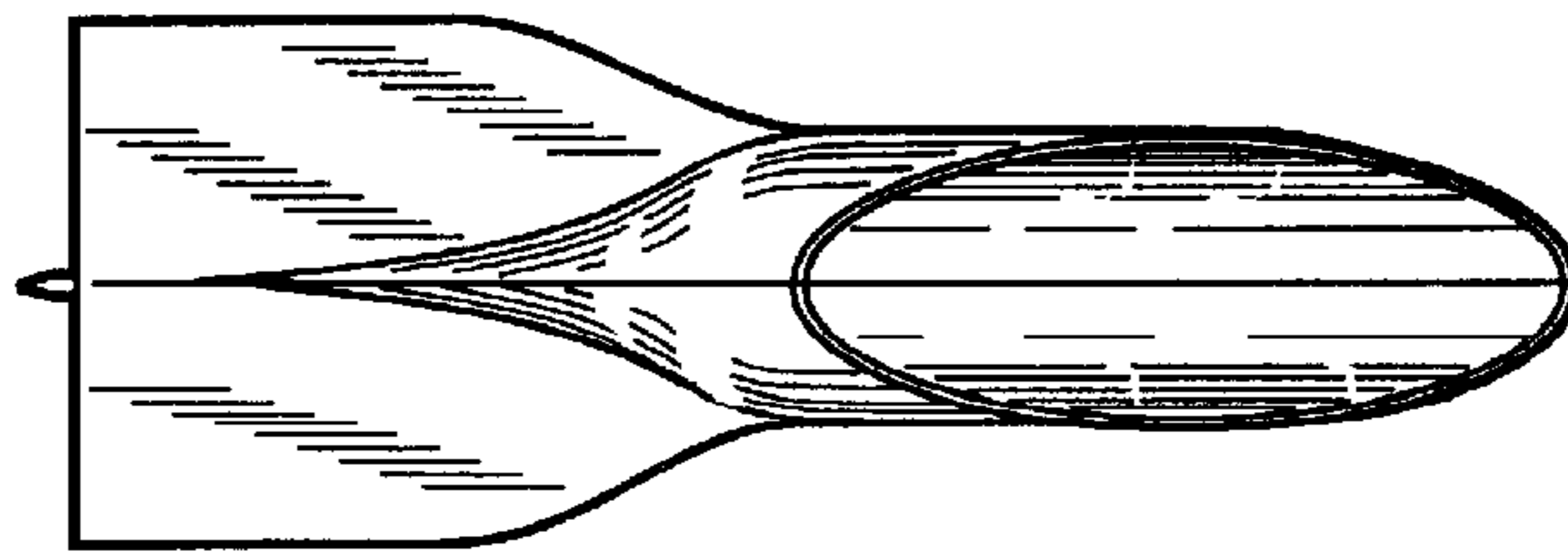

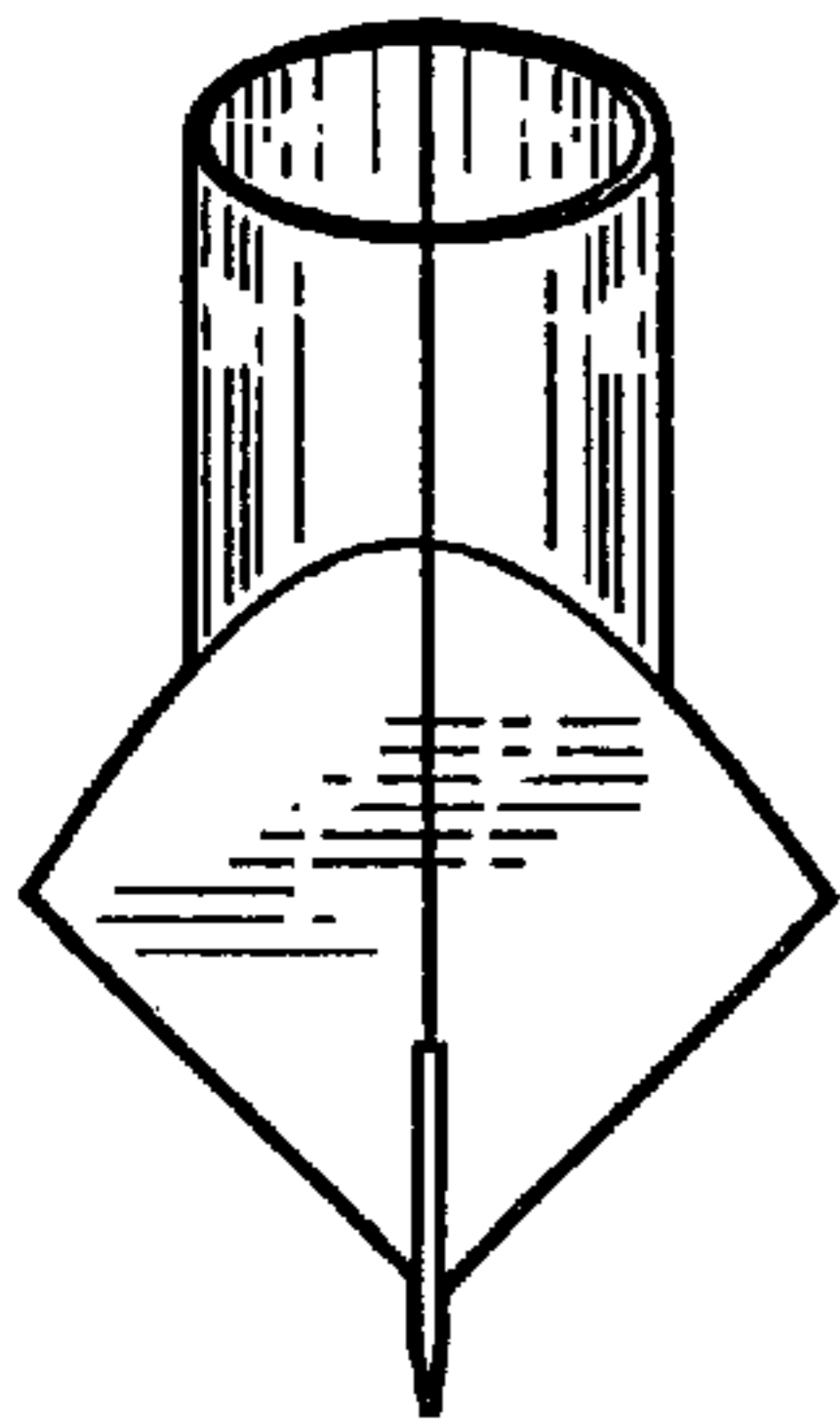

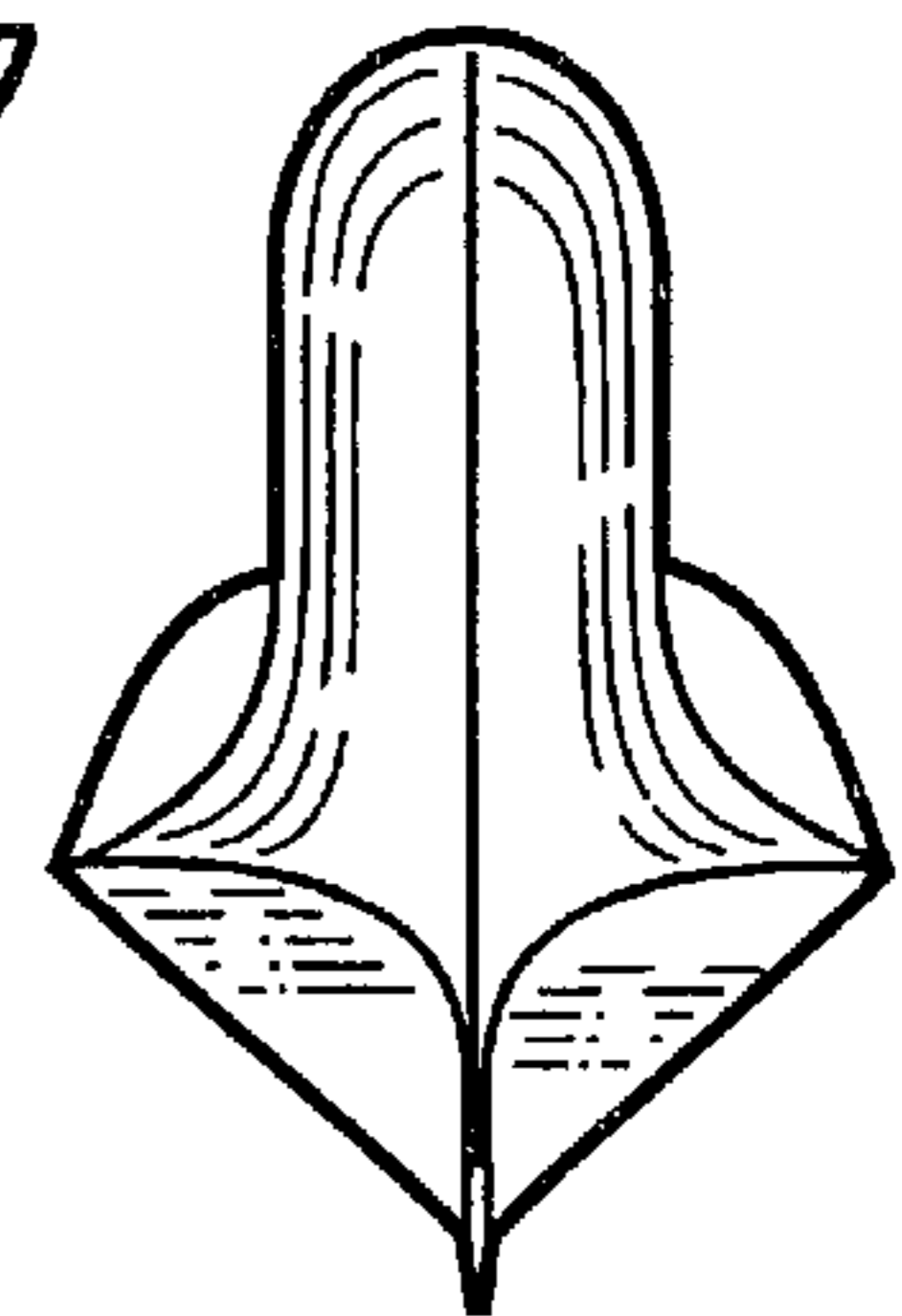
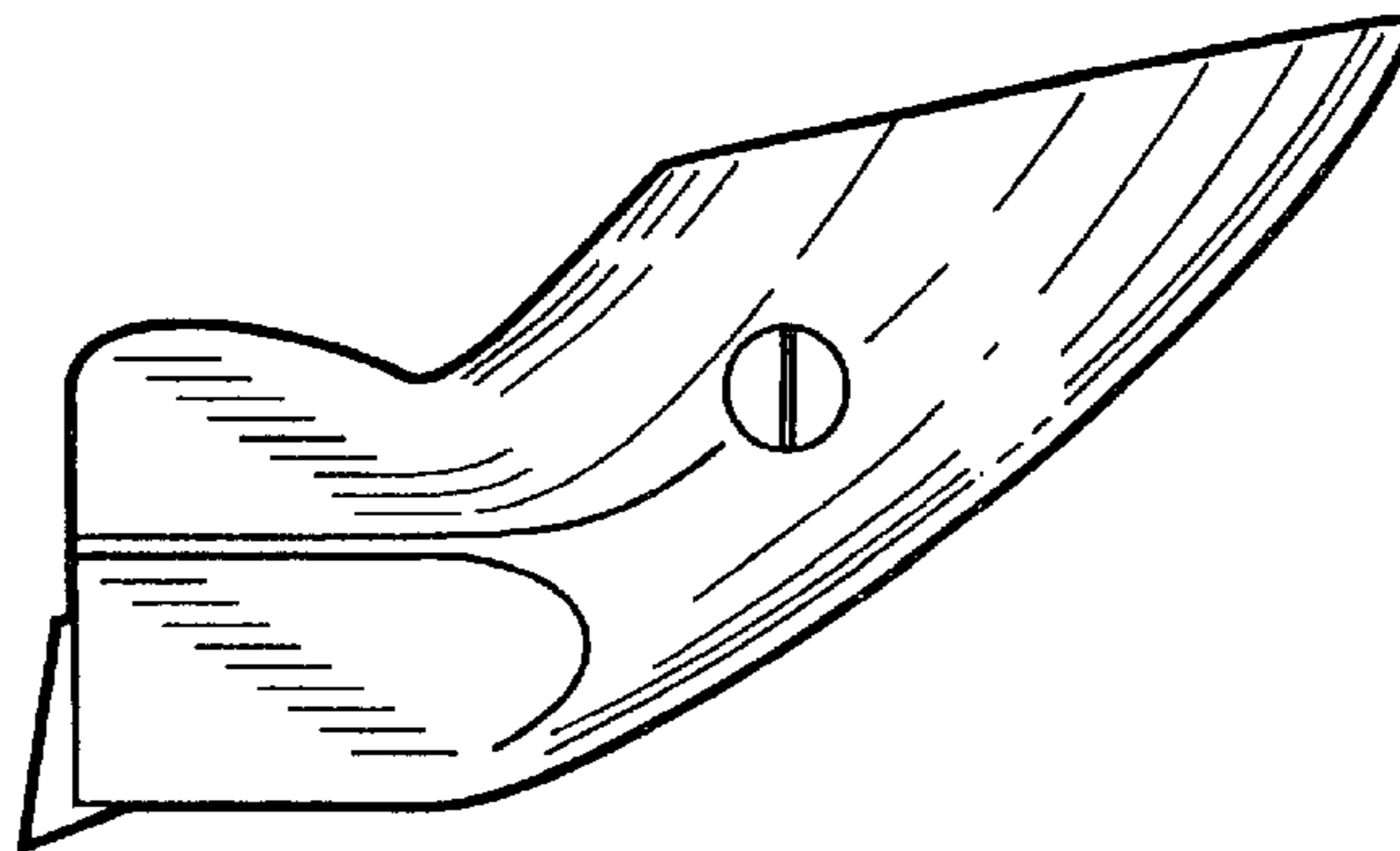

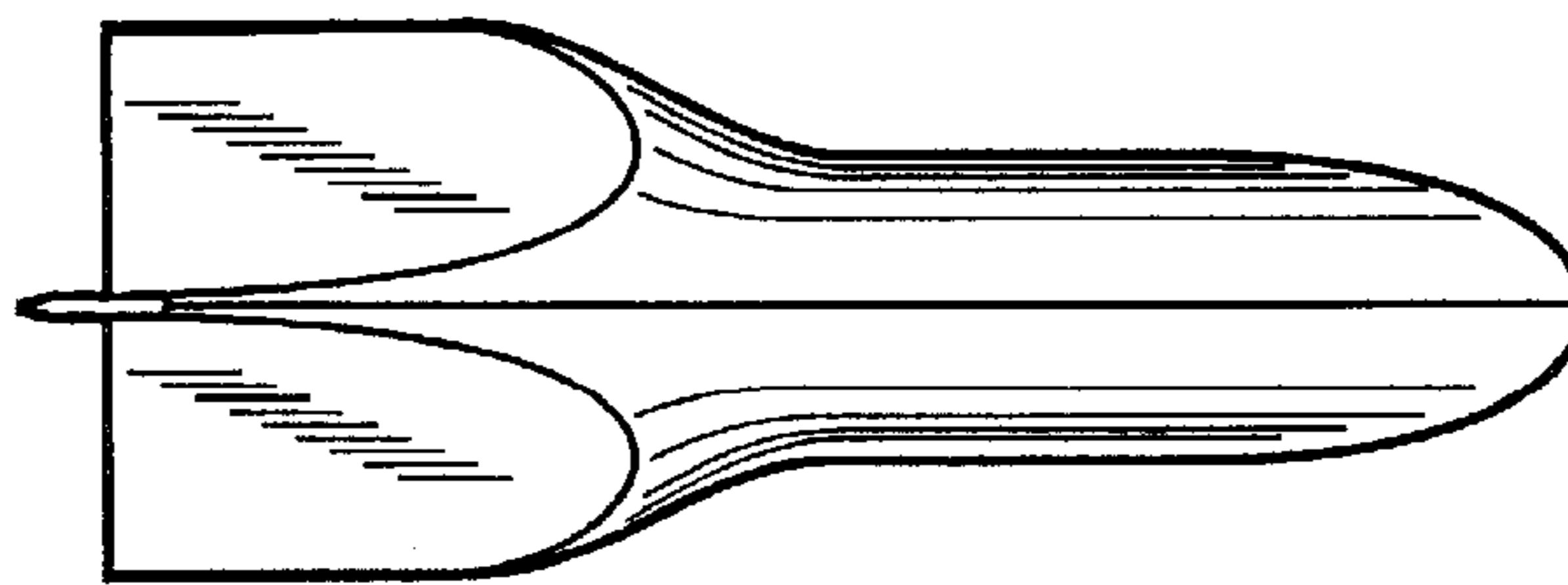

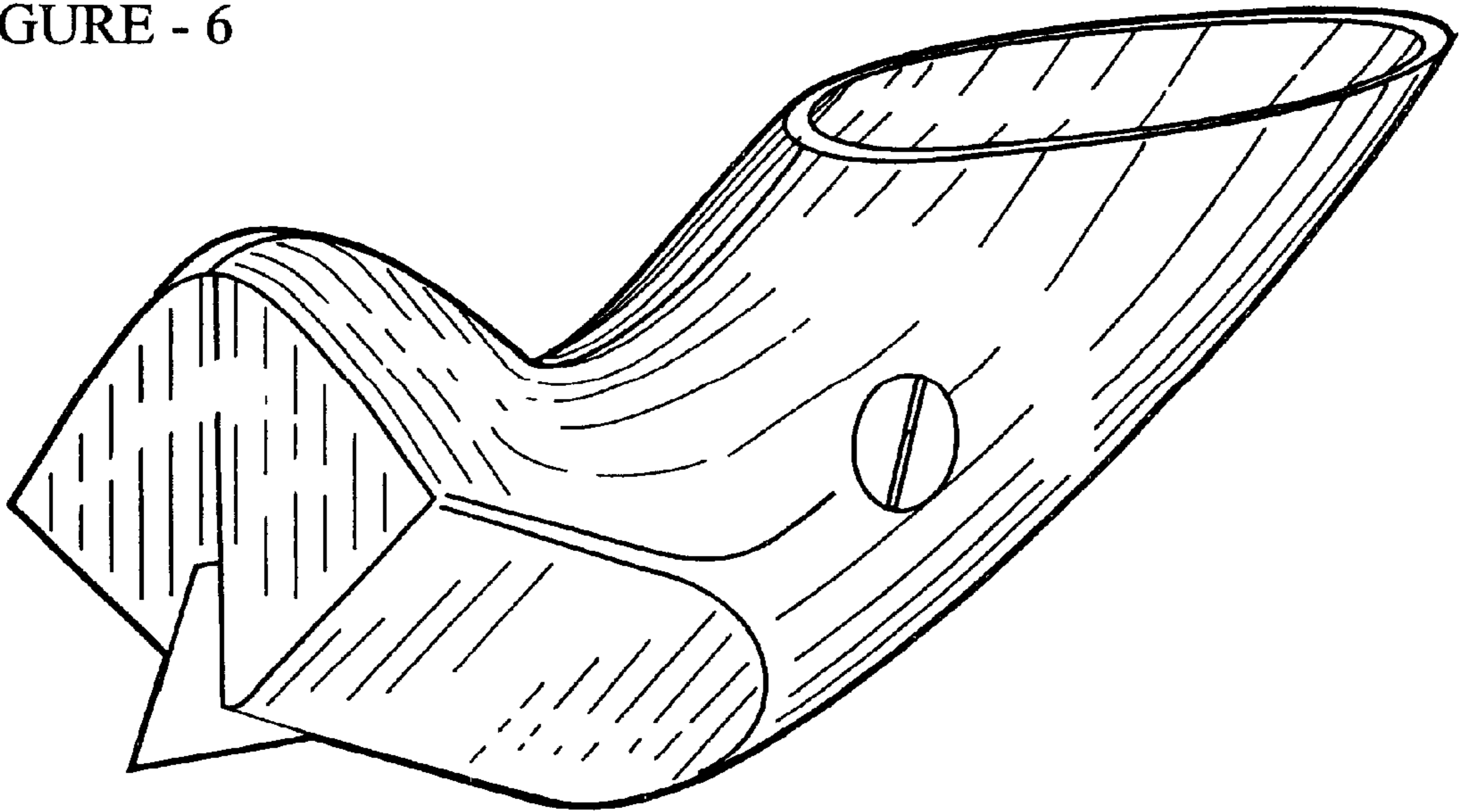

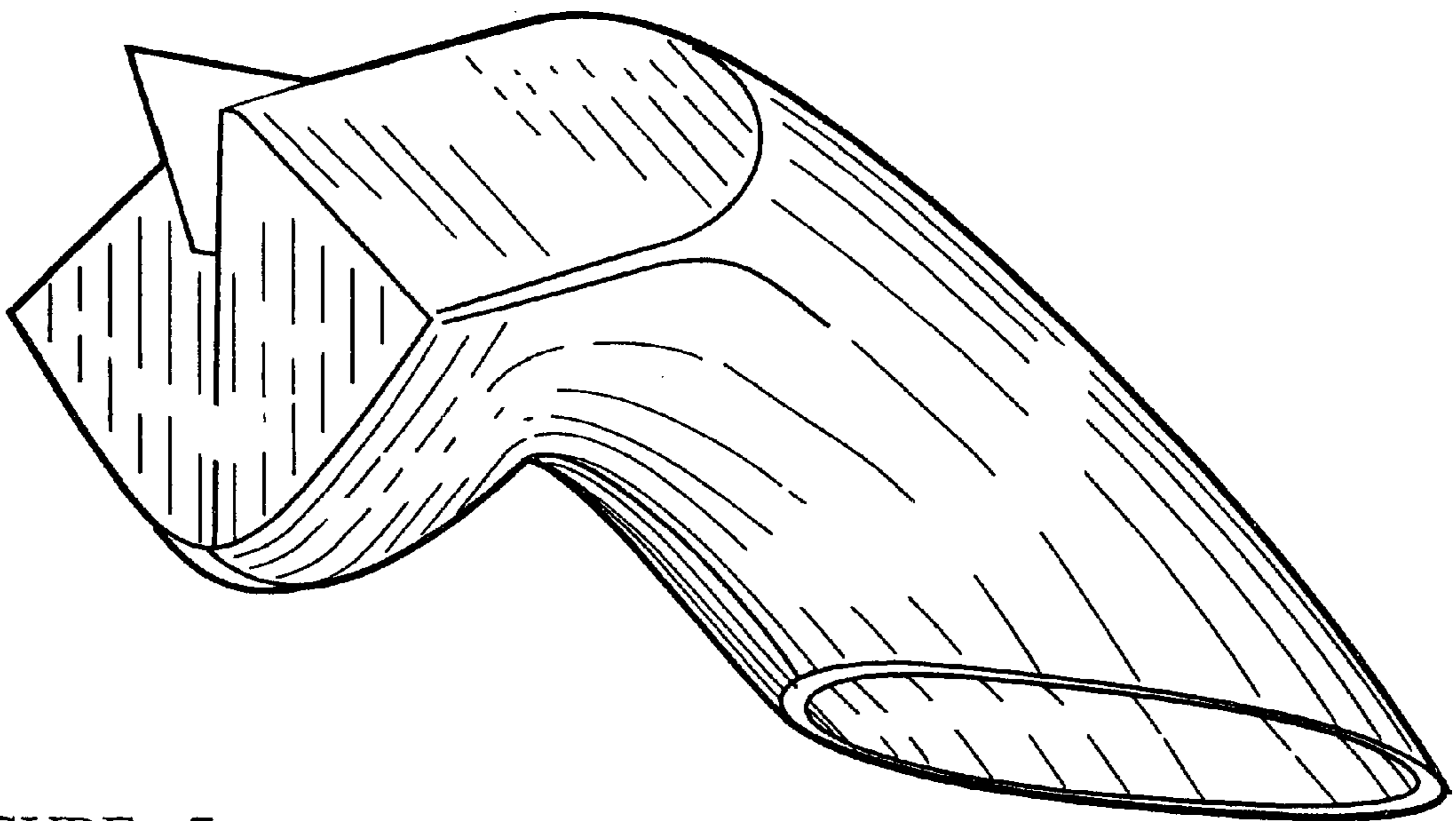

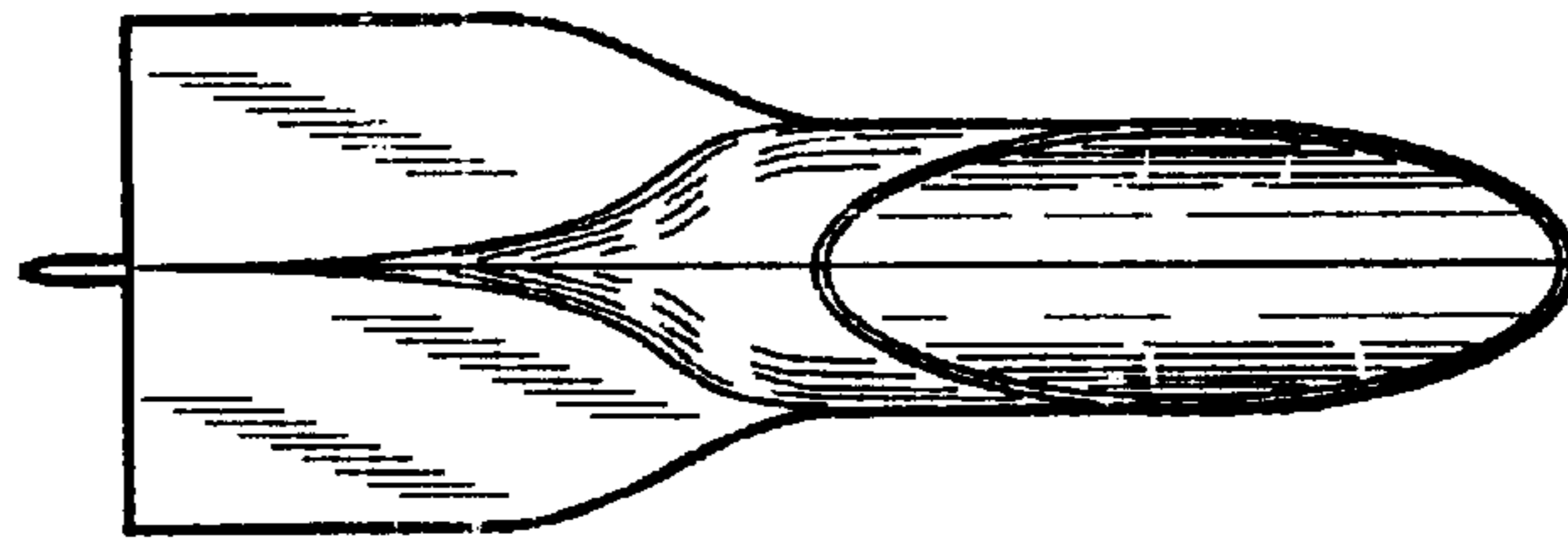

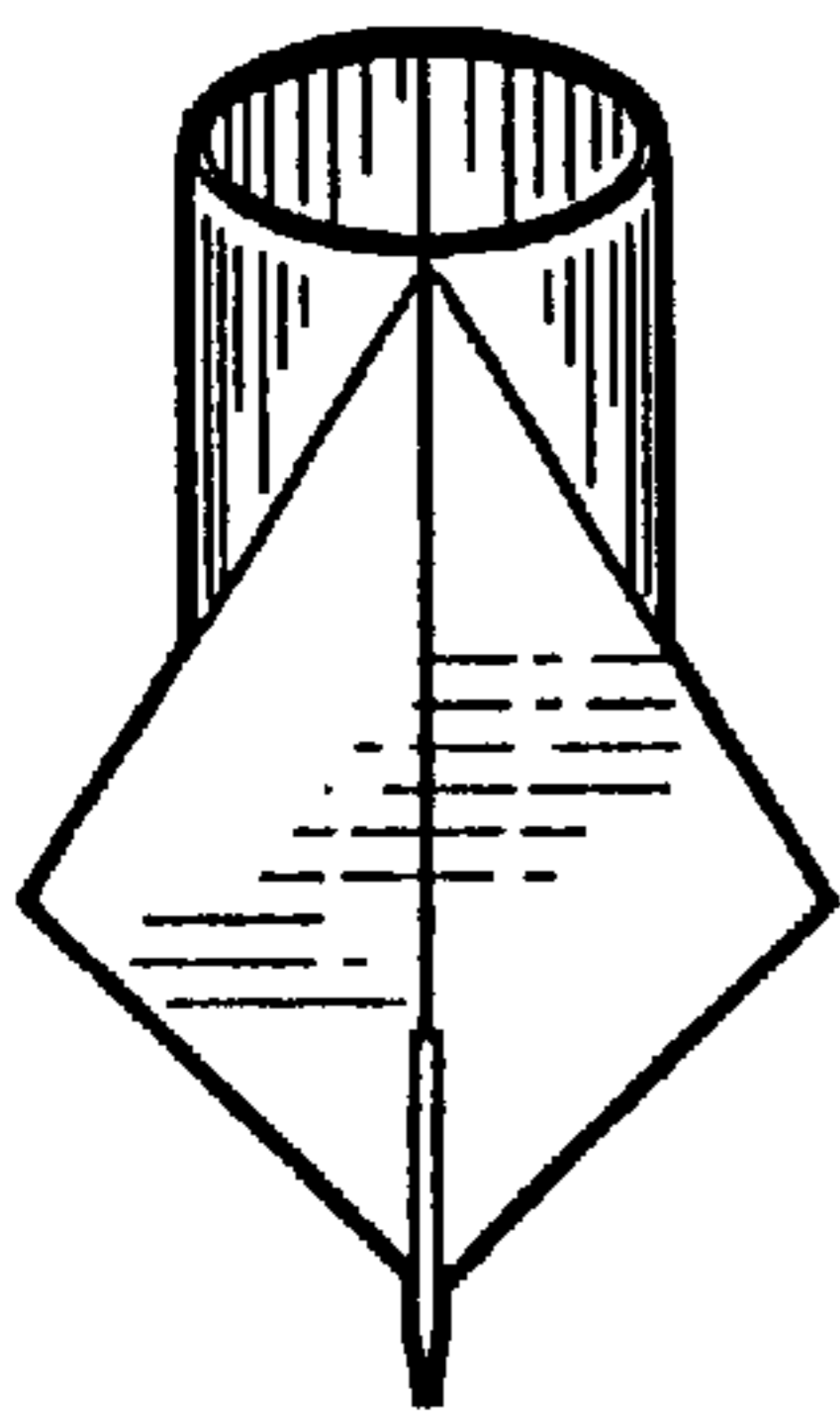

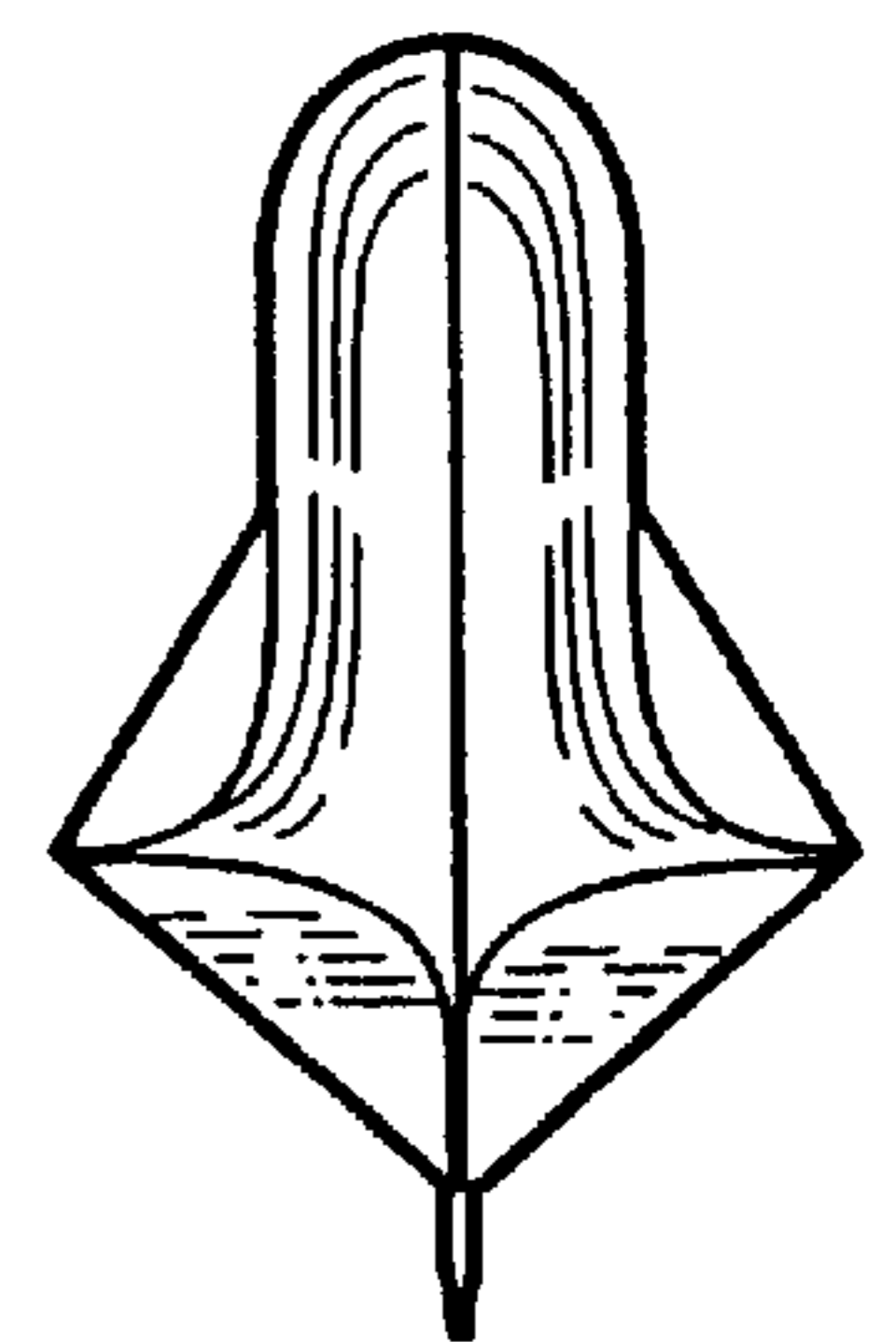
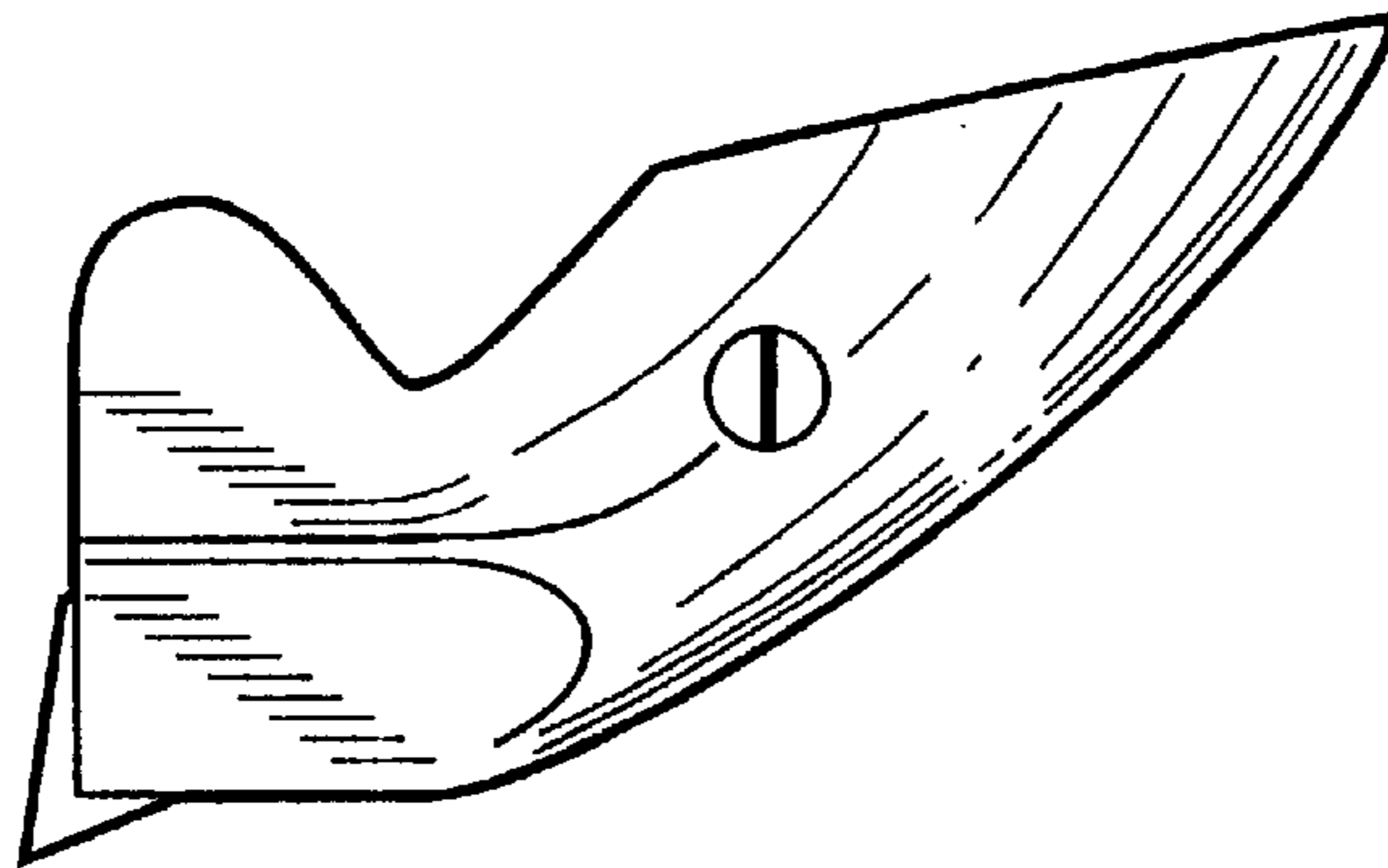

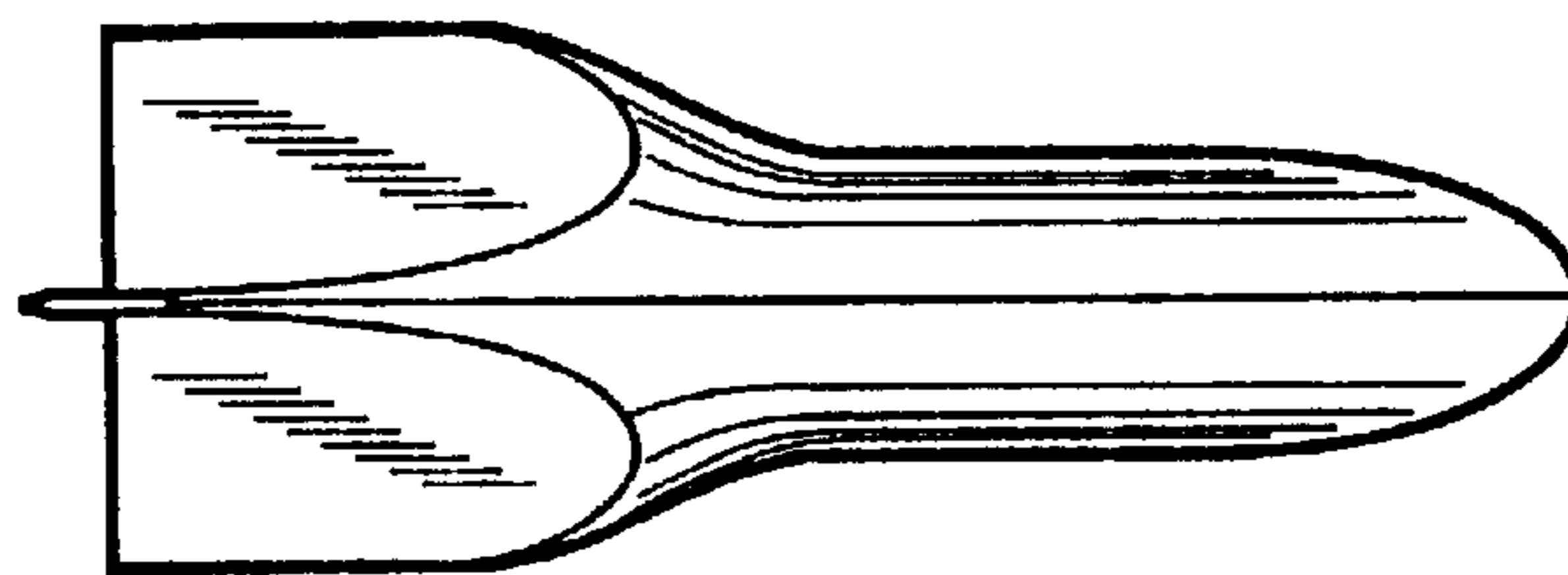

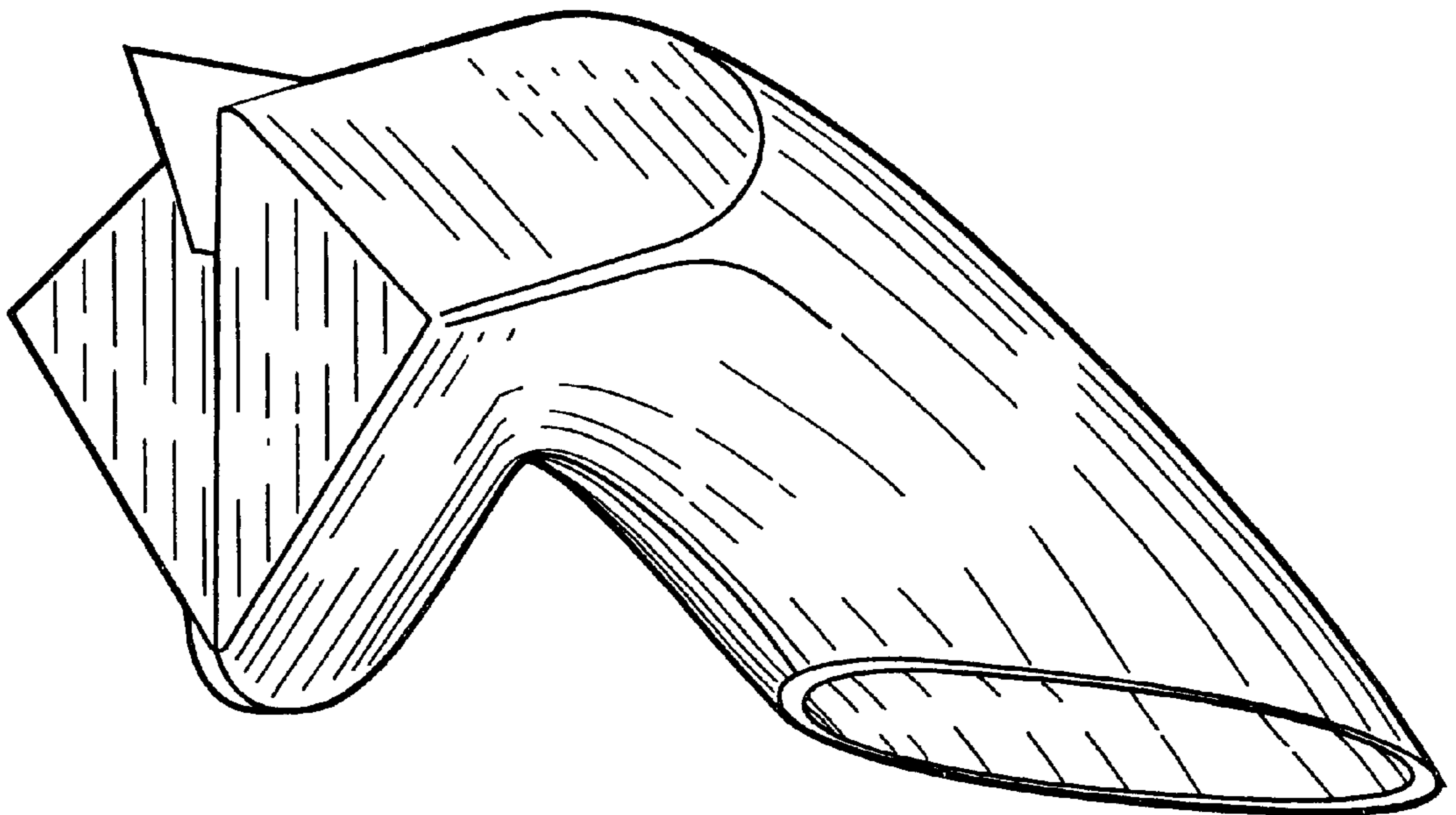
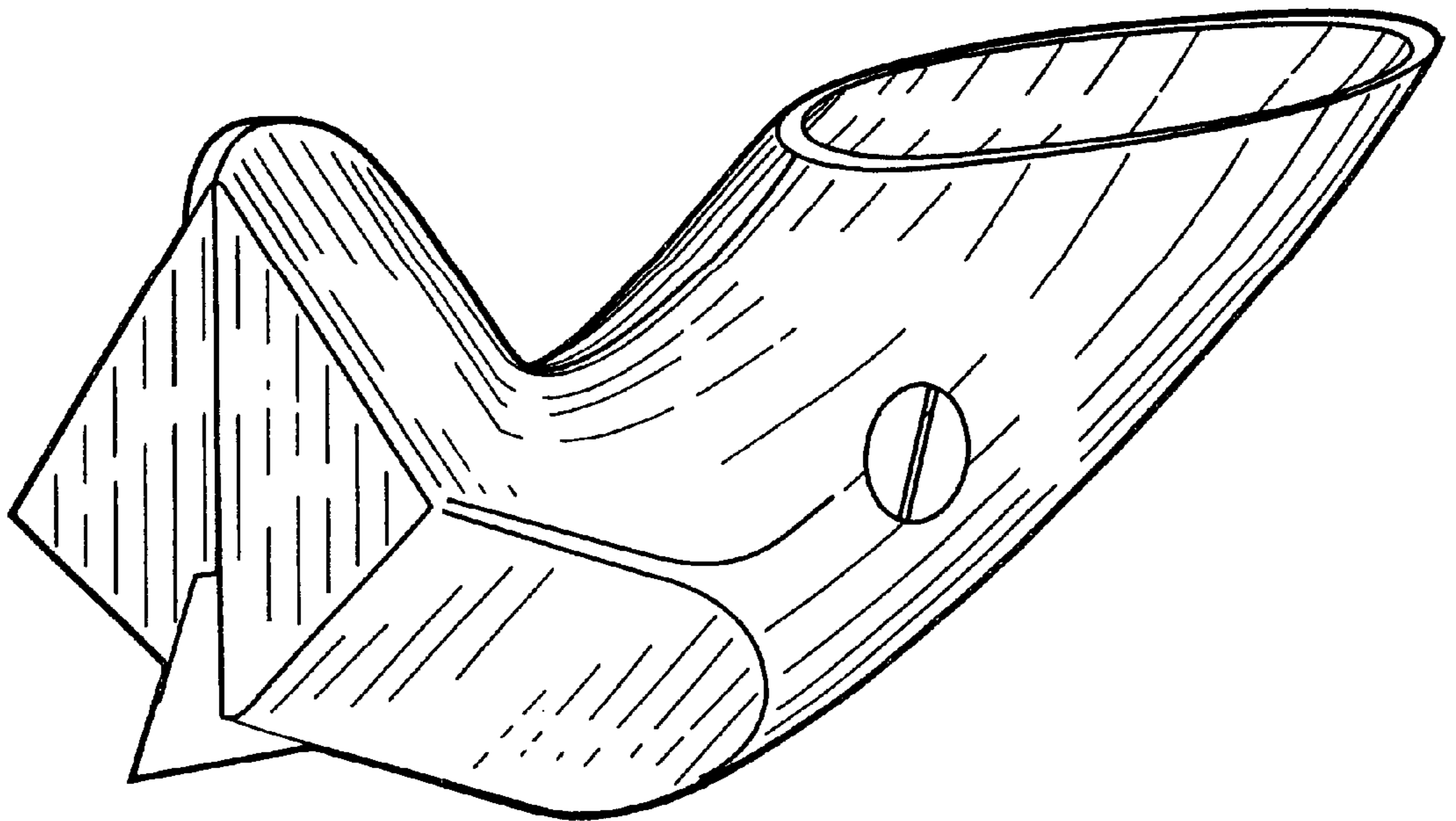
