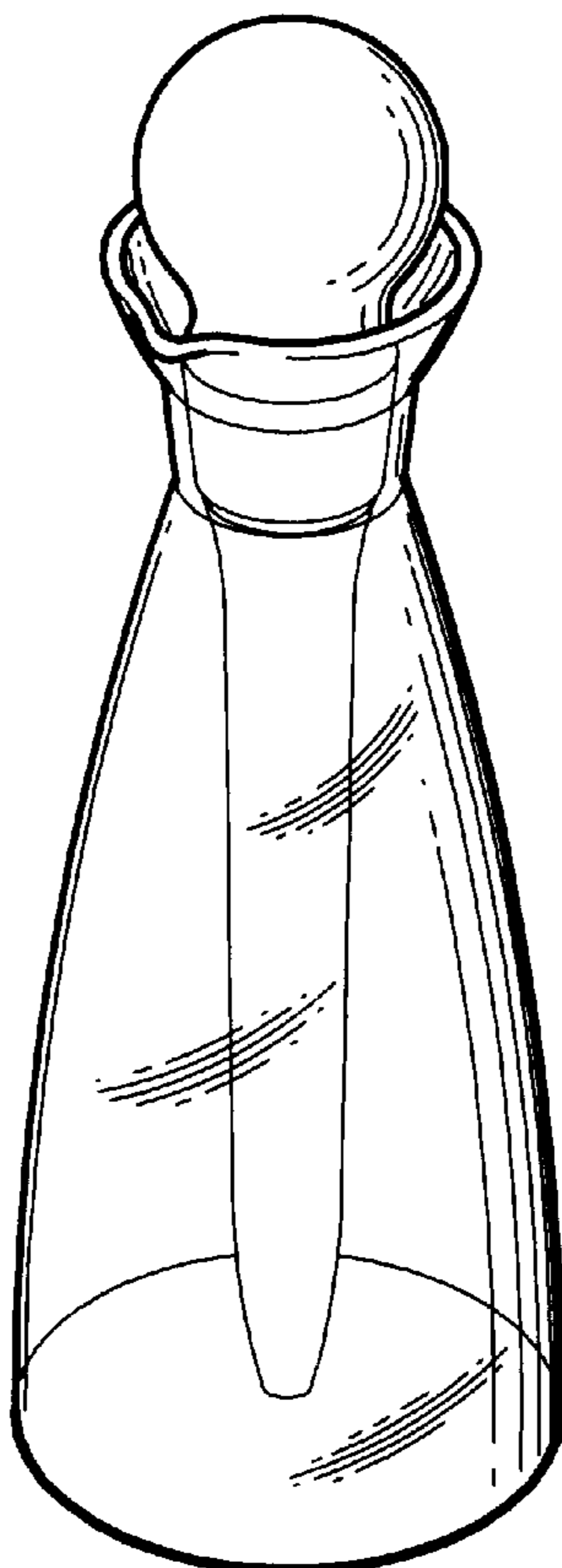
(57) **CLAIM**

The ornamental design for a liquid dispenser, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of the liquid dispenser; FIG. 2 is a top plan view; FIG. 3 is a bottom plan view; FIG. 4 is a back side view; FIG. 5 is a front side view; and, FIG. 6 is left side view, which is a mirror-image of the right side view.

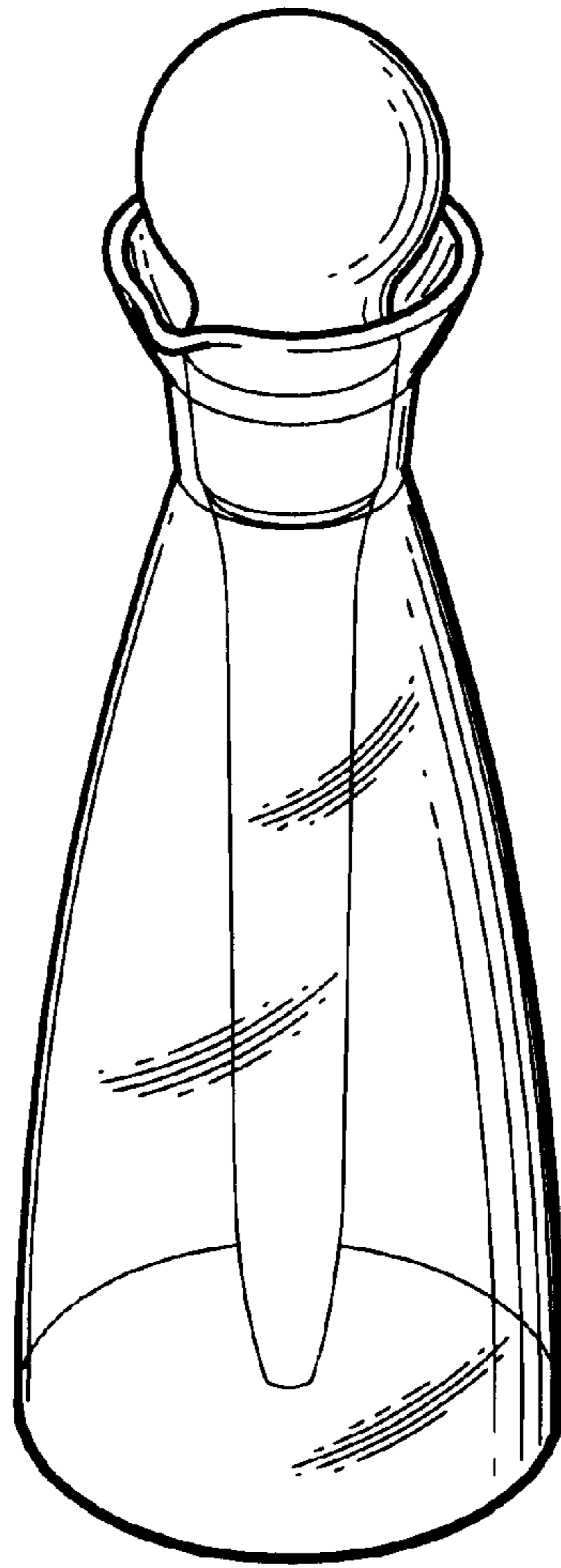

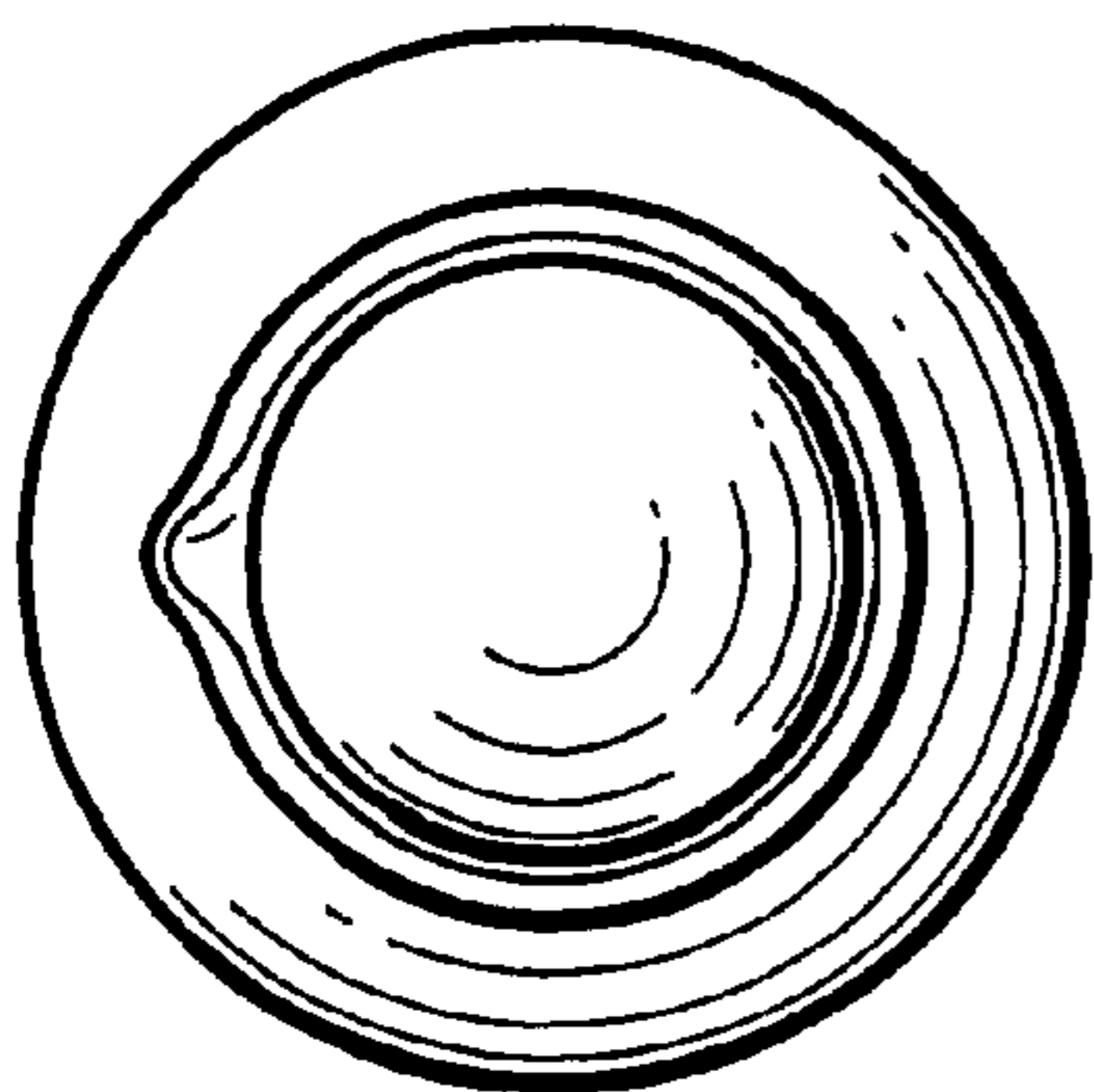

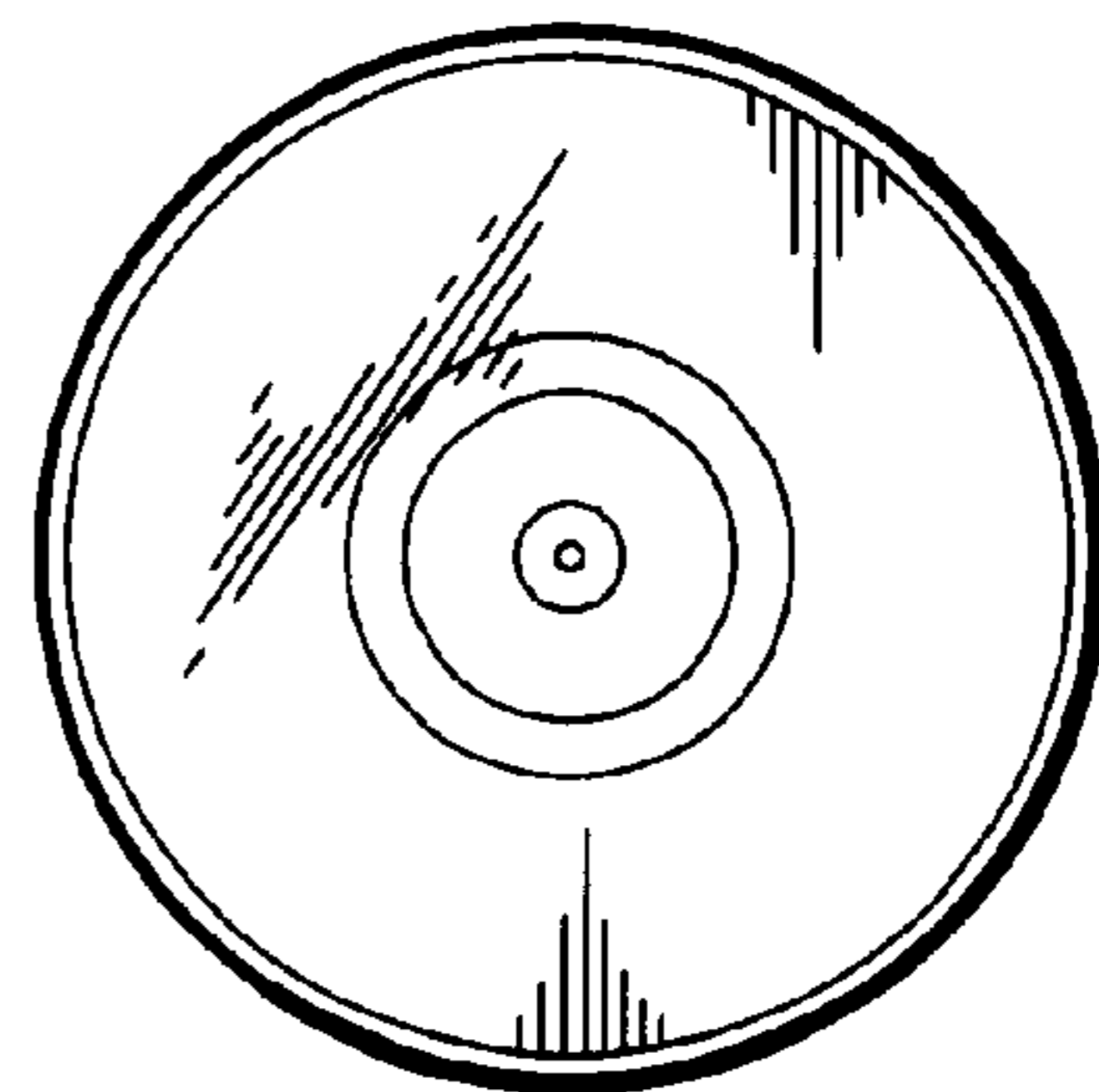

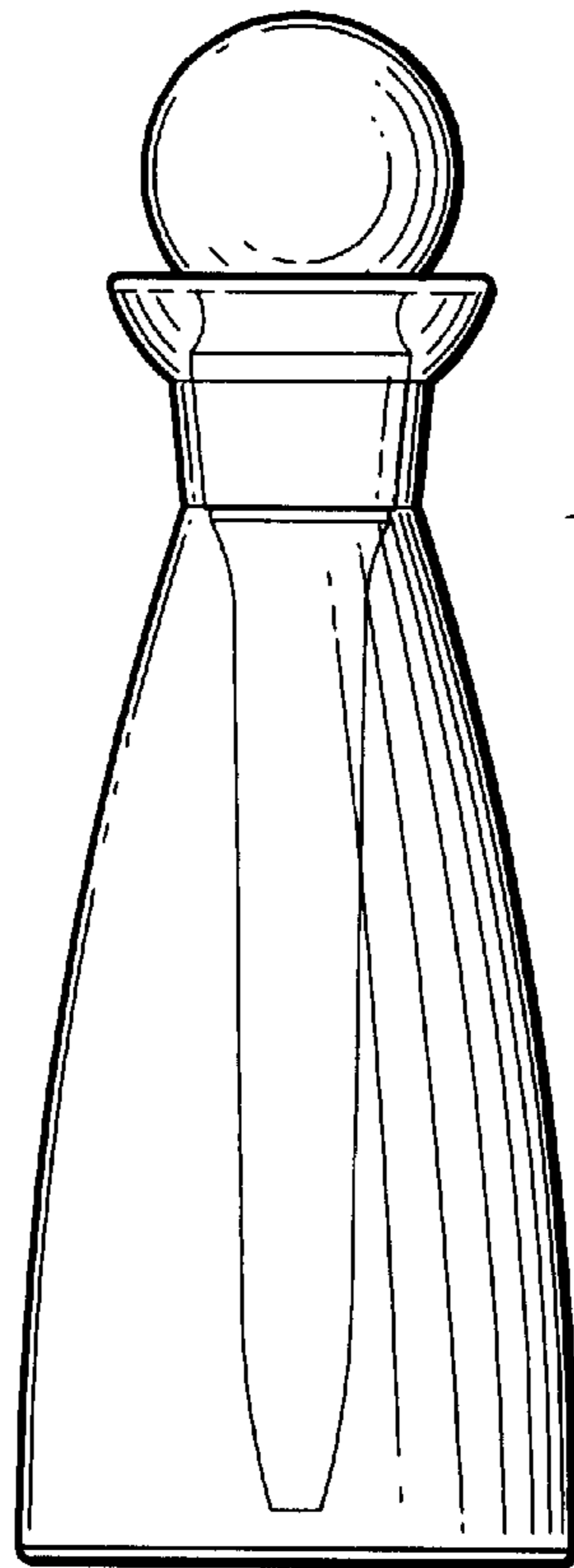

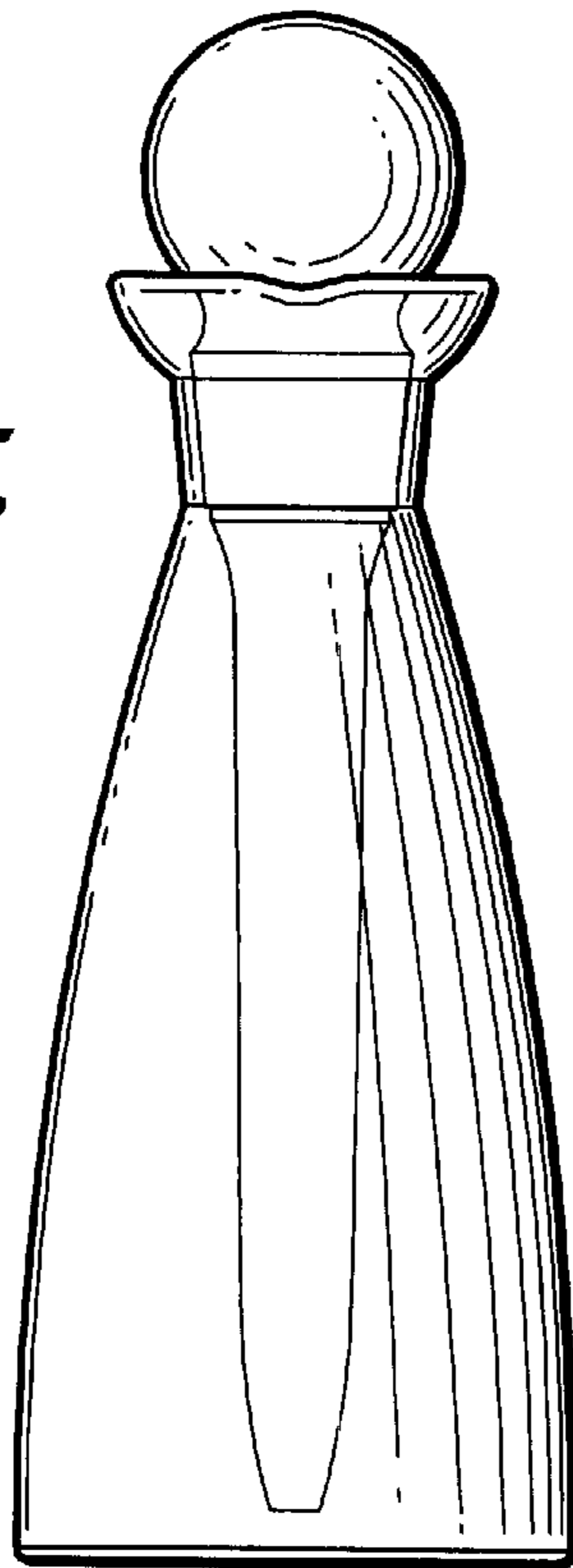

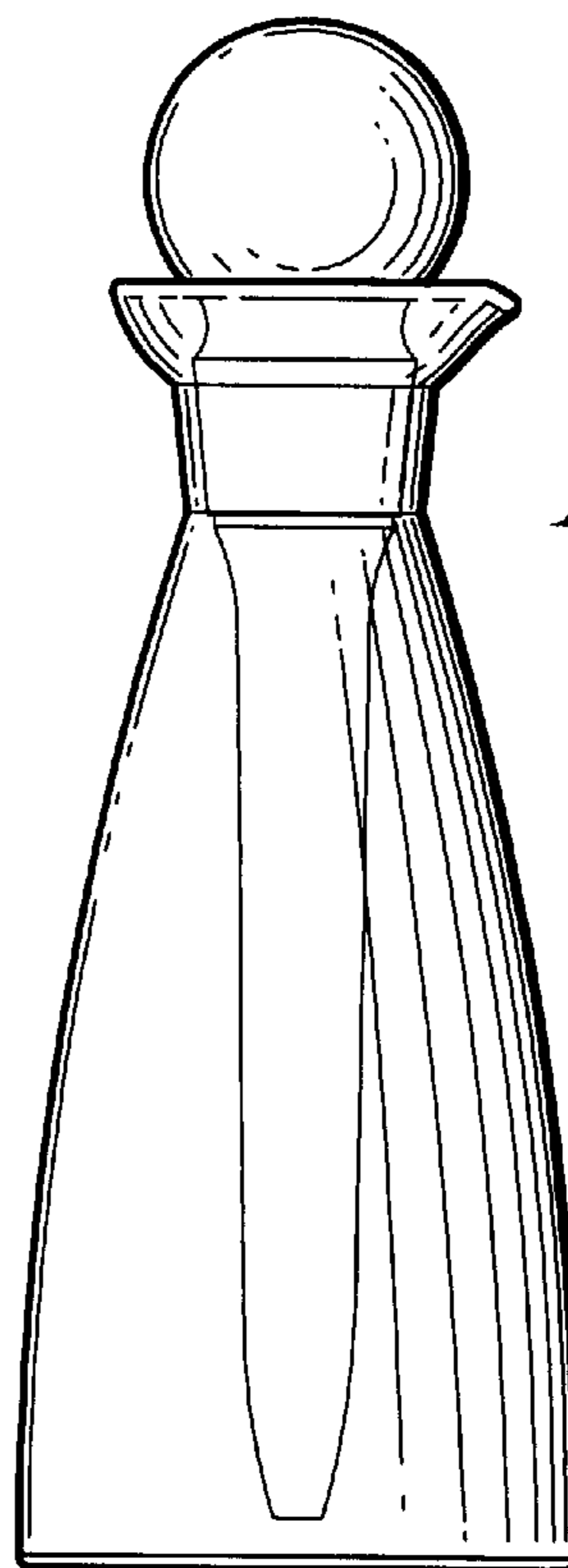
